I was working for the midnight shift and this person called in and said they thought it was going to go down.

Said they saw some bright lights in the air and then they spotted it going down and then further down it got that brighter light start.

And so we took a report on that to begin with and then about 30 minutes later we got a call from the main mobile unit from the Air Force Base that guards an infrastructure out there.

133

Well they said they saw the same thing but it went down and it came straight down from, they figured about 20,000 feet.

134

Came down to about 500 feet above the ground and then they said it shot east of their heading towards Menott.

I don't know what the town was down there.

136

But anyway, it went straight, I figure it went down and straight across for about 5-10 minutes.

Now this couldn't possibly have been a plane?

And they didn't have nothing except for B-52 in the air and that was our own B-52.

In 1956 a group of men with more than a passing interest in flying saucers formed a private non-profit organization which they called the National Investigations Committee on Aerial Phenomena, NICAP.

From its start this organization has been headed by a retired marine pilot, Major Donald Keyhole.

143

He and his co-workers and some 5,000 volunteers conduct their own investigations of sightings.

Keyhole has been, from the start, very critical of Air Force investigations and what he calls the withholding of facts.

145

00:14:48,000 --> 00:14:54,000

Recently Keyhole called a news conference in Washington to say these things are from outer space.

146

He cited many of what he termed prime examples, such as what happened in Exeter, New Hampshire last year.

147

00:15:02,000 --> 00:15:08,000

Recently, and they actually changed up in New Hampshire and probably most of you are familiar with that,

148

the Air Force did publish an answer and later retracted it.

149

00:15:14,000 --> 00:15:24,000

Now for those of you who may not be familiar, this was a report by two veteran policemen of Exeter, New Hampshire and a teen agro, about 19 years old,

150

who first saw this device and went to the police, they went out to the scene and, uh, skeptical,

151

00:15:30,000 --> 00:15:34,000

and when they got there they found exactly what he had described.

152

The very large objects have been close to the ground with light splashing in sequence,

153

00:15:39,000 --> 00:15:45,000

uh, creating such a binding there that it lit up the ground for about 300 feet.

154

00:15:45,000 --> 00:15:52,000

It even caused animals in nearby buildings which couldn't see this object to get upset,

155

00:15:52,000 --> 00:15:55,000

horses kicking themselves and running and so on.

156

00:15:55,000 --> 00:16:02,000

Now this was made, uh, we made this report public and it was picked up by John Fore of Sanity Reviews Literature,

157

00:16:02,000 --> 00:16:05,000

and later published in ROOT.

158

00:16:05,000 --> 00:16:13,000

And somehow that had more effect than any group of sightings that we put out in the last five years,

159

00:16:13,000 --> 00:16:18,000

probably because of his prestige and the fact that he didn't have any axe to grind.

160

00:16:18,000 --> 00:16:26,000

He really went up there and took interviews with all of the witnesses and came back and said there seems to be no doubt that this thing was there in the creel.

161

The Air Force at first said that this was a mistake caused by low flying aircraft,

162

00:16:33,000 --> 00:16:39,000

and the police officers were very much incensed by being called incompetent.

163

00:16:39,000 --> 00:16:43,000

They stated, well, this was wrong. They were not low flying aircrafts.

164

00:16:43,000 --> 00:16:46,000

This was definitely an unidentified flying object.

165

00:16:46,000 --> 00:16:52,000

The same thing happened in another case that very same night, which is not so well known down in Texas.

166

00:16:52,000 --> 00:17:03,000

On the night of September 3rd, two deputy sheriffs saw a plane drop into the sky and they parked their cruiser with a light song into the front of the highway to watch it.

167

00:17:03,000 --> 00:17:09,000

They were Bratoria County Chief Deputy Billy McCoy and Deputy Sheriff Robert Goode, both of Angleton.

168

00:17:09,000 --> 00:17:13,000

We asked Chief Deputy McCoy to describe the encounter.

169

00:17:13,000 --> 00:17:26,000

As we were leaving Dailin, I noticed all over on the right-hand side of the highway there going towards West Columbia,

170

00:17:26,000 --> 00:17:33,000

I noticed a bright purple light over there that looked like it was right on the horizon.

171

00:17:34,000 --> 00:17:40,000

We were talking about various things, and I called this light to make good attention,

172

00:17:40,000 --> 00:17:44,000

knowing that he was real prepared for that area over there.

173

00:17:44,000 --> 00:17:52,000

He said, well, there's probably a light over Pumping Station or a light over to a red light that's going to put quite a few little mercury vapor lights in.

174

00:17:52,000 --> 00:17:58,000

I said, well, it just looked too purple to be a mercury vapor light to me.

175

00:17:58,000 --> 00:18:04,000

We continued driving, didn't stop at that time, and I kept watching the light.

176

00:18:04,000 --> 00:18:17,000

As we traveled down the highway, there appeared to be a blue light that seemed to appear right out of this purple light.

177

00:18:17,000 --> 00:18:23,000

We were just almost parallel with the light.

178

00:18:23,000 --> 00:18:30,000

As we drove, the blue light seemed to move further over to the right.

179

00:18:30,000 --> 00:18:38,000

We pulled over right-hand side of the road and stopped, and I got out and looked at the light briefly.

180

00:18:38,000 --> 00:18:44,000

The blue light had moved a good ways from the purple light at this time.

181

00:18:44,000 --> 00:18:50,000

We made a U-turn there and stopped on the other side of the highway and got out and looked at these lights through the darkness.

182

00:18:50,000 --> 00:19:01,000

At this time, the light seemed to float up in the air just a very few degrees above the horizon and just hanging suspended there.

183

00:19:01,000 --> 00:19:09,000

So we got back in the car to drive back towards Damon, on the tape, one of the back roads to go over towards the seminar.

184

00:19:09,000 --> 00:19:15,000

We were just about to get close to it, and we had driven, I guess, about a half a mile back towards Damon.

185

00:19:15,000 --> 00:19:19,000

We almost stopped again. We didn't pull off the highway.

186

00:19:19,000 --> 00:19:25,000

We were just barely creeping. There was no traffic on the highway, and the dude had his window down on his side,

187

00:19:25,000 --> 00:19:33,000

and he observed the light again with the doctor, and the same thing would still be in the same position as it were.

188

So he laid the binoculars down and said, Would you watch it? I'll drive on back that way.

189

00:19:40,000 --> 00:19:48,000

And just as we started up, he said that although the light is still there, and I said, Man, they're not there. They're right here on us.

190

Well, at the front, the object had moved just in a blink of an eye. It seemed like where they were to ride beside the highway.

191

The purple light was illuminating the inside of a troll car, ground all around us.

192

00:20:08,000 --> 00:20:15,000

And here this thing was just about as little as I could watch it any more than a hundred and hundred and fifty feet ahead.

193

It was right at the side of the highway, completely motionless.

194

00:20:20,000 --> 00:20:27,000

There was a bright almost full of almost directly overhead.

195

00:20:27,000 --> 00:20:35,000

The moon illuminated the object. We could see the outline very distinctly.

196

00:20:35,000 --> 00:20:42,000

We could see the shadow on the ground underneath it, and my gosh, it looked like a football field.

197

The flying saucer controversy raged anew last month when hundreds of people around Hillsdale, Michigan

198

saw a series of strange objects or things. The county sure of there said this.

At the same time, we had six other cars out there and a University of Michigan professor.

They also observed the same thing, and everybody described the thing as the same. No stone to the darn things at all.

Do you have any ideas of what they might be?

I wish I did. I've had more phone calls here this morning, you take a stick at.

I'm going to have to call the government on this. We've got a lot of people who have seen this,

207

and there were 50 people who have seen it at different times, different intervals.

208

Everybody described the thing the same way.

209

00:21:51,000 --> 00:21:55,000

Do you think sherrithese might be visitors from outer space?

210

I don't even want to guess at this. I don't believe it yet, but I can't doubt my myth.

211

According to one of my officers this morning, he said, Sherrith, I've seen it, but I still don't believe it.

212

A co-edit at the University of Hillsdale saw the thing and described it like this.

213

Last night around 11.30 we'd been watching the storm that was taking place here.

And so we caused a civil defense because we'd been asked to call and give a direction in a time, and he called the police.

And as they drove up the Arb road, their red lights bothered whatever we were seeing, because it moved up and down into the right and left,

and the lights fluctuated even more.

220

And then they came back down the road, and the civil defenseman drove around the back of our dorm, and his lights shone across the Arb.

221

And this also bothered it because it became very bright, and then it became very dim, and it started to move back across the horizon.

222

00:23:10,000 --> 00:23:16,000

So we kept watching it, and the civil defenseman came up to our room to watch it, and he watched it for about a half an hour,

223

and he said it was, he would say it was definitely a UFO.

224

That civil defense director is William Van Horn. His report is considered by NICAP one of the most authoritative ever received.

225

Appeared out, looked out the open window. Here the UFO was approximately a thousand to fifteen hundred yards from us.

226

00:23:36,000 --> 00:23:44,000

I observed this with binoculars. To the right was a red light, and to the left was a white light.

227

00:23:44,000 --> 00:23:54,000

A red light at the time that I first observed it was a dim orange in color, and the white light was a quite dim white.

228

00:23:54,000 --> 00:24:05,000

The beacon from the airport sweeping over the area was coming around there, and the object seemed to get within a certain distance of the bottom portion of the beacon,

229

00:24:05,000 --> 00:24:12,000

an array of light, and became stationary. It appeared as if it were attempting to avoid this light

from the beacon.

230

00:24:12,000 --> 00:24:21,000

It would then remain there for just a few moments, and then start its descent back down, and as it were coming back down to the ground, approaching the ground,

231

the lights would become dim. This, in essence, is what we observed at that time, Tony, and through the binoculars I estimated the distance between the two lights to be approximately twenty to twenty-five feet.

232

The Air Force's chief UFO investigator is a Northwestern University Astrophysics professor named Jay Allen Heineck.

233

He went to Hellstead, investigated, and reported the citizens had seen swamp gas.

Whether Heineck was right or not, there are sure to be many co-eds and citizens of Hillsdale who'll remember that incident the rest of their lives.

235

For instance, Madeleine English, do you believe in UFOs?

236

About one o'clock I was looking out the window, and I saw a white glowing object with red lights, and it wasn't an airplane.

237

Yes, I believe in UFOs.

238

Joe Wilson, were you frightened?

239

00:25:13,000 --> 00:25:15,000

Of course I was frightened. Wouldn't you be?

I'm not sure.

241

Well, when you see something strange out your window, especially out of girl's dorm window, and lights, and you don't know what they are, you watch for two hours, you're frightened.

You've heard a series of UFO sightings that have been reported. Confused? If so, you're not alone.

244

In the next section of Spectrum 95, we try to get an answer to the simple question, what is it?

We've subtitled it, would you believe swamp gas? But now let's pause for the news.

The question, what is it? Seems simple on the surface. But with unidentified flying objects, it's complicated by the fact that there are no materials ever taken from a UFO, only reports of eyewitnesses.

250

The director of NICAP, Major Donald Kehoe, has little doubt what these things are. Here's his opinion.

251

00:26:23,000 --> 00:26:32,000

Now these have been evaluated, these sightings have been evaluated by our staff, by scientists, engineers, and their various fields.

252

00:26:32,000 --> 00:26:38,000

The majority conclusion is that these things are real and under intelligent control.

253

00:26:38,000 --> 00:26:53,000

Now in that group, which has reached that conclusion, there is another group, and it's the majority

of that one, which believes that these things must be extraterrestrial because they are so far superior to anything we have.

254

We have to base this on absolutely tracked speeds by radar, visual tracking, and combinations.

255

00:27:04,000 --> 00:27:17,000

Now either all of these witnesses, every one of them, all of the thousands of witnesses here and abroad are absolutely wrong, honestly wrong, but they're wrong.

256

00:27:17,000 --> 00:27:26,000

They're unable to distinguish what they see in the sky, I'm talking about pilots now. They cannot read radar scopes as well as they should.

257

00:27:26,000 --> 00:27:35,000

They can't track things with the semi-theodolites or modern tracking devices. They make mistakes. All of them are wrong.

258

00:27:35,000 --> 00:27:44,000

Not one single man is right or else these things are real, and there is secrecy and the facts for being withheld.

259

00:27:44,000 --> 00:27:54,000

Flying saucers arouse so much public interest, there are several organizations established, and many salaries paid to find out what they are or just to talk about them.

260

00:27:54,000 --> 00:28:04,000

Another who makes his living from flying saucers is the editor of a magazine called Flying Saucer News, published in California. James Mosley tells his opinion.

261

00:28:04,000 --> 00:28:14,000

These things are able to make right angle turns, they make no noise, such as our jets make, and they travel with speeds which are incredible even today.

262

00:28:14,000 --> 00:28:20,000

So I don't believe it's anything that we have here on Earth as far as the known Earth's governments are concerned.

263

00:28:20,000 --> 00:28:22,000

You're convinced this thinks?

264

00:28:22,000 --> 00:28:24,000

Absolutely solid odds, yes.

265

00:28:24,000 --> 00:28:25,000

Why?

266

00:28:25,000 --> 00:28:38,000

Because in some cases they've even bounced bullets off them. In many cases, teenagers out in California a couple of months ago shot at one of these things and heard the ping of the metal before the object took off.

267

00:28:38,000 --> 00:28:44,000

What might be there? U.F. all means unidentified flying object.

268

00:28:44,000 --> 00:28:55,000

Well, of course we think that it could be from another planet, but we can't prove it. It could be some part of our natural environment of the Earth, which is unknown to our present day science.

269

If I knew what flying saucers really were, I'd be proud to be Washington as an advisor to the government. I certainly don't know what they are.

270

00:29:02,000 --> 00:29:07,000

As we mentioned, the chief air force investigator is Dr. J. Allen Heineck.

271

00:29:07,000 --> 00:29:15,000

None of the evidence that I have examined would indicate any proof at all that we are being visited by extraterrestrials.

272

How many other explaining cases are there?

273

00:29:18,000 --> 00:29:22,000

Something like 646 out of 10,000.

274

00:29:22,000 --> 00:29:27,000

But you're confident there are explanations which just have not yet been discovered, sir?

275

00:29:27,000 --> 00:29:38,000

I think there's a whole spectrum of explanations and one should not jump either to saying something is utter bilge of nonsense or jump to the other conclusion that we are being visited.

276

00:29:38,000 --> 00:29:43,000

There are probably hypotheses and answers in between.

277

00:29:43,000 --> 00:29:48,000

But Keoh tells of a case he knows that convinces him flying saucers exist.

278

00:29:48,000 --> 00:30:04,000

This was a report by the commander of a Navy Super Constellation Transport, which was flying the Atlantic, from Newport, I mean from Europe, to Gander, bringing back Navy crews that have been on duty in the European area.

279

00:30:04,000 --> 00:30:16,000

They were flying at 19,000 feet and about 100 miles out of Gander when they saw some lights down and currently only surfs through water very close to it.

280

00:30:16,000 --> 00:30:27,000

The captain came back to take a look and immediately these lights spread out very rapidly and disappeared except for one which came straight up toward them and of course increasing in size.

281

00:30:27,000 --> 00:30:35,000

And when it got to their level it could be seen as a huge flying disk about 350 feet in diameter.

282

00:30:35,000 --> 00:30:43,000

They described it as roughly four times the diameter, four times the wingspan of the conic.

283

00:30:43,000 --> 00:30:50,000

This object came at them so rapidly that the commander and everyone in the cockpit thought they were going to be hit head on.

284

00:30:50,000 --> 00:31:03,000

It flipped to one side, passed the wing and came back so swiftly that no one knows whether it merely stopped and reversed or whether it made a lightning like turn and came back.

285

00:31:03,000 --> 00:31:09,000

At any rate, within a few moments it was back pacing this Navy transport.

286

00:31:09,000 --> 00:31:19,000

It did it for about 10 seconds and then it tilted up and climbed out of sight at a speed of about between two and three max.

287

00:31:19,000 --> 00:31:23,000

That was in 1956.

288

00:31:23,000 --> 00:31:35,000

I regard it as a special important case because this commander, they were all interrogated by Air Force Intelligence at Gander and later by Naval Intelligence when they got down to Patuxent.

289

00:31:35,000 --> 00:31:46,000

Two days later the commander was visited by a scientist from a super secret agency in Washington and that's as far as I'll go to claiming it but you can guess what it was.

290

00:31:47,000 --> 00:31:56,000

He had a folder of photographs, not sketches but photographs and he showed these to the commander and the commander said it wasn't just about like this one.

291

00:31:56,000 --> 00:32:08,000

He picked out a photograph of a fine disc and then he asked the scientist, said I had always thought this was nonsense until the other night we were scared to death by this thing.

292

00:32:08,000 --> 00:32:16,000

What's going on? And in effect the scientist said thank you commander and picked up these photographs and all that.

293

00:32:25,000 --> 00:32:34,000

In an effort to balance this program with all views, I asked the Air Force for a spokesman to present more of the official reaction to UFOs.

294

00:32:34,000 --> 00:32:45,000

I was told the Air Force has no spokesman because I was told every time a spokesman is put on the air or in print somebody tries to make the Air Force look silly.

295

00:32:45,000 --> 00:32:55,000

Incidentally the CBS television network will present a special program this summer concerning UFOs and the Air Force has named a spokesman for that program.

296

00:32:55,000 --> 00:33:04,000

I asked Lieutenant Colonel Hal Harlan, chief of the broadcasting branch of the Air Force Office of Information, why them and not us.

297

00:33:04,000 --> 00:33:15,000

He said they had promised to make the Air Force look good. That may be one of the few times a federal official has openly stated he will help those who make him or them look good.

298

00:33:15,000 --> 00:33:23,000

The Air Force did provide me with a 12-page pamphlet concerning their investigations which works under the code name Project Blue Book.

299

00:33:23,000 --> 00:33:26,000

From that pamphlet, this statement.

300

00:33:26,000 --> 00:33:40,000

To date, the firm conclusions of Project Blue Book are, 1. No unidentified flying object reported, investigated and evaluated by the Air Force has ever given any indication of threat to our national security.

301

00:33:40,000 --> 00:33:54,000

2. There has been no evidence submitted to or discovered by the Air Force that sightings categorized as unidentified represent technological developments or principles beyond the range of present-day scientific knowledge.

302

00:33:54,000 --> 00:34:03,000

And 3. There has been no evidence indicating that sightings categorized as unidentified are extraterrestrial vehicles.

303

00:34:04,000 --> 00:34:13,000

You'll recall that Al Chop was the information officer in the early 50s for the Air Force and he investigated about a dozen incidents during that time.

304

00:34:13,000 --> 00:34:20,000

What does he, personally and as a representative of no organization, what does he think they are?

305

00:34:20,000 --> 00:34:39,000

In the early days of this investigation, I was, like most everyone else, I was, I believe that a startling piece of news was eminent that we would find that these things were interplanetary spaceships.

306

00:34:39,000 --> 00:34:56,000

And the evidence at that time, at least the eyewitness sightings seemed to point that way and so

perhaps it was wishful thinking in a way because man is always intrigued about the possibility of intelligent life on other planets or from other star systems visiting us or,

307

00:34:56,000 --> 00:35:01,000

and perhaps giving us the benefit of a very advanced technology.

308

00:35:01,000 --> 00:35:15,000

However, the lack of these things to come to pass over the past 20 years, I am now quite convinced that this is a natural phenomenon of some sort that will continue.

309

00:35:15,000 --> 00:35:24,000

And I don't see any end to the controversy of whether they are interplanetary vehicles or not interplanetary vehicles.

310

00:35:24,000 --> 00:35:34,000

And I don't think anything can be proved from a scientific standpoint because there is a lack of material substance that can be analyzed.

311

00:35:34,000 --> 00:35:50,000

Dr. Bruce Rogers is Professor Emeritus of Mechanical Engineering from the University of Texas and incidentally a member of the Board of Governors of NCAP. What does he think?

312

00:35:50,000 --> 00:35:55,000

I mean there's no use of arguing about the matter, let's get some measurements if we can.

313

00:35:55,000 --> 00:36:03,000

We found most university professors in such fields as physics, astronomy and so on extremely reluctant to comment on flying saucers.

314

00:36:03,000 --> 00:36:08,000

Even some who told us flatly I don't believe in the things refused to say that on the air.

315

00:36:08,000 --> 00:36:15,000

There were several though who felt the public has a right to know how scientifically trained minds regard these UFOs.

316

00:36:15,000 --> 00:36:21,000

Such a man is Dr. Tom Hudson, Assistant Professor of Physics at the University of Houston.

317

00:36:21,000 --> 00:36:24,000

Again the simple question, what are they?

318

00:36:24,000 --> 00:36:36,000

Well certainly out of all of the observations that have been made there some people saw something and I don't know how much more than that you can see.

319

00:36:36,000 --> 00:36:46,000

Some of the observations have been made by people who were trained to make observations such as the Deputy Sheriff or in some cases say an airline pilot sees something.

320

00:36:46,000 --> 00:36:53,000

Someone else who's a trained observer but does not have a scientific background.

321

00:36:53,000 --> 00:37:09,000

The trouble with trying to then break this further down is that the person who's trying to analyze and discover what this object was that was seen has to take statements from a non-scientific person

322

00:37:10,000 --> 00:37:21,000

and extrapolate these statements into what he thinks the scientific explanation of what this individual saw could be.

323

00:37:21,000 --> 00:37:25,000

And the problems there are just insurmountable.

324

00:37:25,000 --> 00:37:35,000

In fact in any other form of scientific research this would be the, it wouldn't accept such an observation as being an invalid scientific observation.

325

00:37:35,000 --> 00:37:40,000

But this is the best you have in this case so you try to go from there.

326

00:37:42,000 --> 00:37:45,000

Richard Hall, Assistant Director of NICAP disagrees.

327

00:37:45,000 --> 00:37:59,000

A number of astronomers, physicists, chemists, mathematicians, biologists and other trained scientists including engineers have reported you pose.

328

00:37:59,000 --> 00:38:02,000

One section of our report will detail their sighting.

329

00:38:02,000 --> 00:38:07,000

The Director of Houston's Burke Baker Planetarium is Dr. Arman Iramatige.

330

00:38:07,000 --> 00:38:15,000

KPRC's Ray Norton spent quite a bit of time with this astronomer discussing what UFOs may or may

not be.

331

00:38:15,000 --> 00:38:25,000

Dr. Iramatige gave this answer to Ray's question of what are they and the answer is so complete it may stand as a basic lesson in flying saucer watching.

332

00:38:25,000 --> 00:38:30,000

By definition we say UFOs unidentified flying objects.

333

00:38:30,000 --> 00:38:42,000

Unidentified means that they must not be known celestial objects or known celestial phenomena or known natural phenomena.

334

00:38:42,000 --> 00:38:52,000

And of course in the planetary field, in the astronomical field, we know the celestial objects, what they might be.

335

00:38:52,000 --> 00:39:02,000

Many people report even meteors or bolides, that is very large meteors or fireballs that are seen in the sky.

336

00:39:02,000 --> 00:39:10,000

They stream through the sky and sometimes in red or blue or white or green, they're immense fireballs.

337

00:39:10,000 --> 00:39:20,000

They're not seen frequently but every now and then they do speak to the sky and they're large objects that strike through the Earth's atmosphere and burn up.

338

00:39:20,000 --> 00:39:25,000

And as they burn up, of course we see this tremendous glow. These of course are identifiable.

339

00:39:25,000 --> 00:39:36,000

We know and we can by good description and through several observations be able to identify these and therefore they are no longer UFOs.

340

00:39:36,000 --> 00:39:44,000

The reason I want to bring this up before answering your question more directly is because we do get a lot of calls.

341

00:39:44,000 --> 00:39:46,000

Does the planetarium get calls?

342

00:39:46,000 --> 00:40:01,000

Yes, we do get calls frequently about these things and also the Air Force frequently will call us when they get a report and they want to see if this report might have a celestial explanation, something astronomical.

343

00:40:01,000 --> 00:40:13,000

And so I just want to take advantage of this point right now and indicate some of the things that have been seen and are definitely celestial.

344

00:40:13,000 --> 00:40:18,000

Another important thing that is seen frequently is the planet Venus.

345

00:40:18,000 --> 00:40:24,000

The planet Venus is an extremely brilliant planet in the mornings.

346

00:40:24,000 --> 00:40:36,000

Now it can be seen before the sun rises around 5.30 in the morning and it's so extremely brilliant, so much more brilliant than any other star or other celestial object,

347

00:40:36,000 --> 00:40:43,000

that people frequently are just surprised at seeing this tremendously bright object in the eastern sky.

348

00:40:43,000 --> 00:40:55,000

And since the Earth rotates, it rises in the east and goes higher and higher in the sky until the sun comes up, so they see it move.

349

00:40:55,000 --> 00:41:02,000

And for the moment they might not be aware that the whole sky is moving because of Earth rotation.

350

00:41:02,000 --> 00:41:15,000

So this is another object that we frequently get, another object that is referred to as unidentified until they check and find that it could be the planet Venus.

351

00:41:15,000 --> 00:41:17,000

There are other celestial objects.

352

00:41:17,000 --> 00:41:25,000

A person, for example, noticed that there was a star close to the moon and a few hours later the star was at a different place in the sky with respect to the moon.

353

00:41:25,000 --> 00:41:36,000

The reason for this is that the moon revolves around the Earth and over a period of one hour an object will move one Earth diameter away from its previous position.

354

00:41:36,000 --> 00:41:44,000

That is, the moon is moving toward the east. The star would move to the west from the moon, one moon diameter every hour.

355

00:41:44,000 --> 00:41:51,000

And so these objects are seen to move and again they cannot explain what it is.

356

00:41:51,000 --> 00:41:59,000

And of course here's a known object, just a star, and the motion of the moon causes it to move that way.

357

00:41:59,000 --> 00:42:06,000

Other objects that people see are satellites such as the Echo 1 and 2 in Pegasus.

358

00:42:06,000 --> 00:42:17,000

Some are going in a polar orbit, that is moving roughly north and south, and others east to west direction are vice versa.

359

00:42:17,000 --> 00:42:23,000

So these are moving star-like objects, some go rather brilliantly.

360

00:42:23,000 --> 00:42:27,000

Are there particular times in the orbit when the sun will catch them and make them blend?

361

00:42:27,000 --> 00:42:35,000

Exactly. In fact, that's another thing that makes them strange. They expect to see it lit up from one horizon to the other.

362

00:42:35,000 --> 00:42:42,000

But it might be that a satellite will glow close to the horizon and then blink off because it goes into the Earth's shadow.

363

00:42:42,000 --> 00:42:55,000

Others will glow only while they're close to the zenith because they're low enough that only when they are at a high point will the sun's glow reflect on them.

364

00:42:55,000 --> 00:42:58,000

And others of course at different portions of the orbit will glow.

365

00:42:58,000 --> 00:43:04,000

So these objects that seem usually will occur only once, it will not blink twice.

366

00:43:04,000 --> 00:43:09,000

While its eclipse will be dark, it will brighten and then of course become dark again.

367

00:43:09,000 --> 00:43:22,000

So satellites is another celestial phenomenon that's frequently misinterpreted because people do not look up the sky enough and realize what some of the things can be.

368

00:43:22,000 --> 00:43:35,000

And of course as we said meteors and bowlides are moving very quickly and there are not too many bowlides, but nevertheless that is frequently reported.

369

00:43:36,000 --> 00:43:47,000

Jupiter is a very brilliant one. It does not twinkle. None of the planets when they're relatively high in the sky twinkle only when they're low in a close to the horizon do planets twinkle.

370

00:43:47,000 --> 00:44:04,000

Stars twinkle. So twinkling objects usually are stars and if they're, give a study like they're planets, Jupiter at times because people don't realize that the planet can be so bright is reported as an unknown.

371

00:44:05,000 --> 00:44:13,000

Now getting to your initial question, which I avoided, with good reason.

372

00:44:13,000 --> 00:44:18,000

What are these UFOs?

373

00:44:18,000 --> 00:44:27,000

These that cannot be identified as natural phenomena, either celestial or meteorological, that is a weather type of thing.

374

00:44:28,000 --> 00:44:32,000

I might mention before going to this, you see I'm trying to avoid your question.

375

00:44:32,000 --> 00:44:45,000

A sun dog is another object that can be seen during the daytime. There's a halo, sometimes two halos around the sun.

376

00:44:45,000 --> 00:44:58,000

And sometimes one tiny portion of this halo, 22 or 46 degrees away from the sun, this is a tiny portion of it glows and it may be red or some other color of the rainbow are just white.

377

00:44:58,000 --> 00:45:09,000

And so it appears that these two angles from the sun, it's due to refraction from the high ice particles in the sky.

378

00:45:09,000 --> 00:45:14,000

So sometimes these appear as unknown objects.

379

00:45:14,000 --> 00:45:25,000

In other words, you would say that a great percentage of the many thousands of sightings can be contributed to astronomical and celestial phenomena.

380

00:45:25,000 --> 00:45:32,000

Yes. In fact, recently you might have heard of this object that struck a car on Highway 10.

381

00:45:32,000 --> 00:45:33,000

That's right.

382

00:45:33,000 --> 00:45:37,000

We don't know what it was. We investigated it.

383

00:45:37,000 --> 00:45:44,000

We searched through all the areas where the grass was relatively sharp, but there are areas that have cat tails and deep grass.

384

00:45:44,000 --> 00:45:48,000

And so the object might have ricocheted into off the road.

385

00:45:48,000 --> 00:45:50,000

And so we cannot report on that.

386

00:45:50,000 --> 00:45:53,000

But that could have been a meteorite.

387

00:45:53,000 --> 00:45:57,000

And of course it was in hopes that it was that we did this search.

388

00:45:57,000 --> 00:46:11,000

But now once we eliminate all these, and that's where maybe several many thousands of these objects end up as being, we arrive at these that are unidentified.

389

00:46:11,000 --> 00:46:18,000

Really cannot be explained by science today.

390

00:46:18,000 --> 00:46:26,000

There was one, for example, two colonels saw they were command pilots working in the Pentagon and it's reported in Project Blue Book.

391

00:46:26,000 --> 00:46:32,000

They saw two objects, two Delta Wing objects streamed by them extremely fast.

392

00:46:32,000 --> 00:46:36,000

And they knew that the speed of these, they know the Delta wings.

393

00:46:36,000 --> 00:46:39,000

They knew the F-86 is perfectly well.

394

00:46:39,000 --> 00:46:42,000

And this I think was in 1952.

395

00:46:42,000 --> 00:46:45,000

It was during the around three o'clock in the afternoon.

396

00:46:45,000 --> 00:46:50,000

And yet they were going towards Salt Lake City over Carson Sink in Nevada.

397

00:46:50,000 --> 00:46:55,000

Yet they knew that nothing, the no airplane could have gone at that speed.

398

00:46:55,000 --> 00:46:58,000

They saw no canopy or tail on it.

399

00:46:58,000 --> 00:47:01,000

This was going at a tremendous speed by their plane.

400

00:47:01,000 --> 00:47:03,000

They worked for the Pentagon.

401

00:47:03,000 --> 00:47:08,000

They knew perfectly well how to recognize anything that the United States has in the air.

402

00:47:08,000 --> 00:47:14,000

These two objects streamed by them extremely fast speed and took a slight bank and then disappeared.

403

00:47:14,000 --> 00:47:20,000

There were no known F-86s or other possible airplanes that could have been that close to them.

404

He recently talked about men from other worlds.

As the reports of the green men came to UFOs, the great majority of these reports are in the hoax category.

439

writing books about his fanciful trips to various planets in flying saucers

He investigated this man quite thoroughly because of all the stir that he created

He claimed at one time to be an astronomer from Mount Palomar.

Now this is rather impressive on the face of it, but it turns out that he was located at Mount Palomar

and he had a telescope, but the telescope was parked right outside his hamburger stand.

447

This is unfortunately the sort of thing we do run into.

448

However, there is at least one case of a reported occupant of UFO, which seems quite substantial.

The Air Force agrees with us that the case is definitely not explainable as anything conventional.

It occurred in April of 64 in Socorro, New Mexico, where a highly respected police officer

who had had quite a bit of experience tracking meteors with the New Mexico Institute of Meteoritics

reported seeing two small suited occupants near a UFO, which after it left imprints in the ground

and scorch marks on the mesquite bushes and the earth.

Dr. Heineck, the Air Force investigator, was on the scene and our man was on the scene.

455

And when Dr. Heineck left, he admitted openly that he was more puzzled than when he had arrived.

So this is perhaps the only case where an occupant of one of these craft has been reported,

They've been down.

I was reading those reports which, well, I first heard that, I thought it was nonsense.

What could cause this?

if there is such a thing as a flying saucer?

Here we're making conjecture now that there are solid objects.

I'd say a phenomena, it could be a source of light or it could be energy in the atmosphere.

Maybe perhaps there's a function of something that comes from the sun.

I don't know what you can say is that maybe, I think that geologically there are some other forms of energy.

I don't know the form or context it takes, but I have heard of the concept of ball lightning,

which is a glowing circular ball of some type of plasma that may have been observed in our atmosphere.

But what it is, what causes it, where it goes, I don't think that it's generally known or accepted any particular theory.

As you heard earlier, one of the charges that Major Donald Kehoe has leveled against the Air Force is secrecy.

All of them are wrong.

502

Not one single man is right or else these things are real.

And there is secrecy and the fact you're being withheld.

504

Major, do you believe that the Pentagon knows about whatever the truth here is, that the President also must inevitably know about it?

505

And therefore the President is at the top, the one who is responsible for not letting the public have the facts.

506

Can there be any other suggestion in what you say?

507

I don't believe it's absolutely certain that the President has all these details, because I remember back to when President Truman called for a briefing

508

during some excitement during his second administration, I believe it was.

509

He had known nothing about it except what he read in the newspapers, according to what this intelligence associate told me.

And this captain, it was Captain Edward Ruppelhead of the Project at that time.

He gave the President a thorough briefing and said that they didn't find any definite proof that these were or were not space devices.

They certainly didn't see any evidence of hostility.

Therefore they weren't too much concerned.

514

That was however doing their work concerned because there was a terrific outbreak of fighting at that time and they were all over the, the headlines all over the country.

515

Since the Air Force would not provide us with a spokesman to answer this charge, we had to look elsewhere for an answer.

516

We want to make this report as objective and unbiased as possible.

517

Well, a nightcap provided the answer, a tape recording from 1961 when the Air Force did have a spokesman, then Major William Coleman, who had this to say about the secrecy charges.

Again, let me remind you that this was five years ago.

There's no truth to the charges and allegations that the Air Force is withholding information from the public on this subject.

520

We do in some cases withhold the names of the people involved in the sightings because it would attract the idle curiosity of sensation seekers.

521

In some limited instances we will withhold information on our investigative techniques because we use these techniques to evaluate other intelligence information.

522

And finally, we withhold information in some limited instances because we could possibly reveal sensitive areas within our air defense system.

In any case, withholding of information is done for strictly legitimate security reasons.

524

Al Chopp was among the first to take part in Air Force investigations. We asked him about the secrecy charge.

525

Well, I don't think that the Air Force does put out the sightings on a regular basis, and I don't know the reasoning why they don't.

526

00:59:13,000 --> 00:59:23,000

I know we did not when I was with the project. The person making inquiry had to be specific about which sighting he wanted the details on.

527

If he could do this, we would give him the details.

528

All of the details?

529

00:59:27,000 --> 00:59:32,000

All of the details pertaining to a particular sighting that he had to identify.

530

However, most of the sightings in those days at least were made by pilots and military personnel.

And of course, the general public didn't know they had been made or reported.

532

But I don't think the Air Force is deliberately withholding information.

533

I think the information is not forthcoming simply because the Air Force doesn't have it.

534

I don't think that the Air Force had the answer to this. In the evening, they would be more than

happy to scratch it off their books and explain it to the public.

Dr. Tom Hudson from the University of Houston then made this logical observation.

536

I can say no advantage to the Air Force to withhold information.

537

If it were a foreign country's device, then the Air Force could probably get money to build one of their own from Congress if they could show that somebody else had one of these.

538

If we didn't get one, we were going to be behind.

539

If it were from outer space, well, we could perhaps get more money in the space budget to make contact with these alien beings and look at all of the scientific advancement they could provide us.

All the money we would save about taking advantages of their progress.

541

Our examination of the flying saucer flap has been, by necessity, a brief one, and we only skim the surface of officials.

542

But in all fairness, it should be pointed out that we did not encounter any Air Force secrecy in our investigation.

543

We did note several curious quirks that, in my opinion, could be changed to the betterment of all concerned.

544

First, for information on Project Blue Book, we call the project's headquarters at Wright-Patterson Air Force Base in Dayton, Ohio.

They were cordial, but when I said I am a newsman, Project Blue Book referred me immediately to their information officer.

546

01:01:25,000 --> 01:01:35,000

This, I found out in a moment, was not at Wright-Patterson, where the investigations are being conducted, but at the Pentagon in Washington, D.C., nearly 400 miles away.

547

01:01:36,000 --> 01:01:43,000

Not even at the Pentagon is there a Project Blue Book officer, but the reports are disseminated through the Air Force Information Office.

548

01:01:43,000 --> 01:01:54,000

Since almost every Air Force base in the world has its own staff of information officers, this seems a strange departure from the normal, especially because of the high interest of this project.

549

01:01:54,000 --> 01:01:59,000

The Air Force did provide me with their Project Blue Book, which was a disappointment.

550

01:01:59,000 --> 01:02:07,000

It's only 12 pages long. Of those, one page is devoted to listing those materials which the Air Force no longer has available.

551

01:02:07,000 --> 01:02:13,000

One page is a list of suggested reading material on astronomy, physics, and UFOs.

552

01:02:13,000 --> 01:02:20,000

Incidentally, this may be part of the bad blood between Nikeap and the Air Force, because Donald Keeho's books are not listed.

553

01:02:20,000 --> 01:02:27,000

Two pages of Project Blue Book are given over to sightings of meteors, and the last page is blank.

554

01:02:27,000 --> 01:02:38,000

The seven remaining pages of Project Blue Book are a description of the Air Force's program and a statistical summary, but no specifics, on UFOs since 1947.

555

01:02:38,000 --> 01:02:49,000

In comparison, Nikeap's book entitled The UFO Evidence is nearly 200 pages long, contains 200,000 words and many specific examples.

556

01:02:49,000 --> 01:02:53,000

The Air Force's free Nikeap's cost \$5.

557

01:02:54,000 --> 01:02:57,000

More in a moment.

558

01:02:57,000 --> 01:03:22,000

What can be done to find out the origin, whether earth-locked or extraterrestrial, of these mysteries?

559

01:03:22,000 --> 01:03:35,000

There are several plans, some reasonable, some, well, for instance, a retired Army Major named Wayne Ahos says he is negotiating to place observers in the 600-foot-high Space Needle at the Seattle World's Fair site.

560

This former Army Intelligence Officer says he plans to place two spotters armed with telescopes or binoculars on both sides of the tower and keep them on duty night and day to look for flying saucers.

561

Is the Air Force currently doing a competent job of investigating?

562

01:03:51,000 --> 01:03:55,000

Congressman George Miller, Chairman of the House Space Sciences Committee says yes.

563

01:03:55,000 --> 01:04:02,000

Congressman Mendel Rivers, Chairman of the House Armed Services Committee says yes, and this rules out a congressional hearing on the matter.

564

01:04:02,000 --> 01:04:05,000

So we ask Arman Iromadege.

565

01:04:06,000 --> 01:04:23,000

Should I think that the Air Force is being concerned with the defense of our country and certainly wishing to advance our scientific knowledge as much as possible of anything that can possibly be seen in the sky?

566

That branch of government that could best handle this investigation.

567

01:04:30,000 --> 01:04:47,000

However, I do think that possibly a committee at congressional level, that is possibly appointed by the President or Congress, should have the right to, would actually be the body that would determine policy, overall policy.

568

And the Air Force should be the one to carry out the studies. They're the best qualified. They certainly have the personnel, and I think they're the ones that should do it.

569

Dr. Rogers of the University of Texas feels differently.

Do you think another government agency besides the Air Force would be better qualified to investigate?

571

Personally, I'd rather not have the government in it at all.

572

You think private organizations such as NK?

573

01:05:12,000 --> 01:05:16,000

Private organizations, because as soon as you get into a government, then you've got politics.

How old is Trump?

575

I think the Air Force is doing everything it can and everything that is possible.

576

You have to remember you're dealing with citing reports. You're not dealing with objects or something that's a physical matter that you can hold in your hand or analyze or put under a microscope, a measure.

577

These are things that scientists need to do in order to tell you definitely what these things are.

578

01:05:44,000 --> 01:05:58,000

I think on the basis of investigating citing reports verbal from people and the scattering of still pictures, the Air Force is doing everything humanly possible.

579

And they certainly are doing it in a serious vein. I don't think they mean to ridicule anybody, but it's kind of an impossible task.

580

Tom Hudson.

581

My own opinion is they're doing as good as anyone else and probably better than most would do because of the vast physical facilities that are already in place that they can call on to track an object if it makes a radar pattern,

582

or they can call on a fast fighter to go up and see what this object is or if there's an object in this particular point in the sky that's been observed and no other federal agency could do this without going through somebody.

583

Here's how the Air Force investigated the Brasoria County episode.

Major Leeds come down from Ellington and he brought an artist with him.

585

We went over to that area. They drew a whole sketch out of the area, but everything that was there through the craft as we described it and the facilities that we described it.

586

They took a bunch of radiological readings over there. They didn't mind in fact. We had had a couple of showers of rain since then.

587

01:07:17,000 --> 01:07:33,000

The area was scrutinized very thoroughly by them and they took statements from Mr. Goode and

myself.

588

01:07:33,000 --> 01:07:44,000

This was on the floor there to ride Patterson, a professor hiding in Carl Meade on the telephone. I spent probably an hour on the phone with him going over all this.

589

01:07:44,000 --> 01:07:54,000

He was trying to link all of the degrees in our position and how we saw it.

590

01:07:54,000 --> 01:08:05,000

This has been the last I've heard of them, but those people treat us very nice.

591

01:08:05,000 --> 01:08:22,000

We're just as concerned about this thing as we were and I couldn't ask for any more cooperation or any better investigation than I know of.

592

01:08:22,000 --> 01:08:31,000

The Air Force plans to delve into its investigation even more thoroughly. Dr. Heindig says he will pick a score of unexplained cases for closer scrutiny.

593

01:08:31,000 --> 01:08:43,000

I picked some 20 cases. Nothing particular about 20 is a number, but just I thought let's see what are some that have not been explained and which have possible scientific fader in them.

594

And I think those I would recommend that they be looked at quite closely.

595

The flying saucer flap has flapped so loudly recently that the secretary of the Air Force has been stirred to action.

596

A civilian board to investigate the Air Force's investigations in an attempt to determine whether charges by Kehoe and others are valid.

597

01:09:03,000 --> 01:09:12,000

There's a lot of discussion this morning, Mr. Secretary, about a civilian board that would pick out some of the more interesting cases to investigate. How's that going to work?

598

01:09:12,000 --> 01:09:22,000

The Air Force has a civilian scientific advisory board. We've had a panel of that board examine the way that we've been handling these investigations and they say they're quite satisfied,

599

01:09:22,000 --> 01:09:33,000

but they think that there may be some more scientific data to gain by making an investigation in further depth by some such panel and I'm certainly willing to consider that.

600

01:09:33,000 --> 01:09:36,000

I think it may be very desirable to do.

601

Does that mean you're going to go ahead with a civilian group?

602

01:09:39,000 --> 01:09:43,000

We have already and I think we will continue it and perhaps expand it.

603

A final observation on this flying saucer flap of 20 years. When I contacted the Air Force Information Office while investigating the charges by Major Kehoe,

604

I confronted Lieutenant Colonel Harlan of the Pentagon with Kehoe's statements. Harlan said that Kehoe is a private citizen and entitled to his views like everybody else.

605

Kehoe is not only a private citizen. He heads the largest private organization in the country investigating these reported sightings.

606

01:10:10,000 --> 01:10:16,000

In addition, he is a retired military officer, a pilot, and a firm believer in flying saucers.

607

Perhaps he has gone too far in stating without sufficient scientific evidence that these things are from outer space,

608

but it seems the nation might be better served if this private organization and the Air Force were to patch up their differences,

609
