Betty Hill was actually aboard a UFO.

7

00:00:26,240 --> 00:00:35,640

She was the subject of a book by John G. Fuller called The Interrupted Journey, which was published in 1966.

8

Betty is a retired social worker from New Hampshire.

9

00:00:39,200 --> 00:00:46,240

She has been devoting the last two years to full-time UFO research and has made a number

10

of very interesting discoveries, had some incredible experiences, and it's really an

11

honor to be here to introduce Betty Hill.

Thank you, George.

It's my pleasure to be with you tonight.

14

And first of all, I'm going to start out telling you about my capture, which happened on September

15

19, 1961.

00:01:16,920 --> 00:01:23,480

On that night, my husband Barney and I were returning from Montreal.

17

00:01:23,480 --> 00:01:29,640

We left there late afternoon, and then about 10 o'clock that night we stopped in a town

18

00:01:29,640 --> 00:01:33,160

called Colbrook, New Hampshire.

19

00:01:33,160 --> 00:01:40,480

We stopped and had a lunch and had gas put in the car because we knew we would be going.

20

00:01:40,480 --> 00:01:44,920

We just had a complaint that people can't see, Betty, so.

21

00:01:44,920 --> 00:01:50,920

We don't want this disembodied voice booming out over all of you.

22

00:01:50,920 --> 00:01:51,920

Okay.

23

00:01:51,920 --> 00:01:58,320

So as I was saying, we stopped in Colbrook and had a lunch and had gas put in the car

24

because we knew we'd be heading down Route 3 through the White Mountain National Forest.

25

00:02:05,920 --> 00:02:12,920

Since it was September 19, a Tuesday night, beautiful night, the moon was bright, almost

26

full, very few clouds in the sky, and Barney and I was having a very pleasant drive home

27

to Portsmouth, New Hampshire.

28

00:02:22,360 --> 00:02:29,080

All of a sudden, I saw what I thought was a new star in the sky.

29

00:02:29,080 --> 00:02:32,480

While I'm watching this, it began to move.

30

00:02:32,480 --> 00:02:35,520

So we knew it was a satellite.

31

00:02:35,520 --> 00:02:41,240

So we stopped the car to get out with a binoculars to look at the satellite.

32

00:02:41,240 --> 00:02:46,480

And while we're watching this, it turned and started to come in towards us.

33

00:02:46,480 --> 00:02:48,960

So we knew it was not a satellite.

34

00:02:48,960 --> 00:02:51,480

So we're driving along, Barney's driving.

35

00:02:51,480 --> 00:02:59,600

I'm watching this through the binoculars, very unusual zigzagging, acting like a yoyo,

36

00:02:59,600 --> 00:03:00,600

going up and down, spinning.

37

00:03:00,600 --> 00:03:07,560

And it did this for about 30 miles until we came to an area called Indian Head.

38

At this point, this object left the top of the mountain, came out over the highway directly

39

in front of the car, and stopped.

40

00:03:16,920 --> 00:03:21,400

We could see a double-row window, a red light on each side.

41

At this point, Barney decided he's going to get out and identify this object.

42

00:03:28,760 --> 00:03:32,600

So he took the binoculars and stepped away from the car.

43

00:03:32,600 --> 00:03:37,600

Then he did the object shifted out over the field.

44

00:03:37,600 --> 00:03:44,080

Barney walked towards it, looking up, and he could see human-like figures standing in

45

00:03:44,080 --> 00:03:47,160

the window, looking down at him.

46

00:03:47,160 --> 00:03:52,560

And he had the impression that one said to him, as he looked up through the binoculars,

47

keep looking.

48

00:03:55,160 --> 00:03:57,160

Just keep looking.

49

00:03:57,160 --> 00:03:58,160

Don't be afraid.

50

00:03:58,160 --> 00:04:00,600

You're going to be all right.

51

00:04:00,600 --> 00:04:02,760

No harm's going to come to you.

52

00:04:02,760 --> 00:04:03,760

Just keep looking.

53

00:04:03,760 --> 00:04:08,080

And at that moment, the craft began to descend.

54

00:04:08,080 --> 00:04:13,120

And Barney panicked, feeling they planned to capture him.

55

00:04:13,120 --> 00:04:17,160

He came tearing back to the car, saying we had to get out of there.

56

00:04:17,160 --> 00:04:19,720

They were going to capture us.

57

00:04:19,720 --> 00:04:24,240

He put the car into gear, and we went speeding down the highway.

58

00:04:24,240 --> 00:04:30,800

Barney said when he came back, the craft had followed and was now over the car.

59

00:04:30,800 --> 00:04:31,800

So I looked up.

60

00:04:31,800 --> 00:04:34,240

I looked out the window.

61

00:04:34,240 --> 00:04:37,960

I couldn't see the stars or the sky or the moon.

62

00:04:37,960 --> 00:04:41,040

All I could see was something black.

63

00:04:41,040 --> 00:04:46,800

And at that point, there was a series of beeping sounds, and the car vibrated.

64

00:04:46,800 --> 00:04:48,600

And Barney and I stopped talking.

65

00:04:48,600 --> 00:04:49,600

We drove along.

66

00:04:49,600 --> 00:04:54,160

There were spots that I recognized that were familiar to me.

67

00:04:54,520 --> 00:04:56,120

Barney left Route 3.

68

00:04:56,120 --> 00:04:57,120

I was puzzled.

69

00:04:57,120 --> 00:05:01,520

I didn't understand this, but I wasn't too concerned.

70

00:05:01,520 --> 00:05:06,520

He turned onto Route 175 and was still speeding along.

71

00:05:06,520 --> 00:05:12,760

When all of a sudden Barney slammed on the brakes, the car came to a screeching halt,

72

00:05:12,760 --> 00:05:16,560

and he made a very sharp left turn.

73

00:05:16,560 --> 00:05:20,080

The next thing that I could remember was driving along.

74

00:05:20,080 --> 00:05:23,160

We're back on Route 3.

75

00:05:23,160 --> 00:05:27,560

And I said to Barney, do you believe in flying saucers?

76

00:05:27,560 --> 00:05:30,760

And Barney said, don't be ridiculous.

77

00:05:30,760 --> 00:05:37,800

And at that point, we heard another series of beeping sounds, and we drove home.

78

00:05:37,800 --> 00:05:42,240

Now when we arrived home, there were several things that puzzled us.

79

00:05:42,240 --> 00:05:45,560

Both our watches had stopped functioning.

80

00:05:45,560 --> 00:05:48,440

The tops of Barney's shoes were scuffed.

81

00:05:49,160 --> 00:05:55,960

There were highly polished spots on the trunk of the car, and it had taken us seven hours

82

00:05:55,960 --> 00:06:05,000

to drive 190 miles late at night, some of it chimp-piked driving, with speeds of 65 and

83

00:06:05,000 --> 00:06:10,000

70, no traffic, no police, and Barney a fast driver.

84

00:06:10,000 --> 00:06:12,240

So these things puzzled us.

85

00:06:12,240 --> 00:06:15,360

However, this was 61.

86

00:06:15,360 --> 00:06:22,480

We both said that we were going to keep this whatever happened to us very quiet.

87

00:06:22,480 --> 00:06:24,400

We're not going to tell people.

88

00:06:24,400 --> 00:06:31,280

However, we did talk with some members of my family, and a policeman told us that anyone

89

00:06:31,280 --> 00:06:38,000

who had seen a strange craft should report it to P's Air Force Base, which is located

90

00:06:38,000 --> 00:06:39,280

in Portsmouth.

91

00:06:39,280 --> 00:06:44,320

So we did call P's and made this report.

92

00:06:44,320 --> 00:06:50,680

Then Barney and I started on a search to find out what we could about UFOs, because neither

93

00:06:50,680 --> 00:06:53,000

one of us knew anything.

94

00:06:53,000 --> 00:06:59,920

We get books out of the library, and in one book it said, if you've had a contact, seen

95

00:06:59,920 --> 00:07:03,000

a UFO, write to this address.

96

00:07:03,000 --> 00:07:09,000

So we did, with the result that Walter Webb came out to interview us.

97

00:07:09,000 --> 00:07:12,280

And he wrote up the experience, which we told him.

98

00:07:12,280 --> 00:07:16,920

And then later two other scientists came, and they started pointing out why did the

99

00:07:16,920 --> 00:07:21,080

trip taker so long to come home.

100

00:07:21,080 --> 00:07:26,080

They suggested the possibility of regressive hypnosis with a good psychiatrist.

101

00:07:26,080 --> 00:07:35,360

Well, it was a good suggestion, but we were beginning to live with the experience, and

102

00:07:35,360 --> 00:07:39,840

leading a normal life every day.

103

00:07:39,840 --> 00:07:47,200

Right after Thanksgiving, I came down with pneumonia.

104

00:07:47,200 --> 00:07:56,680

And within three years, I was under treatment with my medical doctor six times for pneumonia.

105

00:07:56,680 --> 00:08:03,680

Also at the same time, Barney started having serious health problems.

106

00:08:03,680 --> 00:08:06,000

His blood pressure was fluctuating.

107

00:08:06,000 --> 00:08:10,360

He developed a very severe ulcer, and he just didn't feel well.

108

00:08:10,360 --> 00:08:12,360

He was sick all the time.

109

00:08:12,360 --> 00:08:15,560

So he wasn't responding to treatment.

110

00:08:15,560 --> 00:08:21,960

His doctor suggested that maybe his problem had an emotional basis, and had Barney go

111

00:08:21,960 --> 00:08:25,640

in and talk with a friend of his who was a psychiatrist.

112

00:08:25,640 --> 00:08:29,760

So Barney started going to Dr. Stevens on a regular basis.

113

00:08:29,760 --> 00:08:36,880

One day he happened to remember this experience in the mountains and told Dr. Stevens, who

114

00:08:36,880 --> 00:08:45,200

thought that we should go and have this period that we could not remember opened up by hypnosis.

115

00:08:45,200 --> 00:08:51,440

And he transferred, referred Barney and I both, to Dr. Benjamin Simon in Boston.

116

00:08:51,440 --> 00:08:58,640

Now Dr. Benjamin Simon is probably one of the top psychiatrists in the United States,

117

00:08:58,640 --> 00:09:00,640

possibly in the world.

118

00:09:00,640 --> 00:09:08,880

He had a movie made of his treatment of servicemen returning from World War II and the methods

119

00:09:08,880 --> 00:09:13,400

that he used to get them back into good mental health.

120

00:09:13,400 --> 00:09:19,520

So he was a man who was very well known and well respected, teaches psychiatry in the

121

00:09:19,520 --> 00:09:23,520

past at Tafts, Harvard, Nauraria.

122

00:09:23,520 --> 00:09:29,680

So Barney and I started going to him every Saturday morning for two hours.

123

00:09:29,680 --> 00:09:37,320

We were hypnotized separately, and at the end of each session Dr. Simon gave us amnesia.

124

00:09:37,320 --> 00:09:43,560

So we did not know what we were saying under hypnosis so we could not discuss it with each

125

00:09:43,560 --> 00:09:44,560

other.

126

00:09:44,560 --> 00:09:51,480

At the end of the hypnosis Dr. Simon played the tapes back to us, which opened up our

127

00:09:51,520 --> 00:10:00,520

amnesia, in which Barney and I both told the same experience but from our own viewpoint.

128

00:10:00,560 --> 00:10:06,200

So let's go back now to Barney, bringing the car to a screeching stop, taking the left

129

00:10:06,200 --> 00:10:07,200

hand turn.

130

00:10:07,200 --> 00:10:13,200

And this is the point, at that point, this is where we could not remember.

131

00:10:13,200 --> 00:10:20,200

All right, we went around the curve and there was a group of men standing in the road.

132

00:10:21,600 --> 00:10:28,600

Barney stopped the car, the motor died, he was trying and trying to get the car to start.

133

00:10:28,600 --> 00:10:30,100

It won't.

134

00:10:30,100 --> 00:10:37,100

The men in the road separate, come up on each side of the car and at that moment I panicked.

135

00:10:37,360 --> 00:10:44,200

I tried to get the car door open, I'm going to get out and run and hide in the woods.

136

00:10:44,200 --> 00:10:49,960

Just then the door opened wide and five were standing there.

137

00:10:49,960 --> 00:10:56,960

One put his hand out over my eyes and I went into a sleep-like state.

138

00:10:57,480 --> 00:11:02,960

The next thing, of which I was consciously aware, was I had the feeling I got to wake

139

00:11:02,960 --> 00:11:08,000

up, I got to wake up and I'm struggling and struggling.

140

00:11:08,000 --> 00:11:14,000

And finally my eyes opened and I looked down and I'm walking in the woods.

141

00:11:14,760 --> 00:11:21,360

And there are two in front of me, one on each side of me, then two behind me and I turned

142

00:11:21,360 --> 00:11:27,480

around and looked and here is Barney and two are helping him along.

143

00:11:27,480 --> 00:11:29,920

He's like he's sleepwalking.

144

00:11:29,920 --> 00:11:36,920

And I turned around and I said, Barney, for heaven's sakes, wake up, Barney.

145

00:11:36,960 --> 00:11:41,640

And the one standing here is his name, Barney.

146

00:11:41,640 --> 00:11:48,640

And I said, it's none of your business.

147

00:11:51,480 --> 00:11:55,200

And I'm still saying, Barney, Barney, wake up.

148

00:11:55,200 --> 00:12:02,200

So then we, going through the path in the woods and suddenly the clearing and here is

149

00:12:02,280 --> 00:12:06,920

the craft that we've seen in the sky, it's on the ground.

150

00:12:06,920 --> 00:12:13,920

And at this moment I stopped walking and the one standing here said, go on, don't be afraid,

151

00:12:13,920 --> 00:12:18,680

you're going to be all right, we're not going to harm you.

152

00:12:18,680 --> 00:12:23,760

All we want to do is some simple tests and then you're going to be on your way home.

153

00:12:23,760 --> 00:12:26,200

You be safe, go on.

154

00:12:26,200 --> 00:12:28,880

And I said, no.

155

00:12:28,880 --> 00:12:34,680

And so they started pulling and I'm fighting and they're pulling and I went on because

156

00:12:34,760 --> 00:12:36,960

it was a bit more of them.

157

00:12:36,960 --> 00:12:38,000

I had no choice.

158

00:12:38,000 --> 00:12:45,000

I was dragged on and up a ramp and there was a corridor that went around the inside or

159

00:12:46,800 --> 00:12:51,120

the outside wall and this corridor was dark, no lights.

160

00:12:51,120 --> 00:12:58,120

And as you go in and there was an oval shaped door and a brightly lighted room in the back

161

00:12:58,120 --> 00:12:59,200

of this.

162

00:12:59,200 --> 00:13:03,880

They took me into the first room and Barney into the second room.

163

00:13:03,880 --> 00:13:09,000

And I objected to this, I wanted them to bring Barney into the same room with me.

164

00:13:09,000 --> 00:13:15,440

And the one I called the leader said, we only have equipment to do one in a room at a time,

165

00:13:15,440 --> 00:13:17,560

it will be quicker this way.

166

00:13:17,560 --> 00:13:24,560

So I agreed to this and I was taken in, sat on a stool and my eyes, ears, nose, throughout

167

00:13:25,080 --> 00:13:29,240

were examined.

168

00:13:29,240 --> 00:13:36,240

They took clippings of my hair, my fingernails, scraping of my skin.

169

00:13:36,240 --> 00:13:40,640

And at this point there was the leader and then the one I called the examiner did the

170

00:13:40,640 --> 00:13:41,640

testing.

171

00:13:41,640 --> 00:13:47,480

Now they took a microscope or what I would consider a microscope, kept looking at my

172

00:13:47,480 --> 00:13:51,840

skin and they were very, very excited.

173

00:13:51,840 --> 00:13:58,080

The examiner would look and the leader would look and they turned and they were talking

174

00:13:58,080 --> 00:14:01,840

among themselves with great, great excitement.

175

00:14:01,840 --> 00:14:07,120

So then they finished this, I was put on a table where they said they were checking my

176

00:14:07,120 --> 00:14:14,120

nervous system and then the examiner tried to insert a needle like instrument in my navel

177

00:14:14,320 --> 00:14:21,320

which caused great pain and he said it was a pregnancy test.

178

00:14:22,400 --> 00:14:29,400

And this was 1961 and I said that's no pregnancy test here.

179

00:14:32,240 --> 00:14:38,320

So then the leader left the, the leader stayed in the room where I was and the examiner went

180

00:14:38,320 --> 00:14:45,040

into the next room to do Bione's examination and under hypnosis Bione told very much the

181

00:14:45,040 --> 00:14:52,040

same examination that I had although instead of checking his nervous system they were very,

182

00:14:52,240 --> 00:14:59,240

very interested in his bone structure, particularly the end of his spine and his feet.

183

00:14:59,680 --> 00:15:05,320

And also they placed a cup like instrument on his abdomen.

184

00:15:05,320 --> 00:15:12,320

Now after this experience when we came home a few days later Bione had this sort of irritation

185

00:15:13,800 --> 00:15:20,800

that formed and a pattern of warts developed in the circle which continued to grow.

186

00:15:22,960 --> 00:15:29,960

Now during the hypnosis while Bione was still in the amnesia part these warts became infected

187

00:15:30,960 --> 00:15:37,960

and Bione needed to go into a skin specialist and have them removed. But until the hypnosis

188

00:15:38,200 --> 00:15:44,200

he had no idea what possibility could have created this.

189

00:15:44,200 --> 00:15:50,040

While Bione's examination is going on I'm in the room with the leader and now I'm beginning

190

00:15:50,040 --> 00:15:57,040

to overcome some of my fears because naturally in the beginning I was terrified, also I was

191

00:15:58,040 --> 00:16:05,040

curious and I was also angry. So I'm now getting over these feelings and I'm standing

192

00:16:06,080 --> 00:16:12,040

there and I said to the leader because he keeps reassuring me that now my examination

193

00:16:12,040 --> 00:16:17,640

is completed, Bione's is almost completed, very soon you're going to leave and you'll

194

00:16:17,640 --> 00:16:23,000

be able to go back to your car and go home. So I said to him you know when I go home

195

00:16:23,000 --> 00:16:28,280

and I tell my friends about this nobody's going to believe me, I need something to take

196

00:16:28,280 --> 00:16:35,280

home as proof. He said what do you want? And I said what have you got? So he showed me

197

00:16:37,240 --> 00:16:44,240

a book and I said great I'll take it. And he said I looked at it and he said you're not

198

00:16:44,640 --> 00:16:51,640

going to be able to read it. I said I don't care it's proof. So I had the book there and

199

00:16:51,960 --> 00:16:58,960

then I said where are you from? And he showed me a star map and he said the heavy lines

200

00:16:59,400 --> 00:17:05,480

on the map are where they go all the time. The lighter lines on the map are where they

201

00:17:05,480 --> 00:17:11,760

go occasionally and the broken lines were expeditions. And then he said do you know

202

00:17:11,760 --> 00:17:18,040

where you are on this map? I said no. And he said explained that if I didn't know the

203

00:17:18,040 --> 00:17:23,720

map I couldn't know where the earth was or where we were on the map then he would be

204

00:17:23,720 --> 00:17:30,720

unable to explain it to me. Now during the hypnosis I drew this map. Now at this point

205

00:17:32,840 --> 00:17:39,840

the examiner came running in, opened my mouth and he's pulling at my teeth. And I said to

206

00:17:40,840 --> 00:17:47,840

the leader what's going on? Why is he doing this? And the leader said we're very puzzled.

207

00:17:48,840 --> 00:17:55,840

By these teeth they're removable and yours are not. Why? So I tried to explain to him

208

00:18:00,680 --> 00:18:07,680

that this is what happens to us sometimes is we get older, poor, diet, things like this.

209

00:18:08,400 --> 00:18:14,360

So he started questioning what's older, age, what's age. Ask him your questions, kinds

210

00:18:14,360 --> 00:18:21,360

of questions like this. And he did not understand the words I was using. So then we started

211

00:18:21,840 --> 00:18:28,840

talking about poor diet. What's poor diet? Things, diet, the foods we eat. And I mentioned

212

00:18:30,240 --> 00:18:37,240

vegetables so he described vegetables. So I said I will tell you about squash. It's

213

00:18:37,240 --> 00:18:44,240

yellow. He said what's yellow? So we gave that up. So at that point Barney is coming

214

00:18:47,560 --> 00:18:54,560

out of the examining room. They're still helping him along. He's still very passive as though

215

00:18:54,640 --> 00:19:01,440

he's sleepwalking. And I'm delighted because I'm going to get out of this place. Barney's

216

00:19:01,440 --> 00:19:07,040

being let out so I picked up the book and I sat it out behind Barney and the leaders

217

00:19:07,040 --> 00:19:14,040

walking beside me. And all of a sudden in the corridor had been what I call a crew member's

218

00:19:14,080 --> 00:19:19,960

as a method of identification. I could not understand a thing they were saying but I

219

00:19:19,960 --> 00:19:25,040

could sense that there was a disagreement going on. And the leader went back to them

220

00:19:25,040 --> 00:19:32,040

briefly and he came back and he took the book. And he said you cannot have the book. And

221

00:19:32,040 --> 00:19:38,360

I said you gave it to me. This is my proof. He said I know. They had decided that you're

222

00:19:38,360 --> 00:19:45,860

going to forget the whole thing. So you won't need the book. And I said somehow in some

223

00:19:45,860 --> 00:19:52,860

way I'm going to remember this. And he said well maybe you will but Barney will not. So

224

00:19:54,000 --> 00:20:01,000

then he started walking back to the car with me and I was beginning to feel well I hope

225

00:20:01,000 --> 00:20:06,040

you wouldn't judge everybody by me because I wasn't able to answer his questions. So

226

00:20:06,040 --> 00:20:13,040

I said to him if you will come back I'll introduce you to people who can answer your questions.

227

00:20:14,160 --> 00:20:19,720

And he said well it's not my decision to make. And I said well I must know if you're going

228

00:20:19,720 --> 00:20:26,320

to come back so I'll know where and when to meet you. And he said if we decide to come

229

00:20:26,360 --> 00:20:32,800

back we will find you. So I said you know there's billions of people in this earth you'll never

230

00:20:32,800 --> 00:20:39,800

find me. I don't live around here. And he said I'll find you. So he walked back to the

231

00:20:47,400 --> 00:20:54,400

car and he said if you he said why don't you watch us leave. You'll be safe by the car.

232

00:20:55,400 --> 00:20:59,800

So he turned around and went back to the craft and I went back to the car and I picked up

233

00:20:59,800 --> 00:21:05,520

my dog Delcy who was shivering and shaking on the seat. And I said come on Barney get

234

00:21:05,520 --> 00:21:10,320

out we're going to watch him leave. And Barney is now just beginning to come out of this

235

00:21:10,320 --> 00:21:16,520

condition. So he came out and we stood there leaning against the car and I saw this craft

236

00:21:16,520 --> 00:21:23,520

in the woods become surrounded with a swirling orange mass. It looked like a ball like the

237

00:21:24,240 --> 00:21:31,240

mass was swirling around and around like a churning ball. It went up dipped down went up and was

238

00:21:31,440 --> 00:21:38,440

gone. Barney and I got back in the car. We went back to route 175 to route 3. I said to Barney

239

00:21:41,360 --> 00:21:47,960

well Barney do you believe in flying sources. And Barney said don't be ridiculous. And I

240

00:21:48,040 --> 00:21:55,040

thought good grief Barney does not remember. And then I thought I don't know who you are

241

00:21:55,560 --> 00:22:02,560

away you're from but I wish you luck. And then I started to forget too. Now this was

242

00:22:02,680 --> 00:22:09,680

the experience as we knew it at that point. We had relived the capture under hypnosis.

243
