When I was 17 years old I went into the military service, United States Navy.

And my first new station was in Jacksonville, Florida.

And then from there I went over to the far west command and I helped serve out a flag

11

and fight for it in Vietnam even though I thought it was a immoral act of a war.

Then coming out of the service I went back to Missouri and spent a couple of months there.

13

And I went home to Nebraska where my folks were.

14

And I wasn't making very much money being out of the service, you know, \$2 an hour being

15

a clerk wasn't my bag really.

16

So I wanted newer fuels so I always wanted to be in law enforcement.

17

So I talked to my father about going into law enforcement and he decided that the state

18

patrol in Nebraska would be a good idea.

19

00:01:29,480 --> 00:01:33,600

So we filled out the forms and everything and I had to go to the Ash in Nebraska, to

20

the police department to get a police check.

21

So I walked in and five minutes later I was a policeman.

22

They hired me there.

23

My life before this happened as a police officer the short time I was was a good one.

I enjoyed it.

25

I enjoyed working with the public and serving the community and serving the laws of the state.

Now I guess I'll get on with the story.

It was long, two thirty, actually I think was the time that this happened but around

two twenty I was just checking two gas stations.

I left the two gas stations, excuse me, I left the last gas station that I checked to

30

pull onto the highway and I was making radio contact with the Wahoo Sheriff's Office because

31

we didn't have radio communications available in the city at night time because we couldn't

afford it.

33

00:02:22,960 --> 00:02:26,320

So I told them that everything was all secure.

34

I pulled onto the highway and put the mic down.

35

00:02:29,160 --> 00:02:32,400

I seen some flashing lights in front of me.

36

00:02:32,400 --> 00:02:38,400

First appeared to me to be a truck I thought as I got closer and put the high beams of

37

the lights in the tow car on this, this object started raising.

38

00:02:41,960 --> 00:02:46,320

These lights started raising up in the air to about forty feet.

39

I think I was something like fifty yards from this.

40

These lights were flashing and as they got bigger as I got close to it.

41

It seemed like they were red flashing lights coming out of a porthole which sort of circled

42

It had like a catwalk going around the center of it.

44

It was shaped like a football, very metallic, like a very shiny bumper if you polished a

45

bumper on a car.

46

00:03:14,280 --> 00:03:20,720

It had sort of a reddish, orangey glow coming from beneath it.

47

And then there was this white flash that came on to me in the tow car.

48

It felt as if we were being pulled.

49

And then it was being pulled.

50

You know, we were being pulled up the side of this bank to the left of the road and up

51

toward this field, the car and I.

52

I felt nothing.

53

At first I felt kind of stunned and shocked and then I felt sort of tingly.

And as the car and I moved up the bank to the top of this field, this object landed

I don't remember, you know, being probably scared.

This hatch came open and this light came out of the hatch and this form came down and looked

61

at the form of a human being.

62

00:04:22,360 --> 00:04:27,840

And this form started walking toward the patrol car with an object in both its hands.

63

Appeared to be hands.

64

And he was walking straight toward the patrol car.

65

00:04:32,640 --> 00:04:36,680

As he was doing this, another form came out and started walking toward the patrol car

66

also.

As this being walked up to the front of the patrol car with this object in his hand, which

68

86

And we started moving toward the spacecraft.

And it felt like I was walking on air.

88

We got up to the hatch to where you went inside of the spacecraft and we just sort of like

And he says to me, watchman, come with me and we were in a circular room and there were

91

the whole room.

00:06:24,200 --> 00:06:29,440

And it had sort of like a cable running through it, two cables running through these.

94

They looked like tall batteries to me.

And then in the center of this room was a huge cocoon or, you know, like this shaped

96

97

This cone thing was right in the center of the floor.

111

You can see half of it from on top and half of it from the bottom, but it gave off a red

112

glow that sort of not flashed, but kind of died down and then came back up again.

113

And he says, watchman, come with me.

114

00:07:57,000 --> 00:08:03,040

And we walked over to a screen that was up on the side, I say wall.

115

00:08:03,040 --> 00:08:06,160

It was sort of like a TV screen.

116

And he pressed some buttons and I guess flipped some switches.

117

I wasn't paying too much attention to him.

118

I was looking at the screen and some stars in the sky appeared on there.

And he put his finger up like this and he said, this is where we're from, watchman.

120

And then he put his hand back down.

121

He just pointed.

123

00:08:29,240 --> 00:08:33,520

The purpose that we're here is to get electricity.

124

And there was another being standing a little distance away and a man turned to him and

125

they both looked at each other and he started depressing buttons.

126

And he says, watch, watchman.

127

00:08:47,600 --> 00:08:52,960

And there was this antenna on the outside of the spacecraft which angled toward a power

128

00:08:52,960 --> 00:08:56,440

unit and this bolt went out.

129

00:08:56,440 --> 00:09:00,280

A color I've never seen before in my life and I don't even think I could describe it,

130

went out and came back and this stayed like this for about three minutes and then it went

131

00:09:05,120 --> 00:09:06,120

off.

132

00:09:06,120 --> 00:09:11,960

And he turned and looked at me and I felt as I was getting a very, very, an awful lot

133

of role of input of words that I couldn't understand.

134

00:09:16,720 --> 00:09:26,080

And he reached up and he touched me on the shoulder and he felt real when he touched me.

135

00:09:26,080 --> 00:09:31,480

And I think at that time I did touch him and he felt real to me.

136

00:09:31,480 --> 00:09:33,920

And he says, watchman, come with me.

137

00:09:33,920 --> 00:09:39,240

We walked back over to the exit, I'll say, where we came up and the glass sheet came

138

00:09:39,240 --> 00:09:45,400

down again and we went up into the third part of the craft which was the observation deck,

139

00:09:45,440 --> 00:09:47,360

as he said.

140

00:09:47,360 --> 00:09:50,000

As we stepped off, he said, watchman, come with me.

141

00:09:50,000 --> 00:09:53,800

And we walked over and we were standing there looking out of a big plate glass window type

142

00:09:53,800 --> 00:10:00,320

thing and there was a control panel right in front of it and there were two chairs that

143

00:10:00,320 --> 00:10:04,960

looked like dentist chairs, you know, a grid of the dentist chair but really a superstructure

144

00:10:04,960 --> 00:10:08,960

chair, better than a dentist chair.

145

00:10:08,960 --> 00:10:15,360

We looked out the window and I could see this one being walking back and forth by word

146

00:10:15,360 --> 00:10:17,960

where my patrol car was.

147

00:10:17,960 --> 00:10:19,960

And I think I said, wow.

148

00:10:19,960 --> 00:10:27,680

And he put his, he didn't, no he didn't, he turned to me and he said something I don't

149

00:10:27,680 --> 00:10:34,040

understand and he said some more things that I didn't understand or couldn't make out and

150

00:10:34,040 --> 00:10:36,040

I still don't.

151

00:10:36,040 --> 00:10:43,080

And then he pointed his hand toward the plate glass window, as I say, referred to, to the

152

00:10:43,120 --> 00:10:50,720

stars out there and he says to me, watchman, one day you yourself will see the universe

153

00:10:50,720 --> 00:10:51,720

as I have.

154

00:10:51,720 --> 00:10:56,920

And he reached up and he touched me on the shoulder like this, you know, like grabbing

155

00:10:56,920 --> 00:11:03,760

you on the shoulder like a man does to steer you away and he says, come with me, watchman.

156

00:11:03,760 --> 00:11:10,400

And then he stopped and he said, watchman, and I turned around like this to look at him

157

00:11:10,440 --> 00:11:15,760

and it felt like I was getting more input of something that I couldn't understand.

158

00:11:15,760 --> 00:11:17,760

Then he says, watchman, come with me.

159

00:11:17,760 --> 00:11:23,080

We walked over and we went down all the way out of the craft.

160

00:11:23,080 --> 00:11:28,480

As we got outside, this other being started walking back toward the spacecraft and boarded

161

00:11:28,480 --> 00:11:35,960

it as we were walking toward my patrol car and we stopped right by the patrol car and

162

00:11:35,960 --> 00:11:41,480

I turned to look at him and he was looking at me and then again it felt like I was receiving

163

00:11:41,480 --> 00:11:45,800

input of words of some kind that I couldn't understand.

164

00:11:45,800 --> 00:11:52,400

And he turned, no, he sort of lifted his hand and then he turned and walked back to the spacecraft,

165

00:11:52,400 --> 00:11:54,400

floated up inside.

166

00:11:54,400 --> 00:11:57,320

This catwalk thing started spinning.

167

00:11:57,320 --> 00:12:00,080

The lights started flashing off and on.

168

00:12:00,080 --> 00:12:03,320

This red orange glow came out from beneath it.

169

00:12:03,680 --> 00:12:07,840

It started lifting up in the air and I guess it got about 100 feet high and just shot straight

170

out of sight.

171

Let me tell you, I was scared.

172

I started feeling me again.

173

When I was aboard the spacecraft, I had hardly no feeling at all.

174

My body was tingling.

175

00:12:20,720 --> 00:12:21,720

I was inspiring.

176

00:12:21,720 --> 00:12:22,720

I was hot.

177

00:12:22,720 --> 00:12:25,240

I felt nauseated.

178

00:12:25,240 --> 00:12:27,360

I got back into the patrol car.

179

00:12:27,360 --> 00:12:32,200

I turned it around and I headed back for the police station.

180

00:12:32,200 --> 00:12:41,400

On the way to the police station at a high-radius speed, I tried to make communication with

181

00:12:41,400 --> 00:12:46,080

Wahoo Sheriff's Office and it appeared the radio was dead.

182

00:12:46,080 --> 00:12:47,240

I got to the station.

183

00:12:47,240 --> 00:12:52,880

I jumped out of the car and a fast walk, walked into the police station and I noticed that

184

the wall clock in the police station said, one minute after 3 a.m.

185

00:12:58,600 --> 00:13:01,040

Well, I went directly to the bathroom.

186

00:13:01,040 --> 00:13:06,040

I had to go to the bathroom to drink water because I was hot.

187

00:13:06,040 --> 00:13:08,680

I walked back into the main room of the police station.

188

00:13:08,680 --> 00:13:10,880

We had a real small police station.

189

00:13:10,880 --> 00:13:15,160

It was about 20 by 20.

190

00:13:15,160 --> 00:13:23,240

I sat there at the table and I lit a cigarette and I said, wow, what the hell happened?

191

00:13:23,240 --> 00:13:24,640

Something happened to me.

192

00:13:25,640 --> 00:13:27,200

Did I really see a flying saucer?

193

00:13:27,200 --> 00:13:29,080

Did this really happen to me?

194

00:13:29,080 --> 00:13:33,280

I looked at my report log and I remembered through all the training and everything I went

195

00:13:33,280 --> 00:13:38,960

through that regardless of the nature or what it was, put it in your report book because

196

00:13:38,960 --> 00:13:41,400

you just might need it.

197

00:13:41,400 --> 00:13:47,040

So I looked at my report book and I got my pen out and I wrote at 2.30 a.m. December

198

00:13:47,040 --> 00:13:50,600

3, 1967.

199

00:13:50,600 --> 00:13:56,600

I saw a UFO at the junction 6 and 63, believe it or not.

200

00:13:56,600 --> 00:14:02,400

About 6.30 that morning, a fellow officer came in and I explained to him what happened

201

00:14:02,400 --> 00:14:08,640

to me and the fellow officer says, I believe you heard.

202

00:14:08,640 --> 00:14:13,720

One time I was on my way to Wahoo, Nebraska and I was driving down the road.

203

00:14:13,720 --> 00:14:14,720

I looked over.

204

00:14:15,400 --> 00:14:20,840

Lo and behold, there were two UFOs sitting in the field and these little green men were

205

00:14:20,840 --> 00:14:23,880

out there walking around it waving at me.

206

00:14:23,880 --> 00:14:25,960

I said, sure, Paul.

207

00:14:25,960 --> 00:14:29,880

He says, I don't think you should tell anybody heard because I don't think anybody's going

208

00:14:29,880 --> 00:14:30,880

to believe you.

209

00:14:30,880 --> 00:14:33,400

Matter of fact, you're going to lose your job if you tell the people.

210

00:14:33,400 --> 00:14:35,640

But I said, Paul, it's the truth.

211

00:14:35,640 --> 00:14:39,320

He said, well, you know, he said a lot of people won't even accept the truth.

212

00:14:39,320 --> 00:14:40,520

I said, well, I'll wait for the chief.

213

00:14:40,520 --> 00:14:41,600

He says, no, I'll go on home.

214

00:14:41,720 --> 00:14:45,360

So I went home and I was, you know, I really felt like everything was drained completely

215

00:14:45,360 --> 00:14:47,200

out of my body and I lay down on the couch.

216

00:14:47,200 --> 00:14:52,840

And as I lay there, I started getting a buzzing feeling in my head and it felt like I was

217

00:14:52,840 --> 00:14:54,880

being head pressure on my body.

218

00:14:54,880 --> 00:14:56,160

I couldn't move my arms.

219

00:14:56,160 --> 00:14:59,360

I couldn't, you know how you try to open up your mouth and you can't say help.

220

00:14:59,360 --> 00:15:01,680

I was trying to say help, you know.

221

00:15:01,680 --> 00:15:05,680

And then I went off to sleep in the phone rang and it was a chief and the chief says,

222

get your butt down to the station right now.

223

00:15:08,880 --> 00:15:09,880

What is this?

224

00:15:09,880 --> 00:15:10,880

You mean you've seen a UFO?

225

I said, I don't feel good.

226

00:15:11,880 --> 00:15:14,160

I'm sick and I'm not coming down to the police station.

227

00:15:14,160 --> 00:15:15,760

He said, I'll be right over.

228

00:15:15,760 --> 00:15:23,360

So the next thing, the TV came in, press came in, you know, newspapers, radio stations

229

00:15:23,360 --> 00:15:26,480

and telephone calls started coming in.

230

00:15:26,480 --> 00:15:30,320

Two days later, the ridicule started coming in.

231

00:15:30,320 --> 00:15:32,680

Believe me.

232

00:15:32,680 --> 00:15:37,080

And I had a man run three blocks huffing and puffing.

233

00:15:37,080 --> 00:15:39,480

He owned the good year tire shop there in Ashland, Nebraska.

234

00:15:39,480 --> 00:15:45,040

He let me, if you ever see another flying saucer and it lands, you tell him I want to

235

00:15:45,040 --> 00:15:49,680

sell him a set of tires.

236

00:15:49,680 --> 00:15:51,920

The phone rang, this is the planet Mars, you know.

237

00:15:51,920 --> 00:15:54,320

I mean, really ridiculous stuff.

238

00:15:54,320 --> 00:15:59,240

I think though being here in Florida, one of the neatest walkings I got was right out

239

00:15:59,240 --> 00:16:00,880

here in the lobby.

240

00:16:00,880 --> 00:16:03,200

The gentleman out there selling books.

241

00:16:03,200 --> 00:16:05,320

And I walked up and he says, Herb Sherman.

242

00:16:05,320 --> 00:16:06,760

I said, yes.

243

00:16:06,760 --> 00:16:19,320

My name is So-and-So and I was taking aboard a police cruiser.

244

00:16:19,320 --> 00:16:22,680

I thought that was neat.

245

00:16:22,680 --> 00:16:28,080

The United States Air Force, conning committee, Blue Book Project or however you want to say

246

00:16:28,080 --> 00:16:34,400

it, investigating team came down to Ashland, Nebraska to investigate me.

247

00:16:34,400 --> 00:16:39,680

A gentleman by the name of John Ehrens, who is a friend of mine and a gentleman by the

248

00:16:39,680 --> 00:16:43,080

name of Roy Craig, who was a physicist.

249

00:16:43,080 --> 00:16:48,520

John Ehrens, he'd probably hit me, but he was a shrink, psychiatrist.

250

00:16:48,520 --> 00:16:53,840

Him and I had long discussions and he told me to tell my story over and over and over

251

00:16:53,840 --> 00:16:56,680

and over and I told it over and over and over and over.

252

00:16:56,680 --> 00:17:01,560

And then they found a 25 minute time lapse in my log.

253

00:17:01,560 --> 00:17:08,680

And John says, Herb, what happened to you between 2.30 a.m. December 3rd, 1967 and 3.00

254

00:17:08,680 --> 00:17:12,160

a.m. or a little before 3.00 a.m.?

255

00:17:12,160 --> 00:17:15,920

And I looked at him and I couldn't say anything because I didn't remember.

256

00:17:15,920 --> 00:17:18,240

So he says, you got to come to Bowler.

257

00:17:18,240 --> 00:17:19,880

That's okay.

258

00:17:19,880 --> 00:17:24,040

So they took me up to Bowler and I met a UFO team there.

259

00:17:24,040 --> 00:17:28,480

A lot of people who've done a lot of tests on me.

260

00:17:28,760 --> 00:17:36,200

A hypnotist by the name of Dr. Leo Sprinkler administered time regression hypnosis on me,

261

00:17:36,200 --> 00:17:41,200
