Before we start talking primarily about the Andreessen Affair and about to, and about,

How did one come from being a UFO, a UFO military investigator with the Air Force to, is it just

a natural kind of sequence to continue this kind of work after the military?

9

Well, really, I was with the United States Air Force for a number of years, not as a UFO investigator.

10

We were doing electronic espionage under the auspices of the National Security Agency.

11

But within this position, UFO reports did come to my attention, which indicated that the United States Air Force was taking the subject very seriously indeed,

which was one of the things that instigated me to look into the matter further when I got out of the service.

So it just developed?

14

That's right.

15

Really, it developed from a teenage interest in experimental aircraft.

16

And when flying saucers became headline news, I thought that we're dealing with another experimental aircraft,

but it didn't take very long for me and the public to realize that when you have all the major governments of the world investigating something,

that something really must be going on.

Now, for many, many years, and I think this is changing somewhat though, but for many, many years,

folks who consider themselves to be,

I think objective investigators of UFO sightings were often referred to as the UFO buffs.

That's right.

That was whether, that wasn't considered too nice in those particular times, too nice praise.

The credibility though, it has changed, or at least the credibility of the UFO investigator has changed tremendously, hasn't it?

24

Yes, and I think this probably stems from the fact that more and more scientifically trained people have become involved in UFO investigation.

25

At the manned space center, for example, we must have a couple hundred people who are interested in

UFOs and some who are actively engaged in UFO investigation.

Back in the 50s, when I was involved in this, more or less, as an interesting hobby,

people of that category probably wouldn't have anything to do with the subject.

Even astronaut Gordon Cooper, an astronaut, James McDivitt are now coming out publicly stating that they believe that UFOs are real.

29

Cooper says that UFOs are interplanetary, and he has recounted several experiences that he has had with UFOs.

30

They wouldn't have done that several years ago.

31

I think the credibility is much higher.

32

Fifty-seven percent of the American people right now, according to Gallup, believe that UFOs are real and believe that they have seen the UFO,

33

and there's 15 million people just in this country alone.

How are you involved in John Fuller's incident at Exeter?

35

I was involved as an investigator for the National Investigations Committee on Aerial Phenomena and conducted the initial investigation.

John Fuller worked for Saturday Review at the time and was interested in UFOs and doing a story and contacted NiCAP and asked what was new.

37

I was right in the process of this investigation and he flew down and looked at my report and went back and reinvestigated what I had done and wrote a very fascinating book.

38

Yes, yes it was.

39

If you would, give us background so we can lead up to what I understand is going to be a pretty startling piece of audio tape that we're going to be listening to.

40

The audio tape that you're going to be hearing excerpts from comes from one of 14 hypnotic regression sessions.

41

It concerns Betty Andreessen who allegedly was abducted by UFO occupants and given among many other things a physical examination.

42

What you're about to hear is a small segment of that physical examination and I think that you will be able to relive with her the trauma and the pain and the emotion that she experienced reliving this experience under hypnosis.

43

And she is under hypnosis and recounting the events of reliving, not recounting.

44

Reliving, okay Zaya.

45

Listen.

He's taking an instrument.

47

Oh.

Why do you have to put that in my nose?

I'm putting that thing in my nose and it's going up and it's breaking through something.

I don't like it.

Oh and I can't move.

It's hurting.

Looks like he's pulling it.

Oh he's opening up this shirt and he's going to put that in my nose.

We apparently had a power failure folks and it really wasn't supposed to happen that way.

You want to hear what happened on another TV station down in Massachusetts?

What happened?

We had two independent tape systems down there taping the TV program when they played it back about every third word was missing all the way through the show and to the best of my knowledge they still haven't found out what happened.

No I didn't arrange anything.

Wow what do you say to that?

We're going to start from the very beginning.

I see you try and try again unless you have another power failure and then you get the message that's out and go right on.

But we're going to try it again from the very beginning.

This is Betty Andreessen reliving under hypnosis a medical exam that, well I'm going to use the word allegedly occurred aboard a spacecraft.

I might go a little step ahead before we play the tape.

The conclusion of the report has been that Betty and her daughter were both telling the truth.

Yes they both believe it happened to them.

There's no doubt that lie detector tests a very rigid character reference check and a number of other things that we can go into later indicates that they're telling the truth as they know it to be.

Okay once again Betty Andreessen under hypnosis reliving that medical exam.

He's taking an instrument.

Andreessen how did you get involved in first of all investigating the case being with my cab you were called in.

93

Well actually not in the gap.

94

00:08:11,840 --> 00:08:16,840

I'm director of investigations on the board of directors of the mutual UFO network headquarters in Saguine, Texas.

95

00:08:16,840 --> 00:08:18,840

It happened in Massachusetts.

96

00:08:18,840 --> 00:08:29,840

I resided in Massachusetts and the state director told me of the case and I became involved with the investigating team which consisted of a aerospace engineer,

97

an electric engineer, and communications specialist and myself.

98

00:08:33,840 --> 00:08:38,840

There were five of us and we were constantly checking each other as we've gone through in a professional hypnotist.

99

We also engaged the services of a professional psychiatrist.

100

The investigation started in January of 1977 and continued for a full year and the final report consisted of 528 pages, three volumes.

101

Thoroughly documenting this close encounter of the third kind type G which involves an onboard experience.

102

In your personal recollection did indeed what Betty Andreessen described during that hypnotic session actually occur to her?

103

I believe that probably most of it did.

104

00:09:14,840 --> 00:09:19,840

We kind of proved that and why I say that is well first of all we know they believe it happened.

105

00:09:19,840 --> 00:09:21,840

They relived it as a real experience.

106

00:09:21,840 --> 00:09:25,840

Becky, her daughter, relived it from her own vantage point.

107

00:09:25,840 --> 00:09:33,840

Three persons consciously remember the initial part of the experience, the father and the daughter and Betty.

108

00:09:33,840 --> 00:09:42,840

I think it's interesting that you can go back to January 25, 1967 and check things like the weather, the power failure, how much snow was on the ground,

109

00:09:42,840 --> 00:09:44,840

what was on TV and things like that.

110

00:09:44,840 --> 00:09:51,840

We were able to do all kinds of checks like that which indicated that they were describing January 25, 1967.

111

What interests me the most is that we have about 200 cases on file very similar to the Andreessen affair.

112

There are subtle similarities which exist between these cases which we feel no way some of these witnesses could have known about.

113

For example?

114

00:10:06,840 --> 00:10:11,840

The needle, for example, that was inserted in Betty's nose.

115

00:10:11,840 --> 00:10:16,840

When they pulled that needle out there was a little BB-like ball on the end of it.

116

We know of one case that has never been published that has a similar thing happen during the physical examination.

117

00:10:23,840 --> 00:10:27,840

Her description of the humanoids very similar to the Hill's case.

118

00:10:27,840 --> 00:10:30,840

I think of a master sergeant who belongs to the human realm.

119

00:10:30,840 --> 00:10:35,840

I don't know, where were you getting all these power failures?

120

00:10:35,840 --> 00:10:37,840

Matter of fact, that's it.

121

00:10:37,840 --> 00:10:46,840

In August of 1965, who had a very similar experience to Betty Andreessen, his description of the craft, the occupants, how they moved, or floated and so forth,

122

00:10:46,840 --> 00:10:49,840

is very consistent with what Betty and others reported.

123

00:10:49,840 --> 00:10:56,840

In the case of the master sergeant, he belongs to the Human Reliability Program which is a select group within the United States Air Force.

124

00:10:56,840 --> 00:11:00,840

They have to pass a battery or psychiatric examination to the cream of the crop.

125

00:11:00,840 --> 00:11:05,840

So there was no possibility of psychosis as a very intelligent man.

126

00:11:05,840 --> 00:11:09,840

You have Betty Andreessen, you have a little country girl that has no knowledge of UFOs.

127

00:11:09,840 --> 00:11:15,840

She had ten years of education, married the boy next door, raised seven kids one after the other,

128

00:11:15,840 --> 00:11:23,840

and her life was mainly tied up bringing up children within the context of the local church and as she was interested in art.

129

00:11:23,840 --> 00:11:26,840

As far as UFOs went, she didn't even know what a UFO was.

130

00:11:26,840 --> 00:11:33,840

And if you told her what a UFO was, it would be really, I suppose, against her religious beliefs to even believe that UFOs existed.

131

00:11:33,840 --> 00:11:42,840

But it was an awful time trying to convince her that hypnosis was something that was legitimate and could be used by surgeons and dentists, criminologists and so forth.

132

00:11:42,840 --> 00:11:55,840

So we have a case where we have someone who had no background in UFOs and yet describes the same type of thing as other types of people from various walks of life have described in this country and abroad, which makes it very interesting.

133

What was the reaction of Betty Andreessen when you first approached her to investigate her experience?

134

00:12:00,840 --> 00:12:04,840

Was she a little bit skeptical of UFOs?

135

00:12:04,840 --> 00:12:18,840

Yes, she had a lot of questions. We originally came to know about the incident because she had written a letter to Dr. Jalen Heineck out of the Centrifu UFO studies in response to a newspaper article which indicated that he was interested in cases of this nature.

136

00:12:18,840 --> 00:12:29,840

Unfortunately, all she could remember was the flashing lights, which I guess we never really went over the story, but they were flashing lights in the backyard, a local power blackout, interestingly enough.

137

00:12:29,840 --> 00:12:45,840

And these beings somehow getting into the house, the father saw them out in the yard coming toward the house, but it was so vague that Dr. Heineck just filed it away for a few years and we came to know about it in 1977.

138

00:12:45,840 --> 00:12:47,840

She was very interested.

139

00:12:47,840 --> 00:12:48,840

So it's just 20 years then after the fact?

140

00:12:48,840 --> 00:12:55,840

No, it happened on January 25, 1967, that we started in January of 1977.

141

00:12:55,840 --> 00:12:56,840

Of course you should, 57.

142

00:12:56,840 --> 00:13:03,840

But she was very relieved that someone might be able to help her discover what had happened.

143

00:13:03,840 --> 00:13:11,840

Unfortunately, as she began to relive this under hypnosis and it came to a conscious mind, she thought she was going to be losing her mind. These things don't happen.

144

00:13:11,840 --> 00:13:19,840

And we killed two birds with one stone. We had her sit with us a psychiatrist to assure her that she wasn't a psychotic.

145

00:13:19,840 --> 00:13:27,840

She felt that she must need medical attention because things like this don't happen, but also to assure us that we weren't dealing with a psychotic.

146

00:13:27,840 --> 00:13:31,840

Let me interrupt you. We'll continue our discussion right after news from CBS. You stand by, won't you?

147

00:13:31,840 --> 00:13:40,840

You know, when Project Blue Book was closed officially, so to speak, by the Air Force, they made the statements that they were able to pretty well discount.

148

00:13:40,840 --> 00:13:48,840

I forget the exact figure. 95, 98% of all sightings or reports, they were able to explain them.

149

00:13:48,840 --> 00:13:51,840

But it left that 2 or 3%.

150

00:13:51,840 --> 00:13:56,840

Among the 2 or 3%, would you include in this the Andreas and Affair?

151

00:13:56,840 --> 00:14:00,840

Yes, I would, but the 2 or 3% is a very, very low figure.

152

00:14:00,840 --> 00:14:09,840

Dr. Heineck, who is Chief Scientific Consultant to Project Signed, Roger Blue Book has indicated that the true percentage was somewhere around 20%.

153

00:14:09,840 --> 00:14:19,840

And I think this came across very clearly in the movie, TV movie on Project Blue Book that was shown for maybe a year or so.

154

00:14:19,840 --> 00:14:30,840

And I think it's indicated a high percentage, just 20%. Other countries, UFO projects also come up with this 20%, which remain unexplained after investigation.

155

00:14:30,840 --> 00:14:37,840

Just because someone reports a UFO doesn't make it a UFO. It only remains a UFO after investigation. I can't find an explanation.

156

00:14:37,840 --> 00:14:46,840

Before we go to our phones, how about explaining to the listeners and to me too, for that matter, what exactly happened to Betty and Becky Andreas and on January 25th of 67?

157

00:14:46,840 --> 00:14:52,840

Okay, and that particular evening, about 6.35pm, there was an intermittent power failure.

158

00:14:52,840 --> 00:15:00,840

Simultaneous with that, there was a flashing orange light which came through the kitchen window, which overlooks a huge field.

159

00:15:00,840 --> 00:15:05,840

The children were scared. Mrs. Andreason showed her 7 children into the living room.

160

00:15:05,840 --> 00:15:11,840

And she had her parents staying with her to take care of the children because her husband was in the hospital at the time.

161

00:15:11,840 --> 00:15:19,840

Her father ran to the kitchen window and looked out and claimed he saw what looked like children dressed in strange Halloween costumes.

162

00:15:19,840 --> 00:15:23,840

This is what his description of these beings were coming toward the house.

163

00:15:23,840 --> 00:15:29,840

On second look, though, he saw that they weren't walking, but they were moving, floating with a hopping motion.

164

00:15:29,840 --> 00:15:32,840

All you can remember after that is them somehow getting in the house.

165

00:15:32,840 --> 00:15:38,840

They did enter the house. Mrs. Andreason communicated with them through mental telepathy.

166

00:15:38,840 --> 00:15:42,840

The members of the family seemed to have just frozen in motion for want of a better term.

167

00:15:42,840 --> 00:15:45,840

We called it, we call it suspended animation.

168

00:15:45,840 --> 00:15:52,840

Mrs. Andreason was very concerned about her family and they allowed Becky Andreason, she was 11 years old at the time,

169

00:15:52,840 --> 00:15:57,840

to come out of this state of suspended animation to assure Mrs. Andreason that she was alright.

170

00:15:57,840 --> 00:16:05,840

On the hypnosis, Becky lives this portion of the experience very vividly, describing as an 11 year old,

171

00:16:05,840 --> 00:16:10,840

although she talked like an 11 year old under hypnosis, used in the 11 year old vocabulary,

172

00:16:10,840 --> 00:16:14,840

described little clay creatures or men rather talking to her mother.

173

00:16:14,840 --> 00:16:23,840

And then to make a long story short, they convinced Betty Andreason to follow them to a craft which is out in the backyard.

174

00:16:23,840 --> 00:16:30,840

She felt that she had free will but looking back hindsight, felt that they had complete control over everything that she did.

175

00:16:30,840 --> 00:16:35,840

The craft was very small. They stayed in that craft for a fairly long time.

176

00:16:35,840 --> 00:16:40,840

She felt heaviness and so forth and then it stopped and she felt that she was taking aboard a larger craft,

177

00:16:40,840 --> 00:16:45,840

where she was subjected to the effects of a number of very very strange instruments.

178

00:16:45,840 --> 00:16:55,840

Then she was brought to an alien place where she had more experiences and then brought back to the craft and returned to her home.

179

00:16:55,840 --> 00:17:02,840

It's a fascinating story. I think the Andreason affair probably is the most documented account of its kind.

180

00:17:02,840 --> 00:17:08,840

One of the interesting things about the Andreason affair is we have a woman who is an excellent amateur artist

181

00:17:08,840 --> 00:17:14,840

and she was given post-synoptic suggestion to remember these things in detail after each hypnotic regression session

182

00:17:14,840 --> 00:17:21,840

and she was able to supply us with a chronological account with her drawings in great detail,

183

00:17:21,840 --> 00:17:26,840

most of which the major ones are included in the book.

184

00:17:26,840 --> 00:17:35,840

One of the interesting things though concerning the case which I feel to mention before is that one of the investigators was an aerospace engineer

185

00:17:35,840 --> 00:17:42,840

and he asked Mrs. Andreason to describe each segment of the craft that she was in,

186

00:17:42,840 --> 00:17:46,840

how she entered that room and how she left the room, what the dimensions were,

187

00:17:46,840 --> 00:17:52,840

and then he took all of this information aside and was able to come up with a logical, very coherent,

188

00:17:52,840 --> 00:17:55,840

strecula shaped craft which really amazed him.

189

00:17:55,840 --> 00:17:59,840

He was very skeptical about this whole thing at first.

190

00:17:59,840 --> 00:18:04,840

That sort of convinced him that they might be some legitimacy to the case.

191

00:18:04,840 --> 00:18:08,840

How long a period, or timeframe now, does this take place?

192

00:18:08,840 --> 00:18:16,840

Did the rest of the family remain in this state of suspended animation while Betty and Becky were wherever it was they went to?

193

00:18:16,840 --> 00:18:25,840

It started at approximately 6.35. They returned to the house at 10.40 and we estimate probably the aliens left

194

00:18:25,840 --> 00:18:30,840

probably between 10.40 and 11.00, probably close to maybe quarter, 11.00.

195

00:18:30,840 --> 00:18:33,840

The abduction experience we feel is about 3 hours and 40 minutes.

196

00:18:33,840 --> 00:18:36,840

The whole experience, maybe 4 hours and a half.

197

00:18:36,840 --> 00:18:42,840

Any ideas on was she indeed transported in that vehicle somewhere?

198

00:18:42,840 --> 00:18:46,840

It would seem to be that. That's the apparent stimulus.

199

00:18:46,840 --> 00:18:49,840

We kind of proved that.

200

00:18:49,840 --> 00:18:54,840

All you can say is that what she described aboard the craft, what she described during the physical examination,

201

00:18:54,840 --> 00:19:02,840

has been described by others from various walks of life in this country and abroad who essentially described similar things,

202

00:19:02,840 --> 00:19:06,840

of which she wouldn't have been aware of at all.

203

00:19:06,840 --> 00:19:14,840

It's hard to prove something like this. You have to use the tools that you do have, lie detector tests, character reference checks.

204

00:19:14,840 --> 00:19:21,840

The same way you deal with a criminal case, you don't have physical evidence of any kind for something like this.

205

00:19:21,840 --> 00:19:26,840

Almost nine years went by before Betty Andreessen ever mentioned this to anyone, didn't it?

206

00:19:26,840 --> 00:19:31,840

They discussed it within the context of their own family. She did discuss it with her sister.

207

00:19:31,840 --> 00:19:41,840

She, not knowing that much about UFOs, was trying to explain it within the context of her very simple Christian faith, really.

208

00:19:41,840 --> 00:19:45,840

She found nothing that really gave her any answers.

209

00:19:45,840 --> 00:19:53,840

Strange things that she couldn't remember had happened to her, but there were just flashbacks of things that had happened.

210

00:19:53,840 --> 00:20:00,840

She couldn't hold it in her mind until this hypnotic regression situation took place.

211

00:20:00,840 --> 00:20:05,840

Back in just a moment. Now let's go to our long distance line and long distance where are you calling from?

212

00:20:10,840 --> 00:20:12,840

Nobody there? The phone's all the rest?

213

00:20:12,840 --> 00:20:17,840

Well, I can't understand what you're saying to me. What does that mean? You're shaking your head no.

214

00:20:17,840 --> 00:20:21,840

Drop it, put it on hold, now watch.

215

Let's take a close encounter of the third kind which is also a close encounter of the second kind where there's physical evidence.

On April 24th, 1964, Lonnie Zamora, a policeman, was chasing a speeding car on South Park Street of Socorro, New Mexico.

Now this is typical of other cases like this. The only difference between this type of case and the Andreessen affair case is that Lonnie tomorrow didn't talk to these beings and was not brought aboard.

So it would seem that close encounters with the third kind type G could be a logical extension of a type of UFO experience which has left physical data behind.

One of the interesting things that has come to light within the past few weeks is a summary report from the government of France to the Center for UFO Studies.

Dr. Claude Poir, a director of a civilian French government sponsored UFO project is on our board of directors.

In 1977 the French government seemingly took the UFO problem, at least partially out of the hands of the military, and commissioned a team of scientists to look at 11 close encounters of the third kind, one of which involved occupants in communication.

They spent the year of 1978 looking at these particular cases. The Center for UFO Studies received several weeks ago a summary of a five volume report which is still classified, a secret, that indicates that, and this is the conclusion of the report,

10 out of the 11 cases were found not to be misinterpretation of natural phenomena or misidentification of man-made devices, nor were they hoaxes.

291

And the conclusion of this study of these 11 cases indicated a very strong statement. Behind the UFO phenomenon there exists a flying machine whose motive, sustenance, and propulsion is currently beyond the scope of current present day science.

Originally when that project was set up, Dr. Claude Poir indicated that the results of this project would be made public, that the five volume report would be sent to people in this country in a broader study, but the French government has classified this secret,

and we don't know when the full results of this particular study will be made public, except for the summary report that was released to the Center for UFO Studies.

294

So I think it's going to take something like the government to release the information that is presently holding on UFOs to at least convince the public that UFOs are real, although the last Gallup poll indicates that 57% of the American people believe that UFOs are real,

295

and that they have seen a UFO. That's about 15 million Americans.

296

From time to time through the Freedom of Information Act we have acquired some very spectacular military reports involving radar visual sightings, weapon systems control panels being disrupted, smaller missiles being fired from larger UFOs at interceptors causing disruption of navigational equipment, communications equipment.

You read these things and you read these twixes. They're addressed to the White House, the Secretary of the State, Defense, all the heads of the intelligence agencies, Joint Chiefs of Staff.

Something is going on somewhere, and these twixes, telegrams classified, telegrams contain some very, very hard information. We've been very fortunate to have got information like that into our hands.

Morning, Iran, KTRH.

Okay. I'm trying to be totally frightened. I have a couple questions.

301

Alright, go ahead.

What does a person do? Are we just totally helpless? What if you see something like that? Do you rhyme? Do you commit?

303

The government has really not recognized that this exists as far as protecting the citizen of the world. What are we supposed to do? You're supposed to walk around thinking any minute you're going to get picked up.

304

I don't want to live that type of life even though I do believe this does exist. Has there been any study as far as how do you react if you're caught in this type of situation?

I don't know. If I were you, though, I don't think I would dwell on it and worry about it. That's for sure. That's not going to cause you all kinds of problems.

However, we were talking during the break that it seemed to me that the kind of evidence that it was going to take to really convince, well, even me and a lot of other people, would be the classic kind of take me to your leader kind of experience.

And you were telling me that the government has already initiated a study on just how to approach that kind of potential problem, haven't you?

308

I was nearly one in co-ordinated for the University of Colorado UFO study sponsored by the United States Air Force.

And during an investigation, we had two scientists fly out to my home to investigate some very strange UFO sightings that occurred in Massachusetts.

310

And at that time, they told me that part of their job was to ascertain what would the government do if a UFO landed on the White House lawn, for example.

311

Interestingly enough, the Condon Report never contained any such report at all.

One wonders how many other reports that went to the University of Colorado never got printed.

One of the reports, for example, that we investigated involved two trained observers, former aircraft spotters and amateur astronomers using binoculars and a telescope and naked eye,

a signaling to a UFO with a flashlight. And they were, the scientists were very intrigued with this report and put some credence in it.

But it never appeared in the final report. And there are a lot of reports like that that never appeared in the final report.

Now, there have been instances of the accounts and of the sightings that remain, let's say, still classified as unknown, where hostile action was encountered on part of the UFO.

There have been some cases, for example, at Otis Air Force Base, for example, in May of 1953, we have a mass asidant who was involved in search for a missing aircraft, which told us, who told us a very interesting story.

Ground radar had picked up unidentified flying objects off the coast of Boston, and they sent F-94C or weather gen interceptor to look into the situation.

The interceptor took off and was over the gunnery range and all communication navigational systems went dead and then the aircraft engine cut out.

And the pilot ejected the canopy, cockpit canopy and ejected himself thinking the radar operator would follow suit.

And his parachute opened just in time. There was no crash. He couldn't figure everything. It was very, very quiet.

And he landed and he went to the nearest house and knocked on the door and called the Air Force Base and told them what happened.

They found the canopy over the weapons range, then find the aircraft, then find the radar operator.

He said that the mother came out, then spent three months living on base hoping to find her son.

He said there's no way that that thing could have kept on going out to the ocean, which was several miles off.

He said it was falling like lead. There was just no way. The plane completely disappeared.

327

Now there are a number of planes that have disappeared. All crashed, chasing UFOs.

And if you consider this hostility, I really don't know.

329

There was one report that these are in the minority, but let me give you an example of a little boy in Bealdsville, Ohio, who went out to get some water with a metal bucket

and returning to his house. He saw this typical oval UFO hovering at treetop level and a ball of fire seemed to emanate from it and come after him.

And he began running and the ball of fire hit him and knocked him to the ground and his clothes, his autocote caught fire and he caught fire, really.

The grandmother and the mother heard him screaming and came out and watched this boy.

They saw this boy rolling over and over. They went out and saw the object. There was a local power failure.

It only lasted about 30 seconds to a minute. They managed to put the fire out and they called a sheriff.

He informed NiCamp in the Air Force and the boy was brought to the hospital and treated for minor burns.

Now what we make of this is this hostile action.

337

The metal bucket that he was carrying initiates some type of protective action on part of the UFO.

338

00:39:03,840 --> 00:39:13,840

The sheriff was convinced it wasn't a hoax, but these cases are in the minority and they might be akin to some native who has never seen an airplane before,

339

00:39:13,840 --> 00:39:21,840

watching an airplane land on the jungle and the occupants leave the airplane, but they leave the propeller going and the native goes walking up to the airplane and sticks his head in the propeller.

340

00:39:21,840 --> 00:39:27,840

And then his buddy's blame it on the airman. Who knows what's going on here.
