sponsored the University of Colorado project.

188

I've been advised that tonight, yes, I presently am with Dr. Hrenick's Center for UFO Studies

189

and Director of Investigations on the Board of Directors for an International Group

190

called the Mutual UFO Network.

191

I think that the character reference check,

192

I believe check from the neighbors, lawyers, ministers, etc.

193

We gave her a true extensive light-effective test,

194

I heard by her daughters to establish whether or not they were trying to perpetrate clever hopes.

195
