So I don't know what attracted my attention while I had reached around and get more bait

I heard some kind of zipping like sound like a steam was coming from a pipe.

And as it turned around, I saw some two blue flashing lights or either pulsating lights,

I'm not sure.

And it seemed like it was some type of craft and it seemed like it was almost down to the

ground then.

In fact, it seemed to be about a couple of feet above the ground and it just hovered

15

So Kevin had turned by this time and he was looking at it too.

And really I didn't know what to do.

So they carried me inside the craft and the light was almost blinding inside.

In fact, for about three or four days I had something like a bed well-inflated in my

I can't recall or I can't remember just what was on the inside simply because the light

was sobriety that I just couldn't make out what it was but I didn't see any tables or

chairs and the room seemed to be round.

Of course that could have been because the light seemed to be glowing from the walls

But they carried me, I guess, about the middle of the room and we would just seem to be suspended

my face and it remained there for a few minutes and then it very few minutes and then it went

44

I'm assuming it did because when it went down like this I seemed to be suspended there

and the next time I seen it it was coming back up over this way so I assumed that it

But it came back in front of my face and stayed there for a few more minutes and then it seemed

And these things, the way they were holding me, I was elevated because they weren't as

move my eyes on the thing that I couldn't move and I could see that they had released

53

me and I don't know where they went, whether they went outside the craft or another room

54

or compartment but they didn't come in front of me and they left me that way for a few

55

minutes, I don't know how long and then after a while I've seen them then when they come

56

back to the side of me and took hold of me again and they carried me back outside the

57

craft and we were still just gliding, I wasn't touching anything that I know of and they

58

seemed to just glide back out the way they had taken me from and put me back down on

59

the ground.

But when they did I fell because my legs were weak and they gave way on me and it was this

61

time that I seen Calvin again, he was standing there, he was standing facing the river with

his arms outstretched and he was almost in shock.

And these things that came out of the craft, they were about five or five foot four inches

Well for some reason just mentioning several reasons I didn't see any movement of breath in the chest area

I didn't see any movement of breath in the slit of the mouth here it didn't move and when they move

they seem to move as something mechanically they could move their arms like this and in the shoulders

but their head didn't move and when they move they seem to turn as if mechanically it appeared to me

this arm here just instantly I felt pain but it was gone just that quick and then once the boy

of the boarded craft at one time I felt this the same pain in the same area again but it was just

instantly and that's the only physical pain that I had through the entire thing. Now approximately

the area going to call it occasionally Air Force Base and all and it could have possibly been as

long

as as um well it could have been anywhere from 30 minutes to to an hour and probably even longer than

Can you give us some idea of the size of this craft that you were suspended with then?

Well the craft uh let me explain now the angle that I was looking toward the craft it's hard for

127

me to say which I can't say whether the craft was round like a disk or what it was long or oblong

like a cigar because I'll be it was it was let me give you an example like the craft was sitting

129

here we're assuming that this is the front end of it that was the end it was torus but I'm looking

130

at it from this angle so all I can see is what is this side is what I'm assuming to be the front

131

and maybe it's a little bit of the back so I can't be sure whether the craft was round like a

132

disk or was long or oblong but it appeared to me there was about 30 or 40 foot long and maybe

133

uh eight or ten foot high just before the opening appeared there seemed to be two small windows

134

up toward the front in the top two small windows and directly behind the windows was the revolving
