Well, now I listened to the tape that they made for the police department when Captain Glenn Ryder, Sheriff Fred Diamond of the Jackson County Sheriff's Department,

when they were trying to break their story and I heard the tape that they made there and from all appearances, something happened to them.

You know, we all find it hard to believe, but something happened to them. Their description, their stories match. They were interrogated separately and then left in a room together to discuss it and it was all the same story all the time.

And what happened? The Ingalls Shipyard is located south of Highway 90 on the Gulf here in Pascagoula.

These two gentlemen were fishing from the old Shaw Peter Shipyard and off an old pier there at the shipyard, which is about a quarter of a mile south of Highway 90, which is one of the most heavily traveled highways in this part of the country.

And about dark, which would have been about 7.30, this spacecraft, spaceship, whatever you want to call it, they saw it coming about two miles away. It had flashing blue lights.

It was, say, our terminology would probably be silver or aluminum. It came down and hovered about three feet off the ground. Three creatures who were described as about five feet tall with big eyes, pointed ears, wrinkle skin, pale colored skin.

They had claw-locked arms and feet. They came out and they hovered or floated. They didn't walk. They kind of floated out.

No, I don't because late yesterday afternoon we kind of wrapped it up for the night and then this morning we haven't made that call to the Sheriff's Department yet to find out what is happening.

But you had heard that the Air Force was sending in investigators from California or something?

Yes, when they were carrying the Keesley Air Force base for the radiation test, they again told their story there to some officials and I'm not sure who they talked with over there,

but I'm sure they talked with the commander of Keesley Air Force base and they have called in some investigators from the Air Force and they are based in California.

Now Chuck, you say you heard the tape of the statement of these two men.

And do I believe them? I believe they saw something and whatever it was has put one of them in shock and I find it all hard to believe.

When I was sitting there yesterday morning listening to the tape, I believed that they saw something, but the further you go and you're to me and I'll say common sense takes over, you begin to wonder, now, you know, did they? How could they?

So I don't know. I think if I were to listen to the tape again, I'd be a believer again. I know Sheriff Fred Diamond is. He is a believer.
