These two men are still being interrogated and we have with us Sheriff Fred Diamond.

Can Sheriff Diamond, could you tell us what took place this morning?

Well shortly after 8 o'clock last 19th John was overfishing here just north of the Pascagulla

8

River Bridge on the East River and they decided to stop me coming down and it landed approximately

two feet off the ground and never touched the ground and two creatures came out and

One of the men passed out and for excitement, one of them never did pass out and the other

at the time that they were ending spacecraft.

They were very excited, they don't want to be interviewed at this time, at the present

time they unwrapped the thing that was in the hospital to be checked out.

This is what we understand Sheriff Diamond that the two gentlemen Charles Hixon and

Calvin Parker are being checked out for radiation at this time.

Now we noticed this morning of course you interrogated these two gentlemen last night

here at the Jackson County Sheriff's Department, you called them, why did you call them back

in this morning?

We wanted to get more information about exactly just what's taking place.

I understand Sheriff Diamond that the youngest man 18 years old I believe, Calvin Parker

23

00:01:49,800 --> 00:01:52,760

is still in quite a bit of state of shock.

24

00:01:52,760 --> 00:01:54,120

That's very, very much true.

25

00:01:54,120 --> 00:01:57,320

He's still very, very upset.

26

Sheriff Diamond, we understand both these gentlemen work at the Johnny Walker shipyard,

they both reported two works this morning if I'm correct and you had them come to the

28

Sheriff's Department here from their job.

29

00:02:10,120 --> 00:02:14,800

That's right, we had them come over, we had several new people here that wanted to interview

30

them at the office of the attorney, they only wanted to release this information to the

31

right government with heart.

This is something I want to ask Sheriff Diamond if you know that we have a local attorney

here representing these two men.

He made this statement this morning before they would let the two men out of the car

that no publicity would be given at that time and you just got through talking to the men

again.

Their attorney has advised that there will be no interviewing because the men according

to the attorney are still in the state of shock, especially the young boy.

But could you tell us why they felt they needed an attorney?

This attorney represented the company that they worked for and they were working through

his regular advice.

This same object that was posted, that picked these two men up was spotted about four to

five minutes earlier up near the Van Cleave area.

It was also spotted by two or three people in Pascagola.

In other words, Sheriff Diamond, I know we talked to Deputy Glenn Ryder earlier this

morning, there have been quite a few reports of this UFO in our area and approximately

at the same time that these two men have stated that they were taken aboard.

That's very true, they even give us a description of the creatures or characters which you

That was a boy to craft.

They give a good description of them.

They were real wrinkled and had sharp ears, sharp nose and their mouth was very near the

They were horrible creatures from the description we got from.

All right, Sheriff Diamond, these two men, as you mentioned, are on the way to the Sinking

57

River Hospital for radiation tests.

What will happen after they leave the hospital?

59

I don't know.

60

They want to get the right authorities, which would be the governmental authorities, and

61

go over this with them before they give any release to any news media.

Sheriff Diamond, I asked Glenn Ryder this morning and it seems to me that we haven't

63

had a chance, of course, to talk to the two men themselves, but everybody that we have

talked to that have talked to the men tend to believe their story.

Yes, sir.

It happened, I believe, early yesterday evening, say around 7.30 or 8.

Why did the men wait so long and reporting the incident?

closed so they immediately left there and came here.

It happened shortly after 8 o'clock.

They were in the Sheriff's Office around 9 or around 5 minutes from that.

I understand we had a report earlier this morning that it was around 11 or 11.15 but

Yes, it was around 8 o'clock last night when it happened and they were in the Sheriff's

81

Office around 5 minutes from that.

Sheriff Diamond, did they describe the outward appearance of the ship itself?

83

No, sir.

Only the blue light.

85

It had our glowing blue light and that's what got their attention.

86

It was the time they saw the light.

87

The craft was almost on top of it.

88

It landed about 25 feet from where the men were fishing and it seemed to just draw the

men to the craft.

All right, Sheriff Diamond, you said after they do leave the Singing River Hospital,

91

their next object is to report to possibly a governmental agency.

Do you know for sure where they will be going or who they will talk to?

No, sir.

I don't.

I imagine they will probably, a governmental agency, will link them here at the Sheriff's

In other words, they'll come down here to meet with them.

We have a lie detector test.

But we were talking to Glenn Ryder while I go and he said that the 18-year-old young

I believe he's from Jones County and that he is really upset by this situation.

That's true.

I got to call his mother about four to five minutes ago and he's not even in the condition

to talk to his mother.

They're saying that going to the hospital, I think they will give him something to quiet

121

them down.

And as you stated, Sheriff Diamond, that you did have quite a few reports this morning

123

coming in from other sightings from people in the different areas here in Jackson County.

Yes, sir.

They were spotted more in Harrison County than it has been in Jackson County.

They've been spotting this thing in Harrison County for over two or three weeks.

But up until about a week ago, I hadn't had any reports of it being spotted in Jackson

128

Sheriff Diamond, have you seen any?

No, sir, I haven't.
