I didn't know how did they find it out.

127

But then the telephone rang again, it was Fred Diamond, the Sheriff.

128

And I said some bad words to him and told him that the news reporter had already been trying to contact him.

129

He said, I don't know, Charlie, I had to get out of this, probably, it had got slipped out somewhere.
