We would like you to meet America's now most controversial and most seen and heard contactee, Woodrow Derenberger.

This is Mr. Derenberger here and with Mr. Derenberger is a very charming wife. His first name is Darla.

the world here,

That is the reason that they are here for.

What did they tell you? I'm dying to know.

What do you, the information comes to me that you have been followed here by flying saucers out of the vicinity?

I know that this is as hard to believe or maybe harder than to believe in the first and least of contact with the people,

99

but I never go anyplace, I never go anyplace at all unless one or two of the space people are very close to me.

100

If I travel on the highway, they travel with me. They travel very close.

101

If I am in a meeting of this sort, they're also very close.

These people are very identically like our own people.

They look just like us today.

Yes, if you could meet one on the street, you could not tell him from a man that was born on Earth.

He could be sitting next to you at any time and you would not know it unless he was to tell you or prove to you that it was so.

What is it that you can contact originally on the 2nd of November of 1966?

We are now pushing toward two years following that date, over a year and a half now.

No significant progress has been made even by their time measurements as you relate them to us.

Why is it taking so long?

I think there has been a great deal of progress made.

111

It may seem so to the general public, but the government itself is getting closer to announce this, to announce what they know on the air.

There is many more people know of these spacecraft or these people and it's generally thought of by the whole public, taken as a whole.

Many times I have been asked to prove this story in some way with some material proof with pictures or some medals from these worlds.

But you do have pictures.

I quit taking pictures. I don't even have any interest in the pictures anymore.

But before you throw them away completely, we have some pictures.

And I think while we're talking, could you roll the monitor out so the audience will have a chance to see firsthand the kind of pictures of what he is talking about.

This is a 25 second film strip that catches a flying saucer in motion.

And while they're getting ready, please proceed with your point.

Well, this kind of proof I did try to and was called a fake and everything.

So instead of trying to prove it this way, the space people told me that they would prove it for me.

But if I wanted to, the people that they had landed and talked to me before these certain people from here.

126

Yes.

127

00:10:11,000 --> 00:10:14,000

But I could use them as witnesses to back up my story.

Now there is two people in the audience tonight that have seen craft at my home in Minerva, West Virginia.

129

And I also have with me tonight six Sworn affidavits of people, but was at my home and seen the spacecraft landing,

seen the people get out of this spacecraft, come and talk to me and then get back in and leave.

They have also these people, some of these people have also seen me get into this spacecraft and leave and have also seen me return.

I can get Sworn affidavits for any of these people or at a short notice, two or three days notice,

I could bring them here on the air and let them travel.

So you think?

Let's take a look at the film now that Woody mentioned existed.

136

Now we were able to see the monitor over there.

137

So if you will, gentlemen, please roll the film.

138

There is a, the item is not in the picture as yet.

139

The camera is apparently disoriented.

140

It must have been in the hands of someone.

141

Woody, who is, there it is.

142

00:11:11,000 --> 00:11:17,000

There is a 16 millimeter film clip that Woody Derenberger brings to us.

143

00:11:17,000 --> 00:11:21,000

And that is a saucer.

144

00:11:21,000 --> 00:11:30,000

It seems to be hovering or fluttering, leaf-like motion that some UFO people have told us about

seems very much in evidence.

145

00:11:30,000 --> 00:11:32,000

Who shot those films?

146

00:11:32,000 --> 00:11:34,000

That was a man that took that film.

147

00:11:34,000 --> 00:11:37,000

He lives in Point Pleasant, West Virginia.

148

00:11:37,000 --> 00:11:40,000

He did release the film, but he will not release his name.

149

00:11:40,000 --> 00:11:44,000

He told me if I use his name, he would see me, so I certainly will not use his name.

150

00:11:44,000 --> 00:11:50,000

But this man took the picture in Point Pleasant, West Virginia with his wife, with him.

151

00:11:50,000 --> 00:11:57,000

He was in a pickup truck when he noticed the object he got out and took the picture with a loaded movie camera.

152

And that was just what he seen.

153

Mr. Derenberger, have you seen these people?

154

00:12:01,000 --> 00:12:02,000

Yes, I have.

155

Have you met Ingrid Colby?

156

Yes.

157

00:12:04,000 --> 00:12:06,000

Were you frightened of them?

158

00:12:06,000 --> 00:12:07,000

At first, yes.

159

00:12:07,000 --> 00:12:09,000

How do you feel about them now?

160

00:12:09,000 --> 00:12:11,000

Some of our best friends.

161

00:12:11,000 --> 00:12:13,000

Very definitely.

162

00:12:13,000 --> 00:12:19,000

Do you say you have some avidates with you from people that have seen Woody getting into this craft?

163

00:12:19,000 --> 00:12:24,000

And this is to whom I may concern.

164

00:12:24,000 --> 00:12:29,000

This is to certify that I, Grace Beckett, will swear that while at the home of Woody Derenberger,

165

00:12:29,000 --> 00:12:34,000

did see a spacecraft land on his property and did see three men get out of the craft.

166

00:12:34,000 --> 00:12:40,000

One looked at the house for about five minutes and then get in the craft and leave Mineral Wells, West Virginia.

167

00:12:40,000 --> 00:12:45,000

Alan Harris is the same thing, seeing spaceships at the home of Woody Derenberger,

168

00:12:45,000 --> 00:12:50,000

talked to the space people, have been in contact with the space people for some time.

169

00:12:50,000 --> 00:12:55,000

I might point out, here's a letter from a doctor, signed MD.

170

I, Dr. Alan Roberts, a doctor of medicine, a month of May 67,

171

00:13:02,000 --> 00:13:09,000

at the home of Woody Derenberger, did see five spacecrafts on his property and did talk with one of the occupants of one of said crafts.

172

00:13:09,000 --> 00:13:15,000

Totally his name was Demo Hassan from the planet Sarabus.

173

00:13:15,000 --> 00:13:16,000

That's right.

174

00:13:16,000 --> 00:13:18,000

That's another planet.

175

00:13:18,000 --> 00:13:24,000

Alan Michaels, seeing a spaceship from the front porch of his house in West Virginia,

176

00:13:24,000 --> 00:13:27,000

are also contacted by the space people of the night of the site.

177

00:13:27,000 --> 00:13:32,000

They also see a spaceship at the Derenberger home and the presence of Mr. Derenberger and so on.

178

00:13:32,000 --> 00:13:35,000

Is Dr. Roberts the psychiatrist?

179

00:13:35,000 --> 00:13:36,000

Yes, he is.

180

00:13:36,000 --> 00:13:38,000

How did you happen to meet Dr. Roberts?

181

00:13:38,000 --> 00:13:39,000

Nightcap.

182

00:13:39,000 --> 00:13:52,000

Shortly after this happened to me, Nightcap engaged this psychiatrist to give me a psychiatric examination and also to take what they call an EEG test.

183

00:13:52,000 --> 00:13:58,000

They, uh, Nightcap did take the results of this test sent it to a clinic somewhere to have it landed.

184

00:13:58,000 --> 00:14:01,000

It came back that it was normal in every way.

185

00:14:01,000 --> 00:14:02,000

The EEG was okay?

186

00:14:02,000 --> 00:14:03,000

Yes.

187

00:14:03,000 --> 00:14:09,000

They said that, uh, Nightcap refused to release it, said it would just cause more publicity and more people would be saying the same thing.

188

00:14:09,000 --> 00:14:11,000

What do you mean, for the record?

189

00:14:11,000 --> 00:14:14,000

Who at Nightcap sicked the psychiatrist on you?

190

00:14:14,000 --> 00:14:17,000

Uh, there was a subcommittee from Pittsburgh.

191

00:14:17,000 --> 00:14:19,000

It was headed by Lou Weitzel.

192

00:14:19,000 --> 00:14:20,000

Okay.

193

00:14:20,000 --> 00:14:26,000

Mr. Weitzel was the man who was responsible for engaging a Parkersburg psychiatrist and sending him to you.

194

00:14:26,000 --> 00:14:27,000

Yes.

195

00:14:27,000 --> 00:14:30,000

Now, Mr. Dr. Roberts, is that the name of the psychiatrist?

196

00:14:30,000 --> 00:14:31,000

That is right.

197

00:14:31,000 --> 00:14:32,000

Uh, he's been on the air with you?

198

00:14:32,000 --> 00:14:33,000

Yes, he is.

199

00:14:33,000 --> 00:14:41,000

He is a qualified medical doctor who then went on to get his degree and became a psychiatrist.

200

00:14:41,000 --> 00:14:44,000

I assume he has been himself, is he a psychoanalyst?

201

00:14:44,000 --> 00:14:45,000

Yes, he is.

202

00:14:45,000 --> 00:14:58,000

Uh, he himself has been psychoanalyzed and he, who was sent to investigate Mr. Derenberger and sort of do a frontal lobotomy to see if Mr. Derenberger was sane or not, is now one of your staunchest supporters.

203

00:14:58,000 --> 00:14:59,000

Is that right?

204

00:14:59,000 --> 00:15:04,000

Yes, because this man has had these space visits since his time to talk to him many times.

205

00:15:04,000 --> 00:15:05,000

He has talked to them.

206

00:15:05,000 --> 00:15:12,000

He has even received help in his psychiatric practice from these people.

207

00:15:12,000 --> 00:15:14,000

It's a very curious aspect of this case.

208

00:15:14,000 --> 00:15:16,000

We'll be back in a moment.

209

00:15:16,000 --> 00:15:21,000

We are talking with Mr. Woodrow Derenberger, who is a very fascinating man.

210

00:15:21,000 --> 00:15:34,000

And Mr. Derenberger, I must share with you a criticism that has been made of you to the effect that it is possible in someone's opinion, another scientific investigator that you have hypnotic powers.

211

00:15:34,000 --> 00:15:36,000

No, I don't feel that I am being hypnotized.

212

00:15:36,000 --> 00:15:38,000

I don't know how you feel about it, Mrs. Derenberger.

213

00:15:38,000 --> 00:15:40,000

Maybe your feelings may be different.

214

00:15:40,000 --> 00:15:50,000

But an investigator from this area went down to your home when you were living in Parkersburg, in the Parkersburg area, spent some time down there with you.

215

00:15:50,000 --> 00:15:55,000

They said they saw some evidence of something out there.

216

00:15:55,000 --> 00:15:58,000

There were some flying saucers or lights they could not explain.

217

00:15:58,000 --> 00:16:02,000

They acquired no pictures and brought back no evidence.

218

00:16:02,000 --> 00:16:13,000

And looking back, one of them said, and I will not name him, said that he felt that he must have had some kind of hypnotic influence, or he was somehow hypnotized in some way.

219

00:16:13,000 --> 00:16:15,000

Would you care to comment on that, sir?

220

00:16:15,000 --> 00:16:20,000

I know very well the man. Actually, there were two men that you were referring to.

221

00:16:20,000 --> 00:16:22,000

Well, there were three on that particular list.

222

00:16:22,000 --> 00:16:23,000

Yes.

223

00:16:23,000 --> 00:16:28,000

But these men, and I do not care to name the men, even though you don't.

224

One of them was her and that, the other was Larry Moyers.

225

00:16:32,000 --> 00:16:38,000

They came down with the express person, heard this, that they wanted a picture of one of their spacecraft.

226

00:16:38,000 --> 00:16:45,000

I took them out behind my house in an open field, and I asked Indy Cole if he would bring his ship in.

227

00:16:45,000 --> 00:16:51,000

He did bring the ship in with them, I would say, between 100 or 200 feet over our heads.

228

00:16:52,000 --> 00:16:56,000

Earl Lipp and Larry Moyers both had a camera hanging around their necks.

229

00:16:56,000 --> 00:16:58,000

They stood with their mouths wide open.

230

00:16:58,000 --> 00:17:03,000

The cameras in their hand never attempted to take any picture whatsoever.

231

00:17:03,000 --> 00:17:07,000

I asked them repeatedly while they were standing there to take the picture.

232

00:17:07,000 --> 00:17:08,000

They never did.

233

00:17:08,000 --> 00:17:09,000

They stood and gazed at it.

234

00:17:09,000 --> 00:17:16,000

When it was over, they turned around and went back to my house, and without even saying thank you, goodbye, or anything, they clung in the car.

235

00:17:16,000 --> 00:17:21,000

Personally, face to face, that is the last time I have ever talked to them face to face.

236

00:17:21,000 --> 00:17:30,000

But they have never, to my knowledge, ever come right out and admitted they need a spaceship or have seen the spaceships.

237

Why they won't admit it? I don't know.

238

00:17:32,000 --> 00:17:34,000

Well, they did on my program now.

239

00:17:34,000 --> 00:17:35,000

They admitted they said...

240

00:17:35,000 --> 00:17:36,000

Yes, indeed.

241

00:17:36,000 --> 00:17:40,000

Yes, indeed, they said they saw lights, and there was no way to explain what they were.

242

A gentleman over here on the side.

Yes, I don't mean to get too personal on this, Mr. Derenburgers, but a technique which has been reported on psychiatrically in a difficult case in the book *The 60-Minute Hour*

is one in which a gentleman did, as a matter of fact, an eminent physicist, did envision himself actually traveling to other planets and getting involved with the people on these planets.

293

The technique utilized in the psychiatric treatment was a difficult one in which the psychiatrist actually became a part of the entire fantasy to in fact cure this particular individual.

294

A very difficult technique and can be disastrous for the psychiatrist.

My question would be, you have been analyzed. Have you ever been under treatment, psychiatrically?

No, I have never been under any kind of treatment by a psychiatrist or any other thing. The only serious illness I ever had that I can remember was I had my appendix removed.

Is it possible to just take the gentleman's question one step further and he probably was ready to ask it himself, that you could be hallucinating or could have been hallucinating on this

and could be rejoined by your wife and conceivably by a psychiatrist?

Could I have also been joined by this by a group of 32 people at one time, all seeing the same thing, several groups of people at different times.

Would they all be hallucinating with me at different times? This would be impossible. It couldn't be done.

Not to my knowledge, sir.

I wish I'd been there.

Let's go to another question on this side here.

306

Would the two other well-known contactees, Betty and Barney Hill, have you ever read of these two people?

I have heard of these people. I thought that I would get to meet them about two weeks ago, but unfortunately I couldn't.

But I have asked Enred Cohen about this, Betty and Barney Hill.

They say we can also make this, that any time that our government will let them land and give them a guarantee they can land and leave at any time they want to.

355

Gentlemen, the audience with the question?

356

I'd like to inquire about, you were talking before, that you had communication with the aliens through telepathy.

357

How does this telepathy work?

This telepathy, they have told me everybody here on earth could use it if they knew how.

The way to do this, as they explained it to me, is simply by merely, like a daydream, simply wish, or let your thought drift out.

365

Do not try to force it.

366

00:30:32,000 --> 00:30:35,000

Just simply release it from your mind and let it drift out.

367

The person cannot force himself to hear.

368

He can only want to hear and he will hear.

369

00:30:42,000 --> 00:30:50,000

Do you have this power of telepathy only with the aliens or can you direct it to other channels as well?

370

00:30:50,000 --> 00:30:56,000

I have only been able to talk with telepathy to two people from here on earth.

371

00:30:56,000 --> 00:31:00,000

One was a close friend, the other is my wife.

372

00:31:00,000 --> 00:31:14,000

We can only do this at certain times and sometimes when we both feel, I don't know how to explain it, when we feel this exactly right, I can get her thoughts or she can get mine.

373

These people do not call it mental telepathy.

374

00:31:16,000 --> 00:31:22,000

They say it is thought transference and telepathy means an entirely different thing.

375

00:31:22,000 --> 00:31:26,000

Another question in the audience, the gentleman up at the top there.

376

00:31:26,000 --> 00:31:28,000

Or is there a lady down here with the question?

377

00:31:28,000 --> 00:31:30,000

The gentleman at the top.

378

00:31:30,000 --> 00:31:40,000

It's interesting to me that you're on the same show with the education people because a lot of what you say is the same as what they say.

379

00:31:40,000 --> 00:31:55,000

Now, for example, they talk about many planets, people living on other planets and so forth, but in one part of their readings they say that the people also dwell, earth people have dwell in between incarnations on other planets.

380

And I'm wondering if any of the people here on earth were at one time on that planet that you're speaking about.

381

That's one part of my question and the other part of my question is, since your contacts, contactees were interested in developing love and harmony between the people here,

Yeah, I was interested again with regard to that other question I asked you, whether any of the people here on earth from your context would possibly be from your other planet?

408

Yes, these people do believe in reincarnation.

They say that a person could live on several different worlds during his step from one plane to

another plane, that we always go forward. We never go backwards.

But they say you could be reincarnated from several different worlds.

But being the offspring of two different races myself, I would not be welcome on that new planet, is that right?

413

Oh, you'd be just as welcome there as you.

414

Who would I fit in though? You say they don't like blacks and whites mixed up.

415

I don't know how to explain what you're wanting to know. There is, actually, there is no blacks in

the way that you were talking about.

416

They are land elysian. They are the same as we are.

417

Why come they can't marry? Intermarry then?

418

There is no difference if they want to. It's simply up to the individual.

I'll go along with that. Now, we have a young lady down here with a question.

421

Yes, I would like for you and your wife to converse in this language. Give us a further example. A poem or a song, something.

She does not talk in this language.

423

Could you give us a poem or a song or a prayer?

No, I'm afraid I couldn't talk at that good. I have to stop the Stedarus family and think out what I'm going to say.

425

How have you communicated this many ideas with these people then if you can?

426

She talks perfect English. He also in what we call mental telepathy or thought transfer.

427

00:36:10,000 --> 00:36:17,000

It is not a word. It is simply a thought. We transfer the thought into words ourselves.

428

00:36:17,000 --> 00:36:30,000

In the same way, there is no language in this mental thought transference because a thought is not a spoken word until you would receive my thought and then you would transfer it into your own words.

429

But that's the way the brain operates. It transfers pictures in the mind into words.

430

A picture of a thought. It isn't a word until you speak it.

431

Could you communicate to me then something like this?

432

I could try.

433

00:36:46,000 --> 00:36:48,000

I think I know what he's thinking.

434

00:36:48,000 --> 00:36:56,000

I'm sorry, Mrs. Karen Burger.

435

00:36:56,000 --> 00:36:58,000

I know what you mean.

436

00:36:58,000 --> 00:37:02,000

You know what he's thinking. It is more of a telepathy than you can imagine.

437

00:37:02,000 --> 00:37:07,000

Is there another question in the audience where we run almost out of time? We have another question over here?

438

00:37:07,000 --> 00:37:12,000

Yes, I'd like to know why they chose you. They must have had a reason.

439

00:37:12,000 --> 00:37:15,000

Why did they choose you?

440

00:37:15,000 --> 00:37:23,000

They did not choose me deliberately. The night that I was stopped the first time I was traveling on interstate I-77,

441

00:37:23,000 --> 00:37:28,000

I was in a Ford economy van hauling storage and sewing machines. It was raining.

442

00:37:28,000 --> 00:37:32,000

There was a car came up behind me, blinked his lights that he wanted to pass.

443

00:37:32,000 --> 00:37:35,000

He did pass me at a very high rate of speed.

444

00:37:35,000 --> 00:37:44,000

When he went to pass, he stopped the car. This ship was after or was going to stop him.

445

But he came to this intersection. The spacecraft didn't want the cars there.

446

It could be a car from an accessory. He stopped the next car behind him, which is me.

you will also remember that the ships didn't show up, but several aircraft did show up overhead.
