Woody Darenberger is with us this morning and we're talking about a trip he made on a UFO and also with us is Harold Hubbard who,

And when we left off just a moment ago, we had come to the point where you were getting the second contact from Mr. Cold,

174

That means that you're leaping over time in an extraordinary, almost a way that transcends our grasp of what time is.

175

They say that they don't move in the speed in the way that we move.

176

Instead of, we travel so many miles per hour.

177

But instead of this they bend distance.

178

They do not bend time. They bend distance. Space itself.

179

Like it did take a string. They say and then they bend them directly together.

180

If you would fit the switch it would end up just coming together and here at that spot.

181

As strange as it is saying, how did it is to believe, these people told me that our government, our own government, here on this earth, could travel at any speed, far greater than the speed of light right now.

And he's been telling us the story of how this all happened and we've come to the point where you've already been taken on their craft to Langelis.

You've seen it, but you have not landed. Now did subsequent to that, did they take you there and let you stay for a while?

Yes, shortly after that first trip. I cannot remember the exact length of time between it, but I was taken to their world.
