Presumably they got in touch with the Syracuse subcommittee head, James Harris.

I was unable to reach him so that when I talked to Dave Saunders, I gave him Harris' phone

number and his address there in Syracuse, hoping that they would be able to get together

and so on.

Harris could start the interrogation of Orr prior to the arrival of the University of

Colorado team if they did decide to send some people out in the field.

Stanley, this is Joe Barberette at WDRC Radio on Hartford, Connecticut.

WDRC Radio on Hartford, Connecticut, sir?

Yes.

00:01:13,760 --> 00:01:17,760

I was just talking to George Early from NICAP and he apparently was talking to you earlier

18

today.

19

00:01:18,760 --> 00:01:19,760

Yes, I called him by an hour.

20

00:01:19,760 --> 00:01:26,760

Well, George and I work very closely on UFO reports and we're extremely interested in

21

them here at the radio station.

22

00:01:29,760 --> 00:01:35,760

And I was wondering if you would like to talk to me about these sightings that you have

23

reported up there.

24

I have no objections, sir.

25

00:01:38,760 --> 00:01:44,760

I know what you want to know, but what I've seen as far as I'm concerned is the most inexplicable

26

frightening series of events in the last four nights that I've ever gone through.

27

We've got a 10 and a 12-year-old boy here in Newfield, New York who have seen something

which I think that very few people have been, as far as I'm concerned, privileged to witness.

They looked inside of a spacecraft two nights ago and saw the occupants.

30

They had a very clear view of it and it didn't occur to a Milwaukee-Tockey radio.

31

And I just, we had one fly over us and four of us in the backyard and flashing red, white

32

and green lights and a brilliant white beam shot right off the middle of it.

33

And I could tell you the whole chronological resume of what's happened.

34

It might take me three or four minutes.

35

I don't know if you've got that much time or not.

36

Go ahead. Why don't you run right through it?

37

Well, it all began Monday night, quarter to eight when I was sales representative and

38

I was coming from Dryden, New York, which is 12 miles from Ithaca.

39

And I got adjacent to the Tomcus County airport and I noticed two red lights which seemed

40

to be hanging in the sky about 200 feet off the highway.

41

And at the time, at that moment, that fleeting moment, I thought it was a tower they'd put

42

lights on to keep the planes away.

43

00:02:48,760 --> 00:02:51,760

And I drove by it and I had my stereo on in my car.

44

00:02:51,760 --> 00:02:56,760

And I looked over my left shoulder and I noticed that the lights began to move and they passed me.

45

And this time there was a third light on top, a full of red flasher.

46

00:02:59,760 --> 00:03:01,760

And these lights were awfully bright.

47

And I turned the door and turned my stereo down and I couldn't hear any noise.

48

And it struck me, you know, it didn't applaud me at the time because I, you know,

I was near an airport and I just associated it with them.

50

I thought it was a Mohawk plane taken off.

51

00:03:13,760 --> 00:03:18,760

And then I watched it disappear in the distance and I kind of dismissed it, you know.

52

And later it began to bug me.

53

The next day I called the airport and asked them if they had a plane with only red light on.

54

And they said, no, they didn't.

55

Every plane they had was got a white beacon and a green light on one of the wings.

56

00:03:28,760 --> 00:03:32,760

You know, one wing is red and one wing is green and they have another red light on.

57

And of course, there was nothing taken off at that particular time.

58

I asked them that.

59

00:03:35,760 --> 00:03:39,760

And then I called again and spoke with a mechanic up there and described what I'd seen.

60

And he said it sounded like nothing they had.

61

Then I thought, well, gee, I saw something big deal.

62

So two days later, which was Wednesday, I was up in Newfield at my girls house.

63

We were talking and she said, did you hear about the boy in Newfield who saw Flying Saucer?

64

I said, no, I didn't.

65

And I went down and I said, I think I'll get on and talk to him.

I went down and I spoke with him.

67

I spoke with several boys and they told me this unbelievable story.

68

At the time it was unbelievable, but I believe it now.

69

They were out in back and they noticed red lights hanging in the sky with flashers coming around the rim.

70

They described it as a rim hovering in back of their house.

71

00:04:23,760 --> 00:04:28,760

This was Wednesday night about 10 o'clock and they were playing with walkie talkie radios.

72

00:04:28,760 --> 00:04:34,760

The thing went around the house at an altitude of about 200 feet, making absolutely no noise.

73

00:04:34,760 --> 00:04:40,760

They crossed the street over a cavern called the White House Inn in Newfield and hovered over a house next to it.

74

Tilted it down at about a 45 degree angle and this boy stood right on the porch.

75

Two boys stood right on the porch, looked up into it, said there were two square windows divided by a metal bar.

76

They looked inside of this thing.

77

00:04:54,760 --> 00:05:00,760

Two of the weirdest looking beings, this boy describes it, you wouldn't believe the description, were looking at him.

78

He saw behind them and saw a control panel slanted against the far wall with what he described were red, white and green lights flashing sequence across it.

79

And all the way around the rim of this thing, there were red, white and green lights flashing.

80

On the bottom there were red, white and green lights which were stationary like a landing gear.

81

He didn't use the word term landing gear, he just said it was something on the bottom of it.

82

This boy drew an astounding sketch of this thing.

83

00:05:26,760 --> 00:05:28,760

The drop was an antenna sticking out.

84

00:05:28,760 --> 00:05:33,760

Here's the remarkable part of the story. All the wing is remarkable but here's another highlight you might call it.

85

They had the walkie-talkies.

86

00:05:35,760 --> 00:05:38,760

He turned it on and he pointed it at the spacecraft.

87

00:05:38,760 --> 00:05:42,760

You know, it's a wonderful wing, a young boy's mind. They didn't register a steer, they were just intensely curious.

88

They hid it around the house.

89

00:05:44,760 --> 00:05:49,760

He pointed the walkie-talkie up and as he pressed the on button, this thing began to oscillate.

90

And then the walkie-talkie just screamed.

91

00:05:52,760 --> 00:05:55,760

And he left an eye on this thing oscillated and all of a sudden it took off and left.

92

This night it came back but it didn't come close enough for an occupant sighting.

93

It just circled the house.

94

00:06:00,760 --> 00:06:05,760

Anyway, he told me this Wednesday and Wednesday night I had brought a friend of mine up who had never believed in him.

95

We sat out here and back and we watched the most fantastic spectacle I have ever seen in my life.

96

We saw some come in low with red, white and green flashes.

97

We saw some that just missed the treetops that were red, bright red.

98

00:06:18,760 --> 00:06:23,760

Over the top of us going due north, every one of these things had a pattern where these monstrous glowing globes,

99

which was just a steady course.

100

00:06:25,760 --> 00:06:27,760

They really knew where they were going.

101

We looked up to the right, way up high was this great big globe and dropping off from it was a white flasher.

It was like a plane.

103

00:06:36,760 --> 00:06:41,760

I was aboard an aircraft carrier and it looked like a plane taking off the deck of a carrier and it came and then it disappeared.

Then a jet fighter came through.

105

00:06:43,760 --> 00:06:46,760

And it was like, God, what can I tell you?

106

00:06:46,760 --> 00:06:50,760

One hung over the trees a glowing globe and then I woke this boy up.

107

A dog was barking and he went to the window and told me that he was always dreaming.

108

00:06:55,760 --> 00:07:00,760

I've got two photographs of the most unbelievable footprints you've ever seen.

109

00:07:00,760 --> 00:07:03,760

It's half as big as mine. I take a size of 10 and a half.

110

00:07:03,760 --> 00:07:12,760

This is half as big as mine and it's got splayed toes way out and a little narrow high instep and a little teeny heel on it.

111

And it was walking along with a horse's track off the main highway up here.

112

And this went on last night too.

113

00:07:18,760 --> 00:07:20,760

What was I going to tell you?

114

Oh, we were out in the backyard Wednesday night and over comes this thing with all the flashes on it.

115

It's just showing up.

116

00:07:28,760 --> 00:07:30,760

We got right over the top of us and it's bright beacon.

117

00:07:30,760 --> 00:07:32,760

Brightest light I've ever seen on any craft.

118

00:07:32,760 --> 00:07:36,760

Beamed right out of it for about three seconds and then just, which one?

119

00:07:36,760 --> 00:07:39,760

I'm sorry. That was Thursday night. I'm very sorry. That was Thursday night.

120

00:07:39,760 --> 00:07:46,760

And yesterday afternoon, my girlfriend and I stood out in the yard here and we saw, and I know you won't believe this,

121

I saw with my own eyes a craft that I would estimate to be a half a mile long.

122

00:07:52,760 --> 00:08:00,760

It looked like two aircraft carriers in broad daylight and it was right silhouette against blue sky and it just disappeared into some clouds.

123

And simultaneously, further overhead, there was a jet and this jet was leaving a long contrail.

124

And this thing was a solid silver object. It looked absolutely enormous.

125

I just can't believe anything that big could be in the air.

126

00:08:13,760 --> 00:08:18,760

And this, again, I say this, has gone on for four, oh, this, oh, you won't, this is remarkable.

127

Last night, mind you, my girlfriend's sister and her husband had been up here and they witnessed all this aerial phenomenon.

128

Her husband came up for the explicit purpose of ridiculing us.

129

00:08:31,760 --> 00:08:36,760

And this guy was so frightened when he left here at 11 o'clock that he was almost afraid to walk outside to his car.

130

00:08:36,760 --> 00:08:38,760

They got in the car and drove to Ithaca.

131

00:08:38,760 --> 00:08:40,760

15 minutes later, the phone rang.

132

00:08:40,760 --> 00:08:49,760

His wife was in hysterics. He could hardly speak. They had encountered a monstrous object hanging over some houses in Ithaca with stationary lights.

133

00:08:49,760 --> 00:08:52,760

And as soon as they pulled off the highway to look at it, the lights went out.

134

00:08:52,760 --> 00:08:55,760

And we drove down there later and every garbage can in the area was tipped over.

135

00:08:55,760 --> 00:08:59,760

Only where that thing was hovering, just like some massive disturbance had knocked them all over the place.

136

00:08:59,760 --> 00:09:05,760

And there were no other garbage cans on the street like if there had been a wind, you know, it wouldn't have had that effect.

137

00:09:05,760 --> 00:09:09,760

Has there been any other reaction from anybody else in Ithaca that you know of?

138

00:09:09,760 --> 00:09:14,760

Sir, I called the New York State Police. What night, John? When did that trooper come up here?

139

00:09:14,760 --> 00:09:21,760

Thursday night. He got here about 9.15 and he got out of his car and he looked at us like, you know, with this incredulous look like we're all insane.

140

00:09:21,760 --> 00:09:23,760

I said, I know what you were going to say.

141

00:09:23,760 --> 00:09:25,760

I said, but just stand here. We'll be in place for a few minutes.

142

00:09:25,760 --> 00:09:30,760

He came out. He came on back of the house, stood there for approximately five minutes and went one over.

143

00:09:30,760 --> 00:09:33,760

A big glowing one. We'll kind of go north, you know.

144

00:09:33,760 --> 00:09:35,760

I said, what do you think that is?

145

00:09:35,760 --> 00:09:37,760

He didn't say anything. His mouth just dropped.

146

00:09:37,760 --> 00:09:41,760

And then at the same time, my girlfriend's sister was screaming at me around the house.

147

00:09:41,760 --> 00:09:49,760

We all ran around the house, including the trooper, and coming in low over 13 was this brilliant bright red glowing object with unbelievably red lights on it.

148

00:09:49,760 --> 00:09:52,760

And it just missed the tops of the hills and disappeared.

149

00:09:52,760 --> 00:09:59,760

At the same time, to our left, comes this white flasher with this tremendous flashing sequence of red, green and white all over it.

150

00:09:59,760 --> 00:10:02,760

And that caught me. He couldn't say a thing.

151

00:10:02,760 --> 00:10:04,760

I said, you know, I think they're land on Connecticut Hill.

152

00:10:04,760 --> 00:10:08,760

Connecticut Hill is a desolate area where they hunt deer. It's about a hundred square miles and nothing.

153

00:10:08,760 --> 00:10:11,760

And he told me and I quote, he says, I'm not going up there.

154

00:10:11,760 --> 00:10:13,760

He got in his car and he drove away.

155

00:10:13,760 --> 00:10:22,760

Later, I called up the true, somebody called, I can't remember if it was me or somebody, but the official explanation he gave them, he had seen jet planes on the newtours.

156

I called Hancock Air Force Base, Circus New York.

157

00:10:25,760 --> 00:10:28,760

I said, I think, I told him everything that I've told you.

158

00:10:28,760 --> 00:10:32,760

And you know what that guy told me? He says, we'll file it through official channels.

159

00:10:32,760 --> 00:10:34,760

And I said, well, thanks a hell of a lot.

160

00:10:34,760 --> 00:10:35,760

And I hung up.

161

00:10:35,760 --> 00:10:37,760

And that was about two o'clock in the morning.

162

00:10:37,760 --> 00:10:40,760

And the jet plane did come through here that night.

163

00:10:40,760 --> 00:10:42,760

It came in real low and I know a jet fighter.

164

00:10:42,760 --> 00:10:46,760

It was a jet fighter and it swooped right through and it circled and then it disappeared.

165

00:10:46,760 --> 00:10:52,760

And at the same time that jet fighter was coming through, there was another UFO higher going the opposite direction.

166

00:10:52,760 --> 00:11:01,760

And last night, I didn't see this personally, but the boys who looked into the one Tuesday night said that they had witnessed a jet plane.

167

00:11:01,760 --> 00:11:05,760

Just a jet being followed by a UFO close behind.

168

00:11:05,760 --> 00:11:09,760

I think I've covered everything that's of any significance, sir.

169

00:11:09,760 --> 00:11:15,760

There's one question I have and it's not that I have any doubt at all about what you told me.

170

00:11:15,760 --> 00:11:17,760

But there's one thing that bothers me.

171

00:11:17,760 --> 00:11:19,760

Mr. Orr, and that is this.

172

00:11:19,760 --> 00:11:22,760

How come you didn't take any pictures of any of these things?

173

00:11:22,760 --> 00:11:24,760

I'm no photographer. I tried.

174

00:11:24,760 --> 00:11:26,760

We looked at you, saw them through binoculars last night.

175

00:11:26,760 --> 00:11:28,760

But look at you, look up at the sky.

176

00:11:28,760 --> 00:11:30,760

I can't, you can't. It's just a little teeny camera.

177

00:11:30,760 --> 00:11:36,760

I tried to get somebody with a Geiger car or anybody with cameras or anything and nobody's interested.

178

00:11:36,760 --> 00:11:38,760

They all stop at your drudiculia.

179

00:11:38,760 --> 00:11:40,760

You can't see anything through that viewfinder.

180

00:11:40,760 --> 00:11:43,760

It's nothing. You look up in the sky and you see nothing but black. It's just a little teeny camera.

181

00:11:43,760 --> 00:11:49,760

And then as much as all these sightings took place over a number of days about maybe you might have a camera or somebody with a camera there.

182

00:11:49,760 --> 00:11:59,760

This is of course what we need, you know, is to get somebody working, is to get some pictures and let them try to dispute that.

183

00:11:59,760 --> 00:12:03,760

We've got photographs of a footprint. The footprint is gone now. It's been obliterated.

184

00:12:03,760 --> 00:12:06,760

You do have the, have you had the prints? Have you had the?

185

00:12:06,760 --> 00:12:10,760

There's four photographs in color, so there's four pictures to be taken yet.

186

00:12:10,760 --> 00:12:16,760

But one thing is, everything is of significance of course, but these things have a definite pattern.

187

00:12:16,760 --> 00:12:22,760

The glowing ones go north. The little red ones, misty trees, flashers go everywhere.

188

00:12:22,760 --> 00:12:25,760

Just like they know exactly what they're doing.

189

00:12:25,760 --> 00:12:27,760

Newfield is right near Ithaca, right?

190

00:12:27,760 --> 00:12:29,760

Yes sir. It's southern miles south of the country. It's 13.

191

00:12:29,760 --> 00:12:31,760

And you say Connecticut Hill, is that what it's called?

192

00:12:31,760 --> 00:12:38,760

Connecticut Hill is a desolate area which it extends from, from Newfield right on back around.

193

00:12:38,760 --> 00:12:40,760

Is there any water around there?

194

00:12:40,760 --> 00:12:45,760

Yes sir. There's Kuga Lake. There's Kuga Lake. A woman down in Kuta has seen one of these things.

195

00:12:45,760 --> 00:12:47,760

I tried to talk to her on the phone. She wouldn't even talk to me.

196

00:12:47,760 --> 00:12:51,760

She said, she, I got to me through my girlfriend's mother. She works for her.

197

00:12:51,760 --> 00:12:54,760

She said she saw a bright glowing object so did her son and they wouldn't talk about it.

198

00:12:54,760 --> 00:12:58,760

But nobody seems interested down here and I'm appalled, especially it's not what I've seen.

199

00:12:58,760 --> 00:13:00,760

You know, I've seen things, okay, a lot of people have seen them.

200

00:13:00,760 --> 00:13:05,760

But what this little Donnie Chazard and Pat Crowes your saw, 12 years old.

201

00:13:05,760 --> 00:13:10,760

As far as I'm concerned, I would think that anybody with any, with any semblance of intelligence,

202

00:13:10,760 --> 00:13:12,760

of scientific nature would want to talk to them.

203

00:13:12,760 --> 00:13:14,760

Has there been any press reports at all about this?

204

00:13:14,760 --> 00:13:16,760

I don't know what's the sense of it. I'm the, you know, I...

205

00:13:16,760 --> 00:13:18,760

Have you talked to anybody in the newspapers?

206

00:13:18,760 --> 00:13:19,760

No sir.

207

00:13:19,760 --> 00:13:20,760

Nope.

208

00:13:20,760 --> 00:13:21,760

Am I the first reporter you talked to?

209

00:13:21,760 --> 00:13:23,760

First reporter? You're the first reporter?

210

00:13:23,760 --> 00:13:24,760

Yes.

211

00:13:24,760 --> 00:13:27,760

The first reporter I talked to, I talked to Dr. Condon from, not Dr. Condon,

212

00:13:27,760 --> 00:13:29,760

Dr. Levine from Dr. Condon's staff in Colorado called.

213

00:13:29,760 --> 00:13:31,760

Oh yeah, from the Colorado Project.

214

00:13:31,760 --> 00:13:35,760

Dr. Mr. A. Aaron's called me. I spoke with him.

215

00:13:35,760 --> 00:13:37,760

You know, they're out in Colorado and we're here.

216

00:13:37,760 --> 00:13:39,760

I spent 50 bucks in phone calls on this thing.

217

00:13:39,760 --> 00:13:42,760

It's just up to me. The situation like this can exist.

218

00:13:42,760 --> 00:13:45,760

And it's, the implications are rather stumbling.

219

00:13:45,760 --> 00:13:49,760

And everybody is just sitting on their duff and takes this apathetic attitude, you know.

220

00:13:49,760 --> 00:13:51,760

Including the police, including the Air Force.

221

00:13:51,760 --> 00:13:52,760

The Sheriff's laugh at me.

222

00:13:52,760 --> 00:13:54,760

I called them too.

223

00:13:54,760 --> 00:13:56,760

Ho, ho, ho, he said over the phone.

224

00:13:56,760 --> 00:13:59,760

But it's not funny as far as I'm concerned. I haven't slept in too much.

225

00:13:59,760 --> 00:14:03,760

That's why I'm so disappointed that you weren't able to get some photographs of this.

226

00:14:03,760 --> 00:14:06,760

Because it sounds to me like you really have something here.

227

00:14:06,760 --> 00:14:09,760

And with photography, you can jam those last way down their throats, you see.

228

00:14:09,760 --> 00:14:12,760

Well, who do they look like? Just a piece of light in the sky.

229

00:14:12,760 --> 00:14:16,760

If you had something, if you got a picture of this thing that looked like two battleships.

230

00:14:16,760 --> 00:14:18,760

That would have been a beauty guy.

231

00:14:18,760 --> 00:14:19,760

That's what I mean.

232

00:14:19,760 --> 00:14:21,760

It was unbelievable. And I could have photographed that too.

233

00:14:21,760 --> 00:14:23,760
