We received a call about 10.30 from the State Police Barret,

in Salt and Fair County.

And I had talked to the trooper who had just came back from the scene of this incident.

4

And he felt that something definitely had going on.

5

00:00:17,920 --> 00:00:24,420

And the main person involved in it, the farmer son who had seen the creatures and shot at them,

6

00:00:24,420 --> 00:00:25,920

was at the barracks at the time.

7

00:00:25,920 --> 00:00:28,420

So I questioned him over the phone.

8

00:00:28,420 --> 00:00:32,340

And they had indicated the object had landed and was sitting on the ground.

9

00:00:32,340 --> 00:00:34,580

And the creatures had been seen.

10

00:00:34,580 --> 00:00:40,840

And there was a glowing area, glowing ring that was apparent after the object had disappeared.

11

00:00:40,840 --> 00:00:43,260

So we got together, Phil team.

12

00:00:43,260 --> 00:00:49,380

We had Dave Smith, who's a physics teacher and so defense radiation defense officer.

13

00:00:49,380 --> 00:00:55,180

We had a professional photographer, George Loots, who is the co-director of our group,

14

00:00:55,180 --> 00:00:58,180

who's a former Air Force pilot and the major near force reserves.

15

00:00:58,180 --> 00:01:01,180

I can't think we had a sociology major with us, myself.

16

00:01:01,180 --> 00:01:07,180

We went out, we made arrangements to meet with the farmer son who's 22 years old, who was the main witness.

17

00:01:07,180 --> 00:01:09,180

But he looks much older for his age.

18

00:01:09,180 --> 00:01:14,180

He's about 6'2", weighs about 270 pounds from around there.

19

00:01:14,180 --> 00:01:16,180

How was this the following day?

20

00:01:16,180 --> 00:01:19,180

That was that night, a couple hours after the incident occurred.

21

00:01:19,180 --> 00:01:21,180

The incident occurred at 9 o'clock.

22

00:01:21,180 --> 00:01:22,180

And you were there about 11?

23

00:01:22,180 --> 00:01:27,180

Well, they called us about 10.30 until we got up there, about an hour drive.

24

00:01:27,180 --> 00:01:29,180

I told them we got there around 12.30.

25

00:01:29,180 --> 00:01:33,180

And until we got to the scene, it was about one o'clock in the morning.

26

00:01:33,180 --> 00:01:36,180

But anyhow, before we got to the scene, we interviewed them.

27

00:01:36,180 --> 00:01:43,180

And here he later, about 9 o'clock, about 15 of the people in the area had seen a glowing red ball in the sky, a spherical.

28

And it was slowly descending towards the ground.

29

00:01:45,180 --> 00:01:51,180

So this fellow, George, and these two 11 year old twins from down the road,

30

00:01:51,180 --> 00:01:54,180

they ran to his house and they got a .30 .6 rifle.

31

00:01:54,180 --> 00:01:59,180

And they proceeded up in his truck up the back, right towards the pasture area.

32

00:01:59,180 --> 00:02:02,180

And they could see the object slowly descending towards the ground.

33

00:02:02,180 --> 00:02:04,180

And it was getting larger, of course, as it came down.

34

00:02:04,180 --> 00:02:07,180

There were headlights and the trucks started to dim.

35

00:02:07,180 --> 00:02:12,180

And they were just going up toward the top of the hill, the horizon, the hill, and disappeared over the horizon.

36

So they got out of their truck and started walking up the hill and they could see it sitting on the pasture,

37

00:02:16,180 --> 00:02:19,180

apparently right on the ground, or else inches above it.

38

They said it was much larger than the house, about 100 feet in diameter.

39

And it was like a dome or a bubble shape thing.

40

And it was bright white at this time.

41

00:02:28,180 --> 00:02:31,180

It was making it sound like a wild lawnmower.

42

00:02:31,180 --> 00:02:35,180

Their eyes stirred water, a little from the brightness of it.

43

00:02:35,180 --> 00:02:39,180

And then they heard these loud screaming sounds coming from the vicinity of the craft.

44

00:02:39,180 --> 00:02:43,180

Some like a lady screaming or whatever, unusual screaming sounds.

45

00:02:43,180 --> 00:02:47,180

And then after about a minute or so, one of the boys yelled that there was something moving up

along the fence line.

46

So they pointed up there, which was opposite where the craft was on the ground,

47

and there were these two figures walking towards them.

48

00:02:54,180 --> 00:02:57,180

At first they couldn't tell exactly what they were.

49

00:02:57,180 --> 00:02:59,180

They assumed they were bears.

50

00:02:59,180 --> 00:03:05,180

But from the light of the craft, and also this fellow had two military tracers around,

51

which he fired directly over their head.

52

And just left for a second, but it gave them some more insight into what they were observing.

53

00:03:11,180 --> 00:03:14,180

Anyhow, they were then able to make out at least one figure,

54

it was about eight foot tall and the other one around seven foot.

55

They were described very similar to the other creatures, completely covered from head to toe,

56

00:03:22,180 --> 00:03:27,180

long arms almost reaching to the ground, they're making crying sounds on each other.

57

00:03:27,180 --> 00:03:32,180

It was a smell like burning tire, burning rubber, and they had, in these cases,

58

00:03:32,180 --> 00:03:35,180

glowing green eyes, which we had in another case,

59

00:03:35,180 --> 00:03:39,180

would be for falls a week later of a landing and creatures being seen.

60

00:03:39,180 --> 00:03:42,180

Anyhow, he fired a tracer around over their head,

61

00:03:42,180 --> 00:03:45,180

then he fired a warning shot, a 30 out of six over their head,

62

00:03:45,180 --> 00:03:50,180

see if they would slow down, but they kept approaching two of them, they were about 60 feet away.

63

00:03:50,180 --> 00:03:55,180

One of the boys upon seeing this ran, became hysterical, and the other boy stayed with George.

64

00:03:55,180 --> 00:03:58,180

Then he fired directly into the larger creature.

65

00:03:58,180 --> 00:04:01,180

Each time he hit it, it made a lot of crying sounds,

66

00:04:01,180 --> 00:04:05,180

and then finally it raised his right hand up, almost touching the smaller creature,

67

00:04:05,180 --> 00:04:07,180

which was walking in front of it,

68

00:04:07,180 --> 00:04:11,180

and all of a sudden as it raised its hand, the object in the field just disappeared,

69

00:04:11,180 --> 00:04:14,180

the light just went out and disappeared, and the sound stopped,

70

00:04:14,180 --> 00:04:18,180

and then the creature slowly turned around, and started walking back into the woods.

71

00:04:18,180 --> 00:04:21,180

So at this point they were both quite shook up,

72

00:04:21,180 --> 00:04:26,180

and they ran back, called the State Police, and State Trooper came out to the area,

73

00:04:26,180 --> 00:04:29,180

and George went back up with him.

74

00:04:29,180 --> 00:04:32,180

He went and notified the State Police,

75

00:04:32,180 --> 00:04:38,180

the State Trooper went back to the area, I believe around 10.30,

76

00:04:38,180 --> 00:04:42,180

I think he went out there around 10.30, until he got called by radio to go out to the area,

77

00:04:42,180 --> 00:04:47,180

and George told him what he had seen, the Trooper proceeded up to the area.

78

00:04:47,180 --> 00:04:52,180

Trooper verified that they did see what appeared to be a glowing ring about 150 feet in diameter,

79

00:04:52,180 --> 00:04:56,180

where the object had been sitting, and he said that the ring was bright enough

80

00:04:56,180 --> 00:05:01,180

that if you sat down in it, you could read a newspaper by it.

81

00:05:01,180 --> 00:05:05,180

It was on a glowing from a height of about one foot off the ground,

82

00:05:05,180 --> 00:05:10,180

but he also said that he could see the small plants inside of the glowing area,

83

00:05:10,180 --> 00:05:12,180

so it was fairly bright.

84

00:05:12,180 --> 00:05:14,180

No, this was the Police Agency.

85

00:05:14,180 --> 00:05:16,180

The State Trooper was with him, they both saw that,

86

00:05:16,180 --> 00:05:20,180

and he said they were walking up along the woods where George had seen the creatures,

87

00:05:20,180 --> 00:05:23,180

and the Trooper confirmed that every time they'd walk,

88

00:05:23,180 --> 00:05:26,180

they'd hear something falling them along the woods.

89

00:05:26,180 --> 00:05:29,180

He said from the sound of it, it didn't appear to be real big,

90

00:05:29,180 --> 00:05:31,180

so he was flying them around, and every time they would stop,

91

00:05:31,180 --> 00:05:34,180

the sound would keep moving for a few seconds, and they would stop,

92

00:05:34,180 --> 00:05:36,180

and when they started moving, it would move.

93

00:05:36,180 --> 00:05:38,180

Basically, that's what occurred there.

94

Before that went back, George had an opinion,

95

00:05:42,180 --> 00:05:44,180

something was coming out of the woods, he heard it coming towards them,

96

00:05:44,180 --> 00:05:47,180

and he claimed he saw a dark figure coming out of the woods,

97

00:05:47,180 --> 00:05:51,180

and so he took a shot at it, and they ran in the State Police car,

98

00:05:51,180 --> 00:05:53,180

and they turned around and got out of there,

99

00:05:53,180 --> 00:05:57,180

and that's when they went back to the barracks, and they called us, and we went up.

100

00:05:57,180 --> 00:06:00,180

All right, now when you arrived, the blow was all gone.

101

00:06:00,180 --> 00:06:04,180

There was nothing there, we took radiation tests immediately, first.

102

00:06:04,180 --> 00:06:07,180

All right, now did you go back the following day?

103

00:06:07,180 --> 00:06:10,180

We were there, well, we were there for a number of days afterwards.

104

00:06:10,180 --> 00:06:13,180

All right, now was there any physical trace left that you could find?

105

00:06:13,180 --> 00:06:16,180

There was no physical trace, there was nothing that indicated

106

00:06:16,180 --> 00:06:19,180

that it definitely had been on the ground, it may have been right above,

107

00:06:19,180 --> 00:06:22,180

but the animals would not go near the area.

108

00:06:22,180 --> 00:06:25,180

The horses and cattle and dogs, and as Trooper said too,

109

00:06:25,180 --> 00:06:28,180

the animals were extremely nervous.

110

00:06:28,180 --> 00:06:30,180

Were they avoiding the area after the trip?

111

00:06:30,180 --> 00:06:33,180

They were avoiding the area after where they had disappeared from,

112

00:06:33,180 --> 00:06:37,180

they would not, they would go in the outskirts of it, the night in the immediate area where it was.

113

00:06:37,180 --> 00:06:39,180

That's the only visible sign you could see.

114

00:06:39,180 --> 00:06:42,180

All right, but then of course there was no opportunity for you

115

00:06:42,180 --> 00:06:45,180

to use any infrared photography up there.

116

00:06:45,180 --> 00:06:49,180

No, well after the incident occurred that it probably related to you.

117

00:06:49,180 --> 00:06:51,180

Did you tell them, what happened that night?

118

00:06:51,180 --> 00:06:52,180

No, no.

119

00:06:52,180 --> 00:06:55,180

With the mind control, whatever the takeover?

120

00:06:55,180 --> 00:06:58,180

What did happen to the mind takeover in this case?

121

00:06:58,180 --> 00:07:04,180

Well, we went back and we were up there and we were looking around the area

122

00:07:04,180 --> 00:07:08,180

and must have been probably around 20 to 1 when we were up in the field

123

00:07:08,180 --> 00:07:11,180

checking for radiation, looking for any evidence.

124

00:07:11,180 --> 00:07:16,180

And Georgian's father were down below the truck, who was the main witness.

125

00:07:16,180 --> 00:07:19,180

All of a sudden both of them yelled, taught us to run down and we went down

126

00:07:19,180 --> 00:07:23,180

and they said that the whole area by the house had lit a bright green

127

00:07:23,180 --> 00:07:25,180

for a second whole area lit up or bright.

128

00:07:25,180 --> 00:07:29,180

So the father was concerned, so one of our fellows and Georgian's father

129

00:07:29,180 --> 00:07:32,180

going in the jeep went down the house, looked it over, couldn't find anything.

130

00:07:32,180 --> 00:07:34,180

They came back 10 minutes later.

131

00:07:34,180 --> 00:07:39,180

We proceeded up along the area where Georgian claimed he had seen the creatures.

132

00:07:39,180 --> 00:07:42,180

So on our way up, we were just talking and so forth.

133

00:07:42,180 --> 00:07:47,180

And all of a sudden the bull, which was up there, came running out of the woods

134

00:07:47,180 --> 00:07:50,180

and was staring up towards one part of the Witted area.

135

00:07:50,180 --> 00:07:53,180

It wasn't bother paying attention to us at all.

136

00:07:53,180 --> 00:07:56,180

And all of a sudden his dog also started picking up a set of something

137

00:07:56,180 --> 00:08:00,180

and started sniffing his way up towards there and he stopped and started looking around.

138

00:08:00,180 --> 00:08:03,180

One of the guys in our group was on one side of Georgian,

139

00:08:03,180 --> 00:08:06,180

Georgian's father, who was Georgian's main witness, of course,

140

00:08:06,180 --> 00:08:09,180

and Georgian's father was on his other side.

141

00:08:09,180 --> 00:08:12,180

And they were just talking to him, asking questions about it.

142

00:08:12,180 --> 00:08:17,180

One guy in our group asked him about where exactly they were standing or whatever

143

00:08:17,180 --> 00:08:19,180

and he didn't answer them.

144

00:08:19,180 --> 00:08:22,180

Then he asked him again, and when he looked at him,

145

00:08:22,180 --> 00:08:24,180

he was like, going like this rubbing his hands over his head

146

00:08:24,180 --> 00:08:26,180

and he thought maybe a branch had hit him.

147

00:08:26,180 --> 00:08:30,180

And he asked him a question again and all of a sudden Georgian had his hand over his head

148

00:08:30,180 --> 00:08:33,180

and he started waving back and forth like he was going to faint a collapse.

149

00:08:33,180 --> 00:08:37,180

So he asked his father to grab him right away, something was happening.

150

00:08:37,180 --> 00:08:40,180

And they were trying to get him down the ground, but he wouldn't get down.

151

00:08:40,180 --> 00:08:42,180

He started breathing real heavy and heavy.

152

00:08:42,180 --> 00:08:44,180

Then all of a sudden he just threw them both.

153

00:08:44,180 --> 00:08:47,180

He just threw them both, the ground, the father and the other guy in our group.

154

00:08:47,180 --> 00:08:50,180

And all of a sudden they started leaving out these very loud screams.

155

00:08:50,180 --> 00:08:53,180

He started walking around in motion just like a loud animal.

156

00:08:53,180 --> 00:08:56,180

And he started swinging and screaming.

157

00:08:56,180 --> 00:09:00,180

His own dog attacked him and the dogs started crying after that.

158

00:09:00,180 --> 00:09:04,180

And he was making the dogs start crying.

159

00:09:04,180 --> 00:09:06,180

And you witnessed this?

160

00:09:06,180 --> 00:09:09,180

We have it all on tape. The whole thing hasn't happened.

161

00:09:09,180 --> 00:09:10,180

Everything.

162

00:09:10,180 --> 00:09:13,180

Anyway, George was going around making these terrible sounds

163

00:09:13,180 --> 00:09:18,180

and the last roar that he made is identical to the sound of these creatures we have taped.

164

00:09:18,180 --> 00:09:21,180

It's a sound that you couldn't duplicate with a human voice.

165

00:09:21,180 --> 00:09:26,180

And all of a sudden he just more or less just collapsed directly on his face.

166

00:09:26,180 --> 00:09:30,180

Just straight down right into the, there was horse manure all over the place

167

00:09:30,180 --> 00:09:33,180

and just came straight down with his face into the ground.

168

00:09:33,180 --> 00:09:35,180

And we ran over and picked him up.

169

00:09:35,180 --> 00:09:39,180

Just after this occurred, one of the other fellas, well there was one of us too,

170

00:09:39,180 --> 00:09:42,180

one of the other fellas in our group started to get lightheaded.

171

00:09:42,180 --> 00:09:48,180

And he couldn't maneuver properly and he was down on his knees.

172

00:09:48,180 --> 00:09:51,180

And then Dave couldn't breathe at all.

173

00:09:51,180 --> 00:09:53,180

He had trouble breathing.

174

00:09:53,180 --> 00:09:56,180

And then this terrible, strong chemical odor came out of the woods.

175

00:09:56,180 --> 00:09:59,180

We all smotted. Most of us all smotted at the time.

176

00:09:59,180 --> 00:10:01,180

This came out in a wave.

177

00:10:01,180 --> 00:10:04,180

The same thing all the witnesses have described with the creature.

178

00:10:04,180 --> 00:10:07,180

It's a very strong, soft furrior like smell.

179

00:10:07,180 --> 00:10:11,180

Almost if you took these old kitchen matches and struck them, but they didn't light.

180

00:10:11,180 --> 00:10:13,180

It was a very strong smell like that.

181

00:10:13,180 --> 00:10:16,180

We were getting George out of the area, just finding out on his feet.

182

00:10:16,180 --> 00:10:18,180

And one of our other guys, we were getting him back down

183

00:10:18,180 --> 00:10:20,180

and we realized that something was happening, unusual.

184

00:10:20,180 --> 00:10:24,180

We wanted to get out of the area very quickly, which we thank God did.

185

00:10:24,180 --> 00:10:28,180

To sell at George as he came out of it, he was talking about this man

186

00:10:28,180 --> 00:10:32,180

in a dark cape with a hood that was calling him

187

00:10:32,180 --> 00:10:37,180

and told him that the man didn't hurry up and shape up, that the end would come soon.

188

00:10:37,180 --> 00:10:40,180

And things of this nature would happen.

189

00:10:40,180 --> 00:10:43,180

There's no way we can really describe the whole incident.

190

00:10:43,180 --> 00:10:48,180

The closest thing you can describe to it is what's known as diabolical or demon possession.

191

00:10:48,180 --> 00:10:53,180

However, in this case, and from reports we've had since,

192

00:10:53,180 --> 00:10:59,180

even though I've always been very reluctant to connect UFOs and creatures,

193

00:10:59,180 --> 00:11:02,180

there's no doubt that there probably is a connection now.

194

00:11:02,180 --> 00:11:06,180

But it seems that there is some type of mind control involved in these cases

195

00:11:06,180 --> 00:11:10,180

where they are able to take control of certain people at certain times.

196

00:11:10,180 --> 00:11:13,180

And Dr. Schwartz was here from New Jersey working on the case.

197

00:11:13,180 --> 00:11:17,180

He said, and other people involved in it, we've had a number of other similar cases now.

198

00:11:17,180 --> 00:11:21,180

People have come forward to who were involved in a Bigfoot situation

199

00:11:21,180 --> 00:11:24,180

where they have had all types of psychic phenomena,

200

00:11:24,180 --> 00:11:28,180

and other guys' activity, memory lapses, and things of this nature,

201

00:11:28,180 --> 00:11:32,180

all in the last few months associated with the Bigfoot cases.

202

00:11:32,180 --> 00:11:34,180

And these are people who had no previous knowledge of this.

203

00:11:34,180 --> 00:11:39,180

In most of these cases, like in one case, the teenage boy thought his mother about it,

204

00:11:39,180 --> 00:11:43,180

but he doesn't want to talk to anybody about it because he said he's afraid to,

205

00:11:43,180 --> 00:11:45,180

because he feels that somebody's watching him,

206

00:11:45,180 --> 00:11:48,180

and if he says anything about it, something will happen to him.

207

00:11:48,180 --> 00:11:52,180

And he's had two car accidents since the occurrence,

208

00:11:52,180 --> 00:11:55,180

and there was no reason why he should have had a car accident.

209

00:11:55,180 --> 00:11:58,180

In fact, another boy who was with him at the initial experience

210

00:11:58,180 --> 00:12:01,180

also had a car accident in a different car on the same night.

211

00:12:01,180 --> 00:12:08,180

All right. Now, did you personally have anything with smack of mind control?

212

00:12:08,180 --> 00:12:10,180

To me? Yes.

213

00:12:10,180 --> 00:12:14,180

Nothing happened to me except to smell. We all smelled at the time.

214

00:12:14,180 --> 00:12:16,180

And, believe me, the guys in the group,

215

00:12:16,180 --> 00:12:20,180

especially some of the guys who were there that night, are extremely skeptical.

216

00:12:20,180 --> 00:12:22,180

They're open minded, but very skeptical.

217

00:12:22,180 --> 00:12:25,180

And I would never have believed it unless I saw it myself.

218

00:12:25,180 --> 00:12:28,180

But there's no doubt that something happened up there.

219

00:12:28,180 --> 00:12:30,180

Now, the dog attacked the...

220

00:12:30,180 --> 00:12:33,180

The dog went after... more or less, yeah.

221

00:12:33,180 --> 00:12:34,180

And then it started crying.

222

00:12:34,180 --> 00:12:35,180

Then the dog started crying.

223

00:12:35,180 --> 00:12:38,180

Well, the dog belongs to his... the boy's... the fellow's father.

224

00:12:38,180 --> 00:12:41,180

But there, you would say it's his dog, too.

225

00:12:41,180 --> 00:12:43,180

Yeah, but they were well acquainted.

226

00:12:43,180 --> 00:12:46,180

Oh, definitely. Definitely. It's been a whole life out there.

227

00:12:46,180 --> 00:12:48,180

How did he indeed fight the boy?

228

00:12:48,180 --> 00:12:50,180

The dog? No, he got scared.

229

00:12:50,180 --> 00:12:53,180

He went after it, and the dog went over and started crying.

230

00:12:53,180 --> 00:12:56,180

He moved away and started crying, which is all on the tape.

231

00:12:56,180 --> 00:12:59,180

What do I have to do to get a copy of that tape?

232

00:12:59,180 --> 00:13:02,180

Well, I'll tell you what. It's like this. Dr. Schwartz...

233

00:13:02,180 --> 00:13:05,180

There's only two of us in our group that have a copy of it.

234

00:13:05,180 --> 00:13:10,180

And because of what occurred, Dr. Schwartz has right now asked us not to,

235

00:13:10,180 --> 00:13:15,180

because of what's involved in it, until we can get more documentation on it and so forth.

236

00:13:15,180 --> 00:13:21,180

Because if we got the wrong hands by mistake, this guy is, like Dr. Schwartz says,

237

00:13:21,180 --> 00:13:24,180

he is apparently could be very dangerous.

238

00:13:24,180 --> 00:13:27,180

He could kill himself or somebody else without even understanding what's going on.

239

00:13:27,180 --> 00:13:30,180

He doesn't have any reoccurrence he has had?

240

00:13:30,180 --> 00:13:34,180

Not on this, but when certain questions are asked of him, he'll go into a trance.

241

00:13:34,180 --> 00:13:39,180

We put him out several times, and he went in and out the bitch a dozen times when Schwartz was here.

242

00:13:39,180 --> 00:13:43,180

And anytime certain questions are answered, he'll go into this trance,

243

00:13:43,180 --> 00:13:47,180

and start rubbing his head again, and start to change. We catch him before it happens.

244

00:13:47,180 --> 00:13:49,180

And how do you break it then?

245

00:13:49,180 --> 00:13:54,180

Well, we just scream a lot. George Schwartz tried to change the subject and try to get him off of it.

246

00:13:54,180 --> 00:13:56,180

Is he aware of this takeover?

247

00:13:56,180 --> 00:14:01,180

Well, he wasn't, but Dr. Schwartz has made him aware of it for special reasons now, certain aspects of it.

248

00:14:01,180 --> 00:14:05,180

How does Schwartz fit into the picture? What's his codification?

249

00:14:05,180 --> 00:14:09,180

Well, Dr. Schwartz is one of the top very prominent psychiatrists in the United States.

250

00:14:09,180 --> 00:14:15,180

And he spent many years investigating the first type of psychic phenomena and contact-a-d cases and so forth.

251

00:14:15,180 --> 00:14:20,180

I've been in touch with him for a while, and he was planning on coming down here anyhow about a week later.

252

00:14:20,180 --> 00:14:26,180

So when this broke and the guy on the verge of suicide, we asked him and he came down early.

253
