I'm going to get a gentleman on the line from Venter, New Jersey who is involved in perhaps

His name is Franky Gargiola and officer, can you hear me okay?

Yes, I can.

6

All right, I'd like to welcome you to our program here on WIND in Chicago.

7

Here is the story that officer in Gargiola is involved in.

8

He was sitting in his patrol car one morning this week.

9

00:00:29,480 --> 00:00:30,480

What's morning was it, Frank?

10

It was Monday night for Tuesday morning.

11

Monday night, he and a news man, a fellow by the name of Femmyshward, he, for all I know,

12

could be a relative of mine, was sitting in your squad car in Benton, New Jersey.

13

Where was your squad car located?

14

00:00:44,480 --> 00:00:47,480

In the intersection of Vassar Square and the Boardwalk.

15

00:00:47,480 --> 00:00:49,480

All right, now there's a body of water there.

16

Is that the ocean?

17

00:00:50,480 --> 00:00:51,480

Yeah, that's correct.

18

00:00:51,480 --> 00:00:53,480

All right, you're right on the ocean.

19

00:00:53,480 --> 00:00:54,480

That's correct.

20

00:00:54,480 --> 00:00:59,480

And these two gentlemen had what we'd call a UFO experience of a place encounter.

21

And I thought I'd call Frank this morning.

22

00:01:02,480 --> 00:01:04,480

The story has been on the National News Lawyers.

23

It's been on network television.

24

00:01:06,480 --> 00:01:08,480

It's been in many newspapers.

25

And now that a couple of days have passed and everybody's had a chance to think it over

and look at some of the drawings that have been made of this object, I thought I'd get

27

a hold of the officer and find out if he's had any kind of solid information developed.

28

Why did you explain to us what happened when you and this news reporter were sitting in

29

your squad car?

30

00:01:29,480 --> 00:01:32,480

Well, it's actually five o'clock in the morning.

31

00:01:32,480 --> 00:01:36,480

And his car was down at Laney Avenue.

32

00:01:36,480 --> 00:01:37,480

And I was giving him a ride home.

33

00:01:37,480 --> 00:01:39,480

We were discussing some of the details.

34

00:01:39,480 --> 00:01:45,480

When we stopped at Vassar Square and the Boardwalk, he had an apartment in a high-rise.

35

00:01:45,480 --> 00:01:52,480

And as soon as I stopped, he had this great object out in the ocean, which he pointed to.

36

And then I noticed it.

37

00:01:54,480 --> 00:02:00,480

And we went up on a boardwalk and that's where we first got a good view of it.

38

00:02:00,480 --> 00:02:03,480

It was off towards the, the venue was connected to Atlantic City.

39

And it was off towards the Atlantic City side of the island.

40

00:02:08,480 --> 00:02:14,480

So we thought we'd take a run down a boardwalk to maybe catch a different view or a little better look

41

of this strange object.

42

So as we proceeded down a boardwalk, we pulled up to the object.

43

We lined up at the police car as far as the passengers' drivers door window was concerned.

44

And then we tried to pass the object and we couldn't.

45

00:02:33,480 --> 00:02:39,480

It just stayed at the driver's door window, which was very hard to understand.

46

00:02:39,480 --> 00:02:43,480

We went as far as, I would say, two miles into Atlantic City.

47

00:02:43,480 --> 00:02:50,480

And the objects wouldn't go behind the car or, you know, in front of it.

48

00:02:50,480 --> 00:02:57,480

So we pulled down one of the larger ramps, which is located on Albany Avenue, you know, in the L.A. City.

49

00:02:57,480 --> 00:02:59,480

It's the main route into the town.

50

00:02:59,480 --> 00:03:04,480

And we sat on a beach for a few minutes just to observe the object.

51

00:03:04,480 --> 00:03:07,480

We didn't really think a whole lot about it at the time.

52

00:03:07,480 --> 00:03:09,480

It could have been anything.

53

00:03:09,480 --> 00:03:16,480

As we were looking at it, I took the sunlight at the police car on the object.

54

00:03:16,480 --> 00:03:20,480

And it appeared, and it didn't even appear, right?

55

00:03:20,480 --> 00:03:24,480

I didn't say it appeared to come in looking at the water's edge.

56

00:03:24,480 --> 00:03:27,480

You know the water breaks and there meets the shoreline.

57

00:03:27,480 --> 00:03:32,480

But that object just came as close as the shoreline.

58

00:03:32,480 --> 00:03:37,480

What would you describe it as? Just a light? Did you see any physical form, officer?

59

00:03:37,480 --> 00:03:41,480

No, sir. No physical form. Neither one of us had a physical form.

60

00:03:41,480 --> 00:03:50,480

There was a long, bright, white object, a approximately 8 foot in diameter.

61

00:03:50,480 --> 00:03:59,480

That's including the yellow piece that was around it, which was placed at 5 of the white object in the center.

62

00:03:59,480 --> 00:04:04,480

How far away was it when it got there? I'd say the closest to you. Is there any way to tell?

63

00:04:04,480 --> 00:04:07,480

I would say it's about 500 feet.

64

00:04:07,480 --> 00:04:10,480

So at 500 feet, it looks to be about 8 feet around you.

65

00:04:10,480 --> 00:04:13,480

I wonder how big it might be in reality then at that distance.

66

00:04:13,480 --> 00:04:15,480

It would be somewhat bigger than would it not?

67

00:04:15,480 --> 00:04:22,480

I would say so. I would say so. But at the time, when the object did get that close,

68

we were sort of in a state of shock, I would say.

69

00:04:26,480 --> 00:04:28,480

What were you hinting to say the least?

70

00:04:28,480 --> 00:04:31,480

It was just unbelievable. I would have never expected it to do that.

71

I would have never toyed with it without sunlight.

72

00:04:35,480 --> 00:04:40,480

Well, soon as we did that, we proceeded back towards the blue rock.

73

I tried radio to the dispatcher to get a landing seat to send a call down to verify it, which they did.

74

00:04:48,480 --> 00:04:57,480

I think there was a approximately 23 officers for about 20 minutes observing the subject, which was fantastic.

75

00:04:57,480 --> 00:05:03,480

Did any of you, the children, try to reattract it with any light, or did you stay away from that?

76

00:05:03,480 --> 00:05:05,480

Well, no. So what happened then?

77

00:05:05,480 --> 00:05:11,480

The object went across my heptamon back out of the sea before the other police cars did arrive.

78

00:05:11,480 --> 00:05:16,480

But I was still clearly saying that on a heptamon, see at a food and a degree area,

79

00:05:16,480 --> 00:05:20,480

nobody tried to attract it back in again.

80

00:05:20,480 --> 00:05:22,480

But I said, I should have been.

81

00:05:22,480 --> 00:05:26,480

How long did this entire UFO encounter last from beginning to end?

82

00:05:26,480 --> 00:05:27,480

One hour.

83

00:05:27,480 --> 00:05:31,480

One hour. Now, what happened? Did it disappear or did you leave the area?

84

00:05:31,480 --> 00:05:36,480

Well, it was disappeared. It disappeared for a period of time and took another spot.

85

00:05:36,480 --> 00:05:38,480

So it finally disappeared and didn't come back?

86

00:05:38,480 --> 00:05:47,480

Well, the last time it was in Brigham Tain, it disappeared at Inventon, so the last time that I had it carried it,

87

00:05:47,480 --> 00:05:50,480

and it almost fit in the blue rock.

88

00:05:50,480 --> 00:05:54,480

So one night, we got a report of Brigham Tain on the radio. It then sighted it.

89

00:05:54,480 --> 00:05:56,480

How far away was that?

90

00:05:56,480 --> 00:05:58,480

Brigham Tain's about five miles away.

91

00:05:58,480 --> 00:06:00,480

I hope a little bit. That's the next time down the coast.

92

00:06:00,480 --> 00:06:04,480

Well, Brigham Tain is on the opposite side of the landing city as we are.

93

00:06:04,480 --> 00:06:05,480

I see.

94

00:06:05,480 --> 00:06:07,480

Alright, so whose side are we there? Police officers again?

95

00:06:07,480 --> 00:06:10,480

Well, police officers are in their radio car.

96

00:06:10,480 --> 00:06:12,480

And they described it just as you did?

97

00:06:12,480 --> 00:06:13,480

That's correct.

98

00:06:13,480 --> 00:06:15,480

Have you ever seen anything like this before?

99

00:06:15,480 --> 00:06:16,480

Yes, sir, I have it.

100

00:06:16,480 --> 00:06:19,480

You normally operate, what, a one-man squad?

101

00:06:19,480 --> 00:06:22,480

Normally, we operate a one-man corps, and that's correct.

102

00:06:22,480 --> 00:06:27,480

Alright, so none of the other officers that you talked to at Tain was before either, huh?

103

00:06:27,480 --> 00:06:28,480

None of them.

104

00:06:28,480 --> 00:06:32,480

What do you think you saw, officer? Have any ideas?

105

00:06:32,480 --> 00:06:37,480

I tell you, I don't know. I really am an expert in the radio operators,

106

00:06:37,480 --> 00:06:42,480

but I can tell you I've seen an extremely bright light that night.

107

00:06:42,480 --> 00:06:47,480

Good manoeuvres in a strange manner,

108

00:06:47,480 --> 00:06:52,480

and I've never seen a light that could turn out to a beacon.

109

00:06:52,480 --> 00:06:56,480

But I can't believe that it would come in and go out the way it was doing.

110

00:06:56,480 --> 00:07:02,480

Have you reported this incident to any agency that might investigate?

111

00:07:02,480 --> 00:07:07,480

For example, here in Chicago, the headquarters are set up for UFO studies,

112

00:07:07,480 --> 00:07:11,480

which is directed by Dr. J. Allen Heimlich, the astronomer at Northwestern University.

113

00:07:11,480 --> 00:07:13,480

Have you made any kind of report?

114

00:07:13,480 --> 00:07:16,480

I've talked to agencies as far as Ohio.

115

00:07:16,480 --> 00:07:19,480

I talked to a faculty of six of them.

116

00:07:19,480 --> 00:07:22,480

They said they saw an experience that I heard from them.

117

00:07:22,480 --> 00:07:26,480

They went and saw it, they personally came here to interview me, take pictures.

118

00:07:26,480 --> 00:07:29,480

I haven't stopped since they're nice.

119

00:07:29,480 --> 00:07:31,480

Who are some of the agencies, do you know?

120

00:07:31,480 --> 00:07:35,480

I've seen it. See, to give you all the different letters,

121

00:07:35,480 --> 00:07:38,480

and they were all abbreviated with gigantic names I couldn't remember.

122

00:07:38,480 --> 00:07:44,480

I understand that in the area, the coastline had some type of station. Is that correct?

123

00:07:44,480 --> 00:07:53,480

That's correct. We have NAFIC, which is one of the biggest experimental air facilities that could possibly date.

124

00:07:53,480 --> 00:07:55,480

Do they have a radar station there?

125

00:07:55,480 --> 00:08:03,480

Yes, they have four radiators in the area, and they said that they could not pick up anything with their radar.

126

00:08:03,480 --> 00:08:06,480

Is it possible this thing was just below their radar?

127

00:08:06,480 --> 00:08:07,480

That's correct. That's correct.

128

00:08:07,480 --> 00:08:10,480

It was lower than our high-rises were flying the beach.

129

00:08:10,480 --> 00:08:13,480

Which means it probably was well below the radar being there.

130

00:08:13,480 --> 00:08:17,480

So you had an UFO experience for an hour. A newsman was with you.

131

00:08:17,480 --> 00:08:21,480

I assume you both read the same conclusion. You don't know what you saw.

132

00:08:21,480 --> 00:08:22,480

That's correct.

133

00:08:22,480 --> 00:08:26,480

There were some 20 other officers at the height of the incident, but they don't know what they saw either.

134

00:08:26,480 --> 00:08:28,480

I'll tell them a little bit, sure.

135

00:08:28,480 --> 00:08:33,480

What is a startup? Is there any type of investigation?

136

00:08:33,480 --> 00:08:36,480

Is there a police department concerned?

137

00:08:36,480 --> 00:08:43,480

As far as the police are concerned, is there any of the UFO agencies that want to pick it up?

138

00:08:43,480 --> 00:08:45,480

They do, so...

139

00:08:45,480 --> 00:08:50,480

As far as any of the air, Air Force agencies are case guard or anything else?

140

00:08:50,480 --> 00:08:53,480

Do they make their routine search and they find nothing?

141

00:08:53,480 --> 00:08:55,480

I don't think anything continues.

142

00:08:55,480 --> 00:09:00,480

Well, I'll tell you there may be a continuation from the UFO studies center up here in Chicago.

143

00:09:00,480 --> 00:09:04,480

What I'm going to do is, after the air, I'll get some info from you.

144

00:09:04,480 --> 00:09:11,480

I'll have Dr. Heineck get in touch with you because you might be able to ask you some questions that some of the other folks have not.

145

00:09:11,480 --> 00:09:14,480

He might be able to give you some idea what you saw.

146

00:09:14,480 --> 00:09:18,480

Now, it did not appear to be any aircraft that you've ever seen before, right?

147

00:09:18,480 --> 00:09:19,480

No, sir. It did not.

148

00:09:19,480 --> 00:09:23,480

I've been in the Navy for eight years and I've been at sea many nights.

149

00:09:23,480 --> 00:09:27,480

And I've spent many watches out at sea and I've never seen anything like it.

150

00:09:27,480 --> 00:09:30,480

Is there any type of airfield in the area there?

151

00:09:30,480 --> 00:09:36,480

We have a landing city airport which is very small. It handles alligating airways.

152

00:09:36,480 --> 00:09:38,480

How close is that to the incident?

153

00:09:38,480 --> 00:09:40,480

I would say two miles.

154

00:09:40,480 --> 00:09:42,480

Did they see an event from their tower?

155

00:09:42,480 --> 00:09:45,480

I don't believe they were asked to look even.

156

00:09:45,480 --> 00:09:48,480

And you didn't hear about them reporting anything anyway?

157

00:09:48,480 --> 00:09:51,480

They do not have a radar tower as far as I know.

158

00:09:51,480 --> 00:09:55,480

I think they called it an open field or something.

159

00:09:55,480 --> 00:09:58,480

It's a non-controlled field.

160

00:09:58,480 --> 00:10:01,480

I understand. How about any people in these high rises?

161

00:10:01,480 --> 00:10:03,480

Anybody get up and look out the window?

162

00:10:03,480 --> 00:10:07,480

Not that I know of. This is a bit of a hard time in the morning.

163

00:10:07,480 --> 00:10:10,480

So I don't think anybody's seen me up at the windows at that time.

164

00:10:10,480 --> 00:10:12,480

Have you been dwelling on these things since it happened?

165

00:10:12,480 --> 00:10:14,480

Has it taken up much of your time?

166

00:10:14,480 --> 00:10:16,480

Well, it's taken up too much of my time to tell you the truth.

167

00:10:16,480 --> 00:10:18,480

It's in the field of my work.

168

00:10:18,480 --> 00:10:24,480

The homes and city hall houses started to climb down after three days.

169

00:10:24,480 --> 00:10:26,480

They've been led up by the Christmas tree.

170

00:10:26,480 --> 00:10:31,480

I suppose you're better at releasing what you know than keeping a...

171

00:10:31,480 --> 00:10:34,480

I presume the following is what you did.

172

00:10:34,480 --> 00:10:37,480

I'd be keeping it to yourself.

173

00:10:37,480 --> 00:10:41,480

No. At first, we're exploring the objects for about...

174

00:10:41,480 --> 00:10:46,480

I would say a good 15 minutes before we radiated in.

175

00:10:46,480 --> 00:10:49,480

Because the audience feels it's anybody's believe it.

176

00:10:49,480 --> 00:10:52,480

But when the object did come as close to the features as it did,

177

00:10:52,480 --> 00:10:59,480

it was necessary to do something about it at the time.

178

00:10:59,480 --> 00:11:01,480

And that's when we did radiating.

179

00:11:01,480 --> 00:11:05,480

And we're more than glad to help on anybody that wanted to try and...

180

00:11:05,480 --> 00:11:07,480

To do it as it is, yeah.

181

00:11:07,480 --> 00:11:10,480

But it moved at you very fast. We were startled.

182

00:11:10,480 --> 00:11:17,480

It happened so fast that you couldn't possibly believe what was happening.

183

00:11:17,480 --> 00:11:19,480

What would you have done if it had come right on you?

184

00:11:19,480 --> 00:11:21,480

You thought it was all about a weapon?

185

00:11:21,480 --> 00:11:25,480

Well, I tried to choose so many things to learn through your mind.

186

00:11:25,480 --> 00:11:28,480

But the thing that learned through my mind, when that did occur,

187

00:11:28,480 --> 00:11:32,480

I knew that the situation around a mic control,

188

00:11:32,480 --> 00:11:36,480

that's the way I felt. Because anything that was that spectacular,

189

00:11:36,480 --> 00:11:38,480

I couldn't control it.

190

00:11:38,480 --> 00:11:42,480

And the last thing I wanted to do would be make it mad.

191

00:11:42,480 --> 00:11:45,480

Whatever it was, right?

192

00:11:45,480 --> 00:11:51,480

I wanted to start seeing it and get a milder lad at me.

193

00:11:51,480 --> 00:11:54,480

Do you guys carry shotguns in the trunks of the slides?

194

00:11:54,480 --> 00:11:55,480

That's correct.

195

00:11:55,480 --> 00:11:59,480

Did you mind at all, think about getting back to the trunk to get you your shotgun?

196

00:11:59,480 --> 00:12:00,480

No, nothing like that.

197

00:12:00,480 --> 00:12:01,480

You didn't think about that?

198

00:12:01,480 --> 00:12:02,480

No.

199

00:12:02,480 --> 00:12:06,480

So here we are a couple of days later and we're still not overdoing it, right?

200

00:12:06,480 --> 00:12:07,480

That's correct.

201

00:12:07,480 --> 00:12:08,480

That's correct.

202

00:12:08,480 --> 00:12:11,480

Have you discussed this with any of the other fellows?

203

00:12:11,480 --> 00:12:15,480

If any of them come up with opinions and the officers are the reporters,

204

00:12:15,480 --> 00:12:17,480

is that anybody trying to explain it?

205

00:12:17,480 --> 00:12:21,480

No, most of the officers take it kind of mildly.

206

00:12:21,480 --> 00:12:24,480

I don't know if they believe in that.

207

00:12:24,480 --> 00:12:27,480

How do you feel now in that one-man squad car,

208

00:12:27,480 --> 00:12:30,480

rolling along the boardwalk early in the morning?

209

00:12:30,480 --> 00:12:32,480

Are you kind of apprehensive at all?

210

00:12:32,480 --> 00:12:35,480

Well, in terms of understanding, you know that as a patient,

211

00:12:35,480 --> 00:12:37,480

you never know what you're going into next.

212

00:12:37,480 --> 00:12:40,480

Some of the milder cars you get turned into,

213

00:12:40,480 --> 00:12:42,480

the more serious ones you see in these.

214

00:12:42,480 --> 00:12:44,480

Have you got your eye on the ocean now?

215

00:12:44,480 --> 00:12:46,480

Are you looking over the water as you drive in?

216

00:12:46,480 --> 00:12:47,480

Everybody does.

217

00:12:47,480 --> 00:12:48,480

There are residents around,

218

00:12:48,480 --> 00:12:50,480

or times they've got up at a food work,

219

00:12:50,480 --> 00:12:51,480

we get phone calls.

220

00:12:51,480 --> 00:12:53,480

If you see anything, give me a call, would you?

221

00:12:53,480 --> 00:12:54,480

It's terrible.

222

00:12:54,480 --> 00:12:59,480

All right, now let's say you saw something like that at five o'clock this morning.

223

00:12:59,480 --> 00:13:00,480

Thank you.

224

00:13:00,480 --> 00:13:02,480

Would you get back on the horn and get people down to watch again,

225

00:13:02,480 --> 00:13:04,480

or what would you do?

226

00:13:04,480 --> 00:13:06,480

Sure, if I said there's people there,

227

00:13:06,480 --> 00:13:09,480

but I'm just saying I do have a camera at the time,

228

00:13:09,480 --> 00:13:12,480

but it's sort of impossible if you have a camera at the time.

229

00:13:12,480 --> 00:13:17,480

Would you try and attract it again with the squad car light if you could?

230

00:13:17,480 --> 00:13:18,480

Of course.

231

00:13:18,480 --> 00:13:23,480

If I had to others around, I could adjust what was going on.

232

00:13:23,480 --> 00:13:25,480

I, Max, and I would do.

233

00:13:25,480 --> 00:13:28,480

In other words, the fear you had before, perhaps, is a little less?

234

00:13:28,480 --> 00:13:29,480

Yeah, that's true.

235

00:13:29,480 --> 00:13:32,480

Well, you've had what we call a UFO experience

236

00:13:32,480 --> 00:13:35,480

or a reasonably close encounter, but not unusual.

237

00:13:35,480 --> 00:13:38,480

Many UFO experiences in the course of a year

238

00:13:38,480 --> 00:13:42,480

happen to people who have jobs such as yours where you're out,

239

00:13:42,480 --> 00:13:45,480

and it's very early in the morning,

240

00:13:45,480 --> 00:13:47,480

and there's not too many people around,

241

00:13:47,480 --> 00:13:49,480

and that's what happened to you.

242

00:13:49,480 --> 00:13:51,480

And you don't know what it is,

243

00:13:51,480 --> 00:13:53,480

but I'll try to maybe hope we'll find out.

244

00:13:53,480 --> 00:13:56,480

Will we be hearing much about this in the future?

245

00:13:56,480 --> 00:13:58,480

Is the television network lucky alone now?

246

00:13:58,480 --> 00:13:59,480

Is there more of that coming up?

247

00:13:59,480 --> 00:14:03,480

No, the TV networks have sort of seized on it.

248

00:14:03,480 --> 00:14:05,480

They'll just carry it more or less the one day

249

00:14:05,480 --> 00:14:07,480

and must have longer instances.

250

00:14:07,480 --> 00:14:11,480

Up in North Korea, there are a few people that have seen the objects

251

00:14:11,480 --> 00:14:14,480

and a few that more people have seen it lately.

252

00:14:14,480 --> 00:14:16,480

But I saw the TV stations,

253

00:14:16,480 --> 00:14:18,480

I just went on to that one day,

254

00:14:18,480 --> 00:14:22,480

and several stations and the tingles dropped off.

255

00:14:22,480 --> 00:14:25,480

I saw you on the CBS television network twice the other day.

256

00:14:25,480 --> 00:14:26,480

Right.

257

00:14:26,480 --> 00:14:29,480

And you were describing it in...

258

00:14:29,480 --> 00:14:30,480

Still in a little bit of shock.

259

00:14:30,480 --> 00:14:33,480

I saw the other conception, the drawing that was made.

260

00:14:33,480 --> 00:14:35,480

Was that made from your description of what you saw?

261

00:14:35,480 --> 00:14:39,480

Well, I saw it a little bit more than what I saw in a little bit of a scanner.

262

00:14:39,480 --> 00:14:41,480

So let it look like a bright light.

263

00:14:41,480 --> 00:14:42,480

Right, exactly.

264

00:14:42,480 --> 00:14:43,480

A bright light.

265

00:14:43,480 --> 00:14:44,480

And round.

266

00:14:44,480 --> 00:14:45,480

All right.

267

00:14:45,480 --> 00:14:48,480

Well, I thank you for the information you've supplied to me,

268
