this story, we're going to the government files and to experts on all sides of the issue.

We're going after facts. In just a few moments, UFO, the enigma of the skies on the Armstrong

Today, we stand on the threshold of outer space. Is space the emptiness we've long believed?

12

It may not be. For life, intelligent life, may already exist somewhere out in the unmeasurable

vastness of space. In a universe containing billions of planets, millions of galaxies,

by the simple law of chance, there must be planets enough like our own to sustain life.

Actually, some authorities have gone so far as to offer evidence that such life does exist.

Here's an example of the evidence they offer. This is the planet Mars with its mysterious

canali, the lines crisscrossing its surface. Forty years ago, first of all Lowell, a distinguished

American astronomer stated that the canali are evidence of intelligent life on Mars.

He said Mars was a dying planet from lack of water and the lines were actually irrigation

canals that the Martians had dug to bring water from the melting polar ice caps into their

parts' planet. Let's look at another example. This is the moon, our nearest neighbor in space,

and the only one our powerful telescopes can carefully survey. For years, astronomers

have been mapping its surface. Some have seen strange things indeed. Here, for example, is

Schroeder's Valley. In 1953, a report was made that a gigantic bridge now stretches across

the region of the moon known as the Marais-Cresium. Scientists charted this region many years ago

and no such bridge was in evidence then. If it's a natural object, why wasn't it seen before?

If it's not a natural object, then what can it be? There are those who claim that its construction

proves the existence of intelligence on the moon, not necessarily moon people but beings

How can we find out about this? Where do we start? Well, we start with background, with history.

Unidentified flying objects are nothing new. The Bible gives us a report of a sighting by

the prophet Ezekiel, a sign in the heavens, large, brilliantly colored in the shape of

a wheel within a wheel. 1554, a mysterious object flashed across the sky near Saint-Saint-Charles-Mont-France.

In 1709, a flock of strange phenomena invaded the skies over Europe.

Today, science explains most of these ancient sightings in terms of natural phenomena, meteors,

shooting stars, comets, or unusual auroral displays. But not too easily explained are some occurrences

of not too long ago. November 23rd, 1896, Oakland, California. A mysterious object appeared in the sky.

A strange cigar-shaped object reportedly witnessed by thousands sailed eastward.

Moving slowly, gathering headlines, the UFO was reported from Salt Lake City, Denver, Omaha,

and finally Chicago, where it sailed off the front page into the unknown.

The first few decades of the 20th century brought few sightings, possibly because the flying saucers

43

took a dim view of this newly invented earthly airplane suddenly trespassing their private

nobain. But in 1947, year two of the atomic age of the real UFO story began. It began here,

the Pacific Northwest, one June morning, 10 years ago, in the vicinity of Mount Rainier,

a C-46 Marine transport plane crashed. Among the volunteer civilians who aided the military

47

searchers was a veteran mountain pilot who had logged thousands of hours of flying in the area.

48

What he saw and reported made international news. Here now is Earth Tunic, a man who over the past

months has literally spent hundreds of hours reading the massive material printed on the subject,

interviewing the people involved. Earth, what was seen near Mount Rainier on that memorable afternoon?

Well, to begin with, Doug, though it's popularly thought that the Mount Rainier incident represents

the opening of the current phase of flying saucer history, that's not quite right.

The fact is that during World War II, a number of military pilots reported rather strange,

rather than objects mysteriously circled or paced their planes in flight.

Now, Air Force Intelligence investigated these reports. That's on the record. However, the incident

56

that did trigger the current interest in UFO was the Mount Rainier occurrence.

With Wilder Mountain pilot was searching for the crash marine transport, that he noticed

58

the terrific blue flash reflect from his airplane. The pilot noticed that the flash came from a chain

59

of rather peculiar looking objects that were approaching Mount Rainier, flying at course

60

at about 170 degrees. Now, he assumed at the time that they were a formation of some new type of jet,

61

but it rather baffled him because they just didn't seem to have any tail.

62

And he judged their wingspan to be about, oh, 120 feet across. The pilot watched them for several minutes.

63

They were traveling from north to south and flying in a rather reversed echelon formation.

64

And as they flew, they weaved in and out between the mountain peaks.

65

They had kind of a skipping motion as they sailed along, and after the sighting,

66

the pilot landed and reported the incident to the local representative of the CAA,

67

00:07:38,000 --> 00:07:43,000

the Civil Aeronautics Administration. The pilot didn't make too much of the incident.

68

He thought they were just a new type of jet. Described them as fluttering, and well,

69

he said they flew like you, took a saucer and skimmed it across the water.

70

And some newspapers printed a rather gobble version of this, and they quoted him as saying

71

that they looked like saucers when he said that they flew in a saucer like fashion.

72

00:08:03,000 --> 00:08:09,000

And that was rather an historic misquote, because that's how the name Flying Saucers came to be.

73

Now, our air forces investigated at the time, and they said no air force or naval aircraft were flying

74

00:08:16,000 --> 00:08:23,000

in the vicinity of Mount Vrigny on that day. The possibility of foreign aircraft being present was just not believable.

75

So the only conclusion that the pilot could come to was that they must be of extraterrestrial origin

76

from another world, another planet.

77

This Mount Vrnigny sighting might have been quickly forgotten, except that within the next 30 days,

78

there were 53 more reports of so-called flying saucers, but making allowances for illusion,

79

00:08:46,000 --> 00:08:54,000

delusion, hoax, and hallucination, there remained enough incredible reports by credible observers

80

to set people thinking. They came from every section of the country, San Fernando, California,

81

Boulder, Colorado, Washington, D.C., Greenwich Point, Long Island.

82

And if anyone was less than serious about flying saucers, the tragic Mantell incident that Godman field,

83

Fort Knox, Kentucky, gave them real cause to reflect.

84

On January 7, 1948, early in the afternoon, Kentucky State Police reported an unidentified flying object,

85

circular in appearance, moving westward at a good cliff.

86

The UFO was also sighted by the commanding officer of Godman Field.

87

The control tower at the field checked and found no experimental aircraft in the neighborhood.

88

Just at this time, a flight of F-51s under the command of Captain Thomas Mantell,

89

a veteran combat pilot, neared the field and was immediately vectored in on a strange, spherical shaped object.

90

What happened then depends upon what version you read.

91

There were seven witnesses in Godman Tower, and there are accounts differ in many details, but this is sure.

92

Captain Mantell, by radio, reported sighting the object above him.

93

He said it was a metallic thing in a tremendous size.

94

00:10:14,000 --> 00:10:18,000

Mantell's plane was not equipped with oxygen, and yet he headed upward.

95

00:10:18,000 --> 00:10:22,000

By 15,000 feet, his wingman had broken off.

96

00:10:22,000 --> 00:10:28,000

Mantell was in a maximum climb at 22,500, his plane under perfect control.

97

Well, from this point on, there's nothing but mystery.

98

The transmission was garbled and attempts to contact Mantell went unanswered.

99

Mantell's plane began to level off at 30,000 feet, began a gradual turn to the left,

100

and then it nose downward, and at full power began to dive.

101

Between 10,000 and 20,000 feet, the plane literally tore apart.

102

Mantell was killed. Parts of his plane were found more than half a mile from the wreckage.

103

And are there questions that must be answered about this tragic incident?

104

Why did an experienced pilot like Mantell break one of the cardinal rules of flying,

105

00:11:07,000 --> 00:11:10,000

never go above 10,000 feet without oxygen?

106

00:11:10,000 --> 00:11:15,000

What did he see that forced him to throw caution to the winds?

107

00:11:15,000 --> 00:11:20,000

After the Mantell crash, UFO reports continued to pile in.

108

00:11:20,000 --> 00:11:26,000

During January and February of 1948, the sightings took on an international flavor.

109

00:11:26,000 --> 00:11:33,000

Falls of fire traveling slowly across the sky were reported from Norway, Denmark, Sweden, Germany,

110

00:11:33,000 --> 00:11:37,000

then Southern Europe chimed in, and then South America.

111

00:11:37,000 --> 00:11:45,000

On July 21, a report came in from Holland of a UFO, rocket-shaped, with two rows of windows along the sides.

112

00:11:45,000 --> 00:11:50,000

This might have been forgotten fast, except for what happened just one week later.

113

00:11:50,000 --> 00:11:57,000

On July 24, 1948, a commercial airliner flying from Houston, Texas to Atlanta,

114

00:11:57,000 --> 00:12:06,000

was 20 miles southwest of Montgomery, Alabama, at the controls Clarence S. Chiles and his co-pilot John B. Whithid.

115

00:12:06,000 --> 00:12:12,000

At 2.45 in the morning, these veteran flyers saw light dead ahead and closing in fast,

116

00:12:12,000 --> 00:12:16,000

traveling at a speed estimated between 500 and 700 miles an hour.

117

00:12:16,000 --> 00:12:20,000

The light bore in on them. The rocket-shaped object was brilliantly lighted,

118

00:12:20,000 --> 00:12:24,000

and it appeared to have two rows of windows underneath.

119

00:12:24,000 --> 00:12:28,000

From the belly of the ship, there was a sort of a blue fluorescent glow.

120

00:12:28,000 --> 00:12:34,000

As they watched, fascinated, the object flashed by about 700 feet to their right.

121

On landing, Chiles and Whithid reported the incident to the proper authorities,

122

00:12:38,000 --> 00:12:42,000

and then each drew a sketch of what he'd seen.

123

00:12:42,000 --> 00:12:45,000

This is the child sketch.

124

00:12:48,000 --> 00:12:54,000

Double windows in size about twice the diameter of a B29.

125

And this is the sketch drawn by a co-pilot, Whithid.

126

The same general shape with double row of windows, or what appear to be windows, no wings.

127

00:13:09,000 --> 00:13:11,000

What was it?

128

00:13:11,000 --> 00:13:17,000

To this day, according to the two pilots involved, no logical explanation offered by scientists,

129

00:13:17,000 --> 00:13:20,000

by experts, fits the bill.

130

00:13:20,000 --> 00:13:25,000

People may argue about what they saw, but they can't deny that they saw something.

131

00:13:25,000 --> 00:13:29,000

Something that these men, with thousands of hours of flying experience,

132

00:13:29,000 --> 00:13:33,000

had never seen before and haven't seen since.

133

Well, is there an explanation, a reasonable, natural explanation

134

for the mysterious objects seen by so many credible observers over the past ten years?

135

For this?

136

Or this?

137

To get the official Air Force point of view, we're going directly to the source,

138

directly to the Air Force files that have been thrown open to us.

139

Can every sighting be reasonably explained, or must we accept the proposition, the fact,

140

00:14:04,000 --> 00:14:08,000

that at least some of these objects originate in outer space,

141

00:14:08,000 --> 00:14:13,000

and that our Earth is now being observed by creatures from another world?

142

00:14:13,000 --> 00:14:18,000

Fairly a day passes by that sightings of flying saucers are reported.

143

00:14:18,000 --> 00:14:23,000

People are seeing something. Something is there.

144

00:14:23,000 --> 00:14:31,000

An employee of a supersonic laboratory saw a thick, ruddered object shaped like this.

145

00:14:31,000 --> 00:14:36,000

Two airline pilots spotted a round object with portholes and planks,

146

00:14:36,000 --> 00:14:43,000

two airline pilots spotted a round object with portholes and flashing lights.

147

00:14:43,000 --> 00:14:52,000

A group of college professors in Lubbock, Texas saw these lights moving across the sky.

148

00:14:52,000 --> 00:14:58,000

Authorities have been accused of dropping a paper curtain on this problem,

149

00:14:58,000 --> 00:15:02,000

issuing statements hiding the true facts from the public.

150

00:15:02,000 --> 00:15:04,000

What are the facts?

151

00:15:04,000 --> 00:15:07,000

Here's the evidence. Where do we go for our story?

152

Right Patterson Air Force Base, Dayton, Ohio, location of the Air Technical Intelligence Center,

153

00:15:13,000 --> 00:15:17,000

Air Force collecting point for all UFO sighting reports.

154

00:15:17,000 --> 00:15:22,000

The outfit chart with the responsibility of analyzing all flying saucer data.

155

00:15:22,000 --> 00:15:28,000

Project Lubbock, since January 1953, the investigation work of Project Lubbock

156

00:15:28,000 --> 00:15:34,000

has had the services of the 42nd-oh-second Air Intelligence Service Squadron, Air Defense Command,

157

00:15:34,000 --> 00:15:39,000

that's a highly trained field investigation outfit, with field units scattered around the country,

158

00:15:39,000 --> 00:15:46,000

so deployed that they can arrive on the spot almost immediately after a sighting is reported to them.

159

00:15:46,000 --> 00:15:51,000

Over 6,000 reported flying saucer sightings since 1947,

160

00:15:51,000 --> 00:15:56,000

each sighting, investigative and analyzed by specialists in top-notch military

161

00:15:56,000 --> 00:16:01,000

and non-military scientific personnel at Wright-Patterson.

162

00:16:01,000 --> 00:16:05,000

We get the full promise, the full cooperation from the Air Force,

163

00:16:05,000 --> 00:16:09,000

and to explain how the Air Force reaches certain conclusions on certain sightings,

164

00:16:09,000 --> 00:16:14,000

the Air Force has detailed to us Lieutenant Colonel Spencer Whedon,

165

00:16:14,000 --> 00:16:19,000

Chief of the Air Intelligence Office, Air Technical Intelligence Center.

166

00:16:19,000 --> 00:16:26,000

He will explain these files, many of which were hitherto classified, but now thrown open to us.

167

00:16:26,000 --> 00:16:33,000

This, for instance, is the complete file on the Mantell case, the tragic incident we talked about earlier.

168

00:16:33,000 --> 00:16:39,000

Originally it was reported that Mantell might have mistaken the planet Venus for a UFO

169

00:16:39,000 --> 00:16:43,000

flown too high, blacked out and crashed.

170

00:16:43,000 --> 00:16:47,000

Colonel, I understand the Air Force no longer holds to that opinion.

171

00:16:47,000 --> 00:16:54,000

No, we don't, Mr. Edwards. We still believe that he blacked out from lack of oxygen and crashed,

172

00:16:54,000 --> 00:16:59,000

and this is supported by findings of the Air Force accident investigators,

173

00:16:59,000 --> 00:17:02,000

an outfit completely independent of Project Blue Book.

174

00:17:02,000 --> 00:17:08,000

But we are now sure that this is what he was chasing, a skyhook balloon,

175

00:17:08,000 --> 00:17:14,000

a giant 100-foot balloon used to gather information about the upper air,

176

00:17:14,000 --> 00:17:19,000

cosmic radiation, wind flow, temperature.

177

00:17:19,000 --> 00:17:24,000

In 1948, these were top secret, you knew about them.

178

00:17:24,000 --> 00:17:32,000

Later, the investigation revealed that in January 1948, that is the time of the Mantell crash,

179

00:17:32,000 --> 00:17:40,000

these skyhook balloons were being launched from Clinton County Air Force Base in Southern Ohio.

180

00:17:41,000 --> 00:17:48,000

We examined a weather map showing wind direction on 7 January 1948.

181

00:17:48,000 --> 00:17:52,000

Starting here at Clinton County Air Force Base,

182

00:17:52,000 --> 00:17:58,000

prevailing winds would have carried the balloon west for a while as it climbed.

183

00:17:58,000 --> 00:18:08,000

At about 35,000 feet, the balloon would have entered the wind jet stream, flowing south.

184

00:18:08,000 --> 00:18:13,000

It would have moved rapidly south, still climbing.

185

00:18:13,000 --> 00:18:20,000

At a point south to southwest of gun Air Force Base here,

186

00:18:20,000 --> 00:18:25,000

it would have climbed up out of the jet stream into a calm belt,

187

00:18:25,000 --> 00:18:31,000

and from there it would have drifted very slowly south and southeast,

188

00:18:31,000 --> 00:18:35,000

directly over the area where the UFO was spotted.

189

00:18:35,000 --> 00:18:42,000

The Colonel, you believe it's possible for trained observers, pilots like Captain Mantell,

190

00:18:42,000 --> 00:18:46,000

to see a balloon and not recognize it as such?

191

00:18:46,000 --> 00:18:51,000

Certainly, Mr. Edwards, in a period when balloons of that size were rare,

192

00:18:51,000 --> 00:18:56,000

a balloon can be sent into an almost horizontal position by strong wind currents.

193

00:18:56,000 --> 00:19:03,000

During the day, a balloon can look like this, but visibility can play tricks.

194

00:19:03,000 --> 00:19:08,000

The same balloon at twilight or dawn can look like this.

195

00:19:08,000 --> 00:19:11,000

Angle of vision is important.

196

00:19:11,000 --> 00:19:14,000

Now this sighting, reported over Minneapolis,

197

00:19:14,000 --> 00:19:21,000

photographed with the gun camera of an F-86 fighter, also turned out to be a balloon.

198

00:19:21,000 --> 00:19:23,000

And here's another.

199

00:19:23,000 --> 00:19:30,000

A balloon launched in Japan was tracked by government facilities all the way across the Pacific.

200

00:19:30,000 --> 00:19:35,000

It meandered all over the country before it finally sailed off into the Atlantic.

201

00:19:35,000 --> 00:19:39,000

This resulted in literally dozens of UFO reports.

202

00:19:39,000 --> 00:19:41,000

On that basis then, Colonel Wheaton,

203

00:19:41,000 --> 00:19:46,000

some large percentage of flying saucer reports are actually nothing but balloons, right?

204

00:19:46,000 --> 00:19:48,000

Oh, right, Mr. Edwards.

205

00:19:48,000 --> 00:19:54,000

They can show that balloons account for 26.4% of all recent UFO sightings.

206

00:19:54,000 --> 00:19:57,000

Well, let's take another case.

207

00:19:57,000 --> 00:20:03,000

Three objects observed, round shaped, steady white light, no trail or exhaust,

208

00:20:03,000 --> 00:20:07,000

moving slowly southwest of Macon, Georgia.

209

00:20:07,000 --> 00:20:12,000

Weather clear and visibility unlimited, photographs made and available.

210

00:20:12,000 --> 00:20:15,000

No interception or identification action taken,

211

00:20:15,000 --> 00:20:19,000

no air traffic in general area at time of sighting.

212

00:20:19,000 --> 00:20:21,000

What about this case, Colonel?

213

00:20:21,000 --> 00:20:24,000

Well, the first thing we did was to get a map.

214

00:20:24,000 --> 00:20:29,000

Now, here's West Macon, Georgia.

215

00:20:29,000 --> 00:20:31,000

And here's Fort Benning.

216

00:20:31,000 --> 00:20:36,000

We immediately established that training operations were being conducted at Benning.

217

00:20:36,000 --> 00:20:41,000

Part of the operation was the dropping of parachute flares from aircraft,

218

00:20:41,000 --> 00:20:44,000

as well as jet support for our ground operations.

219

00:20:44,000 --> 00:20:48,000

We obtained the photographs mentioned in the report.

220

00:20:48,000 --> 00:20:54,000

Using a new photo analysis technique, we managed to get some surprising results.

221

The first slide showed little more than two brilliant dots,

The bright object is the flame from the jets after burn.

Oh, conventional aircraft often seem to be what they are not.

This is the plane flying at high speed in a fog-shrouded sky.

Speed causes a moisture condensation around the wings,

228

which gives the appearance of a disk or saucer.

229

Planes of unorthodox configuration, a swept wing or delta jobs.

230

00:21:35,000 --> 00:21:43,000

Or this radar plane called the flying pancake, give rise to many UFO sightings.

231

Based on our latest reports, the cases where aircraft have been reported as UFOs account for 28.8%.

232

Another case now, spring 1957.

233

The commercial airliner flying between New York and Puerto Rico had an extraordinary experience.

234

Flying at 19,000 feet, it sighted a large bright object that appeared to be coming directly towards the liner.

235

It was described as a magnesium flash in color with a pale green tint.

236

The pilot had to swerve his plane violently to avoid collision.

237

What does the Air Force have to say about it, Colonel?

238

Well, a check of military positions in the area ruled out any unusual plane or missile activity.

239

However, the Civil Air Naughty Squad did report six other commercial flights,

240

over approximately the same area at the time of the sighting.

241

Five of the six planes reported similar sightings.

Flooding their positions on a map showed all the planes that sighted the same object.

The major clues we had to work on were the color, the trajectory,

and the fact that three of the planes reported that the object seemed to split apart from the air.

This description coincides with the known features of what are called bow lights or fireballs.

Rather rare astronomical phenomena, but reported from time to time and especially from the southwest.

And so the Air Force attributes this sighting to a fireball, right?

248

Oh, it wasn't only our finding, Mr. Edwards.

249

We submitted all the data to a member of the Smithsonian Astrophysical Observatory,

250

who confirmed our conclusions completely.

251

Do these astronomical phenomena play a large part in the UFO story?

252

Pretty large. The moon and the planets, observed through haze, light fog or moving clouds.

253

All these things can play optical tricks.

254

And then there are the rarest celestial sights, mirages, rural displays.

255

Or how about this, caused by an Air Force photographic mission over Richmond at the end,

and actually a subsun effect.

A rare aerial phenomenon caused by the reflection of the sun's rays on suspended ice particles.

Strange or unusual weather tricks not only fool the eye,

but such supposedly foolproof mechanical marvels as radar.

260

Temperature inversion, where a massive cold air collides with a layer of warm air.

261

Or even thunder clouds sometimes come up on the radar scope as blips.

262

One minute you see them, and the next moment you don't.

263

Even the most experienced radar operator can be fooled by these.

264

We attribute 24.4 percent current UFO sightings to astronomical phenomena.

265

Well, here's another case, Colonel Whedon. The date? August 1955, the place Kentucky.

266

Now, according to press reports, an entire family was besieged all night by goblin-like creatures

267

reported to have emerged from a flying saucer that landed nearby.

Here is a sketch of one of these extraterrestrial visitors drawn by a local artist

269

and sworn to as accurate by the family.

270

One of your investigators didn't get a chance to interview him, did he, Colonel?

271

No, unfortunately he didn't seem to be around, Mr. Edwards.

272

We did interview the family.

273

00:25:23,000 --> 00:25:27,000

They had spent the evening attending a spirited meeting.

274

They'd all undergone a tremendous emotional experience which,

275

quite possibly, might account for the incident.

276

I suppose this whole UFO situation is complicated by crackpots, publicity seekers, and hoaxers, is it not?

277

Oh, it definitely is, Mr. Edwards.

278

One of the roughest areas involves the so-called contact sightings.

279

People who claim to have spoken to creatures from flying saucers.

Some who claim to have written in them.

And one, at least, who was whooshed off to Venus.

And they're married into Venusian royals.

Oh, what a trip.

A whole cult is drawn up around these contact incidents.

And woe to him who dares to question.

Doesn't the Air Force question, Colonel?

Well, we never go on the assumption that anything is a fraud.

We put all material sent to us through the analysis mill.

Cleverness knows no end in this flying saucer business.

Here's a beauty.

291

Enlargement reveals strange lines coming from the object.

292

And further enlargement shows these lines to be part of the corner ceiling of a room.

293

The saucer turned out to be a light fixture.

294

00:26:40,000 --> 00:26:42,000

Oh, here's a flying saucer.

295

It turned out to be a flying hat.

296

And here's a real fry.

297

Supposedly a UFO.

298

Fixed up by a sky science teacher.

299

Looks very, very formidable. A genuine Sputnik, maybe, Colonel?

Well, afraid not, Mr. Edwards.

Whoever made it went through a lot of trouble trying to letter Russian words on the inside,

302

but they got the letters wrong and forgot to remove the name of the New Jersey manufacturer from the tubes.

I see the words there, and the tubes.

304

There's nothing but a hodgepodge of wires inside.

There are no real circuits. They don't go any place.

To finish it off, to give the effect that this thing went through space, I suppose,

Still a rather neat job for those of us not up on our Sputniks.

In the total picture, Colonel, what percentage of current UFO reports does the Air Force classify

as hoaxes?

When we lump this category into a general heading, along with sightings that turn out to be birds, search lights, and so on.

They add up to 6.4 percent.

317

And can ATIC solve all UFO reports referred to it?

318

No. Many sightings come to us with insufficient data.

Fertinent items of information missing.

No precise description of size, shape, or color of the object.

Without knowing direction and altitude, time and location, wind and weather conditions, we cannot reach a valid conclusion.

322

The Air Force provides every observer of a UFO with a detailed questionnaire.

323

The answer is kept in confidence if it is so desired.

324

But we must have full information if a sighting is to get a complete analysis.

325

Sightings that come to us with insufficient information account for 12.1 percent of all current UFO reports.

326

Colonel, let's do a little arithmetic.

327

A little rapid calculation here.

328

00:29:25,000 --> 00:29:35,000

Adding these percentages, if it comes out right, let's see, it would figure out to 98.1 percent.

329

Now, that's a large percentage, but it's not 100 percent.

330

That still leaves 1.9 percent.

331

Still to be explained.

Let 1.9 percent remain.

333

It represents the cases the Air Force classifies as unknown, and this category is different from insufficient information, I take it.

Well, take the child sighting you mentioned earlier.

Yet after the most careful study and analysis, we cannot fit it into any of our regular categories.

It doesn't appear to have been a balloon, a plane of any kind.

Nor does it put the circumstances of an astronomical phenomenon.

341

In view of this, that is sufficient data, but no logical explanation.

342

We classify it as a true unknown.

343

00:30:28,000 --> 00:30:33,000

Now, this doesn't happen often, but when it does happen, we don't dodge the issue.

344

It's an unknown and so listed.

345

00:30:37,000 --> 00:30:49,000

Unknown, not because it's anything new and strange, but simply because we can't identify it with the particular normal phenomenon it undoubtedly is.

346

Not too high a figure.

347

00:30:51,000 --> 00:30:54,000

Little less than 2 percent.

348

00:30:54,000 --> 00:30:56,000

Two out of a hundred.

349

Yet, if even only one in a hundred represented an object of interplanetary origin,

350

00:31:02,000 --> 00:31:07,000

we still would have to call this the biggest news of this or any century.

351

What's the opinion of those who believe in flying saucers about that 2 percent?

352

00:31:12,000 --> 00:31:18,000

Or for that matter, what about their opinion of the Air Force Analysis Program Project Blue Book?

353

There's several sides to every story.

354

00:31:20,000 --> 00:31:22,000

You've heard only one.

355

00:31:23,000 --> 00:31:35,000

Unknown is defined in the dictionary as not discovered, not identified, not brought to knowledge.

356

00:31:35,000 --> 00:31:44,000

After 10 years of investigation and analysis, the Air Force still lists a small percentage of UFO sightings flying saucers as unknown.

357

00:31:44,000 --> 00:31:51,000

But to many who have become intensely involved in the puzzle of UFO, this figure seems utterly unrealistic.

358

00:31:51,000 --> 00:31:59,000

Of the scores of private, non-government organizations that are devoted to UFO, possibly the most

active and eminent,

359

00:31:59,000 --> 00:32:04,000

is the National Investigations Committee on Aerial Phenomena of Washington, D.C.

360

00:32:04,000 --> 00:32:08,000

On its board of governors are a number of outstanding citizens.

361

00:32:08,000 --> 00:32:13,000

Among them are Vice Admiral R.H. Hillenkoater, former head of the Central Intelligence Agency,

362

00:32:14,000 --> 00:32:22,000

Rear Admiral H.B. Knowles, U.S. Navy retired, Major Dewey Fornay Jr., former Air Force UFO investigator.

363

00:32:22,000 --> 00:32:28,000

Its director is Major Donald E. Kehoe, anapolis graduate and a former Marine Corps pilot,

364

00:32:28,000 --> 00:32:31,000

author of Flying Saucers from Outer Space.

365

00:32:31,000 --> 00:32:38,000

Well, Major, you've seen our report on the Air Force conclusions dealing with the current UFO sightings.

366

00:32:38,000 --> 00:32:42,000

They've narrowed the unknowns down to 1.9 percent.

367

00:32:42,000 --> 00:32:44,000

How do you feel about that figure?

368

00:32:44,000 --> 00:32:49,000

Well, even if you accept that figure, Mr. Edwards, there's one thing you have to remember.

369

00:32:49,000 --> 00:32:52,000

It covers only the last two months of sightings.

370

00:32:52,000 --> 00:33:01,000

Actually, the figure for all unknowns since 1947, using official Air Force statistics, is over 12 percent.

371

Now, that is based on this official Air Force record known as Project Blue Book,

372

and tables which you will find showing various percentages over the years.

373

Out of the 6,000 cases investigated by the Air Force, 700 still remain unknown.

374

It comes down to this.

Either all of the hundreds of skilled observers, that means pilots, missile trackers, radar operators, and astronomers,

376

were either deluded or incompetent, or they saw exactly what they reported.

377

I think everyone will agree that deluded pilots would have been grounded very quickly,

378

00:33:41,000 --> 00:33:44,000

and imminent radar men would have been fired.

379

00:33:44,000 --> 00:33:47,000

Not one such case is on record.

380

00:33:47,000 --> 00:33:54,000

Our National Investigations Committee has hundreds of UFO reports from highly trained observers

381

describing real objects maneuvering under intelligent control.

382

00:33:58,000 --> 00:34:01,000

Real objects under intelligent control,

383

00:34:01,000 --> 00:34:06,000

the implication being that they originate in outer space, that's for sure.

384

00:34:06,000 --> 00:34:11,000

Well, actually, that is a probability which is shared by many pilots and many scientists,

385

00:34:11,000 --> 00:34:15,000

including, for instance, Professor Herman Oberth, a great rocket designer.

386

00:34:15,000 --> 00:34:19,000

So we must agree that it is a probability.

387

00:34:19,000 --> 00:34:25,000

Well, all right. We'd like to hear the evidence on which you base this particular assumption, Major.

388

00:34:25,000 --> 00:34:31,000

Fine. And I want to begin by saying that all the cases I intend to cite are known to the Air Force.

389

I also want to point out that our analysts on the committee include astronomers,

390

missile engineers, pilots, radar men, former intelligence officers, and experts in many associated fields.

May 1954, Dallas, Texas.

A flight of four Marine Corps jets commanded by Major Charles Scarborough,

cited in broad daylight a formation of 16 discs flying in groups of four.

395

When the jets tried to box in these discs, they climbed a terrific speed and disappeared.

396

Here's a quote from Major Scarborough.

397

00:35:14,000 --> 00:35:18,000

These discs were real. They flew at incredible speeds.

398

00:35:18,000 --> 00:35:20,000

Another case.

399

November 1957, Long Beach, California.

400

00:35:24,000 --> 00:35:29,000

Major Lewis F. Baker, commanding officer of the Air Force Weather Station at Long Beach,

401

00:35:29,000 --> 00:35:34,000

along with two other Air Force weather experts, and 10 airmen.

402

00:35:34,000 --> 00:35:42,000

This group saw a formation of six discs making terrifically fast turns and maneuvering at an

altitude of 7,000 feet.

403

00:35:42,000 --> 00:35:48,000

They appeared to be larger, according to Major Baker, than a twin-engine airliner.

404

00:35:48,000 --> 00:35:53,000

Statements from Major Baker. They were circular in the color of spun aluminum.

405

They changed course instantaneously.

406

00:35:56,000 --> 00:35:59,000

A case in 1952.

407

00:35:59,000 --> 00:36:03,000

This was from Captain William B. Nash, a veteran airline pilot.

408

He and his co-pilot cited a formation of eight 100-foot discs flying in echelon below their plane.

409

00:36:10,000 --> 00:36:14,000

Captain Nash told me personally,

410

00:36:14,000 --> 00:36:19,000

I am convinced these were machines from outer space.

411

00:36:19,000 --> 00:36:21,000

End quote.

412

00:36:21,000 --> 00:36:26,000

Our committee agrees with the announcement of the Air Force on this particular case.

413

00:36:26,000 --> 00:36:28,000

Objects unknown.

414

00:36:28,000 --> 00:36:31,000

Let's take another. Another commercial airliner case.

415

00:36:31,000 --> 00:36:35,000

This one, this airliner was flying near South Bend, Indiana.

416

00:36:35,000 --> 00:36:39,000

At the controls was a veteran, Captain Robert Adicus.

417

00:36:39,000 --> 00:36:45,000

Adicus is crew and 10 passengers, so a spherical object pacing the plane.

418

00:36:45,000 --> 00:36:50,000

When Adicus tried to close in, the UFO accelerated and raced out of sight.

419

00:36:50,000 --> 00:36:53,000

A quote from Captain Adicus.

420

00:36:53,000 --> 00:36:56,000

Before then, I wasn't convinced by the saucer reports.

421

00:36:56,000 --> 00:36:59,000

Now I know they do exist.

422

00:36:59,000 --> 00:37:01,000

Let me show you one more case.

423

00:37:01,000 --> 00:37:05,000

This from an eminent astronomer, Dr. Clyde Tombow.

424

00:37:05,000 --> 00:37:08,000

Discover of the planet Pluto.

425

00:37:08,000 --> 00:37:16,000

Dr. Tombow cited a cigar-shaped object with what appeared to be windows and moving at tremendous speed.

426

00:37:16,000 --> 00:37:27,000

Now note how similar this object is to the one cited by Captain Charles and Whithitt that you mentioned earlier.

427

00:37:27,000 --> 00:37:36,000

Dr. Tombow, these things which do appear to be directed are unlike any other phenomena I ever observed.

428

Other stars in our galaxy may have hundreds of thousands of inhabitable worlds.

429

00:37:41,000 --> 00:37:50,000

Races on these worlds may have been able to utilize the tremendous amounts of power required to bridge the space between the stars.

430

End quote.

431

00:37:51,000 --> 00:37:56,000

These cases you've cited, Major, from the files of the National Investigating Committee.

432

00:37:56,000 --> 00:38:01,000

You also have some analyses on some of the cases the Air Force discussed earlier, have you?

433

00:38:01,000 --> 00:38:05,000

Yes, we do, and I'd like very much to go into two of them.

434

00:38:05,000 --> 00:38:07,000

First, the Mantell case.

435

00:38:07,000 --> 00:38:13,000

A Project Blue Book says that or suggests that Mantell died chasing a skyhook balloon.

436

00:38:13,000 --> 00:38:20,000

The Air Force has never provided any record of a balloon being launched on the day Mantell crashed.

437

00:38:20,000 --> 00:38:28,000

There is absolutely no record that any Air Force or Navy balloon was launched then from Clinton Air Force Base or any other station.

438

00:38:28,000 --> 00:38:34,000

Now, any project in a top secret category must keep detailed, accurate records.

439

00:38:34,000 --> 00:38:37,000

It's not any casual operation.

440

00:38:37,000 --> 00:38:41,000

Yet no such report has ever been produced.

441

00:38:41,000 --> 00:38:44,000

And now another point which I believe is conclusive.

442

The Air Force tells us that the balloon hovered over Godwin Field for two hours, almost motionless.

443

00:38:50,000 --> 00:38:59,000

Minutes after Mantell's disappearance, one of his wingmen, equipped with oxygen, took off and searched the entire area for 100 miles.

444

00:38:59,000 --> 00:39:01,000

He found absolutely nothing.

445

00:39:01,000 --> 00:39:04,000

Now what happened to the balloon?

446

00:39:04,000 --> 00:39:09,000

The searching plane was an F-51, which could fly at 350 miles per hour.

447

00:39:09,000 --> 00:39:16,000

Any slowly moving balloon would have been sighted in minutes, but the sky was completely empty.

448

00:39:17,000 --> 00:39:20,000

Now just a word about another case the Air Force presented.

449

This was the airliner which flew between New York and Puerto Rico and which Project Blue Book says,

450

00:39:27,000 --> 00:39:33,000

sighted a bow-eyed or fireball, which caused the pilot to zoom to miss it.

451

Now when we investigated, we found that the similar non-explored disagreed entirely with that conclusion.

452

The professional astronomers, the CAB consulted, said there was no evidence that this UFO was a fireball or a meteor.

453

00:39:48,000 --> 00:39:56,000

Our committee agrees that this case is an unknown, just like the tragic Mantell incident.

454

Well now Major, you believe that the massive weight of evidence proves that flying saucers are real?

Professor of Astrophysics and Director of the Observatory at Harvard University and author of Flying Saucers published by the Harvard University Press.

Professor Menzel, in your considered opinion, has our atmosphere been invaded by spaceships, flying objects originating in outer space?

475

No, emphatically no.

476

Now I don't quarrel with the assumption that there is life on other planets.

477

As I have stated on a number of occasions, life, even human or superhuman life, may exist in millions of places in the universe.

478

And I also concede that space travel for earthlings is imminent.

479

But these two facts can't justify the conclusion that flying saucers represent space travel in reverse.

480

And yet tonight we've heard a good bit of evidence that UFO unidentified flying objects do exist, Professor.

481

They are unidentified flying objects only because of mistaken identity. In fact, they're often not even objects.

That is why I prefer the name flying saucer to the term unidentified flying objects, which implies that they are material or tangible.

The observations, and most particularly the interpretation of these observations, is strictly a scientific matter.

You wouldn't call in a carpenter to diagnose a pain in your stomach.

485

Well, why call in untrained laymen when you want to diagnose a strange occurrence in the sky?

486

And strange things do occur, all the time.

487

I think Project Blue Book hasn't paid enough attention to aerial phenomena in its analysis work.

488

Merages, ice crystal reflections, even cloud formations such as this one, these can undo account for many UFO reports.

489

It's understandable that untrained observers are startled when they see unusual occurrences in the sky.

490

It even happens to many of us who have studied the heavens for years. It happened to me.

491

Let me give you the bare details. Just three years ago when I was flying from the North Pole to Alaska,

492

I saw an object pop over the horizon and buzzed my plane twice.

493

Then it stopped and flew along parallel to it, at an apparent distance of 300 feet.

494

I judged it to be about two feet in diameter. It seemed to have flashing red and green lights and something looked like a lighted propeller on the top.

Did you ever find out what it was?

496

Certainly, as soon as I got over the initial shock, I did a little calm analyzing.

497

The mysterious saucer proved to be a mirage of the bright star Sirius.

498

Actually, the star was slightly below the horizon.

499

But the queer bending of light by the atmosphere, called refraction, had brought it into view.

500

Distortion and diffusion caused by alternate layers of warm and cold air had added the finishing touches,

501

creating a bizarre pulsating whirling effect similar to the twinkling of a star.

That was the answer to my saucer and to a lot of other people's saucers I'd like to bet.

503

And I've seen hundreds of other saucers from dozens of causes.

504

For instance, high-flying spider webs, owls that glow in the dark.

505

In other words, Professor, if more people were astronomers, there'd be fewer flying saucers.

506

Fewer flying saucers and a lot less declauding of the issue by over-eager amateurs.

507

Earlier in the program, you mentioned the reported sighting of a bridge on the Maura Cresium region

of the moon.

508

Now, that's my special field.

509

I'm now preparing some new lunar maps for a field guide to the skies that will soon be published.

510

The first man who reported that bridge, an amateur, used only a four-inch telescope.

511

Now, that's like using a BB gun in an elephant hunt.

512

00:45:37,000 --> 00:45:44,000

I've examined that area with the Harvard 15-inch telescope, and there is no bridge there.

513

Here's a photograph of the Maura Cresium region taken with the 12-inch telescope at Griffith Observatory.

514

An untrained observer might possibly interpret this fan of light as coming from under a bridge.

515

Actually, it is light shining through a well-known deep pass bordered by high peaks.

516

No bridge exists.

517

00:46:06,000 --> 00:46:15,000

This only emphasizes the importance of careful observation by experienced people who are capable of evaluating what they see.

518

Well, let's agree that astronomers are best equipped to evaluate aerial phenomena.

519

But wouldn't you agree that pilots, meteorologists, are also trained observers, and many of them have reported UFOs?

520

No, they're not trained observers in this sense.

521

A pilot can observe a plane and know what it is.

522

A meteorologist can spot a cloud and not be fooled, but many things occur in the sky that are completely beyond the knowledge or experience of many pilots or weathermen.

523

Mirages, moxons, caused by the reflection from ice crystals, they're fairly uncommon, but when they do happen, only trained scientists can recognize them and understand them.

524

If a pilot swerves his plane to avoid a fireball that misses him by hundreds of miles, or if he fails to identify a sun dog, that doesn't mean he's incompetent as a flyer.

525

I think Mantell didn't die chasing a balloon, nor I do. I think he died chasing a spaceship.

526

I believe he mistook some sort of aerial phenomenon, a moxon perhaps for a flying saucer.

527

I believe he mistook some sort of aerial phenomenon, a moxon perhaps for a flying saucer, one that's too high and crashed.

528

Well, summing up then, Professor, you feel that all the flying saucers reported in the past ten and a half years, even before that,

529

including the 1.9% of the Air Force classifies as unknown, can be explained then as completely natural occurrence.

530

I most certainly do. And I think the Air Force has been put upon in this whole affair.

531

They've had to make their investigation, of course. They're bound by the most serious of considerations, the security of our country. But it's gone far enough.

In my opinion, it's not the reports of the flying saucers that should be analyzed. It's the non-qualified interpreters themselves who argue that these saucers come from outer space.

Thank you, Dr. Mantell. We've given the facts, we've had the opinions. What about our own conclusions?

Well, for thousands of years, man has been studying his own body, and yet today, he can only explain about 25% of bodily functions.

It's only 350 years since Galileo invented the telescope. Certainly, there must be much in the heavens left to be explained.

Perhaps in time, the enigma of the skies, flying saucers, will be explained to the satisfaction of all.

This evening, we've given you the facts as we've found them. We leave them with you. What do you think?

In just a few moments, the Honorable Richard E. Horner, Assistant Secretary of the Air Force for Research and Development, will bring you a summary of the Air Force's position and the report by a special scientific panel.

Now, the Honorable Richard E. Horner, Assistant Secretary of the Air Force for Research and Development.

Thank you, Mr. Edwards. During recent years, there has been a mistaken belief that the Air Force has been hiding from the public information concerning unidentified flying objects.

541

Nothing could be further from the truth. And I do not qualify this statement in any way.

The activities of the International Geophysical Year, which is serving to focus more trained eyes on the skies than ever before, climaxes 10 years of Air Force investigation of UFO sightings.

All but a small percentage of these reports have been definitely attributed to natural phenomena that are neither mysterious nor dire.

544

A report of a special scientific panel on UFOs assembled at the request of the United States government concludes that the evidence shows no indication that these phenomena constitute a direct physical threat to national security.

545

They find no evidence that UFOs are capable of hostile acts. They find no evidence that UFOs indicate a need for revision of current scientific concepts.

546

00:50:44,000 --> 00:50:53,000

And finally, they recommend that the subject be stripped of the aura of mystery it has unfortunately acquired.

547

00:50:54,000 --> 00:51:09,000

The panel's findings coincide completely with the announced position of the Air Force. There is no evidence at hand that objects popularly known as flying saucers actually exist.

548

Not a single speck of material evidence, not a fragment of a flying saucer has ever been found.

549

00:51:18,000 --> 00:51:26,000

This does not mean that the Air Force can or will be complacent about UFO reports.

550

We will continue our program of detailed investigation of all UFO sightings and invite everyone who observes an object in the sky he sincerely cannot identify or explain to report it immediately to the nearest Air Force activity.
