Ladies and gentlemen, according to the United States Air Force, in following a policy which

But in their UFO reports, or after they have made them, the Air Force has stated that they

7

did not see what they thought they saw and in effect they are incompetent.

8

The same thing applies to several hundred radar officers, radar men, plastic controllers

9

and others who are responsible for bringing you in safely, particularly in bad weather,

10

to the terminals and major airports.

11

It also applies to missile trackers, rocket trackers and in general to competent, reliable

12

citizens around the country.

13

Now if you add them all up, you will find there are at least 100,000 people in this

14

country embracing almost every trade and profession, besides all the military and all

15

the flying personnel who simply cannot be trusted, their judgment cannot be trusted at

16

least in regard to what they see in the sky.

17

This is not an attack on the Air Force spokesman or the project spokesman.

18

They are simply following orders to explain away all UFO sightings as quickly as possible

19

when they become public and deny that UFOs really exist.

20

00:01:48,680 --> 00:01:54,840

Over a period of nine years, we have gathered about 8,000 reports of which at least 1,500

21

00:01:54,840 --> 00:01:58,440

dozen come from extremely competent witnesses.

22

00:01:58,440 --> 00:02:03,920

We have reports from pilots on every major airline, all the military forces, the tower

23

00:02:03,920 --> 00:02:12,440

operators I was mentioning, astronomers, scientists, engineers, a very good level of American citizens.

24

Now these have been evaluated, these sightings have been evaluated by our staff, by scientists,

25

00:02:20,360 --> 00:02:22,360

engineers and their various fields.

26

The majority conclusion is that these things are real and under intelligent control.

27

In that group which has reached that conclusion, there is another group and that is the majority

28

00:02:34,400 --> 00:02:40,320

of that one which believes that these things must be extraterrestrial because they are

29

00:02:40,400 --> 00:02:43,040

so far superior to anything we have.

30

They base this on absolutely tracked speeds by radar, visual tracking and combinations.

31

Either all of these witnesses, every one of them, all of the thousands of witnesses here

32

and abroad are absolutely wrong, honestly wrong, but they are wrong.

33

They are unable to distinguish what they see in the sky.

34

I am talking about pilots now.

35

They cannot read radar scopes as well as they should.

36

They can't track things with the Sun and the other lights or modern tracking devices.

37

They make mistakes.

All of them are wrong.

39

Not one single man is right or else these things are real and there is secrecy and the

40

fact you are being withheld.

41

We have a report here that we prepared two years ago.

42

It is about 200,000 words.

43

00:03:40,520 --> 00:03:46,720

It contains names, details and dates of sightings by all the people or many of the people I

44

00:03:46,720 --> 00:03:48,520

mentioned.

45

00:03:48,520 --> 00:03:49,520

You read that.

46

00:03:49,520 --> 00:03:54,920

I don't think you can come out of a complete reading of that without believing that it is

47

00:03:54,920 --> 00:03:56,000

probable.

48

00:03:56,000 --> 00:04:00,840

You may not be completely convinced, but you will not be a complete skeptic as incidentally

49

00:04:00,840 --> 00:04:05,640

well as when I started in on this years ago.

50

00:04:05,640 --> 00:04:12,040

As a result of this policy to explain away, you will read about a sighting and then almost

51

00:04:12,040 --> 00:04:18,040

instantly or within 24 hours you will read something like swamp gas.

52

00:04:18,040 --> 00:04:25,760

This case, the recent case up in Michigan was investigated rather briefly by the Air Force

53

00:04:25,760 --> 00:04:31,760

and the statement was released by Dr. J. Allen Heineck who is the number one Air Force investigator.

54

He said that what these witnesses saw was swamp gas.

55

00:04:36,120 --> 00:04:39,720

They all have denied it because they were familiar with swamp gas.

56

00:04:39,720 --> 00:04:45,080

Since then we have made a preliminary investigation into the characteristics of swamp gas.

57

00:04:45,080 --> 00:04:51,280

It is not completed, but so far it doesn't seem possible that this could have been anything

58

00:04:51,280 --> 00:04:52,280

of the kind.

59

00:04:52,280 --> 00:04:53,280

It doesn't conform.

60

00:04:53,280 --> 00:05:02,080

There are also press reports that Dr. Heineck was pushed into making this statement publicly.

61

He has since denied that he was pressured.

62

00:05:04,360 --> 00:05:11,400

However, there have been cases from my personal knowledge that I know that people spokesmen

63

for the project are on the Air Force press desk and this was sometimes back said that

64

00:05:16,760 --> 00:05:22,360

they had to answer these cases if they could and sometimes it was embarrassing because

65

they knew that the answers wouldn't stand up.

66

In many cases they have had to retract them and go back to some other answers.

67

Recently in the famous Exeter case up in New Hampshire and probably most of you are familiar

68

with that, the Air Force did publish an answer and later retracted it.

69

For those of you who may not be familiar, this was a report by two veteran policemen

70

of Exeter New Hampshire and a teenager about 19 years old who first saw this device and

71

00:05:55,400 --> 00:05:56,400

went to the police.

72

00:05:56,400 --> 00:06:02,480

They went out to the scene and skeptically and when they got there they found exactly

73

00:06:02,480 --> 00:06:03,480

what he had described.

74

00:06:03,480 --> 00:06:09,040

A very large object having closed to the ground with lights flashing in sequence creating

75

00:06:09,040 --> 00:06:13,760

such a blinding glare that it lit up the ground for about 300 feet.

76

00:06:13,760 --> 00:06:20,600

It even caused animals in nearby buildings which couldn't see this object to get upset,

77

00:06:20,600 --> 00:06:25,480

horses kicking their stalls and wining and so on.

78

00:06:25,480 --> 00:06:31,480

We made this report public and it was picked up by John Fuller of Sederdy Review of Literature

79

00:06:31,480 --> 00:06:34,000

and later published in Look.

80

00:06:34,000 --> 00:06:40,040

Somehow that had more effect than any group of sightings that we put out in the last five

81

00:06:40,040 --> 00:06:41,360

years.

82

00:06:41,360 --> 00:06:46,680

Probably because of his prestige and the fact that he didn't have any edge to grind.

83

00:06:46,680 --> 00:06:50,400

He really went up there and taped interviews with all of the witnesses and came back and

84

00:06:50,400 --> 00:06:55,240

said there seems to be no doubt that this thing was there and it's real.

85

00:06:55,240 --> 00:07:01,760

The Air Force at first said that this was a mistake caused by low flying aircraft.

86

00:07:01,760 --> 00:07:07,240

Later they have put out this statement in an official letter but not in a release.

87

00:07:07,240 --> 00:07:14,360

Because of nightcap publicity, our first report, it was picked up by newscasters and program

88

00:07:14,360 --> 00:07:21,960

directors and magazines and widely publicized so they reexamined it.

89

00:07:21,960 --> 00:07:28,000

What they did, they went back to the police officers and queried them over again and the

90

00:07:28,000 --> 00:07:31,960

police officers were very much incensed by being called incompetent.

91

00:07:31,960 --> 00:07:35,240

They stated, well this was wrong.

92

00:07:35,240 --> 00:07:36,960

They were not low flying aircraft.

93

00:07:37,000 --> 00:07:40,120

This was definitely an unidentified flying object.

94

00:07:40,120 --> 00:07:44,600

The same thing happened in another case that very same night which is not so well known

95

00:07:44,600 --> 00:07:45,600

down in Texas.

96

00:07:45,600 --> 00:07:52,200

On the night of September 3rd two deputy sheriffs saw strange objects in the sky and they parked

97

00:07:52,200 --> 00:07:56,040

their cruiser with the lights on into the side of the highway to watch it.

98

00:07:56,040 --> 00:08:05,000

It came down toward them and when it was about 150 or 200 feet away the light was still bright

99

00:08:05,040 --> 00:08:08,120

and the object was so near they could feel heat from it.

100

00:08:08,120 --> 00:08:12,520

One of the sheriffs immediately started the car and they went down the highway at 110

101

00:08:12,520 --> 00:08:13,520

miles an hour.

102

00:08:13,520 --> 00:08:20,160

Now this is from the signed report that they gave to the Air Force and also to us.

103

00:08:20,160 --> 00:08:23,600

Then after a while they thought well maybe we better go back and take another look.

104

00:08:23,600 --> 00:08:28,280

So they went back, the object was there, it came toward them again and once more they

105

00:08:28,280 --> 00:08:31,240

went down the highway at over 100 miles an hour.

106

00:08:31,240 --> 00:08:37,880

Now these men aren't, they're not kids and they're men who are old enough to have had

107

00:08:37,880 --> 00:08:43,440

a lot of experience in handling criminals and all sorts of law work.

108

00:08:43,440 --> 00:08:47,720

But they were frightened, they were actually terrified and they didn't mind saying so.

109

00:08:47,720 --> 00:08:52,240

Now repeatedly there have been cases where these things have come close to observers

110

00:08:52,240 --> 00:08:53,240

on the ground.

111

00:08:53,240 --> 00:08:55,520

They've come close to automobiles.

112

00:08:55,520 --> 00:09:00,320

Several times they have come down in front and actually touched down on highways or else

113

00:09:00,320 --> 00:09:03,120

they've come very close to it.

114

00:09:03,120 --> 00:09:08,040

In several instances causing drivers to run off the road or go into the ditch.

115

00:09:08,040 --> 00:09:13,280

All of these things added up show that there has been within the last year a noticeable

116

00:09:13,280 --> 00:09:18,000

increase in very close approaches and touch landing.

117

00:09:18,000 --> 00:09:20,120

Not only here but abroad.

118

00:09:20,120 --> 00:09:29,000

Over in South Africa last year in the fall there was a touch landing in, I forgot the

119

00:09:29,000 --> 00:09:35,680

name of the town but at least it was down in South Africa and two constables saw this.

120

00:09:35,680 --> 00:09:39,760

Their headlights fell on the Al Digny and got a very good picture of it.

121

00:09:39,760 --> 00:09:44,640

As they got a little nearer they blasted the flame, discharged from the bottom of this

122

00:09:44,640 --> 00:09:47,080

thing and it rose very swiftly and disappeared.

123

00:09:47,080 --> 00:09:52,760

But where it had been, the blast of flame or the weight of the Al Digny both had broken

124

00:09:52,760 --> 00:09:58,520

through the pavement and scorched, left a very hot fire and scorched the area for some

125

00:09:58,520 --> 00:09:59,520

feet around.

126

00:09:59,520 --> 00:10:05,560

Now this is an official report and it was confirmed by one of the government officials

127

00:10:05,560 --> 00:10:08,840

in that area and it's still being investigated.

128

00:10:08,840 --> 00:10:14,760

I named these few cases or I described them to show you that in contrast to all of the

129

00:10:14,760 --> 00:10:21,760

ridicule to read about, I met a golden haired spaceman and talked with him by sign language

130

00:10:21,760 --> 00:10:27,240

and telepathy and he took me up to Venus, to Mars, to the moon and we had a wonderful

131

time and all that and he told me they were here to save us from ourselves.

132

We constantly fight to expose all these crack spots and to get the serious evidence on record.

133

Now there is at present an increasing wave of sightings within the last 72 hours new

134

reports have come in including one more from up near Ann Arbor, Michigan.

135

Three witnesses in that case were included a research professor on a NASA space agency

136

00:10:57,880 --> 00:11:03,440

project, an electronic expert and an electrical engineer.

137

00:11:03,440 --> 00:11:10,080

He described this object as about 30 feet in diameter, six feet thick at the center

138

00:11:10,080 --> 00:11:13,480

and emitting a blinding red glow.

139

00:11:13,480 --> 00:11:18,560

Now this is somewhat similar to the Exeter case.

140

00:11:18,560 --> 00:11:25,080

There have been cases since then in Colorado, Maryland, Florida, down in the Gulf of Mexico

141

00:11:25,080 --> 00:11:28,760

where a Coast Guard crew is supposed to have seen an object.

142

00:11:28,760 --> 00:11:33,360

We're still checking that one and it looks as though there's going to be another flare

143

00:11:33,360 --> 00:11:39,120

up which may extend all around the country, not only here but abroad.

144

00:11:39,120 --> 00:11:47,040

Now I repeat all of these people are either deluded, self-deluded, some of them are frauds

145

00:11:47,040 --> 00:11:49,840

or they're simply, honestly mistaken.

146

00:11:49,840 --> 00:11:56,680

As we think in NYCAP and our Board of Governors has voted unanimously on this subject that

147

00:11:56,680 --> 00:12:03,760

it is time to end the secrecy, bring the material out in the open and if we're wrong that will

148

00:12:03,760 --> 00:12:11,160

end it and if they're wrong it's going to open up one of the greatest developments in

149

00:12:11,160 --> 00:12:12,160

century.

150

00:12:13,040 --> 00:12:18,760

I was talking with Representative Gerald Ford, the minority leader, after his statement to

151

00:12:18,760 --> 00:12:24,880

the press and on Face the Nation yesterday and he said, I see nothing but benefit from

152

00:12:24,880 --> 00:12:27,840

a full congressional investigation.

153

00:12:27,840 --> 00:12:34,280

If the Air Force is right this will strengthen them and it will end all of this controversy.

154

00:12:34,280 --> 00:12:39,520

If they're wrong it should be criticized, witnesses should be brought in.

155

00:12:39,520 --> 00:12:44,040

The whole thing should be openly investigated because people are, at least some people,

156

00:12:44,040 --> 00:12:47,000

are getting a little bit concerned about this.

157

00:12:47,000 --> 00:12:50,960

In some cases it's even worse than concern, it's actual fear.

158

00:12:50,960 --> 00:12:56,360

There have been a few cases where people have been so frightened they've actually fired

159

00:12:56,360 --> 00:13:01,880

at these objects which when they appeared near their cars or hovered close to the ground.

160

00:13:01,880 --> 00:13:08,520

In case any of you have not seen this, later on we will try to provide each of you with

161

00:13:08,520 --> 00:13:14,640

a copy of this called the UFO evidence which will show the names of pilots on all major

162

00:13:14,640 --> 00:13:20,640

airlines and many military officers and also the conclusions of scientists and others who

163

00:13:20,640 --> 00:13:23,240

have examined this evidence.

164

00:13:23,240 --> 00:13:29,960

We are now recommending that the government set up an instrumented network around the

165

00:13:29,960 --> 00:13:36,840

country which can track these objects so that they can be passed from one tracking station

166

00:13:36,920 --> 00:13:39,080

to another across the country.

167

00:13:39,080 --> 00:13:44,480

Their speeds, their courses and even the shapes can be identified and within a very short

168

00:13:44,480 --> 00:13:51,720

time you'd have a mass of accurate data which you could release to the public and also the

169

00:13:51,720 --> 00:13:57,360

scientists who could then go into the various aspects of this problem.

170

00:13:57,360 --> 00:14:03,560

One thing it would prove is that these machines or devices or whatever they are move at speeds

171

00:14:03,560 --> 00:14:07,480

far exceeding anything that we have, it can move in our atmosphere.

172

00:14:07,480 --> 00:14:14,880

They've been tracked up to 18,000 miles an hour at white sands moving in our atmosphere

173

00:14:14,880 --> 00:14:18,280

50 miles above the ground.

174

00:14:18,280 --> 00:14:24,200

Now an ordinary conventional machine moving at that speed at that height would certainly

175

00:14:24,200 --> 00:14:25,680

burn up.

176

00:14:25,680 --> 00:14:32,800

Furthermore no conventional machine could make such violent turns, climbs and descents

177

00:14:32,800 --> 00:14:35,880

as these things have been tracked and doing.

178

00:14:35,880 --> 00:14:41,920

The print lately has been of great value and great help to those who believe these things

179

00:14:41,920 --> 00:14:49,160

are real and that's a serious problem and has caused a general reversal among thousands

180

00:14:49,160 --> 00:14:52,080

and I believe hundreds of thousands of people.

181

00:14:52,080 --> 00:14:58,080

We have collected editorials from newspapers all around the country and in magazines from

182

00:14:58,080 --> 00:15:06,040

the Christian Science Monitor on the Saturday Review and others stating that this seems

183

00:15:06,040 --> 00:15:11,040

to be a serious problem, it is real and the government should be looking into it.

184

00:15:11,040 --> 00:15:14,380

As a result of this we are even getting hidden reports.

185

00:15:14,380 --> 00:15:18,760

People have been sitting on citing reports for years for fear of being ridiculed and

186

00:15:18,760 --> 00:15:24,520

now they are sending them in saying well it looks as though you don't have to be called

187

00:15:24,520 --> 00:15:28,040

a fool to say that you've seen one of these objects.

188

00:15:28,200 --> 00:15:38,200

Several aspects of UFO operations which can be handled by various members of our staff

189

00:15:38,200 --> 00:15:46,640

here, for instance radar cracking, electromagnetic interference and other aspects.

190

00:15:46,640 --> 00:15:55,480

Before I turn the meeting over to questions I would like to emphasize one thing.

191

00:15:55,560 --> 00:16:02,280

There are about 50 members of Congress already on record who have told us that they believe

192

00:16:02,280 --> 00:16:04,400

this is not a joke.

193

00:16:04,400 --> 00:16:10,480

It is, many of them have said they would support hearings if they were brought up.

194

00:16:10,480 --> 00:16:16,600

If this thing suddenly does come to the point of hearings you are going to see and you are

195

00:16:16,600 --> 00:16:23,080

going to hear some of the most amazing testimony from veteran pilots, people in the government,

196

00:16:23,160 --> 00:16:30,560

FBI agents, legislators, incidentally newsmen, editors and newscasters.

197

00:16:30,560 --> 00:16:33,000

Quite a number of them have reported seeing these things.

198

00:16:33,000 --> 00:16:36,040

Some of them come out in the open and some don't.

199

00:16:36,040 --> 00:16:42,440

I think you will eventually find that there is substantial evidence that we are being

200

00:16:42,440 --> 00:16:50,400

observed by some type of device which is ahead of us, far ahead of us and is probably controlled

201

00:16:50,400 --> 00:16:54,640

by a highly advanced superior civilization.

202

00:16:54,640 --> 00:17:00,480

Now this is a conclusion which I personally have stated and is shared by some members

203

00:17:00,480 --> 00:17:04,840

of our board of governors and advisors, not all of them.

204

00:17:04,840 --> 00:17:10,240

It has reached to the point where many people in the Air Force have the same conclusion.

205

00:17:10,240 --> 00:17:14,800

In fact the Air Force at one time had a top secret estimate that these things were interplanetary

206

00:17:14,800 --> 00:17:17,000

spaceships.

207

00:17:17,000 --> 00:17:23,560

This was confirmed to us by the head of the project at that time and also by the monitor

208

00:17:23,560 --> 00:17:27,880

of the Air Force project who is now on our board of governors.

209

00:17:27,880 --> 00:17:35,560

You will see that this instead of being a sub-diparidicule and a big joke actually is

210

00:17:35,560 --> 00:17:39,880

a serious matter which could affect the lives of all of us.

211

00:17:39,880 --> 00:17:46,600

Dr. Charles Olivier, president of the American Meteor Society, without taking any stand on

212

00:17:46,600 --> 00:17:53,840

the extraterrestrial nature of these objects, has said that there is no question that the

213

00:17:53,840 --> 00:17:58,440

information has been withheld and witnesses are ridiculed.

214

00:17:58,440 --> 00:18:05,040

The problem should be brought out into the open, examined scientifically and the public

215

00:18:05,040 --> 00:18:08,560

given the facts which have been hidden from them to this time.

216

00:18:08,560 --> 00:18:14,240

Now I would like to open this meeting for questions and I will try to answer some of

217

00:18:14,240 --> 00:18:19,000

them and turn others over to the people who are more qualified to answer them.

218

00:18:19,000 --> 00:18:31,200

Well I was told back in 1952 at a time when they were preparing to release their motion

219

00:18:31,200 --> 00:18:37,120

in cases that at first, at the very first, they feared perhaps the Russians had gotten

220

00:18:37,120 --> 00:18:40,200

ahead of us with the aid of captured German scientists.

221

00:18:40,640 --> 00:18:46,640

I very shortly realized that was impossible because Russia had hardly started to rebuild

222

00:18:46,640 --> 00:18:47,640

its factories.

223

00:18:47,640 --> 00:18:54,320

So the only alternative was that all these reports were wrong or else these things must

224

00:18:54,320 --> 00:18:57,240

be interplanetary.

225

00:18:57,240 --> 00:19:04,040

If so, such an admission might frighten people so it was decided best to go underwrap.

226

00:19:04,040 --> 00:19:11,600

The project was set up which was labeled secret and openly the reports were played down inside

227

00:19:11,600 --> 00:19:12,600

the project.

228

00:19:12,600 --> 00:19:16,400

They were considered very serious and as I say there was a majority conclusion that they

229

00:19:16,400 --> 00:19:17,400

were interplanetary.

230

00:19:17,400 --> 00:19:24,840

In 1953, early in 1953, the plan to tell the people what we had, not announce any conclusion

231

00:19:24,840 --> 00:19:32,560

but tell them that we did have evidence of extraterrestrial operation, that was canceled

232

00:19:32,560 --> 00:19:38,840

because there was a sudden outbreak of sightings and intelligence Colonel Hyup and the directorate

233

00:19:38,840 --> 00:19:43,640

said we would be in serious trouble announcing they were probably real without any idea of

234

00:19:43,640 --> 00:19:45,320

their purpose here.

235

00:19:45,320 --> 00:19:49,400

So it's been an often on movement within the Air Force.

236

00:19:49,400 --> 00:19:52,840

Some people in the Air Force believe that you should come out and tell everything you

237

00:19:52,840 --> 00:19:58,400

have, people should be told, since there's actually no evidence of any danger or hostility

238

00:19:58,400 --> 00:20:03,680

and others say don't tell anybody anything do we know more of the answers.

239

00:20:03,680 --> 00:20:10,320

It may be asking everyone to take an open mind and yet you seem to be precluding any chance

240

00:20:10,320 --> 00:20:14,160

of the Air Force convincing you that these are not real.

241

00:20:14,160 --> 00:20:21,520

Well we have studied of this but we ought to and the government ought to make it known

242

00:20:21,520 --> 00:20:22,520

to the public.

243

00:20:22,520 --> 00:20:25,760

They're not giving the Air Force a chance to say maybe they're not real.

244

00:20:25,760 --> 00:20:31,320

We have I think every Air Force statement going back to the opening of the project,

245

an executive order from the Pentagon telling people to use the equipment they already have?

374
