We received a call about 10.30 from the State Police Barracks of the county.

2

And I had talked to the trooper who had just came back from the scene of this incident.

3

And he felt that something definitely had going on.

4

00:00:18,000 --> 00:00:24,000

And the main person involved in it, the former son who had seen the creatures,

5

00:00:24,000 --> 00:00:28,000

who shot at them was at the barracks at the time, so I questioned him over the phone.

6

00:00:28,000 --> 00:00:32,000

And they had indicated that the object had landed and was sitting on the ground,

7

00:00:32,000 --> 00:00:37,000

and the creatures had been seen, and that there was a glowing area, glowing ring,

8

00:00:37,000 --> 00:00:41,000

that was apparent after the object had disappeared.

9

00:00:41,000 --> 00:00:47,000

So we got together, Phil team, we had Dave Smith who's a physics teacher and

10

00:00:47,000 --> 00:00:49,000

facility defense radiation defense officer.

11

00:00:49,000 --> 00:00:55,000

We had a professional photographer, George Loots, who is the co-director of our group,

12

00:00:55,000 --> 00:00:58,000

who's a former Air Force pilot and the major near force reserves.

13

00:00:58,000 --> 00:01:01,000

I can't think we had a sociology major with us myself.

14

00:01:01,000 --> 00:01:06,000

We went out, we made arrangements to meet with the farmer's son who's 22 years old,

15

00:01:06,000 --> 00:01:09,000

who was the main witness, but he looks much older for his age.

16

00:01:09,000 --> 00:01:15,000

He's about 6'2", weighs about 270 pounds from around there, 280 pounds.

17

00:01:15,000 --> 00:01:16,000

How was the following day?

18

00:01:16,000 --> 00:01:19,000

That was that night, a couple hours after the incident occurred.

19

00:01:19,000 --> 00:01:21,000

The incident occurred at 9 o'clock.

20

00:01:21,000 --> 00:01:22,000

And you were there about 11?

21

00:01:22,000 --> 00:01:27,000

Well, they caught us about 10.30 until we got up there, about an hour drive.

22

00:01:27,000 --> 00:01:31,000

I told them we got there around 12.30, and until we got to the scene,

23

00:01:31,000 --> 00:01:33,000

it was about 1 o'clock in the morning.

24

00:01:33,000 --> 00:01:36,000

But anyhow, before we got to the scene, we interviewed them,

25

00:01:36,000 --> 00:01:40,000

and here we later had about 9 o'clock, about 15 of the people in the area

26

00:01:40,000 --> 00:01:45,000

had seen a glowing red ball in the sky, spherical, and slowly descending towards the ground.

27

00:01:45,000 --> 00:01:51,000

So this fellow, George, and these two 11-year-old twins were down the road.

28

00:01:51,000 --> 00:01:54,000

They ran to his house, and they got a .30-gut 6-rifle,

29

00:01:54,000 --> 00:01:59,000

and they proceeded up in his truck up the back road towards the pasture area.

30

00:01:59,000 --> 00:02:02,000

And they could see the object slowly descending towards the ground,

31

00:02:02,000 --> 00:02:05,000

and it was getting larger, of course, as it came down.

32

00:02:05,000 --> 00:02:07,000

There were headlights and the trucks started to dim,

33

00:02:07,000 --> 00:02:11,000

and they were just going up toward the top of the hill, the horizon, the hill,

34

00:02:11,000 --> 00:02:13,000

and disappeared over the horizon.

35

00:02:13,000 --> 00:02:15,000

So they got out of their truck and started walking up the hill,

36

00:02:15,000 --> 00:02:17,000

and they could see it sitting on the pasture,

37

00:02:17,000 --> 00:02:20,000

apparently right on the ground, or else inches above it.

38

They said it was much larger than the house, about 100 feet in diameter,

39

00:02:23,000 --> 00:02:29,000

and it was like a dome or a bubble shape thing, and it was bright and white at this time.

40

00:02:29,000 --> 00:02:32,000

It was making it sound like a wild lawnmower.

41

00:02:32,000 --> 00:02:35,000

Their eyes started to water a little from the brightness of it,

42

00:02:35,000 --> 00:02:40,000

and then they heard these loud screaming sounds coming from the vicinity of the craft.

43

00:02:40,000 --> 00:02:43,000

It sounded like a lady's scream or whatever, unusual screaming sounds.

44

00:02:43,000 --> 00:02:46,000

And then after about a minute or so, one of the boys yelled at her

45

00:02:46,000 --> 00:02:48,000

with something moving up along the fence line,

46

00:02:48,000 --> 00:02:51,000

so they pointed up there, which was opposite where the craft was on the ground,

47

00:02:51,000 --> 00:02:54,000

and there were these two figures walking towards them.

48

00:02:54,000 --> 00:02:58,000

At first they couldn't tell exactly what they were.

49

00:02:58,000 --> 00:03:01,000

They assumed they were bears, but from the light of the craft,

50

00:03:01,000 --> 00:03:05,000

and also this fellow had two military tracers around,

51

00:03:05,000 --> 00:03:08,000

which he fired directly over their head,

52

00:03:08,000 --> 00:03:11,000

and just let up for a second, but it gave them some more insight into what they were observing.

53

00:03:11,000 --> 00:03:15,000

Anyhow, they were then able to make out at least one figure,

54

00:03:15,000 --> 00:03:18,000

and the figure was about eight feet tall and the other one around seven foot.

55

00:03:18,000 --> 00:03:20,000

They were described very similar to the other creatures,

56

00:03:20,000 --> 00:03:23,000

completely covered from hair from head to toe,

57

00:03:23,000 --> 00:03:26,000

long arms almost reaching to the ground,

58

00:03:26,000 --> 00:03:28,000

they're making crying sounds on each other.

59

00:03:28,000 --> 00:03:31,000

There was a small, like burning tire, burning rubber,

60

00:03:31,000 --> 00:03:34,000

and they had, in these cases, glowing green eyes,

61

00:03:34,000 --> 00:03:37,000

which we had another case of beaver falls a week later,

62

00:03:37,000 --> 00:03:40,000

of a landing and creatures being seen.

63

00:03:40,000 --> 00:03:43,000

Anyhow, he fired a tracer round over their head,

64

00:03:43,000 --> 00:03:46,000

and he fired a warning shot, a .30 out of six, over their head,

65

00:03:46,000 --> 00:03:49,000

to see if they would slow down, but they kept approaching two of them,

66

00:03:49,000 --> 00:03:51,000

they were about 60 feet away.

67

00:03:51,000 --> 00:03:54,000

One of the boys, upon seeing this, ran, became hysterical,

68

00:03:54,000 --> 00:03:56,000

and the other boy stayed with George.

69

00:03:56,000 --> 00:03:59,000

Then he fired directly into the larger creature.

70

00:03:59,000 --> 00:04:02,000

Each time he hit it, it made a lot of crying sounds,

71

00:04:02,000 --> 00:04:04,000

and then finally it raised its right hand up,

72

00:04:04,000 --> 00:04:08,000

almost touching the smaller creature, which was walking in front of it,

73

00:04:08,000 --> 00:04:10,000

and all of a sudden as it raised its hand,

74

00:04:10,000 --> 00:04:12,000

the object in the field just disappeared.

75

00:04:12,000 --> 00:04:15,000

The light just went out and disappeared, and the sound stopped,

76

00:04:15,000 --> 00:04:17,000

and then the creature slowly turned around,

77

00:04:17,000 --> 00:04:19,000

and started walking back into the woods.

78

00:04:19,000 --> 00:04:21,000

So at this point, they were both quite shook up,

79

00:04:21,000 --> 00:04:24,000

and they ran back, called the State Police,

80

00:04:24,000 --> 00:04:27,000

and State Trooper came out to the area,

81

00:04:27,000 --> 00:04:30,000

and George went back up with him.

82

00:04:30,000 --> 00:04:33,000

He went and notified the State Police,

83

00:04:33,000 --> 00:04:36,000

and State Trooper went back to the area, I believe,

84

00:04:36,000 --> 00:04:40,000

around 10.30, I think he went out there around 10.30,

85

00:04:40,000 --> 00:04:43,000

until he got called by radio to go out to the area.

86

00:04:43,000 --> 00:04:45,000

And George told him what he had seen,

87

00:04:45,000 --> 00:04:47,000

the Trooper proceeded up to the area.

88

00:04:47,000 --> 00:04:50,000

Trooper verified that they did see what appeared to be a glowing ring,

89

00:04:50,000 --> 00:04:53,000

about 150 feet in diameter, where the object had been sitting,

90

00:04:53,000 --> 00:04:56,000

and he said that the ring was bright enough

91

00:04:56,000 --> 00:05:01,000

that if you sat down in it, you could read a newspaper, buy it.

92

00:05:01,000 --> 00:05:05,000

It was only glowing from a height of about one foot off the ground,

93

00:05:05,000 --> 00:05:08,000

but he also said that he could see the small plants

94

00:05:08,000 --> 00:05:12,000

inside of the glowing area, so it was fairly bright.

95

00:05:12,000 --> 00:05:14,000

No, this was the Police Agency that did that.

96

00:05:14,000 --> 00:05:16,000

The State Trooper was with him. They both saw that.

97

00:05:16,000 --> 00:05:19,000

And he said they were walking up along the woods

98

00:05:19,000 --> 00:05:21,000

where George had seen the creatures,

99

00:05:21,000 --> 00:05:23,000

and the Trooper confirmed that every time they'd walk,

100

00:05:23,000 --> 00:05:26,000

they'd hear something falling them along the woods.

101

00:05:26,000 --> 00:05:29,000

He said from the sound of it, it didn't appear to be real big,

102

00:05:29,000 --> 00:05:31,000

but it was falling them around, and every time they would stop,

103

00:05:31,000 --> 00:05:34,000

the sound would keep moving for a few seconds,

104

00:05:34,000 --> 00:05:37,000

and it would stop, and when they started moving, it would move.

105

00:05:37,000 --> 00:05:39,000

Basically, that's what occurred there.

106

00:05:39,000 --> 00:05:42,000

Before that went back, George had an opinion

107

00:05:42,000 --> 00:05:44,000

that something was coming out of the woods.

108

00:05:44,000 --> 00:05:47,000

He heard it coming towards them, and he claimed to saw a dark figure

109

00:05:47,000 --> 00:05:50,000

coming out of the woods, and so he took a shot at it,

110

00:05:50,000 --> 00:05:52,000

and they ran in a state police car, and they turned around

111

00:05:52,000 --> 00:05:56,000

and got out of there, and that's when they went back to the barracks,

112

00:05:56,000 --> 00:05:58,000

and they called us, and we went up.

113

00:05:58,000 --> 00:06:01,000

All right, now when you arrived, the glow was all gone.

114

00:06:01,000 --> 00:06:04,000

There was nothing there. We took radiation tests immediately first.

115

00:06:04,000 --> 00:06:07,000

All right, now did you go back the following day?

116

00:06:07,000 --> 00:06:10,000

We were there, well, we were there for a number of days afterwards.

117

00:06:10,000 --> 00:06:13,000

All right, now was there any physical trace left that you could find?

118

00:06:13,000 --> 00:06:15,000

There was no physical trace.

119

00:06:15,000 --> 00:06:18,000

There was nothing that indicated that it definitely had been on the ground

120

00:06:18,000 --> 00:06:22,000

and may have been right above, but the animals would not go near the area.

121

00:06:22,000 --> 00:06:26,000

The horses and cattle and dogs, and as Trooper said too,

122

00:06:26,000 --> 00:06:29,000

the animals were extremely nervous.

123

00:06:29,000 --> 00:06:31,000

Now were they avoiding the area after the drill?

124

00:06:31,000 --> 00:06:33,000

They were avoiding the area after where they had disappeared from.

125

00:06:33,000 --> 00:06:35,000

They wouldn't, they'd go in the outskirts of it,

126

00:06:35,000 --> 00:06:37,000

but not in the immediate area where it was.

127

00:06:37,000 --> 00:06:39,000

That's the unenviable sign you could see.

128

00:06:39,000 --> 00:06:42,000

All right, but then of course there was no opportunity for you

129

00:06:42,000 --> 00:06:45,000

to use any infrared photography up there.

130

00:06:45,000 --> 00:06:49,000

No, well after the incident occurred that it probably related to you.

131

00:06:49,000 --> 00:06:52,000

Did you tell you about what happened that night?

132

00:06:52,000 --> 00:06:53,000

No, no.

133

00:06:53,000 --> 00:06:55,000

With the mine control, whatever the takeover?

134

00:06:55,000 --> 00:06:58,000

Now what did happen to the mine takeover in this case?

135

00:06:58,000 --> 00:07:02,000

Well, we went back, and we were up there,

136

00:07:02,000 --> 00:07:04,000

and we were looking around the area,

137

00:07:04,000 --> 00:07:07,000

and must have been probably around 20 to one

138

00:07:07,000 --> 00:07:10,000

when we were up in the field checking for radiation,

139

00:07:10,000 --> 00:07:11,000

looking for any evidence.

140

00:07:11,000 --> 00:07:14,000

And George and his father were down below the truck

141

00:07:14,000 --> 00:07:16,000

who was the main witness.

142

00:07:16,000 --> 00:07:18,000

And all of a sudden both of them yelled,

143

00:07:18,000 --> 00:07:20,000

told us to run down, and we went down,

144

00:07:20,000 --> 00:07:22,000

and they said that the whole area by the house

145

00:07:22,000 --> 00:07:24,000

had lit up bright green for a second.

146

00:07:24,000 --> 00:07:26,000

The whole area lit up real bright, so the father was concerned,

147

00:07:26,000 --> 00:07:29,000

so one of our fellows and George's father,

148

00:07:29,000 --> 00:07:31,000

going in the Jeep, went down the house,

149

00:07:31,000 --> 00:07:33,000

looked it over, couldn't find anything.

150

00:07:33,000 --> 00:07:35,000

They came back 10 minutes later.

151

00:07:35,000 --> 00:07:37,000

We proceeded up along the area where George

152

00:07:37,000 --> 00:07:40,000

claimed he had seen the creatures.

153

00:07:40,000 --> 00:07:43,000

So on the way up, we were just talking,

154

00:07:43,000 --> 00:07:47,000

and all of a sudden the bull, which was out there,

155

00:07:47,000 --> 00:07:49,000

came running out of the woods and was staring up

156

00:07:49,000 --> 00:07:51,000

towards one part of the Witted area.

157

00:07:51,000 --> 00:07:53,000

It wasn't bothering to pay any attention to us at all,

158

00:07:53,000 --> 00:07:56,000

and all of a sudden his dog also started picking up a set of something

159

00:07:56,000 --> 00:07:58,000

and started sniffing his way up towards there,

160

00:07:58,000 --> 00:08:00,000

and he stopped and started looking around.

161

00:08:00,000 --> 00:08:03,000

One of the guys in our group was on one side of George,

162

00:08:03,000 --> 00:08:05,000

and George's father, who was George,

163

00:08:05,000 --> 00:08:07,000

the main witness, of course,

164

00:08:07,000 --> 00:08:09,000

and George's father was on his other side,

165

00:08:09,000 --> 00:08:11,000

and they were just talking to him,

166

00:08:11,000 --> 00:08:13,000

asking questions about it,

167

00:08:13,000 --> 00:08:15,000

and one guy in our group asked him about

168

00:08:15,000 --> 00:08:18,000

where exactly they were standing or whatever,

169

00:08:18,000 --> 00:08:20,000

and he didn't answer them.

170

00:08:20,000 --> 00:08:22,000

Then he asked him again, and when he looked at him,

171

00:08:22,000 --> 00:08:24,000

he was like going like this rubbing his hands over his head,

172

00:08:24,000 --> 00:08:26,000

and he thought maybe a branch had hit him.

173

00:08:26,000 --> 00:08:28,000

And he asked him a question again,

174

00:08:28,000 --> 00:08:30,000

and all of a sudden George had his hand over his head,

175

00:08:30,000 --> 00:08:33,000

and he started waving back and forth like he was going to faint a collapse.

176

00:08:33,000 --> 00:08:35,000

So he yelled to his father to grab him right away

177

00:08:35,000 --> 00:08:37,000

at something was happening,

178

00:08:37,000 --> 00:08:39,000

and they were trying to get him down the ground,

179

00:08:39,000 --> 00:08:41,000

but he wouldn't get down.

180

00:08:41,000 --> 00:08:43,000

He started breathing real heavy and heavy,

181

00:08:43,000 --> 00:08:45,000

and then all of a sudden he just threw them both.

182

00:08:45,000 --> 00:08:47,000

He just threw them both, the ground, the father,

183

00:08:47,000 --> 00:08:49,000

and the other guy in our group,

184

00:08:49,000 --> 00:08:51,000

and all of a sudden he started leaving out these very loud screams.

185

00:08:51,000 --> 00:08:54,000

He started walking around in motion just like a loud animal,

186

00:08:54,000 --> 00:08:57,000

and he started swinging and screaming.

187

00:08:57,000 --> 00:08:59,000

His own dog attacked him,

188

00:08:59,000 --> 00:09:01,000

and the dogs started crying after that.

189

00:09:01,000 --> 00:09:05,000

And he was making the dogs start crying.

190

00:09:05,000 --> 00:09:07,000

And you witnessed this?

191

00:09:07,000 --> 00:09:09,000

We have it all on tape. The whole thing hasn't happened.

192

00:09:09,000 --> 00:09:11,000

Everything.

193

00:09:11,000 --> 00:09:14,000

Anyhow, George was going around making these terrible sounds,

194

00:09:14,000 --> 00:09:16,000

and the last roar that he made

195

00:09:16,000 --> 00:09:19,000

is identical to the sound of these creatures we have taped.

196

00:09:19,000 --> 00:09:22,000

It's a sound that you couldn't duplicate with a human voice.

197

00:09:22,000 --> 00:09:25,000

And all of a sudden he just more or less collapsed

198

00:09:25,000 --> 00:09:28,000

directly on his face, just straight down right into the...

199

00:09:28,000 --> 00:09:30,000

There was horse manure over the place,

200

00:09:30,000 --> 00:09:34,000

and it just came straight down with his face into the ground.

201

00:09:34,000 --> 00:09:36,000

And we ran over and picked him up.

202

00:09:36,000 --> 00:09:39,000

Just after this occurred, one of the other fellas,

203

00:09:39,000 --> 00:09:41,000

and they was with us too,

204

00:09:41,000 --> 00:09:43,000

one of the other fellas in our group started to get lightheaded,

205

00:09:43,000 --> 00:09:47,000

and he couldn't maneuver properly,

206

00:09:47,000 --> 00:09:49,000

and he was down on his knees.

207

00:09:49,000 --> 00:09:52,000

And then Dave couldn't breathe at all.

208

00:09:52,000 --> 00:09:54,000

He had trouble breathing.

209

00:09:54,000 --> 00:09:57,000

And then this terrible, strong chemical odor came out of the woods.

210

00:09:57,000 --> 00:10:00,000

We all smelt it. Most of us all smelt it at the time.

211

00:10:00,000 --> 00:10:02,000

This came out in a wave.

212

00:10:02,000 --> 00:10:05,000

The same thing all the witnesses have described with the creature.

213

00:10:05,000 --> 00:10:07,000

It's a very strong, sulfur-uric-like smell.

214

00:10:07,000 --> 00:10:09,000

Almost if you took these old kitchen matches

215

00:10:09,000 --> 00:10:11,000

and struck them, but they didn't light.

216

00:10:11,000 --> 00:10:13,000

It was a very strong smell like that.

217

00:10:13,000 --> 00:10:15,000

We were getting George out of there,

218

00:10:15,000 --> 00:10:17,000

and we were finding on his feet,

219

00:10:17,000 --> 00:10:19,000

and one of our other guys, we were getting him back down,

220

00:10:19,000 --> 00:10:21,000

and we realized something was happening, unusual.

221

00:10:21,000 --> 00:10:23,000

We wanted to get out of the area very quickly,

222

00:10:23,000 --> 00:10:25,000

which we, thank God, did.

223

00:10:25,000 --> 00:10:27,000

This fella, George, as he came out of it,

224

00:10:27,000 --> 00:10:31,000

he was talking about this man in a dark cape with a hood

225

00:10:31,000 --> 00:10:33,000

that was calling him and told him

226

00:10:33,000 --> 00:10:35,000

that the man didn't hurry up and shape up,

227

00:10:35,000 --> 00:10:37,000

that the end would come soon.

228

00:10:37,000 --> 00:10:40,000

And things of this nature would happen.

229

00:10:40,000 --> 00:10:43,000

There's no way we can really describe the whole incident.

230

00:10:43,000 --> 00:10:45,000

The closest thing you can describe to it

231

00:10:45,000 --> 00:10:48,000

is what's known as diabolical or demon possession.

232

00:10:48,000 --> 00:10:53,000

However, in this case, and from reports we've had since,

233

00:10:53,000 --> 00:10:59,000

even though I've always been very reluctant to connect UFOs and creatures,

234

00:10:59,000 --> 00:11:02,000

no doubt there probably is a connection now.

235

00:11:02,000 --> 00:11:06,000

But it seems there is some type of mind control involved in these cases,

236

00:11:06,000 --> 00:11:10,000

where they are able to take control of certain people at certain times.

237

00:11:10,000 --> 00:11:13,000

And Dr. Schwartz was here from New Jersey working on the case.

238

00:11:13,000 --> 00:11:15,000

We've had other people involved in it.

239

00:11:15,000 --> 00:11:17,000

We've had a number of other similar cases now,

240

00:11:17,000 --> 00:11:21,000

people have come forward to who were involved in a Bigfoot situation,

241

00:11:21,000 --> 00:11:24,000

where they have had all type of psychic phenomena,

242

00:11:24,000 --> 00:11:27,000

poltergeist activity, memory lapses,

243

00:11:27,000 --> 00:11:30,000

and things of this nature, all in the last few months,

244

00:11:30,000 --> 00:11:32,000

associated with the Bigfoot cases.

245

00:11:32,000 --> 00:11:34,000

And these are people who had no previous knowledge of this.

246

00:11:34,000 --> 00:11:37,000

And most of these cases, like in one case,

247

00:11:37,000 --> 00:11:39,000

the teenage boy taught his mother about it,

248

00:11:39,000 --> 00:11:43,000

but he doesn't want to talk to anybody about it because he said he's afraid to,

249

00:11:43,000 --> 00:11:45,000

because he feels that somebody is watching him,

250

00:11:45,000 --> 00:11:48,000

and if he says anything about it, something will happen to him.

251

00:11:48,000 --> 00:11:52,000

And he's had two car accidents since the occurrence,

252

00:11:52,000 --> 00:11:55,000

where there was no reason why he should have had a car accident.

253

00:11:55,000 --> 00:11:58,000

In fact, another boy who was with him at the initial experience

254

00:11:58,000 --> 00:12:01,000

also had a car accident in a different car on the same night.

255

00:12:01,000 --> 00:12:08,000

All right, now, did you personally have anything with smacked of mind control?

256

00:12:08,000 --> 00:12:11,000

To me? Nothing happened to me except to smell.

257

00:12:11,000 --> 00:12:13,000

We all smelt at the time.

258

00:12:13,000 --> 00:12:16,000

And, believe me, the guys in the group,

259

00:12:16,000 --> 00:12:18,000

especially some of the guys with their that night,

260

00:12:18,000 --> 00:12:20,000

are extremely skeptical.

261

00:12:20,000 --> 00:12:22,000

They're open minded, but very skeptical.

262

00:12:22,000 --> 00:12:25,000

And I would never believe it unless I saw it myself.

263

00:12:25,000 --> 00:12:28,000

But there's no doubt that something happened up there.

264

00:12:28,000 --> 00:12:31,000

Now, the dog attacked the master.

265

00:12:31,000 --> 00:12:33,000

More or less, yeah.

266

00:12:33,000 --> 00:12:35,000

And then it started crying.

267

00:12:35,000 --> 00:12:36,000

Then the dog started crying.

268

00:12:36,000 --> 00:12:39,000

Well, the dog belongs to the boy's, the fellow's father.

269

00:12:39,000 --> 00:12:41,000

But you would say it's his dog too.

270

00:12:41,000 --> 00:12:44,000

Yeah, but they were well acquainted.

271

00:12:44,000 --> 00:12:45,000

Oh, definitely, definitely.

272

00:12:45,000 --> 00:12:47,000

It's been a whole life out there together.

273

00:12:47,000 --> 00:12:49,000

How did he indeed bite the boy?

274

00:12:49,000 --> 00:12:51,000

The dog? No, he got scared.

275

00:12:51,000 --> 00:12:53,000

He went after it, the dog went over and started crying.

276

00:12:53,000 --> 00:12:56,000

He moved away, started crying, which is all on the tape.

277

Doesn't he have any reoccurrence that he has had?

Not on this, but when certain questions are asked of him,

he'll go into a trance.

We put him out several times and he went in a bunch of dozen times when Schwartz was here.

Well, he wasn't, but Dr. Schwartz has made him aware of it for special reasons now.

How does Schwartz fit into the picture?

What's his qualification?

302

Dr. Schwartz is one of the top very prominent psychiatrists in the United States.

303

And he spent many years investigating the risk of having a psychic phenomenon

304

and contact the cases and so forth.

305

I've been in touch with him for a while and he was playing on it coming down here anyhow about a week later.

In one case, it was walking along the road in front of them,

346

but from the angle, with the lights on the motorbike,

347

they didn't see from the waist down.

348

And there was a tail on this one.

349
