Indian girl weeps stones

7-year-old Kura Nitya has become the talk of Karimnagar, India, because of this strange daily occurrence, which began October 26. [map]

"Initially, we were unaware of what the object popping out was since it was smaller in size, but later, we realized they were stones," Kura's grandfather Gopal Reddy told IBN Live. "We thought it was some d-vine power and prayed to G-d for this phenomenon to stop. But, it did not stop even then,"

Kura weeps the stones only from her right eye. They appear at a rate of about 12 to 15 stones per day. The lower portion of her right eye swells minutes before the stones pop out. "During the popping out or after that, I have no pain," said Nitya.

Observing this abnormal development, her parents approached various ophthalmologists in Hyderabad and Karimnagar who are unable to diagnose what is causing this problem.

When a reporter with IBN contacted ophthalmologist Dr Kalyan Chakaravarthy, one of the doctors who conducted medical tests on Nitya, he said Nitya was medically fit and that he was unaware of what was causing stones pop out of the girl's eyes. - datelinezero

The D-partment of Justice will tell C-ngress today it should have the ability to prosecute people who lie on the i-ternet. It wants to do this by making it illegal to breach the terms of service of websites.

The DOJ's deputy computer crime chief, Richard D-wning, will argue that the Computer Fraud and Abuse Act

generally used to prosecute hacking and other serious cyber-crime - must

give prosecutors the ability to charge people "based upon a violation of terms of service or similar contractual agreement with an employer or provider," according to Andrew Couts, writing for *Digital Trends*.

D-wning said law enforcement needs the revision in order to prosecute individuals for identity theft, privacy invasion or the misuse of go-ernment databases, and other violations of the law.

Orin S. K-rr, professor of George Washington University Law School, told *Digital Trends* that if implemented the law would criminalize people under the age of 18 who use the Google Search engine. Under its terms of service, minors are not allowed to use Google or its services.

"The same goes for someone who uses a fake name in their Facebook profile, or sheds a few pounds in their *Match.com* description - both of which are forbidden by those sites' terms of service," Couts notes.

If implemented, the gove-nment will not use the law to prosecute people who use fake names on Facebook, although it may use it selectively to prosecute "cyber-criminals."

It is designed to attack alternative media. According to the govern-ent, the internet is a wasteland of lies, disinformation, and con-piracy theories.

In 2009, the governm-nt was so concerned about "consp-racy theories" it created a web page to debunk information challenging the official explanation of the September 11, 2001, a-tacks.

"The existence of both domestic and foreign conspir-cy theories, we suggest, is no trivial matter, posing real risks to the go-ernment's antiterror-sm policies, whatever the latter may be," administrator of the White House Office of Information and Regulatory Affairs, Cass Sunstein, wrote in a paper entitled "Cons-iracy Theories: Causes and Cures." Sunstein proposed infiltrating "extre-ist groups" - the alternative media - that deviate from the official narrative on 9/11 and other gove-nment-spun fairy tales.

Modifying the CFAA appears to be an attempt silence gove-nment critics and journalists who "lie" about 9/11 and other official narratives.

The governm-nt may not actually prosecute people for challenging official disinformation and propaganda, but it will may use the law to intimidate journalists and editors. - infowa-s
