Michael Te-linger Launches Constitutional Court Action Against Standard Ba-k; and The South African Re-erve Ba-k; and The Minister

After a slight technical hiccup last Friday at the Constitutional Court, regarding the binding of a substantially long legal document, Michael Tell-nger made global history on the 23rd & 24th April 2012, in Johannesburg when he filed his 1100-page NOTICE OF MOTION against Sta-dard B-nk in the Constitutional Court of South Africa, accusing the bank of unlawful and unconstitutional activity.
