This is in response to your request to Defense Security Service (DSS) on April 27, 2011 and your follow up request on 10 August 2011 regarding a letter dated April 30, 1986 and a copy of your DSS file "6520-DK1-3409-1W9". We have processed your request in accordance with the Privacy Act of 1974 (5 U.S.C. 552(a). 

Dear Sirs:

Please note (see enclosure A) from Mr. C. A. Bowers (Director of Security) to "All Employees", of the Aerojet Electrosystems Corp., dated 6 October, 1986, wherein it is stated- "An industrial inspection was conducted at the Aerojet Azusa facility during the month of September 1986 by the Defense Investigative Service, Industrial Security Representatives. Results of the inspection disclosed that our security program is in accordance with the requirements of the Industrial Security Manual."

On 7 October 1986 (prior to this memo), I met with Mr. C. A. Bowers and presented him with a copy of a memo (see enclosure B) detailing my activities and acknowledging his permission to pursue them. Upon reading this memo he made NO request to me to cease my activities and agreed to the content of this memo.

On the 19th of March 1986 (see enclosure C-C1), I was asked by your agents Alex Naval and James Kirk if I had ever received a classified document. I responded yes and surrendered the copy I had of this (see enclosure D) document to Mr. Kirk. He read the document and returned it to me, stating that it had been sanitized for release and that I was free to share a copy of it with anyone and make FOIA requests as to the agency of its origin.

Mr. Kirk asked me for the name, telephone number, and address of the individual who had provided me with a copy of this document (see enclosure D). I gave him this information, as also I did your agents Joe Moussiaux and Mat Bartenelli on the 18th of September 1986, when they interviewed Mr. Ron Regehr at Aerojet in Azusa, CA. Mr. Regehr collaborates with me on attempting to authenticate this document (see enclosure D). Mr. Moussiaux and Mr. Bartenelli (at this interview) led me to believe that the investigation had ALREADY been COMPLETED on me!

On the 16th of October 1986, I had dinner with the individual who gave me this document (see enclosure D). He stated that he HAD NOT been contacted by ANYONE representing the Defense Investigative Service and that he WOULD NOT BE, because your computer system is flagged not to interview or interrogate him!

Being a high performance aircraft buff, I am seeking to prove the existence of a Mach 6 aircraft Mr. Fletcher Prouty has led me to believe is being test flown in Nevada (see enclosure E-E3). That is why I made the request that I did (see enclosure B #1) which representatives of the Company for which I work believe would be of great value (i. e. the proof).

I am also convinced that the satellite system detailed in (see enclosure F) has detected the aerial object indicated in this article (see enclosure G). That is why I made the request that I did (see enclosure H-H1) which was responded to with (see enclosure J-J1). Seeing that this DOES exist by declaration of OPEN literature (see enclosure K-K2), and noting that YOUR agents have stated (to me) that this document (see enclosure D) HAS been sanitized for release, I made the request that I did (see enclosure B #2), i. e. with the acknowledgement that an extraterrestrial intelligence does exist (the "Aliens", see enclosure D), the statement- "mere existence" (see enclosure J) may now be amended and by permission of my Company's Security Office (see enclosure E), I am free to pursue the fact that this satellite system (see enclosure K-K2) HAS detected an aerial device of apparent extraterrestrial origin.

I have informed you of these (my) activities, because I have NO intention of violating my Security Clearance and/or our National Security. By the fact that you HAVE NOT interrogated the individual who has led me to pursue/persist in demonstrating that the "Aliens" exist, I MUST believe that is what I am SUPPOSED to do. Seeing that you HAVE completed your investigation (see enclosure A), I respectfully request-

1. The release of my records as per your statement (see enclosure C).
2. A statement of authenticity or repudiation of this document (see enclosure D) as WAS promised/STATED by YOUR agents Joe Moussiaux and Mat Bartenelli to Mr. Regehr and myself on the 18th of September 1986 in the Security Office at Aerojet Electro-systems Corporation, in Azusa, CA.

Dear Dear Mr. Hartig:

Sir I am writing to you because of your statement- "If you have any questions regarding the contents of your file or the information released to you, please feel free to contact my office." (see enclosure A para. 8).

On Saturday May 2, 1987 I received THIS documentation (see enclosure B-B5) from my good friend William L. Moore. I am on the Board of Directors of the "Fair-Witness Project".

Please note enclosure B3; especially the names on page 002. This is the MJ-12 document that I related to your agents Alex Naval and James Kirk; I was briefly allowed to read a copy of the VERY SAME night that I was given a copy of this (another document (see enclosure D)).

It is this document (see enclosure D) that caused my security to alert you (see enclosure A3) AFTER I made a request to them to authenticate or repudiate it (see enclosure A2). Document D is one page of document B5.

On Monday morning May 4, 1987 I gave a copy of this material (see enclosure B-B6) to my security officer (Mr. Raymond J. Bader for reference. As I indicated, I had earlier reported the existence of this document (see enclosure B3) to Mr. Kirk and Mr. Naval. They had indicated that I should notify my security office or your office upon receipt thereof. I was interviewed by Mr. Kirk and Mr. Naval on 5/10/86 (see enclosure A2). I again reported the existence of this documentation to your agents Joe Moussiaux and Mat Bartellini on the 18th of Sept. 1986 (see enclosure E2 page 1 para. 4) when they interviewed Mr. Ron Regehr. Mr. Regehr and myself are both trying to authenticate or repudiate this material.


If you note the names found in this document (see enclosure B3 page 002) you will see that they are the same as those found in my letter to Barry Greenwood of 5 Oct. 1985 (see enclosure F page 3 para. 4).

Since I have made a concerted effort to inform you of my activities (see enclosure E-E3) and you have NOT asked me to

desist; I MUST presume that I have your permission to seek the authenticity of this documentation. Indeed; your letter (see enclosure A para. 7) states..."it is suggested you contact the agency that initially provided you with this document." This is AFTER I reported to your agents the identity of the source of the document (see enclosure A5 page 2). Noting these facts I would like to ask the following-

- 1. Are there governmental rules that require the removal of an alleged Top Secret document from circulation if such a document is suspected of being a phony?
- 2. Are there governmental rules that require the removal of an alleged Top Secret document from circulation if such a document has not been properly declassified?
- 3. Does the circulation of ANY of this material (see enclosure B1-B5, C, and D) violate any of the above rules?
- 4. Do you for ANY reason believe that this material (see enclosure B1-B5, C, and D) is not authentic?
- 5. Do Mr. Regehr and myself have the right to continue to attempt to authenticate this material (see enclosure B1-B5, C, and D); i. e., are we breaking any of the above rules?

This is response to your letter of May 5, 1987, seeking information regarding rules pertaining to the classification and declassification of government documents, and information regarding a document in your possession.

The security offices in appropriate agencies maintain rules pertaining to the classification and declassification of documents containing sensitive information.

For your information, the Defense Investigative Service (DIS) is authorized to conduct personnel security investigations for the Department of Defense (DoD) components and other U.S. government agencies when authorized by the Deputy Under Secretary of Defense for Policy. Therefore, there is no reason for us to maintain information concerning aircraft and/or UFOs. In addition, you would not obtain permission from this agency to verify the authenticity of the documents you were provided.

As we explained to you previously in our letter of January 30, 1987, the document of concern to you did not originate with DIS. It is suggested you address your questions to the provider of the document or the U.S. Air Force.

We regret that we can be of no assistance to you in this matter.

This letter is in response to your request dated June 13, 2012 for release of information from the George Bush Presidential Library under the Freedom of Information Act (FOIA)(5 U.S.C., as amended) and the Presidential Records Act (PRA)(44 U.S.C. 22).

Dear Sirs:

This is a follow-up letter to my request (see enclosure A), which you responded to with reply (see enclosure B).

When I received a copy of the document (see enclosure B2), I made a request to my security office (see enclosure C) seeking to authenticate or repudiate the claims made in this document. I did this, because I do not have a Top Secret clearance and was, therefore, concerned if a breach of security may have been made.

My security office made no request to me to surrender the document (see enclosure B2) making the assumption that it had been released and that I could share same with anyone.

The document (see enclosure B2) had been given to me to (in turn) give a second copy (also provided by the source and as yet not reproduced by me) to researcher John Andrews for authenticating.

Mr. John Andrews of the Testor Corporation is a fellow aircraft buff and expert on the histories of the development of the CIA/USAF Lockheed U-2 (see enclosure D), the CIA/USAF Lockheed A-12/SR-71/D-21 aircraft (see enclosure E) and the alleged USAF/Lockheed F-19 stealth fighter which I have recently become most interested in (see enclosure F).

Following the request of my security office to you (see letter C), to investigate the document (see enclosure B2), my neighbors, my landlady, and my fellow employees began telling me, that you (the Defense Investigative Service) had approached them asking various questions about me and MOST SPECIFICALLY about my interest in investigating the UFO phenomena, i. e., in authenticating the document (see enclosure B2). It was this investigation (without yet informing me), that led me to make the request that I did (see enclosure A).

Upon giving the copy (given to me) of the document (see enclosure B2) to John Andrews, I was informed by him, that this document had to have been released, and that it was the intention of its source (through me) to disseminate same among the members of the Aerospace community in which I work, and this I did as so indicated to me. Indeed, the source of the document (see enclosure B2) had indicated to me that he had been approached by AFOSI for that very purpose, i. e., to disseminate information to the Public in order to convince them that the UFO phenomena was real and of extraterrestrial origin.

Upon disseminating this document among my fellow employees, some individuals became concerned, resulting in the memo (see enclosure G).

On the 19th of March 1986 I was interviewed by two agents (Alex Naval and James Kirk) representing the Defense Investigative Service (see enclosure H). In the course of this interview, Mr. Kirk stated that this document (see enclosure B2) had been sanitized for release and that I was free to share same with anyone or make FOIA requests as to its authenticity (see enclosure I) and the agency of its origin. I asked if there were agencies within our Government who approach individuals (researchers) like myself for the express purpose of "leaking" such documentation and was told... "Yes, the Office of Air Force Investigations is one of them!"

I was asked who gave me the document (see enclosure B2) and I gave his name and address.

I also reported to Mr. Kirk, that the individual who gave me the document (see enclosure B2) had an identification card, just like the one HE and Mr. Naval presented me with, to identify themselves as being agents of the Defense Investigative Service. It is to be noted, that this individual HAS NOT been arrested, nor even interrogated for having this document (see enclosure B2). I MUST, therefore presume that this document is GENUINE and has been released! My security office has identified (to me) agents Alex Naval and James Kirk as being with the Defense Investigative Service.

Having been told that this document (see enclosure B2) had been sanitized for release, I shared this information with the source (who provided me the copy of same) and he affirmed that the document HAD, indeed been released.

Prior to having been given the sanitized copy of this page (see enclosure B2) of this document, I was shown the same page, which had NO censoring at all! I MUST, therefore, presume that this document (see enclosure B2) in its entirety, has been declassified for release to the American public. I respectfully request-

1. A complete uncensored copy of this document (see enclosure B2) and/or the agency to which I should make the request to acquire same.
