

CLASSIFIED INFORMATION NONDISCLOSURE AGREEMENT

AN AGREEMENT BETWEEN

Eric A. Walker

AND THE UNITED STATES

(Name of Individual - Printed or typed)

1. Intending to be legally bound, I hereby accept the obligations contained in this Agreement in consideration of being granted access to classified information. As used in this Agreement, classified information is marked or unmarked classified information, including oral communications, that is classified under the standards of Executive Order 12356, or under any other Executive order or statute that prohibits the unauthorized disclosure of information in the interest of national security; and unclassified information that meets the standards for classification and is in the process of a classification determination as provided in Sections 1.1(c) and 1.2(e) of Executive Order 12356, or under any other Executive order or statute that requires protection for such information in the interest of national security. I understand and accept that by being granted access to classified information, special confidence and trust shall be placed in me by the United States Government.

2. I hereby acknowledge that I have received a security indoctrination concerning the nature and protection of classified information, including the procedures to be followed in ascertaining whether other persons to whom I contemplate disclosing this information have been approved for access to it, and that I understand these procedures.

3. I have been advised that the unauthorized disclosure, unauthorized retention, or negligent handling of classified information by me could cause damage or irreparable injury to the United States or could be used to advantage by a foreign nation. I hereby agree that I will never divulge classified information to anyone unless (a) I have officially verified that the recipient has been properly authorized by the United States Government to receive it; or (b) I have been given prior written notice of authorization from the United States Government Department or Agency (hereinafter Department or Agency) responsible for the classification of the information or last granting me a security clearance that such disclosure is permitted. I understand that if I am uncertain about the classification status of information, I am required to confirm from an authorized official that the information is unclassified before I may disclose it, except to a person as provided in (a) or (b), above. I further understand that I am obligated to comply with laws and regulations that prohibit the unauthorized disclosure of classified information.

4. I have been advised that any breach of this Agreement may result in the termination of any security clearances I hold; removal from any position of special confidence and trust requiring such clearances; or the termination of my employment or other relationships with the Departments or Agencies that granted my security clearance or clearances. In addition, I have been advised that any unauthorized disclosure of classified information by me may constitute a violation, or violations, of United States criminal laws, including the provisions of Sections 641, 793, 794, 798, and \*952, Title 18, United States Code, \*the provisions of Section 783(b), Title 50, United States Code, and the provisions of the Intelligence Identities Protection Act of 1982. I recognize that nothing in this Agreement constitutes a waiver by the United States of the right to prosecute me for any statutory violation.

5. I hereby assign to the United States Government all royalties, remunerations, and emoluments that have resulted, will result or may result from any disclosure, publication, or revelation of classified information not consistent with the terms of this Agreement.

6. I understand that the United States Government may seek any remedy available to it to enforce this Agreement including, but not limited to, application for a court order prohibiting disclosure of information in breach of this Agreement.

7. I understand that all classified information to which I may obtain access by signing this Agreement is now and will remain the property of, or under the control of the United States Government unless and until otherwise determined by an authorized official or final ruling of a court of law. I do not now, nor will I ever, possess any right, interest, title, or claim whatsoever to such information. I agree that I shall return all classified materials which have, or may come into my possession or for which I am responsible because of such access: (a) upon demand by an authorized representative of the United States Government; (b) upon the conclusion of my employment or other relationship with the Department or Agency that last granted me a security clearance or that provided me access to classified information; or (c) upon the conclusion of my employment or other relationship that requires access to classified information. If I do not return such materials upon request, I understand that this may be a violation of Section 793, Title 18, United States Code, a United States criminal law.

8. Unless and until I am released in writing by an authorized representative of the United States Government, I understand that all conditions and obligations imposed upon me by this Agreement apply during the time I am granted access to classified information, and at all times thereafter.

9. Each provision of this Agreement is severable. If a court should find any provision of this Agreement to be unenforceable, all other provisions of this Agreement shall remain in full force and effect.

I acknowledge that the officer has made available to me Sections 641, 793, 794, 798, and 952, Title 18, United States Code, Section 783(b), Title 50, United States Code, the Intelligence Identities Protection Act of 1982, Executive Order 12356 or its successor, and Section 2003.20, Title 32, Code of Federal Regulations, so that I may read them at this time, if I so choose.

Dear Dean Bowen:

After receiving your letter of April 5th regarding the annual dinner of the Tattered Purple Badges, it is with great sadness that I write to tell you that Dr. Eric Walker passed away this past February 17th. Upon Dr. Walker's death I attempted to notify as many people as I could, knowing that it would still be necessary throughout the year to prepare this response to invitations such as yours. One of Dr. Walker's favorite events was his attendance at TPB dinners. And since there were few occasions when he had the opportunity to see and talk with his TPB colleagues, he thoroughly enjoyed receiving the collection of letters which kept him abreast of their activities and accomplishments. If you will indulge me, I would like to make one last entry for Dr. Walker in this collection, telling of some of the things that kept Dr. Walker busy since last year's TPB entry.

Dr. Walker returned from his home on Hilton Head Island, SC during the second week of April. While he didn't mind missing the cold, slushy days of winter here in central Pennsylvania, he missed his friends terribly while he was gone. Subsequently, each year his stays in Hilton Head became shorter and shorter; leaving State College later in the Fall, and returning earlier in the Spring. Shortly after his return, he celebrated his 84th birthday on April 29th.

In 1994 Dr. Walker helped plan the retirement celebration for State College mayor (and long time personal friend and colleague), Arnold Addison. In addition, he was active on an advisory committee for a local, new, high tech entrepreneurial business where he shared his still keen business sense. Later in 1994 he broke down and finally purchased a new IBM PC with all the "trimmings," and proceeded to learn some new software packages. His favorites were learning how to E-mail, and surfing the Internet! I used to love to tease him about learning to surf at 84!

Those who knew Dr. Walker well knew of his great love for golf. Every morning, regardless of the weather, he would be on the course at 7:00 a.m. with his cronies, walk nine holes, and then come into the office. Wanting to give something back to the game, Dr. Walker spearheaded a fund-raising effort to remodel the golf clubhouse on campus. The drive was enormously successful due primarily to Dr. Walker's efforts, and the clubhouse was dedicated in late Spring.

In his fervent desire to stay in touch with students, Dr. Walker accepted several invitations to address engineering classes in 1994 where he would talk about professional ethics and the entrepreneurial spirit.

After World War II, Dr. Walker moved the Harvard Underwater Sound Laboratory here to Penn State where it became the Applied Research Laboratory. Late last summer the Lab celebrated its 50th anniversary, and fortunately, Dr. Walker was there to participate in the festivities.

After undergoing a battery of tests, early last October Dr. Walker learned that he had a faulty heart valve which was inoperable and would quickly worsen. He was advised that at the rate his condition was deteriorating, it would be only months before his illness overcame him. Not wanting to burden others with the knowledge of his impending demise, Dr. Walker asked that no one be told of the graveness of his illness; only that he was not feeling very well and was trying to get a lot of rest. His hours on the golf course grew shorter and shorter because of his inability to walk. He played fewer holes, then he tried a golf cart, but eventually in mid October golfing became impossible. Up until he began undergoing tests in September, in addition to golfing every day, he played tennis on the weekends. He was also an avid bicyclist and put on a lot of miles during his winter stays in Hilton Head.

Although those of us who knew him well are saddened by his death, we take comfort in knowing that Dr. Walker lived the personal and professional life of a dozen men. He enjoyed life to the fullest up until the last couple of months, and even then he made constructive use of his time at home. He was an inspiration to me and to many others with whom he came in contact.

Thank you for this opportunity to recap some of Dr. Walker's activities during the last year of his life. I hope he will be in your thoughts as the Tattered Purple Badges gather once again to reminisce and speculate.

# Penn Staters remember Walker

Eric Walker, who served from 1956 to 1970 as Penn State's 12th president, died Feb. 17.

**UNIVERSITY PARK** — About 300 people gathered at the Applied Research Laboratory Wednesday to remember the man who brought it to Penn State.

But speakers at the memorial service for Eric Walker, the former university president who died Feb. 17, remembered him not just as the man who helped Penn State grow from an obscure public college to one of the nation's leading research universities.

For instance, Charles L. Hosler, retired senior vice president for research and dean of the Graduate School, described Walker's ability to use his wits to get things done.

In one case Hosler recalled, Walker was trying to persuade the Board of Trustees to approve construction of eight new buildings.

The president added a ninth building to the trustees' agenda. The ninth building was a brick storage shed for the women's field hockey team and would have been located in the middle of the Hetzel Union Building.

Walker's ruse worked, Hosler said.

"The trustees argued for 90 minutes about that storage shed and then passed the rest of the agenda unanimously," he said.


Walker oversaw the construction

of more than 100 buildings during his tenure, which was from 1956 to 1970, but physical plant wasn't the only growth area. Also during his administration, student enrollment tripled, the size of the faculty doubled, eight new branch campuses opened for business and the university's reputation, especially for scientific research, spread far and wide.

Robert A. Patterson, another former senior vice president, told stories of life in Old Main during Walker's administration. For instance, Patterson said, no one in the building used green ink except Walker, who initialed all his memos with a green letter W, known throughout Old Main as "the green weenie."

"The secretaries would come run-

He said, "It is better to be vaguely right than precisely wrong."

Former Vice President Richard Grubb remembered Walker's punctuality. One day, Walker couldn't get a university car to take him to commencement ceremonies, so he recruited Grubb. "We went out and got in my little red Mustang convertible, he with his Harvard crimson robe," Grubb recalled. Walker attracted the attention of a police officer when he insisted on taking a shortcut through a pedestrians-only road. At first the officer blew his whistle and moved to stop the car, but then he got closer and saw who was in it.

"The officer took one look in that car and saw that crimson robe, and said 'You're cutting it pretty close. Follow me,'" Grubb said. "We arrived at Beaver Stadium at 10:25 a.m. and once again Eric Walker did not keep anybody waiting."

## **Eric Arthur Walker**

April 29, 1910 - February 17, 1995

Dr. Eric Arthur Walker served as President of Penn State from 1956 to 1970 during a period of unprecedented growth and development for the University and for higher education. His term of office was marked by rapid growth in all areas—students, faculty, physical plant, and demand for University services. Student population increased from 13,000 to 40,000; the Commonwealth Campus system emerged as an integral part of the total University; student numbers at the campuses increased five-fold. Improvements in the quality of the educational program received major attention. A department-by-department evaluation of the entire academic structure revealed both strengths and weaknesses and laid the foundation for much corrective action. Highlights of the period include the development of The Milton S. Hershey Medical Center and its College of Medicine, the opening of a graduate center at King of Prussia, the addition of seven campuses, and the expansion of Continuing Education services.

A native of England, Dr. Walker moved to Canada with his parents at an early age and lived with an aunt in Wrightsville, York County, Pennsylvania, during his high school years. At Harvard University, where he made his own way with a scholarship and part-time work, he earned a B.S. in electrical engineering, an M.A. in business administration and an Sc.D. in general science and engineering. He was a professor and head of electrical engineering at Tufts College and the University of Connecticut. Early in World War II, he was

appointed associate director of the Underwater Sound Laboratory at Harvard, where development of the homing torpedo was a principal mission. When a portion of the laboratory was moved to Penn State in 1945 as the Ordnance Research Laboratory, he became laboratory director and head of the Department of Electrical Engineering. He became dean of the College of Engineering and Architecture (1951), vice president for research (1956), and then President of the University. He served on many professional, educational and governmental boards and agencies concerned with improving American higher education and applying its resources in the national interest. Dr. Walker was a member of the National Academy of Sciences and a founding member of the National Academy of Engineering. Upon his retirement from the University, he served for five years as vice president for science and technology of the Aluminum Company of America.

Dr. Walker once described the University in these terms:

“When I think of Penn State, I always think of a big, adolescent youngster, strong, attractive, and awkward, one who has grown too fast, whose jacket is splitting at the shoulders, his trousers too short and white socks showing, with big strong hands hanging self-conscious out of his too-short shirt sleeves. It is a young, strong, attractive university just about to embark on an adventurous career.”

# Eric A. Walker, 84, an engineer and former Penn State president

Eric A. Walker, 84, former president of Pennsylvania State University, died Friday at his home in State College.

Mr. Walker presided over one of Penn State's greatest periods of expansion. His presidency, from 1956 to 1970, saw enrollment triple to 40,000 and the faculty more than double to 3,200. More than 100 new buildings were constructed, and the university's Hershey Medical Center was established.

Eight new two-year campuses opened, which by 1970 expanded the number of Penn State campuses to 22. That network places campuses within 30 miles of 90 percent of Pennsylvania's population.

"Eric Walker was a great scientist and educator," said Joab Thomas, president of the university. "He provided wide and visionary leadership for Penn State that laid the foundation for the growth of the university into one of the premier public research universities in the nation."

Mr. Walker, a Harvard-educated scientist-engineer, stayed active in research and engineering during his presidency. "It is an error for academic administrators to abandon their fields," he once said.

He also helped develop national science and technology policies. A prime mover in the establishment of the National Academy of Engineering, he was its president from 1966-1970, as well as president of the National Science Board from 1964-66, the Engineering Joint Council from 1962-63, and the American Society for Engineering Education from 1962-63.

His numerous awards included the Horatio Alger Award, given annually

to a distinguished American whose career paralleled those portrayed in Alger's books.

Born in England, Mr. Walker came to the United States by way of Canada and settled in Wrightsville, Pa., with an aunt. He earned bachelor's, master's and doctoral degrees at Harvard.

After teaching at Tufts University from 1933 to 1940 and heading the electrical engineering department at the University of Connecticut, he worked at Harvard on new types of torpedoes to attack German submarines. For that, he won the Naval Ordnance Development Award and the Presidential Certificate of Merit.

When that laboratory was divided into two groups, Mr. Walker headed

the group transferred to Penn State as the Ordnance Research Laboratory. He was professor and head of the electrical engineering department from 1945 to 1951 and dean of the College of Engineering and Architecture from 1951 until his appointment to succeed Milton S. Eisenhower as university president in 1956.

Mr. Walker, the first engineer to serve as Penn State's president, wrote an autobiography, *Engineering My Way*, and wrote or co-wrote more than 300 publications.

The Penn State board of trustees in 1977 named the new environmental sciences building on the University Park campus the Eric A. Walker Building.

After leaving the Penn State presidency, Mr. Walker began a second career as vice president for science and technology for Aluminum Co. of America. He retired from Alcoa in 1975, but continued to be involved in engineering education, chairing the National Science Foundation's Committee on Centers of Engineering Excellence.

He was a major Penn State benefactor. He and his wife, the former Josephine Schmeiser, established a fund to improve golf and tennis facilities at Penn State. A new clubhouse serving golfers on the Blue and White golf courses at University Park was named in their honor.

Surviving in addition to his wife are a daughter, Gail Walker Hearn; a son, Brian, and two grandchildren.

Services will be private. The university suggests memorial contributions to the Eric and Josephine Walker Scholarship Fund, 119 Old Main, University Park, Pa. 16802.

Dear Mr. Cameron:

This responds to your November 17, 1996, Freedom of Information Act request, filed with the Department of Justice, Federal Bureau of Investigation, and forwarded, with one document, to this office, for release determination and response directly to you. The request and document were received March 1, 1999.

Mr. J. Kevin O'Brien, Chief, FOI/PA Section, Federal Bureau of Investigation, has determined that disclosure of the blacked out information in the margin of the enclosed document could reasonably be expected to constitute an unwarranted invasion of the personal privacy of others. Therefore, he has denied its release under the provisions of 5 U.S. Code 552, (b)(7)(C).

You have the right to administratively appeal the decision to deny the information. Any such appeal should be forwarded to the Co-director, Office of Information and Privacy, U.S. Department of Justice, Flag Building, Suite 570, Washington, D.C. 20530-0001.

There are no fees assessed in this instance.

The individual did relate that Dr. Walker, while president of the Pennsylvania State University, accepted a position on the Board of Directors of the First Bellefonte Bank and Trust Company, Bellefonte, Pennsylvania. Soon thereafter, according to the individual, Dr. Walker exhibited an "unethical" method of doing business. He cited as an example, Dr. Walker's effort to establish a bank branch near the Pennsylvania State University. Dr. Walker allegedly directed a letter to the Pennsylvania State Banking Association written on the stationery of the Pennsylvania State University in which he pointed out the need of additional bank services in the vicinity of the university. In this regard Dr. Walker reportedly did not mention he was a member of the Board of Directors of the First Bellefonte Bank and Trust Company. The individual also alleged, since Dr. Walker became a bank official, he has given the First Bellefonte Bank and Trust Company a much greater percentage of university business than he did prior to his bank appointment.

b7C { The individual further alleged Dr. Walker has refused to "open" purchasing procedures of the Pennsylvania State University. The individual estimated eighty per cent of the office equipment for the university was furnished by Mr. [REDACTED] Bellefonte, Pennsylvania. Mr. [REDACTED] is a brother of Mr. [REDACTED] who is an attorney for the Pennsylvania State University. Both reportedly are close personal friends of Dr. Walker.

b7C b7D { Mr. [REDACTED] Federal Savings and Loan Association, Bellefonte, Pennsylvania, advised Dr. Walker is an extremely able and intelligent person who has the reputation of being "short" with people, and that he has few real friends. Mr. [REDACTED] further stated this is caused to some extent by Dr. Walker's own personality and to some degree by the great responsibility [REDACTED] assumes as President of the Pennsylvania State University.

An individual who has requested anonymity advised that Dr. Walker is of above-average ability and is an outstanding member of the engineering profession. No information has come to the individual's attention which would cause him to doubt Dr. Walker's loyalty to the United States.

The summary memorandum transmitted herewith contains information concerning Dr. Walker's activities since May, 1960. The investigation of Dr. Walker covered inquiries as to his character, loyalty, general standing and ability, but no inquiries were made as to the sources of his income.

appointee expressed concern over the fact that it had been called to his attention that [redacted] had expressed doubts concerning his, the appointee's, loyalty. According to the letter, [redacted] was supposed to have said that he believed that on the appointee's trips to Europe he had made contact with foreigners for purposes which are not to the United States' best interests. The appointee stated in his letter that he had been puzzled over this matter and wished to have a military security officer visit [redacted] in order to resolve the question.

In reply to this letter, [redacted] wrote a letter dated September 25, 1950, which was also contained in the appointee's security file. [redacted] stated that the issue had grown from "a molehill into a sand dune." [redacted] explained that he, in 1942 while with the [redacted] dimly recalled hearing a rumor that the appointee's name had been associated with "some alleged Red-sponsored organization." [redacted] stated further that he did not know what prompted this rumor and indicated that he did not have any facts which he could furnish to a security officer concerning this matter.

There was no additional pertinent information in this file.
