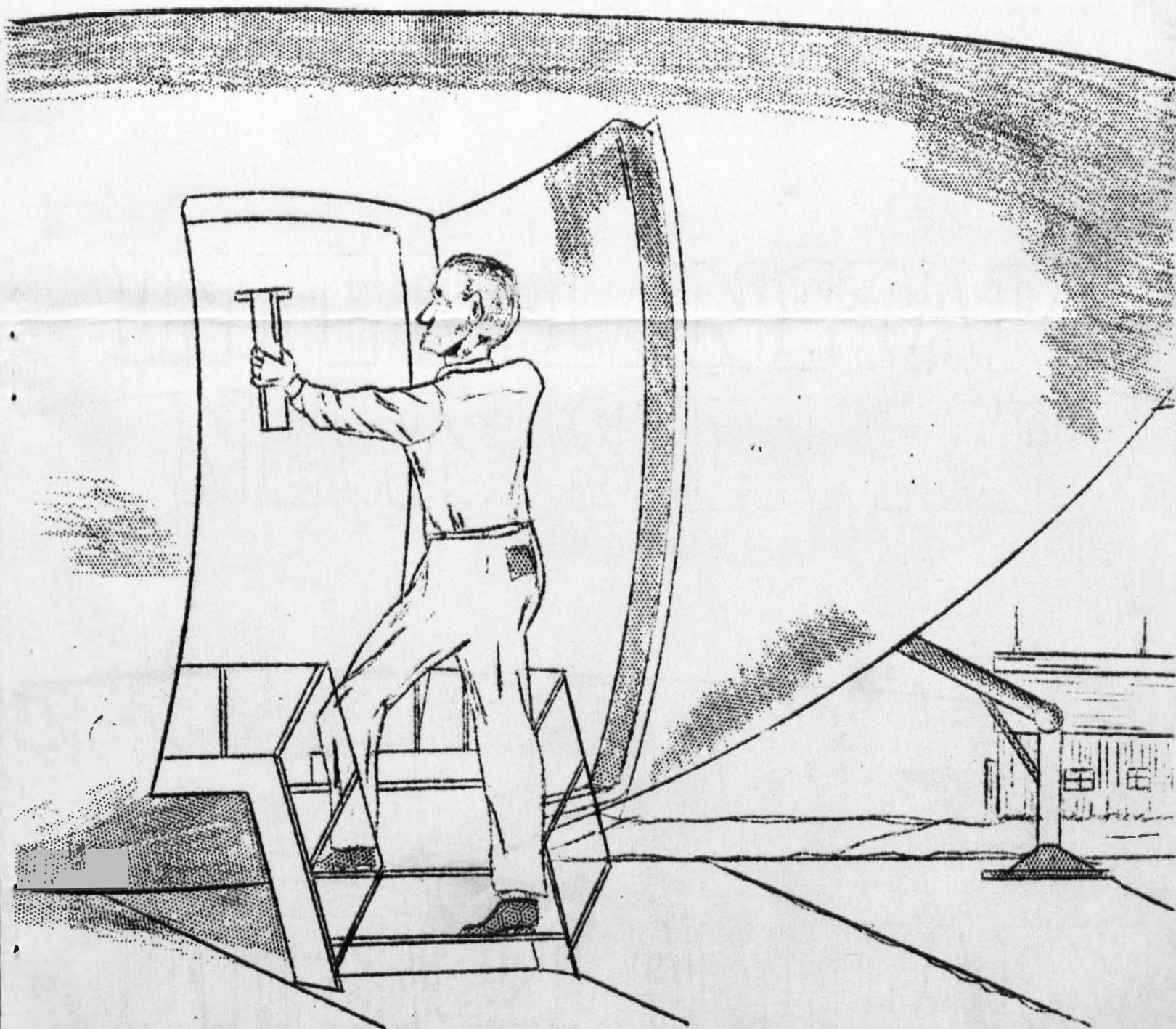

George D. Fawcett has brought up a point which I have been expecting to crop up ever since writing the article. I did not say, nor did I imply, that the Air Force receives every sighting of UFOs. However, it does receive a fairly regular percentage of them-10%, Mr. Fawcett states --and thus we are able to judge what years the most UFOs are being seen. For example, if there are 100 saucers seen, about 10 will be reported to the Air Force; if 500, about 50. In this way "flap" years can be determined.

Your May issue was very interesting to read. I would like to comment on the article written by Jerome Clark: "Some UFOlogical Fallacies". Jerome Clark states -- "Another UFOlogical fallacy, closely connected with contact claims is the myth that the flying saucers are here to save us... This theory... is completely without basis, for all data collected on UFO activity indicates that the phenomena are either neutral or hostile. Although I can recall numerous cases in which saucers have been responsible for the deaths of individuals, there are none, to my knowledge, that describe UFO's saving someone." -- It is essential for the UFO researcher to be open-minded and unprejudiced. We have UFO reports that extend from ancient Rome and Egypt to the present time. and in all probability into the future. Consequently, one cannot say that in the future the UFO may save us or portions of the human race. As I see it, the UFO is apparently performing intelligent, large-scale and complex operations over this planet. This operation appears to be part of one large plan or project and to be connected to the design of the Earth and the history of the human race. The UFO operations of the past, I think, point forward to some unprecedented and future world event. This event, I think, will involve the direct intervention of the UFO into the affairs of the nations of Earth... Kenneth L. Larson, Los Angeles, California

Reply by I.N.S. Assistant Editor Jerome Clark

Unfortunately, Mr. Larson, your letter cannot be discussed from a strictly factual basis, for what you have written depends almost completely on personal beliefs not susceptible to rigorous proof. My comments in the article were based upon, and I quote, "that which past experience and logic prove to be false." It is not, of course, absolutely impossible that the UFOs may be here to save us. However, in the light of what the saucers have evidenced about themselves during their tenure in our atmosphere, this seems most improbable. I myself prefer to use past performances as criteria for judging future actions, since, and I believe most researchers will go along with me on this, it is not likely that sometime in the future the intelligences piloting the UFOs will effect a drastic change in their views toward us.

I again am taking the opportunity to reply to Assistant Editor Jerome Clark and Editor Timothy Green Beckley through these pages. Let me first concern myself with the "little men" idea. I did state in my letter that I don't believe in them. But my (or anyone else's) disbelief in no way disproves them as a possibility. Opinions influence many people, but prove very few

things, because of their being just that--opinions. I believe that "little men" are a possibility in the light of my thesis in "A Case for the Contactee." But in the light of what I have read of future evolution (see article in next issue of the I.N.S. Report), I prefer to visualize the "space beings" as possessing characteristics more like than different from earth man. Answering the question "Do I believe in little men?" I reply no. But, once again, this does not disprove them as a possibility. In a similar light, let me clarify another point as to why I believe in the possibility of the contactee, yet do not accept all contactees and their opinions. If, for example, one contactee says that all contacts come from Mars and another says that they all come from Venus, how can I accept both of these, with one disagreeing with the other? If we are to assume that at least one is right, we can accept only one. We can't accept both, because of the one contradicting the other. One can believe one of four things from this example: (1) that neither of these are proven, but both remain a possibility; (2) the Mars concept is the right one; (3) the Venus concept is the right one. Or (4) that neither of these is right. It is obvious that to accept all contactees as being truthful I would be contradicting myself. Jerome Clark asks in "Some UFOlogical Fallacies" what I meant by proper information. I meant the purpose for which the saucer people have come. I do not say (or mean to imply) that this purpose is known. The third quoted paragraph shows this, namely, "...for whatever purpose these saucer people are here (mapping, surveillance, hostility, Great White Leaders, Saviors, etc.)." I merely list these as opinions of the purpose. It isn't known for certain what the purpose is. It may be one of these listed; but the possibility of it being something else is just as great. To the question of who is more qualified--Asimov or Michel--I now turn. I know that Dr. Asimov is on the faculty of Boston University. Information can be found in any public library on him and his achievements both in science fiction and science. Following are some questions perhaps someone could answer pertaining to Aime Michel: What degree does he hold? Where did he teach? Who described him as well known French Mathematician and engineer? Well-known by who? Certainly not by the common man as a mathematician or lecturer. What other accomplishments has he besides his books? Why aren't his books recognized by any authority on scientific matters as being factually important? What position does he now hold? I believe there can be no doubt as to who is the most qualified! Joe Wright has greatly clarified his position and explained the apparent contradictions in his written works. However, I feel that there are several areas in which he has maintained rather questionable positions, and it is these I now take issue with. I do not understand why he is so receptive to the idea of contacteeism and so repelled by the idea of "little men", whose existence can hardly be in doubt (it is interesting to note that even the most conservative researchers--notably Michel, Hall, Maney, and Lorenzen--accept these beings as the pilots of the UFOs), whereas there are so many objections to the contact claims that it is a mystery in itself why they are even considered by students of the subject. To this Mr. Wright will undoubtedly say that he is merely defending the contactee as a possibility, not necessarily a fact. This hardly needs to be said, for no one will deny that such claims are not absolutely impossible. But at the same time it is a possibility that within five minutes of my writing this a meteorite will fall out of the sky, pierce my house roof, and demolish this typewriter. Improbable, surely--but still possible. I am sorry that I cannot supply any information on Aime Michel's scientific training. Nevertheless, I will say that I know of at least one well known scientist (a UFO skeptic, be it noted) who has commented favorably on Michael and his ability.

BRINGING THE JOE SIMONTON UFO
CONTACT UP-TO-DATE

You probably read of the Joe Simonton contact near Eagle River, Wisconsin with an unidentified flying object on Tuesday April 18, 1961, and the write ups in all the daily papers. In fact the write-ups were so good that Major Donald E. Keyhoe Director of the National Investigation Committee on Aerial Phenomina (1536 Connecticut Avenue, Washington D.C.) objected when I mailed a letter to him on Friday April 21st, 1961 and enclosed one of the alleged "cakes" to be analyzed in order to check the story of Joe Simonton and if possible to see if the cakes were of earthly origin or some outside origin not common to us.

You will recall that Simonton was alone at the time when he heard a noise outside his farm house, some four miles west of Eagle River, Wisconsin. When he went to see what caused this noise he discovered that an unknown object had landed in his driveway near the house. One of the occupants of this strange vehicle about thirty feet in diameter beckoned him to fill a metal receptacle or urn, with what he understood was to be "drinking water". Thusly he went to the house and filled same, and returned with it, and handed it up to the occupant, and leaned his left hand on the metallic side of the object. At that time he noticed another man working over what he thought were controls, and a third man over somekind of a heating or cooking unit and was interested in cakes seemingly being cooked thereon. When the first occupant who took the receptacle of water noticed Joe's interest in the cakes being cooked, he caused some of them to be scooped up and given to Joe, and then the object took off at considerable speed.

Joe knew that I was head of a flying saucer group at Eagle River, and arranged to come to my home late at night and tell me his story. I asked him if he would give me one of the alleged "pancakes" in order that I might check his story and send same in to be analyzed. I was quite surprised that he would agree so readily in giving up one of the few samples that he had. This fact rather convinced me that Simonton was not lying. He was not a flying saucer enthusiast, and had never attended any of our meetings nor read up on any of the literature, so I began to believe his story, for he was not a "drinking man" and was not bearing a reputation as a liar nor as a story teller nor as a seeker of publicity. Just a plain common plumer that was not known as a reader of science or space literature. I know what I am talking about in regards to his reputation around our community as I was born there 71 years ago and served as County Judge for 42 years and knew everybody in that small community. Joe really came to me for help in giving him information as to what it was all about.

Being a flying saucer enthusiast since reading "The Coming of the Saucers" by Kenneth Arnold and everything else that I could possibly get my hands on in connection with the subject. Altho I was NOT a believer in the so-called "contact" stories, but more closely connected to the Major Keyhoe group, for I had read all his books and was a member in his group. I naturally thought immediately, "Now here is a chance to send this 'cake' to Keyhoe and his organization, and analyze it to find its contents and try to find out if the Simonton story was a HOAX or indeed true. So I mailed him (Keyhoe) a long letter dated April 21, 1961 containing the story and the sample for the sole purpose of having it analyzed. I wanted very much to check Joe's story so you can see.

The daily press all over the country immediately got on the job and began calling me at all hours of the day, even while on the "judicial bench on scheduled cases" and I resented being called to the phone while so serving, and told them all that I had mailed the cake on to Keyhoe and his NICAP to be analyzed. It now seems that Major Keyhoe got "sore" because I told the press just that. Furthermore Keyhoe did not acknowledge the receipt thereof and I had to check to see if they had ever received the "pancake". Keyhoe did not answer the letter but his secretary, Richard Hall, answered my correspondence after much insistence that I wanted to know what had become of the sample. I then learned of their anger in receiving it, particularly because I gave the press the story that I sent the sample on to them to be analyzed. Why this should be so disturbing to such an INVESTIGATING COMMITTEE I cannot understand even to this day. Most saucer book authors complain of "poor press," "service" which they get on saucer sightings and yet, here, in this particular saucer sighting and contact story, the press was glad to get all the information that they possibly could. Even were somewhat obnoxious in calling me at some of the most outlandish periods of the day FOR INFORMATION. So I personally have experienced a different attitude as to sightings than others have otherwise announced in the past.

I was anxious to learn what the analysis would show; whether the sample was a fake or a hoax. Other saucer investigating societies such as Mrs. Coral Lorenzen of Tucson, Arizona, director and publisher of the A.P.R.O. Bulletin, who thru her friend, Mrs. Cecelia Hess, of Rhinelander, a neighboring city just begged for the return of the "sample" so that Mrs. Lorenzen could analyze it, or, at least, obtain another sample, but Joe would not let another go after the Keyhoe treatment.

Keyhoe's secretary had a bitter correspondence with me over the publicity and I then demanded the return of the sample, and that I would take care of the analysis myself, but I could not obtain the sample back that I so innocently mailed them. They alleged that they had sent it on to a chemist in New York City and that he had it and that I would get a report when the analysis was actually completed. Making a long story short, I state positively that to this day (over two years later) I have NEVER received any report of that chemical analysis from Hall, Keyhoe, NICAP or any chemist that they allegedly sent it to be analyzed. I rather believe that in all fairness to me, after all the effort I made to send it on to them, in the first place, demanded that I get some kind of a direct report on this strange "pancake". But NO: this is the truth as to the treatment that NICAP hands out.

Now, later, one of the members of NICAP (I dropped out after such treatment) Mrs. Cecelia Hess of Rhinelander, Wisconsin, who lives about 24 miles from Eagle River and had attended some of our saucer meetings at my home and otherwise, has REPEATEDLY spread the FALSE story that one realtor, of Eagle River (Harry Pride) also interested in so-called, "Pleasure Island" an amusement park here had hypnotized Joe Simonton to tell the now famous "pancake" story. Now I have nailed her on the false story to her face, before the other members present at several of our meetings, that I have known the said Harry Pride personally since he was but a kid, and that I have known him well; that he is a personal friend of mine; that he never knew anything about Hypnotism and still does not; that I have been a "showman" all my life; a semi-professional magician and ventriloquist (just returned from such a convention of the International Brotherhood of Magicians at Knoxville, Tennessee, July 1st to 4th, 1963 inclusive, where they came from all over the world to this gathering); that I knew practically all Hypnotists in Illinois, Minnesota, Michigan and Wisconsin personally, and that Harry Pride NEVER could hypnotize anyone and that I was certain that he associated with no one that could do so; and in fact when I approached Harry over a year ago, and also within ten days,

he nearly laughed and said "She is crazy" in spreading such a story. Now Harry is a "so-called good fellow" and may have originally made that story up for her benefit, as he met her at a Dale Carnegie meeting, taking the course together, and may have "played the trick" on her, because she was as big an enthusiast of flying saucers as I am, but the point I have tried to make is that in spite of his attitude, and also my refutation of the hypnotism story she continues to repeat this story. Remember she is still a member of NICAP and a friend of Major Keyhce.

Let me also state that there appeared the "identical story" of Cecelia Hess, in Ray Palmer's FLYING SAUCERS of July 1962, an article under the name of Frank Patton. I have reason to believe that that name is not the true name of the author thereof, or authoress of that story. That it is a fictional name, or Nom de Plume, for Cecelia Hess, of Rhinelander, Wisconsin. I could be wrong, but does any one know of a Frank Patton and his address? If I am wrong, I shall gladly apologize in this magazine. But I believe Ray Palmer, whom I know personally, and have been at his home and he has been in mine, ought to check this story, as to whom this party Frank Patton is under these circumstances.

The Patton article on page 18 of that issue states: "I won't hedge.. here is the gist of what I heard: It seems a local real estate firm was planning to open an amusement park in the vacation area near Eagle River" (Authors comment: There is no other amusement park at Eagle River but "Pleasure Island", and it is operated chiefly by Harry Pride and John Morley, of Eagle River, 1962 and presently again in 1963).. Pride is a legitimate realtor at Eagle River he is the only person who could possibly fit the description, and wouldn't it be quite an incident if another party (one Frank Patton) whom I do not know of actually eases dropped on Pride's conversation in a restaurant after one of the Dale Carnegie Classes, wherein Cecelia Hess attended, with Harry Pride and others, actually heard such a story and remembered it all in details, names, places, and all? Then the article in Palmer's magazine goes further "One of the features was to be Joe Simonton, who would be available to tell his story to one and all. It should be quite a drawing card." Notice that Simonton DID NOT appear before the public at the park in 1962 nor has intentions of doing so in 1963. I know because I saw him on the street in Eagle River June 8th and he just recently got back from the annual convention at Buck Nelson's where he met plenty of others and tells me that he learned a lot about flying saucers, and in fact, has a tape recording of all the speeches and came to my summer home on Wednesday evening to listen to it. To continue with Palmer's mag. "we visited Joe several times. Each time we gave him the treatment, over and over, until he had the exact details of a visit from a flying saucer, a request by one of the occupants for water, and a gift from him of the three pancakes. Joe really believes he saw those saucers, but it was all HYPNOTISM. We got the idea from noting all the publicity saucer sighters get, and we thought it would be a terrific drawing card for our new park." There you have it. Joe Simonton never saw any flying saucer, no three men, one of whom asked for water and no hovering disc that made off at terrific speed. He did receive three pancakes, made by his hypnotists, and they certainly are not of other-world origin."

Now that the story by one alleged Patton. We saucer enthusiasts of this community have called a meeting at my summer home on Sugar Maple Lake, three miles north of Phelps, Wisconsin for 7:30 P.M. Thursday August 8th, 1963, when Joe will give a report on the Buck Nelson convention that he recently attended. I shall afterwards present the present status of the UFO situation. Joe will be there, and I have also invited Mr and Mrs. Hess and may even call upon Harry Pride to attend. I hope to be able, once and for all to clear up the above incident so that Mrs. Hess will never again spread the false story that Joe Simonton was hypnotized.

THE GALT SAUCER

It was back in 1957 when we were all talking about flying saucers. I had purchased many books on the subject, just like everyone else, and had even organized a small group who were interested in learning more about the subject.

In July of '57 when there was news of many sightings, we got word that one saucer had landed in Galt, Ontario and that it had been observed by a number of teenagers. We wasted no time in getting down there as Galt is located approximately ten miles from Kitchener where I reside. We drove to Jack Stephens home, he was one of the witnesses, and found that he was quite tired of answering too many questions about the landing but he consented to show us where the saucer had landed.

When we arrived at the scene, we found plenty of evidence. The ground where the object had landed was scorched black, bales of hay had been broken open. Branches broken off in the nearby bushes. Hundreds of people had previously been there and trampled most of the area, so that the footprints made by the saucer had almost been wiped out. Jack told us that we could get some earlier photos taken by the Galt Reporter, or from Mr. Hartman who at the time was interested in the ground analysis.

I thusly obtained several prints from Phil Potentier of the Evening Reporter and one from Mr. Hartman.

However it was not until a month or so later that I began to study the footprint photos and discovered to my surprise that faces appeared to be on one of the prints. I pointed this out to others but none guessed this had any connection with the saucer, thinking it was just our imagination.

I had completely forgotten about these faces, until about a year or so ago I myself photographed a UFO.

Several months had passed since the sighting and I was beginning to get discouraged that no one seemed to take an interest in the photo. I thought it strange that many well known researchers refused to answer my letters or analyse the photo. The only unusual thing about the picture I thought was the fact that I also got the planet Venus at the same time.

Studying the picture some more, I found that I could make out several faces and also transparent spacecrafts. Possibly due to the fast film I used in my Polarcoid camera.

Things were beginning to add up now, and suddenly I realized that "negative" entities were connected with it. The pieces of the puzzle began to fit together, and I realized that I had indeed stumbled on to a possible solution to the saucer mystery.

The space craft which landed in Galt back in July of '57 was possible from the same place, as the one I was able to photograph in April of 1962. In both instances "unfriendly faces" appeared on the pictures, and the fact that I had been silenced, helped to prove that they came from some negative dimension or planet.

On April 6, 1958 along with Gene Duplantier I visited Mr. Hartman to find out the results of the tests he had made on the area in which the Galt saucer had landed. The results were as follows: 1) Shortly after the saucer took off, soil samples were tested under a microscope. An odd blue radiation was observed. Soil taken a fraction of an inch from outside the area of which the object had landed showed no affects what-so-ever. 2) Using an instrument to tell pressure of the soil, he had pressed the device into the earth. It went in about one inch before pressure registered. But, where the soil in the print should have been compressed and much harder due to the weight of the

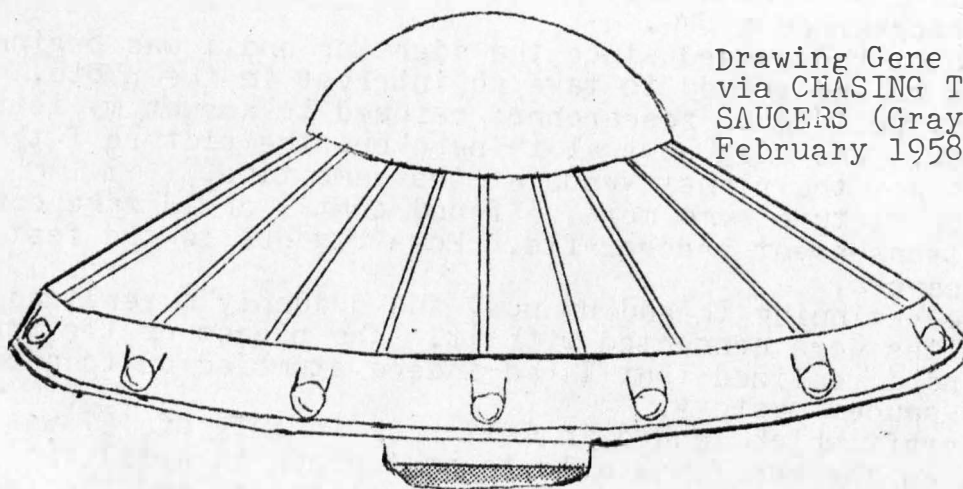
saucer, the device went down four inches before registering pressure. It could be described as moon dust. 3) Soil was sealed in test-tubes. It divided itself into fine particles which went to the east side of the tube, and coarse particles went to the west side. A thin layer of earth at the top seemed to glow when put near the light. Water was also present on top. 4) When grain samples were grown, they were healthy and sturdier than the grain elsewhere in the field. 5) Ants in the scorched area where the saucer landed were larger and stronger looking than ants in untouched areas. Also the ant hills themselves were much higher than the ordinary ones. 6) More of this earth was placed in a jar and sealed. A tiny spider was unfortunate to get itself into this jar the same time the earth was put in. But if the spider was to face its like species now, it would be called a giant, because it was about ten (10) times its usual size. 7) Six inch long nails were put in another jar containing earth from the print. Two probes were put on the various nail heads which was in turn attached to a galvanic meter. This is an instrument for determining the strength and direction of a electric current. When connections were made, the galvanic meter hand on the dial jumped the full range of the dial.

Two more tests were made for (a) continuity, (b) magnetic current. Conclusion: POLARITY IS ELUSIVE, COULD NOT FIX POLARITY. This test was made by a Mr. J. Stauffer, a "ham" radio operator. The above test was witnessed by Mr. Mike Mathews, news announcer for Galt radio station CFTJ.

The above information was printed and verified in the May 1958 issue of Gene Duplantier's SAUCER SPACE AND SCIENCE.

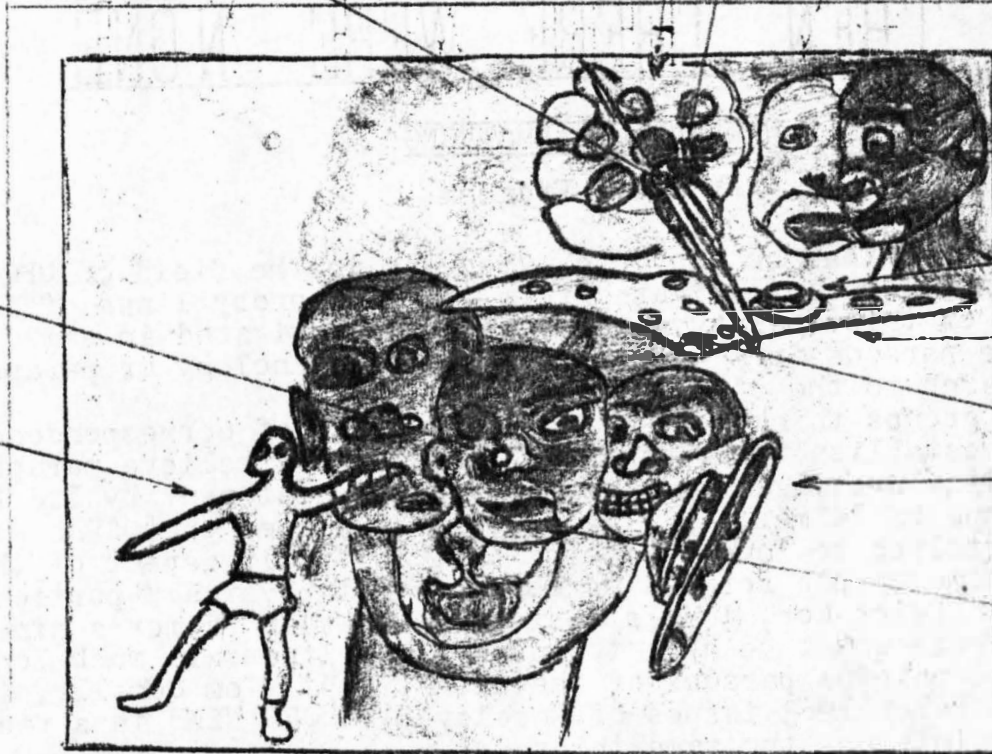

I am glad to see that so many clergymen are in the field of UFO research. Since "reality" is to be investigated from all and sundry lines of inquiry UFO's are a part of this reality and should be investigated in same. A UFO group should have persons from space medicine to demnology or parapsychology. From atomic research to the clergy.

Not all UFO groups think so. A recent exchange of correspondence between NICAP and myself establish the fact that NICAP doesn't believe parapsychology is necessary in its investigations. A more recent statement by L.J. Lorenzen in the May, 1963 issue of Palmer's Flying Saucers discloses that APRO has completely resigned themselves to investigating the "physical" aspect of the UFO's, as if there was some simple formula whereby the "metaphysical" portion can be conveniently abated. Peter Kor, in his series of works in Palmer's zines, has shown why researchers won't be able to investigate like this much longer without "realizing" the painful paradox of the situation". Tom Comella, in the December 1962 and March 1963 issues of Moseley's SAUCER NEWS in a facsimile of Kor's works, points out the same thing.

It can be seen, that if we cannot come to somekind of an understanding between these two extremes -metaphysical, etc, one hand the physical on the other how can we even come to cope with the much more accepted and common sister link between the two: religion. For it has been said that religion (a fundamentalistic and Christian viewpoint) is the link between the occultistic metaphysicals and the strict materialistic science. Even here, we have various "faiths". The orthodox researcher, with a statu quo that he does not want to dirty, throws his hands up at the whole mess and resigns himself to a convenient line of investigation. As Kor points out, in the long-run, this solves nothing. It was said in a UFO publication that "it is the opinion of this organization that UFOlogy is a non-religious topic....that religion, like politics, has no place in the UFO world. Let's keep UFOlogy what it is supposed to be, a scientific inquiry into (the) UFO." The afore-quoted is similar to other of the modernistic viewpoint. First, it is assumed that science investigates the total of all reality. As Peter Kor and others have pointed out, it does not....ergo, it is "half-fact". Second, the above publication, like the majority of religions today, don't realize the true purpose and information in the Bible and that the Bible contains more unique information than thought. That the true understanding of the Bible may prove to have more genuine connection with the UFO than thought. The remainder of this article is written about a certain group and its founder and that understanding of the Bible....its "prophecies", purpose of man on this earth, and reality.

Usually, the Bible is treated somewhat mundanely. As if it were somekind of opium or a psychological medicine that is good for whatever our superstitions cause us. They have lost all understanding that the Bible is an authority. On the other hand, personages bombastically teach that they have found the answers to "hidden" passages in the Bible, that verse such and such mean so and so. Such mystic and psychoc groups purport to be good, but they make the mistake of not letting the Bible interpret itself. However, one group of Bible enthusiasts showed the Bible is the above mentioned authority. An authority that tells of man's future, man's purpose on this earth and his relation to God and His universe. This is really unfamiliar to the layman. But let not the layman feel resentful: the clergy, our vast majority, do not realize the proceeding, too.

One important facet of this Biblical information is its "prophecies". One third of the Bible containing prophecy of this day and age. God tells us of the events of major and important happenings that will occur before he comes.

It is quite discouraging to find out that the Bible makes no mention of space ships in its history when the Bible is interpreted correctly. Since such evidences as the "Piri Reis" map (see Keyhoe's FLYING SAUCERS:TCP SECRET pages 212 to 215) indicates that the earth was under a "world wide AERIAL survey" by cartographers "more expert" than curs, it seems ironic that the Bible makes no uniform mention of such. Still further, in 1958 an object found near Piraeus, Greece was examined by Dr. Derek Price at the Institute of Advanced Studies in Princeton. He found it to be a mechanical instrument operated by a lever. It showed and precisely moved the reproductions of the planets of our solar system at a time when we thought they had no knowledge of our solar system! That's like a jet plane in King Tut's tomb. Yet there it is, a fantastic instrument and an ancient map, but no mention of the vast activity that most surely accompanied the two incidents.

UFO's (as UFO's) MAY be mentioned in the Bible's historical date, but let's look for mention of space ships in the Bible's prophecies for this day and age. The one-third of the Biblical prophecy for now and our future. Perhaps, even more strongly we are confronted with the shocking fact that our "future" makes no mention of space ships in the Bible's prophecies for today and tomorrow. Further, no mention of outer space life and intelligence is told of. He tells of the troubles we must suffer through. He tells us of several major happenings that He feels are important enough for mention in His Book. But he doesn't mention space people, other gods, etc., or giving us a cure for cancer. Nor does He mention that the just mentioned will invade us from outer space (although, there will be plenty "hell" right here on earth, besides). In short, the Bible centers around the human beings of this earth and their troubles and trials. After mentioning the devil and his demons over a hundred times, and God and His angels more than that, it can be seen that it is particular in its terminology. There is no reason why Biblical ancients should have had "amentia" or a stupidity that wouldn't enable them to label and record the details of space ships and space people, much like we would today, not to mention: Tero, Dero, Serpent Races, Elder Gods, Venus brothers, etc.

It is necessary that the Bible mention intelligent outer-space life and space ships. It is the criticisms of many that the Bible is not a historical-scientific book and it wouldn't be necessary to list such statistics as space ships and intelligence in outer space. What they over look is the fact that the Bible reveals the "purpose of man on earth, in regards to God and His universe". Further more the Biblical prophecy of our future is quite detailed (once understood) and can be used as an active standard to judge UFO theories in the light of our future. Ergo the words of the Bible. "If they speak not according to THIS WORD it is because there is no light in them." (Isaiah 8:20) "Prove all things, hold fast that which is good" (1 Thes. 5:21) takes on real and different significance. As far as statistics, in the light of the just discussed, the Bible words "Man lives not by bread alone....but every word of God" takes on weight, too.

This does not necessarily mean that UFO's don't exist; more specific, the "unknowns". The evidence for some "unknowns" is there, although, the outlined remarks that I have made would tend to cast a damaging picture for UFOlogy. But they exist as what? The Bible says that God has used the shape of the saucer and different celestial events. Ezekiel had a vision. But this was a IVG (Identified Vision of God). In Acts 10:11, Peter has a vision of another IVG: a vessel. Although, Acts 2:19 does tell us that God plans to show signs and wonders in the heavens, it is understood that these "wonders" are self explanatory when the "end time" arrives. It is doubtful that they will have anything to do with space people since the aforementioned paradox will still be evident. These "end events", when prophecy is understood, seem to have more to do with upheavals in the weather and nature, rather than space ships.

We also know that the devil will have the power to fool us. To Satan, it is a simple prankster's trick to make "unknowns" appear as "space ship". To Satan, it is a simple task to, actually, manipulate physical material to arrange a saucer with a cabin and have it emit angel hair, magnesium fragments or what have you. Feeling around with a radar signal isn't any hardship for him either. It is a precise warning of God that Satan will be here to torment us in EVERYWAY (Rev. 12:9). The devils tactics are even revealed to us in air-phenomena (Isaiah 14:29).

If I had a choice, I'd be the first to cast my ballot in favor of the many popular UFO theories with the hundreds of wonderful and fantastic promises of salvation from all the threats that muster around our being. Usually, these sundry theories use "space people" as their format. But, what I wish and what the real answer indicates are two different things, and since the Bible says the devil has the power to fool us in such a way, it may be necessary to have clergymen look into documented cases of demonology and parapsychology. Not in the sense that the two mentioned fields should become a substitute of religion (for the Bible has just as much to say against the "wild" claims of Shaver, Trench, Adamski, Ogden, Bender and others. With their matrix-mosaic of metaphysical and supernatural new age jargon and melange - as in contrast to the "orthodox" views of NICAPIans and APRCIans, whose trite theories are none the less just as ineligible) but as to assist the clergy UFOlogical investigator. ~~God made it clear that Satan will torment us in this modern era, it is quite natural that parapsychological and demonological "case histories" will reveal abundant information.~~

What one would have to do is to look for himself into this matter. Many people have brought Bible passages to my attention as proof of space people. However, I find it to be only circumstantial evidence. Poor circumstantial evidence at that. For, in the light of Bible prophecy and its purpose of man on earth, the evidence should be clear and uniform and concrete. I can't say it is by any means. Here is the barrage of verses:

Job 25:1-6 Does the unclean stars refer to unclean people? Ps. 19:3 outer-space people would hear God's voice too. Job 26:13-14 is God concerned with another people in space? Ps. 29:3 Is this a reference to the waters (heavens) in Genesis 1:6-7? Does Ps. 50:4 refer to future dead astronauts or space people? Ps. 18:2 is space people to be faithful or God's angels? Ps. 57:10 is His mercy great to non-living solar bodies or living things? Ps. 19:3-6 of course, God is concerned with whatever His universe MAY contain. I Corinthians 15:29-40 Here God is telling of the difference of things. Switching from earthly to heavenly things, He states that some things out in space are "equal" to earth things. Angels are not. Who is he talking about? Isaiah 40:22 does this verse, as some say, refer to "dwelling places" of outer space people? In Isaiah 45:12, is God talking of someone other than His angels? In Jeremiah 10:13, is He once again referring to waters (heavens) in Genesis 1:6-7? The preceding has been a gist of the kind of verses that have been brought forth as evidence of the many popular UFO theories. But, when they are looked at in the light of future Biblical prophecy and its connection with man's purpose for existence, it (or they) are understood to be "out of context"; as far as "proof wise".

The aforementioned Biblical situation is open for discussion and re-proof and refutation. But it can't be done with wild sarcasm and sardonic remarks. Honest and polite corrective criticisms are tolerable, not bitter "go jump in the lake". If the pessimistic out look of this article stirs such ineligible criticisms, it would be a reflection on the "criticiser" and not the "accused". In the face of honest and genuine remarks, let's hear your opinions: pro or con.

There is a tremendous amount of activity in UFOdom. As we look at this scale of activity, we see at one extreme the "space brothers" arriving in all their drama to prepare earth people for their quixotic and romantic return. Everyone from "sister" Kalna and Illmuth to "brother" Adonai, Soltec, Voltra, and Monka are viciously flexing their jaws.

Further down the scale, NICAP, APRC and others are running after their "spacecraft" and "space machines" substantiated by their purported tons of filed evidence.

Meanwhile, back at the ranch, Peter Kor sentimentiously alternates that something does exist, but as a hopeless, mundane problem of chemistry of "antibodies" and "extraordinary matter" demonstrated in the collective unconscious.

Ray Palmer has his sloven, inordinate, bizarre Shaver Mystery and a sacrilegious CAHSPE bible paralleled by his reccondite, insatiable, often mysterious private thinking and complete allergy for uniform scientific presentation. A rather similar problem exists with James W. Moseley, who uses his publication as a jaunty playground of entertainment.

The remainder of UFOdom is comprised of "borderland" ideas, concepts of dimensional spaceships, spirit mediums, space contacts, prehistoric birds, space plasma, ray gun bolts and time machines. The scale almost wavers into oblivion with spirits of the dead, equational concepts, and biological factors of borderland sciences.

The preceding paragraphs clearly show the lack of cooperation which is languid and taken for granted in all parts of UFOlogy. There exists a ampliative, stentorian activity, but completely and excessively "undirected".

There is a final shock coming to the groups and individuals listed at the beginning of the last few paragraphs. This shock will NOT come from the infamous adversary of the advocates of the above listed ideals the Air Force. Instead, it will come from a source completely unrealized as scientifically demonstratable (unrealized by such as those publications that say that there's NO scientific qualities in the Bible): the Holy Bible! The Bible is, as Mr. Herbert W. Armstrong (founder of the Ambassador Colleges and formulator of the WORLD TCMRCW radio and television broadcasts) points out a "scientific axiom". Also Mr. Armstrong preaches his words in the form in which the Bible prints them. There are no derogatory stolen verses or little elf thefts. After all, THE BIBLE'S DEMONSTRATABILITY, OR PROPHECY, WHICH IS NOW BEING PROVEN CORRECT, DEPENDS ON THERE BEING NO DELITIONS OR MISINTERPRETATIONS. The Bible proves itself as an authority, and EXHIBITS TRUE PROPHECY AND A "SEQUENCE OF EVENTS" WHICH LEAVE NO PRACTICAL USE OR REVEAL NO AMELIORATIVE INTELLIGENCE BEHIND THE UFO, as avered in the thousands and one popular and unique and rare, alike, theories. This is unpleasant, but as Armstrong says: "I know this is not pleasant to contemplate! I know well, too, that it won't be believed by more than a few. I know only too well that our proud and stiff-necked nations will heedlessly refuse to take warning! But I also know that these prophecies are as certain as tomorrow's sun...."

Briefly, here is the sequence of "damning-to-ufoology" events: When the Nazis went underground after the second World War, they took with them a plan which calls for them rising to power again through the economical (later political) power of the European Common Market (example: see chapter one of Douglas M. Kelley's 22 Cells in Nuremberg). This is final restoration of the Roman Empire, prophesied in the Bible. After their position is restored, the Nazis will cut off trade with America, causing the greatest depression ever. This probability is realized in the news (see: TIME MAGAZINE, July 13, 1962 NEWSWEEK January 28, 1963, LIFE MAGAZINE, April 20, 1962, pages 102-104, 108, 112. SATURDAY EVENING POST, January 6, 1962, pages 45, 48, 50). Coupled with drastic meteorological conditions, this will greatly weaken the United States and Great Britain, inviting every invasion (a point of interest FATE MAGAZINE, June, 1963, pages 40-47). The Nazis will chillingly comply, and conquer America and Britain, making slaves of the survivors. Russia will then conquer the Nazis, but God's supernatural intervention will end the hell in which we will have been forced into. We will watch God destroy Communism and Nazism, in addition to the devil and his demons. The ultimate outcome will be "utopia", Kingdom of God, to the small few that have become true converted Christians, in the quality that God wanted man to become.

Our future will bedevil such people as Norbert Gariety of the, now defunct SPACE magazine, who is on a anti-communist kick, even though communism and Nazism are at a par. Many people will be looking to the skies for their "space friends" to land and rescue them in the nick of time. This just won't happen. Even NICAP and APRC will be genuinely shocked when "nothing becomes" of their mountains of proof of interplanetary spaceships. Peter Kor is wrong by placing the "religious" theory of UFO's on the same par as others, because it is above them all. It is languid in saying, as he does, that the gods won't come down to earth, because only ONE "God" descends. Trench will be just as surprised when all juggling and rearranging of Bible verses to support his "sky people" thesis come to nought. Adamski is in the same boat with his "brothers" and "sisters". Shaver will be plain sacrilegious when what I write here becomes reality.

In retrospect, there can be only three possibilities for a case to uphold the existence of UFO's. The following MAY be accepted by the Bible: (1) UFO's are an invention of a nation (in the light of remarks by such as Michael X in his We Want You, about the rise of the underground Nazi and UFO's the Bible does leave the possibility open for such "weapons" of future warfare. Also, note on flying saucers Flying Saucers, September '62). (2) UFO's are from the devil; or (3) God is using this phenomena. In regards to number three, it must be remembered that if God is using them, directly, they WILL be kept in accordance with the words of His Bible and its prophecy. As far as this is concerned, number two, of the above, would seem to be a better possibility. No dero, terc, or space brother is mentioned in the Bible, which is very particular in its terminology. It's either, maybe one of the above OR NONE. Regardless, and it can be said in the words of Mr. Armstrong's son, Ted: "Prophecy races on...remember, and never forget, we told you so!!" As far as UFO theories, fulfilled prophecy may prove damageing (to think out side UFOlogy as well) and we may one day say: "and then there were none".

If after a personal examination, you feel that the first possibility may be plausible, I refer you to such as Michael X's We Want You (this by no means is confirmation of other of his written books and works). If you want to stick to statistics and are interested in the remaining two possibilities, you will find a lot of case histories in Rhine's "para" and late C.J. Jung's "synchronistic" phenomena. Meanwhile we are left with an explosion of space brothers, subterranean beings, time machines, spirits, and others. A confusion explosion!!!!!!

A vivid, but melange, picture forms before our eyes: there is a tremendous amount of activity; vehement; gigantic; stupendous; bizarre; ominous. The air is saturated with excitement, but it may as well be going on inside a test-tube, it is completely undirected.

Personages in UFO research seem to be saying: "Blood, confusion, disallusion. The world is crammed full of futility and calamity. But, instead of feeling depressed and meaningfully concerned, I feel exhilarated. Naw, naw, naw, naw, until there's no skin left. I want everyone to NAW themselves to death!!" At a time as this, Joseph Auslander's poem Hope of the World would be stimulating to aver: "World, O world of muddled men, seek the peace of God again: In the humble faith that kneels, in the hallowed word that heals; in the courage of a tree, in the rock's integrity; in the hill that holds the sky, the star you pull you heart up by; in the laughter of a child, altogether underfilled; in the hope that answers doubt, love that drives darkness out... FRANTIC, FRIGHTENED, FOOLISH MEN, TAKE GOD BY THE HAND AGAIN."

TWILIGHT OF THE SAUCER ERA

EDITORS NOTE: Besides being a personal friend of your editor and an active Interplanetary News Service advisory board member Jim Moseley is editor and publisher of the second largest and oldest saucer magazine in America, SAUCER NEWS. This is the first article that the author has ever done for a "rival" zine with the exception of Barker's SAUCERIAN years ago. A six issue subscription to SAUCER NEWS is \$2.00 and we recomend it as a must.

The above title may seem rather strange, considering that the author has been publishing a saucer magazine for almost a decade, and plans to continue publishing it indefinitely.

However, it is no exaggeration to say that we are gradually approaching what may well be the end of the saucer era. It isn't that UFO's aren't seen any more! On the contrary, there has been a rather constant number of saucer sightings throughout the years since 1947, -except for the big "flaps" in 1952 and 1957. The trouble is, though, that few people realize this. Even saucer zine editors who do not have the benefit of a press clipping service, as we do, are inclined to think that saucer sightings are decreasing in frequency. The truth is that there are as many interesting sightings as ever, in various parts of the U.S. and around the world, -but, saucers are "old hat" now, and the wire services only pick up a very few of the most sensational incidents. Thus, even a New Yorker, reading his local newspapers, soon comes to the conclusion that saucers are "dying out." This is even more true of a person living in a small town. Unless he subscribes to a saucer magazine, which is most unlikely, years may pass without his reading about a single sighting in his hometown paper.

There are also other, more important factors that are tending to kill off the saucer saga. One of these is the very same factor which has already practically killed the whole field of science fiction. I refer to what might be called "science reality" -namely, the unbelievable advances which the physical sciences have made since the end of World War II. Even ten years ago, only a few visionaries dared to talk about space exploration in our life time. Now only a handful of incurable pessimists and crackpots would deny that the Moon will be explored within a decade, and the nearby planets soon thereafter. Thus, what has happened is this: Whereas the idea that creatures may be visiting us from other planets used to be exciting, fantastic, and daring -today, the reaction of the average man on the street to the idea of extraterrestrial life would more likely be "Who cares?" rather than "I can't believe it." If we Earthlings are soon going to visit other planets, it is no longer as thrilling as it used to be to believe that extraterrestrials are visiting us. The fantastic has become commonplace, and with scientific knowledge now doubling every decade, there is hardly time to formulate a dream before someone makes it into a reality!

Another very serious trouble is that saucer research really has not gotten anywhere in all these years. Hundreds of thousands of words have been written, thousands of speeches have been made, at least a hundred major books have been written -and still no real progress! There is no theory or combination of theories which has made any real headway, and worst of all there is still no direct objective proof that saucers even exist! Yes, we have mountains of indirect evidence: and a few careful researchers have gone so far as to use up their eyesight carefully placing hundreds and hundreds of sightings on file cards, and classifying the UFO's according to speed, color, shape, size, etc. All of this work has accomplished exactly nothing. Even the Air Force tried the same thing, culminating in their famous

statistical analysis called Project Blue Book Special Report #14, published in 1955. If we are to believe the Air Force, they were not able to get any closer to a solution to the saucer mystery than were the civilian researchers, in spite of all the money, personnel, and facilities available to the Government for their investigation.

A mystery which lingers on without any solution in sight, eventually becomes boring to the public. Sensational events help to keep interest alive, but in the long run interest will die out anyhow. This is proven by the fact that the saucer conventions at Giant Rock, California, attract fewer and fewer people each year. Even the contactees are losing their following, and it is small wonder! One contactee or another has already (allegedly) visited all the nearby planets, so it becomes a matter of "can you top this?". In other words, each contact must be more fantastic than the last one, or else it's merely "old hat." Recently, two books were published which had enough of a new angle to be of interest. Al Bender's FLYING SAUCERS AND THE THREE MEN supposedly solved a ten-year-old mystery, and it contained a lot of interesting-if-true material. UFO WARNING by John Stuart of New Zealand, was definitely the ultimate in something-or-other, as it consisted mainly of sexual attacks on an Earth girl by various extraterrestrial monstrosities. Yet these books, particularly the latter, attracted relatively little attention and did not sell very well - mainly because they appeared too late in the game. The saucer book market has become a question of supplying ever-wilder stories to an ever-decreasing public.

In the nine years that I have been publishing and editing SAUCER NEWS, I've seen dozens and dozens of saucer clubs and publications start out with a flourish, reach their peak, and then fade away into oblivion. The average life of a saucer club is about two years. I have seen myself pass from a "green" newcomer into the field back in 1954 to one of the last of the "oldtimers." Al Bender, August Roberts, Dominick Lucchesi, Elliott Rockmore, Gray Barker, and most of the other leaders in the field in those days are now in retirement or semi-retirement. In addition, a surprising number of saucer leaders and authors have died over the years Edward Ruppelt, Morris K. Jessup, Harold T. Wilkins, Meade Layne (founder of BSRA), Tiffany Thayer (secretary of the Fortean Society, and only active member), Cedric Allingham, and several others who are less well-known.

Where will it all end? Frankly, my SAUCER NEWS subscription list was dwindling until I recently took over Gray Barker's SAUCERIAN BULLETIN. How long I can hang onto a "hard core" of my fans and his former fans, remains to be seen. Personally, I expect to see saucers eventually descend to the semi-oblivion enjoyed by ghosts, poltergeists, and other psychic phenomena. Everyone who has studied these fields with an open mind knows there is something to each of them; but as these drag along, with similar phenomena repeated over and over again, and no hope of a solution - they attract only a few followers and are rather consistently ignored by the scientific community and the general public.

It has been said by certain cynics that the real name of the three men in black are Boredom, Frustration, and Disgust. I myself have never been troubled with any of these three, and my personal interest in the subject of unidentified flying objects (UFO's) remains as keen as ever. SAUCER NEWS is committed to continue publication "till the last cup and saucer" (whatever that may mean!). But just how soon the last cup and saucer will be reached, I do not know.

A PARTIAL SOLUTION TO THE UFO PROBLEM

For those who believe in contacts, let me say that this writer told Mr. Adamski, in long talks with him in 1958 and 1959, that the man he met in the desert described in FLYING SAUCERS HAVE LANDED, did not come from Venus, but that the man was trying to indicate the history of Venus to Mr. Adamski. Mr. Adamski would be first to admit that he may not be a perfect mind reader.

Frank Scully was the first to know the answer to the reason for the UFO. He wrote this answer in BEHIND THE FLYING SAUCERS under the chapter title "Theories in Collision", in 1950. But Mr. Scully also got mixed up in the origin of the UFO as Mr. Adamski did. It is no small wonder that Mr. Scully ever heard of Immanuel Velikovsky. WORLDS IN COLLISION, was printed in 1950, the same year BEHIND THE FLYING SAUCERS was printed. How did Frank Scully have access to Dr. Velikovsky's manuscript?

Areal Phenomena Research Organization headed by Coral E. Lorenzen has shown in recent issues; January 1963, March 1963, that the UFOs have surveyed the geological features of our planet. Now they are concentrating on the fauna.

All UFO fans are asked to read all of Dr. Velikovsky's book WORLDS IN COLLISION published by Doubleday, 1950 at your local bookstore. I expressly point out, pages 368 to 371: "The Gases of Venus"; "The Thermal Balance of Venus."

Page 20 of the college astronomy book ASTRONOMY, 1959 by R. Baker says that the clouds on Venus are positively "carbon dioxide". So did all astronomy books prior to the Mariner Two probe of Venus.

Under "The Gases of Venus", Dr. Velikovsky says that the brilliant gases of Venus are the remnant of the tail of a great comet three thousand years ago.

On the basis of research in this book, he concludes that the clouds on Venus are rich in petroleum gases. He shows that Venus is too hot for the liquefaction of petroleum, and concludes that hydrocarbons will circulate in gaseous form in the clouds of Venus. Dr. Velikovsky shows that the absorption of petroleum in the spectroscope is far in the infra-red where 1950 photographs did not reach. He predicted that when the technique of photography improved enough to differentiate the hydrocarbon lines, (by the way, Mariner Two was loaded with infra-red cameras) the spectrogram of Venus, would show that its clouds were hydrocarbons: gaseous oil. Astronomers were as usual blind, as the albedo of Venus is greater than any other planet; .75 compared with .22 for Mars, .13 for the moon. Venus is as bright as newly fallen snow.

Under "The Thermal Balance of Venus", Dr. Velikovsky shows that whether Venus turns rapidly or slowly, the root of the problem lies in the fact that Venus is hot. It is hot because Venus experienced in quick succession its birth and expulsion from a major planet under violent conditions. (All astronomers admit that do not know where comets come from) Venus was a huge comet on an ellipse which approached the Sun closely: it had near collisions with the earth, accompanied by discharges of potentials between these two planets which was accompanied by a thermal effect caused by the conversion of momentum into heat. Venus also had a number of contacts with Mars and Jupiter. All these contacts happened between 2000 BC, and 1 BC., so the core of Venus must still be hot. Dr. Velikovsky predicted in 1950 that the surface of Venus would be found to be very hot, a prediction laughed at by the "know

it all" astronomers of that time.

On March 8, 1963, TIME MAGAZINE published a cover story: VENUS, WHAT MARINER TWO SAW.. Dr. Louis D. Kaplan of the University of Nevada and designer of Mariner Two's infra-red experiments is quoted on page 80. The surface of Venus is 800 degrees F.; a temperature too hot to support life at this time. There is only ten percent carbon dioxide on Venus.

The surface of Venus has both mountains and smooth places like earth. And what are the clouds? The clouds are, says Dr. Kaplan, HYDROCARBONS! On the surface of Venus, says Dr. Kaplan, is "compressed, oily air". The pressure is twenty or more Earth's atmospheres, enough to keep any water on its surface from boiling.

For some years, this writer has corresponded with Dr. Velikovsky, and let me warn readers that it would be useless to mention the UFO to him. He would not throw away his life's work on the solar system to make any sort of public statement in regards to the UFO.

I called attention to the TIME article to Dr. Velikovsky and he wrote me March 14, 1963 that I had correctly observed "that both crucial tests claimed by him in WORLDS IN COLLISION HAVE FOUND VERIFICATION IN THE RESULTS OF THE MARINER TWO PROBE. A photo copy of this letter has been sent to Mr. Beckley.

What do scientists think of Dr. Velikovsky's theory now? In the December 21, 1962 issue of SCIENCE sent to me by Dr. Velikovsky and written by V. Bargman, Dept. of Physics Princeton University and Lloyd Motz, Dept. of Astronomy, Columbia University points out that Dr. Velikovsky worked in person with Dr. Einstein, and Dr. Velikovsky asked Dr. Einstein to use his influence to see if Jupiter emitted radio signals. On April 5th, 1955 B.F. Burke and K.L. Franklin of Carnegie Institution announced strong radio signals emanating from Jupiter. I should add that scientist Roger Gallet, Boulder Laboratories, National Bureau of Standards, in 1957, pinpointed these to two surface spots; explosions of "Tremendous power".

SCIENCE continues that this was a complete surprise to astronomers. On December 5th 1956, Dr. Velikovsky submitted a memorandum to the U.S. IGY Committee suggesting a magnetosphere reaching to the moon. This was found in 1958 by Van Allen, says the article.

SCIENCE then states that in 1950 Velikovsky stated that the core of Venus was hot. In 1954 N.A. Kozyrev found that the surface temperature of Venus was plus 30 degrees C. But by 1961 the surface temperature on Venus was known to be "almost 600 degrees F." Again astronomers were "surprised" in a field where few "surprises were expected". The article points out that radio activity will not produce "an enhanced surface temperature".

Bargman and Motz state they feel impelled to establish Velikovsky's priority of prediction of these points, and urge, in view of this, "that his other conclusions be objectively re-examined".

Now, what about Mars? The readers of this article are going to have the horse laugh on Keyhole, and his predictions of aluminum moons of Mars, complete with space colonies, and other science fiction.

The moons of Mars are, as Dr. Velikovsky predicts, huge chunks of irregular rocks with much drag. They are not only as bright as aluminum, but brighter, probably with an albedo of .75, the same as Venus. They are surrounded by an atmosphere of hydrocarbons-gaseous oil-due to Mars near collision with Venus, in the second millennia BC. These moons must look larger than they are: therefore must seem light.

The canals are huge fractures on the surface resulting from the collision of Mars and the asteroid belt behind Mars says astronomer Clyde Tombaugh, page 289 EARTH IN UPHEAVAL, by Immanuel Velikovsky. Page 366 of WORLDS IN COLLISION shows the "ice caps" to be really some sort of carbon compound acquired from Venus in a near collision, which distills during the Martian summer. Mars's difference in temperature keeps this "manna" from being permanently dissolved under the rays of the Sun. Mars must be exceedingly dry

due to near collisions with the Sun where it must have been almost burnt to a crisp.

What about the "atomic" explosions witnessed by Dr. Saheke and others, since 1951 (page 55 FLYING SAUCERS FACT OR FICTION by Max B. Miller). This is the biggest laugh of all on Keyhoe and his "atomic spaceship" in Siberia, in 1908. On page 256 of EARTH IN UPHEAVAL by Dr. Velikovsky, he shows that should an interplanetary discharge take place between the earth or any planet, another planet; "planetoid or trail of meteorites", with billions of volts of potential difference and nuclear fission or fusion take place, the effect would be similar to the explosion of one or more hydrogen bombs. (One reaction could be neutrons plus nitrogen gives radio-carbon 14 plus hydrogen). There aren't any "atomic spaceships". The explosions on Mars are due to the collision of Mars with asteroids: possibly causing deep craters, or "oases".

It seems to me that Coral Lorenzen and the late M.K. Jessup continually hinted to you UFO fans about Velikovsky. But none of you will take the hint. Why? I call attention to A.P.R.O. Bulletin, July 1962, article "Visitors" where she speaks of Velikovsky.

In the January-February 1958 issue of the British saucer magazine FLYING SAUCER REVIEW M.K. Jessup said, page 23, "Sometimes the Solar System may emit a quantum (comet) at which time a planet might change from one orbit to another. Such a disturbance would fit Velikovsky's postulates about Venus and Mars leaving their orbits at a time of great earthly cataclysm." End quote.

Is there a Mars 26 month cycle in saucer sightings or not? Yes all deep research has shown this. But they do not come from Mars. If you were in charge of all UFO's, and there is some possibility that Velikovsky's theory will happen again sometime in the future, would you not be interested in the gravitational pull, and electrical interaction of Mars and Venus, when both of these planets are in their cycles of nearest approach to the Earth?

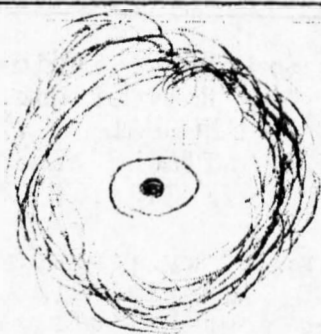
More Biblical Explanations of the Cherubims, Ephas, and Angelic Chariots

BARKER-MOSELEY MERGER

SOME MONTHS AGO Gray Barker gave up the editorship of his Saucerian Bulletin and combined it with Jim Moseley's Saucer News, supposedly ending the "feud" between Barker and Moseley. This means, however, that these two will, now in the guise of friends instead of that of enemies, still continue to con the saucer public in close association with each other. Actually, all the while they have been the very best of friends!

They have made this latest public development between them, as with all their other public actions, into a publicity stunt with which to further shroud themselves in mystery!

This is evidenced by Moseley's 16th "Non-Scheduled Newsletter." In this sheet dated May 15th, Moseley tells of his last visit earlier that month with Barker.

The Moseleys, after having completed the purchase of the Saucerian, are vacationing in Florida when they receive an urgent telegram from Barker requesting that they visit him on their way home.

Later upon arriving in Clarksburg, they find, "The Gray Barker who greeted us there was taciturn and frightened, much as Al Bender is said to have been after his 'hush up' ten years ago. The Barker we had known before was arrogant, carefree, and apparently well off financially. He had had a comfortable office downtown and a pleasant apartment on Mulberry St., in a nearby residential area. Now the big office and apartment were gone, and Barker was living in a run-down old house on a high hill near the edge of town. Barker asked us to be his guests rather than stay at a hotel. It was obvious that his new generosity was not altruism, but some sort of deep rooted fear of being alone at night."

Moseley goes on to tell that a thug assaulted Barker, on whose forehead a small scar remains, and had damaged the printing press. Further Barker dismissed his four employees for their own protection. Barker would not tell Moseley what had caused this sudden change in his life: nevertheless it was quite obvious to Moseley that Barker felt there was an organized force causing his afflictions of those past several months.

As the Moseleys are leaving, Barker, having wished them well, adds mysteriously, "I shall go on publishing books no matter what happens, because I believe."

This above parting pronouncement is typical of Barker's writings. I bid my readers to please beware of his touching tales, written to play to your emotions in an attempt to cause you to lose all objectivity. STRANGE PARANORMAL INCIDENTS! PERSECUTIONS! AN ORGANIZED FORCE BEHIND THE VARIOUS ATTACKS AGAINST HIM! THE "SILENCE GROUP"! LORD, PLEASE HELP THE GOOD MR. BARKER IN HIS LONELY BATTLE AGAINST EVIL! BAH!!!

Friends keep your heads above the water! More than a few of my readers are very happy believing in Mr. Barker's fictitious troubles and will certainly continue doing so. Perhaps it is best not to try and change your beliefs, for if your hearts were seared, you might then espouse something far worse than Barker's secretive spacemen! And yet, who knows, you could be the ones who are right; however, if you were to bother to learn a few of the facts, you too would hold a more realistic viewpoint.

Now to get back to Moseley's bloody Newsletter, the underlying facts in it are true (i.e., Barker's loss of office and apartment, etc.), but its implications are definitely without candor. However Barker is worried, not of any space-monsters, but of some very down to earth troubles. DOBBINS EXPEDITION

EARLIER THIS YEAR a main topic of interest and debate to many saucer leaders, the Dobbins expedition. This, a caving trip into the mountain area around Magdalena, New Mexico in pursuit of discs, flying saucers, and what not was headed by Robert L. Dobbins. According to Dobbins, he had seen discs the size of headlights leaving a cave; but, having attempted to enter the cave, found that he could not descend to a depth of twenty feet, because of a strange paralytic effect upon the spine. Dobbins gave out variations of the above account, but that was basically the story.

According to a report on the expedition sent out by Dobbins, a round brilliant, red light was observed in the nearby hills a few days before the members of the expedition were to arrive in early June. The illusive object was chased by the City Marshall and aids for three consecutive nights. Then on the day the members arrived, "the telephone went out of order, the members took sick, something was wrong with any mechanical mechanism connected with the exploration. It would take several pages to tell of how many things went hay-wire and all in a few hours. It was as though some unseen power had everything under its control. The expedition was attempted and a week later there was nothing in the way of a force or disc observed at the cave."

The whole story is very debatable; in fact, we're not ever sure that anyone went on the trip. The expedition was a first composed of two factions; one the saucer people including the Director of I.N.S., John F. Miller, Ricky Hilberg, Robert Miller and others, and two the occultists. Dobbins himself has embraced the Black Arts. Apparently all the ufologists either didn't consider the story

to be very credible or else couldn't travel to New Mexico, for we know of none that did. Dobbins, however, states that "ten high occultists" whose names he could not reveal, were definitely on the expedition. Also a person with that magical title, "a scientist" had joined. His name, of course, had to be withheld too.

Two members of our staff, besides the director himself, Jim Kelsey and Jim Moseley, had planned on making the trip together. Although neither one of them bought Dobbins's story, they wanted to go probably anticipating a pleasant camping trip, an opportunity to observe some paranoids close at hand (our advise here: get a mirror boys!), and an excellent occasion to invent their own hoax producing front page copy for Saucer News.

SMUT MAGAZINES?

PALMER PUBLICATIONS HAS TEMPORARILY DISCONTINUED PUBLICATION of Flying Saucers and Search. Ray Palmer, the brilliant editor of Amherst, Wisconsin, has gotten into quite a bit of trouble, according to a prepared sheet sent out to all subscribers.

The Freedom Publishing Company, which gave its address as Milwaukee, Wisconsin, was listed as the publisher of one of "the dirtiest of the dirty" as the Saturday Evening Post described it, pornographic smut books published in the country. When the records at the state capital were checked, Palmer was found to be a director of the company. So the District Attorney, having first made a statement to the press that Palmer Publications in Amherst was publishing those books, came down to accuse Palmer and to search the printing plant.

Palmer says that some months before Richard Shaver had formed a corporation for the purpose of publishing his science fiction—and had Palmer to sign as a director because he needed a third party besides himself and his wife. Palmer states that he signed as a friend, without even reading what he had signed (emphasis curs), so he never knew the name of the company.

Although nothing was found, the incident was played up fully by the press, radio, and television; and no one retracted their accusations made prior to the search.

All this brought drastic repercussions. Palmer's paper suppliers decided not to sell paper to a smut publisher. They even demanded that he pay his bills immediately. The banks refused to renew his loans; friends snubbed his family.

Palmer's story for discontinuing publication at this time is quite a bit more convincing than those of the past, but we have a feeling that he hasn't given us the full story. We are sure of one thing though: that no matter what happened, they won't be able to keep the "grand daddy of flying saucers" down for long!

TRAPPED MINERS SEE LIGHT, PEOPLE AND
A DOOR
DENIES HALLUCINATION

Besides the outer limits of space our readers are always interested in knowing about the inner limits of the Shaver Mystery and the possibility of an inner earth.

During the month of August three miners were trapped more than 300 feet below the earth's surface in a Hazlet Pennsylvania mine for more than two weeks. Then two of the miners were brought to the surface (David Fellin and Henry Thrcne) where they related to the press a most unusual story. The third trapped miner Louis Bova has not been found and it is feared he is dead.

On the fourth or fifth day down according to Fellin they saw a door and although they had no light from above or from their helmets it was clearly visible to them. The door was covered in a bright blue light.

Two men, ordinary looking according to Fellin and Thrcne, opened the door. They say beautiful marble steps on the other side. They saw this for a while and then they didn't.

Before they heard from the men on the surface they had light now and then. David Fellin is quoted as saying "...I was really scared when we saw two men dressed like power linemen. Don't ask me what men like that were doing down in the bottom..." Hank Thrcne asked Fellin two or three times to ask the men for some light but this idea scared Fellin down to his toes. "I had the feeling this was something outside of our reach, that we shouldn't talk or do anything."

However after a while Hank Thrcne asked the men "Hey buddy, how about showing us some light?" They didn't answer and in a while they were gone.

On the sixth day Louis Bova who had been separated from Thrcne and Fellin shouted "Hey Dave, hey, Hank! I've come to take you home" The two other miners nearly died the shout came right out of the darkness. Soon after that another voice was heard this time yelling "Look for the light!" This according to Fellin and Thrcne was not their fellow miner Louis Bova.

After hearing the voice yelling, "Look for the light" the two trapped miners started digging like mad toward the sound. After about two hours they found the light about six feet away. It was hanging on a cord from a six inch hole which had been drilled from the top. Along with the light a microphone, food and later a TV camera were lowered.

The two miners still insist they saw what they saw. "One thing I am sure of" David Fellin said "I was convinced we'd get out even if I had to dig myself out."

Now their trying to say that these things were hallucinations that we imagined it all.

We didn't. Our minds weren't playing tricks on us. I've been a practical hard-headed coal miner all my life. My mind was clear down there in the mine. It's still clear.

We saw what we saw. These things happened. I can't explain them. I'm almost afraid to think what might be the explanation."

So goes the story of two trapped miners. The third miner Louis Bova is believed dead however drilling at the site still continues as this is going to press. Another chapter has been added to the Shaver Mystery. In the near future the Interplanetary News Service hopes to extend an entire edition of its publication to this theory along with more information on the inner earth. A PRIEST UFO FAN

A WHISKING WHIRL

If you readers will recall, last issue we were discussing various theories in connection to what is referred to sometimes as "mysterious falls from the sky". In trying to explain them away we come next to animal matter and the like which fall or appear to fall from the sky.

And fish? Well, they too very likely will fall together. Granted they have a smooth aerodynamic shape. But they will spread their fins, I suppose. For the latter reason they may glide quite far and stay up much longer, especially if they hit rising currents of air. And the frogs, by their shape, outspread webbed feet, will perhaps glide even better than fish. But they're all the same, almost identical, and their instinctive reaction will very likely be uniform so that they too will fall on one small plot, as if they had been deliberately dumped there by some intelligent creature.

And, by the way, let us not forget that Charles Fort and others who gathered reports on such phenomenal sky-falls say explicitly that many times these weird events were somehow or other associated with storms, and that these were UNUSUAL storms: They came just before, during or right after the storm; or they were on the edge of it, i.e. clear skies at the fall, but frighteningly dark skies within the eye's reach.

Three more facts should be stressed here: 1) The eyewitnesses said that these storms were UNUSUAL by their violence, and/or rareness. Now, the sky-falls themselves are unusual in many ways, including their rarity, when you compare their frequency with that of tropical storms in general. 2) Jessup and others report that eyewitnesses said they saw people disappear SKYWARD during some tropical storm or other, for instance during the hurricane of 1780 which killed 6,000 people.

3) According to Larousse's French dictionary seafarers have seen at sea violent whirlwinds pull up with great noise columns of water: a continuous mass, not just a spray. The same authority asserts as an accepted fact that small bodies of water and swamps are sometimes dried up by these winds. Now, the late Morris K. Jessup pointed out that generally the animals in these sky-falls are aquatic or of the lowest forms like fish, snakes, eels, snails, frogs and the like. He stresses that this shows intelligent selection. Not necessarily, as you should see by now. Keep in mind that many other kinds of animals and all kinds of objects have been reported.

And lest I forget, I'd like to point out here that since certain small bodies of water will get very warm and stay that way even through a good part of the cold season until the arctic fronts start to come down and spawn tornadoes, one should not immediately see ufological action when eyewitnesses report that WARM water fell from the clear skies in one mass as if from a torn balloon.

For the reasons given above and others yet to be presented, I am inclined to think that the Air Force is right when it dismisses sky-falls with one or two words: "whirlwinds" and/or "jet streams." The latter need to be defined clearly before we attempt to use it in order to explain further and better, the above and other various aerial phenomena connected with sky falls. According to the United States Department of Commerce Weather Bureau a jet stream is a narrow current of air moving eastwardly, continuously or brokenly in several discontinuous segments, over the northern or southern hemisphere, wave-like (both horizontally and vertically). "Sometimes,

especially in the winter, there may be more than one jet stream at the same time over a hemisphere. On occasion there will be two jet streams over the continental United States....one along the northern border and another well to the south. Its intensity (velocity) varies with the seasons, being generally most pronounced in the WINTER." In other cases, smaller detached 'fingers' of VERY STRONG winds are found some distance from the parent jet stream. The maximum speed is in the core: 250 mph. On either side it diminishes to 100 mph. And vertically the difference in velocity between the maximum (core in center of top layer) and the minimum (that of the lowest layer) at say 5,000 ft., may be more than 100 mph. "The height of the core is not always uniform...nor the velocity." In one illustration the core reaches its maximum speed as it passes over St. Louis, Illinois, then slows down gradually to 150 mph."

The above are quotations and paraphrases from the weather bureau with my own emphasis to bring out important FACTS in the case.

Suppose that the waterspout-whirlwind-tornado detailed earlier originated and developed in one of the Southern States of the U.S.A. in the winter and that it carried in its swirls a variety of aquatic animals, plants, organic and inorganic matter. As the whole system spirals skyward, with its load, it also and at the same time moves horizontally an average of 25 to 40 mph. The topmost spiral arc will fling its contents up and away, as if from a giant sling. Now, if there is one of those jet streams in the vicinity, the barometric pressure just outside its course will be unusually low due to Bernoulli's principle. Hence, the mass catapulted by the whirlwind will meet with less resistance, stay together and go much further than otherwise.

And now suppose that the trajectory of this mass happens to be eastward, which happens to be generally the direction of the jet streams in the Northern Hemisphere, it will be taken for a ride and probably a long one. Some articles will go further than others because of their kinetic energy ($mv^2/2$) and their aerodynamic shape. So, already there will be some selection and segregation. Furthermore, at least some of these objects will perhaps account for "clear air turbulence, which has been found to be closely associated with the jet stream...and is believed to be caused by the shearing or 'tearing' effect that occurs when adjacent air currents move at different speeds." As a result, the articles caught in there will be tossed around. Some will rise higher, then fall to lower levels and be tossed up again by rising currents. In some instances not too far fetched, there will be freezing. And that explains how, embedded in many cakes of ice that fell here and there over the years, fish, frogs, pebbles, etc. were found. The fact that sometimes the animals are still living is astounding but not necessarily ufological.

And now another fact, generally ignored by those who have made up their minds that ice-falls must be the work of the ufnauts (ufocrew). In a booklet titled: ICE ON AIRCRAFT, by the U.S. Weather Bureau, the authors say that among the many circumstances which will bring about the formation of ice on an airplane the following are quite commonly the cause: If a plane is flying say at 2,000 feet from a cold region (below freezing) into a freezing rain, clear ice will form on the wings. The pilot is told that "one way of escaping the ice would be a gradual climb into the warm air above; that the airplane may already have a heavy load of ice that makes it impossible to climb." Obviously, if the load is not too heavy yet, he will climb in order to avoid grave danger. When he does the ice will escape. But, for reasons one can easily surmise, the observers down below on the ground will be able to see nor hear the plane; and so they will not directly associate the ice-fall with it. Since damage could and does sometimes occur, the Air Force is not anxious to admit the ice came from the plane.

Coming back to the natural forces as a sufficient explanation for the above mentioned extraordinary sky-falls, it occurs to me that just an ordinary thunderstorm along has enough well known factors to explain part of this aerial phenomenon, even when it happens "out of a clear sky." A thunderstorm

cell in its first stage is composed of one cumulus cloud and an UPward current of air, which begins generally near the ground and continues right through the cloud, the top of which in this stage, is at about 25,000 ft. altitude. In the second stage the cloud has expanded up to 40,000 ft. The upward draft has increased in velocity as it rose and may have reached 30 mph. Some irregular eddies or WHIRLS rise at even 50 mph. As the altitude increases the temperature drops, and this causes the water vapor to condense into liquid or solid, depending on altitude, and I think pressure. When the drops or other forms of condensed water are heavy enough they fall, and this causes a downward draft, for a vacuum is created in the wake. When the resultant mass of air hits the surface of the ground or nearly so, it takes a horizontal course, at a speed which sometimes is 75 mph.

Now, many thunderstorms are multicelled with individual cells at various stages. Suppose that the just-mentioned horizontal draft hits some shearing, and this brings about a turbulence according to the meteorologists. At this point, the author will try to explain by himself how probably a whirlwind and or a waterspout will be formed, given the conditions: Fluids, as Perry and others have proven, behave like semi-solids, when they are in energetic motion. Now, strong winds are gases and vapors (fluids) in rapid motion. So, the above mentioned 75 mile per hour, horizontal current should cause the vertical upward draft to spin. Therefore, the air should rise spirally, or cylindrically. Prior to this impact, the rising column already had that tendency and more due to the rotation of the earth on its main axis, plus other factors detailed above. Now, matter in motion leaves in its wake a space which will be more or less and momentarily empty. The surrounding air will rush in. Everyone I am sure is quite familiar with the fact that mud rain and/or snow will follow in the wake of a van and even cling to the rear. A swirl of air, being matter in motion, must produce that effect. If so, the air adjacent to the swirl, but not yet part of it, will suddenly find itself under a relatively higher barometric pressure. As a consequence, the molecules of air, water vapor, etc. will push each other outside and upward into the wake of the swirl. It follows from this that the interior of the spiral will suddenly become a partial vacuum. Here again the explanation is personal and subject to error. However, regardless of the explanation, the facts remain.

That, I believe, supports sufficiently my theory that an ordinary thunderstorm, a fortiori a violent one, could lift various objects up to even 40,000 ft. If you have doubts, consider the fact that the U.S. Weather Bureau in Washington states clearly in its brochures that if an airplane flying through an exceptionally severe storm at 200 mph at a constant power setting and altitude, could be displaced UPward by as much as 5,000 feet.

Lest I forget, allow me to insert here the probability that, as for tornadoes, the upward drafts of the extremely severe thunderstorms could inject their contents into the jet stream, including cakes of ice. But, there is an apparent contradiction: Before the supercooled water can solidify, the pressure around it must diminish so the molecules can take their positions to form crystals. Now, the pressure inside a stream of air in rapid motion must be very high since it behaves like a solid. This current must be quite rapid if it's going to inject itself into the jet stream. It is rapid on top of some cumulus clouds it has been clocked at 500 mph, and some gusts are faster yet. Moreover, as it reaches the top, it arches so that in some cases it could pierce the jet diagonally and then go along with it more or less smoothly like one who would run along a moving train while boarding it so as not to get that jerk which could be disastrous. But, there is bound to be some shearing with resulting turbulence at the juncture. We need that to account for the congealing of our pockets of water into blocks of ice, which after that will be carried away, far away from the storm and fall out of a clear sky with no storm in the vicinity. Turbulence, of course, will break up the current, reduce its interior pressure and allow the molecules of water to align themselves so as to form beautiful cubic crystals.

But how about the blocks of ice which are associated with a storm?

Obviously, that is more easily accounted for. Simply change the numerical values for the size, shape, weight and density of the pieces adrift. Another plausible explanation: When a cell (cloud) is mature, rain and/or snow begins to fall. A vacuum is then created in the wakes of these falling particles. The molecules of air and other entities in the vicinity follow, and as a result the "downward draft which begins in the middle and lower levels of the cell gradually increases in horizontal and vertical extent." Thus, pockets of supercooled water in the higher regions will gradually slow down and then stop. The pressure around them, will be greatly reduced and solidification should be very rapid. The ice could come right down through the cell or just on the outside, for, in multicelled thunderstorms some of the clouds are tilted. It is also quite conceivable that sometimes while falling from a tilted. It is also quite conceivable that sometimes while falling from a tilted cell, the cakes of ice fall on a "young", immature cell in its first stage with a strong upward draft. If one of these, as authorities claim, could lift an airplane 5,000 ft., it certainly could do the same and better to a mere 50-lb. block of ice.

And that very aspect, plus others, gives us a good hint as to how we can explain by natural, telluric forces alone why some blocks of ice, meat and even pebbles were seen drifting and then falling with an astounding slow speed. Note well that the downdraft has a maximum speed of only 20 mph. And it begins to slow down long before it reaches the surface of the earth, which obviously acts as a barrier. Sometimes this deceleration begins even at 5,000 feet altitude. Why? Meteorologists say: "This downdraft.... begins in the middle and lower levels of the cell." Now, according to the diagrams I have here the lower level is sometimes at about 4,000 ft. So, it seems that at the onset of the precipitation phase some air may still be rising up to even 5,000 feet and that would slow down the downdraft. Near the earth, of course, the first portions of the downward stream must backlash into the portions that follow, slow them down and make them swerve. Whatever the explanation is, the FACT is that the downward current of air, before it reaches the ground, loses its vertical direction and arches out under the cell in various direction, but especially in that direction toward which the cell and the whole storm is moving, for, that must be the imaginary "line" containing the lowest barometric pressures, and, therefore, the line of least resistance.

The resultant surface wind will reach even 75 mph and "will extend for several miles (emphasis mine) in advance of the thunderstorm itself." When it encounters obstructions such as buildings, hills and the like, rising eddies will be formed.

With all these FACTS in mind, whatever the explanations to account for them may be, any really broadminded person should see how sometimes the sky-falls drift in the air and then fall down so slowly that some of the animals, surprisingly enough, are not killed by the impact and the ice is not always as broken as one would have expected.

And that, in my humble opinion, takes care of another aerial mystery. But, how about the sliced and shredded meat? For a long time, I too, had to blame the ufonauts for that one. Whole animals like frogs and birds especially, since they're aerodynamically shaped, and probably under such circumstances would help the wind by spreading their appendages, offered me no problem. Four footed animals who while running for protection would be off the ground or nearly so, thus offering the whirl the extra assistance it needed, did not pose a problem when I tried to substantiate my theory. Neither did the fall of blood.

But, when I read reports of pieces of animals especially when in a particular shape: strips, shreds, I was stumped, and glad to be because then I had another argument, I thought, for the fact that extraterrestrial humanoids are visiting our planet. However, to my dismay, an explanation suddenly flashed under my cranium. I couldn't get rid of it. Quite the contrary, when I metaphorically dashed it on a boulder, insted of killing it, I made two out of one

Years ago, and even today, on farms, also in lakes and other bodies of water you find all kinds of animals confined in cages, coops, pens, sties, nets, etc., which are made up at least in part, especially on top, of fine wire in various types of meshwork. Now, out of the millions of tornadoes which occur here and there over the globe in the course of a few years, you can visualize one with a 300 mile per hour gust in it passing by one of these many wire constructions. At the immediate approach of the storm an animal would have the tendency to run. So it would be off the ground completely at times, which obviously would accentuate the striking force of the whirl. Also, the animal's skin would taut because of the extensive and intensive muscular activity. Add to that violent breathing, which at times at least makes the thorax very tight. All this is a perfect preparation for slicing, stripping and/or shredding. Density reduced, but tightness increased. The wind, of course, will pass unimpeded right through the wire; the animal too will pass, but, not in one piece. A bird would produce shredded tweet.

But, sometimes the flesh, according to the eyewitnesses, falls in amorphous pieces. What happened then? I'd say that the poor animal exploded. When a tornado passes over a house with its 'eye' the pressure around the house is suddenly reduced considerably. The air inside, being under a much higher pressure, especially if all the vents are closed, rushes out violently and that causes the house to explode. Are the ribs and skin of an animal stronger than the walls of a house? And by the way, you need not postulate a wire enclosure to explain this case.

While we are at it, I like to suggest that we have right here the probable explanation for hailstones and other pieces of fallen ice that explode. Air was trapped inside and the ice fell on a low pressure area. Add to this the fact that every often these blocks of ice contain dark material. Now, ice with a curved surface could act as a lens and converge light rays on this dark material, which as seen, would convert this form of energy eventually into heat. Now, air is a poor conductor of heat. So, the air would expand very fast, long before the ice would even begin to melt. As a final result the cake of ice would explode.

All in all then I have the temerity to think that our violent storms sufficiently account for the sky falls as defined above. There is one type, however, which, I am most happy to say, the above theories fail to encompass: the famous 'angel-hair' which I'd like to christen: ufolon, obviously from the word ufo and the suffix-lon as in nylon, orlon, etc.

To be noted here, the fact, as far as I could find out, that harring ufolon, the other sky-falls were never seen coming down from a ufo, nor even associated in any other way with the ufo. But, the ufolon, on the other hand, is most of the time seen very closely associated with these spacecraft: It's coming out of it, or it's coming down while the craft is above actually or was there shortly before.

Finally, this ufolon has never been analyzed nor duplicated yet. So, I for one firmly believe it is extraterrestrial. But, the other sky-falls are at most and only at times exotic. And that, by the way, could account for the mysterious vanishing of certain people, animals, airplanes, etc.

In conclusion, I submit that with the exception, of course, of angel-hair, sky-falls should not even be mentioned as an argument to prove the fact, otherwise very well established, that extraterrestrial humancids have visited us in the past and are visiting us now. Indeed, in argumentation it's not the quantity but the quality of reasons that count. In fact, poor arguments tend to weaken the value even of the good ones and hence the very position itself. Weak blows not only do not hurt the opponent, but they arouse him into more violent reactions which may turn out to be disastrous.

HEY, URANUS, WHAT'S THIS???

On July 15th Roy Blanchard found a three foot deep pit in one of his barley fields near the tiny Dorset village in Charlton, England. Convinced it was a craft from outer space, he called in the Army and police.

Everysince that time the area has been anything but drowsy with helicopters roaring around overhead and Army Engineers digging away at the hole. Cars are reported to have been parked for miles the day after the hole appeared on an old dirt road near the sight of the landing with everyone trying to get a good look at the sight where in all probability a flying saucer landed.

The crater or hole is eight feet wide with four trenches radiating from the edge.

It was the first in a series of such craters which have been recently showing up all around the country. In Scotland, police and bomb disposal men were just as baffled by two other craters. These were discovered on James Brown's farm 21 miles south of Dunbar in East Lothian.

Each of these craters is about 16 feet across and 2 or 3 feet deep. Forty feet away are great lumps of earth with channels up to 44 feet long radiating away.

Nearby are a series of square holes about a foot wide and two feet deep.

Brown himself advanced rather straightforward hypothesis. "There appears to have been two big explosions and a lot of little ones."

A spokesman for the Scotland command said the army had taken a look without determining a possible cause. For the moment he mulled over the problem of the craters and commented: "There're popping up all over the place now. These men from Mars-if that's who caused them-are becoming a nuisance."

While all this is taking place in Scotland back in England Roy Blanchard had some of his barley and potatoes disappear and apparently the object what ever it may have been scorched one of his cows.

The cow began shedding its skin about the time Blanchard discovered the mysterious crater.

The army stated shortly after the landing that its instruments showed that something giving off a metallic reading was indeed in the crater. But an army spokesman at the same time emphasized no positive finding had been made. He said the readings indicating metal beneath the crater "could come from anything-an old bomb, a shell, or anything at all."

Others had speculated the crater might have been formed by a shower of meteorites. The London Daily Sketch reported that one army expert indicated he thought the hole might have been made by a World War II bomb exploding after deteriorating for 20 years.

The day before this statement was made a Dr. Robert Randall, a leading Australian astro-physicist linked the crater with other mysterious marks found in nearby fields and said they were caused by the forced landing of a saucer he estimated to be 500 feet across, weighting 600 tons and carrying a crew of 50 or so.

Randall, who visited the site, said the markings on the ground were caused when the saucer "bounced" while making a force landing. He said he believed the saucer's solar batteries failed and that its crew had to repair it.

He thought the incident was possibly linked with other purported evidence of landings in Australia and France over the past nine years. "We think these aircraft are coming from somewhere in the region of Uranus", he said.

Waveney Girvan editor of the FLYING SAUCER REVIEW was interviewed by the press and his statement is as follows. "It must have come from outside the earth-from space."

The public got so excited over the entire incident that Labor Party MP Roy Mason submitted a question to the government asking "to assess the possibility of its having been made by an unidentified flying object."

However for most the excitement was short lived for on July 25th an object was pulled out of the crater. The object was nothing more dramatic than a half round lump of matter which appeared to be a meteorite. However it was sent to the British Museum for investigation. The official statement at the time goes something like this, "We are sorry that a hole which showed so much promise should have failed to live up to its notoriety."

However two days later most papers carried a small item stating that the object about the size of a tennis ball which was at first believed to be a meteorite on investigation proved to be a piece of pyrite an iron sulphur compound which had been in the earth for some time.

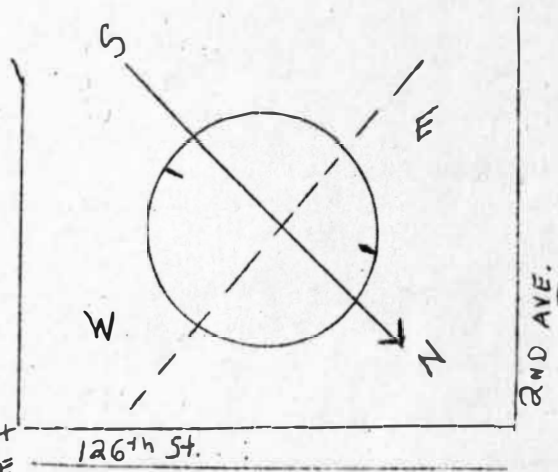
The War Office satisfied that the crater was not caused by a deteriorated World War II bomb stated that their investigation was completed and that they didn't wish to speculate about the crater having been caused by a flying saucer.

This incident backed up by similar ones in the past show that indeed we are being visited by strange crafts which we do not know much about. Perhaps we are being visited by more than one source and for different reasons. Your editor has his own opinions but opinions without concrete proof never solved anything. UFOLOGY NEWS SHORTS & SAUCER BRIEFS =

BECAUSE of the space devoted to constructive articles in this issue we shall have to present a capsule summary of some of the better saucer sightings of recent date along with some of the local color....THE August 5th edition of NEWSWEEK carried an article centered around the book authored by Donald Menzel and Mrs. Lyle G. Boyd entitled "THE WORLD OF FLYING SAUCERS", which we expect to review in a forthcoming issue....MICHAEL Freedman reports that Chester Penna. officials deny claims that bright orange spots which suddenly appeared on some 75 homes and a dozen or so cars are left over from the annual celebration of Orangeman's Day. The spots showed up on July 14th after a heavy rain. They have officials scratching their heads and homeowner's tempers rising. Officials state that the stuff whatever it may be won't come off. It's imbedded, and deep....FRM Armand Laprade of Worcester, Mass. comes word that a Holden, Massachusetts woman looked out her window on the morning of July 6th and was startled to find that it had rained needles during the night. The lawn of Mrs. Robert C. Malm was covered with hundreds of needle-like pieces of aluminum, some of which this editor has in his office at this time. A check with NASA authorities revealed that the aluminum had not fallen from a satellite or rocket in space. Mrs. Malm who later corresponded with Mr. Laprade reports and we quote from her letter "...the material was found only on my lawn and was in sort of a ball. Not scattered. When picked up and dropped they went back into the same shape as though magnetized....On June 7th an 8lb. metal object crashed with an explosion like force on the porch steps of Mr. and Mrs. James C. McDonald of West Quincy, Massachusetts....Other reports from the Massachusetts area according to George D. Fawcett include a photograph of a UFO taken on June 22 in the backyard of Richard Pothier, reporter for the Quincy Ledger, in Wollaston. On July 22 New Englanders watched a "V" formation of five yellowish-white oval-shaped saucers in flight at 3 p.m.

ON Thursday June 20th at approximately 9:18, New Yorkers reported seeing a white, fiery, object or objects plunging earthward in the vicinity of the Battery. Illustrated to the right is reconstruction of scene by eyewitness George Emerson Fox, of 328 East 126th Street, at 1st Avenue, Manhattan, N.Y.C. Mr. Fox caught a glimpse of the flaming fragments or object just as it disappeared behind the towering Wagner Houses at 123rd & 2nd Avenue. The momentary glimpse revealed what might be a craft burning in three places (one large white flame foremost, followed by two lesser flames). Only the flame was visible. The drawing is an attempt to show the line of sight in relation to a compass needle, (made several days later), from roof of original sighting. A call to the New York Mirror, next day, revealed that the object was still classed as a "UFO".....I.N.S. assistant director, Lucius Parish informs us that Robert Rogers and James Smith both of Plumerville, Arkansas employed as guards on Titan Missile Complex 10 sighted on two consecutive nights (July 29 & July 30) unidentified flying objects over Site No 10. The objects



were observed both nights in straight flight, with no visible maneuvers performed. At one time, two objects crossed each other's flight path, but both remained in straight flight at this time. One object was reported in the northern sky and ascended vertically at the same speed as that flown horizontally by the other objects. The objects had no trails and appeared as merely "lights" with no details of the craft visible. Their speed was very high, and as described by one of the witnesses, "if you blinked your eyes, you missed them." The objects disappeared by vanishing into the distance....HOWEVER nutty this may seem Joseph Knex who has been a pilot for some 15 years reports that while seven miles south of Norfolk at 3,500 feet on July 15th he was chased by a flying saucer which appeared to be shaped like a soup bowl upside down, and barreling right for him. Knowing that this was rather unusual Mr. Knex grabbed his camera and started shooting away still headed straight for the object. We quote from a newspaper account of the incident. "I'll give you one more second, saucer boy," told myself, grim, determined, tight lipped and all that sort of thing. And of all the bald-faced arrogance, he took it, and I did a double-barreled wing-over dive that not only emptied the ashtrays but spilled peanut shells all over the ceiling. I love peanuts. At that instant, the loud speaker boomed to life; 'CHICKEN! CHICKEN!' followed by the most hideous laughter I ever set ear to. When I got straightened up a thousand feet down, he was gone, disappeared, nowhere in sight." The photos taken by Mr. Knex showed only empty air. HEADQUARTERS HIT BY NEW WAVE OF HOAX CALLS

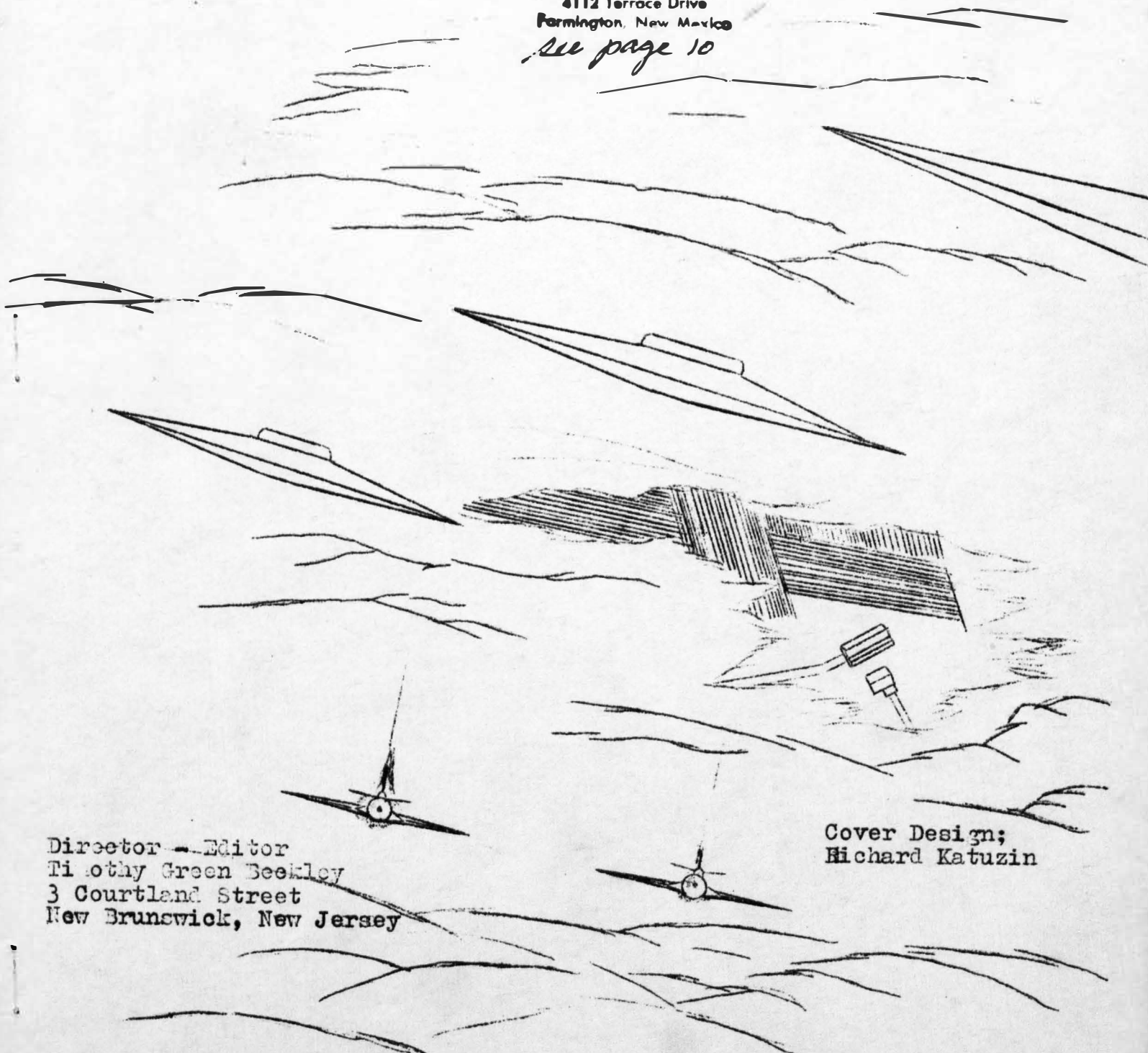

Re the little men reports. Basically, I think that MAN is universal throughout not only the universe, but the COSMOS, which includes many universes. IS THERE AN ANCIENT UFO RECORD BURIED NEAR THE SALTON SEA?

EDITOR'S NOTE: During the past three years the author has completed well over 300 detailed drawings and a series of articles having to do with these UFO reports. The last series of technical drawings-involving maps and geometrical analysis of the maps-seems to indicate the possibility of this buried record. If possible, the author plans to put the last series of 33 drawings into a book with explanatory notes. If such a UFO record exists, it would make clear that the UFO has visited the Planet Earth in the ancient past. The coming of the UFO since 1947 would make clear that they know of the existence of this buried record and had performed their operations over the past 16 or 17 years because of the existence of this record and the fact that it might become recovered at some future date. This record would apparently be related to the Old and New Testaments, the Great Pyramid design, the Dead Sea Scrolls Caves, the Book of Enoch records, the Rosetta Stone, the design of the U.S.A. West Coast and the coming of the UFO.

The Los Angeles Times for November 6, 1957, printed a short article concerning a UFO report near the Salton Sea, California. According to this article, Mr. & Mrs. A. A. Burnard of Escondido Springs, California, were camping in the desert near the west shore of the Salton Sea. At about 5 p.m. the couple saw an unidentified flying object hovering over the desert floor. The UFO reportedly flashed a powerful white light eight times and at a two second interval. The Burnards described the light as flashing in all directions and somewhat similar to a silent explosion. This Salton Sea UFO report took place the day following the phenomenal UFO sightings at Leveland, Texas, on November 3, 1957. According to the Los Angeles Times and the LUBBOCK AVIATION JOURNAL, Lubbock, Texas, there were seven separate UFO reports in the immediate area of Leveland. The first UFO report came at about 10:30 p.m. on the night of November 2 and was four miles west of Leveland. The second UFO was four miles east, the third was eight miles north, the fourth was ten miles north, the fifth UFO was five miles west, the sixth was three miles northwest, and the seventh UFO was five miles northwest of Leveland. The seventh UFO came at about 1:30 a.m. on November 3, 1957. Following the Leveland reports and about 17 hours later, similar UFO's were sighted by two separate military patrols at the White Sands Atomic Test Site of July 16, 1945. The UFO's were described as white objects that descended to the ground. This took place on November 3, 1957. The Salton Sea was formed between 1905-1907, and it is located in the southern part of California. At present the length is about 30 miles and the width is about 12 miles with a depth of 280 feet below sea level. It has a high concentration of salt. Terraces indicate that there was an ancient lake called Lake Cahuilla on the site. This ancient lake was about 120 miles long and 30 miles wide. By examining a map, one can determine that Leveland could be positioned at one end of a straight line and the Salton Sea at the other end. The distance between the two points would be about 761 miles (that is, the distance between the Salton Sea base and the Leveland UFO one).

It is interesting to note that the distance of the base of the Great Pyramid of Gizeh in ancient Egypt is also about 761 feet. In this case, one foot would equal one mile....if one were to conclude that the Levelland and Salton Sea UFO's were measuring off the base length of the Great Pyramid design. The Great Pyramid is located at latitude 30 North, and Levelland is located at latitude 33.35 North. Estimates place the date of construction at around 2600 B.C. The Great Pyramid has five sides and five corners, and the chief corner stone is at the apex. But this chief corner stone is missing.

One would expect that if the UFO had established some type of "signal" or "beacon" at the Salton Sea in November, 1957, that the UFO would repeat this pattern at some later date. Such repeat signals have recently taken place at the Salton Sea.

On April 11, 1963 Mr. & Mrs. Lucille Revels of Anderson, California, were driving on the east shore of the Salton Sea. There were about four or five persons in the party heading south-southeast. According to Mrs. Revels, the travelers saw a brilliant UFO flashing a series of blue-green lights. One member counted the flashes, and they were repeated seven, eight, nine and ten times in succession. The light was described as being over the Salton Sea the first time and later just east of the Salton Sea. Mrs. Revels has also stated that another green flashing UFO was sighted east of the Salton Sea on June 5, 1963. This UFO flashed a green light eight times in succession. It seems apparent that the 1963 UFO's were related to the 1957 UFO pattern. However, the UFO of this year did not perform the patterns over Levelland but over the Salton Sea. Consequently, the primary emphasis involved the Salton Sea and the area around it. As noted earlier, the Salton Sea Levelland line would serve as a type of measuring line on the surface of the land. In my earlier article on the subject of the UFO, I concluded that these 1957 reports were connected with the intelligent and mathematical design of the U.S.A. West Coast. Furthermore, that the UFO were involved with the creation and design of the Planet Earth by an intelligent and scientific Creator.

Certain data seems to indicate that there might be some type of record buried near the Salton Sea. This record could be on metal plates or engraved on stones, or it could be an ancient type of UFO. Such a record might account for the Mount Rainier UFO's of June 24, 1947, the Los Angeles UFO's of February, 1942, the Salt Lake UFO's of July 1952, the Levelland UFO's of November, 1957, the Salton Sea UFO's of November, 1957, the Red Bluff UFO's of 1960 and the Salton Sea UFO's of April, 1963. In order to determine if the data is correct, it would be necessary to undertake a program of archaeological research and digging at the particular site. As of this date, there are two possible sites marked on a map of the area. I would welcome any suggestions on this particular matter and planned project of exploration.

Along with the above information I have sent the Director, Timothy Green Beckley, an illustration of the area. The top drawing shows the significant UFO reports in the western U.S.A. between 1947 and the present. Point A represents Levelland, Texas, where the seven UFO's came on the night of November 2 and 3, 1957. Two UFO reports followed a few hours later at Point J the site of the world's first atomic test of July 16, 1945. Continuing West, we find the Salton Sea at point B. There were two different types of UFO "signals" at the Salton Sea. The first one November 4, 1957 flashed a powerful white light eight times in succession. The second UFO, April 11, 1963 reportedly flashed a brilliant blue light 7-8-9-10 times. The distance from Points A to B is 750 miles. Each unit on the drawing (top) represents 50 miles (or 50 x 15 units: 750 miles). The distance from A to the Salton Sea center is about 755 miles. Therefore, the base line A to B would represent the base of the Great Pyramid design with one foot equal to one miles. In other words, 755 feet equals 755 miles.

Angle B-C-A shows the side view of the Great Pyramid design (looking at it from the ground level). Point C would be the apex point 481 miles north of the base at point D (or 481 feet). The distance from D to C is 481 miles, and A to B is 755 miles. Angle B-C-A is $76^{\circ} 17' 31.4''$, the apex angle of the Great Pyramid. Angle B-A-C is $51^{\circ} 51'$ and angle A-B-C is also $51^{\circ} 51'$. These are the base angle of the Great Pyramid design. At the same time, Point D is the apex point of the PLAN VIEW of the Great Pyramid (looking at it from space). The plan view is shaped like a square. Therefore, using Point D as the center, a circle can be drawn having the radius D to C or of 481 miles (feet). The side view will show the Pi ratio of the diameter and circumference values of a circle. For example, 481 is the height, 755 is the base length-this can be expressed as $481:755 \times 2 :: 1:3.14159$. Apparently the Levelland and Salton Sea UFO's of 1957 and 1963 measured off the basic geometrical pattern of the Pi ratio on the land surface of the U.S.A.

Using line A-B as the base line, we would form the angle B-A-G of $26^{\circ} 18' 10''$. This angle line intersects point G (Red Bluff, California) where the UFO came on November 24, 1896, and again on August 13, 1960. There was another UFO report on June 2, 1963, near here.

This angle of $26^{\circ} 18' 10''$ is found inside the Great Pyramid of Gizeh. It is the slope of the first ascending passage and the grand gallery leading up to the King's chamber. (The same angle is found extending from the Great Pyramid site to Bethlehem along latitude 30° North). Therefore, points G-M-N-A show the four corners of the plan view of the King's Chamber in the Great Pyramid (as seen from space) Point H is San Francisco, California site of the UFO reports of November 24, 1896, and January 18, 1961. A straight line extending from H through G will extend north to Mount Rainier, Washington where the 9 UFO's came on June 24, 1947. The distance from G to H is 162 miles. This can be divided into 9 equal units of 18 miles each. The 8-13-1960 UFO was 18 miles south of Red Bluff (or 18×9 units equals 162 miles). This might explain the 9 Mt. Rainier UFO's in line from north to south.

The Mt. Rainier, Red Bluff, San Francisco line (L-P-A) will form the side angle of $76^{\circ} 17' 31.4''$ of the Great Pyramid design with the Levelland, Salton Sea base line. The UFO came on July 2, 1952, to Salt Lake (Point E) and were photographed in flight on film by an official U.S. Navy photographer. Salt Lake would be 550 miles north of Levelland and 550 miles west of Levelland. Points E-A-B form 45 degrees, and this angle line will extend northwest through the 1952 Salt Lake UFO to the 1947 Mt. Rainier UFO. Point K represents the Los Angeles UFO's of February 25, 1942, and the Long Beach UFO's of September 23, 1951, and November 6, 1957. The bottom drawing shows the approximate sites of the Salton Sea UFO's of November 4, 1957, and April 11, 1963. The Salton Sea is Point B in the top drawing.

There are two integrating scales of measurements used on the large drawing. From point A (Levelland), 50 mile units extend north to the U.S.A. - Canadian border at point 8. From point A, a second scale of 68.1818 miles per unit extends west to the Salton Sea at point B. This explains the 11-3-1957 UFO at Levelland, and the 11-4-1957 and 4-11-1963 UFO at the Salton Sea. The Salton Sea is 11 units west of Levelland, and Levelland is 11 units east of the Salton Sea. Point 11 (Salton Sea) is 4 units east of point 7-a. Notice how 11-4 and 4-11 can be reversed so as to represent the Salton Sea UFO's. At the Salton Sea (B), a vertical line extends north to point Ra. two 45° angles extend northwest and southwest from Ra and intersect the Pacific Coast at points near 5-5 this is where the circle cuts the Pacific Coast and is parallel to it. This circle has the radius Ra-L, and it cuts through points 3 and 3 as well as the Mt. Rainier

--UFO's of 6-24-1947. Therefore, Mt. Rainier serves as a geometrical point of reference for the two angles extending northwest and southwest from points E and Ra. (Point E is Salt Lake City). From point E and point Ra, the 90° angle is divided into 8 and 5 equal units. The line extending from point 8 (upper left) through point 5 also intersects San Francisco at H. In other words, point Ra represents the center of the circle parallel to the Pacific Coast and the site of the Great Pyramid. (If necessary, consult a map of the Nile Delta with the north coast to the north and 112.5 miles from the Great Pyramid.) The quarter circle formed at points Ra-5-5 forms an exploded view of the U.S. West Coast. This exploded view design is about four times larger than the Great Pyramid-Nile Delta Quadrant of the Circle.

The distance from point G (Red Bluff UFO) to the West Coast at point X is 112.5 miles. The distance from the Great Pyramid to the Nile Delta north coast is also 112.5 miles. 112.5 x four equals 450 miles. The distance from point Ra to point Ta equals 450 miles. Note that the square 3-3-3-3 centered on Salt Lake (E) cuts point Ra. Point 3 is also 11 units northwest of Levelland. Each unit on the Levelland, Mt. Rainier line equals 95.45 miles, so that Mt. Rainier is six units northwest of Salt Lake and 14 units northwest of Levelland. (Note that the Mt. Rainier UFO's came on 6-24-1947). Since point 3 is also 11 units northwest of Levelland, it could be considered 11-3 (and this is the date of the Levelland UFO's). The square 3-3-3-3 and 8-8-8-8 forms the plan view of the Great Pyramid, with the center at Salt Lake. Point represents the Redmond, Oregon, UFO of 9-24-1959.

In the bottom drawing, the plan view of the Great Pyramid design are formed so as to coordinate with the Salton Sea UFO reports of 11-4-1957 and 4-11-1963. It is important to note that the Salton Sea is rotated 45° to the northwest, in this way, the Great Pyramid plan view (a square with the apex in the center) is superimposed over the Salton Sea. Note that point 5 is the corner secret of the plan view T-V-5-Y. At the same time, point 5 becomes the apex point of the plan view R-S-Va-Z. Is it possible that there is an ancient UFO record buried at one of these geometrical points?

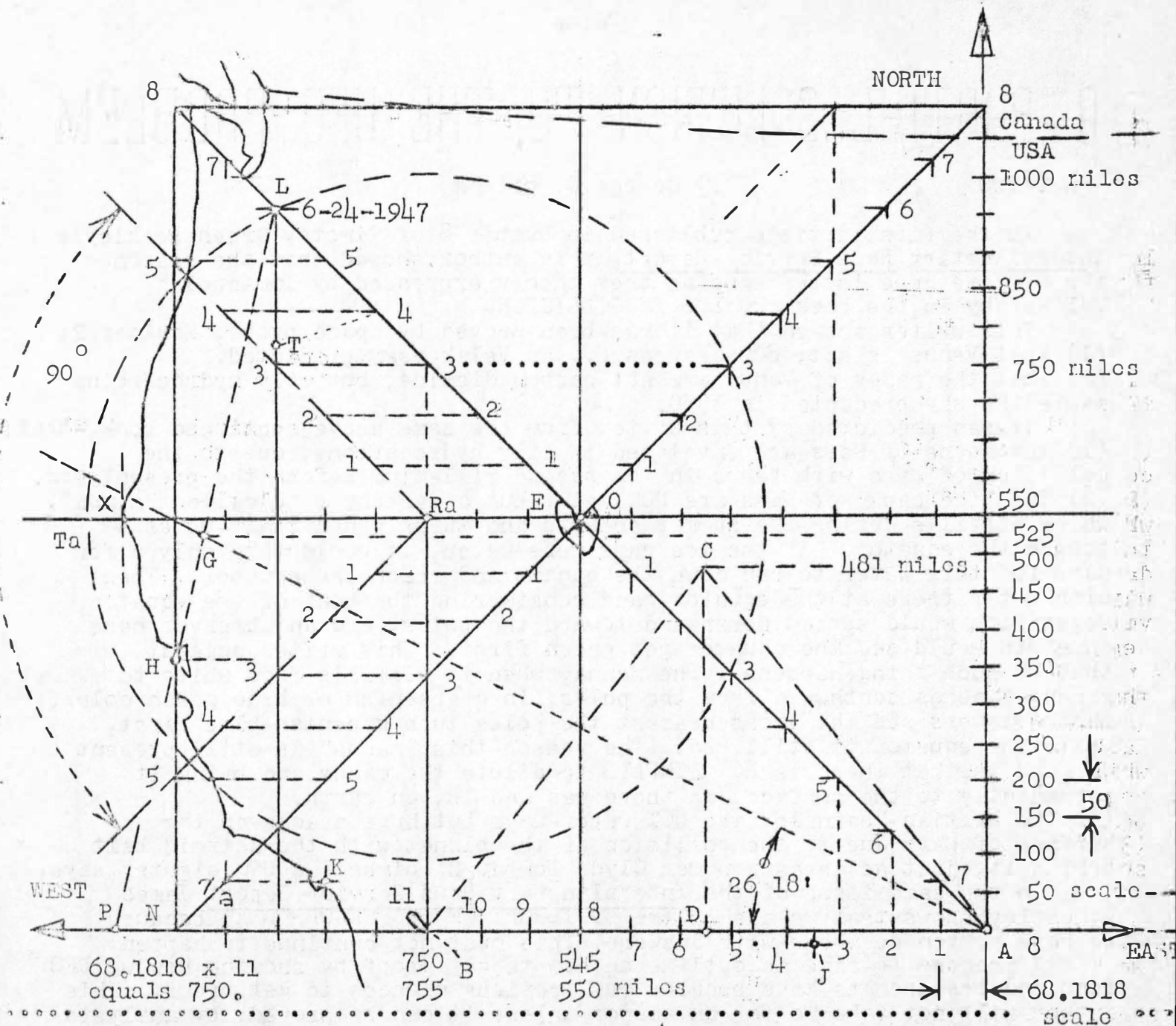

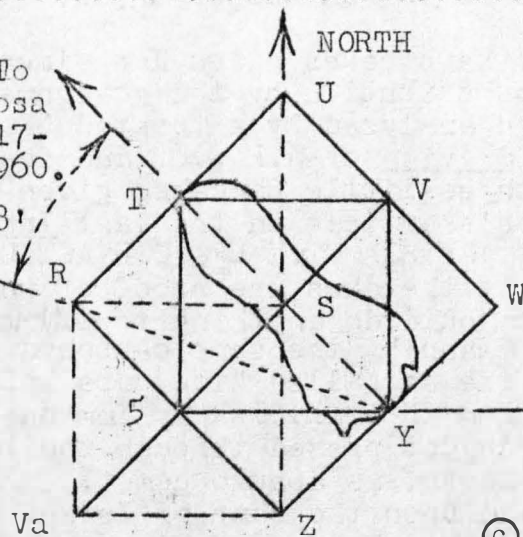

A PARTIAL SOLUTION TO THE UFO PROBLEM

PART TWO

In the first article published in Number 8 of Timothy Green Beckley's Interplanetary News Service Report, this author showed that the reason the UFO are here is the same as the theory expressed by Immanuel Velikovsky in the book, WORLDS IN COLLISION.

This writer showed that it has been proved by space probe, Mariner 2:
 (1) That Venus is hot; 800 degrees F., as Velikovsky predicted.
 (2) That the gases of Venus are not carbon dioxide, but oily hydrocarbons as Velikovsky predicted in 1950.

It was predicted by this writer from the same above mentioned book, that:
 (1) The moons of Mars are enveloped in oily hydrocarbons, due to the collision of Mars with Venus in the second millenium before the present era.
 (2) The "ice caps" of Mars are NOT water but a carbohydrate called "manna", which distills during the summer on Mars and turns green as it moves toward the equator. If the ice caps were water, it would take only a few days for this water to run down the canals and reach the equator. Then with water there at the equator, and considering the heat of the equator, vegetation would spread Northward toward the poles, and an observer here on earth would see the equator get green first. This writer suggest that NO such thing happens. The manna, when it distills from white to green, spreads southward from the poles, in a greenish or blue green color. Earth viewers see the areas nearest the poles turn greenish-blue first, while the equator is still red. The reason this "manna" is still present on Mars is that there is NO RAINFALL to dilute the manna and bring it permanently to the surface, as there was and is, on earth.
 (3) The Martian "cannals" are NOT water-ways but huge cracks on the surface of Mars due to the collision of the planet with the astroid belt behind it, just as astronomer Clyde Tombaugh, himself a UFO sighter, says.

In the same issue of the Interplanetary News Service Report James W. Moseley shows that we are in the "TWILIGHT OF THE SAUCER ERA" because we have gotten nowhere with answers. This must not continue to happen!

I propose to give an outline on how to get proof by showing how we fans and researchers have bungled our previous chances to get proof. author will not take no for an answer unless it can be proved by analysis of the cakes:

(1) It is one of the same cakes given Joe Simonton April 18, 1961, and it has not changed by substitution by the government.
 (2) The cake has been analyzed by a trusted UFO Organization, such as the Interplanetary News Service or A.P.R.C. and found NOT to be what I say it is.

What were the three little pancakes given Joe Simonton, as described in Judge Frank Carter's article in the last Interplanetary News Service Report, BRINGING THE JOE SIMONTON UFO CONTACT UP TO DATE?

My answer is that the cakes are proof of why the UFOs are here: something the government would do anything to withhold from the public.

The cakes were "Manna", the same carbohydrate that this author predicts will be found to be the so called "ice caps" of Mars.

Page 134 of WORLDS IN COLLISION by Immanuel Velikovsky, described this manna. The Earth had just passed through the tail of Venus, as Venus passed close to the Earth, as a huge comet.

When the dew fell upon the camp of Israel in the night, the manna fell with it. It had the shape of coriander seed, the yellowish color of bdellium (it can also be green as will be shown) and an oily taste somewhat like honeycomb.

It should be noted here that Judge Carter says the cakes were extremely oily, according to a letter received by this author from the local newspaper in Eagle River. Manna apparently loses its honey flavor when cooked.

To continue Velikovsky's book, page 134: The manna was called "corn of Heaven" and it was ground between stones and baked (or fired) in pans by the Israelites.

I have before me a newspaper clipping from The Madison Wisconsin State Journal dated April 21, 1961, and it says that one of the three cakes was tasted and it tasted "LIKE CORN MEAL". Simonton's cakes were the "corn of Heaven" this writer says.

I suggest that Keyhoe's group was distressed over the publicity given over the cakes because the Government, one way or another, stepped in and took the cake away from him. They did this once before in the case of Reinhold Schmidt, as will be shown.

We all know that the U.S. Government got one of Joe Simonton's cakes directly, as a news clipping before me, from the SENTINEL, Milwaukee, Wisconsin, dated April 28, 1961, says that Dr. Allen I. Hynak, astronomer, for Northwestern University, took one of Joe Simontons three cakes to deliver it to "The United States Air Force".

For Keyhoe's group to admit this would be the same as for his group to say to the public that Simonton had a genuine contact. Keyhoe would never do this. He is against contactees. All contactees!

This then, is why you get such shoddy treatment, Judge Carter. I assure you Judge, we all believe your account of Joe Simonton, especially when we know what the government is afraid of.

To continue with page 134 of WORLDS IN COLLISION. After the cooling of the night, the carbohydrates of manna precipitated and fell with the morning dew. The grains dissolved in the heat of the day and evaporated; but if the manna were kept in a closed Vessel, the substance could be preserved for a long time.

UFO fans, does this remind you of anything? Now about "angel hair" found so many times after a UFO flies over. Remember how "angel hair" evaporates before your very eyes. I can see the Air Force now, dropping tons of white Nylon to throw us off the track.

I quote here from the book, "THEY KNEW TOO MUCH ABOUT FLYING SAUCERS" written by Gray Barker, page 195.

"On November 3, 1953 Jarrold sent a worried letter to Fulton. Jarrold had come to certain conclusions...He felt sure that he knew the principal facts. Ever since that startling realization had hit him he had been upset, hoping tremendously that the interpretation he made was a lot of nonsense. But as the pieces fell together...he could see that the theory was not absurd. Jarrold didn't know what to do with the knowledge since he considered it highly dangerous. Jarrold said, 'I wish I had never undertaken saucer research'".

On Page 158, Jarrold had made two conclusions:

(1) the saucers came from Mars.

OR

(2) The other theory involves a staggering event which, unfortunately, for very vital reasons, cannot be revealed--or even discussed theoretically by Jarrold, until specific additional data not currently in the possession of the A.F.S.B., has either been established or rejected with positive certainty. All that can be conveyed here is that the particular information emphasises the CAUSE (eg: Velikovsky's Theory) of the saucers rather than their origin.

And page 156 answer five, says, "This and other information the visitor disclosed, revealed the most fantastic situation it seems possible to conceive by normal standards." Jarrold was terrified by Dr. Velikovsky's theory, no doubt about it. This then is the reason the UFO hint, rather than say directly. It is too much for a person to take.

Now, Gray, don't you dare come forward at this late date and try to tell us that I am all wet, and that Jarrold was afraid of spooks: well, we won't buy it! Especially since you sent me a photo of that letter from Jarrold or was it his friend saying that he had a suitcase full of "manna" as "PROOF"... "Of Velikovsky's theory".

Now, UFO fans, what about Reinhold Schmidt?

The KEARNEY INCIDENT by Reinhold Schmidt was published October 1959, FLYING SAUCERS by Ray Palmer. Read it.

On November 5, 1957 (and this writer does not care what Mr. Schmidt has done after this date as it has nothing to do with his sighting) Mr. Schmidt was invited inside a large cigar shaped ship, by four men and two women.

Reinhold says, after the ship took off he and the deputy sheriff of Kearney returned to where the ship had landed on the bed of the Platt River. They could see the imprints of the hydrolic rams where the ship had stood on the river bed. By the prints they found "some oil", dark green in color, fine in texture, and SWEET SMELLING. Mr. Schmidt and the deputy gathered the oil in a mustard glass and turned the oil over to the Air Force, which arrived the night of November 5.

At a lecture following November 5th, the time of the sighting, this writer rushed to see Reinhold and inquired if "THE SWEET SMELLING OIL", smelt like HONEY. "YES," was Mr. Schmidts answer. This writer then asked if he had ever heard of Immanuel Velikovsky. "NO" was Reinholds reply. I did not discuss Dr. Velikovsky's theory further with Mr. Schmidt, as I did not want to wind up confined as Mr. Schmidt had been.

At 10 a.m. November 6, 1957, the county attorney, after confering with the Air Force all night, brought in two cans of Veedol Motor Oil, and said an empty can was found where the ship had stood. Some person had during the night poured Veedol over the laundry in the trunk of Schmidt's car. I suggest it was the Air Force that did this as a cover up. But on November 6th, the Veedol Co. announced over the local Radio that their "OIL DID NOT SMELL". The Company thought they were very funny, but they had hit the nail on the head. No motor oil smells sweet "LIKE HONEY".

Well, we bungled it again, UFO fans. We let the Air Force get its hands on the manna: the proof.

If the UFOs have left this "Manna" at least twice, they will do it again. The carbohydrate seems unknown on earth at this time. Next time a contact occurs, with manna being left, we must get a sample first, long before the Air Force does. Note to any newsman who reads this. You could have gotten a sample. We must have the sample analyzed and then we will have our proof. Now we all know what we are looking for.

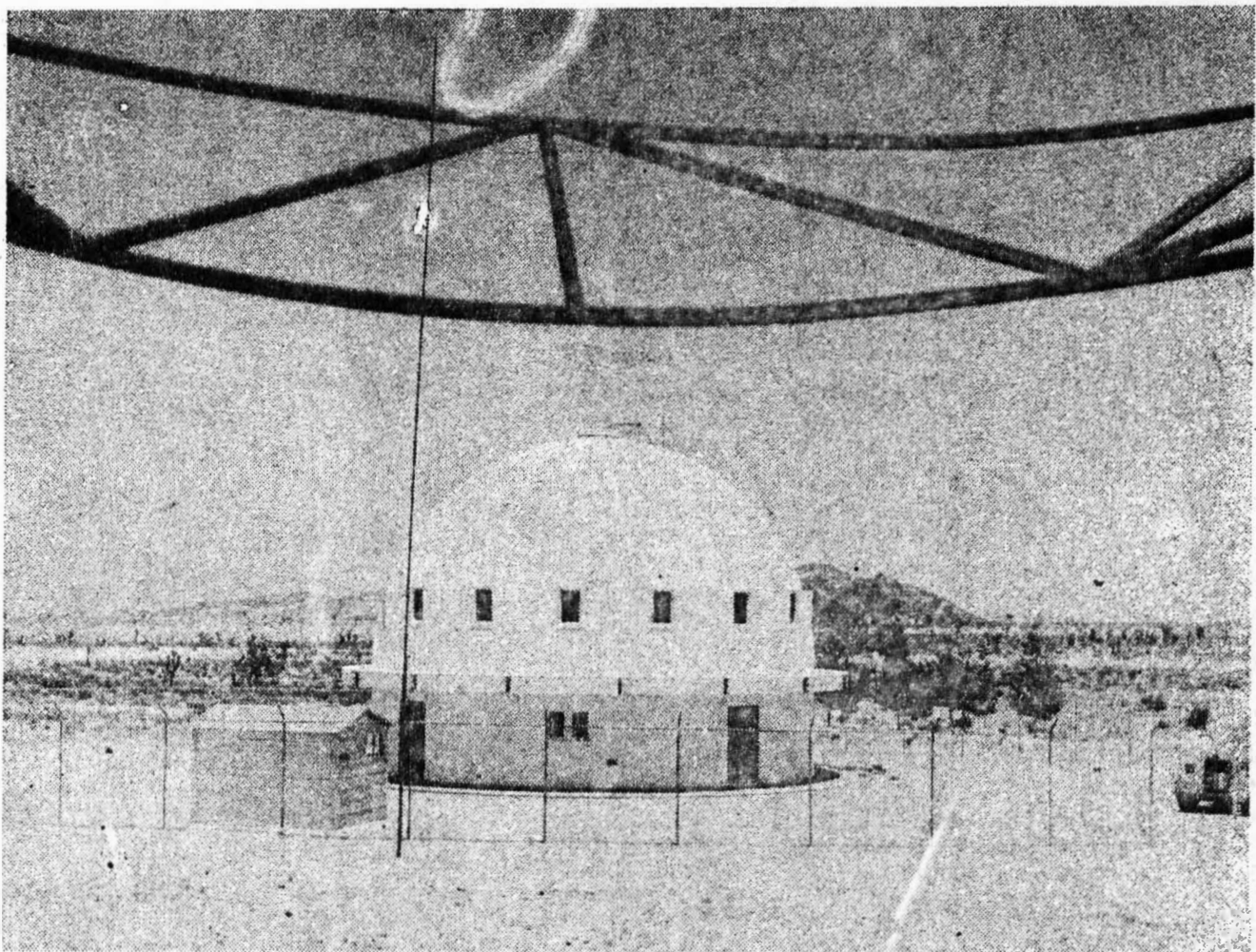

GEORGE VAN TASSEL SEER OF THE NEW AGE

Many of our readers in recent months have asked us to print material regarding some of the contactees while still others wish to know how we feel towards those who claim contact with space people and who claim to have ridden in flying saucers. We report their ideas and efforts with an open mind, and in an objective manner, as we do with all aspects of the saucer enigma. One of these contactees is George Van Tassel owner and operator of The Giant Rock Airport in Yucca Valley California. He is also the editor of PROCEEDINGS a magazine which keeps his followers up to date on the latest developments on the world's first rejuvenating machine which as a side line is also a time machine.

Alto Van Tassel states that the machine will not be completed for at least two years we are informed by private investigators for I.N.S. that work is continueing.

The dom shown in the photo on page 13 is two floors high and when completed will contain the vital coils which will power the machine. It is 48 feet at the base and build according to newspaper reports like a Chinese puzzle without a single nail, screw or metal fixtures which might disturb the electro static field.

The machine itself was suggested by Van Tassel's visitor's. It was back in 1953 when a saucer landed on the desert and the occupants invited George aboard for a short visit. While on the craft one of the visitor's asked George if he would like to do something for his people. Van Tassel replied that he would and thusly the craft's occupant handed him an equation and informed him how he was to go about winding a unique electrical coil which would be the power source for the rejuvenating machine.

Van Tassel has experimented on mice and reports that they live from 72 to 223 days more than normal. Van Tassel hopes to allow 10,000 persons a day through the rejuvenating machine. Altho one will feel years younger his looks will not change.

AFSCA was formed in January 1959, at the suggestion of our Space Brothers, in an effort to bring greater unity and effectiveness to the flying saucer movement. Since that time many club leaders have gradually begun to realize the imperative need for greater affiliation and active cooperation among all saucer clubs both in this country and throughout the world, if our cause is to be successful and our goals achieved.

It is true that we have received a great deal of opposition to this concept of unity and our efforts to help achieve it. Some of it has come from leaders who openly advocate a continued dis-unity. Nevertheless, we feel that some progress has been made over the years, and now more and more group leaders are expressing their concern for this great need of unification. It is because of this that I now direct to them a new proposal for the advancement of our movement.

But before we can expect to have agreement, we must have something specific to agree upon. What are the goals of our movement and how can we work more effectively together to achieve them? I believe that nearly everyone in our movement will agree that more light should be shed on the flying saucer subject; that the results of our accumulated information and research should be disseminated to the general public throughout the world; that official governments should not allow anyone concerned to adulterate the facts and keep the people of the world ignorant of the vital truth about this subject, which may mean the difference between survival and total annihilation of our civilization. On these things there is a great foundation of mutual agreement of which to build greater understanding, cooperation and unity in the more advanced aspects of our subject.

Merely proving to the general public that flying saucers exist is not enough, however, nor is the gaining of new advanced knowledge from extra-terrestrial sources enough in itself. In order to be of real value, such knowledge must be applied for the benefit of all mankind. So our goal cannot be limited to mere possession of advanced knowledge or proof of the existence of unknown crafts in our skies. Our goals must also include the application of that knowledge towards building a better world and towards increasing the degree of freedom, peace, security, abundance, health and happiness for everyone of the planet Earth.

Our task might be considered three-fold. 1. Openminded research (seek and ye shall find) 2. Education (Dissemination of findings). 3. Application of new knowledge to benefit everyone. (Obviously, the latter two goals are much broader than that of being occupied only with the elementary phases of flying saucer research, that is, being primarily concerned with whether or not flying saucers are actually real. However, most of those who have had continuing contacts with our space friends will have world betterment as their end goal. This is also the main purpose of the visitors in our skies in this critical period of the Earth's evolution.

How can these goals be better achieved? As a first step, we recommend that all groups become "co-affiliated" with all other cooperating groups. There would be no costs to any group for this action. Co-affiliation of groups would not include membership in any group or membership privileges, unless voluntarily granted by individual groups. Co-affiliation would not charge any club's independent status nor affect its present administration. It would help to publicize all cooperating groups and their activities. This would enable members of a group in one area to refer their friends or relatives in another area to the appropriate local group.

AFSCA will print under the heading of "Co-affiliated Flying Saucer Clubs", a list in our publication "UFO International" of all those clubs which send us notice of their agreement to cooperate in this plan. We urge other saucer publications to announce that they will do the same. Publication of up-to-the-minute lists of cooperating flying saucer groups throughout the world would help to promote better exchange of information and saucer publications between groups. It would encourage correspondence between group leaders and build up individual club meeting attendance, memberships and finances by letting others know of their existence, time of meetings, price of publications, etc. Such cooperation would also facilitate national and international lecture tours by flying saucer movement speakers. This may seem like a small first step, but who knows what more significant actions might develop ultimately when the spirit of unity and willingness to cooperate is formally acknowledged in this manner?

We realize that there will still be some leaders who, even now, will continue to oppose this effort toward greater unity, as they did in the beginning. But the selfish egotism and limited vision of the few cannot forever thwart the progress of the many. Each club leader naturally wants to have his "place in the sun" and to feel that he is contributing to the success of the cause. But each one's place will be much more important when we all work together rather than separately, cooperating on our existing areas of agreement while developing new ones. This can come about through growing understanding which results from greater communication between groups.

Labor unions still have their areas of disagreement, but they have learned the wisdom of cooperation and the effectiveness of joining their members to gain the consideration and respect which they seek for various causes. The flying saucer movement can do the same. How about it, club leaders? Let's have your reaction to these suggestions. Which do you prefer --- success for our goals or a continuation of our relative ineffectiveness? Your action, or failure to act will be your answer.

AFSCA now has 55 affiliated saucer clubs. But all club directors, including directors of present AFSCA Affiliates, are urged to send in their Co-affiliation application to indicate their willingness to cooperate in becoming co-affiliated with all saucer groups. Only those groups which file a new Co-affiliation Application Form will be included on the new list of "Co-affiliated Flying Saucer Clubs."

We hope that you will choose the path of cooperative action, and that you will fill out and send in the co-affiliation application form below to AFSCA today.

AND THEN THERE WERE NONE: AND NOW THE DEVIL

"Wagner's peculiar way of saying we are protected from without, and our escape is prevented from within seems to be his way of expressing his conviction that we are indeed 'captive', if not by design, at least by circumstance. Perhaps he does believe it is design, for today, scientists are taking more cognizance of the place of religion in reality, and posulating that all is not pure chance or cosmic accident. We might point out to him one quotation from the bible which seem to justify his scientific opinion: '(God) has given the earth to the children of men...but the heaven, even the heavens, are the eternal.'...if this is true, then we will not only see nothing in space, but we will not go there." FLYING SAUCERS Jan.1962.

I know a few UFOlogists who are trying hard to muscle us, clergymen, out of this field of research saying that it's none of our business because religion, so they say, has nothing to do with this. But, of course, as you write, religion could be the very foundation of this and maybe we should study the Bible more carefully to see what it has to say on the UFOs. For one thing, you are one hundred percent right when you write that "a well-rounded group should have persons from every field of human occupation."

But the gem in your letter, which pleases immensely the heart of a Catholic priest, is: "...make the mistake of not letting the Bible interpret itself." How true: Directly or indirectly the Bible should interpret itself. Indeed, would we know the meaning of the Old Testament in general, if we didn't have the New Testament to explain it to us? It's very reasonable to argue that way, for, God, according to the real scripture scholars, is the real author of the Holy Bible, although he did use instruments, i.e., men like Moses and others, who got their ideas from God Himself, couched them in their own words according to their own individual styles. In other words, God, Himself, worked on-say-Moses's will and persuaded him to write; then He enlightened his mind with ideas and guided him all the way so he would write what He (God) wanted, and nothing else, without error or untruth, regardless of the nature of the idea.

Now since God, Himself, is the author of the Holy Scriptures, who can interpret it for us better than God, Himself. Of course, God revealed and did many things which are not in the Bible.

So, as you say yourself, implicitly, but truly just the same: One passage of the Bible interprets, confirms, and explains another, so that, although there are many and various human instruments who "wrote" it, it stands out as one solid masterpiece.

However, that, by no means, is saying that every statement in the Holy Book is clear to everyone. Certain passages are not clear to certain individuals because their passions are blinding them. For instance, the average Jewish leader, at the time of Christ, unquestionably disregarded God's interpretation of His own Word in the Bible regarding the Messiah, and so, he didn't see this Messiah in Jesus of Nazareth, who, among other indications of His Messiahship, fulfilled the prophecies said of the Saviour. And so, it is even to this day, many refuse to accept Christ because they want to give their own private interpretation of His Words.

But, of course, some passages, though nobody's fault, are not clear yet, even to the scholars, who are honestly looking for the true meaning.

With regard to the UFOs, I'm inclined to think that at least a few passages indirectly, and in the language used by ancients, refer to them. The most famous of all, obviously, is the one telling how Elias was taken up alive in a chariot, a fiery chariot. But why didn't God come out clearly, if he did at all, on the subject of space-ships and life on other worlds? Who are we to tell Him what to do and say? We must never let it escape our minds that the Holy Bible is first and foremost a religious book, dictated to man by God, Himself, for the purpose of helping us in our eternal salvation, as the Book, itself, states it all over; it tells us, therefore, the things we have to believe and do in order to be saved. It follows from that principle that, although there are no errors nor untruths in there, scientific, historical, or what-so-ever else, because God can't err or lie, the Holy Bible is not meant to satisfy our scientific-historical curiosity. Moreover, if God told us everything, how would man on earth keep himself busy, and where would be the undescribable kick that we get from finding out things for ourselves? For instance, who gets the greatest kicks out of our space shots? The common citizen watching it on his TV set? Indeed, not! It's the scientists and engineers who have been planning those things years back and now are seeing their efforts rewarded.

As for the prophecies, since they generally contain various ingredients of disaster which would befall IF we don't behave right, we can rarely be sure BEFOREHAND as to the exact time and exact nature of the catastrophe, since they are, generally, CONDITIONAL, depending on our conduct. However, once the prediction has been fulfilled, v.g., the flood, the destruction of Sodom and Gomorrah, Jerusalem, then man knows and sees, unless he is spiritually blind (and some are) how prophecy and occurrence fit together perfectly. Then he glorifies God for His Omniscience. How many times, for instance, have you heard or read the prediction of the end of the world or some other such cataclysm? By "prophets" who claim they are simply basing their knowledge on Biblical prophecies. There is only one sure thing about these "prophets": They were always wrong as historical FACTS demonstrate. Private interpretation of the Bible led them astray.

And now the Devil. You are absolutely right when you assume that he really exists and that God allows him to fool, harass, and especially, tempt us. However, I must frankly admit that after studying at least 50 books and hundreds of articles on UFOlogy, I have failed to find evidence, even an indication, that he has a hand in it. We must look for natural explanations first for these phenomena. On that subject, you should read: OCCULT PHENOMENA, by Wiessinger, Dr. and Priest, published 1957 and translated in English from the German, I believe. Your type of personality will enjoy this book, I am sure; as far as I know, he is a parapsychologist too. You will find in there and in other books, that the devils are out to do us SPIRITUAL harm, and that the physical evil he brings about is only incidental, in-as-much-as, he is, or rather, they are eternally mad at God, therefore, are jealous of us, not because we have beautiful TV sets, but because as long as there is life in us we can get to Heaven if we want to. And so, he tries to lead us into sin. Consequently, if I find no immorality, no sin, neither directly or indirectly connected with a UFO sighting, I can't say the devil is in it. He can stay in sheep's skin just for so long. His lions roar and teeth are bound to show sooner or later. God allows him certain powers but at the same time, He gives us His graces, whereby, we can always detect the work of the evil one, if we want to.

We thank you for your letter...Your interest and desire for truthful answers is inspiring to us.

You asked us to point out the errors in Mr. Cyr's letter. First, let me make it plain that we do not argue about the Bible. However, for one truthfully seeking the truth, we are glad to explain what God says.

In regard to Mr. Cyr's idea that the fiery chariot which took Elias was a UFO, there is certainly no Bible proof or even indication that the fiery chariot was a UFO. Everyone knows what a chariot is. A chariot is not a UFO.

It is certainly very true that God has not told us everything. However, this does not annul what He has told us.

Next, Mr. Cyr said that Bible prophecies are conditional. In a sense, this is true. In other words, if people will repent, then the destruction will not come upon them. Mr. Armstrong constantly says this on the broadcast. The whole theme of the broadcast is to repent.

But, on the other hand, it is not true that one must live after the prophecy has been fulfilled in order to know that God's word is true. The whole point is, it is SURE that the prophecy will happen exactly as stated if the people do not repent. Look around you today. Are the people repenting? The very fact that they are not is valid reason for our knowing that what God has said will happen to them. But, for us as individuals, we can know that we will be protected.

It is certainly true that there have been "prophets" who have claimed to prophesy using the Bible as an authority. And, as Mr. Cyr pointed out, they have always been wrong. But, is the Beast Power rising in Europe today? Is the United States going down? Is the world finding peace? In other words, are the things which you are reading in the PLAIN TRUTH coming to pass? Is it FACT or FICTION? The PROOF is before you.

Mr. Cyr mentions that he finds: "No immorality, no sin, neither directly nor indirectly connected with a UFO sighting..." That is a true statement. When one does not know the plan of God, no apparent reason can be seen for the existence of a UFO.

Now, I realize, Mr. Erdmann, that you asked for a complete detailed refutation of Mr. Cyr's remarks. However, as I hope you are beginning to realize, God's truth is so different from the error of the world, that it requires a vast amount of study and submission to God in order to obtain the proper meaning of God's revelation. For this reason, I encourage you to continue listening to the WORLD TOMORROW broadcast and reading The PLAIN TRUTH magazine. These, in connection with private Bible study, will help you to understand the truthful meaning of God's word. Continue to check up on everything that we say. We highly encourage you to do this. It is only when you personally prove these things that you can be assured it is true. It is NOT a matter of defending the views of some man. You should be taking these things and proving it to be GOD'S WILL.

I am in agreement with Rev. Cyr, and with Mr. Erdmann, that we must let the Bible interpret itself. I am also in agreement that the Bible is primarily given to reveal to us the basic spiritual laws, whereby, we must live if we wish to gain eternal life. And that it is not primarily written to satisfy all our scientific-historical curiosity. Therefore, we must, through our own research learn many things about the physical universe, which are not specifically revealed in the Bible. It is even conceivable that there might be life on other worlds, and God wouldn't have deemed it necessary to tell us about it. However, since the Bible does reveal in

advance the major events to occur, up through the second coming of Jesus Christ and beyond, with no mention of mankind making contact with, or being invaded by, beings from outer space (excepting the return of Christ and His Angels), it hardly seems logical to think that an event of such world shaking importance could occur. The Bible does plainly reveal that Satan and his angels, after warring against God, were cast into the earth, and are here to this day. They are capable of appearing and disappearing (as in Spiritist Seances), and of manipulating physical objects (as in certain poltergeist reports), and certainly they are capable of causing the UFO phenomena. These phenomena have been observed and recorded by man for thousands of years, yet never has mankind been officially "contacted" by space people. We can see, therefore, at least a logical possibility that Satan could be causing such phenomena.

The main point in Cyr's letter and in a related letter from Thomas Roark (Editor's Note: Mr. Roark at one time was Director of CORAP and published with Alan Katz THE COSMIC RESEARCHER) seems to be the question regarding a specific Bible prophecy about this age. That's easy, just quote Matthew 24: 21-22, regarding the fact that unless the tribulation of "those days" be shortened, "no living creature would be saved", as the Catholic New Testament says, or, as another version says, "no flesh would be saved alive". Now, such a thing as the destruction of all life on earth, by any means except an act of God, has never been possible until the last 5-10 years, with the advent of the H-bomb, etc. So that part of the prophecy, could not refer to long past events, but is yet future.

Another one would be Ezekiel 38-39, which tells of the rise of power "in the last days" of Gog and Magog, and their invasion of Israel. Almost, all Biblical scholars, Catholic or otherwise, recognize that Gog refers to Russia. Russia was never a world power until the last twenty or thirty years, at most. Here are two scriptures which no one can gainsay.

Now, I especially want to point out to Rev. Cyr, that in the case of the modern "contactees", who claim to have been visited by space men, there have been a host of un-Christian and spiritually harmful doctrines (from his religious viewpoint as well as mine), which have arisen from such "contacts". Some have reported their "space-contacts" as teaching the pagan doctrine of reincarnation, totally foreign to the scriptures. Others have prophesied a "new age" when all present earthly religions will be destroyed. Some have reported talking to Jesus Christ, Himself, and the Bible plainly states that at Christ's second coming "every eye shall see him", it is not to be a secret thing in a desert or a lonely mountain top. Space is not sufficient here to go into detail on all these cases, but I would specifically refer to the case of Albert K. Bender, who, in his recent book Flying Saucers and the Three Men, reports being visited by three men in black, who told him, among other things: (1) There is no God and no future life. (2) The story of the resurrection of Jesus Christ is a myth and untrue. (3) All religions on earth are simply the result of human imagination. These "men" claimed to be pilots of flying saucers from a distant solar system. Certainly, if anyone believed such teachings, it could do great spiritual harm.

One may dismiss all "contactee" stories as coming from crackpots and liars. Probably, some do come from such sources. But no one can claim to be scientifically investigating the UFO mystery if he arbitrarily chooses to disregard any phase of the phenomena, or source of information, such as the contactees. That is not a truly scientific attitude, but is biased and one-sided. And where there is so much smoke, there must be some fire. There are a lot of reasons for believing that Bender, especially, really was contacted. Just as there are some fraudulent spiritist mediums and some genuine ones, so it is with saucer contactees. And, in truth, saucer contactees are just a space-age version of spiritist mediums. Since we cannot study the

nature of a UFO itself, we must determine their nature from their "fruit", as revealed in contactee cults. Huey P. Beasley, Hawthorne, California

One of the biggest issues, as revealed by these disclosed comments, here-in, are concerned with the purpose of the Bible and its connection with God, man and the universe. To be altogether frank and not recondite, I say that the following conjecture is a summary of the views of Herbert W. Armstrong and associates (Pasadena, California). I feel that they may help others in coming to a decision.

Rev. Cyr, has several comments that revolve around man's efforts of science and how these hold no intricate concern with the spiritual essence of the Bible. What the paradox may be is that there is more intricate intermingling of the two than we think, as follows: "The scientist, falsely so called, sneers at this Book of Knowledge, and says, 'the Bible is not a textbook of Science'. Of course not. There is MUCH within the realm of the physical sciences that man is equipped-with eyes, hands, mind, instruments, ability to travel, explore, investigate, make tests and to discover for himself. All these things the all-wise Creator left for man to discover and record...Man is able to invent, produce and use telescopes, microscopes, laboratory facilities. He can observe, measure, and reason. But BASIC knowledge, cannot be discovered by any means available to man EXCEPT by direct revelation from God!...Does science know WHY man was put on earth or the REAL PURPOSE of human life? Most certainly it does not! Actually, even the leaders of this world's RELIGIONS do not know, even those who profess to be "Christian!" (THE PLAIN TRUTH, July '62. page 26)

The important thing about the fact that the Bible tells the "purpose" is that in knowing this "purpose", you also know if any intelligent life exists in space. Two booklets, WHO WILL RULE SPACE? and WHY WERE YOU BORN?, are two good foretastes.

Man is a "earth-bound" creature. In a pre-Adamic period, Satan was not content to be the ruler of this planet and wanted to rule in space, also (Isaiah 14:13,14) evidence of such a stupendous battle can be found in the markings on the moon and other heavenly bodies. Satan was defeated and forced to be the ruler of this earth, of evil nature, for thereon (12:9). Since, then and still, the devil has kept to the attempt to get into space. One of the earliest was when he told Adam and Eve that they could be as "God" and be in the heaven. The next, a large tower reaching to heaven (Gen.11:4). Each has ended in tragedy. AN INCREDIBLE SAUCER EXPERIENCE IN C O L O R A D O

During July, 1963, I had occasion to be on the west coast. While I was there I chanced to meet a Jerry James from Pueblo, Colorado. He was a little less than my own age of 23, and he proved to be an interesting conversationalist, especially in regard to the discussion of off beat topics. Soon after I had made his acquaintance I let go with one of my favorite questions, as a means of launching a discussion, interesting if only to myself. I said, "Jerry, have you ever seen a flying saucer?" I expected him to give me a strange and quizzical look and wonder if I shouldn't be in a mental hospital. But, fortunately, he asked me why I had asked, and, when I explained, he gave me a positive reply to my question. Not only was his "yes" startling to me, but even more startling was the long and detailed account of his rather close saucer contact. He told me that it happened back in 1957.

Jerry, his father, mother, and younger sister, if I remember correctly, were driving somewhere for a summer vacation. It was during the night when the family stopped at a service station to refresh themselves. Jerry and his father came back to the new Chevrolet pickup truck, behind which was being towed a house trailer. They got up into the cab to wait for the others. Suddenly something moving around overhead caught their attention. It was round and gradually got smaller towards the top. It had the shape of the classical flying saucer so dramatically portrayed in science fiction movies. The saucer was giving off a bright white light. Jerry was so bewildered at such a sight that he could only stare as the thing came down low over the truck. He said that it seemed to be about the size of an automobile. It hovered for a little while only a few feet from the top of the truck before zooming off into the distance without making any perceptible noise. For a moment Jerry became extremely frightened and talked with his father about what they had just seen. Neither found it easy to believe what their eyes had told them.

The next day found the James camped off the highway, several miles from where the saucer was seen. But, there was a silver looking thing that appeared to be floating in the air near a mountain estimated to be about a mile away. Jerry noticed the object and thought that it might possibly be the same weird craft they had encountered the night before. It travelled from the mountain over to within 60 yards of the James' camp, settling almost to the ground--yet hovering about a foot off the ground. It was just like the skin of an airplane, aluminum colored with rivets visible. This time the whole family saw it and Mrs. James was so frightened that she had a nervous breakdown soon afterward, not knowing the nature of the object.

Later on Jerry and Mrs. James went around the back of the trailer only to find it unlocked, and, upon their entering, they discovered that everything inside was in perfect order. The beds had been left unmade when the family began the trip. Now, the beds were made up, although not exactly as Mr. James would have done it, and everything was as neat as it could be. On the kitchen cabinet they found the small dish with the sprouting carrot which had been put there sometime ago. But something had happened to it. The carrot did not resemble a carrot any more. It had

spread out, as if having grown for weeks, in a very wild manner. Roots were outside the dish. In appearance the carrot had grown extremely rapidly. It must have gotten that way in only a day or so, since it was not that way before the James family embarked a few days earlier. On the cabinet near the carrot was some green, vile-smelling substance. When Jerry touched it with a pencil point it ate up the wood of the pencil.

Soon after that Jerry and Mr. James left the trailer and drove to a service station in order to call the police of a nearby town for some kind of investigation. On route there the truck which Mr. James was driving began accelerating against the will of its driver. Only a fractional depressing of the accelerator was now at least adequate for proper speed. But this is not all. Upon arriving at the service station Mr. James removed the gas cap. Out rushed a gaseous material, causing a hissing noise and bringing with it a strong smell like that of sulfur dioxide, or rotten eggs. Jerry met a salesman, among other travelers at the gas station, who had experienced a similar phenomenon with his car.

Later, the James family discovered that the part of the truck seat where the driver would sit rotted out over night and that the ignition keys glowed in the dark and were soft and rubbery, as if having been exposed to intense atomic radiation. Yet, they experienced none of radiation's ill effects, themselves. They were supplied with a new truck by their insurance company. Policemen and an insurance investigator were witnesses to the weird results of this saucer encounter.

After he had finished telling me these strange things I remarked to Jerry that it was so incredible that it was difficult for even me to believe such a tale. But he said that even so, sometimes he has unpleasant dreams about the event and that he will never forget it. He also said that he had no idea what that thing he saw was.

In regards to Ramsey's WATCHING THE WAY-OUTISTS, let me say that I read this with a great deal of interest, but with the kind of interest one has, I'm sorry to say, when reading a gossip column or overhearing some talk about one's neighbors. I think that readers will be interested in this but that some of them, who are more mature than myself, will be repulsed by an underlying vicious quality of the material.

Excusing the discussion of myself in the column (now discontinued-EDITORS NOTE) the material is almost negative in that it attempts to ridicule and disparage more than one prominent person in the UFO field. This hardly seems to be connected with UFO reporting and research; instead it gets into personalities, and in some case the private difficulties, unconnected with saucers, that a publisher is now having.

Let us speak of Ray Palmer. I do not know the facts about the troubles Ray was allegedly in, but I do know that he has consistently put out a wonderful saucer magazine and done valuable research in the field. I have done a lot of business with him, and have had no reason to believe he was not other than a most honorable man and a most sincere UFO investigator and reporter. Palmer has done more to bring UFO's to the attention of the public than you, I, and all the other enthusiasts on the scene put together.

Ray, unfortunately, unlike yourself and Mr. Ramsey, has to make a living out of his publishing. Your airing of an incident which may or may not be true (and if so I'm sure Ray was an innocent victim) not only tends to decrease public confidence in a giant of UFO research, but it also helps to deprive him of his livelihood.

Now regarding Ramsey's discussion of Moseley. Now although I like Jim much better than I used to, I still differ with him greatly on a number of UFO matters, and I certainly will criticize him publicly whenever I still disagree with him. The "feud" between Moseley and myself, consisting of an honest difference of opinions, detracted from circulation rather than helped it. I am certain that Jim has never published SAUCER NEWS with a profit in view.

I also believe I know to whom the columnist is referring to when he describes a lady who is allegedly a witch. This charming woman is now, I unhappily learn, quite ill, and I would have liked to have seen a little note wishing her a speedy recovery, rather than the unusual discussion published about her.

As Mr. Ramsey giggles, quite alone about the "way-outists," he probably does not realize that he would not have an opportunity to write such a column were it not for these "way-out" people, who are interested enough in borderland sciences to subscribe to your publication. Indeed they make up the bulk of people who actively support the publication of your magazine and my own books. Could it be that Ramsey is publicly sneering at something that he personally entertains some belief in (otherwise why would he be in the field), and so effects a kind of worldiness and sophistication?

If your magazine had no capacity to do harm, I certainly wouldn't feel this a worth subject to go into at such great length. But fortunately, your publication is becoming so good that it no doubt is now being read very widely. Why not use it for a positive good, rather than to harm?

As an example, let's look at Ray Palmer again. If he is in the straits of difficulties Ramsey claims he is in, the poor guy is off his feet. Ramsey would give him a kick instead of a helping hand. If Palmer is in such bad shape he very likely needs orders very badly for his books. If the article caused the public to lose confidence in this man who has done so much for the field to the extent that ten people did not send orders they would ordinarily send, your publication has done a great deal of harm. If you will look through the issues of FLYING SAUCERS, various science fiction magazines, AMAZING, SEARCH, and various books Palmer has published, I challenge you or anyone to find anything in them even approaching smut.

I note that Ramsey also takes a poke at Gene Duplantier, who also edits a very fine publication. Apparently the only thing he could think of saying about Gene was the reference to occultism, which is a most ridiculous assertion.

Throughout the column, however, Ramsey exhibits a writing style which is witty, entertaining and professional. My admiration for the high quality of writing makes almost regrettable my pointing out what I consider to be other, more serious, deficiencies -- those of personality, tolerance, maturity and human-kindness.

EDITORS NOTE: After thinking the matter over we have come to the conclusion that the opinions expressed above by our own Gray Barker are true and we wish to extend this small amount of space to plead forgiveness to everyone that Lawrence Ramsey struck out against. However in the case of Ray Palmer evil turned into good as his troubles brought about new interest from his readers and enabled him to start publishing "SPACE WORLD". The below letter from the desk of Mr. Ramsey should close the matter for good.

"I am very sorry but I must ask you to kindly let me step down from the position of Associate Editor for your magazine. Recent events have finally brought me to the conclusion that the petty nonsense intimately connected with flying saucer research is not worth one's bother nor interest. I do still believe, however, that the investigation of reports pertaining to alien craft entering our atmosphere does merit further study; but, alas, I shall leave that to others..." THE WORLD OF FLYING SAUCERS
Dr. Menzel - Dr. Boyd. Doubleday

MENZEL'S DEBUNKING BUNK

A PRIEST U.F.O. FAN

Have you been menzelized? Have you been brainwashed by Menzel's halftruths in his second book on ufcs? It's very possible. For, an UNscientific scientist is disgustingly effective in deluding people.

The author and co-author from the very start point out emphatically that they as scientists, researching in the field of ufology, will first of all try to account for the FACTS. Having pompously announced this selfevident truth to us, "amateur investigators", who allegedly misunderstand, misrepresent and criticise the scientists attitude, they ignore this basic principle entirely and proceed in a way which is diametrically opposed to it: In case after case, they leave out pertinent FACTS given by reliable witnesses and distort those they can't leave out in order to make the incidents fit snugly into their own crackpotish theories which were exploded a long time ago. No wonder they beg the indulgence of their colleagues.

For example, in the very first page they adroitely mislead their readers into thinking that Charles Fort is not a reliable reporter, since his challenge to scientists, according to their allegation, is based on 'tales' gathered from books of folklore, old journals and newspapers. However, as a matter of FACT, Fort quotes also and PROFUSELY from many and varied SCIENTIFIC journals, reviews, and abstracts, especially in the fields of physics and ASTRONOMY. Is the Director of the Harvard College Observatory suggesting that astronomical accounts, reports, etc, which he and his learned colleagues write are nothing but 'tales'? Moreover, the journals Fort quotes are generally not 'old'; they are vastly contemporaneous to him.

These inaccuracies and distortions relatively to Fort, although not particularly important per se in our context, do show clearly, however, a field wherein their emotions are grazing at large. And just what is that field? Briefly, the subjectmatter of our research is: Are the ufcs real? Material? Solid? Physical? If so, are they extraterrestrial? The authors of the above mentioned book say they find no evidence and superciliously laugh at us who believe.

First and foremost, a casual examination of this book shows that at least 20 of the most baffling cases have been deliberately left out. This is considering the U.S.A. incidents almost exclusively, covering only about three years. Most of the below mentioned cases were studied very carefully from all angles by selected teams of scientists and other experts. According to Captain Edward Ruppelt, Chief of the Air Force's Project Blue Book, an operation of the Air Technical Intelligence Center, they were marked "unknowns" (ufcs). Here are a few of them: White Sands-McLaughlin; Jacksonville, Florida-1952; (near) Alexandria, Virginia-May 1952; Los Angeles-June 1, 1952; Goose Air Force Base, Newfoundland early 1952; Boston-Lynn-Bedford, July 1, 1952; same date Washington D.C.; Tokyo Bay, Haneda, U.S. Air Force Base, late Aug. 1952; Brookley Air Force Base, Mobile, Alabama-September 1952; Air Force Defense Command radar station, near Yaak, Montana-August 1, 1952; NATO naval maneuvers off coast of Europe-September 20, 1952; West-Midwest to Chicago, for 4 months, November 22, 1896 thousands of witnesses; Rome, September 1954; Dayton, photo May 1954; San Fernando Valley-November 1953 and again February 1, 1954; Florence, Italy -November 8, 1954. The list is endless.

So, we have a clear case of dogmatism: Two scientists report on a controversial subject. They had access "without restriction" to the best

source on the topic, the U.S. Air Force files. Yet they choose to leave out many of the most important cases: the ones that puzzle the Air Force with its teams of selected scientists.

Furthermore, although recognizing the obvious: proof demands knowledge of ALL the facts, they ignore entirely this fundamental principle when hundreds of times giving cases they leave out and/or adulterate the facts. For instance, when one reads their 'explanation' of the origin of angel hair one gets the impression that they don't know the first thing about a scientific report. But, they know better; at least they should. So, why this nonsensical hodgepodge? Consider, for example, their account of the well known Cleron, France case of October 17, 1952.

The authors conveniently omit the fact that out of dozens of eyewitnesses the main one, Yves Prigent, had training in meteorology and is Principal of the High School in Cleron at the time of the fantastic incident. Obviously, these small but important circumstances, both physically and psychologically, make him a far more trustworthy reporter than a sky pundit who dogmatizes from his armchair about an event which took place 3,000 miles away from him.

And here are a few more FACTS which our orthodox scientists cut out of the picture so they won't disturb their dogma. Prigent, who was there and who observed the UFO show through binoculars, stated that the long, narrow cylinder was inclined on its trajectory at an estimated angle of 45 degrees and that it was "very distinctly defined." Our scholars were not there. But they know better anyway: Prigent and the hundred people who saw the object were mistaken. They saw a gossamer parachute. Cranial temperature inversions fooled our savants that time. According to UFC News Report (Yokohama), No. B-11, a nonvolatile residue from a specimen of angel hair which fell in Japan October 4, 1957, was investigated as to its crystalline structure by X-ray diffraction. The angel hair residue, it was found, has an X-ray pattern which is DIFFERENT from that of spider gossamer.

And that is not all by any means, at least six other very important items were removed from the accounts of the eyewitnesses. For instance, not a word about the most important fact that Prigent made his observations through binoculars. With the help of that optical instrument he was able to clearly that the 20 to 30 smaller objects in front of the long cylinder weren't at all puffs of white smoke, as the Menzel-Boyd pair would induce us to believe; but actually they were RED spheres. Who spears red gossamer? Russian spiders? Moreover, each sphere according to Prigent was surrounded by a sort of yellowish ring inclined at a definite angle. How can a man, who calls himself a scientist, expect the blind forces of nature to produce in the sky, not one but 20 to 30 spheres with a yellowish ring around each inclined at a definite angle, all made up of gossamer? A most ridiculous theory, to say the least.

Further omission: The spheres moved (zigzagged) in PAIRS. Again it's evidently absurd to think that the forces of nature without any outside intelligent control can cause gossamer parachutes to behave in that orderly fashion.

According to numerous French newspaper accounts the aerial 'ballet' and angel hair were seen and watched not only by Cleronites but also by the folks in the country side, in the village of Gernce, in the Josbaigt valley, etc. Farmers, peasants and hunters saw this fibrous material and handled it. That type of people as such doesn't know what the crystalline structure of gossamer is, but, they know what cobweb and/or gossamer is, how it behaves when you touch it, pull on it, etc. So, as a 'jury' they certainly could and would explode the 'gossamer parachute' theory. The supporters of this wild theory were aware of this. Hence, they didn't even mention this group of A-1 witnesses. This calculated disregard, over and above what has been said already, covers up also the most embarrassing fact

that the filaments came down in such a great abundance that you would need to blister your imagination in order to make it conceive enough spiders to cover so much terrain in such a short time.

But, an author can't conceal all the facts. Certain ones are so big and so well known even to the neutral observer that you just can't hide them. What does the author do in that case? He distorts or camouflages them. Our two sky-doctor friends did exactly that at least seven times in their so-called 'scientific' report on this one incident, which, by the way the red spiders repeated almost identically ten days later at Gaillac, France. A subtle trick which along with others has caused people at large to look upon us, 'amateur investigators' as stupid idiots, 'visionaries', for believing in the reality of flying saucers or unidentified flying objects.

According to the witnesses, including Prigent, the long, narrow cylinder was clearly defined and a sort of plume of white SMOKE was escaping from its UPPER end. Now, the Menzel-Boyd team says that the object was trailed by a white plume. The word 'plume' alone is very general and most confusing because with the rest of the mutilated report as given by our two theocrists the reader easily gets the impression that this plume is solid matter: gossamer. But the witnesses call it "smoke" and affirm that it was coming out of an object with clearly defined edges. Gossamer parachute? Absurd!

Prigent, who, lest we forget, had technical training in making meteorological observations, explicitly states that the smaller objects when examined with the naked eye, looked like featureless balls, resembling puffs of smoke. However, as soon as he studied them under the binoculars he noticed the many and puzzling details mentioned above. Menzel and Boyd, so as not to damage their pet theory say that these objects resembled puffs of smoke. As a result the reader is forced to accept the dogma that these objects were just natural with no special, consistent shape such as machines have. According to Prigent and the other witnesses the array of small spheres moved two by two along the trajectory to be taken by the long cylinder, each one making short and rapid zigzags. All this, especially viewed in its local and universal context, clearly shows that these objects were airships or probes under some kind of intelligent control.

But, our so-called scientist who, years ago took a positively strong stand against the believers in the existence of flying saucers, making them feel like fools, can't admit today that he was all wrong. So, he has to twist the truth in this event so as to make it look like a series of natural phenomena. Hence, he 'scientifically' summarizes the whole thing by simply saying **that** the puffs of smoke went along, zigzagging swiftly. All the spiders in one ball, I suppose, sneezed together, and that made the ball produce a short, rapid zig. How about the zags? Who cares? When your a scientist, the folks will believe anything you say no matter how nonsensical.

Furthermore, according to those who were there on the spot and saw exactly what happened in that blue sky that afternoon, as each sphere zigged or zagged away from its partner, a whitish streak was produced and left between and behind them. All these numerous white streaks turned out to be solid, filamentous material which floated abundantly to the ground.

Clear testimony like this, especially since it's corroborated plentifully by many similar occurrences all over the globe, pulverizes whatever is left of the Menzel-Boyd theory, if one call it that. So, the reader must be served "managed" facts. Hence, he is told that the smoke-like object left a broad ribbon that drifted to the ground.

A few French newspapers said that "entomologists" explained the event as a migration of ballooning spiders. It all sounds very good except that there were no balloons and no spiders. So, the now famous Aime Michel

hunted high and low for these "entomologists" and he couldn't find who they were. The obvious conclusion is that the writers of these articles lied or that the "entomologists" became so ashamed of their puerile 'explanation' that they did not dare come out of their hiding and stand behind their words. However, according to our pair of pundits, who know better, the French entomologists theory still holds. Where is their knowledge and respect for the SCIENTIFIC method?

Another glaring distortion of facts: They say that none of the material was preserved for examination. A perfect travesty of truth which will misinform and win over the approval of the general reader who doesn't know any better and will not check the FACTS. It's down in the records that a science teacher, M. Poulet, as so many others before and after him, tried to preserve some for analysis; but, the mysterious filaments sublimed and disappeared before his eyes before he had time to apply the various tests he had in mind. As scientists they must have studied at least the basic literature on the subject. Then why do they deliberately conceal from their readers the most important SCIENTIFIC FACTS on this? From at least March 1665 up to this day teams of scientists all over the globe have tried again and again to preserve, to analyze the genuine angel hair (unfolding) i.e. the mysterious, fibrous material seen dozens of times in dozens of places by literally in all thousands of people, including engineers, technicians and scientists. The amazing FACT is that so far their attempts at this analysis have ended in a complete failure, unless the information is under the wraps of top secrets and thus the puzzle is now a muzzle. Finally, why hide the fact that no scientist has yet identified this inscrutable fiber as the web of ballooning spiders. By the way it might be pointed out that the junk which is blown into the air by our industries is not genuine angel hair. So, why do they bring up the analyses of that stuff? To confuse and conquer!

Incidentally, we hope that these two 'scientists' who pretend to give an account of all the facts, will at least try to explain how it is that the thousands of witnesses all over the globe, including scientists, who in all handled millions of yards of this 'gossamer' never reported seeing any of the myriads of spiders who sneezed the stuff? Where did they go? They probably went back to the RED planet for more red pigment. Why not? Captain Mantell chased Venus around didn't he? When it hid in a cloud, he accidentally rammed into it. Or was that a sky mirage caused by one of those vicious temperature inversions? Beware of them! They're around again. Three of them July 10th dug 3 huge holes in a field near Dorset, England, and sucked up all the potatoes and barley around the craters. The British army and scientists who investigated are still puzzled.

THE STRANGE CASE OF ——— DR. M. K. JESSUP

This book should be in the collection of all that have read anything at all about the late Dr. M. K. Jessup.

The book is a collection of material gathered from different sources to further shed light on the mysterious death, believed to be suicide, of this foremost researcher.

This volume brings out among other things Jessup's great interest in the Psychic and one is led to believe that Dr. Jessup believed in later years that the saucers were perhaps of a non material nature.

Also brought out is information surrounding the strange Varo edition of THE CASE FOR THE U.F.C. According to Jessup this book had been reprinted at the government's expense in a rather large mimeographed edition along with strange notations. This mimeographed version we are told had a rather large circulation in certain branches of our government.

To further add mystery to the life of Dr. Jessup we are told that he received some rather odd letters from a Carlos Allende which are reproduced in Barker's book. These letters explained a top secret experiment in which our Navy was involved. The experiment centered around Einsteins Unified Field Theory in which one of our ships completely vanished for a time and the crew went mad, while in what Allende calls a "deep freeze".

The Allende letters are written in a rather strange style both in grammar and language. Apparently Jessup took a great interest in these letters.

Persons who investigated deeper into the Allende letters have apparently drawn a blank according to Mr. Barker. However one person we are told claims to have some knowledge of the alleged Naval experiment and claims that a "strange little man with a small black suitcase" was seen going on board just before the experiment took place.

"The Strange Case of Dr. M. K. Jessup" ends with a transmission through a medium who claims contact with a UFO researcher now on Venus (on another plain of being) and altho Dr. Jessup is not mentioned we are led to believe that this researcher is none other than our Dr. M. K. Jessup.

An interesting side line in the book is a letter published in the introduction by Richard Ogden from Seattle Washington. The letter goes something like this...."Now as for Jessup his suicide was a frame up. Jessup fell victim to hypnotism. He was sent a tape recording that contained self destruction suggestions. The type employed hypnotic suggestions superimposed on music and mixed with white sound. No one can resist being hypnotized by sound waves. This is disguised hypnosis and it is foolproof. The white sound produces subliminal conditioning, a conditioning of the subconscious, a stimulus which affects the brain below the threshold of conscious awareness. There are certain sound wave lengths which are not audible to the conscious hearing but are heard by the subconscious.

"The equipment is officially known as Auralgesiac, audio analgesia, and connects to any high quality music system: type recorder, phonograph. The white sound is used by physicians, dentists, and psychotherapists; it eliminates all pain and even major operations can be performed in hospitals with it and there is no pain. It eliminates the use of drugs."

Strangely enough even before reading this statement in "The Strange Case of Dr. M. K. Jessup" this editor had come across the same example only from another person. Perhaps there is something to what Mr. Ogden claims.

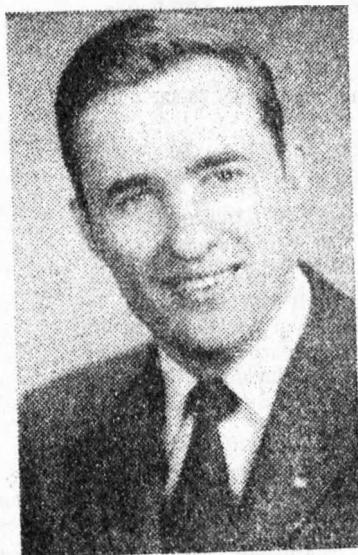
"DETERMINING THE SKY VAMPIRIES, AND WATCHER WISPS!"

Over 50 Air Force Reserve Officers and their guests last week were told of the dangers and handicaps of the present military and government censorship and secrecy orders and policies directed towards "Unidentified Flying Objects", commonly called 'flying saucers' at the Hanscom Field Officers Club at Bedford, Massachusetts. Stories of hostile acts by UFOs were related.

Speaker of the evening was Mr. George D. Fawcett of 9A Warren Avenue, Woburn, a top civilian UFO researcher for the past 16 years and the present Director of Public Relations of the Massachusetts and Rhode Island Two-State UFO Study Group for Adults, which he Founded in 1959.

Fawcett, who was introduced at the supper meeting by Major Otto Essigmann, USAFR, pointed out the incidents where UFOs were fired upon by jet pilots over New Jersey in 1949, over Ohio in 1952 and over Illinois in 1955. Similar incidents were reported by civilians in California, Brazil, Virginia and many other localities worldwide since 1947.

The lecture was highlighted by the showing of over 120 35mm slides of UFO photographs since 1947. The researcher mentioned the loss of a F-89 jet with its pilots on a UFO chase over Kinross AFB in 1953; an American Airliner-UFO chase by AF order over Albany, New York in 1956; an Air Force Transport Captain's report of his plane being 'shot at' by a UFO over the Pacific in 1958. Civilians told of electric shock and burns due to close UFO encounters.

Fawcett then told of Air Force Navy, Air Force Policy 146-B, CIRVIS sightings, an Alamogordo, N.M. order, some of which carry court martials, fines and prison terms for reporting UFO sightings to the public. "Open hearings in Congress" on the UFO problem in 1963 would do much towards eliminating the possibility of an Accidental World War III being caused by mistaking UFOs for planes and missiles of an enemy (several times the Air Force has confirmed SAC bombers have headed towards Russia because of such incidents and called back just in time); false claims of 'flying saucer' secret weapons by an enemy in time of crisis and near collisions with military and civilian planes by UFOs that have confused Air Defense Command radar trackers and pilots. Recognition should be given to the existence of these unknown flying objects as it would encourage the reporting of much vital information needed to solve the riddle of 'flying saucers', as only about 1 per cent of all sightings are ever reported to the Air Force at this time.

The UFO researcher closed his talk by mentioning UFO sightings photographs of an object taken over Burlington and an increase in background radiation and a hovering UFO above Woburn, all in 1962.

'Flying Objects' Seen In Wyoming

BUFFALO, Wyo. (AP) — Two unidentified flying objects have been sighted around Buffalo in north-central Wyoming.

A Buffalo radio announcer, Al Bailey, was called by police officers last night to report the first of the flying objects. Bailey watched it through field glasses before it disappeared one hour later.

The object was stationary the entire time. Just before it vanished, Bailey said a second object was seen further to the east.

They're described as large, spherically shaped and with two lights — one red and one blue or green — positioned at both ends. Bailey said the lights appeared to rotate slowly around the object.

A similar unidentified flying object was observed by police in the Cody, Wyo., area for about six hours last Sunday night.

Gillette Residents See Strange Lights

GILLETTE, Wyo. (AP) — Gillette area residents have reported strange lights in the southeastern and western sections of the sky Sunday night. But a spokesman for the Federal Aviation Agency says they are believed to be reflections of aurora borealis — a band of light that circles the earth.

The red and green lights reported by Gillette area residents are similar to the sightings observed in Cody and Buffalo, Wyo., the past week. A Gillette resident said the objects appeared to have tails with red and green rotating lights on them.

Anyway, It Wasn't Hay

Dartford, England, Aug. 29 (AP)—Straw fell for an hour over this part of Kent today, baffling one and all.

Residents soon were busy with brooms and pitchforks removing it from streets and lawns. Then the phenomenon stopped as suddenly as it had begun.

"We are baffled," said the police. "There was far too much of it for it to have been dropped from an airplane."

Valley Youth Warned to 'Stop Talking' of Pre-Dawn Vision

A young Valley man who appeared before CBS-TV cameras this week to tell a strange story of a pre-dawn meeting with three mysterious visitors presumed to be from another planet, has received orders to "keep his mouth shut" about his experience, he said today.

Tod Kittredge of 14302 Hatteras St., Van Nuys, said that shortly after his appearance on the late news cast Monday night, he received a call from a man refusing to divulge his name.

Kittredge was warned to "stop worrying and stop talking" about the occurrence which has set the entire city agog and become a conversation piece in every home in the Valley.

"I could hear machines clicking in the background," Kittredge said, and the voice said "We know all about what's going on. You just keep your mouth shut and forget about it."

Kittredge, who previously refused to divulge his name for fear of ridicule, said that regardless of how impossible his story of the giant gold ball and its cargo of giant men sounded, it was nevertheless true.

"I have been encouraged by the many telephone calls I have received since I got the nerve to appear on television and tell my story," the youth said.

"Some of the calls have been complimentary, others have been derisive."

Kittredge described his visitors as "friendly." They were quite tall, had long flowing locks and spoke English as if they had memorized thousands of conver-

sations and were repeating the words on tape, he explained.

Kittredge said his step-brother, with whom he shares his home, slept through the "entire thing." Kittredge himself was awakened by the barking of his dogs and upon investigation said he saw a huge steel ball in front of his yard.

"Three men approached me without hesitation and told me not to be frightened," he said.

"I was really scared. In fact the whole thing seemed like a dream. Only I know it wasn't. Several other people in the Valley have seen the same thing, even talked with the men. I just hope I never see it again, that's all," Kittredge said.

He said he has received a telephone call from a man who introduced himself as "Major Kehoe," author of a book on flying saucers, and has had hundreds of other phone calls from others wanting to hear his account of the fantastic experience.

Lighted Object '63 Goes Over Falls

NIAGARA FALLS, Ont., Aug. 14.—(AP)—Police kept watch on the Niagara River today after an unidentified object with a light on it went over the Horseshoe Falls. Police said it was possible that the object was a boat with people aboard.

A man working on a cofferdam being built in the river above the falls said he saw the object being carried down the river last night. He shouted for the control gate to be closed but, before it swung shut, the object passed through and dropped over the American end of the falls.

Ghostly Glow Dances Across Sky Third Night

FAIRFIELD, Ill.—Lights are dancing by night in the skies over Wayne county to mystify, puzzle, and even terrorize some of the score or more of persons who have seen them.

Because of the reports from viewers known to be responsible, who tell of seeing the lights, in varied forms, for three nights, the United States air force is sending an expert from Scott Field, Belleville, Ill., to make an investigation.

Dr. J. Allen Hynek, director of Northwestern university's Dearborn observatory is planning to come down to this county seat town, 271 miles south of Chicago, this week-end, if he can.

Not since the days of the "flying saucers" of several years ago, which proved to be myths, has a community been so aroused.

"Reliable People"

But all of those who report seeing the new mystery lights hercabouts are "good, reliable, and sound people," according to Tom Mathews, editor of the Wayne County Press, Fairfield's weekly newspaper. He says:

"We've had reports from these people who saw the lights Sunday night, Monday night and Wednesday night. We know these people. They're seeing something—not seeing things."

"The lights appear in various forms, they say—like a brilliant round ball of fire, with 'horns' sticking out; a big diamond, a kite with a long tail, a jet plane. But there's no noise, so they know it isn't a plane."

Latest to see the mystery lights were Chauncey Uphoff, farmer four miles east of Fairfield on Illinois highway 15, and his guest, Mike Hill, Fairfield cleaning plant operator. Says Uphoff:

"Mike and I were sitting out [Continued on page 4, col. 3]

in the yard Wednesday night—and we hadn't had a drop to drink—when Mike said: 'Did you turn on your porch light?' We saw this light, like a big diamond, it seemed, up in the sky, going east.

1,000 Feet Up

"Then another came along, swooping east, like a kite with a long tail, all lighted up. It was a thousand or more feet up. It was bright. It didn't shed any light on the ground, but it set off my dogs in a round of barking spasms. It wasn't a jet plane—we see a lot of them out of Scott field, and east-west air liner planes."

Uphoff has a pack of bird dogs—and the lights had that effect on the dogs or the Orville Austin farm, near Wayne City, 16 miles west of Fairfield, Monday night.

Ronnie Austin, 18, and his girl friend, Phyllis Bruce, 18, were driving home from an outdoor theater just west of Fairfield when, 10 miles from home, Ronnie says:

"Big As An Auto"

"This big light looked as big as an automobile. My car engine conked out for a minute, and the radio went haywire, when it yassed overhead. It looked like it was chasing us until we got home."

Ronnie called his father, who got his shotgun, went out—but went back in as the light flashed. He turned off the house

lights and called the sheriff's office.

Deputy Sheriff Harry Lee drove from Fairfield to the Austin farm. He said:

"The light had retreated, it seemed—wasn't so bright. It was three or four times bigger than a star. It was moving, but not twinkling, and as quite a distance up."

Orville Austin said the light was visible, high in the sky, for about four hours, until day-break.

"Ball of Fire"

Perry Padgett and his wife, of Cisne, 12 miles north of Fairfield, saw a "big ball of fire" in the skies Sunday night as they drove toward Fairfield on U. S. Illinois highway 45. Padgett says:

"It looked like a big ball of fire or light, with lighted prong extending out. It was very high up, an dmoving at a high rate of speed."

Police radio operator Kenneth Talbert said the Wednesday night light appear to him to be in the shape of a cross, high in the sky.

Many Reports

At Northwestern university Dr. Hynek said the incidence

of reports of strange lights and noises from the sky might be a "problem for a psychologist rather than an astronomer," because many such reports "are the result of people not seeing things they thought they saw."

He said that, in coöperation with the air force, 500 to 600 "unidentified flying object" reports are investigated each year. But, because of the reliability of the persons from the "little Egypt" section of southern Illinois who have reported the recent incidents, he hopes to go down there to see what it's all about.

Manor Mystery

A rock hit George Barnett, ten, of 39 Cheltenham av., shortly before 7:30 Monday night near his home in Oak Lane Manor.

Police said he received a bruise on the arm but required no medical treatment.



They said the boy was the first victim to be pelted since the rocks began falling during early evening hours, May 15.

Police have been unable to determine from where the rocks --some as big as oranges--are coming.

Mrs. Rita Siciliano, of 32 Dewey road, told police a rock broke a rear window in her home. Sunday night, several windows in the area were reported broken by rocks.

Flash— Mystery Light Roams

FAIRFIELD, Ill.—The fast-flying mystery-light-in-the-sky which has turned downstate Wayne county topsy-turvy, has flashed on again, and officials say that other area counties have reported sightings.

A group of Flora residents 25 miles north of Fairfield reported seeing lights similar to those seen in Fairfield.

Paul C. Brock of Albion said he and neighbors saw a brilliant light that was stationary for 5 minutes. It turned red, he said, and floated away making an engine noise.

Authorities trying to track down the lights' origins said amateur scientists are offering much free advice.

An unidentified man telephoned Thursday from Skokie near Chicago, they said, saying he is certain he can prove the lights are flying saucers.
