**SUMMARY**

1. Mr. Lee M. Graham sent a Freedom of Information Act Request (Tab 1) to the Air Force, requesting information about the SR-71 and U-2 Aircraft, the Lockheed CL-400 Aircraft, Lockheed production facilities, camera systems, and a classified AF facility.
2. Most of the requested information does not exist in Air Force records. One requested piece of information, the official AF designation of the classified site, is answered that there is no official AF designation for that site.
3. We are partially denying Mr. Graham's request for the manufacturer of SR-71 camera systems. That information is properly and currently classified. We are informing Mr. Graham that 5 hours of executive/professional research time will be required to provide the answer to one question about camera systems. Under the Freedom of Information Act, Mr. Graham must indicate willingness to pay for the research time if he desires an answer to his query. In any case, if the camera systems were developed for the SR-71 or U-2, the answer to his question will be classified and withheld under Exemption b(1) of the Act.

**RECOMMENDATION**

4. DCS/RD&A or Assistant DCS/RD&A sign the Letter of Response to AF/DADF (Tab 2).






This responds to portion of question in paragraph 3 of your June 4, 1984, Freedom of Information Act (FOIA) request to Foreign Technology Division: "That the satellite system detailed in "B" can and has detected UFOs... is this correct?" The Space Division of Air Force System Command referred that portion of your request to us.

As regards this subject matter, ~~FOIA~~ existence or non-existence is currently and properly classified per Executive Order and exempt from mandatory disclosure under the Freedom of Information Act because it would reveal defense capability or lack thereof. Knowledge of our capability in this area would give nations whose interests are inimical to ours an insight into our capability and would give them a military advantage they otherwise might not possess. We are withholding confirmation of existence or non-existence for these reasons. The authority for this action may be found in the United States Code, Title 5, Section 552 (b)(1) and Air Force Regulation 12-30, Paragraph 10a.



Dear Mr. Graham:

This letter is in response to your Mandatory Declassification Review (MDR) request submitted to the National Geospatial-Intelligence Agency (NGA), dated November 15, 2010. Your request was for "any record in which a DSP Satellite has detected an object of extraterrestrial origin, and thus determined to be of intelligent control" "A machine from another world", believed to be code named a Fast Walker (FW)".

With respect to your request for information and the records you seek, the National Geospatial-Intelligence Agency can neither confirm nor deny the existence or non-existence of records responsive to your request. The information you requested, unless it has been officially acknowledged and disclosed, or otherwise properly released to the public, would be classified for reasons of national security under Executive Orders 13526 and 12951.

I have determined that under these circumstances, your request is denied. Pursuant to Executive Order 13526, Sec. 3.6(a) an agency may refuse to confirm or deny the existence or nonexistence of requested records whenever the fact of their existence or nonexistence is itself classified under this order or its predecessors.

This response constitutes a denial of your request and you may appeal this decision. The decision to withhold this information may be appealed in writing to the National Geospatial-Intelligence Agency. Any appeal should be post-marked no later than 60 calendar days of the date of this letter. Please enclose a copy of this letter with the appeal along with your reasons for reconsideration. AdChoices [PDF Version](#)**Executive Order 12951 of February 22, 1995****Release of Imagery Acquired by Space-Based National Intelligence Reconnaissance Systems**

By the authority vested in me as President by the Constitution and the laws of the United States of America and in order to release certain scientifically or environmentally useful imagery acquired by space-based national intelligence reconnaissance systems, consistent with the national security, it is hereby ordered as follows:

Section 1. Public Release of Historical Intelligence Imagery. Imagery acquired by the space-based national intelligence reconnaissance systems known as the Corona, Argon, and Lanyard missions shall, within 18 months of the date of this order, be declassified and transferred to the National Archives and Records Administration with a copy sent to the United States Geological Survey of the Department of the Interior consistent with procedures approved by the Director of Central Intelligence and the Archivist of the United States. Upon transfer, such imagery shall be deemed declassified and shall be made available to the public.

Sec. 2. Review for Future Public Release of Intelligence Imagery. (a) All information that meets the criteria in section 2(b) of this order shall be kept secret in the interests of national defense and foreign policy until deemed otherwise by the Director of Central Intelligence. In consultation with the Secretaries of State and Defense, the Director of Central Intelligence shall establish a comprehensive program for the periodic review of imagery from systems other than the Corona, Argon, and Lanyard missions, with the objective of making available to the public as much imagery as possible consistent with the interests of national defense and foreign policy. For imagery from obsolete broad-area film-return systems other than Corona, Argon, and Lanyard missions, this review shall be completed within 5 years of the date of this order. Review of imagery from any other system that the Director of Central Intelligence deems to be obsolete shall be accomplished according to a timetable established by the Director of Central Intelligence. The Director of Central Intelligence shall report annually to the President on the implementation of this order.

(b) The criteria referred to in section 2(a) of this order consist of the following: imagery acquired by a space-based national intelligence reconnaissance system other than the Corona, Argon, and Lanyard missions.

Sec. 3. General Provisions. (a) This order prescribes a comprehensive and exclusive system for the public release of imagery acquired by space-based national intelligence reconnaissance systems. This order is the exclusive Executive order governing the public release of imagery for purposes of section 552(b)(1) of the Freedom of Information Act.

(b) Nothing contained in this order shall create any right or benefit, substantive or procedural, enforceable by any party against the United States, its agencies or instrumentalities, its officers or employees, or any other person.

Sec. 4. Definition. As used herein, "imagery" means the product acquired by space-based national intelligence reconnaissance systems that provides a likeness or representation of any natural or man-made feature or related objective or activities and satellite positional data acquired at the same time the likeness or representation was acquired.

## MAJOR GENERAL MICHAEL C. KERBY

Retired March 1, 1991.

Major General Michael C. Kerby is vice commander in chief, Pacific Air Forces, headquartered at Hickam Air Force Base, Hawaii.

General Kerby was born in 1937, in New York City and graduated from Fordham Preparatory School, Bronx, N.Y., in 1954. He earned a bachelor of arts degree in economics from Georgetown University in 1958 and continued graduate studies in night school at Columbia University in 1959. The general earned a master of arts degree in government and international studies from the University of Notre Dame in 1979. He completed Squadron Officer School in 1963 and Armed Forces Staff College in 1971. General Kerby is currently a doctoral candidate in political science at the University of Notre Dame.

The general was commissioned through the Air Force Reserve Officer Training Corps program at Georgetown University in 1958. He entered pilot training in October 1959 at Malden Air Base, Mo., training in T-34s and T-28s. He transferred to Webb Air Force Base, Texas, in May 1960 for training in T-33s and completed pilot training in November 1960 as a distinguished graduate. After completing advanced fighter and weapons delivery training in F-100s at Luke Air Force Base, Ariz., and Nellis Air Force Base, Nev., General Kerby was assigned in October 1961 to the 417th Tactical Fighter Squadron, Ramstein Air Base, West Germany, as an F-100 pilot. In October 1965 he was assigned as an F-100 flight commander with the 615th Tactical Fighter Squadron, England Air Force Base, La. In July 1966 he deployed with the squadron to Phan Rang Air Base, Republic of Vietnam.

In January 1967 General Kerby became an A-1H pilot adviser to the Vietnamese air force with the Air Force Advisory Group, Tan Son Nhut Air Base, Republic of Vietnam. He returned to F-100s as an instructor with the Air Force Fighter Weapons Instructor Course at Nellis Air Force Base from September 1967 through January 1969. He then served as a demonstration pilot (solo) with the Air Force Aerial Demonstration Squadron, the Thunderbirds, also at Nellis, flying F-100s and F-4E Phantom IIs, until January 1971.

The general completed Armed Forces Staff College in July 1971 and was assigned to the Fighter and Reconnaissance Manning Section, Air Force Military Personnel Center, Randolph Air Force Base, Texas, as a resource manager. He completed his tour of duty there in May 1974 as chief of the Fighter Section. The general was assigned as operations officer for the 421st Tactical Fighter Squadron, Udorn Royal Thai Air Force Base, Thailand, from October 1974 to August 1975. He then served as commander of the 335th Tactical Fighter Squadron and, subsequently, as assistant deputy commander for operations with the 4th Tactical Fighter Wing at Seymour Johnson Air Force Base, N.C., until August 1977.

After completing a research master's program at the University of Notre Dame in June 1979, General Kerby was assigned to Headquarters U.S. Air Force, Washington, D.C., as chief, Senate Liaison Division, Directorate of Legislative Liaison. He was responsible for advising members of the U.S. Senate on Air Force issues and programs. In March 1981 he became vice commander of the 368th Tactical Fighter Wing, Hill Air Force Base, Utah.

General Kerby was assigned as commander of the 474th Tactical Fighter Wing at Nellis Air Force Base in August 1981 and subsequently commanded the 57th Fighter Weapons Wing at Nellis from May 1982 to May 1984. The 57th Fighter Weapons Wing included the Air Force Fighter Weapons School; Red Flag; fighter weapons test, evaluation and tactics development; adversary threat training, the Aggressors, and the Thunderbirds. General Kerby then returned to Air Force headquarters as deputy director of legislative liaison and became director in August 1986. He assumed his present duties in April 1988.

The general is a command pilot with more than 4,000 flying hours and more than 350 combat flying hours. He has flown F-100s, A-1H's, F-4E's, F-5s, F-111s, F-15s and F-16s. His military decorations and awards include the Distinguished Service Medal, Legion of Merit with oak leaf cluster, Distinguished Flying Cross with oak leaf cluster, Bronze Star Medal, Meritorious Service Medal with oak leaf cluster, Air Medal with six oak leaf clusters, Air Force Commendation Medal with two oak leaf clusters, Republic of Vietnam Gallantry Cross with Palm, Republic of Vietnam Air Gallantry Medal with gold wings, and Republic of Vietnam Air Service Medal.

He was promoted to major general June 1, 1987, with same date of rank.

General Kerby's hometown is New York City.

Col. Hennessey (Barry) was in my office yesterday-perhaps at same time FBI was talking with you.

Indeed, as I have just shown above I, signed the enclosed, C E R T I F I C A T E, dated 9/15/87 in which I was given "CLASSIFIED" information on the existence of an Aircraft that Mr. John Andrews identifies in his To Whom It May Concern letter enclosed dated, 17 March 1989, wherein Mr. Andrews states-

"I provided Lee with the Lockheed Stealth designator (F-117), codename (Senior Trend) all before September 1987."

And-

"Col. Barry Hennessey has been my AFOSI contact."

This UNCLASSIFIED letter is now, an integral part of the enclosed Defense Investigative Service (DIS) file number 89311-DK1-3408-1W9, a few pages that I have enclosed for your perusal, to authenticate this MDR request.

3. That specific record that Authenticates the UNCLASSIFIED, copy of the BRIEFING DOCUMENT: OPERATION MAJESTIC 12, as it is found in the enclosed DIS file number 89311-DK1-3408-1W9

Sir this MDR request, and request for information that is predicated on the authenticity of the enclosed UNCLASSIFIED copy of the BRIEFING DOCUMENT: OPERATION MAJESTIC 12, which if genuine, compromises the claims of Air Force Col. Richard L. Weaver, and his treatment of the "Roswell Incident" as but a misinterpretation of the once secret "Mogul Balloon Project", as he indicates during the term of Secretary of the Air Force Shelia Widnall, and I included the soon alleged "Disclosure", that "President Obama may be preparing an official disclosure of the extraterrestrial presence—" article found on the Internet and broadcast to "China."

Please note the enclosed MDR request dated 21 February 2011.

I believe that some people within the Majestic-12 Group wanted the truth of the existence of an Extraterrestrial Presence to come out back in the late 1980s. Enclosed you will find a biographical sketch, found on the Internet of John Barry Hennessey, known to Air Force Office of Special Investigations (AFOSI) Agent William L. Moore as the "Falcon". Col. Hennessey was the prime mover in seeing that I got the BRIEFING DOCUMENT: OPERATION MAJESRIC 12 declassified as it is now found as an integral part of enclosed Defense Investigative Service (DIS) file number 89311-DK1-3408-1W9.

"At the request of Lee M. Graham I am writing this"

And-

I provided Le with the Lockheed Stealth designator (F-117), codename all before September 1987."

And-

"Col. Barry Hennessey has been my AFOSI contact---"

At the request of Mr. Andrews in August or early September 1987, I made a Freedom of Information Act (FOIA) request to the Air Force regarding the existence of the F-117, and received a response, that they had know knowledge of the existence of such an aircraft. However on 9/15/87 I was visited in the Security Office of AerojetElectrosystems, in Azusa, CA by FBI Agent William J. Hurley, and Major General Michael C. Kerby and told that if I would sign the enclosed C E R T I F I C A T E, which I did, I would be provided with some information, and I was shown now A T T A C H M E N T 1, that was then withdrawn as is indicted. As is indicated in the enclosed article from the Internet- Lockheed F-117 Nighthawk, the existence of the F-117 was not made public until November 1988. This is a year after I was shown proof that the F-117 did in fact exist.

As the enclosed C E R T I F I C A T E states, I was provided with information that I "had no need to know", a violation of Air Force Security rules, so it must have been very important for me to have received this information to jeopardize the F-117 Program's existence and the careers of Major General Michael Kerby, and Col Barry Hennessey, who knew what I had been given, as is reveled in John Andrews' letter to me enclosed dated 16 Sep 1987.

Hartig, the Air Force UNCLASSIFIED the document making it genuine. I was cleared of any wrong doing by Col. Barry Hennessey when he signed the enclosed- MEMORANDUM FOR DISTRIBUTION, dated 17 APR 1990, now attached to A T T A C H M E N T 1. Two days later, the DIS file was closed on 19 APR 90.

I Thank, you Mr. Storer, Sir, for your enclosed response, dated FEB 17 2011 which hopefully indicates that there are indeed DSP Satellite records for the detection of 3 DSP Satellite detections of Identified Aliens Crafts, as the attached MDR request, dated 30 December 2010 requests, thus-

I respectfully request the current status of this 30 December 2010 MDR request.

There does exist however a problem with the 11-MDR-066 response, enclosed dated 3 February 2011, for the two attached requests & response dated, respectively 18 January 2011, for the response 11-MDR-066, that according to the enclose Gmail response was

Mr. Andrews has indicated the mailing address where the MJ-12 as "USAF Security Command at Medina base (Medina Annex) at Kelly AFB in Texas", in the enclosed letter to Ron (Regehr), enclosed dated 19 Oct 1987.

And, again in relation to the detection of UFOs by the DSP Satellite, in the FBI file number 190-LA-109564/GRAHAM, LEE, on page 2 may be found the following statement-

Information gleaned from Aerojet security officials reveals that GRAHAM was considered by many to be overly concerned with UFOs and Aerojet's "role" in identifying UFOs

As is indicated in the enclosed EXCLUSIVE article, titled-

Mexican DoD Acknowledges  
UFOs In Mexico

Found on the Internet, wherein on page 2 the UFO, was detected by a FLIR STAR ZAPPHIR II and a RADAR AN/PS 143 BRAVO VICTOR 3-

These UFOs were detected by the Infrared capability of the FLIR STAR ZAPPHIR II, system, but were not visible to the naked eye, ergo an overhead DSP with its Infrared capability would also had detected these UFOs

So I think it obvious that the DSP Satellites have indeed contributed to the detection of Identified Alien Crafts (IAC), and thus can't comprehend the MDR response enclosed, dated 3 March 2011, unless those Satellite records have been transferred to another Agency or Company, most specifically, that of 5 May 1984, and therefore FOIA or MDR requests seeking this record, ostensibly of an extraterrestrial vehicle are not available to the American Public? President Obama has demanded "Transparence" of all Government Agencies, Thus-

1. Under the provision of Executive Order 13526, Section 3.6, I respectfully request for review any Order or Executive Order, still classified or not classified, that requires the DSP Detection of an object of known extraterrestrial origin to be removed from per view of Public access, to be sent to some other Agency or Company, not subject to the Freedom of Information Act (5 U.S.A.C. 552) and or the Mandatory Declassification Review, Executive Order 13526, Section 3.6, and a copy of that Order be sent to me.

"CLOSED with response back to you on 18 Feb 11", and MDR request dated 5 February 2011, with response dated 3 March 2011, that states-

"Reference your letter 5 February 2011. The appropriate Air Force Agency has reviewed your request and after a thorough search, has not found any evidence, classified or unclassified, of the existence of an Defense Support Program detections that were "demonstrated to be vehicles of extraterrestrial origin."

I believe that I was most specific in my MDR request of 3 February 2011, indicating that I had held in my hands the "Time Intensity Profile" detection of the DSP detected event "on 5 May 1984" that had "an intensity of 9,000 Kilowatts per Ster-radian", an impossibility for any rocket engine to burn from "January 31, 1984" to "May 5, 1984" as is suggested on pages 106 and 107 of the very excellent and informative book America's Space Sentinels, by Jeffery T. Richelson, implied to be a secret National Reconnaissance Office (NRO) "VORTEX" Satellite that approached the DSP Satellite, which in the enclosed NRO response dated 2 August 2010, the NRO denies any report of an NRO Satellite involvement "on 5 May 1984."

That there are, Satellites that "approach the DSP Satellite" can be verified as to an open non-classified conversation I had with the Aerojet ElectroSystems President Carl Fischer may be verified, as found on page 3 of the enclosed FBI file number 190-LA-109564/GRAHAM, LEE Indeed I was investigated by the FBI for having used the term "Fast Walker" (FW) in connection with a "Satellite that approaches the DSP Satellite, in a letter to "USSPACECOM" on "APRIL, 1999" as is indicted in this file FBI file.

And as is indicated in this FBI file, "the term FW and SW have been used in the 1950's, and first evolved as descriptive terms for objects appearing on display screens." This is before the first DSP Satellite was launched in the early 1970, and comports with the letter, enclosed, dated 28 May 1987 from John Andrews to Ben Rich, Vice President & G. M., ADP Lockheed-California Company Burbank, CA 91520, wherein Mr. Andrews states-

"I have known of MJ-12 for many years even though, officially, it "didn't exist. There was an Air Force radar (AC & W) detachment at Sinop, Turkey under the cover of Turkey-U.S. Logistics agency (TUSLOG) who tracked Soviet aircraft and, many times UFO's. It was standard for the detachment to forward radar tapes of the UFO's to MJ-12. That was policy."

And-

"That led to USAF Project Aquarius (different from NS project by same codename) dealing with UFO's and "Snowbird." And, even now, their are *discoidal objects flying at Groom Lake. I state that, Ben, with no equivication. The whole coverup is beginning to teeter.*"

Mr. Andrews' further states in his letter to Ben Rich-

If such order is not classified and its locality known to the Department of Defense, I respectfully request the mailing address of that Agency to make a FOIA request for the requested Order.

Enclosed you will find a Xerox copy of an arrow shaped object from the Internet, as it moved above "Red Square in Moscow", please note my MDR request enclosed dated 23 February 2011 which may be of the same type of Aerial Vehicle, thus I respectfully request to know the status the enclosed MDR request dated 23 February 2011, and-

2. Under the provision of the Mandatory Declassification Review, Executive Order 13526, Section 3.6, I respectfully request the review for Declassification, the record of the type of vehicle in the enclosed Internet Article, if and only if it has been determined to be of extraterrestrial origin.

From the enclosed copy of the Project Aquarius document it is, in part, stated-

"MJ12 feels confident that the Aliens are on an exploration of our solar system for peaceful purposes. However, we must continue to observe and track the Aliens' movements until it is determined that the Aliens' future plans contain no threat to our national security or civilization of Earth."

Along with the DSP Satellite tracking of the "Aliens", I felt that the National Reconnaissance Office (NRO) was also tracking the "Alien's movements." As well. However, the enclosed MDR, response, dated 8 March 2011, to my MDR request attached, dated 19 February 2011, The NRO, states-

"You are asking us to review for declassification a "Top Secret SCG on the DSP Satellite." The NRO does not have this document. The NRO is not an Air Force organization."

I made the mistake in the request for an "SCG on the DSP Satellite", an Air Force Program. However, that gave me a clue to that dawned on me, that maybe the "Air Force had developed a secret Satellite, that had as it's main function, was to track, with Radar and Infrared Sensors, besides the DSP Satellite, the "Aliens' movements." I understood, later from Mr. Abretski, that his buddy was laid off for a year while they investigated him, and me also-

3. Left an observer here 2000 years ago: Observer not related to Christ according to sources: "They" may have holographic images of the crucifixion of Christ--- Ergo-





  - c. "[a] DVD copy of the EBEn depiction of the Crucifixion of Christ."

  - e. "a copy of the two pages of the 5 May 1984 Fast Walker that I had sent to the Air Force."
  - f. "that record that evaluates what the DSP detected Fast Walker of 5 May 1984 was, including any Russian Early Warning Satellite report of the same event."



FITNESS-FOR-DUTY EVALUATION

Dear Ms. Brown:

At your request, we conducted an evaluation of Mr. Lee Graham, to assess his fitness for duty in his position as an electronic technician at Aerojet. The evaluation consisted of two separate sessions. On August 27, 1996, Dr. Ryan met with Mr. Graham for two hours. On August 29, 1996, Dr. Tabachnick and Dr. Ryan both met together with Mr. Graham for one hour. Copies of correspondence from Mr. Graham to Aerojet, and from Aerojet to Mr. Graham, were available for review. The evaluation consisted of mental status examination, a detailed review of Mr. Graham's current condition, history of recent events, and review of his past history.

REFERRAL QUESTIONS:

The referral questions presented to us were as follows: 1) Does Mr. Graham present a danger to himself or others at the workplace? 2) Is Mr. Graham mentally or emotionally disabled from performing his job duties in a safe and efficient manner? 3) Is any treatment recommended?

BACKGROUND INFORMATION:

The following background information was provided. Mr. Graham was said to be a 61-year-old man, who is considered a highly skilled technician. He is currently on suspension due to policy violation. He was said to have a classified document in his possession which he wouldn't return to Aerojet. We were told that Mr. Graham made statements which were interpreted as possibly threatening. As a result, the employer was concerned about the potential for violence and about mental and emotional stability. Thus, this psychiatric/psychological fitness-for-duty evaluation was arranged as a condition of Mr. Graham being cleared to return to work. We were told that Mr. Graham had denied making any threats. We were also told that the employer is aware that Mr. Graham has a long-standing interest in U.F.O.'s and related phenomenon.

## FINDINGS AND CONCLUSIONS:

Regarding the issue of potential for violent behavior, we must preface by stating that predicting violent behavior is exceedingly difficult, particularly in an individual who is not admitting to violent intentions or urges, and without a history of violence. The history we know of Mr. Graham contains relatively few of the most prominent risk factors that are often associated with potential for violence. However, this does not guarantee that violent behavior will not occur in the future.

The most specific risk factor for future violence is a past history of violent behavior. Based on what we know of Mr. Graham, he has no past record of violent behavior, criminal arrests, or tendency to act out impulsively or aggressively against others. Additionally, Mr. Graham denies violent intentions, plans, thoughts, impulses, or urges, currently or at any time in the past.

Further, Mr. Graham presented with affect without severe agitation, hostility or irritability. He has no known history of substance abuse, which can impair impulse control. He denied any violent or homicidal ideation or intent.

We reviewed the incidents in question, in which Mr. Graham admits to making statements such as "What do we have to do, rob a bank or blow something up?" He understands why this statement was construed as threatening by his employer. He denies violent or threatening intent, describing his statements as being "figures of speech," or hyperbole, uttered in exasperation. He did not deny that he made the statements, but merely maintained that he did not have actual intent at any time to harm anyone or threaten anyone. He expressed that he understood his employer's concerns about his comments, and their need to take reasonable steps to ensure the safety and security of the workplace.

Further assessment of risk factors reveals that Mr. Graham has a stable, lifestyle, with long-time employment, a long-term marriage, stable residence, and no recent serious life stresses (with the exception of the recent job suspension). These negative findings on the above risk factor reduce, but do not eliminate, the potential for violent behavior.

With regard to the second referral question, it is our opinion, based on our assessment of Mr. Graham, he does appear mentally and emotionally capable of performing the technical aspects of his job duties. This assessment is based on the following considerations. Upon mental status examination, Mr. Graham's cognitive functioning was found to be grossly intact. He is able to perform serial sevens adequately. His concentration and attention were not impaired. He was not noted to be distracted or tangential, and his flow of thought and speech was not impaired. As noted above, mood and affect were grossly within normal limits. Our understanding from the referral information

is that Mr. Graham has been a highly skilled and competent technician. Based on our review of his history, his cognitive functioning has not acutely deteriorated. Thus, his current level of cognitive functioning is sufficiently intact for him to carry out his job duties.

With regard to the precipitating events in this case, in which Mr. Graham was alleged to have violated company rules with regard to possession of a classified document, there is no reason from a psychiatric or psychological standpoint why he should not be managed as any other employee would. That is, Mr. Graham is mentally and emotionally capable of receiving clear and direct communication in written and/or verbal form explaining his specific obligations and responsibilities as an Aerojet employee with regard to how he should handle any classified documents in his possession. Additionally, there is no reason, from a psychiatric or psychological standpoint, why Mr. Graham cannot tolerate being informed of the reasonable consequences of any failure to comply with existing, uniformly applied company procedures.

We were informed as a part of the background referral information that it was known to the employer that Mr. Graham has an interest in U.F.O.'s and related matters. In today's evaluation, we thoroughly reviewed this area with Mr. Graham. Having discussed this issue in detail with Mr. Graham, it appears that Mr. Graham's interest and beliefs in U.F.O's and other related phenomenon have never caused him to present danger to others at the workplace. If, in pursuing this area, he becomes a distraction, preventing himself or others from performing their job duties, or company policies are violated, he should be appropriately managed as described above.

With regard to the third referral question, Mr. Graham is currently in the midst of a work suspension and has expressed to us that his current suspension has been extremely upsetting. We strongly recommend supportive counseling to assist him in coping with the current issues with his employer, as it would give Mr. Graham an opportunity to ventilate his thoughts and emotions, and discuss positive means of dealing with any feelings related to the current conflict with his employer. Such counseling would play an extremely important role in assisting Mr. Graham to maintain a positive and productive approach to the current conflicts, and would reduce the risk that his frustration would lead to inappropriate statements or behavior. This counseling would be of even greater importance to Mr. Graham if the personnel conflicts were to escalate, to the point where Mr. Graham's job security was an issue.
