Dear President Clinton:

My father, Dr. Jules Davids, would send you his greetings for the New Year if he could, but he has unfortunately been ailing in a similar way as former President Reagan. So I send you best wishes on behalf of the whole Davids family. We all support your re-election campaign with gusto and hope for a new House and Senate brimming over with Democrats.

Since hearing from you as President-elect, on Dec. 9, 1992, after sending you some of our Star Wars books, I went on to be executive producer and co-writer of a major film about the Roswell Incident that was nominated for a Golden Globe for Best TV movie of 1994. In fact, it may have been partially responsible for rekindling the controversy about the Roswell Incident which sparked some official inquiries in Washington. It has since been released around the world in many languages, and was also widely presented by the U.S. Navy to its servicemen and servicewomen.

Thus, when you recently made a statement about the Roswell Incident during your trip to Ireland, I felt moved to write to you. Your statement concluded with the words: "*If the United States Air Force did recover alien bodies, they didn't tell me about it either, and I want to know.*" I am therefore enclosing for you:

(1) The movie, "Roswell," starring Kyle MacLachlan, Martin Sheen and Dwight Yoakam, followed by a brief documentary with witness testimony (105 min.)

(2) "Golden Anniversary UFO Briefing for the White Sands Missile Range Pioneers" This is the keynote banquet speech I was asked by the founders of the U.S. rocketry and missile programs to present about Roswell and UFO's to a group of about 200 military men and women celebrating the 50th anniversary of the founding of White Sands. I appealed for a more open policy but defended the rationale that national security may have compelled secrecy on this issue for decades. (1 hr)

(3) "Down in Roswell" This is a compendium of media and news coverage on the Roswell case through the years, which I host. It includes the original ABC radio broadcast announcing the military's capture of a flying saucer. (1 hr)

(4) "Reply to the Air Force Report on the Roswell Incident" This is based on a speech I gave in the aftermath of the release of the A.F. Report in 1994. I took the theme "The UFO Coverup Continues..." in reaction to the flaws and bias of the report.

The Government Accounting Office Report revealed that all the key documents from Roswell that could have answered our questions were destroyed about forty years ago without proper authorization. Your recent declassifications included troop deployments from as long ago as World War I. People wonder why the much more recent Roswell data was destroyed, i.e., communiques from a key World War II base, whereas insignificant documents from 1917 survived. Regardless of whether my assumptions of long-reigning secrecy are well founded or misguided, I concluded that the Air Force Report on the Roswell Incident contains glaring errors, ignores key facts and testimony, debunks and attacks the motives of investigators, authors and Hollywood film producers alike in its seemingly transparent attempt to "spin" the issue. The result was that it was lambasted by those it was intended to satisfy.

Polls now indicate that about 50% of the population believes that some UFO's are extraterrestrial spacecraft, and many also believe that some agencies of government know this to be a fact and may be withholding hard evidence that proves it. This is not a small minority that holds these opinions, nor does a majority still respond by ridiculing or trivializing the issue. The media has had its influence. In fact, no one in public life seems to have fully assessed the schism between media and official government positions on this issue, which bears upon public trust.

You set a bold and much-appreciated precedent in revealing, at a strategic and appropriate time, through the Department of Energy, the facts about experimentation in past decades involving radioactivity. You have been moving the public in the right direction on almost all issues, and I applaud you for your bold leadership and standing up for what is right. I would look forward to continued public developments on this UFO issue, as Laurance Rockefeller and others of stature, including astronaut Gordon Cooper, now publicly recommend. In your letter to me of Feb. 12, 1992, you raised the possibility of tapping my talents in some area. I would like you to be aware of my desire to be of service, whether as a writer or consultant or public speaker on this issue as it relates to media and government, to support any developments toward preliminary disclosures, assuming that there is in fact anything to be disclosed.

Thank you, Mr. President, for taking the time to read this letter and for considering the point of view expressed and the material in the videotapes enclosed.


Thank you for offering, when we spoke today, to provide the contents of this package to Nancy Hrenreich, for the personal and confidential attention of President Clinton. As I mentioned, my father, Dr. Jules Davids, was President Clinton's professor of American history when the President was a student at Georgetown University, and I have received prior letters from President Clinton.

I am sending some of the past correspondence from President Clinton in hopes that it will help in the process of receiving Presidential attention for this communique. I've enclosed a copy of a letter from then-Governor Clinton to my father dated April 8, 1987, then-Governor Clinton's letter to me of February 12, 1992, and then-President-elect Clinton's letter to me of December 9, 1992.

In addition to my enclosed letter to the President, I am enclosing four VHS videotapes I have produced, including the movie "*Roswell*," starring Kyle MacLachlan, Martin Sheen and Dwight Yoakam. All of these bear upon a public statement President Clinton made on his recent trip to Ireland involving the famous "Roswell Incident" of Roswell, New Mexico. Also enclosed, attached to the letter: a New York Daily News article and an excerpt from the Sharper Image catalogue.

The other three tapes are: "*Golden Anniversary UFO Briefing for the White Sands Missile Range Pioneers*," "*Down in Roswell*," and "*Reply to the Air Force Report on the Roswell Incident*." All the tapes are described in my letter to the President. Please check to make sure they did not undergo any X-ray damage. I will of course send additional copies upon request. Thank you for your assistance and consideration.



President Clinton said last month that, "as far as I know, an alien spacecraft did not crash in Roswell, N.M., in 1947. ... If the United States Air Force did recover alien bodies, they didn't tell me about it either, and I want to know."

Laurance Rockefeller wants to tell him. The 85-year-old philanthropist has funded a 150-page study of "the

Roswell incident." This month, he's due to send it to White House Science adviser John Gibbons, as well as every U.S. congressman and senator.


