PURPOSE: To offer wishes for a speedy recovery from his surgery today.

BACKGROUND: The Associated Press is reporting Oscar-winning Director Steven Spielberg underwent surgery for "an irregularity" on a kidney and was recovering at home. In a statement, Spielberg's spokesman said, "During a routine physical examination Steven Spielberg's doctor discovered an irregularity on his kidney. Subsequently it was removed at Cedars-Sinai Medical Center. A complete recovery is promised and no follow-up treatment is necessary."

The AP also reported that last month the Director's Guild of America announced Spielberg will receive its Lifetime Achievement Award on March 11.







We live in an age of great promise -- and great peril -- for our nation's children

Great promise because we live in an exciting age of progress and change, and children are our future. Great peril because we are letting them down when it comes to health care, nutrition, physical safety, education, and the most basic childhood need -- love, affection, and nurturing.

Earlier this month, the Carnegie Corporation issued an extensive report about American children between the ages of zero and three. It was stunning in its breadth, and also in the urgency of its message: We must do more.

THE GRIM STATISTICS ABOUT CHILDREN

- * Today, the infant mortality rate in the U.S. is higher than that of 19 other countries
- * Today, more than a quarter of all mothers do not receive prenatal care
- * Today, more than a quarter of all babies are born to unmarried mothers -- compared to about 5 percent in 1960.
- * Today, of the 12 million children under age 3, three million live in poverty
- * Today, almost 40 percent of American two-year-olds have not been fully immunized against major childhood diseases
- * Today, one third of the victims of physical abuse in this country are under one year old.

OUR MORAL PROGRESS IS LAGGING BEHIND OUR TECHNOLOGICAL PROGRESS

Our technological and scientific progress has far outpaced

our progress as moral beings, particularly when it comes to our treatment of children.

* We have machines that can detect tumors in the brain, yet millions of children never receive a polio vaccine.

* We have the finest libraries in the world, yet too many American children don't know how to read.

* We have an elaborate system of justice, yet more and more American children resolve disputes not with words, but with guns.

As a community, we have shown that we can sympathize with the plight of children. But we have not shown that we are willing to ACT as much as we need to on their behalf.

CHILDREN SHOULD NOT GROW UP WITH A SENSE OF FUTILITY

We must give children a reason for hope about their own futures. Otherwise we will continue to see stories like one I read a few months ago about children in Washington who are so sure they are going to die violently that they have begun planning their own funerals. These are 11, 12, 13-year-olds, matter-of-factly discussing the clothes they will wear, the music they want to have played, at their own funerals.

It doesn't sound so absurd when you stop to consider that these children live daily with the sound of gunfire in the streets, their neighborhoods, and even their schools.

HOW DO WE RESTORE HOPE FOR OUR CHILDREN?

We must commit ourselves as a national community to ensuring that children get the right start in life. That means good health care, proper nutrition, safe streets and safe schools, and a more nurturing, stable home environment.

The Clinton Administration is committed to keeping children squarely on the national agenda and we have made some progress: Head Start, WIC, safe schools, Goals 2000, the Family and Medical Leave Act, crime prevention.

HEALTH CARE REFORM IS THE KEY TO IMPROVING THE LIVES OF CHILDREN

* Today, 10 million children don't have insurance.

I met a 10-year-old boy in Denver recently. He had Down's syndrome, and he had come with his grandmother to the National Guard M*A*S*H unit there. They had lost their Medicaid coverage because of a change in the rules, and the M*A*S*H unit was the only place the grandmother could find care for this boy.

* Reform will assure that every child has comprehensive benefits. No one will be excluded because of a pre-existing condition.

HEALTH CARE REFORM IS NOT ONLY AN ECONOMIC IMPERATIVE. IT'S A SOCIAL IMPERATIVE AND A MORAL IMPERATIVE

Our children tell us who we are and where we are going as a nation. If we can't be civilized for our own sake, let us be civilized for the sake of our children.

Above all, we must remember: children are powerless to affect change. But we are not.






