

No. 5. HOPE MEDICINE FOR PEOPLE AROUND THE WORLD. It is indeed good news that the family and associates of the late Dr. William Walsh intend to keep going his heart's closest desire -- the Hope and Hope Ship endeavor.

His life's story needs telling. I was shopping around for a doctor in a new town and some one suggested Dr. Walsh -- perhaps because he was young and a veteran also. I found him most satisfactory and we became personal friends as well as doctor and patient. In fact, we would forget to talk medicine as I exchanged with him all my tidbits from the politics from Capitol Hill where I was a reporter. He loved to talk politics.

But I was surprised to find on one visit that he was bending closely to the Republican party. I cautioned him about becoming partisan. He denied this and I believed him until I went in an adjoining office to take off my clothes for the usual examination and found behind a door a two foot high stack of political booklets aimed at winning Republican support for his endeavor.

William Walsh was unusual in that he entered the practice of medicine after WW II more interested in his public service than in his own practice. He wanted to get a surplus U.S. ship and carry U. S. doctors for temporary duty to foreign lands, equipped with needed medical gear and supplies so that they could berth at one country and set up medical treatment for the very needy in foreign lands without going ashore.

He had the nerve to go down to the White House and ask President Eisenhower for such a ship. And amazing as it was to his friends, he got it. Immediately he went into business. He could persuade doctors to volunteer to leave their regular duties for weeks or months at a time to work on the ship in foreign lands. He also needed money and asked for donations.

I remember the time when he was summoned to the Mayflower Hotel by U.S. Senator Price Daniel of Texas. Dr. Walsh's eyes glistened as he thought of all that Texas oil money. He went to the Senator's room for a chat. He came back so disappointed that he walked up to me, waiting for the result, practically in tears. "Oh, Sarah, I thought we were making out just fine until he asked me 'Now, Doctor, what is your religion and what is your politics?' I had to tell him the truth, that I was a Catholic (the Senator was a well known Baptist) and a Republican. I guess I will get nothing now."

But William carried on most successfully bringing medical help to the deformed, the sick, the wounded, those with terminal cases, the malnourished.

Then one day I called up for an appointment and was told that William Walsh was no longer going to practice medicine. He was going to devote his full time to the Hope project. I felt very much alone but I could understand and applauded him. Thus he worked hard until his death. Now I am very grateful that his people have elected to keep on with his Project Hope.

NO. 6. WHAT IS PRESIDENT CLINTON'S PLAN FOR THE COUNTRY? He told about it at a Democratic National Committee dinner on June 16, 1997.

"And I wrote a little answer down, and I have said it a thousand times since then. And every single day I think about it. I want my country to be a country where the American dream of opportunity is alive for every person, not just some. I want all citizens to be good, responsible citizens and assume the responsibilities of citizenship. I want the United States to lead the world for peace and freedom 20, 30 years from now, just like we are today. And I want us to live together as one community where we respect, we even celebrate our differences, but we're bound together as Americans.

"Now, those are the things I want. And I wrote it down over 5 years ago, and I've stuck with it ever since. Way back in 1991, before I made the decision to run for President, I said -- nearly 6 years ago, now -- I said, 'No point in me running unless I've got a better reason than I'd like to live in the White House.' [Laughter] What will I say when people say, 'What do you want to do? Why are you doing this?' And every single day I think about it."



Washington, D.C. -- How a large part of the nursing home industry in the United States is inflicting a starvation diet on its inmates as well as bed sores, unchanged linen and a minimum of nursing care has up to now remained undisclosed because the elderly do not talk about this when their relatives visit.

An 82-year-old woman, Virginia Merrill, Santa Cruz, Calif. used a torn muscle in her leg as an excuse to live inside a nursing home long enough to explore what was happening to quiet oldsters in what she terms these "death camps." She is now convinced that many nursing homes -- of course not all -- are charging \$3000 a month, more or less, for patients yet are administering such minimal care that the system leads to misery in bed and earlier death than normal. She withheld the names of some homes she has inspected to avoid blame for staff because the aides were paid so little and forced to work such long hours that they could not provide the top-ranking care the patients deserved. For example, in one place, she found two nurses for 92 patients. This despite the fact the Health Services office of the Department of Health and Human Services claims now that a law passed in recent years specifies how many patients must be assigned to one nurse.

Mrs. Merrill feels that regulations prescribing standards of care are not enforced although federal and state regulations abound. Other observers fault government bureaucrats with not knowing what actually goes on in nursing homes. Visiting doctors, she says, sit at the nurse's desk, read the charts and write 'continue care'."

Mrs. Merrill, who organized groups of citizens to seek improvements in the situation and who is busy following court suits that have resulted from ill treatments, calls the nursing home situations "a national scandal."

X Thus I used this term in asking President Bill Clinton at a recent press conference how the government can overturn this highly serious situation. Much to my surprise, he expressed knowledge of the need and said that the Department of Health and Human Services is now working on the matter and that in about three weeks he expects to make some announcement about meeting the problem. His reply made me very happy and surprised Mrs. Merrill while many in the public thanked me for asking that question. X

Here are some of the conditions which Mrs. Merrill found in her thorough "investigations" of what is happening in nursing homes:

She has many death certificates from 100 California nursing homes which show deaths from starvation, malnutrition, dehydration, renal failure due to lack of water, fractures of many different bones, legs, arms, pelvis, concussion from falls when these feeble people try to go to

the bathroom by themselves or try to make it to the dining room for their food. Such fractures result in the patient becoming totally bedridden while fractures heal. They then are ignored, have no changing of positions in bed, and soon develop pneumonia and die.

Nursing homes charge patients' families for many additional alleged services. Mrs. Merrill says the nursing homes charge for walking the patient to the bathroom or dining area, calling this "physical therapy." They bill for dressing the patient, for bringing in carts, for medications. "False charting in nursing homes is the way of life," she says. Such charges add greatly to the profits of owners.

Bedsore are a frequent find. Some of these are so large as to enable one to see the bone. One patient had maggots in her bed sore. It takes 24 hours for maggots to develop, proving that there was no treatment during that time. This case was taken to court and a fine of \$24,000 assessed but the fine was appealed. "State Licensing and Certification agreed with the facility, that maggots may be beneficial to wound treatment," says Mrs. Merrill. "Show me the physician's orders for maggots... Yet the fine was dismissed. No penalties."

Another fine was dismissed for dropping a patient four feet from a hooyer lift while transferring her from her bed to the wheel chair. Fine dismissed when Licensing and Certification said the Patient "was old and had brittle bones."

These nursing homes often use the phrase "it's the patient's fault" and "they are old and prone to have these conditons."

The death records obtained by Mrs. Merrill in California cover only a few months of the year. "Can you imagine the total number of deaths occurring due to this neglect, abuse and murder if we had them all," she said. "Times this number by the number of states in the union. We have long surpassed the number of Jews Hitler destroyed. Yes, it is happening across this country. I can get you in touch with advocates from several different states, the stories are the same."






He was an advisor to Presidents Jimmy Carter and Lyndon Johnson. He once did some personal diplomatic work with North Korea. He is a loyal Democrat

Dear Judge Edwards:

The enclosed complaint against Judge David B. Sentelle is submitted pursuant to Section 372(c) of Title 28 of the United States Code.

The complaint details a pattern of behavior in three separate cases where Judge Sentelle concealed the fact that he was personally acquainted with the individuals involved in the litigation.

In the case where Oliver North's convictions were overturned, the judge failed to indicate that North's network during the Iran-Contra affair was working with the same North Carolina political network that the judge had worked with for over a decade.

In the Confederate case, Judge Sentelle failed to indicate that he was personally acquainted with those named in that complaint. In addition, the judge knew that the Internal Revenue Service was investigating the Coalition for Freedom for tax evasion because it had used its non-profit status for political activity. The same law firm that set up the Coalition for Freedom also set up North's non-profit Freedom Alliance. In addition, this was the same law firm that represented the Confederate Memorial Association, which was trying to comply with the law by remaining non-political.


And the ruling on the new independent counsel puts the judge in the awkward position of having thwarted the investigation of his political allies who were involved in financial improprieties with MetroBank in North Carolina, while ordering a more vigorous pursuit of Madison Savings and Loan, the Arkansas institution where politicians of a different stripe are involved.

NO. 1. U.S. NOT PREPARED FOR WAR. U.S. soldiers and airmen are not prepared for combat should war break out, a combat veteran and long a Pentagon watcher said here. Carl Barnard, widely experienced Defense consultant, told the McCleendon Study Group at the National Press Club that the Congress has approved spending billions of dollars (which the Defense Department had not requested) on new aircraft, ships, tanks while cutting back on military personnel.

Skilled lobbyists for certain big defense contractors have "sold" the Congress on letting contracts which will increase the national deficit, he said. "We are acting like the Cold War is still going on when our enemy, the Soviet Union, no longer exists," Barnard cited.

NO. 2. NO SOCIAL SECURITY REFORM BILL THIS YEAR. The reason is that Social Security is such a sensitive area that no member of Congress, especially no Republican, wants to have his name and career associated with it. This from Evelyn Morton, legislative

representative for the American Association for Retired Persons. She handles Social Security, Supplemental Security Income and federal retirement systems for the Association.

She says that Social Security is not in as much current danger as has been painted for the public. SS, as it is known today, she told the McClendon Group, will be functioning at least until 2007. She says the system of Social Security carries several other beneficiary programs for the citizen besides social security. If people were investing their retirement money privately they might fall into three factions: those who would invest profitably with knowledge of stocks, those who would not invest it but spend the money now, and those who would become victims of unreliable advisors about investments. She suggests that people should keep the social security system as it now exists and in addition have their own separate retirement plan as well as governmental social security.

NO. 3. THE MR. AND MRS. CLINTON ADMINISTRATION will be remembered in history for fixing national attention on children, on their education, grades, scholarship, teachers, health, insurance, hunger, parents, foster parents, home care, potential opportunities. On all of these the Clintons have focused national attention such as never before. Children are so much in the news now that one sometimes wonders if the Clintons have forgotten about adults. Don't they need major attention also?

NO. 4. THE REDEDICATION OF THE WOMEN'S SUFFRAGE STATUE. The rededication of the statute commemorating women getting the right to vote was more than an artist's rendition of the heads of three outstanding women leaders in that fight. That ceremony, held in the Capitol as the statue was brought forth from the basement after 75 years to be put in a place of prominence in the Rotunda, was to women a combination of their victory, so far, in achieving voting rights but also a symbol of what other rights the women yet hope to attain. Women came from all over the country. Many wore white as if it were a wedding day. Several wore costumes dating from the lives of Susan B. Anthony, Elizabeth Cady Stanton and Lucretia Mott. There were frequent references in speeches made to mothers, grandmothers and great grandmothers. Relatives of those in the statue were recognized. Ladies were asked for a show of hands if they had any connection with anyone who worked to get women the right to vote. When I was six years old, 81 years ago, I went out with my mother, Mrs. Annie McClendon, as she made suffragist speeches in neighboring towns in East Texas to get women the right to vote.

The interesting thing about the statue and where it is placed now in the Capitol is that it represents to women many different types of struggles. It immediately conjures up in the minds of these women, abuse of women, no equal pay for equal work with men, sexual harassment on the job and otherwise, discrimination in jobs, ratings, accessibility, abandonment of women with children by departing husbands, lack of child support, lack of promotions on jobs, in military and in professional levels, exclusion of women from certain jobs, organizations and opportunities for advancement. The very fact the statue is there is sure to become an influence for corrections of these ills in the future. I predict it will become one of the most touched statues in the Capitol.
