Laurance S. Rockefeller, who is a leading U.S. conservationist, businessman, and philanthropist, is anxious to have a brief meeting with Dr. Gibbons to discuss the potential availability of government information about unidentified flying objects and extraterrestrial life. As one who has had a long-time interest in environmental and spiritual issues, Mr. Rockefeller, with other leading citizens, is planning to make an approach to President Clinton on this subject.

Prior to such an approach, Mr. Rockefeller would appreciate the opportunity of discussing the issue with Dr. Gibbons in order to make his communication to the President as useful as possible. The basic message to the President is that there is a belief in many quarters that the government has long held classified information regarding UFOs which has not been released and that the failure to do so has brought about unnecessary suspicion and distrust. Many believe that the release of such information, if it exists, on a basis consistent with national security

considerations, would be a significant gesture which would increase confidence in government.

The meeting should take no more than 45 minutes to an hour. Mr. Rockefeller would be accompanied by Scott Jones, President of the Human Potential Foundation, and Henry Diamond, a Washington attorney and long-time associate of Mr. Rockefeller, known to Dr. Gibbons.
