Dear Dr. Gibbons:

From August, 1991 through April 30, 1994, I was associated with the Human Potential Foundation, Inc., part of that time in support of an ostensible effort by Laurance S. Rockefeller to persuade the President to reveal "what the government knows" about so-called "UFO" phenomena.

Actually, I developed and wrote what is now called the *Matrix of UFO Beliefs*, listing my estimates of the situation as well as possible levels of government awareness and involvements in phenomena generically termed "UFOs." Dr. Gibbons, you may recall that among the dozen books HPF president Dr. C. B. Jones (told us he) shared with you (according to the correspondence draft I've included, of April 30, 1993), many were from my personal library with my name in them. I also wrote that "Annotated Bibliography," which Dr. Jones also said he conveyed to you (4/30/93).

As we (my HPF colleagues and I) learned more about what the actual interests and political intentions of Dr. Jones, his benefactor and others indirectly associated with the "White House UFO Initiative" were, we raised our concerns to Jones. His response was to cycle down his foundation, close offices and move it all into his basement in Falls Church. There is much more, but that is not for this venue. Suffice it to say that we know Dr. Jones' and Mr. Rockefeller's interests were not about "UFOs." And given the excellent CRS report about "UFOs" that your former associate, Ms. Marcia S. Smith, prepared for you in 1980 (we suspect to be "covering document" for inquiring Congressmen), I hardly believe there was ever either reticence or unfamiliarity on your part about the underlying topic, as Jones alluded was perhaps the case in his letter to you of April 30, 1993.

1. Essentially, it would appear that Jones and his backers have been "running a discrediting operation" against the Clinton Administration and other agencies of the U. S. government, trying to force disclosures of the underlying "source events" which the so-called "UFO" scenarios have covered...but without exposing the culpable government and non-governmental people and the companies who have been assaulting the bodies and minds of American citizens, and others. In the process, as I'm certain you are aware, Jones and his backers have simultaneously been developing and funding the "Roswell UFO" scam, which has precipitated so much of the past decade's public hoopla, confusion...and from the enclosed copies of conspiracy materials from ostensible "militia" propaganda, more recently abject terror intended to drive "paranoia" and panic among our citizens.

2. Recently, you allegedly released documents and correspondences about Mr. Rockefeller's "UFO" initiative to a Mr. William LaParl, whose locale I have as in Maine. This information was provided to me by a Mr. Dan T. Smith, of Baltimore, a self-proclaimed confidant and asset of Dr. Ronald Pandolfi, described to me (by Jones, Smith and others) as a CIA scientist. I do know Dr. Pandolfi was associated in some way with your own response to Mr. Rockefeller's initiative, both

from my discussions with Dr. Bruce Maccabee (a Navy civilian physicist and "UFO" scammer) and from Pandolfi himself at an August, 1993 meeting (Ron, two of his associates, Dr. Jones and myself). Dr. Maccabee prepared a "UFO briefing" document for you, which was promptly released widely into the "UFO community." The enclosed purported transcript of a telephone conversation Jones had with Dr. Pandolfi, allegedly discussing his (and CIA's) role in supporting your response to the Rockefeller "UFO" initiative, lends further credence. (Jones routinely 'bugged' Pandolfi's calls, according to Jones' former executive assistant. Dr. Jones himself gave me this transcript, for purposes which were not clear to me then, nor presently; I sent it to FBI & CIA months ago.)

3. Allegedly among the documents you released to Mr. LaParl about the "Rockefeller UFO Initiative" were correspondences between Mr. Laurance S. Rockefeller and yourself, as well as exchanges between former SECDEF Melvin Laird and then-SECDEF-Designate Les Aspin. I have included a copy of one piece of correspondence from Secretary Laird to Mr. Rockefeller, which you may not yet have but which came to me in the legitimate pursuit of my duties with the Human Potential Foundation, Inc., when I was Director of Project Development (6/92-2/3/94). You may add this to your files, if you like. I also have a copy of Mr. Rockefeller's correspondence to the Rev. Billy Graham on this topic, informing Dr. Graham of Mr. Rockefeller's intention to encourage the President toward an ostensible disclosure policy regarding "UFOs," involving Maurice Strong.

4. In any event, Dr. Gibbons, please send me copies of ALL relevant correspondences about the "Rockefeller UFO Initiative" in possession of the Clinton Administration, beginning with a copy of Laurance's letter to you asking for your meeting (of April 14, 1993) and any subsequent correspondences from individuals or agencies about this initiative and its aftermath. Please include all correspondences, both into and from the White House and associated offices of government, particularly (but not limited to) those to or from: Melvin Laird; Les Aspin; Laurance S. Rockefeller; C. B. "Scott" Jones, Ph. D.; Henry L. Diamond, Esq.; Senator Claiborne Pell; Maurice Strong; the Rev. Dr. Billy Graham; and copies of other correspondences pertinent to the so-called "Roswell UFO" scenario and calls for its "declassification." You are undoubtedly well aware that Dr. Jones, with financial support from his international backers including Prince Hans Adam of Liechtenstein, has contributed heavily to the props and propaganda leading to the public "UFO" outcry, including the "Witnesses to Roswell" video tape produced by Dr. Maccabee's "Fund for UFO Research," and the MIT conference on "alien abductions" which led to that transparent "mind-influence" cover.

5. In your provision of these requested copies to me, kindly do include among them a copy of a correspondence to you (dated around Feb. 13 or Feb. 14, 1994) from Mr. Laurance Rockefeller in which he purports to "turn over" his interests and future "UFO" liaisons with the White House to "Scott Jones and his associates," telling you he (LSR) was for the present deferring a letter directly to the President. Although my colleagues and I were presented with a copy of this letter to you (in draft form), subsequent conversation with (an ex-CIA source) suggest that in actuality Laurance Rockefeller sent a letter directly to the President on this topic. Please include a copy of that letter.

6. And, please include all correspondence to or from you, the President and any other official of government about this topic and the general topics of "UFOs", mind-influencing technologies, radioactive testing on human subjects, declassification and policy/political implications of same and exchanges between the White House and any Members of Congress on these topics, including but not limited to Congressman Steven Schiff (First District of New Mexico). Correspondences to or from your office or any other White House office, including that of the President and Vice

President pertinent to these topics, are what I am also seeking and will be of interest. Please respond before any costs to me are incurred, and let me know where and when I may examine any such documents and correspondence, if you can not or will not simply provide the copies to me.

7. Given the tragic events in Oklahoma City last week, you and the President may be more interested in seeing how these so-called "UFO scenarios," particularly the "Roswell" scenario, are being employed among the other fear-building and paranoia seeding efforts stimulating the various "militia movements." I have already provided this material to appropriate intelligence and military, federal law enforcement and Congressional sources, beginning in October, 1994 (and for which my attorney, Edgar F. Heiskell, III, (Capt. USAF-Ret) of Charleston, WV has copies of all return receipts). Most recently, related documentation has been provided to an FBI source who replied to my October, 1994 submission to Director Freeh of much primary documentation on Rockefeller's "UFO" initiative (and C. B. Jones' intelligence activities outside of government). One attachment is something I recovered only recently, and the FBI is receiving it along with their copy of this letter.

8. And as you undoubtedly also know, in February, 1994, I quietly submitted a great deal of this material privately to another Presidential assistant. A copy of part of that exchange is included. My concerns then, which have been borne out by my subsequent research into these topics ranging from the Jimmy Carter Library (about when President Carter was targeted by these rogue agents of disinformation on the so-called "UFO" topic), and evidence now, center on a network of political blackmailers and *agents provocateurs* who have apparently been far out-of-control for a long time.

9. In the present situation on the surface dealing with "UFOs" and related phenomena, it is clear from evidence that some counterintelligence and mercenary activities, such as the old USAF 1127th's activities (now AFSAC) surrounding Project Moondust, may have been perverted in their more recent contexts to become tools of political embarrassment and societal destabilization. Some of the other elements in this field of inquiry are legacies of out-of-control "mind-influencing," (and political and sexual blackmail of high officials) and appear to be offshoots of the "MK-ULTRA" genre, which went "black" and "non-governmental" after the Rockefeller Commission and Church Committee in the mid-1970s. This makes their targeting of our President even more disturbing.

As you will see from the enclosed "conspiracy publicity" about a purported "UFO landing scenario", if President Clinton were to have played out what these powerful proponents of this fraud intended for him, it could have put him and his family even more precisely "into the sights" of those to whom this propaganda is targeted and circulated. If we did not have more documentary evidence, (the files and the primary links between Jones, his international backers and the "UFO" scammers), we would not even think of bringing these issues forward. But the evidence is clear that this "conspiracy" was not generated among "militia" organizations or their frightened "patriot" followers. We are seeing a very public demonstration of "psychic driving," by professionals!

Dear Jack:

At the end of our meeting on the morning of April 14, I asked if it would be helpful to you if I provided an annotated list of books important to the subject we discussed. You answered yes, but requested that I keep it a short list. That turned out to be a challenging task. At the present time the field is disordered. "Evidence" is what various researchers and authors say it is. Additionally, there is a wide range of possible explanations being offered, and most of these cross multi-disciplinary lines. Help is needed to bring rigor to the field. Confusing, incomplete and shortage of data is only one problem. Who inside or outside of government is comfortable or competent to attempt to apply the scientific process to phenomena that frequently has a spiritual aura more than physical reality to it?

We did come up with a "short list" of eighteen books. Many other germane works were excluded to keep it that short.

Not only is the annotated bibliography attached, but the eighteen books also have been provided. This was done simply to assist you. It is not a signal that we think something immediately is going to happen in this area. We would appreciate the return of the books when you are through with them, and fully understand and accept the normal risks associated with loaning books. They are all currently in print and easily replaceable.

Additionally, four letters are attached that will help put the purpose and background of the meeting in focus, and suggest why we anticipate working with you on this subject in the future. The letters are:

- o Melvin Laird to Les Aspin, January 8, 1993, requesting a review of classified space programs with the intent to declassify some of the material.

- o Melvin Laird to Laurance Rockefeller, January 28, 1993, in which he states that Aspin feels that the issue should be coordinated through the office of the president's science advisor.

- o Les Aspin to Melvin Laird, January 14, 1993, acknowledging that he had received the letter on the classification issue.

Additionally, there have been private conversations between these principals and others that have been more direct to the specific issue than the words in the letters suggest.

Finally, there is a draft letter to President Clinton requesting that he take specific action on this subject. There is a very important attachment to this letter. It is entitled "Potential 'Estimates of the Situation.'" This document is important because it lays out the spectrum of six current main ideas which might explain what is going on. The annotated bibliography is keyed to this list. This document also provides four possible government levels of awareness, involvement and/or control of the phenomena. Again, these are addressed in the books we have provided.

The draft letter to the president clearly states where we think we are and proposes a way to move forward in a responsible fashion.

Jack, we don't know what is going on that thousands of observers in the last forty plus years have tried to describe. And the richness of the issue is that this phenomena has been in literature and art for hundreds of years.

You have extensive experience in handling complex issues of politics and science and technology. This one may be the Mother of such a situation. No matter how vexing or distasteful it may appear, I don't think we can or should try to walk away from it. We probably have more time, and right now more knowledge, to deal with this subject than you do. Do you have any suggestions for us? Are there people you know we should be talking to?



R: Hi, Scott

S. How are you today, sir?

R. Okay, very good.

S. Returning your call from yesterday.

R. Oh yes, yes, exactly. Ah, well, you know we had been tasked a couple of days before the proposed visit of Laurance Rockefeller with the White House Science Advisor, to provide a briefing update to him -- and we didn't do that, instead we tasked out friend Dr. Maccabee to do it. He did an excellent job and I was wondering whether you had seen it when you were over there?

S. No.

R. Okay

S. Bruce, of course is quite knowledgeable, but why didn't you guys do it yourselves?

R. We didn't have the material here to do it on that short of notice, didn't have any reference material in the file records, and Bruce had already taken a shot on something fairly similar. We worked with him on it and he did a fairly professional job like you would do a briefing for a President. He had one and a half pages of bulletized notes, and then tabs going back to paragraphs on each of the main points, and then further tabs going back to the original source material.

S. Did you get feedback from Bruce and/or Jack on that briefing, or from both of them?

R. Bruce was not at the briefing so he knows nothing at this point.

S. I thought that Bruce presented the briefing.

R. No, no, it is a briefing book.

S. So Jack had not seen that book before we got to him.

R. He supposedly had. He got it the night before, and he claimed he read it either the night before or early that morning. Kit was supposed to meet with Jack yesterday and supposed to give us some guidance today if there is any additional follow-up or what

his reactions were.

S. Do you want to work separately or together on this?

R. If you want a copy of the briefing book we could send one to you - it is unclassified, and maybe give you some heads-up on what he is doing. My guess is that he is not going to do anything. He seemed to be fairly adverse to this whole subject.

S. What he told me, I've known Jack for eight years, I was not surprised at what he told us during the time we spent with him. He said that he had no information on this, no personal knowledge, and was not read into it, doesn't know the literature. I think that is a true statement. My assessment is that he was not at ease with the subject when we were talking about it. That also did not surprise me. He declared to us that he was an agnostic, that if there was some evidence there he would be glad to look at it. But at this point he has no knowledge of such evidence.





Dear Sir:

I contacted your office, but was unable to flesh out my reasons for contacting you over the phone. I hope this letter clarifies things a bit.

My name is Donna Rice-Bassett. I am currently involved in Dr. John Mack's research into "abductions" as a research subject, and treasurer of his non-profit organization, GRAA. I will also be taking over the publication of the newsletter to the "contactees" and putting together a quarterly magazine for this group in the very near future.

Your name has come up in a very odd way in the course of my contact with John. This seems to indicate some interest on your part which John and others in MUFON wish held at arms length due to your very obvious government connections.

A majority of us who have become John's principle subjects have similar government connections, either past or present. This sub-group feels that what is going on here is questionable, especially since our various positions have included contact with secured materials and/or activities.

John is a very nice fellow, but he refuses to see the significance of what is surfacing in some of these hypnotic regressions: i.e., that several of us have been used as tools to cause key figures to act or think in very specific ways.

* We have termed this ability "overlay". It seems to be some sort of survival characteristic which causes another person to essentially think he is in the company of a friendly "twin". This situation allows us to extract specific information or to manipulate the individual emotionally by generating feelings that the person cannot keep out, because, in essence, they are his own.

* My discussions with persons involved in the Naval DNA testing studies has shown that at least 1% of the American population is genetically similar in ways that communities in other countries who have been inbreeding for centuries cannot duplicate. This is a puzzle.

* In 1973, I had a small, metal object taken out of a sinus cavity by a doctor involved with a government research facility. This object was quite an enigma. I allowed genetic testing to be done as a follow up and was told that I "was a study in recessive genetics". This seemed to explain the presence of this object to some degree, although the specifics were rather vague at the time.

After my discussion with the Navy, I now must conclude that it is entirely possible that this country contains a higher than average percentage of these so-called "contactees". I believe the 1% figure may well be a marker confirming our existence.

That this group has a mind-control capability is becoming increasingly evident as a result of John's research. That he refuses to see the dangers of such a group being put to use by unidentified sources is also evident.

We had hoped that you might be able to offer us some advice on this matter. We have not advised John regarding our attempts to contact you. We trust that you will respect that situation.



THE MAN FROM OUTER SPACE

Harvard psychiatrist John Mack claims that tales of UFO abductions are real. But experts and former patients say his research is shoddy.

THE YOUNG MAN HAD SLOWLY BECOME aware of his enigmatic memories, of otherworldly beings lurking in his life, of "strange coincidences" and time out of joint. What was happening? Who could tell him? Casting about for help, says the boyish Pennsylvania health-care worker, "I saw this article in the newspaper about Dr. Mack. And I thought if you can't trust a Harvard professor, who can you trust?"

John Mack is more than a Harvard professor; he is a respected author (his book on T.E. Lawrence, *A Prince of Our Disorder*, won the Pulitzer Prize in 1977), a psychiatrist who helped found the clinical psychiatry department at Cambridge Hospital and a noted scientific advocate of environmental and antiwar causes. Under Mack's hypnotic guidance, the young man "remembered" being abducted repeatedly by aliens, taken to a spaceship and having a probe inserted in his anus. He also recalled past lives, including one as a young Indian warrior called Panther-by-the-Creek, who died in battle. Even more

astonishing, Mack believed every word.

The story of "Dave Reynolds" is one of 13 recounted by Mack in his new book *Abduction* (Scribners), the result of his study of scores of "experiencers," people who he believes have come in contact with extraterrestrial visitors. The striking similarity of their memories and Mack's academic reputation have led UFO believers to proclaim *Abduction* as the most important step yet in scientifically validating abduction experiences. A 1991 Roper poll found that 4 million people have had at least some abduction-related experiences, such as seeing unusual lights or missing time. "Until John came along, there wasn't enough credibility for this subject to support a methodological investigation," says Caroline McLeod, Mack's research chief. "Until now, if you decided to research alien abductions, you risked being pigeonholed as a lunatic."

Psychologists and ethicists do not question Mack's sanity so much as his motives and methodology. They charge that he is misusing the techniques of hypnosis, trying to shape the "memories" of his subjects to suit his vision of an intergalactic future, and very possibly endangering the emo-

tional health of his patients in the process. "If this were just an example of some zany new outer limit of how foolish psychology and psychiatry can be in the wrong hands, we'd look at it, roll our eyes and walk away," says University of California, Berkeley, psychologist Richard Ofshe. "But the use of his techniques in counseling is substantially harming lots of people."

The scientific skepticism is bolstered by some unusual firsthand evidence. One of Mack's "experiencers" has revealed to *TIME* that she was actually an undercover debunker who worked her way into Mack's confidence and rose high in the ranks of his subjects. She found that Mack's work was riddled with scientific irregularities; it lacked a formal research protocol as well as legally required consent forms that advise research subjects of potential risks. She also discovered that Mack billed the insurance companies of at least some patient-subjects for what he described as therapy sessions.

Mack says he expected the disbelief that has greeted the bizarre tales recounted in his book. "This isn't supposed to be," he explained to *TIME*. "You aren't supposed to have little guys with big black

eye-king men, women and children agat their wills on beams of light through walls and windows into strange cr,t and have this going on all over the country." But after hearing dozens of such stories, Mack concluded that the abductions were real. Moreover, he discerned a motive behind them: the abductors, it seems, were implanting mind-to-mind messages urging better care of the planet. The aliens' apparent objective was an intergalactic breeding program combined with a brotherly warning of impending doom if the earth doesn't change its warlike and ecologically wasteful ways.

Mack's studies are largely funded by a tax-exempt, nonprofit research organization that he founded in 1983, now called the Center for Psychology and Social Change. With headquarters in Cambridge, Massachusetts, the center was started as an attempt to study the nuclear arms race in psychological terms. After the cold war ended, the organization started raising money for scholars who want to combine psychology with such topics as ecology and ethnic conflicts. Explains the center's executive director, Vivienne Simon: "One of our main goals is to challenge current scientific method, which is to deny all things you cannot reduce to statistics."

Donna Bassett's story seemed to fit right in with that goal. Bassett, 37, then a Boston-based writer and researcher, became interested in Mack's studies after hearing complaints that he was "strip mining" the stories of emotionally distraught people and failing to help them with follow-up therapy. After reading stacks of books and articles on UFO abductions, Bassett made up an elaborate story of otherworldly encounters involving her family, going back to the 11th century. Her great-grandmother, she said, saw "little people," whom she called angels from God. Bassett herself saw "balls of light" around her house at age five. She also said that as a child she had a space-alien friend named Jane, who healed her hands after a neighbor stuck them in boiling fudge to punish her for snooping.

Bassett participated in three hypnotic-regression sessions (she says she used method-acting techniques to fake her way through them) and eventually served as treasurer of an abductee support group that Mack organized and ran. "I've never seen a UFO in my life," Bassett says, "and I ain't haven't been inside one."

Bassett, who made extensive tapes and life in the UFO cult, says Mack with UFO literature to read

prior to her sessions—a practice that medical hypnotists say will almost surely influence hypnotic revelations. During the sessions, which Mack held in a darkened bedroom in his house rather than in a neutral office, he asked leading questions that reflected his biases. "John made it obvious what he wanted to hear," says Bassett. "I provided the answers." Among other recollections, she told of an encounter with John F. Kennedy and Nikita Khrushchev on board a spaceship during the Cuban missile crisis. Bassett said Khrushchev was cry-

But what of the surprising consistency of the stories Mack elicited? "Dr. Mack is ignoring the high level of suggestion and imagery that surrounds the way in which he deals with these people," says Fred Frankel, 70, a Harvard Medical School professor and psychiatrist in chief at Boston's Beth Israel hospital. "Hypnosis helps you regain memories that you would not have otherwise recalled . . . But some will be true, and some will be false. The expectation of the hypnotist and the expectation of the person who is going to be hypnotized can influence the result."


To many experts, the abduction scenarios bear a striking resemblance to stories of satanic rituals and child abuse—stories that can be shaped by all sorts of outside influences, from movies and TV shows to the suggestive questioning of a therapist. Says Ofshe, who is an expert in hypnosis: "If you convince someone they've been brutalized and raped, and you encourage them to fully experience the emotions appropriate for this event—and the event never happened—you've led them through an experience of pain that is utterly gratuitous."

Confronted by TIME with the news that Bassett had faked her abduction experience, Mack declined to discuss her case, though he hinted that he had doubts about her reliability. (Hers is not among the 13 case histories recounted in his book, but tapes of her sessions leave little doubt that Mack took her seriously.) In general, he insists, there is no evidence that the core memories he elicited are distorted.

"When [the subjects] talk about this—and other people in the room with me have witnessed this, including several psychiatrists—the experience is that of a person who has been through something deeply disturbing." While acknowledging that he is not "an expert on hypnosis," Mack scoffs at the debunkers. "The attacks on hypnosis didn't begin until it began to reveal information that the culture didn't want to hear."

Mack's view of the UFO phenomenon reflects a larger philosophical stance that rejects "rational" scientific explanations and embraces a hazier New Age reality. "I don't know why there's such a zeal to find a conventional physical explanation," he says. "I don't know why people have such trouble simply accepting the fact that something unusual is going on here . . . We have lost the faculties to know other realities that other cultures still can know. The world no longer has spirit, has soul, is sacred. We've lost all that ability to know a world beyond the physical. . . . I am a bridge between those two worlds." ■

ing and that "I sat in his lap, and I put my arms around his neck, and I told him it would be O.K." Hearing her tale, Mack became so excited that he leaned on the bed too heavily, and it collapsed.

Later, at a support-group session, Bassett confronted Mack about mixing research and therapy. According to Bassett, Mack billed insurance companies for some support-group sessions, claiming they were "therapeutic" rather than "research." Yet some members of the support group complained about the lack of therapy following their traumatic hypnosis sessions. "That I can't do everything that each person needs does not mean that what I'm doing is not therapeutic," Mack said. "There are too many of you, and I'm also doing research."

Bassett's account is supported by others who had close encounters with Mack. "He had a hidden agenda," says Dave Duclos, who left the experiment when he became disenchanted. "He was against anybody who said anything negative about the aliens. Once he said to me, 'If you think the aliens are bad, Mr. Duclos, keep thinking about it until you realize they are good.'"
