Dear Dr. Gibbons:

Anticipating yours is the appropriate office to contact, I request the following information about the referenced topic as it was announced and discussed at the White House press conference yesterday, (Friday, March 28, 1997). If yours is not the correct office for this please direct me to it.

Please either have sent to me or inform me about how and where I may efficiently obtain:

- \* the complete press release and all associated background information that was distributed during the press conference conducted by Energy Secretary Fred Pena, Assistant Energy Secretary Tara O'Toole and Assistant Attorney General John Dwyer, held at the White House (March 28, 1997).
- \* a copy of the complete report of the *President's Commission on Human Radiation Experiments*.
- \* a listing of the members and staff of the Human Radiation Experiments Commission, including the Executive Order which created it and a chronology of its schedule and meetings, hearings and all other activities conducted by members and/or staff of the Human Radiation Experiments panel.
- \* copies of legal documents describing settlements with all the various "classes" of victims and/or their survivors as were discussed by Dr. O'Toole and Mr. Dwyer at the press conference yesterday.

On a personal note, Dr. Gibbons, no doubt you are considering the recent tragic events near San Diego, in which bizarre belief-promotions of so-called "UFOs" has played a central role. This resonates with our previous exchanges, (i.e., my heads-up to you, via Phil Lader), about what Dr. Kit Green terms "myth-making" by cultists and culture-change agents employed in ongoing efforts by Laurance Rockefeller, with his attorney Henry Diamond and former Pell aide (and intelligence "rogue") C. B. "Scott" Jones, to involve President Clinton in their "UFO disclosures" initiatives.

Scott's misstatements and "disinformation" about me and my motivation notwithstanding, I hope you might now agree that the kinds of "psychiatric experimentation" and socio-cultural "mind change" initiatives as still advocated by Laurance, Prince Hans Adam of Liechtenstein, Dr. Jones, Dr. John Mack at Harvard, Dr. Willis Harman and Captain Ed Mitchell, at their Institute of Noetic Sciences, are *neither* benign nor beneficial "to our planet" or to America's people *and* our nation.

That some of this kind of misguided mind-set and hubris underpinned unfortunate "Human Radiation" research is instructive. This is a primary reason for my request for this information and I hope your office will be cooperative so that a broader public discussion might ensue. What I hope the White House *will* consider, in terms of promoting better understanding of how these powerful "mental viruses" are generated and spread through a culture, is a *public* conference on these issues.
