

This is in response to your request dated March 3, 1999, received in this office on March 10, 1999 under the Freedom of Information Act, 5 U.S.C. § 552. Your request to the Office of Science and Technology Policy (OSTP) sought "...all UFO-related documentation generated between Dr. John Gibbons, Laurence Rockefeller, Dr. Scott Jones, the U.S. Air Force, GEPAN, Dr. Jacques Vallee, and for Defense Secretary Melvin Laird, circa 1 March 1993 - 31 December 1995."

In response to your first request, we have located twenty-three (23) responsive documents, which are enclosed.
