BILL'S UFO INTEREST IS SAUCER FULL OF SECRETS AT THE WHITE HOUSE

WELCOME to the great White House UFO cover-up.

All the president's men seem quite embarrassed by the revelation - from disgraced First Pal Webb Hubbell - that President Clinton asked him to use his top Justice Department post to find out if UFOs exist.

After all, the president as UFO maven isn't exactly Clinton's dream image. Some might even find it laughable - remember how Dems tittered over Nancy Reagan's fascination with astrology?

And so, White House spokesman Mike McCurry is doing a full stonewall - he refuses to say whether Hubbell is telling the truth. What is amazing - and appalling - is that the White House press corps is letting him get away with it.

As Hubbell tells it in his new book, Clinton sent him to Justice with this mandate as a personal priority: "I want you to find the answers to two questions for me. One, Who killed JFK? And two, Are there UFOs?"

Lest anyone think this was a jest, Hubbell adds: "He ^Clinton_ was dead serious. I had looked into both, but wasn't satisfied with the answers I was getting."

In fact, Hubbell conceded on CNN last weekend that he was serious enough to ask about UFOs when he met with officials at NORAD, the North American Aerospace Defense Command in Colorado, which monitors satellites and other

objects in the skies.

"They said no," Hubbell reported. Presumably, this was one of the answers that didn't satisfy him.

Hubbell ought to know if Clinton was serious. The disgraced ex-associate attorney general is Hillary Clinton's former law partner and was Bill Clinton's golfing buddy before Hubbell admitted bilking law clients out of \$482,000 and went to jail.

It's easy to see that Hubbell's revelation poses a big problem for the Clinton team.

To confirm it would be to paint Clinton as a bit of a UFO nut (and JFK conspiracy theorist) and invite ridicule from late-night comics.

But it would be dumb and dumber for Clinton aides to call Hubbell a liar. That would hand Whitewater prober Ken Starr a weapon, as he seems to be out to prove Hubbell is lying when he denies the fat fees Clinton aides arranged for him were really hush money.

Besides, Hubbell is loyally insisting - despite a stint in jail and the risk of another one - that the Clintons did nothing at all wrong regarding Whitewater or anything else. That's not the kind of ally whom you want to tick off by calling him a liar.

So McCurry did an all-out stonewall when he was asked if Hubbell is right in saying Clinton has a UFO fascination: "I am not going to respond to the specific things in books that are written."

Huh? "A lot of people are going to write books in the course of the next several years ... I'm just not going to respond to each and every thing that occurs in any of these books," McCurry insisted.

Oh, wonderful. Books are now off-limits - a kind of v-chip to screen out messy questions. Just imagine if Mayor Giuliani insisted he wouldn't

answer any questions about, say, bus advertisements. The press would skewer him.

Or imagine if Ronald Reagan's spokesmen had dared refuse to answer questions on books. After all, Nancy Reagan's astrologist popped up in - what else? - a book. Written by ex-Reagan Chief of Staff Don Regan, who was a known enemy of Mrs. Reagan.

No one would have stood for the no-books nonsense if Reagan's team had tried it. But McCurry did, and only a few members of the White House press corps protested - everyone else just giggled or rolled over and played dead.

Which does show you something about the degree to which the Clinton White House has perfected the art of stonewalling.

The Clintons will be back in New York next week, of course, to pass the cup for still more money for the broke Democratic Party. Word is it'll be a unique Clinton husband-and-wife tag-team effort.

First, on Tuesday night, Hillary Clinton is slated to star at a Women's Leadership Forum. Next day, the president passes the cup.

There's also supposed to be a "message event," but no word on what it might be. That's the supposed policy event on which the White House likes to piggyback fund-raising trips.



Schiff: Roswell UFO A Balloon

GAO: All But Two Documents Destroyed

WASHINGTON -- Two government documents are the only official records remaining of the 1947 Roswell Incident involving the crash of an unidentified flying object, the General Accounting Office reported Friday.

The GAO reported its long-awaited findings on the July 8, 1947 crash of the UFO near what was then Roswell Army Air Force Base.

The report done for Rep. Steve Schiff, R-N.M., drew no conclusions but suggested that there is no further proof that what crashed at Roswell was anything other than a Cold War reconnaissance balloon, as the Air Force stated last year.

For nearly half a century, the mysterious crash has fueled speculation about aliens in the New Mexico desert, Cold War secrecy and a government cover-up.

The report said the Air Force and its predecessor, the Army Air Force, destroyed both outgoing messages and administrative records from Roswell from 1947 through 1949. The GAO report gives no other details.

And after a governmentwide search for documents on the incident, the GAO found two, both of which refer to a balloon crash.

As a result, the signs in the Roswell mystery point to an answer the Air Force supplied last year, Schiff concluded after receiving the report: It was a crash of a

classified Cold War device that triggered the Roswell incident.

"At least, this effort caused the Air Force to acknowledge that the crashed vehicle was no weather balloon," Schiff said Friday, referring to last year's report by the Air Force.

For nearly half a century, the Air Force insisted that the object it originally described as a "flying disc" was really just a weather balloon.

But last year, the service admitted that the Roswell wreckage was probably a balloon launched as part of a classified government project to detect Soviet nuclear weapons. The balloons deployed as part of Project Mogul, as it was known, were no ordinary balloons. They were neoprene structures between 600 and 800 feet tall, designed to probe the atmosphere's highest altitudes.

And though the GAO was careful not to rule out extraterrestrial life on Earth -- or at least in New Mexico -- its few conclusive findings point to the possibility that the crash really was a balloon.

First, though, the service destroyed a lot of records, contrary to its official policy, throughout the late 1940s. As late as 1950, records from Roswell Army Air Force Base are missing, according to GAO.

Schiff, who got the Air Force to acknowledge its Project Mogul as part of his own probe into the Roswell incident, criticized the Army Air Force's destruction of records.

"It is my understanding that these outgoing messages were permanent records, which should never have been destroyed," he said in a statement Friday. Because the outgoing messages from the Roswell base were destroyed over 40 years ago, he said, further inquiry about them is "impractical."

Also, the Army Air Force was required to keep records of air accidents permanently; but it wasn't required to keep records of balloon crashes, possibly explaining why there aren't any.

The GAO did recover a few records, all of which point to some kind of balloon. A July 8, 1947, teletype message from the FBI described the recovery of a "hexagonal disc" suspended from a balloon by cable.

The FBI message, based on Air Force information, had been circulating in UFO circles for years, but, for the first time, the FBI has authenticated it as one of its own, according to the GAO report.

An internal history of the 509th Bomb Group, which recovered the object, notes that the Roswell base was busy answering questions about its initial report of a "flying disc" but says "the object turned out to be a radar tracking balloon."

Perhaps as significantly, the GAO queried a wide array of other government agencies to see if they have been withholding documents about the crash at Roswell. The Central Intelligence Agency, the National Security Council, the White House, the Energy Department, the FBI and the Defense Department were all asked to check for records on the incident.

And except for the FBI confirmation of its telex, as well as the 509th's history, no agency had any documents on the 1947 crash, according to the GAO.

The GAO's document search leaves last year's Air Force explanation of Project Mogul as the most extensive the government has offered on the Roswell Incident.

TEST SITE GAINS CONTAMINATED LAND (AREA 51)

The Energy Department made it official Wednesday: The Nevada Test Site has grown by nearly 200 square miles thanks to some surface contamination from a 1968 nuclear test and President Clinton's signature on a law this year. While department officials took two months to announce the effect from Clinton's signing on Oct. 23 of the Military Lands Withdrawal Act of 1999, the paperwork maneuver changed ownership of the contaminated land, now part of the test site's northwestern fringe, from the Air Force to the Energy Department. The law also allows the Air Force to continue using the 3 million-acre Nellis Air Force Range for the next 20 years.

The change, according to local Energy Department spokesman Derek Scammell, was spurred by the 30-kiloton Schooner nuclear test on Dec. 8, 1968 -- an experiment under the non-military Plowshare program to demonstrate the engineering applications of nuclear devices such as their use in excavating canals and harbors. Surface contamination from that test for the past 31 years has been on land controlled by Nellis Air Force Range. The new law puts a jagged edge on the test site's Pahute Mesa area and keeps the contamination off the Air Force range.

The Nevada Test Site is now 1,573 square miles, or 195 square miles more than its previous size of 1,378 square miles. The change is a 14 percent increase. The test site, 65 miles northwest of Las Vegas, has been the nation's continental nuclear weapons proving ground since 1951. Full-scale nuclear tests were put on hold indefinitely in 1992, but government scientists continue to conduct sub-critical nuclear experiments in a below-ground complex. In the experiments, small amounts of plutonium are detonated but don't erupt into criticalities, or self-sustaining nuclear chain reactions

like what occurs in full-scale nuclear tests. The new law, according to an Energy Department statement, also serves to "correct several land use and jurisdiction misalignments throughout the complex." That means the Air Force takes control over the Energy Department's rectangle around Groom Lake, along the northeastern corner of the test site, which had been used by the Air Force under an agreement that dates back to 1958, when the land was withdrawn from public use by the Atomic Energy Commission, a forerunner of the Energy Department.

The location, also known as Area 51 -- the site of at least one classified airstrip -- has been shown on government maps as a 38,400-acre rectangle primarily in Lincoln County that belonged to the Energy Department but was controlled by the Air Force and had not been shown by the Energy Department as part of the test site. The "misalignments," according to the Energy Department's statement, "had become outdated and inefficient because of evolving mission needs among the Department of Energy and the Department of Defense."

In public comments fielded last year in Las Vegas on whether the Air Force should renew its pact with the Bureau of Land Management to withdraw Nellis Air Force Range from public use to accommodate combat training missions, several citizens urged the Air Force to drop its ambiguous references to activities along the dry Groom Lake bed and name the location in clear terms.

The speakers, Norio Hayakawa, Anthony Hilder and Aaron Johnson, said the Air Force needs to tell the public what really goes on at the mysterious bases near Groom Lake because former workers there have claimed health hazards lurk from materials that have been burned in open trenches such as coatings for radar-evading stealth aircraft.

Congressman Schiff Probing 'Alien Autopsy'

Film Allegedly Of Roswell Crash

It is either the scoop of the century or a very gruesome hoax.

After watching a grainy 15-minute film purporting to show the autopsy of a space alien captured in the "Roswell Incident" in 1947, U.S. Rep. Steve Schiff is unsure.

The New Mexico Republican isn't endorsing the footage, reportedly taken by a U.S. Army photographer on the Roswell Army Air Field in 1947. But he isn't dismissing it as bunk, either.

"There is one thing for sure," Schiff said Tuesday from Washington. "If this is a hoax, it was certainly elaborately done. It looked real to me."

If the footage is verifiable, it would be the first hard evidence that it was a UFO, not an Air Force experiment gone awry as the government contends, that crashed on the range between Corona and Roswell during a thunderstorm in 1947. If the film is a gory hoax, as some UFOlogists say, it would be another blow to the credibility of researchers who believe aliens landed on the Lincoln County plains.

Schiff, who has become Congress' point man on extraterrestrials -- "You've got to be known for something," he says, "but I'd rather it be the crime bill" -- was contacted last month by one of the partners who

owns the film and invited to a private showing.

They popped a videotaped copy of the 16-millimeter film into the VCR in Schiff's office and showed a 15-minute segment.

Lying on a table was a short, stocky figure that appeared to be a female, Schiff said. It was bowlegged and had a distended abdomen, swollen legs and a large head. The figure had six digits on its hands and feet and large eyes covered by black membranes, according to others who have seen the film. Schiff said he did not remember those features.

"It appeared hairless," Schiff said. "And (the footage) was in black and white, but it appeared to be light gray or green in color. It had two arms and two legs. It was humanoid, as they say in the science fiction movies."

The cutting was done with surgical instruments by two people cloaked in protective covering, Schiff said. Schiff, a former Bernalillo County district attorney who has witnessed autopsies, said the cutting, from throat to groin, appeared legitimate although not as deep as he has seen in pathology labs.

The cloaked people removed several organs, which were not identifiable as human, Schiff said.

"I am, in general, skeptical of these things," Schiff said. "This could well be a hoax, but if it was a hoax it was put together with a great deal of thought. It wasn't a couple of people at a party saying why don't we fake an autopsy of aliens."

According to an article in the MUFON UFO Journal last month, Ray Santilli, owner of a London-based film production company, claims to have bought the film -- 15 canisters totaling 150 minutes -- from an Army photographer who was assigned to film the crash site and the autopsy. The man, now in his 80s, claims to have stolen the film.

The film's owner and a television producer who plans to use footage from the film in a documentary set to air in London next month, sought Schiff's counsel for help in verifying the film's authenticity, Schiff said. They told him they had confirmed the film stock dates from the 1940s but had been unable to verify whether the images were decades old or new.

Schiff said he is looking into government technology that might accomplish that.

"I would like to think that this film could be authenticated or debunked based on our technology," he said.

Debate over the authenticity of the footage has raged in UFO publications and in UFO newsgroups on the Internet. "Roswell Incident" researcher Kent Jeffrey, who wrote the MUFON article, says the film is obviously

faked, with the autopsy being performed on a doctored human corpse.

Schiff said the subject didn't appear to be a mutilated corpse, although he acknowledged it could have been constructed of "various objects" that resembled tissue on film.

Schiff, who sits on the Science, Space and Technology Committee and is a member of the congressional space caucus, entered the UFO fray two years ago. After hearing from frustrated constituents who wanted answers from the Pentagon about the "Roswell Incident," Schiff asked the Air Force to declassify and provide him with all its relevant material. When the Pentagon referred the congressman to the National Archives instead, Schiff smelled a cover-up and called in the General Accounting Office to look for documents and investigate whether the Air Force kept adequate records relating to the incident.

Almost immediately, the Air Force issued a short report claiming the debris was part of Project Mogul, an experiment that used airborne balloons and sensors to detect future Soviet nuclear blasts by monitoring sound waves in the atmosphere.

Schiff said he expects the GAO report, which is overdue, to be released soon.

Meanwhile, the Fox television network has purchased the American rights to the purported autopsy reels and is bringing them to Roswell next week for a private viewing.

Walter Haut, the public relations man who wrote the original "flying disks" news release for the 509th Bomb Group and now heads the UFO Museum in downtown Roswell, will watch the film in a viewing room at the museum on Monday, he said.

Haut says he's open to viewing anything, although he doubts he can make any definitive conclusions.

"I don't endorse anything," Haut said. And, he says, that in years of viewing purported footage of alien spacecraft and aliens, "I haven't seen any film that is not challengeable." □
