BILL'S UFO INTEREST IS SAUCER FULL OF SECRETS AT THE WHITE HOUSE

WELCOME to the great White House UFO cover-up.

All the president's men seem quite embarrassed by the revelation - from disgraced First Pal Webb Hubbell - that President Clinton asked him to use his top Justice Department post to find out if UFOs exist.

After all, the president as UFO maven isn't exactly Clinton's dream image. Some might even find it laughable - remember how Dems tittered over Nancy Reagan's fascination with astrology?

And so, White House spokesman Mike McCurry is doing a full stonewall - he refuses to say whether Hubbell is telling the truth. What is amazing - and appalling - is that the White House press corps is letting him get away with it.

As Hubbell tells it in his new book, Clinton sent him to Justice with this mandate as a personal priority: "I want you to find the answers to two questions for me. One, Who killed JFK? And two, Are there UFOs?"

Lest anyone think this was a jest, Hubbell adds: "He - Clinton - was dead serious. I had looked into both, but wasn't satisfied with the answers I was getting."

In fact, Hubbell conceded on CNN last weekend that he was serious enough to ask about UFOs when he met with officials at NORAD, the North American Aerospace Defense Command in Colorado, which monitors satellites and other objects in the skies.

"They said no," Hubbell reported. Presumably, this was one of the

answers that didn't satisfy him.

Hubbell ought to know if Clinton was serious. The disgraced ex-associate attorney general is Hillary Clinton's former law partner and was Bill Clinton's golfing buddy before Hubbell admitted bilking law clients out of \$482,000 and went to jail.

It's easy to see that Hubbell's revelation poses a big problem for the Clinton team.

To confirm it would be to paint Clinton as a bit of a UFO nut (and JFK conspiracy theorist) and invite ridicule from late-night comics.

But it would be dumb and dumber for Clinton aides to call Hubbell a liar. That would hand Whitewater prober Ken Starr a weapon, as he seems to be out to prove Hubbell is lying when he denies the fat fees Clinton aides arranged for him were really hush money.

Besides, Hubbell is loyally insisting - despite a stint in jail and the risk of another one - that the Clintons did nothing at all wrong regarding Whitewater or anything else. That's not the kind of ally whom you want to tick off by calling him a liar.

So McCurry did an all-out stonewall when he was asked if Hubbell is right in saying Clinton has a UFO fascination: "I am not going to respond to the specific things in books that are written."

Huh? "A lot of people are going to write books in the course of the next several years ... I'm just not going to respond to each and every thing that occurs in any of these books," McCurry insisted.

Oh, wonderful. Books are now off-limits - a kind of v-chip to screen out messy questions. Just imagine if Mayor Giuliani insisted he wouldn't answer any questions about, say, bus advertisements. The press would skewer him.

Or imagine if Ronald Reagan's spokesmen had dared refuse to answer questions on books. After all, Nancy Reagan's astrologist popped up in - what else? - a book. Written by ex-Reagan Chief of Staff Don Regan, who was a known enemy of Mrs. Reagan.

No one would have stood for the no-books nonsense if Reagan's team had tried it. But McCurry did, and only a few members of the White House press corps protested - everyone else just giggled or rolled over and played dead.

Which does show you something about the degree to which the Clinton White House has perfected the art of stonewalling.

The Clintons will be back in New York next week, of course, to pass the cup for still more money for the broke Democratic Party. Word is it'll be a unique Clinton husband-and-wife tag-team effort.

First, on Tuesday night, Hillary Clinton is slated to star at a Women's Leadership Forum. Next day, the president passes the cup.

There's also supposed to be a "message event," but no word on what it might be. That's the supposed policy event on which the White House likes to piggyback fund-raising trips.

Recently, a blue-ribbon panel of former French defense officials completed an in-depth study of the scientific, military, and societal implications of UFO reality. Part of their report expressed dismay over the U.S. government's attitude toward the body of forensic/intelligence evidence concluding that some of the reported UFO encounters may well have originated from outer space.

Though certain U.S. officials tend to deny it, much of that evidence appears in UFO-related records amassed by various U.S. intelligence/law-enforcement agencies during the past 50-some years -- records recently accessed via the U.S. Freedom of Information Act. BELFAST, Northern Ireland --**President Clinton** was determined to emphasize children in his visit here. Even if the little scuppers diverted him into the world of **extraterrestrials**.



In his remarks as he lighted Belfast's Christmas tree Thursday night, **Clinton** cited letters that have poured into the White House from young people across the British province.

For instance, **Clinton** said, he had received a letter from a 13-year-old in Belfast named Ryan. And, the president said, he had an answer for the lad.

"No, as far as I know, an alien spacecraft did not crash in **Roswell, New Mexico**, in 1947," **Clinton** said, drawing laughter and perhaps a bit of puzzlement from the throng in the plaza before Belfast City Hall.

Ryan apparently had asked about an alleged incident that is the rage among space alien devotees. At issue is whether the Air Force recovered **alien bodies** from such a crash, performed an autopsy on at least one and then stored the historic remains.

Though the official Air Force story is that what crashed in the desert was an aerial surveillance device used to monitor Russian nuclear tests, **Clinton's** reply was in keeping with the spirit of the youngster's letter.

"And Ryan," the president added, "if the United States Air Force did recover **alien bodies**, they didn't tell me about it, either, and I want to know."

The president might come to regret tangling with this hot issue. Somewhere a supermarket tabloid is probably replating a past cover showing **Clinton** in conversation with a chatty space alien.

Ex-President **Ronald Reagan**, at the time Governor of California, described his sighting of a UFO in 1974 one week later to veteran newsman Norman C. Miller, then Washington bureau chief for the Wall Street Journal.

According to author Doyle McManus, Reagan told Miller:

"I was in a plane last week when I looked out the window and saw this white light. It was zigzagging around."

"I went up to the pilot and said,

"Have you ever seen anything like that?"

He was shocked and he said, "Nope." And I said to him: "Let's follow it!"

"We followed it for several minutes. It was a bright white light."

"We followed it to Bakersfield, and all of a sudden to our utter amazement it went straight up into the heavens."

"When I got off the plane I told Nancy all about it."

His former pilot, Bull Paynter, reveals details of the incident:

"I was the pilot of the plane when we saw the UFO. Also on board were Governor Reagan and a couple of his security people.

"We were flying a Cessna Citation. It was maybe 9 or 10 o'clock at night.

"We were near Bakersfield, California when Governor Reagan and the others called my attention to a big light flying a bit behind my plane.

"It appeared to be several hundred yards away. It was a fairly steady light until it began to accelerate, then it appeared to elongate.

"Then the light took off. It went up at a 45-degree angle-at a high rate of speed.

"Everyone on the plane was surprised.

"Governor Reagan expressed amazement. I told the others I didn't know what it was."

Paynter, who's logged thousands of hours in the sky, says the object definitely wasn't another airplane.

"The UFO went from a normal cruise speed to a fantastic speed instantly," he says.

"If you give an airplane power it will accelerate-but not like a hot rod, and that's what this was like,"

After the encounter, the Reagans reportedly read as much as they could about UFOs.

But later when Reagan was asked if he believed in UFOs, the astute politician with plans for the White House sheepishly said he was neither a believer nor a non-believer.

Pilot Paynter, who now owns a freight airplane in Sacramento, California, says he and Reagan discussed their UFO sighting "from time to time" after it happened.

"But we didn't file a report on the object because for a long time they considered you a nut if you saw a UFO," he says.

Jimmy Carter, ex-President of the USA, and nominated 5 times for the Nobel Peace Prize, in October of '69 witnessed a UFO.

what it was. One thing's for sure, I'll never make fun of people who say they've seen unidentified objects in the sky. If I become President, I'll make every piece of information this country has about UFO sightings available to the public and the scientists."



Dr. Herman Oberth, the father of modern rocketry, is quoted as saying in 1954,

"UFOs are conceived and directed by intelligent beings of a very high order, and they are propelled by distorting the gravitational field, converting gravity into useable energy. There is no doubt in my mind that these objects are interplanetary craft of some sort. I and my colleagues are confident that they do not originate in our solar system, but we feel that they may use Mars of some other body as sort of a way station. They probably do not originate in our solar system, perhaps not even in our galaxy."

The *American Weekly* of October 24, 1954, quoted Dr. Oberth as saying

"It is my thesis that flying saucers are real and that they are space ships from another solar system."

Years later he was quoted as saying,

"We cannot take the credit for our record advancement in certain scientific fields alone. We have been helped."

When asked by whom, he replied,

"The people of other worlds."

Oberth's statement to a group of reporters in 1959 or 1960 upon his retirement is reported in Robin Collyns' *Did Spacemen Colonize the Earth?*, London: Pelham Books, 1974, p. 236. But Oberth wasn't alone in such pronouncements.

Wilbert B. Smith was a Canadian electrical engineer. Following an interview with physicist **Dr. Robert Sarbacher** back in 1950, in which Sarbacher confirmed the existence of crashed saucers and the recovery of alien bodies, Smith got the Canadian government to establish Project Magnet, an attempt to understand and duplicate





flying saucer performance. This has all been well-documented from Smith's notes of his meeting with Sarbacher, confirmation by Sarbacher in the 1980s, and various declassified Canadian government documents.

Smith gave a tape-recorded speech in Ottawa, Canada on March 31, 1958, in which he summarized findings of a two-year UFO investigation, including a series of communications with intelligences claiming to be extraterrestrial and laboratory experiments suggested by these entities that confirmed the validity of their alien science. The transcript of Smith's speech is in "Flying Saucer Review," Sept/Oct 1963, pp. 13-16.

Timothy Good in "Above Top Secret" (p. 205) also noted that Smith wrote an article in 1958 in which he said that contact had been established with the occupants of UFOs and that he had learned a great deal from investigating these contacts. He wrote,

"But it soon became apparent that there was a very real and quite large gap between this alien science and the science in which I had been trained. Certain crucial experiments were suggested and carried out, and in each case the results confirmed the validity of the alien science. Beyond this point the alien science just seemed to be incomprehensible."

Among Oberth's colleagues [or former colleagues] was **Dr. Walther Riedel**, once chief designer and research director at the German rocket center in Peenemunde. After the war he engaged in secret work for the U.S. LIFE Magazine reported on April 7, 1952:

Dr. Riedel has never seen a saucer himself, but for several years he has kept records of saucer sightings all over the world. He told LIFE:

"I am completely convinced that they have an out-of-world basis."

Dr. Riedel has four points to his argument:

"First, the skin temperatures of structures operating under the observed conditions would make it impossible for any terrestrial structure to survive. The skin friction of the missile at those speeds at those altitudes would melt any metals or nonmetals available.

"Second, consider the high acceleration at which they fly and maneuver... In some descriptions the beast spirals straight up. If

you think of the fact that the centrifugal force in a few minutes of such a maneuver would press the crew against the outside, and do likewise to the blood, you see what I mean.

"Third... There are many occurrences where they have done things that only a pilot could perform but that no human pilot could stand.

"Fourth, in most of the reports there is a lack of visible jet. Most observers report units without visible flame . . . and no trail. If it would be any known type of jet, rocket, piston engine, or chain-reaction motor, there would be a very clear trail at high altitude. It is from no power unit we know of . . ."

Also quoted in the LIFE article was Dr. Maurice Biot, leading aerodynamicists and mathematical physicist, who said, "The least improbable explanation is that these things are artificial and controlled ... My opinion for some time has been that they have an extraterrestrial origin."

Senator Barry Goldwater, a retired Air Force Reserve Brigadier General and pilot with many decades of flying experience, was quoted as saying,



"I certainly believe in aliens in space. They may not look like us, but I have very strong feelings that they have advanced beyond our mental capabilities."

He said he was refused permission to check the Air Force files on UFOs and added,

"I think some highly secret government UFO investigations are going on that we don't know about--and probably never will unless the Air Force discloses them."

He said that he put faith in the reports of the Air Force, Navy, and commercial pilots who reported instances where a UFO would fly near them--right off their plane's wing--and then just zoom away at incredible speeds.

"I remember the case in Georgia in the 1950's of a National Guard plane going after a UFO and never returning. And I recall the case in Franklin, Kentucky, when four military planes investigated a UFO. One of them exploded in midair and no one knows why."

"We find ourselves faced by powers which are far stronger than we had hitherto assumed, and whose base is at present unknown to us. More I cannot say at present. We are now engaged in entering into closer contact with those powers, and in six or nine months time it may be possible to speak with some precision on the matter."

Gen. Douglas MacArthur, in a speech given to the United States Military Academy on May 12, 1962 stated,



"You now face a new world, a world of change. We speak in strange terms, of harnessing the cosmic energy, of ultimate conflict between a united human race and the sinister forces of some other planetary galaxy."

"I believe that these extraterrestrial vehicles and their crews are visiting this planet from other planets which obviously are a little more technically advanced than we are here on Earth. I feel that we need to have a top level, coordinated program to scientifically collect and analyze data from all over the earth concerning any type of encounter, and to determine how best to interface with these visitors in a friendly fashion. We may first have to show them that we have learned to resolve our problems by peaceful means, rather than warfare, before we are accepted as fully qualified universal team members. This acceptance would have tremendous possibilities of advancing our world in all areas. Certainly then it would seem that the UN has a vested interest in handling this subject properly and expeditiously.

For many years I have lived with a secret, in a secrecy imposed on all specialists and astronauts. I can now reveal that every day, in the USA, our radar instruments capture objects of form and

composition unknown to us. And there are thousands of witness reports and a quantity of documents to prove this, but nobody wants to make them public.

Why? Because the authorities are afraid that people may think of some kind of horrible invaders. So the password still is: We have to avoid panic by all means."

In another interview he said

"As far as I am concerned, there have been too many unexplained examples of UFO sightings around this Earth for us to rule out the possibilities that some form of life exists out there beyond our own world."

And in an exclusive interview with the *National Enquirer* on 14 January 1997, Cooper speaks openly about alien spacecraft. He says there's been a massive government cover-up of UFOs for nearly 50 years and insists the American public has a right to know the truth.

"I know other astronauts share my feelings," declared Cooper, 69, who went into space aboard a Mercury craft in 1963 and on a Gemini craft two years later.

"And we know the government is sitting on hard evidence of UFOs!"

Cooper said he first encountered UFOs as a military pilot in Germany in the early 1950s, when unidentified craft were spotted over an air base.

"We thought they could have been Russian we regularly had MiG-15s overflying our base. We scrambled our Sabre jets to intercept and got to our ceiling of 45,000 feet . . . and they were still way above us traveling faster than we were.

"These vehicles were in formation like a fighter group, but they were metallic silver and saucer-shaped. Believe me, they weren't like any MiGs I'd seen before! They had to be UFOs."

In 1957, Cooper was one of an elite band of test pilots at Edwards Air Force Base in California, in charge of several advanced projects, including the installation of a precision landing system.

"I had a camera crew filming the installation when they spotted a saucer. They filmed it as it flew overhead, then hovered, extended three legs as landing gear, and slowly came down to land on a dry lake bed!

"These guys were all pro cameramen, so the picture quality was very good.

"The camera crew managed to get within 20 or 30 yards of it, filming all the time. It was a classic saucer, shiny silver and smooth, about 30 feet across. It was pretty clear it was an alien craft.

"As they approached closer it took off."

When his camera crew handed over the film, Cooper followed standard procedure and contacted Washington to report the UFO and "all heck broke loose," he said.

"After a while a high-ranking officer said when the film was developed I was to put it in a pouch and send it to Washington.

"He didn't say anything about me not looking at the film. That's what I did when it came back from the lab and it was all there just like the camera crew reported."

When the Air Force later started *Operation Blue Book* to collate UFO evidence and reports, Cooper says he mentioned the film evidence.

"But the film was never found supposedly. *Blue Book* was strictly a cover-up anyway."

Cooper revealed he's convinced an alien craft crashed at Roswell, N. Mex., in 1947 and aliens were discovered in the wreckage.

"I had a good friend at Roswell, a fellow officer. He had to be careful about what he said. But it sure wasn't a weather balloon, like the Air Force cover story. He made it clear to me what crashed was a craft of alien origin, and members of the crew were recovered."

Why has the government kept its UFO secrets for so many years?

"It started in World War 2, when the government didn't want people to know about UFO reports in case they panicked," said Cooper. "They would have been fearful it was superior enemy technology that we had no defense against.

"Then it got worse in the Cold War for the same reason.

"So they told one untruth, they had to tell another to cover that one, then another, then another . . . it just snowballed.

"And right now I'm convinced a lot of very embarrassed government officials are sitting there in Washington trying to

figure a way to bring the truth out. They know it's got to come out one day, and I'm sure it will.

"America has a right to know!"

"The matter is the most highly classified subject in the United States Government, rating higher even than the H-bomb. Flying saucers exist. Their modus operandi is unknown but concentrated effort is being made by a small group headed by Dr. Vannevar Bush."

On June 7, 1968, **Lee Katchen**, an atmospheric physicist with NASA stated that on the basis of the 7,000 reports that he had examined, he believed UFOs to be extraterrestrial probes.

"UFO sightings are now so common, the military doesn't have time to worry about them - so they screen them out. The major defense systems have UFO filters built into them, and when a UFO appears, they simply ignore it."

When asked for specifics, Katchen specifically singled out the radar network employed by SAGE (semi-automatic ground environmental system), the North American tactical air defense system, which tracks all aircraft flights.

"The filters cut out all unconventional objects or targets and makes no record of UFOs"

"Unconventional targets are ignored, because, apparently we are only interested in Russian targets, possibly enemy targets. Something that hovers in the air, then shoots off at 5,000 miles per hours, doesn't interest us, because it can't be the enemy. UFOs are picked up by ground and air radar, and they have been photographed by gun camera all along. There are so many UFOs in the sky that the Air Force has had to employ special radar networks to screen them out."
