



'MY STEAMY NIGHTS WITH HILLARY IN UFO LOVE NEST'

EXTRATERRESTRIAL AFFAIR: Hillary had some steamy nights with her "rocket man," P'Lod, but it all came crashing to a halt when she found out he was three-timing her.



SENATOR Hillary Clinton's Sautobiography doesn't scratch the surface.

To get the real scoop, read the new book penned by her space-alien boyfriend — pouring his heart out about their steamy love affair!

Six New York publishers are said to be locked in a furious bidding war for the red-hot tell-all, *OUT OF THIS WORLD: My Life as an Alien in Washington*.

One publishing giant offered an unprecedented \$18 million advance for the tale by the space alien P'Lod — who spills his guts about every scintillating twist and turn of the torrid two-year romance, from its fairy-tale beginning to its dramatic implosion.

The handful of insiders who've seen drafts of the book say it's packed with details about the extramarital affair — right down to such tidbits as the sounds the former first lady made during wild, alien-style lovemaking in the cargo hold of P'Lod's UFO.

"As I rubbed my bulbous forehead against Hillary's small, well-shaped, brow, gently at first, then faster and with more vigor, she released a feline mew of pleasure that surprised me with its urgency," P'Lod reveals in the book. "I knew right away this was an Earth woman of enormous passion."

"That night, Hillary proved to be an insatiable head-to-head lover." That the mysterious alien, who's

strived to maintain a low-profile on Earth until now, has suddenly stepped into the limelight, is sending shockwaves through Washington — where his role behind the scenes in U.S. politics has been a poorly kept secret in government circles for more than a decade.

But the publicity-shy E.T., who reportedly ended his relationship with Hillary two months ago, has a good reason for letting the cat out of the bag.

"Hillary has been bad-mouthing him all over town," says an editor at the publishing house closest to sealing a deal on the book. "She's chewed the ears off of every Washington insider who'll listen, telling them how P'Lod 'used' her, then dumped her."

"It's got to the point that government officials are beginning to doubt that he's such a benevolent alien after all. It's threatening his mission here."

"P'Lod wants to set the record straight, tell his side of the story — even if it means finally exposing the extraterrestrial presence on Earth."

It was in our issue that hit newsstands the week of Sept. 11, 2001, that *Weekly World News* first broke the story of the sensational romance — mind-blowing news that was largely overshadowed by the 9-11 tragedy.

Readers were stunned to learn the prim and proper senator from New York was caught with her extraterrestrial beau at a swank Manhattan hotel by her outraged hubby, ex-President Bill Clinton.

A private eye hired by the former commander-in-chief had been following the

lovebirds and took damning photos of them, later leaked to WWN by person or persons unknown.

Hillary first met the E.T. at a fund-raiser in the spring of 1991.

"Our eyes met across the room," P'Lod writes in his book. "We experienced an instant, mutual attraction."

The editor, who requested anonymity, notes: "Hillary might not be a classic beauty, but P'Lod thought her attractive. Her high IQ — for a human — and impressive forehead also appealed to him."

Hillary is said to have likewise found the spaceman's soaring intelligence and lofty morals a turn-on. What's more, she told pals that he displayed lovemaking techniques "thousands of years in advance of any human male."

On several occasions, the rocket Romeo whisked Hillary into orbit aboard his ship, where the pair enjoyed high-flying whoopee in the cockpit, dining hall and even on the floor of the cargo deck, the book reveals.

"Hillary introduced me to human-style lovemaking, which I found satisfying in a primitive way," P'Lod writes. "In turn, I showed her the way my species shows affection. She was a very fast learner."

The relationship soured in June when Hillary learned that the "altruistic" alien was triple-timing her both with a young oil-industry lobbyist and a well-known, slim, blonde GOP strategist.

P'Lod offers a defense for his behavior. "Our species has evolved beyond monogamy," he explains in the book.

"Hillary said she understood this intellectually. But her heart was another matter."

The editor justifies the staggering cash advance offered to the alien — more than twice the sum shelled out to Hillary for her bio.

"This is the first book ever written by a real extraterrestrial — that alone is worth every penny," she says. "Beyond that, it's a riveting love story."

The alien's sexploits with Hillary aren't the only thing in the book.

The 360-page potboiler also reveals why the aliens are here, the true origin of the universe, the E.T.'s ultimate plan for man and other stuff sure to please the egghead crowd.

But it's the out-of-this-world sex that will rock readers back on their heels.

"The descriptions of Hillary's 'close encounters' with P'Lod are incredibly hot," says the editor. "I needed a cold shower after reading Chapter Three."

Sen. Clinton has thus far declined to comment on the upcoming book, which, if the latest offer is accepted, will arrive on shelves by the end of September.

But friends say Hillary feels "betrayed" that P'Lod is exposing her most intimate secrets to the world — and has privately called the book "trash."

Unfortunately, P'Lod's side of the story may never see the light of day. "The Bush administration may kill this book on national-security grounds," says a Capitol Hill source. "Even though P'Lod may think this is a fine time for the aliens to admit they're here, the White House adamantly disagrees."

President can help UFO inquiry

The president's appointment of an independent oversight board to monitor and guide the Defense Department's redress for the victims of the Gulf War syndrome leads me to ask him to appoint another oversight board.

This one would monitor and guide the executive branch's "full, final, and complete" disclosure of all information and artifacts derived from the U.S. military's retrieval, analysis and exploitation of alien spacecraft wreckage at Roswell, N.M., in 1947, near Del Rio, Texas, in December 1950, and at other crash sites worldwide.

By taking this action, he would help fulfill former President Jimmy Carter's pre-election promise to release to the public all federally maintained UFO data.

According to an Oct. 29, 1969, memo by Air Force Brig. Gen. C.H. Bolender, certain "national-security-implicated" UFO reports never were intended to be included in those collected by the now defunct Project Blue Book. Such a diversion and suppression of UFO data constitutes a breach of public trust — and qualifies for appraisal and remedy by a blue-ribbon panel of scientists, legal specialists and academics.

Their oversight function should include the summoning of testimony and other evidence available from a growing pool of UFO-cover-up whistleblowers awaiting a waiver of their secrecy oaths.

Will the president seize the opportunity to do the right thing in defense of the public's right to know (and the government's duty to tell)?





"My hope is that at a minimum someone senior in the administration will make a statement that the area we have been discussing (UFOs) is a reasonable subject of potential great significance to a number of fields. In January 2001, the Clinton White House Office of Science and Technology Policy (OSTP), released to me 991 pages of documents on to a Freedom of Information Request (FOIA) asking for documents related to UFOs, extraterrestrial intelligence, and the Rockefeller UFO Initiative.

The OSTP is one of the few Clinton White House Executive departments that is open for FOIA requests. The other approximately 76.8 million pages of paper documents, 75,000 museum artifacts, and 1.85 million photographs are exempt by law from disclosure or FOIA requests for five years after the end of the Clinton administration, or January 20, 2006.

Based on the UFO records released by OSTP, and testimony of people who were involved in the White House UFO Disclosure Initiative, it is conceivable that there could be thousands of other pages of UFO material in the personal papers of the President and the First Lady, and in the papers of many of the

Extraterrestrial Politics in the Clinton White House: Part 2 - ✓ **Clinton's CIA Director Briefed**

James Woolsey, President Clinton's first Director of Central Intelligence came into the Clinton administration much in much the same way that President Carter's DCI, Stansfield Turner had come into the Carter administration. Woolsey, like Turner had "no substantive experience" in intelligence. What little Woolsey had learned about intelligence, he was taught by his former law partner Anthony A. Lapham, who served as general counsel to the CIA from 1976 to 1979.

Woolsey's ignorance did not create a strong opening position for a man considered "the principal advisor to the President for Intelligence matters related to national security," and who as Director of Central Intelligence (DCI) also served as the head of the United States Intelligence Community consisting of 12 other intelligence agencies. The combined thirteen agencies "carry out all the intelligence activities of the United States Government." These included, among others, the Defense Intelligence Agency, National Security Agency, National Imagery & Mapping Agency, National Reconnaissance Office, Air Force Intelligence, Army Intelligence, Marine Corps Intelligence, and Navy Intelligence.

Consequently, both Clinton and Woolsey were somewhat ignorant on intelligence matters, and were therefore forced to start from zero. Moreover, they were forced to rely totally on George Bush's CIA for the intelligence information they would need to govern. The world view they would develop would be one that was, in part at least, drawn out for them by the CIA, that had been in the hands of a Republican administration for the past twelve years.

Clinton and his running mate Al Gore were given their first briefings by President Bush's DCI, Robert Gates. Gates' boss, George Bush, had likewise done the briefing of then President-elect Carter, when he

The OSTP files showed that 1995 brought with it some new ideas to advance the extraterrestrial hypothesis. The Human Potential Foundation, for example, hosted an international conference: *When Cosmic Cultures Meet* in late May.

Speakers at the Conference were asked to address the "implications, preparations, and response for the time when either or both interdimensional and extraterrestrial cultures come into open contact with cultures of Earth.

The OSTP files document Scott Jones' invitations to a whole list of people including Jack Gibbons, Hillary Clinton, and President Clinton. Gibbons was asked to include in his address comments that "the subject is researchable, should be considered by competent researchers, and that the government will make data available to support the research." None of the three White House invitees accepted the offer. If there was support inside the White House for extraterrestrials, it wasn't going to be open support.

In a February 9, 1995 letter Jones mentioned that for some reason he had been searched out by two sources, and leaked a couple of explosive facts. Jones was told that the "Lincoln Lab has been the site of



THE PRESIDENT: Well, if I didn't, I wouldn't disagree with her in public. (Laughter.)

Q We haven't had a chance to hear what your comment is to the apology that Webb Hubbell and his claim that he was a con artist who fooled people here at the White House. Are you angry at him now? He seems to have caused you a whole lot of trouble, and he seems to be causing it.

THE PRESIDENT: Well, no, I'm not angry at him anymore because he's paid a very high price for the mistake he made. And if he hadn't come up here and he'd stayed home and tried to work it through, he would have paid a price, but it would have been a smaller one.

But let me remind you that everybody pays in life. There's -- somehow we all wind up paying for whatever we do, and he paid a very high price. And he's apologized and I accept his apology. He's got four wonderful children and a fine wife. And he's done a lot of wonderful things in his life, and I hope he'll be able to go on and do some more wonderful things.

And as far as I'm concerned, that's why we have a criminal justice system: people get punished, they pay their price, and they're supposed to be able to go on. He got punished and paid quite a high price, and I hope he'll be able to go on with his life now.

A DISCLOSURE ON THE DISCLOSURE PROJECT

It all started back in March of 1997 when I received a phone call from Dr. Steven Greer's personal assistant Ms. Shari Adamiak. She wanted to know if I would be interested in testifying at a Congressional Briefing for CSETI on my experiences at Area 51 back in June of 1971. The briefing was to take place at the Weston Hotel in Washington, DC on Wednesday April 9th 1997 at 7:00 pm.

I wasn't sure if I wanted to testify on these events for I have been silent on the subject for the last twenty six years. At that time not even my parents (I was seventeen at the time) knew what really happened to me when I left home to go to White Sands to launch my rocket.

After several phone calls by Shari checking in to see if I had decided to go, I then got a phone call from Dr. Steven Greer two days before the briefing was to take place. Steven told me he had one hundred and twenty five hard ware contact people signed up and ready to testify to Congress on their part of the reverse engineering of alien spacecraft and hardware. But the thing that convinced me to go was that Dr. Greer asked me. "What if all these people show up and testify and I was invited and did not go. I would miss out and would never learn the rest of the story because it would be a closed door session to the press and the public." Well that did it, that would be one party I just could not turn down and it all made sense to me. Twenty six years ago I had seen scientists and technicians working on crafts and devices that were so far advanced that they could not have been manufactured by our existing technologies. These people would have day to day work experience of thirty to forty years on these devices making my one day experience seem insignificant. I agreed to come to Washington and testify.

Ms. Adamiak mailed my plane ticket and I flew from Atlanta to Washington and arrived at the Weston Hotel on Tuesday April the eighth in the afternoon. At 6:00 pm all of the witnesses met for dinner at Panevino's with Dr. Greer and his staff. It was at this time the itinerary for the next two days was explained.

The next morning at 9:00 am myself and ten other witnesses along with Dr. Greer and his staff met in a large conference room with twelve chairs in a circle in the middle of the room. This is where all the witnesses would relate their stories one at a time for Dr. Greer. As we went around the circle Dr. Greer took notes and the staff made a transcription of what was said. It was at this time when I learned story by story that no one had any hardware contact except for one man named Steve Lovekin. Steve saw a piece of metal about a foot and half long and it had symbols on it and was he told by his superiors that it had come from a crashed alien spacecraft.

I started to feel like a turkey that had been invited to a thanksgiving dinner. Out of the eleven witnesses nine of them had seen either a blip on a radar screen or lights in the sky, and one person saw a piece of metal. Then there was my story, the one where I was standing on an alien engine the size of a Greyhound bus in an underground top secret Air Force base that doesn't officially exist.

I was disappointed that the hardware contact scientists or technicians that Dr. Greer said he had signed up to testify were not present. It was at this time that I seriously considered leaving the proceedings, not testifying and going back home to Atlanta.

At 5:00 pm the pre-screening process had ended and this is where I had expected for Dr. Greer to ask me to produce evidence that would back up my claims. No one, not even Dr. Greer ever asked me for any evidence although I had a brief case full of documents and pictures with me. It was at this point after Dr. Greer had heard my entire story that I expected for him to say to me that my story was just

too much for him to bring to the briefings. That would have been fine with me because I know better than anyone how far out this story sounds. Instead, out of the eleven witnesses eight of us were picked to speak at the briefings, I was in that group of eight and I felt Dr. Greer really wanted me to testify, so I decided to do just that. The Congressional Briefings were set to start in two hours and I was ready to tell a story that I had been silent about for the last twenty six years.

At 7:00 pm we all met at the Dupont Room of the Weston Hotel and Dr. Greer presided over the proceedings. There were many congressional offices and various agencies represented there that night. Every witness had about five minutes for their presentation followed by a question and answer period that lasted until 9:30 pm. I did my presentation and there was a sincere interest from the audience of wanting to know more and I could tell they were in deed taking this very seriously. The following evening on April the tenth there would be an educational briefing for select members of the press in which they would be allowed to talk to the witnesses. I was asked by Dr. Greer if I would like to participate in this event and I agreed to do so. All the witnesses retired to their rooms for the night.

At ten o' clock the next morning Dr. Greer had a meeting at the Pentagon. At ten thirty I was in my room when I got a knock on my door by several members of Dr. Greer's staff. They told me that I was being moved to another room as they were going about the room physically gathering up my personal things. We went down stairs to the Cameraman's room and I was told this would be where I would stay until I left for my plane back to Atlanta. I asked, "Where is Dr. Greer?". I was told that he would contact me later in the afternoon. I settled in on one of the beds while the cameraman took up a chair near the door and I turned on the TV to wait to see what would happen next. It was at this point I could have started feeling I was being held against my will, but I was so curious about what would happen next that I did not care.

At four pm the phone rang and the cameraman answered it and then handed the phone to me, it was Dr. Greer. I asked Dr. Greer, "what was this all about?" He said that my story was too much for him to deal with in the briefings. Before I could respond with, "what does that have to do with me being detained in your cameraman's room?" Dr. Greer said, "Some of us have had an experience so strange that you don't dare tell anyone. He then told me of an experience that he had where he was abducted by an alien spacecraft and that they had performed a medical examination on him. He was not scared because of his medical training as an ER physician he had a good understanding of what they were doing. Dr. Greer said, "it was because of this experience that he started CSETI so he could reestablish contact with the ETs . (Sean David Morton told me this was the exact same story that was told to him by Dr. Steven Greer.) Then Dr. Greer wanted to know if I wanted to watch the media briefing that evening and if so he would send me some escorts. And I said "Whatever." I was so stunned by this revelation that I hung up the phone and sat back down on the bed and watched TV until it was time to go down to the media briefing. I had time to think about Dr. Greer's story and it made total sense to me. I had wondered what would cause a medical doctor to leave a very lucrative career and go chase after UFOs which is a job that doesn't pay at all. I felt I was in no immediate harm and the only way I could learn more of who or what was behind this was to go along with it. The Cameraman was relieved so he could go film the media event and was replaced by two men of Dr. Greer's staff and Shari Adamiak who would now be my escorts to the media briefing.

We went down to the Dupont Room and upon entering it, there in the middle of the room was a line of cameras facing the opposite end of the room. All of the witnesses (except for me) who spoke at the Congressional Briefing were sitting in a row of chairs in front of the cameras. I was placed in a chair that was on the far side of the room with my back physically against the wall with a man sitting on each side of me and *Shari sitting right in front of me, I was surrounded.

Dr. Greer came in the room and walked over to me put his foot on the chair in front of me and bent down to tie his shoe and asked me quietly. "How are you doing?" I replied "Fine, how about you? He smiled, turned and walked over to the witnesses and began his media briefing. Shari Adamiak then turned and told me not to speak with anyone until I got back to my room.

The media briefing went very smoothly which surprised me given the subject. I had expected the media to be a lot tougher with their questions, they were quite polite. After about an hour the reporters had asked all the questions they seemed to care to and the meeting ended. My escorts then took me straight back to my room where the cameraman took up his original job of being my roommate. Room service brought dinner and then I settled in for the night listening to the cameraman snore like a chainsaw until 6:00am at which time I got up to catch my plane.

After I returned home I tried several times to call Dr. Greer and left messages for him to call me and I never heard from him. It was Dec. 12th 1998 when I met up with Dr. Greer at the Ghost Wolf conference in Las Vegas where we both were speakers at this function. I tried talking to Steven about what happened in Washington, DC but he said he was too tired and too busy to talk about it then. To be respectful and understanding about it I just let it go and he did not look well at the time.

Two and half years passed and I had given up on ever seeing Dr. Greer again until someone e-mailed me a notice that he was going to be in Los Angeles on Sat. August the 4TH 2001 with his Disclosure Project at the Founders Church of Religious Science. During the question and answer session I was number three in the line up. I noticed that Dr. Greer being up on the stage could not see with the lights in his eyes who was at the microphone, so I introduce myself by saying, "Hi Steven, David Adair here." Dr. Greer replied, "Oh, Hi there David." I then said, "You are looking well Steven. You certainly have come a long ways with this project since those days we testified back in April of 97." He agreed and then explained what Congressional Briefings we were talking about to the audience. I then said that I have just a couple of quick follow up questions and he said, "go ahead." "Do you remember Steven, after I testified you invited me to the media briefing the next evening?" He replied "Yes." "Then the next morning at 10:00am you had a meeting at the Pentagon?" He replied "Yes." "Then at 10:30am several members of your staff knocked on my door and physically moved me out of my room and into the your cameraman's room? Dr. Greer replied, "that was my staff doing that." I then asked, "why did they do that?" He replied, "that the staff had some problems with the details of your story." I then said, "Thirty minutes into the Pentagon meeting and I was taken out of my room, did the Pentagon tell you to do this? He replied, "No, you are confusing two issues. They are unrelated." Then I said, "I find this whole thing particularly annoying, that you would not return my calls and force me to come here today and confront you with this in front of all theses good people." It was at this point that the conversation broke down and it was time to leave. Once again Dr. Greer failed to take this chance to explain or apologize as to why I was treated so rudely at the Congressional Briefings in Washington, DC after he invited me.

One can sit and speculate till the cows come home as to why Dr. Greer invited me to the Congressional Briefings, and after hearing my full story at the pre-screening of the testimonies did not say to me that my story would be too much to deal with. If he had said that to me I would be the first to understand and would have thanked him for dinner and went home. The other odd thing was that during all of this no one had ever asked me to produce any supporting evidence. I would also like to know where are all of these reverse engineering hardware contact witnesses that Dr. Greer says he has signed up to testify. Perhaps the biggest question is why did they feel it was so necessary to restrain me for seventeen hours until the conference was over?

We may never know the answers to these questions and that is fine with me. I did not write this disclosure to derail Dr. Greer or his Project or to bring up wild speculation that could never be verified. I believe that in the overall picture that the Disclosure Project could bring about some really important things in the future. I just hate to see a really good idea get so weighted down by all of the human pettiness that it can't move forward. In my lifetime I have seen far too much of this. The reason I wrote this disclosure is that I would like just a simple apology from Dr. Greer for having treated me so rudely and unprofessionally after being invited by him for this briefing.

WHAT'S NEXT ?

I would like for you all to help me apply pressure to Congress and the Senate to grant Dr. Steven Greer and CSETI a Congressional Hearing. Before you think that I have been breathing too many rocket fumes let me explain why I feel this way.

The scenario I am about to run by you is based upon years of experience working in the United States Navy and first hand observations of covert operations, it is my personal opinion.

Dr. Steven Greer is not the "Bad Guy" in this story. He may have an arrogant air about him but that often is found in very high powered intellects as that is required for Medical Physicians of which Steven is. I believe that the Disclosure Project, as with all grass roots campaigns started out small and grew in momentum until it got big enough to catch the eye of the powers to be, in this case the Pentagon. It was then that Dr. Greer had a head on collision with the reality of the real covert community of which he was totally naive.

There were two major differences that surfaced in the pre screening between myself and the other witnesses. The first difference was that I had hardware contact inside a top secret Air Force base and the other that I was minor in age when they took me there. Big mistake on the Air Force's part, the Constitution of the United States prohibits signing a minor to a National Security Oath. As one high ranking official refer to me in the Congressional Briefings was that " I was the worst loose cannon on the deck."

When Dr. Greer sequestered me away from everyone, I believe he did not have any choice in the matter. It did not make sense for him to do that when he had worked so hard to get me there.

What did make sense was this was Standard Operating Procedure of the covert community by dividing the force that is coming at them and having it fight amongst it's own, thereby keeping the focus off of them. They were hoping when Dr. Greer sequestered me that I would get mad at him and then start a disruption which would have damaged the proceedings. I believe that the covert community is working with Dr. Greer and is using him and CSETI to get out a disclosure of information, but they control the content and the rate of flow. If you notice the vast majority of witnesses have seen lights in the sky or blips on a radar screen. We have not seen one reverse engineering scientist or technician come forward on tape or in person with their story. The reason according to Dr. Greer why we have not seen this type of witness is because they must have legal immunity from their signing of a National Security Oath. This is where we can apply pressure onto members of Congress to set forth a Congressional Hearing granting full immunity to all who testify.

In light of the fact that you wanted to become an astronaut as a young girl, and in light of the fact that Laurence Rockefeller met with you in August 1995 to discuss UFOs, I would like to know if you or anyone else in the Clinton White House received a briefing that tell us what's going on.



The phone rang at the CIA, in the office of James O'Grady, Ph.D., a thirty-five-year-old scientist who had been assigned the task of looking after all the bizarre, undocumented and unwanted data that the Agency's vast collection networks were dredging up all the time. Such data didn't fit into any useful political or strategic category, yet it always merited some degree of attention.



"You never know when some innocuous ghost story or some silly occult belief may turn out to be significant," his boss had told him when he was assigned the job of "Keeper of the Weird."

"Look at Hitler's obsession with astrology; or the apparitions of the Holy Virgin in Croatia, a few years before Yugoslavia blew up in our face."

On this particular day O'Grady, a tall man with wire-rimmed glasses and a fine mustache, had already scanned a thick folder of National Security Agency telephone intercepts concerning French parapsychological experiments, and several diplomatic wires about Chinese expeditions into Tibet in search of the elusive Yeti, when the phone rang and he found himself talking to Bill Renslow, the White House Chief of Staff, whom he knew to be a close friend of President Henry Templeton.

"What can I do for you?" asked the young analyst, immediately on his guard. The Directorate of Science and Technology was not used to taking phone calls from 1600 Pennsylvania Avenue.

"I am told that you're the man in charge of analyzing strange occurrences," said the voice at the end of the line. "Does that include UFOs?"

"Not officially, sir."

"We're not speaking on the record here, young man," the voice said dryly "And you're not talking to CBS News. This is the White House, and I'm asking you, yes or no, if you keep up with UFO data."

"Yes, sir. I mean ... In public we deny it ... but I try to make sense of whatever crosses my desk. And most of it turns out to be garbage, naturally"

"Excellent. I'm sure you fellows do a fine job. I have a favor to ask you. Some friends of the president are putting a lot of pressure on us to look into all this UFO business. We have other fish to fry at the moment, of course. I'm sure you know as much as I do about what's going on in Mexico, where the social turmoil is ready to boil over. They might have a coup any day down there. However, these are friends of the president, influential people, Washington socialites, political contributors ... I'm sure you understand."

"Yes, sir, of course."

It was hard to turn down polite requests from people who influenced vast sectors of public opinion, even when they freaked out over such absurd rumors as flying-saucer stories.

"We are setting up a briefing for Tuesday afternoon at 1500 hours. I'd like you to prepare a background paper. If you show your credentials to the Secret Service at the side entrance, they'll take you straight to the conference room."

Dr. James O'Grady hung up the phone and scanned the metal cabinets equipped with combination locks that lined one entire wall of his office. Trust the White House to call him up with such a bizarre request at five minutes to five on a Friday, when he was ready to leave, he thought. He would have to cancel his plans to visit his fiancée in Connecticut. And he would have to find out what information the Agency had on a subject that had generated far more controversy than hard data over the years.
