Thank you for your recent communication endorsing my proposal that Congress investigate the rash of reported sightings of unidentified flying objects in southern Michigan and in other parts of the country.

It is proper for the Federal government to look into a matter which is causing alarm to the people of our nation as these sightings have, and it is for this reason that I have called for the investigation.

Such an inquiry is necessary and wholesome because of the incidents that have occurred and I assure you that I will continue to press for this investigation. I want you to know that your specific comments were helpful to me in this respect, and that your remarks do not go unheeded. I am aware of other reports such as the UFO Evidence which pose questions that, like the most recent sightings, cannot be answered by a few "pat" solutions.

Any reply will be kept entirely confidential, as it is not our policy to publicly discredit anyone.



## UFO FACT SHEET

On December 17, 1969 the Secretary of the Air Force announced the termination of Project Blue Book, the Air Force program for the investigation of UFOs.

The decision to discontinue UFO investigations was based on an evaluation of a report prepared by the University of Colorado entitled, "Scientific Study of Unidentified Flying Objects;" a review of the University of Colorado's report by the National Academy of Sciences; past UFO studies; and Air Force experience investigating UFO reports during the past two decades.

As a result of these investigations and studies, and experience gained from investigating UFO reports since 1948, the conclusions of Project Blue Book are: (1) no UFO reported investigated, and evaluated by the Air Force has ever given any indication of threat to our national security; (2) there has been no evidence submitted to or discovered by the Air Force that sightings categorized as "unidentified" represent technological developments or principles beyond the range of present day scientific knowledge; and (3) there has been no evidence indicating that sightings categorized as "unidentified" are extraterrestrial vehicles.

With the termination of Project Blue Book, the Air Force regulation establishing and controlling the program for investigating and analyzing UFOs has been rescinded, and file copies of Project Blue Book records have been transferred to the Albert F. Simpson Historical Research Center, Maxwell Air Force Base, Alabama 36112, where they are available to the public for review. Although the Center does not have the reproduction capability to provide duplicate copies of Project Blue Book reports (some 26 standard file drawers of material), the complete University of Colorado report is available in paperback form at a nominal cost by Bantam Book Company.

Attached is the Project Blue Book sighting summary for the period 1947-1969. Also included is a listing of UFO-related materials currently available through publication outlets of the federal government.

Since the termination of Project Blue Book, no evidence has been presented to indicate that further investigation of UFOs by the Air Force is warranted. In view of the considerable Air Force commitment of resources in the past, and the extreme pressure on Air Force funds at this time, there is no likelihood of renewed Air Force involvement in this area.

There are a number of universities and professional scientific organizations such as the American Association for the Advancement of Science, which have considered UFO phenomena during periodic meetings and seminars. Such timely review of the situation by private groups insures that sound evidence will not be overlooked by the scientific community.

Dear Sir:

On Wednesday night November 4th, a newscaster, Art Baxter, of KOA Denver, Colorado, played a taped conversation he had held with a retired Dr. in Clearwater, Florida, concerning the crash landing of a U.F.O. in New Mexico in 1943.

The Dr. gave a detailed account of the size of this U.F.O. and the fact that 12 men or as the Dr. called them, "Humanoids" were found dead inside.

He also gave a detailed account of the Space craft and a vivid description of the "Humanoids" found in the Space craft. This Dr. also stated there would be a program on Television December 15th preparing the Public for the eventual admission by the Government that U.F.O.'s actually exist.

After playing this tape interview Art Baxter was dismissed from KOA Radio, Denver, the next day, and speaking from personal inquiry of the Personnel Director of KOA, John Gruble, he could give me no reasonable explanation for Art Baxter's dismissal. Art Baxter was a newscaster on an all night talk program from KOA Radio.

Previously, other people have called the program who live in New Mexico concerning this supposed occurrence.

I'm sure the American public, as a whole, are intelligent enough to accept the probability or fact of visits from more advanced cultures from outer space, and we are also wise enough to discern when knowledge is being withheld from us by the Government.

I would appreciate your opinion on this subject.

A PEACEFUL PETITION  
TO THE PRESIDENT  
OF THE UNITED STATES

TO DOD - FOR APPROPRIATE HANDLING

DATE APR 21 1976

We, THE UNDERSIGNED CITIZENS & REGISTERED VOTERS, DO RESPECTFULLY & EARNESTLY PETITION YOU TO CONSIDER, IN ALL SERIOUSNESS & SOLEMNITY TAKING THESE STEPS IN THE BEST INTEREST OF OUR NATIONAL SECURITY, FOR THE ADVANCEMENT OF KNOWLEDGE AND TOWARD UNIVERSAL PEACE AND BROTHERHOOD, TO WIT:

1) As PENTAGON POLICIES ON UFOs ARE WIDELY DERIDED, ARE DIVISIVE, OBSCUR-ANTIST, POLITICALLY ENCOMPASSING AND SCIENTIFICALLY UNWISE, WE THE UNDER-SIGNED, IMPLORE YOU MR. PRESIDENT, TO DEMONSTRATE ONCE MORE YOUR VISION AND YOUR COURAGE BY REVERSING ALL PREVIOUS PRESIDENTS' COVER-UPS SINCE THE YEAR 1948 AND BOLDLY ADOPT YOUR OWN ANNOUNCED INTENTION OF CONDUCTING AN OPEN ADMINISTRATION THAT KEEPS THE PEOPLE FULLY INFORMED ON MAJOR ISSUES. WE URGE YOU, MR. PRESIDENT, TO CALL FOR THE IMMEDIATE DECLASSIFICATION OF ALL MILITARY DOCUMENTS AND EVIDENCE PERTAINING TO THE NATURE OF UNIDENTIFIED FLYING OBJECTS, TO HALT HARASSMENT AND CLANDESTINE SURVEILLANCE OF CIVILIAN UFO ORGANIZATIONS BY THE CENTRAL INTELLIGENCE AGENCY, AND TO OPENLY ENCOURAGE SCIENTIFIC RESEARCH INTO PARANORMAL AERIAL PHENOMENA.

2) CREATION OF AN EXTRATERRESTIAL COMMUNICATIONS LABORATORY HERE IN THE UNITED STATES TO ATTRACT, INVITE, AND INITIATE TWO-WAY COMMUNICATIONS AND IF POSSIBLE, ACTUAL MEETINGS BETWEEN EXTRATERRESTRIALS AND UNITED STATES CIVILIAN SCIENTISTS. OUR WORLD'S BEST SPACE SCIENTISTS REGARD SUCH A CONFRONTATION AS VIRTUALLY INEVITABLE. BY TAKING THE INITIATIVE IN THIS ENDEAVOR OUR NATION WOULD ONCE AGAIN DEMONSTRATE THE HONESTY AND FORTITUDE AND TECHNICAL KNOW-HOW THAT HAS MADE US THE WORLD'S OLDEST MODERN DEMOCRACY AND THE FIRST NATION ON THE MOON. SUCH AN EXCHANGE OF KNOWLEDGE COULD BE THE DECISIVE TURNING POINT IN MODERN HUMAN HISTORY, WELL SURMOUNTING THE SAME BARRIERS OF IGNORANCE, FEAR AND RIDICULE THAT CHRISTOPHER COLUMBUS HAD TO OVERCOME TO DISCOVER THE "MYTHICAL" NEW WORLD WHICH IS NOW OUR HOMELAND.

3) MR. PRESIDENT, THE HIGH MISSION OF THE EXTRATERRESTIAL COMMUNICATIONS LABORATORY, UNDER YOUR PERSONAL COMMAND, IS TO FOCUS SENSELESS PANDOM UFO ENCOUNTERS WITH UNQUALIFIED AND FEARFUL HUMANS INTO A CALCULATED PRESIDENTIAL INITIATIVE AIMED AT AN OFFICIAL MEETING. FOR THIS GREAT STEP FORWARD YOU WILL ENJOY THE PLAUDITS OF OUR PLANET, MR. PRESIDENT, AND ESPECIALLY THE APPLAUSE OF VOTERS, CHILDREN OF THE SPACE AGE, TO WHOM THE PRESENT UFO COVER-UP IS WORSE THAN ANY WATERGATE.
