

## CARTER WHITE HOUSE PROBE INTO EXTRATERRESTRIAL COMMUNICATIONS SUPPRESSED, NEW BOOK CLAIMS

05-10-2000

EXOPOLITICS, a new book by former Stanford Research Institute (SRI) futurist Alfred Webre, claims that a 1977-78 White House study into Extraterrestrial communications during the Carter years was secretly suppressed at the behest of Pentagon officials, led by the SRI liaison with the Pentagon. The study was to have been undertaken jointly by the National Science Foundation and the Center for the Study of Social Policy at SRI where the author was a futurist and principal investigator of the study.

According to EXOPOLITICS, the suppression of important Carter White House study is part of what he terms "Exopolitics" or the process of government and politics in the Universe.

EXOPOLITICS asks: Is there intelligent life in the Universe? In fact, the truest conception of our human circumstance may be that we are on an isolated planet in the midst of a populated, evolving, highly organized inter-planetary, inter-galactic, universal society. Earth is isolated because we are in intentional quarantine by a structured, rational universe society. Exopolitics, the dynamics of politics and governance in inter-stellar society, is a key channel to transforming our human future. Exopolitics' immediate goal seeks a decade of human education and community politics about the extraterrestrial initiative. EXOPOLITICS is a non-fiction serial. Part One was released in March 2000; Part Two is scheduled for release in September 2000.

His context communication theory of extraterrestrial intervention was first introduced in his earlier book *The Age of Cataclysm*, (New York: GP Putnam's Sons 1974); (New York: Berkeley Medallion 1975); (Capricorn Books, 1975); (Tokyo: Ugaku Sha 1975). Webre is a science journalist who is frequently consulted by national and international media on cometary and near space issues. In the summer of 1999, Webre appeared on over 60 media programs in the United States and elsewhere on issues of near space catastrophe. His most

recent book is a work of futuristic political journalism, *The Levesque Cases*, (Ontario: PSP Books, 1990).

A Fulbright Scholar, graduate of Yale University, Yale Law School (where he was Yale Law School National Scholar) and the University of Texas Counseling Program, Alfred Webre has been an Environmental lawyer, Futurist, University teacher, Author, Radio talk show host, Community health and social activist. He has taught at Yale University and the University of Texas. Webre has been a Non Governmental Delegate to the United Nations, as well as a delegate to the Texas Democratic Convention. Should I be taking this story seriously?

In a listing of disclosure efforts, his claim can be referenced, of course, since it is a matter of public record, I suppose. However, the details as I learned of them appear to be relatively mundane.

I knew Webre when he was at SRI, I liked him and knew of his efforts to get a program going as he describes (which he shared with me). He may even have gotten something (e.g., a White Paper) into the White House for consideration by staffers. However, when I checked with his supervisor (and my close colleague) Peter Schwartz as to whether it really was a Pentagon shutdown of an officially approved project as he implies, he said he did not see it this way, but rather that it was simply a case that that was not something that SRI really wanted to add to the SRI portfolio, in part because SRI was already taking heat for our remote viewing program. So it seems that the program had never actually gone through an approved proposal process, got approved as an official government-funded SRI project, then terminated by some government entity for nefarious anti-disclosure reasons; rather that it was just that there was his attempt to push it forward, but it never really went anywhere because of government/corporate conservatism. My efforts a year or so ago to pin AI down on the details as he sees them has not brought any clarification either. (You might try.) Webre was understandably frustrated by all this, so I can see why he would lean to interpret the outcome as he did, so I do cut him some slack.

However, although I think that there may well be significant anti-disclosure politics and policies in place, this does not seem to me to be an example that fits the bill.

That's my take on it.

## Carter and SRI

Twenty year after the Carter Presidency was over Alfred Webre ,JD, Med, stepped forward to state that he had in 1977 headed up an Extraterrestrial Study for the Carter White House.

Webre was a Yale trained lawyer who at the time of the study was working as a futurist for Center for the Study of Social Policy at Stanford Research Institute. Webre had put forward a proposal to study conspiracy theory, particularly the John F. Kennedy assassination, and the possibility of extraterrestrial visitation. About the same time Jimmy Carter running for President declared that he had had a UFO sighting, and that he was determined to release information on the UFO subject being held by the Government. "It was a godsend," stated Webre. "We took Carter on his word."<sup>1</sup>

Webre's first action was to identify "people inside the Carter White House who were sympathetic to the UFO issue."

Once this was accomplished, and the White House had given it's final approval of the Extraterrestrial study, Webre moved on. He approached the National Science Foundation and brought them on-board the coalition.

Next Webre contacted a number of the leading UFO investigators to become part of the high level agreement with the Carter administration.

The preliminary phases of the study last from May 1977 to September 1977. Everything was ready to roll. "The project plan we had developed," said Webre, "was extremely refined and sophisticated, and would have resulted in a three year study like the French COMETA report."<sup>2</sup>

2. *ibid.* The COMETA report was French report published July 16, 1999 in France. It was titled *UFOs and Defense: What must we be prepared for? ("Les Ovni Et La Defense: A quoi doit-on se préparer?")*. The ninety-page report was an in-depth report covering various aspects of UFOs, especially the military aspects of the phenomena. An independent groups of former "auditors" at the Institute of Advanced Studies for National Defense conducted the study. It was presented upon conclusion to French President Jacques Chirac and Prime Minister Lionel Jospin. It was then made public.

Dick - I am sorry but I do not remember meeting you and I have no idea of who you are. There is a quality of "when did you stop beating your UFO researcher" to your post which I find non-professional. Nevertheless I shall answer straight-forwardly why I am devoting my time to the Disclosure process - which includes both the CSETI events May 8-12, 2001 and the follow on UFO/ET political caucuses planned for the rest of 2001.

If you knew me as you claim, you would know that in 1977, a group of us was able, with the help of the Black Caucus, to get the HCSA (House Select Committee on assassinations started to investigate the JFK and King assassinations.

That same public interest advocacy spurs me now to seek open congressional hearings on the UFO/ET issue, for US Government witnesses - waiving secrecy rules and allowing functional disclosure to take place.

The CSETI Disclosure project approached me in August 2000, and I am one of 90 witnesses whose testimony has been videotaped. I also submitted a sworn affidavit on the 1977 Carter White House extraterrestrial study. In all my dealings with this project I have experienced professionalism and thoroughness. I have also watched other credible high-level witnesses, military and CIA witnesses, being examined and videotaped in August 2000.

This is the first time I have worked with Dr. Greer and his wife Emily, and I find both to be professional, and committed to positive UFO/ET change. For 5 years until 1998 I administered a federally-qualified community health center in the Rio Grande Valley of Texas, and I have a certificate from Harvard School of Public Health in administering physicians. I have a basis for evaluating the conduct of physicians, even in public interest advocacy. Dr. Greer's support has been exemplary and professional. I am now gladly helping set up Congressional appointments for the witnesses that will be coming to Washington. GOAL; Congressional hearings on UFO/ET issues.

A specific instance comes to mind for me, one in which my own soul took over. Not that I won that day! My witnessing led massive surveillance down upon my head. In retrospect, I was able to neutralize the US government thought police. They had come to an illustrious think tank to stamp out my proposal to set up a re-examination of the ETI issue, carried out at the very core of the overt US government – the Presidency.

I remember the scene vividly, a slow motion tableau of confrontation. A senior official of the think tank called a fellow futurist and myself into his office one afternoon. He was an African American, friendly to my proposed ETI research, and to my views for expanding futurist research at the think tank into the more frontier, esoteric areas like ETIs and assassination research.

I was unawares of the purpose of the meeting, and he quickly filled me in.

Department of defense officials had contacted the management of the think tank, demanding that my proposal be stopped, and threatening to withdraw research contracts if the think tank did not comply.

In an instant I surmised what had happened. I had not approached any office or person of the Defense Department about the project. The only US government officials who had been approached were in the Carter White House and the National Science Foundation, who would carry out the study. The probability was that the US secret government surveillance tracking my Washington meetings had flagged my project as a risk to their lid of secrecy on ETIs.

The senior think tank official advised me to duck this one, and accept the ban on ETI research. "Dissimulate," he said.

Two hatchet-faced thought police entered the room, sharp gleams in their reptilian eyes.

The lead nasty opened up, disparaging ETI research, saying this project would discredit the think tank and jeopardize its military contracts.

But that wasn't what the White House and the National Science Foundation said. They thought the project was meritorious and long over due.

I tersely recited some of the evidence for the existence of an ETI strategy with regard to earth.

My fellow futurist and that think tank official went into dissimulation mode, sliding quietly down in their chairs. Theirs was the body language of bureaucratic concession. The more I tried to contain my rising indignation, the more I could not. Battle lines were drawn. The US government agents had the power lines. I had the truth of the situation.

"Blast them," my inner voice said.

Blast them I did with a head-on channeling of the reality of an ETI presence. I veered close to the line of denouncing them as a military secrecy enforcement team. I had a wife and child at home I had to support. When I came to that line I held back.

But I blew the force, the steam, and the deception out of them. They deflated right before our eyes, falling back to shallow power moves.

When they left, it was clear my project would be stopped. I was in an inner rage, not yet knowing if I would stay at the think tank or leave.

But they had not succeeded in furthering a deception.

Everyone in that room knew that they were pushing a lie.

Dr. Alfred Webre, Senior Policy Analyst: I hold a BS degree from Yale, a law degree from Yale Law School a Master's of Education in Counseling from UT...I was a Senior Policy Analyst at the Center for Study of Social Policy at Stanford Research Institute [SRI]. I worked on the 1977 **Carter** White House Extraterrestrial Communication Project. The goal of the study was to fill the knowledge gap on this subject...and would include data on **UFOs** and EBE's [Extraterrestrial biological entities], of which there have been many sightings. It would have gone to as many foreign countries as possible; France the then Soviet Union China under the aegis of the National Science Foundation. The project was terminated. They [management of SRI] had received direct communications from the Pentagon that if the study went forward, SRI's contracts with the Pentagon [which were many] would be terminated. He [my SRI Pentagon liaison] stated that the project, that had just been approved by the ! White House, was terminated because, and I am quoting him, "There are no **UFOs**."

Daniel Sheehan, Attorney: I'm a 1967 graduate of Harvard Law School. studied American government and constitutional law served as general council and co-council for the New York Times in the Pentagon Papers case and was involved in briefing and arguing the case in front of the US Supreme Court represented James McCord in the Watergate burglary.. I subsequently attended the Harvard Divinity school in Judeo-Christian social ethics in public policy did my masters and PHD work there I became the general council for the US Jesuit headquarters in D.C. In 1977, I was contacted by the director of the Science and Technology Division of the Congressional Research Service. She informed me that **President Carter** had held a meeting with the director of the CIA, George Bush sr, and demanded that he [Bush] turn over to the **President** the classified information about **UFOs** and the information that was in the possession of the US intelligence community concerning the existence of ET intellig! ence. This information was refused to the **President** of the United States by the director of the CIA. The DCI [Director of Central Intelligence] suspected that the **president** was preparing to reveal this information to the American public.
