On another matter, I am investigating Carter's famous sighting of his UFO. Schaeffer sort of debunked the sighting since the Lion's Club records indicate that Carter was not in Leary Ga. in October 1969 but in January, which is when Schaeffer insists the sighting occurred. And as Venus was in the ascendant, Schaeffer insists that was what Carter saw. (I think that as an Annapolis graduate in naval science, JC would have recognized the planet Venus! Also, he says his UFO looked as large as the moon.)

The angle I am investigating is the YEAR. Carter writing in 1973 recalled the sighting as happening in Oct 1969. I am wondering, however, if he might have telescoped this in his memory, so that his Leary sighting was in Oct 1967 rather than Oct 1969. I want to check the records to see if by chance Carter was at the Lions Club of Leary in 1967.

My reasons for wanting to do this are twofold: 1) the year 1967 was a record year for UFO sightings in Georgia, and if Carter were seeing them, other people probably were too and (2) I was in college with Carter's son Chip, at Georgia Southwestern College and I seem to recall him mentioning his father's seeing a UFO--only I left Southwestern in June of 1969, which PRECEDES the Oct 1969 date.

Also, I don't think JC and the Lions Club members would have been idling outside the Club in January! as Schaeffer theorizes.

While researching at the National Security Archives here in Washington I came across a document detailing two UFO briefings given to President Carter. The man at the center is Harvey Jack McGeorge.

Could you give me an idea of what material might be at the library on McGeorge? I am interested in how often he met with the President, and if he has a set of files in the archives.

Here is an e-mail that I sent to a dozen researchers as we prepare to interview McGeorge.

The discovered three-page document involves statements that were made by a friend of Harvey Jack McGeorge. McGeorge worked in the secret service at the Carter White House as a munitions counterweapons

specialist. (7/77 - 5/80)

I was searching for a document (in the collection of Scott Malone, a PBS investigative reporter) detailing a Carter official who was in on one of the two UFO briefings given to Jimmy Carter by the NSA. I found it.

The man is Harvey Jack George. The biomaterial in the document I found agrees with his homepage.

The story of the NSA briefing he tells is amazing. McGeorge claims to have been in one of the briefings. It involves Carter being told of the history of UFOs, why the aliens are here etc. The second hand account also details how President Carter was shown the Holloman AFB film, (a 15 minute film where aliens land at the base and are greeted by base officials- George HW Bush just confirmed to a researcher last weekend he had been briefed on the film while DCI director under Ford). McGeorge also details reason for the cover-up (at least the version told to Carter).

As to the reason for the coverup.

"According to McGeorge, the two main reasons the government is withholding the truth about UFOs are the religious question, and the fact that we do not have control of the situation. They are in charge. According to McGeorge, if the Bible said that God created the Heaven and the Earth, what the hell do the aliens believe in? The thing that the aliens fear most is that man would find out that they are not the creation of an omnipotent supreme being, but possibly the creation of tghe aliens themselves - that we are a genetic experiment. And they fear greatly that religion as a controlling factor on behavior in the world - if the truth was known that the controlling factor would immediately be destroyed and there might be anarchy. The second reason - that we are not in control - I think is pretty obvious."

McGeorge claimed that he entered Carter's office 30 minutes after the briefing and Carter had tears in his eyes.

The McGeorge document is a fax from Gus Russo to Scott Malone. Russo is providing a lead for a possible documentary on UFOs being considered by the show "Frontline." The fax document was in a collection of files given by Malone to the National Security Archives at George Washington University. There is no indication Malone followed up except a handwritten notation stating McGeorge couldn't be found.

Russo states that "McGeorge gave an account to a friend who in turn told Harry Lebelson, then of Omni magazine." Russo stated he had obtained a tape of Lebelson interview from researcher Bill Laparl in which he relates the story. In the document Russo then quotes sections of the interview.

I hope you can help provide some background info on this man.

It turns out that Kilgallen had written a syndicated report from London on 22 May 1955 for the International News Service which stated, in part:

"British scientists and airmen, after examining the wreckage of one mysterious flying ship, are convinced these strange aerial objects are not optical illusions or Soviet inventions, but are flying saucers which originate on another planet.

"The source of my information is a British official of Cabinet rank who prefers to remain unidentified. 'We believe, on the basis of our inquiry thus far, that the saucers were staffed by small men--probably under four feet tall. It's frightening, but there is no denying the flying saucers come from another planet.'

"This official quoted scientists as saying a flying ship of this type could not possibly have been constructed on earth. The British government, I learned, is withholding an official report on the 'flying saucer' examination at this time, possibly because it does not wish to frighten the public." [Los Angeles Examiner 5-22-55]

According to one UFO researcher cited by author Timothy Good, Ms. Kilgallen obtained this story while attending a cocktail party hosted by Lord Mountbatten. [GOOD p.44]

The second document is a remarkable recent letter from former Senator Barry Goldwater. He makes two astounding admissions, previously unknown: He was a "very close friend" of Roswell Base Commander Col. 'Butch' Blanchard, who presumably was his source about the alien wreckage at Writ-Pat. Second, the Roswell crash was indeed the specific information Goldwater says he sought "diligently to get [from] General LeMay," which resulted in "the only cussing out he ever gave me..."

Goldwater has also recently disclosed that Gen. LeMay actually threatened to have him "court-martialed" he ever asked about Writ-Pat again.

It should also be noted here that Anne Blanchard, widow of Gen. Blanchard, told Stanton Friedman in 1979 that her husband knew what he had sent to Carswell was NOT a balloon. "He knew it was nothing made by us," she told Feirdman. "At first he thought it might be Russian because of the STRANGE SYMBOLS on it. Later on, he realized it wasn't Russian either." [MOORE p.42]

I trust you had a restful vacation. I'm sorry I haven't been able to get my UFO memo to you. I pray I didn't cause you any sleepless nights under the palm trees.

Several personal problems have arisen, including my mother breaking two ribs in a swimming pool accident, which have caused my attention to wander. Further, the two authors with the most extensive sourcing on Roswell have both been traveling around the country promoting their book. When I do manage to contact them, they have been without the various specific files or documents I have been seeking. They both expect to be back next week at their respective homes. So I still have to obtain certain documents and have various facts checked based on their interviews.

And pursuant to your request for all the information on the "dissenters" to the Roswell story, I have been attempting to obtain a copy of a research paper prepared by Carl Flock, late of the CIA. I hope to succeed this week. Mr. Flock, unfortunately, is apparently working with some independent documentary film maker, and may perceive us as competition. As a consequence, I hope to obtain it through other means.

Attached, please find two new documents which just crossed my desk yesterday and today. The first is an alleged 3 AUG 62 TOP SECRET CIA report on the subject of, of all things, Marilyn Monroe and RFK. The memo quotes wiretaps of telephone conversations between columnists Dorothy Kilgallen and her "close friend" Howard Rothberg. Rothberg was talking about various secrets that Monroe had "to tell."

"One such 'secret' mentions the visit by the [the President] at a secret air base for the purpose of inspecting [things] from outer space. Kilgallen replied that she knew what might be the source of visit. In the mid-fifties Kilgallen learned of a secret effort by US and UK governments to identify the origins of [crashed spacecraft and dead bodies,] from a British government official. Kilgallen believed the story may have come from the [the New Mexico _____] in the late forties. Kilgallen said that if the story is true, it would cause terrible embarrassment for Jack and his plans to have NASA put man on the moon." [CIA 8-3-62]

This document goes on to refer to other wiretaps of Monroe making reference to her knowledge of the Castro plots, and how she was being "ignored by the President and his brother." All of these references correlate with subsequently released data.

The significance of this apparently real [subject to confirmation] document, is the "references" notation at the top right: "MOON DUST Project." This is indeed the designator of the then TOP SECRET USAF space debris/UFO recovery unit. The primary concern of the CIA, which, unlike the State Department, was previously unknown to have been involved in MOON DUST, seems to be the leakage of a presidential visit to a secret base, and a "crashed spacecraft and dead bodies..."

(1) According to several sources who have spoken with him, "ET" writer and "E.T. the Extra-Terrestrial" producer Ernie Shandera tells a very interesting story that confirmed Hollywood Producer/director Steven Spielberg had related directly to him. Spielberg is said to have told Shandera about a special White House screening of the movie "ET" for President Ronald Reagan. At the conclusion of the film, President Reagan told Spielberg that "you don't know how close to the truth you are." President Reagan is further reported to have told Spielberg that there "are only three or four people in the world who know the whole truth." Other variations include 2 or 3 people "here" (presumably meaning the screening room), or 3 or 4 people "in the building" (presumably meaning the entire White House), "who know the whole truth." (REFLINER/WHITING 4-21-94)

(2) A Hollywood producer who wishes to remain anonymous (for obvious reasons), reports that special effects (fx) wizard Rick Baker had a falling out with producer Spielberg over changes made in a script that eventually became the blockbuster "ET." While not in attendance, the source states that the source heard directly from several people who attended various pre-production meetings with both Baker and Spielberg. According to these attendees, the original script was much "darker" story about a dramatic standoff and shootout between an all-American family and a pack of aliens.

Baker had already begun to design the aliens, when Spielberg announced that he was going to scrape that theme entirely. After some prodding by Baker, Spielberg allegedly told those assembled that he (Spielberg) had had a visit from "some government suits" who had suggested that Spielberg "should make it nicer -- warm the populace," not scare them. Baker apparently objected vehemently that they shouldn't be making films at the direction of the government, and he subsequently quit the project.

Legend has it Spielberg apparently later made up and "made" the "ET" movie "his own" and as a consequence, Baker may not have been involved in the project. (REFLINER/WHITING 4-21-94, 8-12-94)





Subject: Authenticity of August 3, 1962, CIA Information Report (IR)

1. The message externals of this document are valid for a standard CIA field IR. The report number, date of distribution, number of pages, references and field report number are in the right order and position on the top right hand portion of this document. Likewise the country, subject, date of information, and date and place of acquisition on the upper left portion.
2. One anomaly is the preprinted source evaluation line. The Agency has different versions for their case officers to use depending on whether the case officer feels the source has been evaluated in the past. Enclosed find two different versions I have located. One says, "Source evaluations are definitive; appraisal of content is tentative"; and the other simply says, "This is unevaluated information." Your subject document appears to be a third version of this, but is too poor a copy to render a reading. Note that part of it is redacted before the letters "ALUATED."
3. The subject document is cut off at the top, with the result that the reverse background "Information Report" header above the CIA header is no longer visible. The CIA header, and the Title 18 warning against unauthorized disclosure are the right items and in the right positions.
4. Typically, an IR begins with a line or a paragraph on the source. The subject document follows this normal practice. Typically, this information on the source is not a numbered paragraph. The subject document matches this pattern as well. After the source information, paragraphs are normally numbered, one-up, with the numbers indented eight spaces from the left margin. The subject document follows this pattern too. Content is normally single spaced with double spaces between paragraphs. This, too, is the case with the subject document.
5. In short, gentlemen, your document appears to me to be a genuine CIA field information report -- *based upon the format.*
6. Interesting little IR isn't this? I am afraid I can't vouch for any of the content. I have made an preliminary analysis of the brackets which appear around certain parts of the text. Normally, this indicates the document is being prepared for sanitization, either for release or release at a lower level of classification. Therefore, the brackets suggest that the document was in the stage before this release, having already had other portions blacked out. The bracketed items, therefore, should be the most sensitive items. This works for me in the subject document in every case except one: this is where -- if it had been me -- I would have bracketed "outer space" or "things from outer space" instead of "things" (see middle of paragraph one).
7. I hope this rough analysis is useful to you.

SUBJ: The Signature of James J. Angleton

1. Scott dug out a cleaner copy of the Moon Dust Information Report (IR) yesterday, one which has an apparent signature by Angleton.
2. I scratched around in my files and located about the only example of his signature I have. I have enclosed blow-ups of the signatures: the example from my files is on the top and the signature on the Moon Dust IR is just below it for comparison. The similarity is much stronger than the difference. In fact I would argue that the similarity is dramatic.
3. I suppose a hand-writing analysis by a credentialed expert would be the way to go. In the absence of going that far, I would say that the signature on the Moon Dust IR is either Angleton's or someone's who is very good at faking his signature. Of these two possibilities, my guess is that it is his signature.
4. If it is an authentic signature, I believe that would up the ante with respect to the IR's content.

1947 ROSWELL INCIDENT

The ultimate mystery story, set in the moody, black & white atmosphere of 1947 - postwar America. It was the dawn of the atomic age, the 'military-industrial complex,' and the ensuing cold-War. There was only one Atomic power in the entire world at the time, and only one atomic bomber base - Roswell Army Air Force Base, N.M.

While this tale has been told and retold in three books and an upcoming SHOWTIME cable docudrama, it has yet to be either well told, or critically examined. Over 60 primary and secondary witnesses listed herein, not to mention a dozen, unquestioned, previously classified government documents are hard to ignore or explain away. From 4-star generals, Colonels, majors and NCOs, to leading scientists (~~other~~ their surviving family members), lack of witness^{es} has not been the problem with the telling of this story. Initial confusion amongst the various witnesses that have been dug up over the recent years.

Story unknown since 1947, until 1978, when UFO researcher Staton Friedman was giving a lecture at LSU in Baton Rouge. Later, during a radio interview, it was suggested that Friedman contact local former Air Force colonel named Jesse Marcel. Marcel came forward. Did not apparently take it too seriously until fellow UFO writer William Moore checked the library and discovered the famous July 8th, 1947, "RAAF Captures Flying Saucer On Ranch in Roswell Region," headline story in the Roswell Daily Record. It named Roswell's intelligence officer, "Maj. J.A. Marcel," as having led a team that "recovered the disk..." [RDR 7-8-47]

Numerous new witnesses, now seem to cross corroborate in rather specific detail. Two new analytical points seem to clear up all the confusion. One, there were two separate and distinct crash sites -- the Brazel ranch where the foil-like debris and 'I'-beam were recovered, and a site much closer to the actual town of Roswell (just north) where much more debris and actual "wreckage," appears to have been recovered, along with the alleged extraterrestrial bodies.

Two, the Army-Air Force July 8th press release was issued almost FOUR days after the crash, which seems to have occurred just after 11 pm on the evening of JULY 4TH. This press release, and the subsequent embarrassment of Major Marcel when his special B-29 flight stopped at 3th Air Force Headquarters at Carswell AAF in Texas, would appear in hindsight to have been a carefully orchestrated, slight-of-hand disinformation operation.

PRIMARY WITNESSES

BRAZEL, Mac - DECEASED, but was interviewed by 'Unsolved Mysteries' on video. "Yeah, only they weren't green." No bodies at the BRAZEL debris field. Randall and Schmidt postulate that BRAZEL was informed about the bodies while being held incommunicado to help secure his silence.

BRAZEL, Shirley
BRAZEL, William

CAVITT, Sheridan - denies all knowledge. Just had a visit from a Col. in the pentagon about this, took documents and copied them.

EASLEY, Edwin Major Provost Marshall in charge of MPs. Couldn't talk about it because he promised the President. On death bed he said "oh, the creatures." Witnessed by his two daughters, (Nancy Strickland, Dallas attorney), GRANDdaughter, and Doctor Harold Graneck, who stated he was medically lucid at the time.

HAUT, Walter - was the base Public Affairs officer. He states that he was called by the base commander, Col. BLANCHARD, who told him "that we had recovered a flying saucer and parts thereof." HAUT wrote out what BLANCHARD told him, got it approved, then went into town and issued the soon-to-be infamous press release to two radio stations and the local newspaper. Another officer was later told to go back and retrieve all copies of the press release, which was done. HAUT today runs the non-profit Roswell UFO museum.

HENDERSON, 'Pappy' on tape Dr. John Kromschoeder dentist friend about the bodies in 77-78. Sappho, pappy showed her tabloid, its all true, I saw the craft, I saw the bodies. One daughter and other bill Ned. family members and friends in Las Vegas. Told Vera McCarthy WWII crew told in 1984. Blanchard favorite trouble shooter. Flew numerous highly classified missions. [HENDERSON's wife & close friend are still alive and on video.]

KAUFMANN, Frank - Not credible.

MARCEL, Jesse Sr. Never saw any bodies. believed he was snookered. Did the analysis for the Air Force and President Truman on the Soviet's first nuclear test in 1949. The material was clearly "unusual enough" to warrant his stopping at home to show what he must have thought was historically significant material to his wife and 11 year old son.

MARCEL, Viaud

RICKETT, Lewis - was the CIC's [Army CounterIntelligence Corp] NCIC [Noncommissioned officer in charge] under Cavitt. deceased on video. Wife can corroborate on camera. RICKETT accompanied CAVIT. "There were MPs everywhere," when he arrived. RICKETT described the debrie as "nothing jagged, nothing cut - it was super hard and super light." Some of the debrie was placed in a "weapons carrier type truck." [note: not a military ambulance.] RICKETT also stated cryptically that "I knew the pilot."

PICKETT stated that he later asked his boss, Joe WIRTH, Chief of the CIC at Roswell, what happened to "all that metal" they had so diligently recovered? "I wish you hadn't asked me that," WIRTH reportedly stated. "They sent it to the lab. They still couldn't cut it."

RICKETT knew KAUFMANN and his nickname. Said that was there at the crash site. Cavitt called after forty years about Roswell. "We both know what happened" - "maybe someday."

RAGSDALE, *NOT CREDIBLE*

SELF, Naomi - nurse who described the alien bodies to mortician Glen Dennis.

WILCOX, Sheriff George A. -

OTHER WRECKAGE MATERIALS/SPECIAL FLIGHTS WITNESSES:

Equally confusing. More than one flight. (Must have been a hell of a large target balloon.) Materials are more subjective, more open to interpretation.

SHIRKEY, Robert - was present in the base operations office when Col. Blanchard walked in and asked if the plane was ready. The special B-29 to be flown to the laboratories at Wright-Patterson AAF was sitting just outside the operations office. When Shirkey responded in the affirmative, Col. Blanchard ordered his men to bring in "the parts of a flying saucer," and load it onto the plane. As the materials were carried in, Shirkey, who was standing in a narrow doorway with Col. Blanchard, asked the Colonel if he, Blanchard, could turn sideways so that Shirkey could also see the materials. "I got to see some of the materials," recalls Shirkey. "I saw that piece of 'I' beam with the markings. The other material I saw [very briefly] was similar to brushed stainless steel, but somewhat like aluminum foil in that one side was reflective." These materials were apparently placed aboard the B-29 in the bomb bay section.

PORTER, Robert - Flight engineer on the "original" July 8th flight with Major Marcel to Wright-Pat AAF via Carswell AAFB. According to Porter, he was later told they had carried parts of a "flying saucer" by Captain Pappy Henderson, who piloted at least one later "saucer parts" flight. Porter states that also on the July 8th flight were a Col. JENNINGS (Blanchard's deputy, who later disappeared MIA over the Mediterranean), a Col. BARANTHAL (who has not been located) a Major WONDERLICK (also not located) and Major MARCEL.

Employing a ground vehicle, Porter apparently delivered some of the materials to the forward crew compartment where the previously listed officers were lodged. These materials were wrapped in brown paper and tape. One piece was about 2 & 1/2 feet across and was triangular in shape. "The rest was in shoe boxes. They were very light - flat like they were empty." (Rand & Schmidt point out that these materials seem to match the actual balloon parts, complete with brown wrapping paper and shoe boxes, exhibited in the photograph taken in Gen. Ramey's 8th Air Force office at Carswell. They state that additional materials were also stored in the B-29's bomb bay where Porter did not see.)

Porter and the above listed officers flew a B-29 'Strato-Fortress' which was logged to fly to Wright-Patterson AAF in Ohio with a refueling stop at Carswell AAF. Most interesting, according to Porter, after a red-faced Maj. Marcel delivered his "space" debris, and it was announced to the whole world that it was merely debris from target balloon, this flight continued via a B-25 bomber onto the laboratories at WRIGHT-PAT AAF!!! (Porter is willing to do an interview, also on video)

SLUSHER, Robert - Slusher was the bombardier of a B-29 flight crew that flew "classified" cargo on a special flight from Roswell to Carswell on July 9th, the day after the Balloon press conference. Slusher states that one of the gunners (he can't remember who) told him during the flight what they were saying "up front," in the cockpit: "That we had made history." The flight began just off the operations building, then taxied over to a hanger, where a large CRATE was loaded into the bomb bay at "Bomb Pit #1." He said there were "armed M.P.s on board," who were still there while he helped unload the crate. "It was a low level flight," which Slusher says was also unusual.

Slusher remembers that the person who had apparently stated that "we had made history" was Major MARTUCCI. Slusher recalls that their flight was met by a party of individuals, and that Martucci greeted an old classmate on tarmac at Carswell AFB. This former classmate was MORTICIAN. Martucci lives in Texas and has declined so far to discuss this July 9th "historic" flight. (Slusher believes that Major Marcel joined their return flight back to Roswell - so Marcel spent the night at Carswell while his original flight continued onto Wright Field.) [Slusher is willing to do interview, also on video]

SMITH, Robert - was a flight loader who helped load debris onto 3 separate C-54 transport planes for flights that continued up until July 10th. This flights were apparently destined for Kirtland AFB and the Los Alamos Research Laboratory. Smith called in after an airing of an 'Unsolved Mysteries' episode on Roswell. Smith says the debris was housed in the "East side hanger," and that they measured the aircraft and crated up "the stuff" accordingly. The crates are stenciled "TOP SECRET." Smith said that the material, when crumpled up, would instantly spring to to its original shape.

Smith states that he had "distant cousin" who was with the U.S. Secret Service in Washington in 1947. During a family reunion in 1972, Smith talked with this cousin for the first time about the 1947 incident at Roswell. Smith's cousin (who is still believed to be alive, but not yet located), told Smith that he had "come [to Roswell] as representative of President Truman. He told me that he saw me [at Roswell], but that he didn't want to identify himself to me at the time." When Smith asked his cousin about "flying saucer parts" in 1972, his cousin "just grinned." [Smith is willing to do interview, also on video]

WIRTH, John (Joe?) - was chief of the CIC unit at Roswell in 1947. CIC-NOO Lewis Rickett, who was involved in the early recovery efforts, stated that he later asked his boss, WIRTH, what happened to "all that metal" they had so diligently recovered? "I wish you hadn't asked me that," WIRTH reportedly stated. "They sent it to the lab. They still couldn't cut it." WIRTH, if still alive, has not been located.

BLANCHARD, Anne - widow of Gen. Blanchard, she told Stanton Friedman in 1979 that her husband knew what he had sent to Carswell was NOT a balloon. "He knew it was nothing made by us," she told Friedman. "At first he thought it might be Russian because of the STRANGE SYMBOLS on it. Later on, he realized it wasn't Russian either." (MOOPE p.42)

BODY WITNESSES

Most serious and unambiguous. Not hardly as subject to selective interpretation as the recovered materials witnesses.

BROWN, Sgt. Melvin - BEAN Beverly -- father on death bed. [willing to be interviewed, also on video]

BUSH, Mary - George H. Bush, his nephew, his other sister corroborate that their sister who was the secretary Hospital administrator, documents check. came home incredibly adgitated after she had stepped in to a room by accident she was ordered out, saw what she said "was not a human body." ~~seen one of the bodies.~~ she was never the same after the incident. frightened would get in trouble. told her family this at the time it was in the newspapers. Committed suicide 3 years ago. despondent over a divorce. x-husband still alive. [Check RANDLE/SCHMITT p.18]

DENNIS, Glen city directory listed him as mortician

DURAN, LTC Robert Lovejoy --white sands. dying of sciroscis of the lead, when drunk, he would talk about seeing bodies at Roswell. when he was brought in. Daughter & sons in Colorado

HOLDEN - "I was there I saw everything." site was North of Roswell. C. Boltren Schultz - Holden told him about the craft and the bodies in July 1947 heard the radio broadcast., his two daughters been told story about crashed flying saucers since they were children. saw the military cordren near Roswell.

MARTUCCI, Major - Ancy about talking about Roswell. Reportedly made the statement during one crucial recovery flight: "We're making history." Martucci met old classmate on the tarmac at Carswell AFB who was a MORTICIAN.

RANDALL, Burid daughter of MSGT Terrance Randall, who 35 years ago told her. died 20 years ago of radation sickness, roswell to white sands exposed to raw plutonium. He mentioned that the bodies "humunoid, she asked what that ment, they looked like humans". A lot of guys took to heavy drink because of what the saw.

SECONDARY & CORROBORATORY WITNESSES

HALL, L.M. drove motorcycle for ambulance and hearse, Dennis told him a number of days after the press release, mentioned about calls for small caskets. My god, accident involved small children? Dennis said no it involved flying saucers.

HENDERSON, Sappho WIFE & FRIEND bill & Ned HENDERSON?
KROMSCHROEDER, Henderson friend saw material in 1977. "Henderson really bothered that he still couldn't get those faces out of his mind after all these years."
LOUNSBURY, W.E. Henderson friend saw material soon there after.

BREECE, James R. - Marcel deputy that weekend haven't found yet.

BRILEY, LTC Joe C. H.q. the Operations officer Blanchard at crash site for FOUR days following the press conference. Everything was "rushed up immediately."

PROCTER, Lorretta - Mac neighbor who saw the material, said it was "like a piece of tape with printing," which was "not Japanese writing." [on video].

JOYCE, Frank - Radio reporter who firsted talked to Mac Brazel and advised him to contact the Army Air Force base. [available for interview and also on video]

McGUIRE, Phyllis - Sheriff Wilcox's daughters - Said she read the story in the newspaper and then asked her father about it. Said that Wilcox's deputies went out but came back at nightfall. They went back the next day, but by then the Army had blocked the area off. [available for interview and also on video]

TULK, Elizabeth - Another Wilcox daughter, who recalls the presence of a large number of Air Force personnel and jeeps when she and her husband Jay visited her father's office. Her late husband and her *self* were apparently shown some of the material in a box in one of the jail cells which appeared to have been like "burnt brass." Tulk recalled that her father had been told by the Air Force people to "Keep his mouth shut." [available for interview and also on video]

DUGGER, Barbara - Sheriff Wilcox's granddaughter who lived for several years in the late 1960s with his widow. While watching a TV show about the space program, Mrs. Wilcox told her granddaughter, in great secrecy, about how they had recovered a "flying saucer back in the 1940s." Mrs. Wilcox also told her granddaughter, "with fear in her voice," that she was present when "MP. told George [Wilcox] and I would be killed along with our family." Sheriff Wilcox had apparently visited the one of the Sobrie fields on the evening of discovery. His widow told her granddaughter that "four beings" had been recovered. "They were grey, with large heads and silver suits." Mrs. Wilcox added that she thought that "one of them was alive." [available for interview and also on video]

STRICKLAND, Maria - Mac Brazel neighbor who said that "Mac was not supposed to talk about that material. He was told. Mac felt mistreated and abused by the government."

The memo was written by GUY HOTTEL, the Special Agent in Charge (SAC) of the important Washington DC Field Office:

DATE: March 22, 1950

They were described as being circular in shape with raised centers, approximately 12 feet in diameter. Each ONE was equipped by three bodies of human shape but only 2 feet tall, dressed in metallic armor of a very fine texture. Each body was bandaged in a manner similar to the blacked out suits used by speed flyers and test pilots.

"According to Mr. [blacked out] informant, the saucers were found in New Mexico due to the fact that the Government has a very high-powered radar setup in that area and it is believed the radar interferes with the controlling mechanism of the saucers.

"No further evaluation was attempted by SA [blacked out] concerning the above." (FBI 3-22-50)

Absolutely astounding. The description of the bodies (9 bodies apparently) and their metallic type uniforms matched rather precisely those of the military and civilian witnesses from the Roswell incident three years previous. The source for this FBI information, an "investigator for the Air Forces," the rest blanked out above, desperately NEEDS to be obtained for the best evaluation. (FOIA suit?) Even by itself, this document is an amazing admission, whose details would seem to have been corroborated other, earlier eye witnesses.

Guy HOTTEL is deceased, but any relatives and any personal papers should be located.

1) ROSWELL

When Scott and I divided up the workload, he took the Roswell episode. I provided him with my sources and he took it from there. -so his report will be more detailed. However, I thought I'd give you some thoughts, based on what I've picked up. Although my sources are convinced that there were legitimate Top Secret balloon experiments that had to be covered up, there appears to have been something else afoot. First, there seems to be no end to "strong" witnesses with good credibility, who witnessed something other than a balloon crash. Moreover, the official response is very suggestive - especially the use of full colonels as "materiel" couriers back to Washington, and Wright-Pat. However, this does not get us any closer to the truth of what happened. My interviews suggest the following avenues might be pursued:

- An all-out search should be undertaken to locate one of the most protected witnesses to the event - an Army nurse who assisted in the autopsies of the "creatures". She related her story only once, to mortician GLENN DENNIS, who gave nurse NAIOMI SELF his word that he would never reveal her name or whereabouts. Her name popped up, however, in old base records. CINDA ELSER should be authorized to spend some serious \$\$ to locate her. She has never been interviewed, in spite of being potentially THE most explosive witness at the scene.

- maintain a strong liaison with Congressman Schiff's office to be up to date on their research. I have already initiated this with CARL PFLOCK*, JACKIE KRIETH*, BILL LAPARL*, FRED WHITING*, ROB SWIATEK*, AND DON BERLINER*. They have provided me with both public, and internal Schiff documents (attached). If nothing else, these docs demonstrate that Schiff is very serious about this investigation. They also provide some good contact names and numbers at the Air Force, and elsewhere. Also attached are some of the original government documents that relate to the case.

- An effort should be made to assess, not only the materiel, but where it went, which leads us to the second category -- WRIGHT-PATTERSON AFB. Witness (US ARMY) FRANK KAUFMAN* claims to have materiel.

2) WRIGHT-PATTERSON AFB

Not only did Roswell residents recall hearing that the materiel was being transported to Wright, but early government documents seem to support this as well (attached). Of course that doesn't mean that the materiel was anything other than top secret, high tech military equipment. To determine what arrived at Wright, I sought out info from people who have worked there.

COL. ERNST KELLERSTRAUS* (USAF INTELL, ret.)

4/11/94

Growing up near Wright (and having anecdotal encounters there as a student (attached article by "Hawke", actually Kellerstrauss), he was assigned to WP in the early 1970's. His office was the very office that housed the recently disbanded OPERATION BLUEBOOK. Among other things, WP was used for storage of highly explosive silver nitrate film plates from WWI. They were stored in three cryogenic vaults. Some of story he recounted to me is the same as the one in the magazine article (attached) attributed to an "unnamed source":

-K was told by a visiting VIP USAF INTEL Officer that OPERATION BLUEBOOK was a sham, a public relations cover. This VIP would occasionally visit to go through the files to cull any serious sightings from the files and forward them to Washington. (there are actually USAF documents that admit that BLUEBOOK was a PR cover, and virtually all my sources say it is now accepted as fact). The USAF "purposely picked the dumbest officer they could find to run it. It was a cover. The real operation didn't use the name BLUEBOOK. It was run out of the NAVAL OBSERVATORY in COYOTE CANYON, near ALBERQUERQUE, NM." Earlier, in 1964, K had been in Coyote Canyon, and was curious why all the PhD heavyweights were there. He was told that it was because that's where autopsies were performed on the alien crash victims. He later visited Coyote again in 1985 when he was told by a maintenance worker that only "bits and pieces" were there, that "whole bodies" were sent to WP, and finally to LOS ALAMOS.

- In 1974, K was told by the original custodian of the vaults (he refused to name him) the following story: Sometime in the late 1940s, he was given 24 hours to clean out one of the vaults. Upon completion, he witnessed the transfer of three small bodies into the vault.

BILL LAPARL TOLD ME THAT THE NAVY DETAIL HAS THE RING OF TRUTH,

CITING THE FACT THAT THE NAVY HAS ALWAYS BEEN IN THE FOREFRONT OF SCIENCE, THAT THEY FOUNDED THE SPACE PROGRAM, AND THAT IT HAS THE LARGEST PURE INTELL ENTITY OF ANY OF THE SERVICES.

BRG. GEN. ARTHUR E. EXON* (USAF INTELL -ret.) . EXON was assigned to the Air Materiel Command at WP in the 1950s. I located, but did not interview him as the materiel is so sensitive that he has only spoken in person, and very rarely. He lives in southern California. The attached article gives detail of his story: He visited the Roswell crashsite (and described something other than a balloon crash); his workers at WP told him of the unearthly materiel received there; of the bodies found, etc. Apparently, he is on record somewhere as saying "there was more than just the Roswell wreckage brought to Wright- Patterson." The article also names three others who had some knowledge: JOHN G. TIFFANY's father who described the debris to his son; SARAH HOLCOMB, who was told by a sergeant that he was there on a special mission, and that they had brought in bodies from a flying saucer crash.

COL. JAMES MILLER - current commander of the Air Force Foreign Aerospace Science and Technology Center at W-P, said in February that base officials have extensively research the issue, in hopes that they might find some evidence. He told the Assoc. Press that although they have found no documents or artifacts, "if the object had been easily identifiable as a weather ballon, it probably would not have been brought to Wright-Patterson."

BARRY GOLDWATER - see separate section.

3) DR. ERIC WALKER*

In 1983, DR. ROBERT SARBACHER (d.), a highly respected scientist, who, according to TIM GOODE, " was a former consultant to the DOD's Research and Development Board and president and chairman of the Washington Inst. of Technology, acknowledged to researcher WILLIAM STEINMAN in a letter that the U.S. had indeed recovered both craft and bodies, and confirmed names of those involved at a high level. 'About the only thing I remember at this time is that certain materials reported to have come from flying saucer crashes were extremely light and very tough....There were also reports that instruments or people operating these machines were very light'." Sarbacher later wrote Canadian Government scientist Wilbert Smith that "the authorities were unable to duplicate the performance of the discs" and that "it is the most highly classified secret in the US Government at this time."

I have received transcripts of phone conversations between SARBACHER and researcher STANTON FRIEDMAN. SARBACHER makes it clear that he was not cleared to attend most of the Research and Development Board meetings on the subject (in the 1950s) - held at WRIGHT-PATTERSON. However, there was one man, whose name he forgot, who attended ALL of the meetings. He gave Friedman enough of the man's specific credentials (including that he was a board member, a former president of a Penn State University, and had received numerous presidential appointments) that it was only a matter of time before he was identified. In 1984 the break came. FRED DARWIN, EXEC DIRECTOR of the Guided Missile Committee for the Dept. of Defense's Research & Development Board from 1949 to 1954 responded to an inquiry by Steinman. In the letter, DARWIN stated that if such a group existed, he hypothesized and named six individuals who might be on it. Incredibly, 5 of the names would later match names on the *yet to be released* MJ-12 documents (all deceased) ! The sixth matched all of SARBACHER's criteria, and he was still alive - DR. ERIC ARTHUR WALKER. His credentials are extremely impressive (attached). It was only a matter of time before researchers STEINMAN, FRIEDMAN, and TOM MINKUS contacted WALKER (very few of the UFO buffs are in the loop on this, and no media has as yet gotten onto it). I have received transcripts of the phone conversations with WALKER and the above individuals, in which he makes some remarkable admissions. In the late 1980's, according to DAN SMITH, KIT GREENE ("BLUEJAY") met with WALKER. There was a blow up (recorded

on tape). Ever since, WALKER, who is now 84 years old, has kept mum on the subject. The following are excerpts of these transcripts (which are very persuasive), showing Walker's major admissions:

.....

"Yes, I attended meetings at Wright-Patterson on that subject matter. Why do you want to know about that?"

.....

"Yes, I know of MJ-12. I have known of them for 40 years,"

.....

"You are delving into an area that you can do absolutely nothing about. Why don't you just leave it alone and drop it? Forget about it! It's not worth it. Leave it alone!"

.....

In a separate conversation, with a different researcher:

Q: MJ-12, have you ever heard of it?

A: "For a long time now. I have nothing to do with them."

Q: Are the documents authentic?

A: "I don't think so."

Q: Who makes up the "group"?

A: "They are a handful of elite."

Q: Are you a member of that group?

A: "I cannot answer that."

.....

In another conversation:

Q: Were bodies recovered?

A: "How do you know there were bodies? Maybe they walked away. You assume too many things. Most of the things are wrong (laughs). It is none of your business. Just to satisfy your curiosity...it is not going to do any damn good except making you happy. Is it not true? Are we to change all the plans and regulations just to make you happy? If you say you are looking for the truth, you will never get it anyway, so forget it."

.....

NOTE: THIS ISSUE IS VERY SENSITIVE, AND NOONE SHOULD ATTEMPT TO CONTACT WALKER WITHOUT US MEETING ON THIS, DISCUSSING THE APPROACH IN DETAIL, WITH A THOROUGH STUDY OF THE TRANSCRIPTS.

ALSO, TIME IS OF THE ESSENCE -- 84 YEARS OLD>

4) FT. BELVOIR, VA

If Kellerstraus is accurate about the fact that BLUEBOOK was a sham, then a candidate for the real UFO HQ may be FT. BELVOIR. To the best of my knowledge (and that of my sources), no media have ever gotten on to this allegation. The attached documents from the USAF and researcher CLIFFORD STONE make it clear that the unit (the 4602d Air Intelligence Service Squadron - AISS) was set up in 1954 to oversee retrieval of ALL space debris (BLUEBOOK was set up in 1952). In a 1969 memo, BRG. GEN. C.H. BOLENDER wrote that UFOs that might affect national security "ARE NOT PART OF THE BLUEBOOK SYSTEM." In addition, routing slips obtained under FOIA show that retrievals all over the world were routinely reported to the BELVOIR Unit, and it is clear in some documents that only the FT. BELVOIR routing was blacked out. Possibly subsidiary to BELVOIR are OPERATION BLUEFLY, and OPERATION MOONDUST, which provide logistical support for the debris retrieval. This USAF admission came begrudgingly (after denials) after they were presented with FOIA documents by New Mexico Senator JEFF BINGAMAN in 1993 (attached).

5) BARRY GOLDWATER*

Goldwater's somewhat provocative statements (attached) are highlighted. I called his office and left a message. As yet I have gotten no response. I was recently heartened by the fact that he won't respond to Schiff's investigation either. The whole idea of the then-Chairman of the Armed Services Committee, and member of the following committees: Tactical Warfare, Strategic Nuclear Forces, Science, Technology, and Space, in addition to being a retired USAF Brg. General, being stonewalled by Wright-Pat is pretty amazing.

6) THE AVIARY

Beginning on Dec 11, 1984, when BILL MOORE's associate, JAMIE SHANDERA was anonymously sent the MJ-12 documents, the history of the "aviary" continues to the present. Since the MJ12 incident, a group of highly connected CIA and Military Intell. officers have communicated with researchers, claiming a desire to help them penetrate the riddle of MJ-12, and UFOs in general. They were probably given the name "aviary" by MOORE, who developed the initial sources. They all seem to point to a Super Source, above the Aviary, who knows the secrets, if he would ever talk. Rumors abound that he is in contact with the "aliens". He has been given the bird name RAVEN, although technically, he does not appear to be a "member" of the group. Because of the sensitive positions of the Aviary members, it may be worthwhile to touch bases with them.

RAVEN - - possibly DALE GRAFF, who performed contract oversight for DIA at Wright-Pat; was chief of DIA's Defense Technology/Special dept. He is now head the military UFO working group at Los Alamos, according to aviary contactee, DAN SMITH*. BILL LAPARL* has developed new info. based on talks with aviary member PELLICAN (RON PANDOLFI*) that lead him to believe RAVEN may be someone named DALE STROUGH (?) - more to come. A third possibility is JACK VORONA, who was believed to be the liaison between Capitol Hill and Los Alamos.

PELLICAN - ROLAND "RON" PANDOLFI* - Directorate of Science and Technology, CIA. Allegedly the "WEIRD DESK" at CIA, which deals with all things paranormal.

CONDOR - ROBERT M. "BOB" COLLINS*. Capt. USAF (ret.); worked at Wright-Pat w/ HAWK (KELLERSTRAUS); closely associated w/FALCON (RICK DOTY)

PENGUIN - JOHN ALEXANDER*. Referred to in HOWARD BLUM'S book as "COL. HAROLD DONNY PHILLIPS"- head of "UFO Working Group". CIA rep. to NAT. INTELL OFFICERS GROUP; gave briefing to Los Alamos on UFOs in Sept, 1993; allegedly admitted to being "Phillips." Career Army, Aerospace Laureate winning weapons specialist. Now heads the non lethal defense program at Los Alamos National Lab. I have gathered about a half dozen monographs he's written in science journals on the non lethal theory

(I've attached two reviews of his work - it is fascinating). Last year he organised a meeting called "Treatment and Research of Experienced Anomalous Trauma" which discussed, among other things, alien abductions.

CHICKADEE - SCOTT JONES*, former aide to SEN. CLAIBORNE PELL; extremely well connected, with numerous highly placed gov. sources. former ONI, runs the well funded Human Potentials Foundation (Laurence Rockefeller); claims to have info. on presidential briefings, including three sources on Carter briefing. Told STEFULA that REV. BILLY GRAHAM "holds president's hands" during UFO briefings.

BLUEJAY - DR. CHRISTOPHER "Kit" GREENE.* CIA (ret.) Pandolfi's predecessor at the Weird Desk. Now Chief of Biomedical Sciences Dept. for General Motors; claims to meet w/ VP GORE. Rumored to know of alien biology.

HAWK - ERNIE KELLERSTRAUS* (USAF RET.) - see previous section on Wright -Pat.

FALCON - RICHARD DOTY* (USAF/OSI ret.) - responsible for leaking bogus info to BILL MOORE.

SEAGULL - DR. BRUCE MACCABEE*; Naval photographic expert; a director of the Fund For UFO Research. Close friend of "KIT" GREENE (BLUEJAY)

7) PRESIDENTIAL KNOWLEDGE

EISENHOWER

WHAT IS KNOWN: While on vacation in Palm Springs on Saturday Feb 10, 1954, Ike disappeared for a number of hours, rumors of his death circulated among the press. The Press Secretary, James Haggerty, was forced to call a press conference and declare that the president suffered a dental emergency and was treated by a "local" dentist. At the Eisenhower library there is a file on dentists, but none exist for this visit. THE RUMOR: Ike was whisked to Edwards AFB and viewed aliens, and wreckage, stored in hanger 27. A British writer named DESMOND LESLIE claims to have interviewed an Air Force man who witnessed the visit. Another British Writer, BRINSLEY TRENCH, claims to know of a retired Colonel who puts a different spin on it: five alien craft landed, and the inhabitants met with the president on a diplomatic mission (these last two names come from writer TIMOTHY GOOD). Also, the controversial MJ-12 papers say that the unit was formed by Ike. And the equally controversial AQUARIUS "CARTER BRIEFING" document (attached - unearthed by BILL MOORE) recalls Ike and MJ-12.

RICHARD NIXON.

JACKIE GLEASON'S second wife, BEVERLY MCKITTRICK, recalls the star coming home one night visibly shaken. He told her that NIXON had arranged for him to see the bodies of aliens at HOMESTEAD AFB, from where he had just returned. A FOIA of HOMESTEAD revealed that Gleason was approached by a filmmaker to comment, and he would neither confirm or deny the rumor. Interestingly, BENTWATER'S witness corroborated the same story to me many years ago. I reinterviewed him for this report. The story acc. to WARREN: Jackie Gleason was obsessed with UFOs and other things paranormal (I actually believe I've heard this before). In approx. 1986, just before his death, Gleason was told by his nephew that he knew WARREN. Gleason was well aware of the BENTWATERS story and had his nephew invite WARREN to his Westchester county (NY) home. There Warren saw the largest paranormal library he had ever seen. Gleason told Warren that Nixon also was into UFOs and had a huge library. Gleason then told Warren that in 1970 he had played a day of golf with RMN near his Florida home. Later that night, Nixon appeared at Gleason's home -- ALONE, having shaken his Secret Service detail. They got into Nixon's car and heard over the CB the Secret Service frantically calling out Nixon's code name.

Nixon told Gleason that he wanted to show Gleason something he had just been shown, and had shaken him greatly. They drove to nearby HOMESTEAD AFB, went through long clearances and checkpoints, were shown into what was obviously a temporary setup in a hangar. What was inside were the remnants of a recent event. Gleason told Warren "What I saw changed my life." There were big hunks of wreckage, and about a half dozen Coca Cola coolers, each one housing a small, brownish, mutilated, burned, humanoid body. Gleason told Warren "It's all going to come out soon anyway."

JIMMY CARTER

In addition to the JACK MCGEORGE story (now disproven, but attached for your entertainment), there was a report from U.S. News (attached) which stated that Carter was to make some "unsettling disclosures" about UFO's. The disclosures never occurred. Also attached is Carter's NICAP report of his 1969 close encounter. It would be useful, not only to speak with Carter, but also his Science Advisor (?). Also attached is the mostly illegible, and controversial "CARTER BRIEFING PAPER" and a translation. It was surfaced by a "contact" of BILL MOORE.

RONALD RAYGUN

STEVEN SPIELBERG (see separate section) told this story to JAMIE SHANDERA who was doing a biographical film on him. While screening the film "E.T." for Reagan at the White House, the prez turned to him and said: "There are only a half dozen people in this room who know just how true your story is." It is not clear if Reagan was one of them.

GEORGE BUSH

UFO researcher WALT ANDRUS claims to have an audio tape of a question he put to Bush "Are there UFOs ?" Bush replied "You don't know the half of it."

8) ROBERT EMENEGGER'

A documentary filmmaker, Emenegger was in Washington in 1974, working on a PR film for the Air Force. At some point he is told that the AF will provide for him actual footage of an alien contact at Holloman AFB in New Mexico in 1970 (this is the same site for the film LEBELSON says SS Agent MCGEORGE told him about- see separate section). Although EMENEGGER never got the film, it's contents were described to him by someone who saw it -- PAUL SHARTLE of NORTON AFB. Shartle still sticks to his story, and when he confronted the Air Force, they told him it was theatrical footage. The attached book chapter describes the contents of the alleged film.

9) BENTWATERS

All of my sources are skeptical of witness LARRY WARREN's* story of seeing alien contact with US Military in Dec 1980. His story of retina burns (substantiated by his medical records), and his contemporaneous letter home to his mother describing the incident (Jan 6, 1981) are compelling (he showed me the letter a number of years ago). However, his story of contact between WING COMMANDER GORDON WILLIAMS* and the aliens on the first night of the three day event was denied vigorously by WILLIAMS to DC researcher PHILLIP KLASS. I have located WILLIAM'S address, and hope soon to get his phone number. BASE COMMANDER CHARLES HALT'S* Jan, 1981 letter (1st attachment) describes WARREN'S contemporaneous reporting of the event, which helps WARREN'S case. However, HALT only witnessed ground depressions, strange lights, and moderate radiation readings - and there are hundreds of sightings like that. In light of WILLIAM'S denial, HALT'S letter, and the relatively weak corroboration of ADRIAN BUSTINZA, and JOHN BURROUGHS (see attachments), most agree that there is virtually no way to advance the story. I concur. Also, in the April, 1994 OMNI, HALT called Warren's assertions "pure fiction."

10) STEVEN SPIELBERG*

In addition to the earlier reference to Ronald Reagan, there is a persistent rumor of Spielberg doing a UFO film based on some actual retrieval footage he has acquired. I've attached the only written references I can find to it . Also attached is a copy of the letter I wrote to his office.

11) AREA 51

I concur with all of my sources who told me "stay away from the Area 51/Nevada bunch." The hottest sources (LAZAR, LEAR, etc.) all seem to be nutso, with absolutely no evidence, with TOM BECKHAM type backgrounds. 'Nuff said? In addition, the area is so secret (legitimately), that there is no conceivable way to pry any info. from the credible employees, or the government. However, a program should at least allude to the area. The best way into this would be to interview JOHN ANDREWS* of the TESTOR CORPS. These are the folks who have spent the most time spying on the government there to make their highly successful model airplanes (STEALTH, AURORA) well in advance of government disclosures. They are incredibly good at their sleuthing, as the later government admissions attest. ANDREWS, who is charge of the sleuthing, has never seen a UFO there, nor have his minions.

HARVEY JACK MCGEORGE / JIMMY CARTER BRIEFING

WAS IN SPECIAL FORCES RESERVE, GREEN BERETS, FORT BRAGG, NORTH CAROLINA; ALSO AFFILIATED WITH FORT DRUM (?) HE WAS WITH THE SECRET SERVICE DURING THE CARTER YEARS. HE IS SAID TO HAVE RECENTLY BEEN THE DIRECTOR OF AN ANTI TERRORIST SCHOOL, INSTRUCTING IN EVASIVE DRIVING TECHNIQUES, ETC. ALSO THOUGHT TO BE IN GEORGIA. I SPOKE WITH A NUMBER OF SECRET SERVICE PERSONNELLE WHO REMEMBERED HIM IN THE TECHNICAL DIVISION, BUT HAVE YET TO LOCATE HIM. HE DOES NOT TURN UP DEAD ON THE NATIONAL DEATH INDEX.

Sometime in the 1980's, McG gave an account to a friend who in turn told HARRY LABELSON, then of OMNI magazine, (last known P.O. Box 19-0917, Miami Beach, FL 33119- no phone found). I obtained a tape of Labelson from BILL LAPAPL (508)435-4961, in which he relates the story. Below is a transcript of the relevant portions:

"Jack McGeorge was a member of the Special Forces, Green Beret who now runs a school for anti terrorist tactics for the preparation of presidential bodyguards. I was introduced to him by a contact who met him at Camp Drum (?), the training site for Green Berets).

McGeorge held an incredible position in the Jimmy Carter White House. He was advisor for national and international terrorism, and his office was located one floor below Carter's. What's unique about Jack McGeorge is that he was also a member of the Secret Service, and he was the first member of the Secret Service, outside of the chief of the Secret Service, to have witnessed a presidential briefing on UFO's. The reason McGeorge was allowed to attend was because during his tenure at the White House he had struck up a friendship with Jimmy Carter. Carter considered him a close personal friend and confided in him on confidential matters about twice a day. So upon Carter's insistence, and in spite of protestations from the National Security Agency, McGeorge was allowed to attend the briefing session on UFO's given to Jimmy Carter. There were two briefings given to Carter. McGeorge attended at least the initial briefing. He told my contact the following regarding the briefing:

Once the president was in the room, seated at a table, Jack McGeorge at another table, a member of NSA gave an overall briefing on the phenomenon, stating it's historical characteristics and bringing it up to the present time. At that point a number of documents describing the evolutionary habits of the beings, the reasons they were here and other matters of that consequence were shown to Jimmy Carter. The next thing to be shown to Jimmy Carter was a 15 minute film

taken at HOLLAMAN AFB in which UFO inhabitants and military personelle made physical contact. It is a color film. After that were more briefings by national security people - and basically that was the end of the briefing. McGeorge, being a very observant person, noticed that on re-entering Carter's office about a half hour after the briefing - and I know this is going to be hard to believe - but he stated that Carter had tears in his eyes.

According to McGeorge, the two main reasons the government is withholding the truth about UFO's are the religious question, and the fact that we do not have control of the situation. 'They' are in charge. According to McGeorge, if the Bible said that God created the Heaven and Earth, then what the hell do the aliens believe in? The thing that the aliens fear the most is that man would find out that that we are not the creation of an omnipotent supreme being, but possibly the creation of these aliens themselves - that we are a genetic experiment. And they also fear greatly that religion, as a controlling factor on behavior in the world - if the truth was known that that controlling factor would immediately be destroyed and there might be anarchy. The second reason - that we are not in control - I think is pretty obvious."
