| 1415 | Signal Duty Officer reports that the courier plane will not leave Andrews until 2000. Pouch will close at 1800 since courier has to be at airfield at 1900. Informed Nash's office. |
| 1545 | William Buffum, State Internat'l Org., called and asked if we could have a letter from Am. Goldberg to the President delivered to the President at the Ranch. Told him to send the letter and we would get it to the Ranch. |
| 1720 | FAA reports a mid-air collision between a TWA 707 and an Eastern Airlines Constellation near Danbury Conn. Informed Maj. Robinson at the Ranch. |
| 1722 | Califano's office informed sitroom that they would have material to go to the Ranch by plane but it would not be ready until 1900. Called Col. Cross and asked if it was necessary could the plane be held up for awhile. He said it could be done. |
| 1920 | Pouch closed. Califano has released aircraft for the flight. |
| 2030 | Will Sparks, press office, asked that we send Mr. Valenti a copy of a messg. sent earlier to the President. Mr. Valenti wants the material at his home in the AM. |
| 2043 | Califano says that Jacobsen wants to be kept informed on the investigation of the mid-air collision. Sent a detailed summary of the accident to the Ranch. |
| 2230 | Jacobsen said to keep the FAA reports on the collision coming all night. During after duty hours com center at the Ranch will hold the reports until OOB. |
| 0430 | NMCC reports that an A4e Skyhawk has rolled off the deck of the carrier Ticonderoga. The aircraft was carrying a _____ . Reported this info to Maj. Robinson at the Ranch. He will notify the President when he awakens in the AM. NMCC has not notified the Secretary yet. They will do so in the AM. AEC has been notified of the incident. <i>16,000 ft</i> |
| 0730 | Material sent to Valenti's residence. See 2030 entry. |
