

PETITION TO INDICT

The Government of these United States of America, having been formed under the Constitution and having been duly elected and appointed by the people of these United States of America under the terms of the Constitution, has violated the public trust, terms, conditions and laws of the land as outlined and enshrined within the Constitution of these United States of America.

- To Wit:
- (1) The government has approved and entered into a secret treaty with an Alien Nation against the terms of the Constitution and without the advise and consent of the Congress or the people.
 - (2) The government in this treaty has given this Alien Nation land and bases within the borders of these United States of America.
 - (3) The government in this treaty has traded human lives and property for the alien technology and has denied the citizens of these United States of America the lawful protection due them under the Constitution. The property is in the form of livestock and land.
 - (4) In the taking of human lives, property and livestock of the citizens of these United States and in the commission of numerous other abominable and barbarous acts, this Alien Nation has proven to be the mortal enemy of the people, the nation, and all of humanity. Abductions, surgical operations, implantations, biological sampling, impregnations, psychological damage, and other horrors have been and are being performed upon humans by this Alien Nation. For these reasons a state of war now exists and has existed between the people of the United States and this Alien Nation.
 - (5) In approving of, and participating in the crimes outlined in paragraphs 1, 2, 3, and 4 above, the government is in violation of Article II Section 2, Article III Section 3 and several other Articles of the Constitution, and is guilty of and is hereby charged with conspiracy, murder and treason against the people and the Constitution of these United States of America.
 - (6) In the process of aiding and abetting the Alien Nation in the performance of these crimes against the people, the Nation, and humanity, the government, with full knowledge and consent, has murdered, incarcerated, forcibly relocated, brainwashed, drugged,

harassed and otherwise interfered unlawfully in the lives of patriots, including a President of the United States, who have attempted to expose this murder and treason.

- (7) To keep this secret from the Congress and from the people of these United States of America, the Government has financed its Alien involvement through the importation and sale of illegal narcotics to the nations people and specifically to the nations youth. The Central Intelligence Agency has been and continues to be the main instrument in the control of the worlds drug market. "The use of illegal narcotics to finance the Alien connected projects and other black projects will identify and eliminate the weak elements of our society", is the rationalization used by the Government to justify these heinous and treasonous acts.
- (8) In the pursuit of bringing all those in or out of the government who are responsible for these acts of conspiracy, murder and treason to justice, the Trilateral Commission, the President, Vice President, the Director of Central Intelligence, certain other members of the Central Intelligence Agency, the Director of the National Security Agency, certain members of the President's Cabinet, the Joint Chiefs of Staff, those people designated MAJORITY, MAJORITY TWELVE, MJ-12, MAJORITY AGENCY FOR JOINT INTELLIGENCE (MAJI), the JASON SOCIETY or JASON SCHOLARS, the DIRECTOR of the SENIOR INTERAGENCY GROUP (SIG), the National Security Advisor to the President, the Navy Department which has field operational control of all Alien connected projects, and others having taken part in the joint government and alien conspiracy are hereby charged with conspiracy murder and treason. This is to include all those who served in these positions from 1953 up to and including the present administration.
- (9) We call for the impeachment of the President of these United States, George Bush. He has been a member of MJ-12 and the Trilateral Commission since he was the President and CEO of Zapata Oil. George Bush organized and has headed the narcotics smuggling conspiracy since its beginning. The offshore oil platforms of Zapata Oil were used as staging areas from which the drugs were moved into these United States from Central and South America without passing through customs or undergoing inspection of any kind. We firmly believe that George Bush now heads this shadow government that controls the Alien

technology, the military industrial complex, and thus the Nation. The fact that he is now the President of these United States of America makes George Bush the most powerful and dangerous criminal in the history of the world.

- (10) In the interest of preserving the Constitution and the government of these United States of America, and to save and protect the human race, and for no other reason, we bring these charges by the authority of the Constitution of these United States of America, against those named who had full knowledge of and who willfully participated in the violations of Article II Section 2, Article III Section 3 and several other Articles of the Constitution of these United States of America. The government and those individuals named in paragraph 8 and 9 are hereby charged with conspiracy, murder and treason.
- (11) In the interest of preserving the Constitution and the government of these United States of America, we ask full pardon in exchange for full disclosure. We ask the Judicial branch of the government to honor this request for all guilty conspirators who voice full disclosure by May 30, 1989. We ask the Judicial branch to give no mercy to those who persist in this conspiracy, murder and treason.
- (12) We hereby, and in the name of the people and by the authority of the constitution, charge the government to cease aiding and abetting and concealing this Alien Nation which exists within our borders. We charge the government to cease all conspiracies, operations, projects, treaties, and any other involvement with this Alien Nation. We charge the government to order this Alien Nation and all of its members to leave the United States and this earth immediately, now and for all time, by November 1, 1989, and we charge the government to enforce this order. We further charge the government to make a complete disclosure of its alien conspiracy to the American people prior to May 30, 1989 and to make a full accounting for its actions. We charge the Congress to order this to be done and we charge the Congress to enforce this order.
- (13) Should the Executive, Judicial, and Legislative branches choose to ignore these charges, we hereby swear upon the Constitution that we will not rest until this conspiracy and these crimes are exposed

to the American people. We swear on the Constitution that all guilty parties shall be brought to justice. We swear that we will persist until our death to accomplish these ends in the name of humanity, the Constitution of these United States of America, and in the name of all true patriots who have gone before us, we do so swear.

- (14) We firmly believe and know and have evidence that this conspiracy and these crimes and charges are true and have occurred and is now true and is now occurring and were and are perpetrated, aided and abetted by those so charged. This we do swear.
- (15) We hereby, and upon delivery of this document to the members of the Senate and House of Representatives of the Congress of these United States of America, serve notice to the world that these charges and this document are now and forever recorded in history. This document and these charges will not and cannot ever be revoked by any act, present or future. History alone will be the judge should the Congress fail to act and we have no fear of that judgement. We hereby warn each member of the Senate and the House of Representatives of the Congress of these United States of America that failure to act upon these charges will forever brand each and every one of you as accessories to the conspiracy and the crimes outlined in this document. Your children, grand-children, great grand-children, and the present and future generations of the people of these United States of America will not forget and will never forgive. We warn you now and forever that these United States of America, the Constitution, and Freedom, has never been in greater danger. We hope and pray that it is not already too late to save the Nation.

Being of sound mind and body and with full knowledge of the implications and consequences of these charges and having only the interest of saving humanity, preserving the Constitution of these United States, preserving the government of these United States, and, being patriots, having sworn to preserve and protect the Constitution of these United States of America do affix our signature to this document in full affirmation of our dedication and commitment to our sworn duty.

Hi Steve,

I'm not sure you've been up on Lambda, but perhaps you have read my rather caustic response, LANG.RES regarding the Lear issue. I have reason to believe that my initial reactions were inappropriate. I have been enlightened regarding the mission of these forums. Our impatience to get all the info yesterday has led many, including me, to be premature in drawing conclusions. I'm not sure we haven't pressed this issue too hard too soon without awaiting reaction time.

I have interviewed Mr. Lear and while I have many questions regarding the nature of his material, I'm willing to give him a chance to present his case. I have found him anxious to do so, and I'm sure he would be open to developing a similar arrangement with Alpha. We're supposed to be acting in a professional manner on these issues, yet we tend to forget that we're human beings with fears, reflex reactions, an imprecise language, and whether we like it or not... our own biases regarding the UFO issue.

At one time I too experienced a sighting, with witnesses, which I recorded on paper at the time. I never released it because I was afraid of just the reaction Lear.txt has received. Ironically, I was one of the first to put my emotions before my head in dealing with the issue... not a good position for the sysop of such a BBS! Why? Because Lear's contentions conflicted with my idealized view of benevolent beings from space being necessarily committed to the same values and ideals as we here in western civilization. Examples from our own world, even our august group of open minded skeptics in the Paranet system, have altered this view. If we can't

take the time to give the guy a chance to support his views,, then what are we doing this for in the first place? Are we all, as Jim pointed out, fantasy prone even at the level of discussion? John has agreed to share this resource of evidence with Lambda in the next few days by mail.

Perhaps Alpha will be afforded the same opportunity if the climate here was a little less hostile. It took a few days for Lambda to come around, but we have... and now, with an OPEN mind, we're going to have the opportunity to see just what Mr. Lear has to share.

First of all, I want to thank you for taking the time to participate in the interview of 02/03/88. I do however, feel that its appropriate that I make a statement of my own regarding the issue at hand.

During the interview, I tried to remain neutral and ask questions that may be helpful to those users who have clamored for more information. I believe that I have met this responsibility.

For myself, I'm afraid that I find a great deal of the material wanting in proof, or even reasonable expectations for such an advanced culture. You have said that these are the facts, but without proving these facts in some objective, verifiable way, you must understand that your allegations are without substance. If you are sincere about establishing the validity of your claims, you're going to have to go openly public on a nationwide basis with credible witnesses, dates, times, records, physical evidence, and whatever means possible to support what you are saying.

I'm not saying that within the framework of your story, there are not elements of strangeness that have been reported in other media at different times in the last 40 years. All I'm saying is that the statement without proof is doing more to harm credible UFO research than it is helping it. I hope this was not your intention, but lets look at this objectively, the story makes alot of the material you read in the tabloids pale by comparison..."Insects From Space Align with US to Harvest Human Enzymes!" You've got to admit, that sounds pretty silly.

My final point is one that regards my beliefs about intelligence in the universe and is no more valid than your contentions, but given a civilization "BILLIONS" of years advanced beyond us, I'm very dubious that they would even need bodies let alone spaceships... the more primitive instincts would be barely a race memory. I can't buy the "backside of an evolutionary curve" theory either. I don't even know what that means! De-evolve? De-evolve to me is nonsense. Evolution is an adaptive process that moves in the direction of greatest survivability. John Lear, a captain for a major US Airline has flown over 160 different types of aircraft in over 50 different countries. He holds 17 world speed record in the Lear Jet and is the only pilot ever to hold every airline certificate issued by the Federal Aviation Administration. Mr. Lear has flown missions worldwide for the CIA and other government agencies. A former Nevada State Senator candidate, he is the son of William P. Lear, designer of the Lear Jet executive airplane, the 8-track stereo, and founder of Lear Siegler Corporation. Lear became interested in the subject of UFO's 13 months ago after talking with United States Air Force Personnel who had witnessed a UFO landing at Bentwaters AFB, near London, England, and three small aliens walking up to the Wing Commander.

Note to the Press:

The government of the United States continues to rely on your personal and professional gullibility to suppress the information contained herein. Your cooperation over the past 40 years has exceeded our wildest expectations and we salute you.

"The sun does not revolve around the Earth"

"The United States Government has been in business
with little gray extraterrestrials for about 20 years"

The first truth stated here got Giordano Bruno burned at the stake in AD 1600 for daring to propose that it was real. The second truth has gotten far more people killed trying to state it publicly than will ever be known.

But the truth must be told. The fact that the Earth revolves around the sun was successfully suppressed by the church for over 200 years. It eventually cause a major upheaval in the church, government, and thought. A realignment of social and traditional values. That was in the 1800's.

Now, about 400 years after the first truth was pronounced we must again face the shocking facts. The "horrible truth" the government has been hiding from us over 40 years. Unfortunately, the "horrible truth" is far more horrible than the government ever imagined.

In its effort to protect democracy, our government sold us to the aliens. And here is how it happened. But before I begin, I'd like to offer a word in the defense of those who bargained us away. They had the best of intentions.

Germany may have recovered a flying saucer as early as 1939. General James H. Doolittle went to Sweden in 1946 to inspect a flying saucer that had crashed there in Spitzbergen.

The "horrible truth" was known by only a very few persons: They were indeed ugly little creatures, shaped like praying mantises and who were more advanced than us by perhaps a billion years. Of the original group that were the first to learn the "horrible truth", several committed suicide, the most prominent of which was General James V. Forrestal who jumped to his death from a 16th story hospital window. General Forrestal's medical records are sealed to this day.

President Truman quickly put a lid on the secret and turned the screws so tight that the general public still thinks that flying saucers are a joke. Have I ever got a surprise for them.

In 1947, President Truman established a group of 12 of the top military scientific personnel of their time. They were known as MJ-12. Although the group exists today, none of the original members are still alive. The last one to die was Gordon Gray, former Secretary of the Army, in 1984. As each member passed away, the group itself appointed a new member to fill the position. There is some speculation that the group known as MJ-12 expanded to at least several more members.

There were several more saucer crashes in the late 1940's, one in Roswell, New Mexico, one in Aztec, New Mexico, and one near Laredo, Texas, about 30 miles inside the Mexican border.

Consider, if you will, the position of the United States Government at that time. They proudly thought of themselves as the most powerful nation on Earth, having recently produced the atomic bomb, and achievement so stupendous, it would take Russia 4 years to catch up, and only with the help of traitors to Democracy. They had built a jet aircraft that had exceeded the speed of sound in flight. They had built jet bombers with intercontinental range that could carry weapons of enormous destruction. The post war era, and the future seemed bright. Now imagine what it was like for those same leaders, all of whom had witnessed the panic of Orson Wells' radio broadcast, "The War of the Worlds", in 1938. Thousands of Americans panicked at a realistically presented invasion of Earth by beings from another planet. Imagine their horror as they actually viewed the dead bodies of these frightening looking little creatures with enormous eyes, reptilian skin and claw like fingers. Imagine their shock as they attempted to determine how these strange "saucers" were powered and could discover no part even remotely similar to components they were familiar with: no cylinders or pistons, no vacuum tubes or turbines or hydraulic actuators. It is only when you fully understand the overwhelming helplessness the government was faced with in the late 40's that you can comprehend their perceived need for a total, thorough and sweeping cover up, to include the use of "deadly force".

The cover-up was so successful that as late as 1985 a senior scientist with the Jet Propulsion Laboratory in Pasadena, California, Dr. Al Hibbs, would look at a video tape of an enormous flying saucer and state the record, "I'm not going to assign anything to that (UFO) phenomena without a lot more data". Dr. Hibbs was looking at the naked emperor and saying, "He certainly looks naked, but that doesn't prove he's naked."

In July of 1952, a panicked government watched helplessly as squadron of

"flying saucers" flew over Washington, D.C., and buzzed the White House, the Capitol Building, and the Pentagon. It took all the imagination and intimidation the government could muster to force that incident out of the memory of the public.

Thousands of sightings occurred during the Korean war and several more saucers were retrieved by the Air Force. Some were stored at Wright-Patterson Air Force Base, some were stored at Air Force bases near the location of the crash sight.

One saucer was so enormous and the logistic problems in transportation so enormous that it was buried at the crash sight and remains there today. The stories are legendary on transporting crashed saucers over long distances, moving only at night, purchasing complete farms, slashing through forests, blocking major highways, sometimes driving 2 and 3 lo-boys in tandem with and extraterrestrial load a hundred feet in diameter.

On April 30, 1964, the first communication between these aliens and the U.S. Government took place at Holloman Air Force Base in New Mexico. 3 saucers landed at a prearranged area and a meeting was held between the aliens and intelligence officers of the U.S. Government.

During the period of 1969-1971, MJ-12 representing the U.S. Government made a deal with these creatures, called EBE's (Extraterrestrial Biological Entities, named by Detley Bronk, original MJ-12 member and 6th President of Johns Hopkins University). The "deal" was that in exchange for "technology" that they would provide to us, we agreed to "ignore" the abductions that were going on and suppress information on the cattle mutilations. The EBE's assured MJ-12 that the abductions (usually lasting about 2 hours) were merely the ongoing monitoring of developing civilizations.

In fact, the purposes for the abductions turned out to be:

- (1) The insertion of a 3mm spherical device through the nasal cavity of the abductee into the brain. the device is used for the biological monitoring, tracking, and control of the abductee.
- (2) Implementation of Posthypnotic Suggestion to carry out a specific activity during a specific time period, the actuation of which will occur within the next 2 to 5 years.
- (3) Termination of some people so that they could function as living sources for biological material and substances.
- (4) Termination of individuals who represent a threat to the continuation of their activity.
- (5) Effect genetic engineering experiments.
- (6) Impregnation of human females and early termination of pregnancies to secure the crossbreed infant.

The U.S. Government was not initially aware of the far reaching consequences of their "deal". They were led to believe that the abductions were essentially benign and since they figured the abductions

would probably go on anyway whether they agreed or not, they merely insisted that a current list of abductees be submitted, on a periodic basis, to MJ-12 and the National Security Council. Does this sound incredible? An actual list of abductees sent to the National Security Council? Read on, because I have news for you.

The EBE's have a genetic disorder in that their digestive system is atrophied and not functional. Some speculate that they were involved in some type of accident or nuclear war, or possibly on the back side of an evolutionary genetic curve. In order to sustain themselves they use an enzyme or hormonal secretion obtained from the tissue that they extract from humans and animals. (Note: Cows and Humans are genetically similar. In the event of a national disaster, cow's blood can be used by humans.)

The secretions obtained are then mixed with hydrogen peroxide and applied on the skin by spreading or dipping parts of their bodies in the solution. The body absorbs the solution, then excretes the waste back through the skin. The cattle mutilations that were prevalent throughout the period from 1973 to 1983 and publicly noted through newspaper and magazine stories and included a documentary produced by Linda Howe for the Denver CBS affiliate KMGH-TV, were for the collection of these tissues by the aliens. The mutilations included genitals taken, rectums cored out to the colon, eyes, tongue, and throat all surgically removed with extreme precision. In some cases the incisions were made by cutting between the cells, a process we are not yet capable of performing in the field. In many of the mutilations there was no blood found at all in the carcass, yet there was no vascular collapse of the internal organs. This has been also noted in the human mutilations, one of the first of which was Sgt. Jonathan P. Louette at the White Sands Missile Test Range in 1956, who was found three days after an Air Force Major had witnessed his abduction by a "disk shaped" object at 0300 while on a search for missile debris downrange. His genitals had been removed, rectum cored out in a surgically precise "plug" up to the colon, eyes removed and all blood removed with, again, no vascular collapse. From some of the evidence it is apparent that this surgery is accomplished, in most cases, while the victim, animal or human, is still alive.

The various parts of the body are taken to various underground laboratories, one of which is known to be near the small New Mexico town of Dulce. This jointly occupied (CIA-Alien) facility has been described as enormous, with huge tiled walls that "go on forever". Witnesses have reported huge vats filled with amber liquid with parts of human bodies being stirred inside.

After the initial agreement, Groom Lake, one of this nation's most secret test centers, was closed for a period of about a year, sometime between about 1972 and 1974, and a huge underground facility was constructed for and with the help of the EBE's. The "bargained for" technology was set in place but could only be operated by the EBE's themselves. Needless to say, the advanced technology could not be used against the EBE's themselves, even if needed.

During the period between 1979 and 1983 it became increasingly obvious to MJ-12 that things were not going as planned. It became known that many more people (in the thousands) were being abducted than were listed on the official abduction lists. In addition it became obvious that some, not all, but some of the nation's missing children had been used for secretions and other parts required by the aliens.

In 1979 there was an altercation of sorts at the Dulce laboratory. A special armed forces unit was called in to try and free a number of our people trapped in the facility, who had become aware of what was really going on. According to one source, 66 of the soldiers were killed and our people were not freed.

By 1984, MJ-12 must have been in stark terror at the mistake they had made in dealing with the EBE's. They had subtly promoted "Close Encounters of the Third Kind" and "E.T." to get the public used to "odd looking" aliens that were compassionate, benevolent and very much our "space brothers". MJ-12 "sold" the EBE's to the public, and were now faced with the fact that quite the opposite was true. In addition, a plan was formulated in 1968 to make the public aware of the existence of aliens on earth over the next 20 years to be culminated with several documentaries to be released during 1985-1987 period of time. These documentaries would explain the history and intentions of the EBE's. The discovery of the "Grand Deception" put the entire plans, hopes and dreams of MJ-12 into utter confusion and panic.

Meeting at the "Country Club", a remote lodge with private golf course, comfortable sleeping and working quarters, and its own private airstrip built by and exclusively for the member of MJ-12, it was a factional fight of what to do now. Part of MJ-12 wanted to confess the whole scheme and shambles it had become to the public, beg their forgiveness and ask for their support. The other part (and majority) of MJ-12 argued that there was no way they could do that, that the situation was untenable and there was no use in exciting the public with the "horrible truth" and that the best plan was to continue the development of a weapon that could be used against the EBE's under the guise of "SDI", the Strategic Defense Initiative, which had nothing whatsoever to do with a defense for inbound Russian nuclear missiles. As these words are being written, Dr. Edward Teller, "father" of the H-Bomb is personally in the test tunnels of the Nevada Test Site, driving his workers and associates in the words of one, "like a man possessed". And well he should, for Dr. Teller is a member of MJ-12 along with Dr. Kissenger, Admiral Bobby Inman, and possibly Admiral Poindexter, to name a few of the current members of MJ-12.

Before the "Grand Deception" was discovered and according to a meticulous plan of metered release of information to the public, several documentaries and video tapes were made. William Moore, a Burbank, California, based UFO researcher who wrote "The Roswell Incident", a book published in 1980 that detailed the crash, recovery and subsequent cover-up of a UFO with 4 alien bodies, has a video tape of 2 newsmen interviewing a military officer associated with MJ-12. This military officer answers questions relating to the history of MJ-12 and the cover-up, the recovery of a number of flying saucers and the existence of a live alien (one of 3 living aliens captured and designated, or named, EBE-1, EBE-2, and EBE-3, being held in a facility designated as YY-II at Los Alamos, New Mexico. The only other facility of this type, which is electromagnetically secure, is at Edwards Air Force Base in Mojave, California). The officer names as previously mentioned plus a few others: Harold Brown, Richard Helms, Gen. Vernon Walters, JPL's Dr. Lew Allen and Dr. Theodore von Karman, to name a few of the current and past members of MJ-12.

The officer also relates the fact that the EBE's claim to have created Christ. The EBE's have a type of recording device that has recorded all of Earth's history and can display it in the form of a hologram. This

hologram can be filmed but because of the way holograms work does not come out very clear on movie film or video tape. The crucifixion of Christ on the Mount of Olives has allegedly been put on film to show the public. The EBE's claim to have created Christ, which, in view of the "Grand Deception", could be an effort to disrupt traditional values for undetermined reasons.

Another video tape allegedly in existence is an interview with an EBE. Since EBE's communicate telepathically, and Air Force Colonel serves as an interpreter. Just before the recent stock market correction in October of 1987, several newsmen, including Bill Moore, had been invited to Washington, D.C., to personally film the EBE in a similar type interview, and distribute the film to the public. Apparently, because of the correction in the market, it was felt the timing was not propitious. In any case, it certainly seems like an odd method to inform the public of extraterrestrials, but it would be in keeping with the actions of a panicked organization who at this point in time doesn't know which way to turn.

Moore is also in possession of more Aquarius documents, a few pages of which leaked out several years ago and detailed the supersecret NSA project which had been denied by them until just recently. In a letter to Senator John Glenn, NSA's Director of Policy, Julia B. Wetzel, wrote, "Apparently there is or was an Air Force project with that name (Aquarius) which dealt with UFO's. Coincidentally, there is also an NSA project by that name." NSA's project Aquarius deals specifically with the "communications with the aliens" (the EBE's). Within the Aquarius program was project "Snowbird", a project to test-fly a recovered alien aircraft at Groom Lake, Nevada. This project continues today at that location. In the words of an individual who works at Groom Lake, "Our people are much better at taking things apart than they are at putting them back together."

Moore, who claims he has a contact with MJ-12, feels that they have been stringing him along, slipping him documents and providing him leads, promising to go public with some of the information on extraterrestrials by the end of 1987.

Certain of Moore's statements lead one to believe that Moore himself is a government agent working for MJ-12, not to be strung along, but string along ever hopeful UFOlogists that the truth is just around the corner. Consider:

1. Moore states emphatically that he is not a government agent, although when Lee Graham (a Southern California based UFOlogist) was investigated by DIS (Defense Investigative Service) for possession of classified documents received from Moore, Moore himself was not.
2. Moore states emphatically that the cattle mutilations of 1973-1983 were a hoax by Linda Howe (producer of "A Strange Harvest") to create publicity for herself. He cites the book "Mute Evidence" as the bottom line of the hoax. "Mute Evidence" was a government sponsored book to explain the mutilations in conventional terms.
3. Moore states that the U.S.A.F. Academy physics book, "Introductory Space Science", vol. II chapter 13, entitled "Unidentified Flying Objects", which describes four of the most commonly seen aliens (one of which is the EBE)

was written by Lt. Col. Edward R. Therkelson and Major Donald B. Carpenter, Air Force personnel who did not know what they were talking about and were merely citing "crackpot" references. He, Moore, states that the book was withdrawn to excise the chapter.

If the government felt they were being forced to acknowledge the existence of aliens on Earth because of the overwhelming evidence such as the October and November sightings in Wytheville, Va., and recently released books such as "Night Siege" (Hynek, J. Allen; Imbrogno, Phillip J.; Pratt, Bob; Night Siege, Ballantine Books, Random House, New York), and taking into consideration the "grand deception" and obviously hostile intentions of the EBE's, it might be expedient for MJ-12 to admit the EBE's but conceal the information on the mutilations and abductions. If MJ-12 and Moore were in some kind of agreement then it would be beneficial to Moore to tow the party line. For example, MJ-12 would say... "here are some more genuine documents... but remember... no talking about the mutilations or abductions". This would be beneficial to Moore as it would supply the evidence to support his theory that E.T.'s exist but deny the truths about the E.T.'s. However, if Moore was indeed working for MJ-12, he would follow the party line anyway... admitting the E.T.'s but pooch pooch the mutilations and abductions. If working alone, Moore might not even be aware of the "grand deception".

Time will tell. It is possible that Moore will go ahead and release the video interview with the military officer around the first of the year, as he has promised. From MJ-12's point of view, the public would be exposed to the information without really having to believe it because Moore is essentially not as credible a source as, say, the President of the United States. After a few months of digestion and discussion, a more credible source could emerge with a statement that yes in fact the interview was essentially factual. This scenario would cushion somewhat the blow to the public. If, however, Moore does not release the tape by, say, February 1 of 1988, but comes instead with a story similar to: "MJ-12 has informed me that they are definitely planning a release of all information by October of 88. I have seen the plan and have seen the guarantee that this will happen, so I have decided to withhold the release of my video tape at this time as it may cause some problems with MJ-12's plans." This would in effect buy more time for MJ-12 and time is what they desperately need.

Now you ask, "Why haven't I heard about any of this?" Who do you think you would hear it from? Dan Rather? Tom Brokaw? Sam Donaldson? Wrong. These people just read the news, they don't find it. They have ladies who call and interview witnesses and verify statements on stories coming over the wire (either AP or UPI). It's not like Dan Rather would go down to Wytheville, Virginia, and dig into why there were 4 THOUSAND reported sightings in October and November of 1987. Better that Tom Brokaw or someone else should risk their credibility on this type of story. Tom Brokaw? Tom wants Sam Donaldson to risk his credibility. No one, but no one, is going to risk their neck on such outlandish ideas, regardless of how many people report sightings of 900 foot objects running them off the road. In the case of the Wytheville sightings, dozens of vans with NASA lettered on the side failed to interest newsmen. And those that asked questions were informed that NASA was doing a weather survey.

Well then, you ask, what about our scientists? What about Carl Sagan? Isaac Asimov? Arthur C. Clarke? Wouldn't they have known? If Carl Sagan knows then he is committing a great fraud through the solicitation

of memberships in the Planetary Society, "to search for extraterrestrial intelligence". Another charade into which the U.S. Government dumps million of dollar every year is the radiotelescope in Arecibo, Puerto Rico, operated by Cornell University with - guess who? - Carl Sagan. Cornell is ostensibly searching for signals from Outer Space, a sign maybe, that somebody is out there. It is hard to believe that relatively intelligent astronomers like Sagan could be so ignorant.

What about Isaac Asimov? Surely the most prolific science fiction writer of all time would have guessed by now that there must be an enormous cover-up? Maybe, but if he knows he's not saying. Perhaps he's afraid that Foundation and Empire will turn out to be inaccurate.

What about Arthur C. Clarke? Surely the most technically accurate of Science Fiction writers with very close ties to NASA would have at least a hint of what's really going on. Again, if so he isn't talking. In a recent Science Fiction survey, Clarke estimates that contact with extraterrestrial intelligent life would not occur before the 21st Century.

If the government won't tell us the truth and the major networks won't even give it serious consideration, then what is the big picture, anyway? Are the EBE's, having done a hundred thousand or more abductions (possibly millions worldwide), built an untold number of secret underground bases (Groom Lake, Nevada; Sunspot, Datil, Roswell, and Pine Town, New Mexico, just to name a few) getting ready to return to wherever they came from? Or, from the obvious preparations are we to assume that they are getting ready for a big move? Or is the more sinister and most probable situation that the invasion is essentially complete and it is all over but the screaming?

A well planned invasion of Earth for it's resources and benefits would not begin with mass landings of ray-gun equipped aliens. A properly planned and executed invasion by a civilization thousands and probably hundreds of thousands of years in advance of us would most likely be complete before even a handful of people, say 12?, realized what was happening. No fuss, no muss. The best advice I can give you is this: Next time you see a flying saucer and are awed by its obvious display of technology and gorgeous lights of pure color - RUN LIKE HELL!

Robeert _____, a young man in his early 20's came to work at my shop as a temporary help during the 2nd week of October 1986. The first day at work, he approached me asking about my interest in the UFO phenomenon. Then he smiled, paused, and waited for my reaction. I told him that I was interested, particularly in the crash/recovery of saucers and bodies of occupants. That I was secondly interested in the rumors pertaining to an "alien" and intelligence group alliance set up years ago.

He then told me he would reveal something to me pertaining to my second interest as mentioned above. He told me the following (condensed by me):

1. He was in the military headquartered with the 4th Engineering Group at Fort Carson, Colorado. Just got out 2 months prior to the date of telling me this.
2. He showed me a military I.D. card from Fort Carson and another with a strange checker board design on it.
3. He said he had a Super Top Secret clearance and worked as a laboratory assistant in southwestern Colorado associated with the Delta Group out of Fort Carson.
4. He witnessed cryogenic experimentation going on with human beings. This experimentation was conducted by both "aliens" and some Super Secret intelligence group.
5. "Some high ranking military and scientific personnel were taken down to cryogenic temperatures through a process of draining their blood and pumping a chemical mixtur into the circulatory system to prevent cell destruction during the freezing and thawing periods." "The "aliens" were the only ones who knew the mixture formula and the gradual thawing process. They at first refused to give the formula and process to the scientific team, and threatened to leave the above mentioned personnel in that cryogenic state forever unless the scientists cooperated on some certain issues."
6. He also told me about some "alien" technics concerning time travel, Dimensional travel, related to unified field physics.

After revealing these seemingly fantastic things to me over a 3 week period of time he quit the temporary job here. I finally found out that his father Robert _____ Sr. (Robert used to be Robert _____ Jr. before his father and mother divorced and he took the name of his mothers second husband, _____.) worked with me in the metal finishing department. The following was told to me by Robert _____ Sr. on Dec 16, 1986:

"On the evening of Wednesday, Dec. 3, 1986, my son Robert _____ called me via the telephone (he hadn't been home for over a week) he soundeed as if he were scared to death. He

said I have to go back to Colorado immediatly. I asked why. He said, The bounty hunters found me and told me that I had to go back with them to the base in Colorado because I know to much. I asked if there were any way he could beat them and get out of it? Robert stated, They said there is no way out. In fact the chief bounty hunter confronted me face to face.

Evidently Robert Jr. tried to beat the bounty hunters. His alleged body was found in room #5 of the Walls Motel in Long Beach, California, with a gun in his hand and a bullet hole through his head. Drugs were found in the room, but not in his body. (he was not the drug type).

The Long Beach Police Dept. investigated the case which ended very abruptly with no explanation. When I asked them why the case was closed so quickly, they snapped back, Its none of your business. The final autopsy report stated that the death was a drug related suicide.

I was not allowed to see the body for one solid week. I would call the police, they would say the body was at the funeral parlor. The funeral parlor would say we don't have the body. This went on back and forth for that one solid week. (Dec. 5th - Dec. 12th, 1986) When I was finally allowed to view the body, I immediatly could tell it was not him!! This body, alleged to be Robert _____, was about 20 Lbs heavier and about 3 to 4 inches shorter than my son. That was not Robert even tho the basic facial feature's were his.

One very significant thing that Robert stated to me before his alleged death was, Dad, they are coming to take me away. I will give you a code name _____ (only Robert and his father know that code name). If you receive a letter, telephone call, or by messenger, sometime in the future, this code name, you will know that I am alive. They need me for my special DNA, that is why I have to go back.

Robert has special Occult Powers and has an interest in witch craft. he says all of this UFO stuff is directly related to witch craft and the occult.

In February - April 1987 both Robert _____ Sr. and myself were under surveillence by what we considered an agent from the cover-up group. He went by the name of John Chunn. We finally confronted him face to face concerning all of this. Needless to say he quit work that day and never came back. Robert Sr. has been harassed several times by an individual who wanted Robert Sr. to go to the 4 corners area with him. On April 16, 1987, he said he would reunite him with his son. _____ backed out the last minute.

Later Robert Sr. was picked up by the police for no reason at all and held for one week. When he hot back home he found out that his place had been ransacked.

On Nov. 9, 1987, a person riding a motercycle and dressed like a biker approached _____ identifying himsself as Lt. eed or Reade and claimed that he had a Top Secret clearance

and had access to the files pertaining to the projects that his son was still involved in. He said that he would place _____ in touch with Robert _____ and said he was working in an underground base. He said you cannot find this base on any maps or in any military directories.

(NOTE! All names addresses and phone numbers are in the original document and all of this information checks out with the Long Beach Police Dept. and with Robert Sr. whom I have talked to. The information was sent to a friend of mine in exactly this form and he forwarded it to me in exactly the form that I have typed it to disc. Bill Cooper)

This file contains the; (1) My reason for releasing this information to the public, (2) My credentials, (3) The validity of the information (% from sources, % from my own knowledge, % from research), (4) The existence of one other person to whom I gave the information in 1972 in anticipation of one day needing to validate the information.

(1) I have 2 reasons for releasing this information at this time. (A) When I first saw the information I was sure that the government would handle the situation and not allow the people to be abducted, injured, or just disappear. My belief in the government has proven false. Not only has it not been handled but the situation has deteriorated and the incidents have increased worldwide. What has happened is against the Constitution of the United States of America which I have sworn to uphold and protect. What is happening is against every law in every state. What is happening violates the human rights of every citizen of the world. It could happen to any member or members of my family or your family at any time. I am a loyal american and have never divulged any of my countrys secrets and except for this one I never will. I do not believe that revealing this secret is against the law as the secret itself violates every law that has ever been written. Senator Barry Goldwater was the Chairman of the Senate Committee which aproved funds for the CIA and has stated publicly that he has no knowledge of any of this. That means and it is a fact that the Congress is ignorant of what is going on. In fact I believe that it is my duty to expose it as thoroughly and as quickly as possible. I only regret that I have waited so long. I waited because I believed so much in our system of government. THE UNITED STATES GOVERNMENT HAS BETRAYED ALL OF US. (B) In my efforts to get the information out it became obvious that soon the government would discover what I am doing and my life would be in danger. I believe that my life is now in danger and the only way to protect myself is to go public with the information. I realize that the information is hard to swallow and that many people will not believe it. I also realize that I have exposed myself to ridicule. So be it. If I am prosecuted or harmed in any way you all will know that the information is correct. If I suddenly disappear you will all know that the information is correct.

(2) I am the son of an Air Force officer and was reared on Air Force bases all over the world. My father was a pilot. As a child I repeatedly overheard pilots and airmen discuss strange stories involving UFO's, Foo Fighters, strange crashes of craft "not from here", and other subjects that were exciting to me at the time. I graduated from High School in Japan and shortly there-after joined the Air Force. I finished basic at Lackland Air Force Base and was assigned to the Strategic Air Command. I was an Aircraft and Missile Pneudraulic Technician. During my training instructors would regale us with tales of lonely nights spent on flight lines, alert pads, and missile silos. They told of strange alien craft that would come down and paralyse the men on station and then remove the warhead from the missile and disappear at fantastic speed. I met a sargeant who told me that he was part of a team that transported such a large crashed disk that it could only be moved at night on back roads and fences

and poles had to be torn down and replaced as the convoy passed. I listened to all these stories and wondered what was going on but didn't really believe them. I was discharged from the Air Force in 1965. I was very adventurous at the time and joined the navy in December of 1965. I volunteered for submarines and was assigned to the USS Tiru (SS-416) at Pearl Harbor, Hawaii. On a cruise to the Portland Seattle area, while on lookout a UFO the size of an Aircraft carrier rose up out of the water and disappeared into the clouds while we were on the surface and I was the Port lookout. Currently The institute where I am presently employed is known to 3 of you and I do not wish it to be disclosed as the release of this information could have adverse affects upon my employment.

(3) Approximately 50% of this information comes from documents that I saw with my own eyes and I personally know it to be true and absolutely accurate. I saw and read GRUDG/BLUE BOOK REPORT NO. 13. I saw and read the MAJESTY document which contained the Aquarius information. I was present at a briefing where much more information was discussed and some of it has become cloudy over the years but has come back to me when I saw information on that subject. About 50% of the information comes from my sources who will remain un-named. About 60% of the information is backed up by research and information available to you all however the information is not generally shared. It is out there in various places and on various boards. Due to the potential monetary value of the information I believe that it probably never will be shared.

(4) In 1972 I related this information to one other person for self protection and so that the information could be verified at some latter date should the government not handle the situation. I gave him the information on the eve of my wedding. The last person to person contact I had with him was in 1974. The last contact of ANY kind was in 1976 or 1977 by phone. I have not seen him, written to him, phoned him, or had any contact with him at all since that time. I maintained this distance to prevent any accusation of collusion or hoax should it ever be necessary to release the information. I also did it for his protection so that he would not be involved if the government should decide to harm me before the information could be released. I have him a copy of the information in the form of a copy of an original document. I retained the other copy but mine was destroyed

in a storage fire. He can and will verify the information to the right person with the right code (which we agreed upon) to release it. 3 of you have his name, the last place he lived in 1976, and the code. I will not contact him until the information is verified. He can validate my intelligence background and the information. He can state all of this truthfully and because of our seperation over the years will be able to pass any lie detector test to prove this is not a hoax. I would also be able to pass the same test or any other test, sodium pentathol etc.

I have also received a call from a man named Christopher who called from an area code in Maryland. By his conversation with me on the phone I know that he has also seen the MAJESTY information and the AQUARIUS document. I also know that he is a member of Compuserve. That is all I know about him. I left out a graphic on the reconstructed document that I posted in my MAJIC file and he questioned the ommission. It is a minor detail that I did not think important but he spotted it. The only way he could have known that the graphic was missing would be that he has seen it himself. The graphic was 2 lightning bolts which strike at the bottom of the finned rocket which is enclosed in the circle. Since I could not put graphics in the document I only included a short description.

I tested my father once by relating that I had seen information while in the navy that the Government had recovered UFO's which had crashed. I did this to guage his reaction because I knew that at one time when I was very little he was the radar Officer at White Sands Proving Ground. He gave me a very knowing look and advised me not to talk about it. I have never discussed the matter with him since.

A series of PROJECT GRUDGE/BLUE BOOK reports have been released over the years in connection with the USAF's investigation into UFO's which was supposedly terminated with the release of the Condon report in the late 1960's. Reports 1 through twelve of GRUDGE/BLUE BOOK were generally innocuous and contained no classified or truly sensitive material. There was a final report, #14 which was widely circulated and about which an entire book was written: FLYING SAUCERS: AN ANALYSIS OF THE AIR FORCE PROJECT BLUE BOOK SPECIAL REPORT NO. 14 by Leon Davidson: the fifth edition was published in 1976 by Blue-Book Publishers; 64 Prospect St., White Plains, New York 10606. Missing from public view, however, was report #13.

Several years ago, Bill English, son of an Arizona state legislator and former captain in the Green Berets had been assigned to an RAF 'listening post' north of London as an information analyst. English was, in the course of his duties, asked to prepare an analysis of the elusive GRUDGE 13 report. On his discharge from his work at the 'listening post' he returned to the United States and began to do a little UFO research on his own. English had been no stranger to the UFO phenomenon. In Viet Nam he was a member of a Special Forces investigative team that went in to retrieve a B-52 that was forced down by a UFO and all the occupants killed. Communications had been received from the B-52 before it went down to the effect that it was "...under attack by a UFO..", A "...large light...". The plane was found intact, sitting in the jungle. There was no swath indicative of a crash landing. Only the bottom of the fuselage showed any damage, there was no damage to the underside of the engine pods. Although the plane was completely intact the entire crew had been mutilated.

English, through contacts he still maintains has determined that the US Government 'most definitely' supports a 'project dealing specifically with UFO's and captured aliens'. According to what he has learned, the US government captured a trio of aliens, and that as of mid 1981, one of the beings was still alive in captivity. English also claims that "at one point in the early 1950's until the mid 1960's the Air Force maintained relocation and debriefing colonies for people who had experienced close encounters of the 3rd and 4th kind. They were isolated for all intents and purposes for the rest of their lives. He doubts that these colonies are still in existence.

English dictated 2 audio cassettes outlining what he remembered from the Grudge 13 report. These audio cassettes were transcribed into hand written notes by another person. The information contained therein indicated what had been suspected all along: that the US government was involved in the greatest deception in the history of mankind and that not only did flying saucers exist but that the government had several in secret storage and had captured at least 3 live aliens.

The following is a summary of what Bill English remembers from what he read during that day in June, 1977 of PROJECT GRUDGE/BLUE BOOK REPORT NO 13.

In Box, diplomatic pouch under lock and key system. Lock had been opened, pouch was easily accessed. Standard diplomatic couriers pouch marked American Embassy Couriers, contained pouch serial number JL327Delta (JL327D?). Inside a publication with red tape which indicated code red security precautions and an Air Force disposition form. Disposition form was standard white page copy, title was 'Analysis Report'. Further down was "Analyse enclosed report under code red measures. give abstract breakdown and report on validity. Observe all code red measures. Analysis required immediately'. Underneath were a series of dashes then the letters NDF then another series of dashes. Below that, lower left hand corner were the initials WGB.

Publication was withdrawn from pouch. It measured approximately 8" by 11" with gray cover. Heavily bound, paper back style similar to technical manuals. Across the center front it read, "Grudge/Blue Book Report No. 13". It was dated 1953-(1963). In the lower right hand corner was AFSN 2246-3. In upper left hand corner was the word 'annotated'. Across the front upper right hand corner to lower left hand corner was red tape indicating code red security measures. Across the front was stamped in red ink 'Top Secret Need To Know Only Crypto Clearance 14 Required' Inside front cover upper left hand corner were hand written notations in ink which were blacked out by black felt pen.

Inside cover sheet was basically the same information as the cover. Second page was title page. Next page after that was an appendix with numerous notations made in it. Notations dealt with inserts of what appeared to be photos and additional notes. At bottom of third page it read G/BV Page 1 of 624 pages. Title page was subject letter. Complete list of appendix not remembered. Title. Some notes on the practical applications of the Worst Nemo equations.

Table of Contents, Part 1. "On the design of generators to accomplish strain free molecular translation". Part 2, "The generation of space time discontinuums, closed, open and folded". Part 3, "On the generation of temporary psuedo acceleration locas". Part 1, Chapter 1, "design criteria for a simple generator and control system referring to equation 17 appendix A". Part 1, chapter 2, reports of UFO encounters, classification "Close Encounters of the 1st kind", subtitle sightings and witnesses. Part 2, Chapter 2, "Close Encounters of the 2nd kind", subtitle UFO sightings witnessed within close proximity. Part 3, Chapter 2 "Close Encounters of the 3rd kind", subtitle UFO encounters and extraterrestrial life

forms witnessed and personal encounters. Subtitle, "Colonies relocation thereof". Case histories. Chapter 3 Part 1, titled "Military Encounters with UFO's". Part 2 Chapter 3, "Military Reports Concerning sightings on Radar and Electronic Surveillance of UFO's". Subsection 2, Analysis Report, J. Allen Hynek, LtCol. Friend. Appendix continued on for about 5 pages. Opening subject page consisted of a report of the findings as written by LtCol. Friend and his analysis.

Must stress at this point that the version seen was annotated. There were inserts that were added to this copy after it had been initially printed. Sections remembered very vividly are the photographs and the reports concerning captive sightings of various UFO's to include Mexico, Sweden, United States and Canada. There were also what was then classified Close Encounters of the 3rd kind. It was made very clear that these people whom it was determined had genuine CE 3's were move in the middle of the night by Air Force personnel and relocated to various sites in the midwest and northwest parts of the United States. In many cases these people experienced physical ailments from exposure to various types of radiation.

One case especially noted and remembered very vividly was entitled 'Darlington Farm Case' out of Ohio. Case apparently took place in October 1953. Man, wife and 13 year old son were sitting down at dinner table. As they sat there the lights in the farm house began to dim. Dogs and animals raised rucus on outside. 13 year old boy got up from dinner table to see what was going on. Called his mother and father to come look at the funny lights in the sky. Father and mother got up and as they got up the son went outside into the yard. Father and mother went out onto the porch. When they got out on the porch one of the dogs broke loose from leash beside house and came running around front. Boy began chasing it out into the open field. As mother and father watched the light came down from the sky. They described it as a round ball of fire and it began to hover over field where boy and dog had run to. As they stood and watched, the mother and father heard the boy start screaming for help whereupon the father grabbed his shotgun which was right next to the door and began to run out into the field with the mother following. When the father got to the field he saw his son being carried away by what looked like little men, into this huge fiery looking object. As it took off the father fired several rounds at the object, to no avail. They found dog, its head was crushed but no sign of boy or any other footprints of the little men who apparently carried him off. Father immediately called Darlington police and they immediately came out to investigate. The official report read that the boy had run off and was lost in the forest which bordered the farm. Within 48 hours the Air Force made the determination that the family was to be relocated and the mother and father were picked up by Air Force Intelligence and all personal belongings and possessions were loaded into U.S. Air Force trucks and moved to a northwestern relocation site.

The mother was in shock and had to go through a great deal of

psychotherapy and deprogramming as did father. One interesting aspect about this case was classification under the Air Force report which read it was a genuine CE 3 and that for the good of the national security the mother and father had been relocated to relocation zone Z21-14. Not sure whether this indicated map grid coordinates or latitude longitude. According to the report there were at least 4 relocation sites across the United States. Depending upon which type of encounter these people had, the report indicated that there were extensive medical facilities available at these relocation sites to deal with all medical emergencies up to and including radiation poisoning. The report mentioned a site located in the Utah-Nevada area, but no indication of its purpose or what it was for.

Report gave a clear indication of reports of human mutilations, most notably was a case witnessed by Air Force personnel in which an Air Force Sgt. E-6 by the name of Jonathon P. Lovette was observed being taken captive aboard what appeared to be a UFO at the White Sands Missile Test Range in New Mexico. This abduction took place in March of 1956 at about 0300 local and was witnessed by Major William Cunningham of the United States Air Force Missile Test Command near Holloman Air Force Base.

Major Cunningham and Sgt. Lovette were out in a field downrange from the launch sites looking for debris from a missile test when Sgt. Lovette went over the ridge of a small sand dune and was out of sight for a time. Major Cunningham heard Sgt. Lovette scream in what was described as terror or agony. The Major, thinking the Sgt. had been bitten by a snake or something ran over the crest of the dune and saw Sgt. Lovette being dragged into what appeared to him and was described as being a silvery disk like object which hovered in the air approximately 15 to 20 feet. Major Cunningham described what appeared to be a long snake-like object which was wrapped around the sargeants legs and was dragging him to the craft. Major Cunningham admittedly froze as the sargeant was dragged inside the disc and observed the disc going up into the sky very quickly. Major Cunningham got on the jeep radio and reported the incident to Missile Control whereupon Millile Control confirmed a radar sighting. Search parties went out into the field looking for Sgt. Lovette. Major Cunnighams report was taken and he was admitted to the White Sands Base Dispensary for observation.

The search for Sgt. Lovette was continued for 3 days at the end of which his nude body was found approximately 10 miles downrange. The body had been mutilated; the tongue had been removed from lower portion of the jaw. An incision had been made just under the tip of the chin and extended all the way back to the esophagus and larynx. He had been emasculated and his eyes had been removed. Also, his anus had been removed and there were comments in the report on the apparent surgical skill of the removal of these items including the genitalia. The report commented that the anus and genitalia had been removed 'as though a plug' which in the case of the anus extended all the way up to the colon. There was no sign of blood within the system. The initial autopsy report confirmed that the system had been completely drained of blood

and that there was no vascular collapse due to death by bleeding. Subcomment was added that this was unusual because anybody who dies or has complete loss of blood there is vascular collapse. Also noted was that when the body was found there were a number of dead predatory type birds within the area who apparently had died after trying to partake of the sargeants body. There were a number of extremely grisly black and white photos. From all indications the body had been exposed to the elements for at least a day or two. The New Mexico sun in the desert is extremely hot and debilitating under normal circumstances.

In this section of the report it also indicated that there were numerous occasions in which a UFO tracked alongside of a fired missile and on one occasion said missile was observed being taken aboard a UFO while in flight. The speeds indicated were absolutely phenomenal. (English's father had told him privately that on more than one occasion he had personally tracked what they termed as 'foo fighters'. English's father was an electronic engineer by profession and was fairly well versed on electronics engineering and design and on more than one occasion he was involved in telemetry programming of milliles. English's father is currently a state legislator in Arizona.)

The report also indicated that there were a number of recovery teams that were activated specifically for the purpose of recovering any and all evidence of UFO's and UFO sightings. Most notably recorded in publication was what they called Recovery Team Alpha. It was reported that Alpha had been extremely active in a number of areas and on certain occasions had travelled outside of the continental United States. Alpha was based out of Wright Patterson Air Force Base and was on the move constantly.

Further information in the report consisted of such things as reported sightings and where air force planes had been destroyed or had combat encounters or had been attacked by UFO's. Also there were autopsy reports of various human mutilations.

About midway through the report came a section which dealt specifically with photographs. Each photo was labeled and appended to certain reports. A number of photos in there dealt with a recovery program of some type that took place in the southwestern part of the United States. They did not give a location name but they did give grid coordinates for that area. There is no clear indication to exactly where it was. The photos dealt with special teams that were called in to recover a crashed UFO. It also dealt with alien bodies and autopsy reports, autopsy type photographs, high quality, color, 8 x 10, 5 x 7.

Photo number 1 showed an alien being on an autopsy table which is a metal with runnels and traps underneath to trap fluid and feces. Body appeared to be an little short of 4 feet. Table was about 7 foot. No clothing on body, no genitalia, body completely heterous, head was rounded cranium, slightly enlarged, eyes almond shaped, slits where nose would be, extremely small mouth, receding chin line,

holes where ears would be. Photo was taken at angle, side view, looking at body from 45 degrees elevation, left hand was visible, head was facing to left, body was right to left position (head on right, feet on left), eyes were closed appeared oriental-looking and almond shaped, left hand slight longer than normal, wrist coming down just about 2 to 3 inches above the knees. Wrists appeared to be articulated in a fashion that allowed a double joint with 3 digit fingers. Wrist was very slender. There was no thumb. A palm was almost non-existent. The three fingers were direct extension from the wrist.

Color of the skin was bluish gray, dark bluish gray. At base of the body there was a darker color, indicating body was dead for some time. Body fluid or blood had settled to base of body. This indicated that body had been examined before beginning autopsy.

Picture showed beginning stages of autopsy, following standard procedure, body was slit from crotch to just under chin and green viscuous liquid was in evidence. There were internal organs but these could not be identified. Photos thereafter concerned specific areas of internal organs of what appeared as small cluster of a multi-valve heart or at least 2 hearts within the cadaver. No accurate description of autopsy report or what was found within corpse accompanying photos. Indication that there was no stomach or digestive track per se. Later analysis showed that fluid within body was chlorophyll-based liquid which apparently dealt with photosynthesis or similar process. The report theorized that nourishment was taken in through mouth, however since there is no digestive track or anything of this nature, the waste products were excreted through skin.

One section of report did specify that cadavers were extremely odorous, but this could be accounted for by either deterioration or a number of things, but theory was that waste was excreted through pores of skin. They could only theorize in report because there was no xenobiology.

A report by Dr. J. Allen Hynek was recalled vividly which indicated that he had also studied the information provided by this particular case and that he felt that it was indeed a genuine UFO capture and subsequently the alien was part of UFO. Dr. Hynek was non-committal but did however sign the report. Also indicated in report that he did not view bodies personally, but viewed photographs and accompanying reports from autopsies.

Other photos dealt with a number of bodies which were vivisectioned in various ways. At one point, a head was removed from body and photographed and autopsy was performed on head. The cranium was opened and brain matter was photographed and evident. Interesting thing about photo was that there was a ridgebone or dividing partition-type bone running directly through center of skull, from front to back, as though dividing two brains, one from the other. This seemed apparent from the picture. The skin was completely removed from cranial structure and the skull was layed bare as much as possible.

At one point the skull was cut directly in half and photo showed under developed esophagus and nasal cavaties. No clear photo of eye orbs as we know them, just photos of complete vivisection of skull itself.

Numerous photos of flesh of the being starting with cutaneous and subcutaneous microphotographic plates. Appeared to be cellular studies done under microscope and electron microscope type photos. Extreme magnification of tissue samples.

This concluded Bill English statement which was transcribed from 2 cassette tapes. I obtained this handwritten memorandum in August of 1987 from Paul Bennewitz during my visit with him in Albuquerque. In September of 1988 I received a call from Bill English. I asked for a chance to meet him and discuss the Grudge 13 report. He said that this could be arranged but that the meeting would have to be on his terms for security reasons. He explained that there had been several attempts on his life by persons unknown since he had made the cassette tapes about 6 years ago. We arranged a meeting at a small airport in Virginia on September 16. I was to sit in the lobby with by black flight bag and for identification purposes I told Bill what I would be wearingj. I had no telephone number for Bill.

As I walked in the small airport lobby after a 3 hour drive from Richmond I immediatly noticed 2 gentlemen who seemed 'out of place' for this locale. Both were wearing pin striped 3 piece suits, both had on dark glasses. One was a black gentleman. One was stationed inside the lobby door looking out at the parking lot, one was leaning up against an airline counter. I sat down and after a few minutes was approached by a tall, bearded man in jeans and a heavy jacket. He asked if I wanted to have a drink. We walked outside and he introduced himself as Bill English. We drove in Bills car into town to a local bar. About 5 minutes after we ordered and had started to talk, the men I had seen at the airport came into the bar and sat down. We left for Bill's house and never saw the men again for the next 2 days.

During the next 2 days I stayed with Bill and his wife and 2 children in a small trailer in the middle of a field at his farm. I asked him endless questions concerning the Grudge 13 document, how he happened to see it, what happened to him after he saw it and literally thousands of questions about the content of the document. My impression of Bill English was that he was totally honest, that he stood behind his statements and recollection of the Grudge 13 papers, that he was a devoted husband and father to his wifes 2 children. That Bill English was ready to come forward and enter into any debate regarding the legitimacy of the document and his recollections thereof. Of Bills compassion for his father and his fathers feelings concerning Bill and the reasons for their occasional disagreements. I have tremendous respect for Bill and what he has tried to do in getting this information out to the public. It has been at tremendous

personal risk not to mention the ridicule by sponsored agents such as Bill Moore who has stated that the Grudge 13 papers are a fraud. (How would Bill Moore know?)

What follows is additional information about the Grudge 13 papers that I obtained from Bill during my visit. In addition to the following Bill painstakingly drew many sketches of the photos of different types of flying saucers, the equipment obtained from them including a sketch of the football sized nuclear generator and sketches of the autopsy photos.

From my notes taken during our 2 day meeting: Bill described a photo taken of 3 live aliens. Very clear photo, aliens standing against white tile wall, looking confused as if they had been shoved, were looking in different directions. Report said that aliens had contacted a U.S. Intelligence Agency for initial 2 meetings, one at Holloman one at Homestead.

U.S. Air Force relocation personnel (for persons involved in close encounters) were referred to in report as 'men in black'.

Major Cunningham was initially accused of murdering Sgt. Jonathon P. Lovette. Charges were later dropped.

Bill English's place of employment in England was RAF Security Services Command, RAF Chicksands.

Entire Grudge 13 report was written as if report was geared toward preparation of defenses.

Report told of ultrasonic weapons found in Germany at the end of WW II that could shatter 4" thick armour.

Report told of sensitive military and industrial areas at which personnel experienced missing time.

Report told about missing time experienced with personnel associated with North American X-15 rocket plane project.

Report stated that there were 17 different extraterrestrial species accounted for up to the time of the report.

Extraterrestrials were referred to as A.L.F.'s, Alien Life Forms in the report.

Report referred to one UFO that was recovered and test flown. The UFO blew up as the 2 Air Force pilots aboard attempted to leave the atmosphere. English recalls the date as the mid 50's.

Report refers to flying saucer program as Project 'Red Light' and that a secret installation had been constructed in the middle of the Atomic Energy Commission testing ground in Nevada.

At the time of the report 11 alien cadavers were being kept at Wright Patterson Air Force Base.

That additional alien cadavers were being stored at 4 to 5 other medical institutions.

That 2 flying saucers of extraterrestrial origin had been tested in the wind tunnel at Langley, Va.

That at the time of the report, 1 damaged disc was at Elgin Air Force Base in Florida.

That at the time of the report there had been 2 UFO incidents at Ft. Riley, Kansas.

That at the time of the report a detachment of the Alpha recovery team was based at Randolph Air force Base.

The report discussed civilian and military personnel who had been terminated 'to eliminate potentially dangerous elements to the national security'.

That General James Doolittle had been mentioned several times in the report with the notation that "His (Doolittle's) predictions might be correct". There was no indication of what those predictions might have been.

A short segment containing the quotation, "By presidential order, certain aspects of research had been undertaken."

This report about Bill English and the Grudge 13 papers was prepared by John Lear, 1414 Hollywood Blvd., Las Vegas, Nevada 89110, telephone number (702) 438-8181, on October 7, 1988.

This report was typed onto disc verbatim from the original document which was sent by John Lear via Federal Express and arrived on October 8, 1988 by Bill Cooper. I Bill Cooper do swear that no changes were made and do swear that this is an exact verbatim copy of the original.

STATEMENT

I, William S. English, do hereby state and affirm that I have met with Mr. John Olson Lear, on September 16-17, of 1988, and that we discussed my original report on my viewing of the Grudge/Bluebook Report 13, in June of 1977.

I Further state that whatever opinions Mr. Lear form or express on this matter are entirely his own, and that I stood behind my statements made originally when I came forward with this matter, and that I continue to stand behind my statements to this date.

I further state that anyone saying that they have an admission from me personally that this was a hoax is a liar and that if I was in fact perpetrating a hoax I could have

found a better way of doing it. Instead I have chosen to allow time to either prove or disprove my claims on the information on this matter. Time it seems has proven the validity of my statements.

I welcome the chance to defend my position in either public or private debate and will continue to stand behind by original report.

The following file contains clarification and correction of a number of claims attributed to Tracy Torme by Larry Fenwick within the Fenwick.txt interview transcript of Nov.6/88. Tracy Torme's version comes from a taped conversation I had with him on Dec.4/88 In addition to Torme's reaction, I also have Larry Fenwick's response to this. Lastly, Tracy also has kindly offered to give his views on the Gulf Breeze series of UFO sightings, and of his appraisal of "Mr. Ed".

The following is a series of selected statements made by Tracy Torme, who gave me permission to use "any, or part of this" so as to reproduce in electronic form for distribution on ParaNet.

<Tracy Torme>

"Although there are grains of truth...small grains of truth, in some of what Larry said, a great majority of it is inaccurate and highly exaggerated. Just for the record, some of the positions that he has me taking are positions that I absolutely do not believe...I never did, and I still don't. When I talked to Larry about this after having read the transcript, Larry was pretty apologetic, and said, well, he realizes he has a faulty memory and he tends to exaggerate. Thats his quote. And that's how I found the whole thing on me.

For the record, the following things are the way that I feel:

- (1) I do not have any inside information on Project Aquarius.
(2) I have strong doubts that Project Aquarius even exists as interpreted by Larry Fenwick.
(3) I do not believe in underground alien bases. Although I keep open the possibility that such things exist, I personally would tend to disbelieve that. And never said anything like that.
(4) The "religion" comments were taken out of context. And most of what was said were not my words. When I was pressed to reveal anything I might know about Bill Moore's situation, I basically refused. Then Larry and Harry Tokarz etc., and Joe Muskat started asking me, well, if the stuff that Bill is onto is true, then what would it affect? And they started running through a number of things, and one of the them that I agreed could be affected, would be religion. But I never said it would be affected. And I never NEVER said anything about 20 million suicides. That is something that someone from CUFORN said, and Larry is getting them mistaken."

"As far as me knowing everything that Bill Moore knows, that is ridiculous...back in 1982 or today."

"I'm often amused with people who decide that I'm some kind of agent who knows all that Moore knows, and works so closely to

Moore. Because the reality is that I know only slightly more than what most people do. For instance, John Lear came out and said I was an agent of disinformation for Bill Moore. And when I asked John why he said that, he said, well you seem to agree with him alot. That's the kind of reasoning that leads to these nonsensical claims."

[Regarding the New York Meeting with...here are some of Torme's remarks]

"Larry Fenwick used to tell me that he saw suspicious people in the lobby of my hotel who's eyes were following me wherever I went. So he started to suspect that I was being surveilled. And again, I don't think there is anything to that either."

"I don't specifically remember anything about saying "don't take notes", but I'm not denying I said that, because most likely what the context of it was...they [the CUFORN guys] started asking alot of questions again...and they may have gotten a tape recorder out or something, and I may have discouraged them and said, "look guys I'll just talk to you off the record, but I don't want this to become like an interview, where I'll have to watch my words. Thats as much as there is to that."

"Basically, my last statement would be that this is a small but important example how rumour mongering, exaggeration, excitability, melodrama, etc....enter into the simplest of stories, and by the time they make their rounds of the UFO grapevine, they are blown all out of proportion."

[In response to my query about what percentage of Moore's info Tracy knows..]

I think I still know some things that Bill Moore knows that only a few people know. I'm sure there are some things that I still know that are not known to the general public. I wouldn't say [they are] anything earth-shattering, nothing that anyone wouldn't imagine."

"In my viewpoint, if the UFO community knows 15% of what Bill Moore knows, then maybe I know 25%."

"I don't know where MJ-12 hangs out, where they play golf, and all that kinda stuff. I don't know that stuff. If anyone thinks that I do, then more power to them, but its not true. So thats the situation."

[Regarding the above...in conversations with Larry Fenwick, he has agreed that his recollection of what transpired during certain events (all of which did occur as Fenwick mentioned) was indeed "faulty", and as they took place some 6-8 years ago, Fenwick blames the passage of time for this error on his part.]

[One mistake made while transcribing, was my attributing Torme with working at CTV instead of at SCTV. - other than that, except for a few typographical errors, the text is an accurate portrayal of the Fenwick.txt transcript.]

[The following are Tracy Torme's views on the Gulf Breeze UFO sightings, whose views I solicited due to Tracy's own work with, and meetings, with many of the individuals involved...including with "Mr.Ed" and his family. As you may know, Tracy's work on the TV special "UFO-Coverup LIVE" was

primarily on the Gulf Breeze segment, and as well as to the [redacted] with it.]

<Torme>"Well, I started as a skeptic, and became a [redacted] skeptic. I keep hearing from skeptics that new information, or certain things that have come out, have bitten the case out of the water. But everytime I look into that so-called "new information", there's nothing there that damages the case at all, really. So I'm still keeping the door open that its an increasingly elaborate hoax...because I don't think that's an impossibility. But I'm 98% convinced that something very unusual really was going down there. That much, I'm pretty convinced off."

<Mickus>"So I guess you and Jim [Speiser] would differ on that [redacted] cause I know that he's come out and called it a hoax."

<Torme>"Jim Speiser has?"

<Mickus>"Well, ParaNet's current classification on it is that it is a hoax."

<Torme>"Is that right?"

<Mickus>"Yes. I thought that it was maybe a little premature."

<Torme>"I'm surprised to hear that. There's so much to the case, that someday I would love to be part of a real, bigger discussion about it. I've been down there now I think four times. And I've been involved with all the principals directly down there in Gulf Breeze. If its a fake, they sure got me fooled, I can tell you that much. And I'm not saying that that's impossible, but it would be a real surprise."

"One thing I will say about it is that, its an interesting case in that most cases like it, like the Meier case...and others, the more you find out about them, the less you believe in them. What I've found with Gulf Breeze is, that the more you stay at a distance from it, the easier it is to say that its not real. Because the photos look fake, and its the type of case that has never happened really legitimately before. So its easy to just base it on the superficial ideal like that, and say okay its not real. And I think to a certain extent, Richard Haines and Richard Hall, and other people that are good people in the field...when I talk about it to them, that's pretty much where they stood. But I really found out that I didn't feel like they knew as much about it as they should, in order to make that decision [against GB being legit]. The interesting thing about Gulf Breeze is the [redacted] and the more you get to know who "Mr. Ed" [redacted] of the other witnesses are, and the details [redacted] think you have to come away from it making the [redacted] Hopkins made and that Maccabee has made and the [redacted] with most other people, and that is that it is [redacted] incidents. I've spent quite a bit of time with [redacted] to all the major sites where with him where he had [redacted] I've relived them with him [through Ed's re-telling] [redacted] family, his kids, his wife and some of his neighbors and [redacted]

"I think the guy has a lot of integrity, and I think he's [redacted] because of this, instead of profiting because of it." I think [redacted]

[Lastly, a closing remark about Tracy Torme's view of Larry Fenwick...]
