

Clearly the mutilations follow a pattern world wide... there are some very unusual characteristics regarding the wounds which appear to only be possible with technology beyond our own, again, I have no way of validating this. The mere fact that the pattern is world wide does suggest something strange... but as to what it means... this remains highly speculative based solely on this documentary.

The next two features; an HBO special "UFO's: What's Going On" and "UFO's: It Has Begun," both offer further random hints at a coverup of the UFO issue. In both cases, no hard evidence seems apparent, although there is a reference in one of the documentaries, perhaps the last one or the next one, showing a hand written note from J. Edgar Hoover of the FBI explaining to the army that they must allow access to the salvaged alien spacecraft. That is one I can't explain away.

The final documentary that I really understood was "UFO's Are Real" by Brandon Chase which offered the greatest amount of video footage, photocopied FOIA documents on UFO's, and an impressive display of physical evidence, particularly regarding UFO landing sight soil characteristics that was really turning the tide... until...

...the Billy Maier material was celebrated as one of the most complete and significant cases of UFO evidence to date. Inclusive in the Maier data was the contention that the photographs had been authenticated by photographic analysis techniques. That last entry threw my entire growing optimism that someone had done some exhaustive research into doubt once more... this in the light of our recent feelings about the veracity of the Maier materials.

Despite the Maier material, I feel that this particular video presented the most compelling evidence not only that UFOs are real, but that they are literally not of this world. If followup on the specifics dealt with in "UFO's Are Real" corroborates the conclusions drawn in the film, I would be willing to accept the majority of the evidence as proof of extraterrestrial involvement in earthly affairs.

The last two entries, "The Tacoma Incident" and "Japanese Moon Pictures" do not offer me any ideas at all regarding the UFO issue. I may need to view these last two segments while following along in John's enclosed documentation to glean whatever meaning they may have.

Having viewed the video once, and skimmed the substantial number of documents, I'm still unclear as to how John's hypothesis was arrived at unless its a reference on one document that I have yet to locate. One point seems much clearer to me now than it was before, there is no doubt that there is something strange about UFO's and that they do represent something that we do not understand and that there may in fact be some sentient beings involved from some other world. The Laear materials are a good introduction to the scope of the UFO issue and I highly recommend that anyone who is interested in UFO's should review these materials. I myself must do alot more reviewing before making any final summations. The jury is still out on the hypothesis Lear has presented but I think the circumstantial evidence for the reality of UFO's is enough to secure a conviction in most courts.

I will likely have more to say about this at a later time, particularly in light of the recent Texarkana sightings.

If there is reason to question the accuracy of the information presented in the original AQUARIUS/MJ-12 document as well as the information in the recent documents pertaining to MJ-12, does this logically imply that the 1980 Kirtland/Bennewitz events should be considered questionable? Any single-witness UFO sighting has always been somewhat questionable, this is exactly why we look for multiple witnesses and any other supporting evidence. If Richard Doty, or Paul Bennewitz were alone in reporting these incidents then the Kirtland events would never have become as major an issue as they have. However there were numerous individuals involved not only in the events precipitating the documents but in the preparation of the documents themselves. A brief summary of the incidents is as follows:

Early 1980, Paul Bennewitz becomes involved in observing and filming objects which he has sighted on the ground and in the air near Kirtland AFB and the Manzano range. Reportedly his wife was also present to witness some of the first landings he witnessed and filmed in the Coyote Canyon area. Subsequently he contacts Earnest Edwards of the Kirtland Security Police who, over the period of the next few months, becomes concerned and requests the guards on the Manzano Weapons Storage Area report to him any sightings of unusual aerial lights. At the beginning of August 1980 three guards report sighting an aerial light which descends on the Sandia Military Reservation. This is the first sighting described in the complaint form signed by Richard Doty. Edwards reports the sighting to Doty unaware that Doty has already heard from Russ Curtis (Sandia Security Chief) that a Sandia Security guard sighted a disc-shaped object near a structure just minutes after the sighting by the three Manzano guards. Doty includes these reports and several others in his Complaint Form and forwards the report to AFOSI Headquarters in Washington.

From this point on many other persons became involved. Bennewitz was called down to a meeting at Kirtland AFB at which several major Air Force officers and Sandia personnel were present, including a Brigadier General. Earnest Edwards has confirmed that the three guards under his command reported what was described, and that the meeting took place. Bennewitz has confirmed that Doty and Jerry Miller came to his home to view his materials and there is a document signed by Thomas A. Cseh, Commander of the Base Investigative Detachment, to confirm this. Finally there is the complete set of documents which were released by AFOSI Headquarters under cover of the Department of the Air Force relating to the described events.

Guests: Richard Hall, Jim Speiser

Transcript begins approx. 7:15PM

EB: ...this hour, we have the author of a book with us, it says "Top Secret" on the cover, and I don't know, I've read a lot of the secrets in here. "Uninvited Guests", its a "documented history of UFO sightings, alien encounters, and cover-ups." And the author is Richard Hall. Richard is with us here on The Talk Station via the telephone. Hello, Richard Hall!

RH: Hi. How're you doing?

EB: Pretty good. And we have in studio, Jim [Speezer], or is it Speiser? Speiser...who is a ufologist, and director of ParaNet, which is a computer Bulletin Board of explorers of the paranormal...a network, I guess, of all those people who are comparing data [such] as you have in your book. Your book is a compendium of all of the reports correlated here in different categories, from "Close Encounters of the Vehicular Kind" to bodies in the morgue, humanoids, and big secrets and other...uh, what gave you the idea for doing this, Richard Hall?

RH: The idea for doing it was that the public at large has had very little in the way of current, honest sources of information on this subject for many years now, and their primary source of information, very regrettably, has been the tabloid newspapers. The conventional news media do not give adequate coverage of the subject, so I felt it was time to do an update, pulling together the most impressive information, and (whether impressive or not) the currently reliable information on the subject. So that's what I tried to do.

EB: Now isn't this a case of, "where there's smoke there's fire," the idea, with all this smoke there must be a flame somewhere? With all of the reports, and many of them seem to correlate, most people who sight spaceships seem to give the same general description. Most people who see lifeforms coming from spaceships, or assuming they come from some kind of extraterrestrial vehicle or transportation, put them in similar categories, and, are we saying, because these things have gone on for many, many years now, and seem to correlate from different sources, different countries, and come up with the same kinds of general observations, that there must be something to it?

RH: Yes, indeed. I think that's exactly right. I think if we'd had all these reports over the years, and they were of 90,000 different sightings, and no two were alike, you know, you could write it off as some kind of psychological phenomenon or whatever, but we do indeed have all these converging patterns, very STRONG patterns, in fact, of exactly, similar descriptions from people worlds apart, continents apart, all walks of life, and it tells a very important picture here of some real phenomenon going on that has not been adequately investigated.

- EB: What disturbs me is the fact that it has NOT been adequately investigated, and that there seems to be a pattern of covering up; that, if there is something to this, the government - the military in particular - doesn't seem to want anybody else to have the information.
- RH: Yes.
- EB: And why is that?
- RH: Well, one can only speculate. But the case I build in my book is that, sometime back several decades ago, the government and/or the...at least the military services found very strong evidence of what we will call extraterrestrial visitation, for lack of a better term - some kind of intrusion into our airspace by mysterious, unexplainable objects and apparently humanoid beings. And they really didn't know how to cope with this. It was not really treated as a scientific problem, it was treated as a national security problem. Who are these beings, what are these craft, where are they coming from? Are they about to attack us or what? But there was no evidence of any kind of invasion per se. So the military forces were stuck with a problem that they really couldn't cope with. Now there's much more to it than that, which I'll be glad to get into, but that's as short an answer as I can give to such a complex question.
- EB: Let me ask our guest, Jim Speiser...how did you get an interest, or develop an interest in UFOs, extraterrestrials, and the like?
- JS: I got an interest in it from way back, about 1966. I was a young boy and I read all of the pulp magazines, etc. Kinda lost interest up until college, when I learned of the "skeptical side" of things. From there on I proceeded from a skeptical point of view, as I pursued many other facets of the so-called "paranormal": ghosts, ESP, etc. [But] it soon came to my attention that the skeptical information I was getting on UFOs - that they didn't exist, that they couldn't possibly be here, that they've been explained in other ways - I slowly came to the realization that those explanations were not quite as scientifically based as the skeptics would have us believe. And so I said, "Wait a second. If our best debunkers and skeptics can't explain these cases, or have to resort to way-out left-field explanations that make the 'alien' theory look ridiculous, maybe there really IS some fire behind the smoke."
- EB: Was there any one, or two or three, basic incidents that convinced you there was something out there? or up there?
- JS: Well, I remember the particular turning point in my mind was the Helicopter-UFO Incident over Mansfield, Ohio in 1973, and...that's a case where the best debunker in the world, Philip Klass, as far as I can see, really dropped the ball. He tried to explain this thing as a "bolide", or meteor, that lasted some one minute and twenty seconds, which...I've called dozens of meteorologists, astronomers, experts...[and] no one can tell me that a meteor could possibly last a minute and twenty seconds.
- EB: OK, and, Richard Hall, the author of "Uninvited Guests", was there one turning point, one "ah-HA!" factor for you that said,

"there must be something to this?"

RH: I'm not sure I can pin it down to one precise case, but I think one category of reports that impressed me highly was reports by professional pilots, military and civilian professional pilots, airline pilots, Air Force pilots... and I have over the years talked to many, many of them, face to face. Reports sometimes that they don't put on public record, because they fear ridicule. But their reports are being investigated by Dr. Richard Haines at NASA-Ames Research Center, and I think they're a very impressive category of reports.

EB: Mm-hmm. And, uh, some of the movies, like "Close Encounters of the Third Kind," "ET," and like that, they've done a lot of research, which seems to be paralleled by a lot of the stories, this documented history that you present in your book "Uninvited Guests." Do you think that Steven Spielberg, for example, was borrowing from the same basic materials that you've used in your book, to background his films?

RH: Yes. Steven Spielberg had some contact with the Center for UFO Studies, which was headed by Dr. J. Allen Hynek, and did indeed borrow from the UFO literature, but I think he expanded beyond that and took a few "artistic liberties," shall we say...went a little beyond the legitimate database, but indeed he was borrowing from it.

EB: OK, because I notice that, "Close Encounters," I notice a lot of the lights and the sightings and the shapes of the humanoids seem to correlate with a lot of the actual sightings that are documented in your book.

RH: Right.

[Commercial Break]

[Transcript picks up when Speiser is talking to Baldwin about Senator Goldwater incident. Tape started late...]

JS: ...confirmed to ParaNet that he was not allowed access to records where UFO information was kept.

EB: Why? Isn't he...

JS: That is a good question....

EB: ...a high muckety-muck, or was...

RH: He didn't have a high enough security clearance.

EB: ...a member of the Senate, head of the Armed Services Committee, whatever he was the head of, a top-secret clearance...

JS: He was head of just about every possible Senate committee that would have oversight powers over anything that would have anything to do with foreign technology, alien technology, space...he was head of just about everything that would come under that venue.

EB: Is there any member of [the] Senate, or of the President's

Cabinet, who would be allowed...I mean, the head of the Armed Services on the President's Cabinet, the head of Defense, the Defense Secretary, rather, wouldn't that person be allowed...?

JS: Well, any answer I give would only be speculation, we don't know who has the clearance... Dick might have a better aspect than I do on that...

RH: Well, I'm in the same boat. We really don't know who has been told what, you know. All we know is that increasing documentation from the past suggests that there has been a tightly-held secret by a group called MJ-12...

EB: MJ-12?

RH: Yes, MJ-12, which was a group of very high, highly placed political leaders and scientists, back when they allegedly first got some kind of physical evidence. And this was just between the President (then Harry Truman) and this group of scientists. And it was very tightly-held. Other members of the Administration were not told, other military leaders were not told, other politicians were not told, so we just don't know. Assuming that's true in the first place, which we don't really know, although there's suggestive evidence of it...assuming that's true, then we don't know where it went from there...what has become of this evidence, who has been clued in and who hasn't. So it's very much up in the air. But there's enough suggestive evidence and leads here that we only wish that we could get some high-powered investigative reporters involved, to really dig into this, because, you know, we could certainly provide some very substantial leads to them that they could have a ball with.

EB: Well now, in your appendix, Appendix B here, you have a briefing document of Operation Majestic-12 that was "prepared for [then-] President Dwight David Eisenhower," back in November of 1952, and it says "Copy 001 of 001," which means this was the only copy ever made? "Top Secret" is crossed out and "Eyes-Only" crossed out on my copy, in the book. Can't you get in trouble for even copying this, or publishing this?

RH: No, no.

EB: Why? says "Top Secret"!

RH: Civilians are not subject to this kind of thing. If I were a member of the military and published this, then I might get in trouble, but they have no hold over me...

EB: Well, the Rosenbergs weren't members of the military and they took some Top Secret information out of the country...

RH: Well, I'm not publishing any atomic secrets, see, I'm publishing something whose validity is denied...

EB: Oh, I see, they deny that this is an actual document...

RH: ..and also I'm not the original publisher of this. This was released by Bill Moore and Stanton Friedman and Jaime Shandera.

EB: How did they get it?

RH: They...Shandera received it in the mail anonymously on film. It was an undeveloped roll of film, and he had it developed, and this was what was on the film. They have spent several years since then (this was several years ago), they've spent several years doing a lot of clever documentary research, and biographical research to find out who are the principals named in here - they name the twelve, the Majestic Twelve, in here - they did a lot of research to find out who these people were, where they were at the time of the alleged incidents, you know, the whole thing. And everything they've been able to find out is at least CONSISTENT with this report. Doesn't prove it...

EB: Well, now wait, according to this there were nine, whatever, nine spaceships or craft or whatever else flying over New Mexico, right? Or the Cascade...I'm sorry, uh, Cascade Mountains in the state of Washington, but then, later on, there was a [begins more-or-less quoting from document] crash in a remote region of New Mexico, about 75 miles northwest of Roswell Army Air Base (now Walker Field), and aerial reconnaissance discovered four small human-like beings that had apparently ejected from the craft, somewhat before it exploded, and fallen to the earth about two miles east of the wreckage site, and all four were dead and badly decomposed due to the action [of] predators and exposure to the elements due to the approximately one week time period which had elapsed before their discovery. Now they removed the bodies, and so forth, and put a cover story out about a weather balloon. But the question I have is, that there were nine of these craft visible just before, or a month before, in the Cascade Mountains, and a month later, one of these, obviously, from the same formation, or a similar one, crashes, why wouldn't the other eight have stuck around or why wouldn't they be able to get there if they have the advanced technology and pick these other creatures up, or find out where they had crashed, if they had this advanced technology? Why couldn't they find it before we did?

RH: We don't know, but, the point is that these things allegedly crashed and allegedly were retrieved. And you can only speculate about what else went on. Actually, if the story...if you take it at face value, the beings were dead when they hit the ground and the craft exploded in the air. So they may have been "written off..."

EB: Oh, and they thought there wasn't enough to even go after...

[Commercial Break]

[Tape again started late...]

EB: ..if they know that much about us, why don't they speak our language? Because some of the sightings, uh, the people say they make "unintelligible sounds." Why wouldn't they have taken a Berlitz course or something, in English?

RH: [chuckles] That's a good question. I don't know. I say in my book, in various places, that we may underestimate the difficulties in cultural differences between us and supposed

alien beings, or beings [from] elsewhere, as I call them...

EB: But if you can build a spaceship, you must have some computer technology. We have computers that will translate most foreign languages. They can translate Chinese to Russian to English in a matter of seconds.

RH: Yes, but if they come from a totally different biosphere than anything we're familiar with, you know, and there could be tremendous roadblocks. They might not even be able to recognize, out of all the myriad forms of life on Earth, which is the supposedly intelligent life. They may be down there trying to talk to porpoises. Who knows?

EB: Well, we have some intelligent life now on Line #1. From Phoenix, here's Charles, at 258-KFYI. You're on with the author of "Uninvited Guests," Richard Hall, and Jim Speiser, the ufologist and director of ParaNet. Charles, you're on KFYI, hello there.

Caller: Hello. Uh, gentlemen, I frankly, I think this is all hogwash.

RH: Good.

EB: Hogwash!

Caller: Right. And here, let me give you my proof. Now, I don't know about the rest of it, but this one part where these craft landed, and all that, and our government is either hiding it, hiding them, or destroying them, or something, to keep us from finding out. Now, just think of this for a moment: We are not the only nation on Earth. I mean, there are hundreds of nations where others could have landed, and it is assumed that...I don't believe that for whatever planet they come they'd pick just the United States and these little confines. Therefore, all the nations of Earth - Russia, China, India, Australia, Canada, England, Germany - all of them must have ALL gotten together in one great conspiracy to keep this information from all the peoples of the Earth. Is that humanly possible?

EB: Or extraterrestrially possible...

Caller: It is?

EB: Is it EXTRATERRESTRIALLY possible, not HUMANLY possible.

Caller: Well, no, WE are the humans who are hiding this, you see. Or our government.

EB: Well, that's a good question, except that, in this book, I might point out, that there are sightings in places like Finland, France, Italy, and New Guinea, and Brazil.

Caller: But how about absolute proof, that is, like you say, wreckage, bodies, even though decomposed...apparently, since these bodies were damaged by predators, they are apparently edible.

RH: Well, that's very interesting, you show some signs of having read the literature, because we didn't mention the predator damage before...

EB: I had mentioned that just a moment ago...

RH: Oh, did you mention predator damage? OK, but let me just say that, you talk about the international scope of this thing, that's absolutely correct. We've learned that even mainland China, communist China, has had a long history of UFO sightings in modern times, which is only now beginning to come out since the country has opened up a little bit to the West. We have an official ongoing investigation in France, and so forth. I don't think it requires any international conspiracy to account for why governments haven't told us things. The governments are confronted with some very strange, baffling information and so are we. What we're getting tonight in this discussion is some of the most extreme, very dubious sort of information. In my book, I have a solid underpinning of why we take this subject seriously at all. This question of whether or not there are crashed UFOs and physical evidence is definitely up in the air. I don't insist that that's true. All I do is report the information that is available, and suggest that we really need to study this seriously. But I don't think it necessarily follows that there has to be some big international conspiracy, I don't follow that logic.

Caller: Well, somehow it must have sneaked out from SOME country, that they have evidence which I assume that they would have also, not just we.

EB: Oh, well there have been crashed UFO reports from other countries. There have been abduction reports from other countries.

Caller: And they are also keeping this a deep, dark secret from their people?

RH: No, its NOT being kept a deep, dark secret, because we're aware of it. But its just not believed, you see....

Caller: Well, if they would show me, I'd believe it.

RH: ...like you, people say "hogwash."

Caller: Yeah, but if they would show me, I would believe it!

RH: Well, read my book. I'll show you.

EB: We had a shooting down of an airplane by one of our Naval vessels with hundreds of casualties, and people called our station and said they don't believe it, that it was set up and that there were fake bodies and corpses that were set up from Iran...

JS: That's the trouble, a lot of people...you've heard the expression, "I'll believe it when I see it." A lot of people will see it when they believe it. They preface it by that..."I have to believe it first, and no matter what you show me, I'm not going to believe it until I believe it."

[Commercial Break]

EB: Six minutes before 8:00, we had a fellow named Joe waiting on Line #2, but obviously a UFO has spirited him away. So if anybody else is allowed to call us, if they're not in the hands of either the Air Force or the extraterrestrials, then you are free to dial 258-KFYI or toll-free 1-800-242-TALK. And our guests for these last few minutes of this first hour: we have Richard Hall, the author of "Uninvited Guests," which is probably the best collection in logical sequence of all the sightings, all the reports, and lots and lots of theories on whether or not the government is covering up something, or whether or not we have aliens among us. And Jim Speiser in our studio, ufologist and director of ParaNet. Now that's a computer Bulletin Board, Jim?

JS: Yeah, its a network, actually, of computer Bulletin Board Systems, designed to collect and disseminate information on what's happening right now in the paranormal, especially UFOs and other anomaly fields such as Bigfoot, Loch Ness Monster, Cattle Mutilation, things like that. There's a communications gap in these fields...

EB: So sharing information, and trying to see if there's a pattern here...

JS: Exactly.

EB: ...might help. Richard Hall, I understand our government, or SOMEONE, investigated you, when they found out you were putting this book together, this gathering of all the intelligence data on possible life from other atmospheres, other planets, other solar systems. Is that true?

RH: I was investigated back a few years ago, a number of years ago by the Central Intelligence Agency, and its kind of an elaborate story, but the bottom line is that I found out, through some other acquaintances and some Freedom of Information Act requests that they had conducted a security clearance on me, without my knowledge or consent and...

As you know, I had posted a general notice on ParaNet Alpha to the effect th

anyone knowingly posting false or misleading information regarding government involvement in UFO investigation, or any other paranormal field, would be given the boot. I've done it before, and I'll continue to do it. I didn't want anyone to get the impression that I was singling out Cooper. I ixnayed a guy named Lemming for the same thing over a year ago.

Stan Friedman was unable to substantiate any of Cooper's claims, and my intelligence sources actually had a good laugh over it. These sources will remain anonymous, despite any protests from Cooper. The reason I did not take the same action with John Lear is this: John has continually stated that his information is nothing more than an hypothesis, based on information from "confidential informants" and other sources such as "UFO CRASH AT AZTEC." Wild as his story is, none of it can be directly contradicted by the public record because there IS no public record. Phil Klass, relying largely on information from British researcher Christopher Allan, has made a big deal out of the fact that the "MJ-12" briefing paper uses an unusual format in writing the dates, which happens to be exactly the same unusual format that Bill Moore uses in writing HIS dates. Our comment is: Whereas the notorious Straith Letter Hoax of 1957 DID reflect Gray Barkers' stylistic peculiarities, since it was written late one drunken night with no forethought, Moore would have to be remarkably stupid or insane to make such a naive mistake. If the dating similarity means anything, it more likely means that the REAL hoaxter was trying deliberately to frame Moore!

So, to get to the point: It appears that most thoughtful Ufologists believe "MJ-12" is possibly or probably a hoax, and some Ufologists, plus all of the debunkers, believe that Moore & Co. are behind it. Our position is that, although "MJ-12" is a hoax in all probability, Moore's group is NOT behind it. On to our exclusive information:

Your humble "Smear" editor spent large parts of three days with Moore and Shandera recently (Sept. 23-25), in Burbank, California, discussing "MJ-12" and related topics. Like "Deep Throat" in the Watergate Scandal, these informants do not always hand him answers, but they tell him where to look. As a result, Moore has given up his literary career, which looked very promising after the publication of "The Roswell Incident" (with Charles Berlitz) in 1980, and has devoted all of his spare time to research related to these ufological matters. He earns a bare living by selling UFO books and his own tracts by mail order.

Shandera joined Moore in the quest in 1982. He too has largely given up his career, which was in film and broadcasting. His financial situation is better than Moore's however, as his wife has a very good job in the TV industry.

Friedman is, it seems, a more passive partner, in that he is merely kept informed of information received by the other two. He continues to work at a normal science-related job in his home town in Canada.

Another thing that Ufologists don't seem to realize is that Moore's evidence consists of a great deal more than what he has released so far. (Apparently his sources tell him what he can release, and were he to disobey, he would blow the whole ongoing relationship.) There are other documents, including one he claims was given to him for exactly 20 minutes to do what he wanted with, and then was taken back. He photographed it and read it into a tape recorder, in the presence of the agent who lent it to him.

There are also several videotapes. We were allowed to see one 20-minute tape and most of another. These consist of a supposed agent talking in a totally disguised voice, answering a list of questions from a supposed newsman. The agent is disguised, and the newsman has his back to the camera. The proven identities of these two are known to Moore and Shandera, they say. No one was present at the tapings except these two, plus Moore, Shandera, and th

THE "MJ-12" FILE: ANOTHER EXCLUSIVE "SMEAR" REPORT:

We have already published our exclusive information from Dr. Ernest Taves, a very close friend of Dr. Donald Menzel, who apparently was "MJ-10". Taves, like others who knew Menzel well, cannot believe that the long-deceased former director of Harvard Observatory could have had this above-mentioned knowledge of UFO reality and still have written 3 anti-saucer books, and still have debunked UFOs emotionally at every opportunity. CUFOS, in an editorial by Jerry Clark in the May-June issue of the "International UFO Reporter", and in a more recent press release, seems generally supportive of "MJ-12", and claims that the "verdict is still open."

MUFON has expressed various opinions, swaying pro and con. They used our Taves material in a recent issue of their Journal, and in the August issue of their Newsletter, edited by MUFON's Massachusetts director James Melesciuc, they state: "The results of the MJ-12 circus created by Moore, Shandera and Friedman could be detrimental to the future of document research. Needless to say, CSICOP, as personified by Phil Klass, issued a totally negative press release, based on insufficient information, in our opinion. Much more interesting than the CSICOP release is the September issue of "Just Cause", published by Lawrence Fawcett and Barry Greenwood. In an article entitled "The MJ-12 Fiasco," they give a vast amount of detailed negative data that no student of this matter should overlook. (Address: P. O. Box 218, Coventry, CT., 16238). To this Bill Moore's only comment (to us, by phone) is: "Sour Grapes."

"Just Cause" introduces into the fray the name of a present or former intelligence officer named Richard Doty, assigned to Kirtland Air Force Base, New Mexico. The magazine alleges that Doty may very likely be Moore's source. A Dialogue with a former member of the Intelligence Community

This summer, while on vacation back to my families residence, I encountered a family friend that I had not seen since 1973. For obvious reasons I will not identify him, but for this record will call him "Paul". Paul is retired from over 30 years of distinguished government service, is a widower, and is one of the most closed mouthed men I have ever known. When I first came back from Viet Nam in 1972, I saw Paul at a family get together, and even though he was just back from South East Asia, he never mentioned it. I found out through his brother. When I went back east, I had taken a number of text files from my records, for my sister, who is fascinated by the subject of UFO's. It so happened that one evening, my sister and I and wife and another friend, Bob, were sitting outside my mothers house, and were discussing several of the files that I had taken back. Paul stopped out at the house, as he was going to a function with his sister and my mother. He sat down on the patio with us, and as usual, did not say much. My sister was reading the file concerned with the Majestic 12 papers and making some comments, that if this file was for real, the implications of alien contact could be staggering for the world if verified. At this point Paul leaned forward and asked if he could see the papers. My sister passed several of the texts to him, and until he left, he spent the remainder of his time reading them. Just before he left, he got me off to the side, and asked how I was involved with UFO's. I told him that I was an investigator for MUFON, and was involved with a computer network system with Paranet. This was the first of several conversations I had with Paul, and I don't ask anyone to believe it, because, frankly, I have problems with several things he told me. And you may wonder why Paul would tell me anything, considering his government service, and the agency he worked for. To begin with, Paul is very ill, the last time I spoke with him, he told me that he doesn't expect to be around for more than 18 months, maximum. Next, he told me that he never agreed with all the secrecy that surrounded the government and the subject of UFO's. And lastly, what he hinted at was actually occurring seemed to haunt him. As he said, there wasn't a hell of a lot that even the government was able to do about the situation. I present the following, and you can make up your own mind about whether to believe or not.

This summer past (1988) was the 20th reunion of my High School. This was the reason that I traveled back, and besides, my wife is in love with the east coast. While back, I became ill, and ended up spending almost two weeks in the hospital. Paul came and visited me, and this is how we ended having the several conversations that we had.

Paul at first asked if I realized what dangers were present in the subject of UFO's. I said "No", but I had heard rumors that this could be the case. He said you damned betcha it could. "If you stumbled over the right information you could end up among the missing, and Don, this sure as hell wouldn't be the first time."

I asked him how he came to know so much about the subject, and he said with the job he held, it was his business to know about a lot of things. I then said come on Paul, I had dealings with spooks while in Viet Nam, so don't try that line on me. He told me then, that this was to his knowledge, still one of the most highly classified subjects in the intelligence community. That

brought to mind the "Smith Memo" from the 50's, and I relayed it to Paul. I mentioned that Smith had stated that the subject of UFO's had been rated higher than the H bomb, and in perspective, was this still the case? Paul's reply follows, and for the purposes of this file, I have condensed into one session our talks.

In the 40's, when the "flying saucer" scare started, the military and government were concerned that it was possible that the Soviets had made a breakthrough in technology with their German scientists, that our German scientists had not been able to duplicate. It then became evident that this technology was above and beyond what we were able to achieve, so the phenomenon had to come from outside. For a while there was a deadlock as to what to do, but then apparently the military was able to secure one of the craft. I asked Paul if he meant Roswell, and he only smiled. He said to read the MJ 12 stuff again, that there were enough facts to get an idea of what he was talking about. After that, it was apparent that the technology was well above what we were capable of. There were fears among certain people that this could be the prelude to invasion, or possibly even worse. Others saw this as a straight shot to technology that we couldn't even dream of, and to exploit everything we could out of it. Paul stated that there was a genuine fear that if the Soviets could get one of these, and exploit it, the United States would be in deep excrement. There was a "think tank" that was set up, and the decision for secrecy was understandable in that scenario. Many of these craft were flying over nuclear installations, and one thought at the time was that they could be after uranium among other things, if they were, as believed then, coming from a "dying" planet. I asked if at that time, were they considered to be benign, and Paul said yes, they were, but then several things happened to change that idea. He would not elaborate, so I mentioned the Mantell incident, and he said that is the most well known case, but there were others, and some very bizarre.

The think tank that was set up in the 40's were concerned that some of these cases would become public knowledge, and they still remembered the "War of the Worlds" scare that Wells threw into the public in 1938. They did not want a panic that could affect the nations security, commerce, industry, finances and so forth. The result was to debunk the whole damn thing, and hope it would either go away, or they could solve it in time before it did become public knowledge.

I asked Paul about several cases that I read about in "Clear Intent", one of them being the Cuban Jet Incident. Paul said that he had heard about that, he wouldn't say much, but this is not the only case where one of these objects had shot down aircraft, "and it didn't all happen outside the U. S. either".

"Look", he said, "if you were out in a very primitive area, and were lost, or hungry, or what ever, and came across a primitive native tribe, and I mean compared to you, really primitive, would you trade with them, or take what you needed, food, women, whatever, IF YOU WERE VERY AMORAL?" "Look, if in this case, you regard these natives as less than dirt, and the only thing they have in common is that they have what you NEED." You are familiar with the animal mutilations aren't you? Many people think that this was a government sponsored operation, testing chemicals or something. Well, it wasn't, and farm animals are not the only thing that has been tested. The guys I know that are still active have said that right now, is one of the biggest "UFO flaps" that they have ever heard of, and there is a lot of concern as to how long it can be kept secret.

I hated to break in on Paul when he was talking this freely, but had to ask about the reported astronaut sightings. Yes, there were sightings on damn near all the "shots", and it was always feared that the news services would

pick up on some of the reports. We did a damn good job of damage control though. "Well Paul, what about reports that these things have been seen on the moon?" I asked. "Yes" he said, "they have been seen there, and some of this has come out, so I don't think I am breaking any oaths, but , haven't you asked yourself why after all the billions of dollars that we had spent to get to the moon, after the early 70's No one, us or the Russians, have gone near the place." Yes, I admitted, I had wondered why, and then asked him if he knew why. Paul just smiled and then pointed to the file that contained the Lear Text. "You know", he said, "this guy has hit pretty close on several points, and I wonder if anyone has approached him?" I asked what he meant, and he looked at me and said "Don, you know what I mean, and after all, if a lot of the general public became aware of this, they would scream like a mashed cat, and demand to know what the hell the government is doing about it. The problem is, there are some that still think that they can control events and keep a lid on this, and others that know we are way in over our head and are looking for a way out." Alright then, what are these things, where do they come from, and what DO they want? I must have looked pretty exasperated then, and Paul looked at me and gave me kind of what I thought was a sad smile. "Don" he said, "I don't know where they come from, as to what they are, they are very different, and as to what they want, you are gonna sleep a lot better if I just go." And he did leave then.

I haven't talked to Paul since I got back home, and just several days ago, I got word that he had a heart attack and is in very poor condition. I have wondered about a lot of what he said, and have decided that in lieu of keeping the whole thing to myself, I would put it on my word processor, and then make a decision whether to release it or not.

Paul had stated on several occasions that this subject had the potential to be very dangerous, and to be careful of pursuing it. "With access to the right information, if it became known, people have disappeared." I don't think he was just trying to scare me, the guy had been a professional intelligence agent for longer than I have been alive, and I am sure he knew a hell of a lot more about this, than I would even want to. He had mentioned several things, that even now I hesitate to put down, but the thing that inclines me to accept what he said, was knowing a bit of what kind of man he was, he seemed haunted and scared.

Well, in light of several things that have occurred recently, with the "New and Improved" BlueBook, which I might add I distrust wholeheartedly, the meltdown within MUFON, the continuing "flap" that doesn't show any signs of slowing down, much less stopping, and the fragmented community of UFO investigators, I discussed this with my better half, and have decided to throw it out, and see where it landed. Take it for what it is worth, and remember, I have just relayed what I was told, and I did warn you up front that this was almost beyond belief.

This information is never to be declassified. Each page of each document will be numbered consecutively and the number of pages will appear upon the cover sheet. Copys of MAJESTIC TWELVE beyond the original number are forbidden.

PROJECTS under MAJESTIC TWELVE

The operations listed here were current as late as 1976 with absolute certainty and are still operational to the best of our knowledge. The names of the original operations were changed several times over the years and eventually evolved into those listed.

PROJECT SIGN (PROWORD) MAJIC

The first project under MAJESTIC TWELVE. The mission of project sign was essentially the same as that which PROJECT AQUARIUS evolved into. PROJECT SIGN referred to aliens as Extraterrestrial Biological Entities. The reasons for the absorption of PROJECT SIGN by PROJECT AQUARIUS were mainly of a political and security nature. PROJECT AQUARIUS stripped the Air Force and

Army Generals of their historic control of the UFO/IAC projects and placed most of it under the Intelligence umbrella.

PROJECT AQUARIUS (PROWORD) MAJIC

Established in 1953 by President Eisenhower under control of MJ-12 and PROJECT SIGN. The Project contains all information collected by the United States since it began investigating UFO's (Unidentified Flying Objects) and IAC's (Identified Alien Craft). At the time we saw this information it existed in approximately 15 or 16 volumes. This project became an independent project when PROJECT SIGN was eliminated in 1960. PROJECT AQUARIUS referred to aliens as Alien Life Forms. The mission of PROJECT AQUARIUS was to gather all scientific, technological, medical, and intelligence information from UFO & IAC sightings and contacts with Alien Life Forms. The information was to be used in the space program.

PROJECT SIGMA (PROWORD) AQUARIUS

Established in 1954 as part of PROJECT SIGN. The mission of PROJECT SIGMA was to establish communication with the aliens. First communication was established in 1959 through binary computer language. On April 25, 1964 a USAF (OSI) officer met with aliens at a prearranged desert location in New Mexico. Information was exchanged and a basic understanding was reached after several hours. It was learned through this effort that several species of alien life existed. Communication was eventually established with all of them. Through communications it was determined that 3 categories existed. The three categories are MALEVOLENT (DANGEROUS), BENEVOLENT (GOOD-HELPFUL), and NEUTRAL (OBSERVERS ONLY) The project has been extremely successful.

PROJECT PLATO (PROWORD) AQUARIUS Established in 1960 after the United States established communications with the aliens. The mission of PROJECT PLATO was to establish diplomatic relations with the aliens. Project Plato made agreements in order to prevent hostilities between the United States and the aliens. An agreement was made with the MALEVOLENT aliens whereby they could abduct humans. The purpose of these abductions were to provide blood and other biological fluids as food for the aliens. The aliens agreed to furnish a list periodically to MJ-12 of the names of those abducted. PROJECT PLATO took whatever steps necessary to prevent public disclosure.

* PROJECT PLUTO (PROWORD) AQUARIUS

Established in 1947 after the Roswell incident. The mission of PROJECT PLUTO was to recover all crashed or downed alien craft, to recover all evidence of alien presence or technology, and to recover all alien bodies (alive or dead). PROJECT PLUTO developed cover stories to satisfy press and civilian curiosity. PROJECT PLUTO was authorized use of deadly force and/or relocation to insure secrecy. PROJECT PLUTO was responsible for and biological intelligence of the Alien Life Forms.

PROJECT POUNCE (PROWORD) AQUARIUS Established in 1968. The mission of PROJECT POUNCE was to evaluate all UFO/IAC information pertaining to space technology. The goal was to duplicate the technology and/or improve upon it. Ultimate use of the technology would establish the United States as the dominate world power and close the gap in any confrontation with the aliens.

PROJECT REDLIGHT (PROWORD) AQUARIUS Established in 1954. The mission REDLIGHT was to test a recovered alien craft. The mission was accomplished in part only. PROJECT REDLIGHT was terminated in 1963 after every (flyable) recovered craft exploded during test flights. There were no survivors among the human test pilots.

PROJECT SNOWBIRD (PROWORD) AQUARIUS Established in 1972. The mission of

PROJECT SNOWBIRD was to test fly a recovered alien craft. The project was on going the last time I saw this information.

PROJECT ????????? (PROWORD) AQUARIUS (NOTE...We are recall the name of this project nor have we been able to get response from anyone on it. At the time we saw the information the project was ongoing. It cannot be determined if this project is still in existence.) The mission of this project was to develop a low frequency pulsed sound generator. The energy produced from this generator was to be concentrated so that it could be aimed and used as a weapon in order to destroy the alien craft and beam weapons. The alien beam weapons were described as ange but able to incapacitate or destroy any weapons system known to date (1972). The aliens also possess a beam weapon which is described as being able to paralyse any human within range. Tests were described as having shown that the alien craft and weapons were extremely sensitive to low frequency pulsed sound waves. This weapon was to be used to incapacitate the alien defenses in order to allow PROJECT EXCALIBUR to succeed in its mission. The initial technology used in this project was capture the Germans during WW- II. The German sound generators were described as being able to knock down reinforced concrete buildings and shatter 4" thick armour from a great range. This technology is believed to further substantiate that Germany had recovered alien craft and had possibly had some dealings with the aliens prior to or during WW-II. Documents captured during and after WW-II indicated that an alien craft had been recovered by Germany in 1939. A German built flying saucer was captured dur last few months of WW-II.

PROJECT EXCALIBUR (PROWORD) AQUARIUS Established in 1972. The mission of PROJECT EXCALIBUR is to develop a weapons system capable of destroying the alien underground base after the alien beam weapons have been incapacitated or destroyed. The alien underground base is located beneath an indian reservation near the small town of Dulce, New Mexico. The device must be capable of penetrating 1,000 meters of tufa / hard pack soil and sustain no operational damage. This typ is commonly found in New Mexico where the alien base is located. Missile apogee must not exceed 30,000 feet AGL. Impact deviation will now exceed 50 meters. The device will carry a 1 megaton warhead.

PROJECT BLUE BOOK A U.S. Air Force project established to determine whether UFO's pose a threat to the security of the United States and to determine whether UFO's exhibit any unique scientific information or advanced technology which could contribute to scientific or technical research. PROJECT was successful in its primary mission outlined above. PROJECT BLUE BOOK was not quite so successful in its secondary mission which was to publicly explain away the UFO phenomenon as natural or known phenomenon in order to eliminate public interest. To completely fulfill the secondary mission it was decided that an outside commission of distinguished scientists would be convened in order to permanantly lay the issue to rest. After this 'study' was completed (Condon Commission) the Air Force state the continuation of Project Blue Book cannot be justified, either on the ground of national security or in the interest of science. PROJECT BLUE BOOK was abandoned and its mission and information was consolidated under PROJECT AQUARIUS in 1969.

SCIENTIFIC STUDY OF UNIDENTIFIED FLYING OBJECTS Contracted to the University of Colorado in 1966 and Chaired by Dr. Edward U. Condon. The results of the panel were dictated before the first meeting. Despite objections of the other panel members, Dr. Conde le to fulfill the mission. The general conclusion was that "nothing has come from the study of UFOs in the past 21 years that has added to scientific knowledge." A panel from the National Academy of Sciences agreed. The press and the public were satisfied. Except for a hard core element of UFO believers the issue died in the public forum.

OPERATION UFO (NSA OPERATION IN SUPPORT OF PROJECT PLUTO) The mission of Operation UFO was to form intelligence teams versed in all of the knowledge learned which would be the first on scene of any UFO crash site in order to secure the technology and prevent it from falling into foreign hands. Several teams existed over the world. The United States was specifically concerned that it did not fall into Soviet hands. This mission was to be accomplished no matter the country of occurrence. Many subsequent ALIEN CRAFT recoverys would occur in foreign countrys as well as the United States. UFO was also used to recover downed space hardware (especially So d to recover nuclear weapons which became lost (usually by accident)).

OPERATION MOONDUST (SUPPORTED SPACE PROGRAM & UFO) The mission of Operation Moondust was to provide a cover which would neutralize public curiosity while recovery of an ALIEN CRAFT was being conducted. The teams that made up the compliment of Moondust were the same teams that made up UFO. Moondust was made public and its mission (to the public) was to identify and recover United States space hardware which might fall to earth. s a bonified mission when circumstances dictated.

OPERATION BLUEFLY (SUPPORTED UFO & MOONDUST) The mission of operation Bluefly was to provide QUICK REACTION COMBAT TEAMS known as ALPHA teams (fight for technology if neccessary), mechanical and technological support in recovery, rapid and secure transport to secure storage and examination areas. There are several of these storage and examination areas in order to limit distance traveled and thus limit the possible chance of an accident that cou e cargo to public knowledge. Several teams existed over the world. Recovery and transport of both EBEs (dead or alive) and Alien craft were accomplished. Bluefly was also utilized in event of recovery of space objects (of terrestrial origin), and event of recovery of lost nuclear weapons (usually due to accident).

NOTE....This account of the history and current status of MAJESTIC TWELVE and the Alien Life Forms has been kept brief. We believe that the intent, however, has been served with th on provided. The whole story would fill several hundred volumes. We realize that even with the combined effort of several memorys we have probably made some mistakes. We have tried to minimize the mistakes and feel that what is represented is true and correct to the best of our combined knowledge.

>> The question is often asked, why don't more military UFO witnesses come forward publicly, and provide names, dates and places? Surely they aren't REALLY intimidated by such empty threats as JANAP 146-E, which provides for hefty fines and jail sentences for breaking silence on a military UFO sighting. Surely they realize the scientific import of their sighting transcends any nationalist or military considerations. If more military witnesses don't come forth publicly, isn't it possible that there aren't really as many as hardcore ufologists would have us believe? Its a question I've often asked myself.

ParaNet is deeply indebted to, and a little honored by, user Bill Cooper of Fullerton, California, for this, the first known report of a multiple military witness sighting that occurred onboard the submarine USS Tiru in 1966.

In 1966 during the month of the Rose Festival in the Pacific Northwest United States, the USS Tiru SS-416 left Pearl Harbor bound for Seattle Washington. The sub moored to a civilian pier near the downtown Seattle area and thousands of people toured the sub during its stay in Seattle. After its duty as "showboat" it proceeded to a back bay area where it underwent torpedo trials. I believe the area was called dabob bay [pronounced day-bob] but I am not sure of the spelling. I include the above information because it should be easy to research. During the cruise from Pearl to Seattle five of the crew had a very unusual experience. During one late afternoon the sub was cruising on the surface at approx. 10 knots when the port lookout reported a strange contact at a range of 2 miles bearing 315 degrees relative. The lookout refused to tell the OOD what it was that he had seen and instead insisted that the starboard lookout and the OOD both look at that area. The three men looked through their binoculars toward the area reported and were astounded to see a metal craft larger than a football field tumble from the clouds into the ocean. It actually tumbled end over end and when it hit the water and sank beneath the ocean huge geysers of water rose into the air. When the port lookout was sure that the others had seen it he then told the OOD that he had seen it tumble from the ocean up into the clouds. The OOD and the starboard lookout were speechless. Within a few minutes, however, they all became excited when it again rose from the water and tumbled up into the cloud layer. At about the same time a crew member below queried the bridge about a radar contact at the same range and bearing. Sonar also reported strange echos. The OOD called for the Captain to come to the bridge at that time. He also called for the camera to be sent to the bridge. The Captain arrived on the bridge within 2 minutes and the Chief Quartermaster was right behind him with the camera. At about the same time the object emerged from the clouds and fell down into the ocean. All five men witnessed this. The QMC took pictures as it rose up into the clouds and then back down into the ocean once again. The five men watched for quite a while longer but nothing else happened. Soon the sub had moved out of visual range and the Captain told all witnesses that they were never to discuss what they had seen with anyone

under any circumstances. He stated that the incident was classified information. The Captain then went below and sent a radio msg. There was no doubt as to what we had seen. It was a metal craft with machinery on and around the outside of it. It appeared to have windows or lenses placed around its perimeter. It made no noise that we could hear. It did not disturb the subs electrical systems nor did it affect the gyro compass. It looked very much like a round flying "ship" as in sea going ship. It had the shape and form of a saucer with a bowl inverted in the saucer and it was huge. I will never forget it as long as I live. When I first saw this craft I believe that my heart literally stopped beating and I was terrified. The name of the OOD was Ensign Ball. The starboard lookout was an American Indian seaman that the crew called Geronimo. The port lookout was a new man who left the sub soon after the return to Pearl Harbor and his name was Cooper. I do not remember the Captain's name nor the Chief Quartermaster's name. This is the first time I have ever mentioned it since the moment that the Captain told me that it was classified. As far as I know it has never been reported to the public before this instant. It should be easy to verify the facts if you can get a copy of the log and/or contact the other witnesses. The names should not be too hard to find in the ships records/logs. I was the port lookout. I must say that I feel a great uneasyness in posting this, much like the way I felt in Vietnam when my life was in great danger.

Press ENTER to continue:

I had my first contact (other than public messages on the Paranet BBS) with John Lear on October 4, 1988. I called him at his home in Las Vegas because he had asked me to by msg on Paranet BBS. At the time I called he could not talk long as he had visitors from Los Alamos LANL WX (weapons) division (4 men, he told me). We had a short pleasant talk during which he thanked me for my support and expressed the feeling that, if I had not come forward when I did, he would have left Paranet and would never have returned. We promised to talk at a later date.

We spoke again on Thursday Oct. 6th when he called and asked if I would help him out by posting the Bill English statements to Paranet. I told him that I would. he stated that he would also send me a lot of other documents and statements which he had in his possession. John called again on Friday Oct. 7th to say the package was on its way. I told him I would look forward to reading his information.

I received the information by Federal Express on Saturday Oct. 8th at about 10:30 am. Nonstop it took me until around 4:35 PM to read everything. I was numb. It confirmed everything I personally knew and had seen first hand (information which I had delivered to others a week previous). Here at last was confirmation of both John Lear's statements and confirmation of my statements. All from several different sources (most named some not). Our statements confirmed theirs. The important thing is that none of these people know the others and they all say the same thing.

I will upload as much of this information to the board as quickly as I can beginning with the Bill English statements. I will follow with the others as fast as I can type them to disk and archive them together. I will be somewhat selective as to what I put in at first because I want those with the greatest impact to be seen first. Some of these things were obviously published before but take on new meaning when combined with this stuff. I have chosen to call this information FEDEX for lack of a better title and will upload it as FEDEX1.ARC, FEDEX2.ARC, FEDEX3.ARC, etc.

I would like to say in closing that I believe that John Lear has been treated in a most uncivilized manner by a lot of supposedly civilized people. In fact I believe that some of you were downright degrading and vulgar to say the least. I have also (at times) been treated in the same manner. Specifically since I first expressed my knowledge that Mr. Lear is right. Therefore I know how he feels. I hope that those of you who are guilty can clean up your act. If you can then we can get on with solving this mystery and exposing it. Leave the debunking to Phil Klass and those others who's job discription, in part, is specifically to debunk. We must stick together or all is lost. The mission of those in the Government who's task is to keep all this a secret is to make all of us look like fools. I must say that some of you are making their jobs very easy. Think about it. Respectfully, Bill Cooper

Abduction...to take away a person by force (against the free will of the person abducted). (The Merriam Webster Dictionary, paraphrase by Michael Corbin). This word is associated with many things that one would read about in the newspaper virtually everyday. The Iranian hostages, young girl abducted by two men and held for ransom. But, the word 'abduction' has even more serious implication of late. Whitley Streiber's abduction, Budd Hopkins' abduction studies. What does this mean? Over the last few years, there has been an ever increasing rate of alien abductions of human beings. As a matter of fact, the numbers have grown enormously over the last year! As the record indicates, seemingly normal human beings are being removed from their homes and vehicles, sometimes in broad daylight, to be examined by alien beings. Reports have indicated that these examinations include the taking of ova and sperm samples from the victims and the possible insemination of female abductees who report subsequent pregnancy only to find that the pregnancy has mysteriously disappeared shortly after the first trimester. These disappearances of fetus' are, likewise, associated with another abduction of the victim. Mysterious scarring and implants around the frontal brain area have also been commonplace. At first, one would naturally speculate that the people reporting such abductions were obviously hallucinating such events, however as time has passed, more and more people have been coming forward reporting the most bizarre abduction reports of our history. People, whom doctors report are average intelligence and normally adjusted socially. What is going on? I have been asking this question of myself and others over the last year, and have been drawn to this mystery only to find that it goes much deeper than most people would realize or acknowledge. Speculation has ranged from nothing more than an over active imagination, on the down side, to stories of the last days and 'fallen angels', on the high side. It is here that I would like to analyze what we know to be true in the area of UFO's and abductions.

Recently discovered by Barry Greenwood and Lawrence Fawcett, authors of the well known book, Clear Intent, have discovered that the United States Government has over 10,000 documented reports of UFO sightings made by the general public, airline pilots, both civil and military, radar observed UFO's and on and on since as early as 1942. During the period of 1942 to 1947, the reports were sparse and generally were not treated too

seriously. Then, in 1947, things took a sudden and mysterious turn when the news wire buzzed that a saucer had crashed in a remote region of New Mexico near the town of Roswell. As quickly as the story went out over the wire, it was immediately silenced by the U.S. Government and later explained away as a radar reflecting device attached to a weather balloon. However, despite the government attempts to disguise the possible recovery of an unknown type aircraft, using the weather balloon story, the rumors persist that what actually was recovered in that field was an actual spacecraft piloted by aliens. Even unto 1988, the mystery as far as the public is concerned remains unsolved and steeped in more secrecy than ever before. Greenwood and Fawcett launched a massive and bold campaign to have the government release to the public, any and all documents related to this bizarre phenomenon, only to be met with resistance of a large degree by the military entities that on one hand, deny the very existence of such phenomenon and on the other, outright admit their existence by withholding documents pertaining to them. Many documents are classified 'Above Top Secret'. So, with this in mind, are we to believe that nothing exists? Are we to believe the Philip Klass' that would have us understand that we are involved in a phenomenon known as mass hallucination or mistaking something moving across the sky as the planet Venus? Not hardly. But, what is it?

Anyone could let their imagination run away with them speculating on what this phenomenon is and from where it comes. We have seen this lately in the form of frantic appeals that we are being invaded by little green men from outer space. We have heard stories about MIB's (Men In Black) stalking abduction victims, dark helicopters buzzing homes and observing the movements of individuals who are deeply involved in this mystery. We have heard that there are underground bases where the aliens perform horrible experiments on hapless human victims. And, on top of all of this, we have heard of MJ-12, the secret, covert organization, responsible only to the President of the United States. MJ-12 is supposed to have the complete and total access to actual living aliens who are visitors of the government. The stories go on and on. What is true and what is false? Since no civilian researcher has ever been invited to a full blown crash investigation, the civilian ranks must work at this project in the blind. Many times, there have been reports of actual physical evidence of an encounter, but to this day, not one piece of evidence has been circulated among the civilian ranks. So, once again, in the absence of physical evidence to examine, we are left with our minds to speculate on what could be going on.

While it is not the scope and purpose of this document to discuss theology, it is important to keep in mind that there could be a possible link between the phenomenon of today and what has been recounted in ancient documents. In 1968, Barry H. Downing published a book called 'The Bible and Flying Saucers'. In this book, Mr. Downing attempts to relate the Bible to this phenomenon. What makes this theory so difficult in this day and age is the fact that mysticism has been replaced with science. As science has made such leaps and bounds in discovering our roots, it seems that the Bible and God has been traded off for science text 101. But, even with all of science's knowledge, the basic meaning of life has still not been discovered. We have always needed a balance of Science, Philosophy, and Theology to

get us where we were going. For nearly 6000 years men have tried to discover their meaning and roots of being. Yet, in today's modern world, we feel that we are so close to the answer. Accident. I have heard our existence justified as being part of the 'Cosmic Cookbook' where you add a little of this and a little of that and poof!, out comes instant life. But who or what has been doing the 'adding' of the ingredients to this large cosmic pot? While I am not a scientist, I can say that so far, nothing to my knowledge has been discovered that will validate the principle of perpetual motion. In any event, if motion is to exist, something external must be applied to that object to put it into motion. Once motion is achieved, then periods of external intervention are necessary to keep that object in motion, lest it would eventually cease to move. Let's take a large metallic ball and suspend it from a string. That ball will just hang there until we apply the force to it to get it to move. Once moving, we will have to continue applying an external force to that ball to keep it moving. If we don't then that ball will cease to move. Now all of us are not scientists, but we do know that the ball exists since we can see it. We know that by hitting that ball, it will move. We also know that if we do not keep hitting that ball, it will stop moving in a short time. Science has taken this everyday phenomenon and studied it. They have come to the same conclusion scientifically that we have. Now science can acknowledge this because it has been observed, but science cannot necessarily determine why this is so. If they had, then we would know all there is to know about perpetual motion, but we don't. This same discussion could apply to our existence. We know that everything around us is in motion. This would lead us to believe, that some external force had to be applied to get things moving. What was that external force? Until these answers are beyond reproach, no one can say that this is wrong and that is right. Even science cannot definitively state that we are the products of an accident. The universe is in motion, but what force put that process in motion. Arguments will be that if God is responsible then who created God? But, until we reach God, then we can only speculate. Nevertheless, there are several viewpoints in favor of and against what I am saying here.

If God created us, what does that tell us about God? It tells us that God is the Greatest Scientist around. We have been created in a physical world with physical bodies and senses. We know that we know we exist. Thus, God must be bound by the same physical laws that we are, only He has the only real understanding of these laws. We know from the Bible and other ancient documents that have been found that throughout man's history on earth, he has been visited by beings not of this world, representing God and appearing to have physical bodies just as we do. These beings, while not revealing the mysterious meaning of life, have been instrumental in changing world events, both directly and indirectly. These beings have been referred to as angels. Recently, I utilized my computer to count the occurrences of angels in the Bible. Using Today's English Version, I referenced the word 'angel' and came up with over 400 occurrences of the word in the entire Bible. Thus, it would seem that there were angels reported quite a bit in the Bible. Where does this all fit in with the modern world? Many will say that the Bible is a collection of mythological tales designed to symbolize something moral, etc. Yet, the Bible is historically

correct. There have been cataclysms on this earth that were recounted in the Bible. There are events that are recounted in the Bible that are historically correct. How could a book of mythology be correct historically unless these events that we call myth actually did occur? Aside from the Bible, there are ancient documents that recount flying shields and strange visitors interacting with earth people. What about our modern world? Are we to say that the hundreds, even thousands of people that claim they have been abducted are the result of mythological beings? If this be true, then we are all victims of this biggest hoax to befall us in the 20th century.

Below follows an excerpt taken from the Pseudepigrapha's First Book of Enoch. As some may recall, Enoch was the seventh descendant of Adam and as Genesis 5:24 recounts, '...Enoch walked with God. Then he vanished because God took him...'. Most scholars agree that this work was written in both Hebrew and Aramaic, Aramaic being the language that Jesus spoke. As you read this, recall the modern abductions that have been taking place.

The Fall Of Angels

6 In those days, when the children of man had multiplied, it happened that there were born unto them handsome and beautiful daughters. And the angels, the children of heaven, saw them and desired them; and they said to one another, "Come, let us choose wives for ourselves from among the daughters of man and beget us children." And Semyaz, being their leader, said unto them, "I fear that perhaps you will not consent that this deed should be done, and I alone will become (responsible) for this great sin." But they all responded to him, "Let us all swear an oath and bind everyone among us by a curse not to abandon this suggestion but to do the deed." Then they all swore together and bound one another by (the curse). And they were altogether two hundred; and they descended into 'Ardos, which is the summit of Hermon. And they called the mount Armon, for they swore and bound one another by a curse. And their names are as follows: Semyaz, the leader of Arakeb, Rame'el, Tam'el, Ram'el, Dan'el, Ezeqel, Baraqyal, As'el, Armaros, Batar'el, Anan'el, Zaqe'el, Sasomasp w e'el, Kestar'el, Tur'el, Yamayol, and Arazyal. These are their chiefs of tens and of all the others with them.

7 and they took wives unto themselves, and everyone (respectively) chose one woman for himself, and they began to go unto them. And they taught them magical medicine, incantations, the cutting of roots, and taught them (about) plants. And the woman became pregnant and gave birth to great giants whose heights were three hundred cubits. These (giants) consumed the produce of all the

people until the people detested feeding them. So the giants turned against (the people) in order to eat them. And they began to sin against birds, wild beasts, reptiles, and fish. And their flesh was devoured the one by the other, and they drank blood. And then the earth brought an accusation against the oppressors.

8 And Azaz'el taught the people (the art of) making swords and knives, and shields, and breastplates; and he showed to their chosen ones bracelets, decorations, (shadowing of the eye) with antimony, ornamentation, the beautifying of the eyelids, all kinds of precious stones, and all coloring tinctures and alchemy. And there were many wicked ones and they committed adultery and erred, and all their conduct became corrupt. Amasras taught incantation and the cutting of roots; and Armaros the resolving of incantations; and Baraqyal astrology, and Kokarer'el (the knowledge of) the signs, and Tam'el taught the seeing of the stars, and Asder'el taught the course of the moon as well as the deception of man. And (the people) cried and their voice reached unto heaven.

9 Then Michael, Surafel, and Gabriel observed carefully from the sky and they saw much blood being shed upon the earth, and all the oppression being wrought upon the earth. and they said to one another, "the earth, (from) her empty (foundation), has brought the cry of their voice unto the gates of heaven. And now, (o) holy ones of heaven, the souls of people are putting their case before you pleading, 'Bring our judgment before the Most High.' " And they said to the lord of the potentates, "For he is the Lord of lords, and the God of gods, and the King of kings, and the seat of his glory (stands) throughout all the generations of the world. Your name is holy, bless, and glorious throughout the whole world. You have made everything and with you is the authority for everything. Everything is naked and open before your sight, and you see everything; and there is nothing which can hide itself from you. You see what Azaz'el has done; how he has taught all (forms of) oppression upon the earth. And they revealed eternal secrets which are performed in heaven (and which) man learned. (Moreover) Semyaz, to whom you have given power to rule over his companions, co-operating, they went in unto the daughters of the people on earth, and they lay together with them—with those women—and defiled themselves, and revealed to them every (kind of) sin. As for the women, they gave birth to giants to the degree that the whole

earth was filled with blood and oppression. And now behold, the Holy One will cry, and those who have died will bring their suit up to the gate of heaven. Their groaning has ascended (into heaven), but they could not get out from before the face of the oppression that is being wrought on earth. And you know everything (even) before it came to existence, and you see (this thing) (but) you do not tell us what is proper for us that we may do regarding it.

10 And then spoke the Most High, the Great and Holy One! And he sent Asuryal to the son of Lamech, (saying), "Tell him in my name, 'Hide yourself!' and reveal to him the end of what is coming; for the earth and everything will be destroyed. And the Deluge is about to come upon all the earth; and all that is in it will be destroyed. And now instruct him in order that he may flee, and his seed will be preserved for all generations." And secondly the Lord said to Raphael, "Bind Aza"el hand and foot (and) throw him into the darkness!" And he made a hole in the desert which was in Duda'el and cast him there; he threw on top of him rugged and sharp rocks. bAnd he covered his face in order that he may not see light, and in order that he may be sent into the fire on the great day of judgment. And give life to the earth which the angels have corrupted. And he will proclaim life for the earth: that he is giving life to her. And all the children of the people will not perish through all the secrets (of the angels)," which they taught to their sons. And the whole earth has been corrupted by Azaz'el's teaching of his (own) actions; and write upon him all sin. And to Gabriel the lord said, "Proceed against the bastards and the reprobates and against the children of adultery; and destroy the children of adultery and expel the children of the Watchers from among the people. And send them against one another (so that) they may be destroyed in the fight, for length of days have they not. They will beg you everything- for their fathers on behalf of themselves- because they hope to live an eternal life. (They hope) that each one of them will live a period of five hundred years." And to Michael God said, "Make known to Semyaz and the others who are with him, who fornicated with the women that they will die together with them in all their defilement. And when they and all their children have battled with each other, and when they have seen the destruction of their beloved ones, bind them for seventy generations underneath the rocks of the ground until the day of their judgment and and of their consummation, until the eternal judgment

is concluded. in those days they will lead them into the bottom of the fire-and in torment-in the prison (where) they will be locked up forever. And at the time when they will burn and die, those who collaborated with them will be bound together with them from henceforth unto the end of (all) generations. And destroy all the souls of pleasure and the children of the Watchers, for they have done injustice to man. Destroy injustice from the face of the earth. And every iniquitous deed will end, and the plant of righteousness and truth will appear forever and he will plant joy. And then all the righteous ones will escape; and become the living ones until they multiply and become tens of hundreds; and all the days of their youth and the years of their retirement they will complete in peace. And in those days the whole earth will be worked in righteousness, all of her planted with trees, and will find blessing. And they shall plant pleasant trees upon her-vines. And he who plants a vine upon her will produce wine for plentitude. and every seed that is sown on her, one measure will yield a thousand (measures) and one measure of olives will yield ten measures of presses of oil. And you cleanse the earth from all injustice, and from all defilement, and from all oppression, and from all sin, and from all iniquity which is being done on earth; remove them from the earth. And all the children of the people will become righteous, and nations shall worship and bless me; and they will all prostrate themselves to me. And the earth shall be cleansed from all pollution, and from all sin, and from all plague, and from all suffering; and it shall not happen again that I shall send (these) upon the earth from generation to generation and forever.

11 "And in those days I shall open the storerooms of blessing which are in the heavens, so they I shall send them down upon the earth, over the work and the toil of the children of man. And peace and truth shall become partners together in all the days of the world, and in all the generations of the world."

Quite an incredible story. Budd Hopkins is the leading researcher on human abductions. He has worked with many people that claim that they have been abducted by strange creatures and were made to helplessly watch as these creatures probed and prodded at their bodies. There have even been reports of insemination and a victim meeting with a child that she feels was her child, but was fathered by an alien. As the above story goes, could there have been genetic engineering as long as 6000 years ago? Seems quite suspect to me. If so, why? Are these creatures somehow tied to who we perceive to be God? Are they

the fallen angels associated with Lucifer, the one supreme angel that rebelled against God and was cast out of heaven by Michael, the famous Archangel? These beings, if they are capable of having sexual intercourse with earthlings, must have a physical body. Could there exist out in the vast expanse of universe, a whole world devoted to the creatures spoken of in the Bible? Perhaps, they had been appointed as Watchers over the human race and violated a sacred oath not to interfere with us, but to guide us in our maturation process externally and quietly. Again, one can only speculate about what they want with us.

There are many whom I am sure will disagree with this approach, however lest we totally deny our own existence, we must work with what knowledge we have. The ancient peoples of this world could not have had in mind to perpetuate a grand hoax such as the Bible, made it historically true and expected it to last as long as it has. I say that all things, in all parts of the world, have a commonalty to them. The commonalty is that they are all pieces of the big puzzle. Each piece fits intricately with the next piece and we should not be so quick to discount something such as this because it is based on religion. You see, religion and science all have their nature closely intertwined. For it was out of structured religion that we have made important discoveries about who we are and what our purpose is. There really cannot be one without the other. For if it is all true that we are the product of an external force that we call God, then science and religion will be forced to reconcile the separation of the marriage that has been valid all these years and has kept them apart.

For now, though, we must continue to work together to figure this puzzle out. We must remain open minded enough to explore all possibilities of this phenomenon and be ready to acknowledge that something is occurring even as this is being written that someday will expose itself to all nations and people.
