Government won't go public on UFOs

A phenomenon has existed on this Earth for uncounted years. It is the UFO phenomenon, and unlike the cultural fads which grow and eventually fade away, UFOs have remained as much a part of human existence as ever before. In fact, the numbers of UFO sightings are growing.

Since the times of Ezekiel as told in the Bible, people have been seeing strange, unidentifiable objects in the sky. The plains of Nazca in Peru remain a mystery even to this day. Before airplanes were even thought of those primitive peoples constructed "landing strip" type geometric designs shaped like spiders, birds and strange beings, all of which were only distinguishable from high in the air.

While most reported sightings of UFOs can be explained away as meteorites, stars, weather balloons, swamp gas, birds and satellites, a good number of sightings have even the most learned scholar stumped. For example, who on the face of this earth ever saw a bird travel at speeds faster than the speed of sound? Or an airplane able to make 90-degree turns with speeds in excess of 300 MPH? And what star in the entire universe ever landed on earth, left behind burned patches of grass, then took off vertically and disappeared into the sky?

It's amusing to think that the United States government (and other world governments) actually expects its citizens to believe that each and every UFO sighting can be explained away as a usual common occurrence (fast-flying

birds, incredibly agile airplanes or periodically visiting stars). How naive we have been to believe this!

Consider the JAL (Japan Airlines) encounter a year ago over Alaska. The pilot saw a UFO the size of two football stadiums. It also appeared on radar. The incident made a small appearance in local newspapers and even a spot on the evening news. Soon the reliability of the pilot was questioned and the public was led to believe that it was just a cloud that the experienced pilot saw. What is startling, is that the public believed the explanation, and thus both the public and the government were happy.

Readers must wonder why I mention the government so often. It is because the government has known about the existence of UFOs for many years now, and is not letting the people of the United States of America know the truth. Senator Barry Goldwater tried to obtain top secret information on UFOs from the Air Force but was denied access. President Carter wanted NASA to study UFOs. President Ford wanted investigations of UFOs since a wave of UFO sightings in 1966.

Why has nothing surfaced? It couldn't be because UFOs do not exist, for if they did not exist, then President Ford and President Carter's investigations would have been made public, and the UFO

nearly 100 UFO documents. The knowledge of the NSA's UFO documents was only possible through the FOIA (Freedom Of Information Act).

The FBI (Federal Bureau of Investigation) has been involved with UFOs since at least 1947, and CAUS (Citizens Against UFO Secrecy) a locally-based UFO research group, has been able to obtain approximately 1,700 pages of UFO files from the FBI only with the help of the FOIA.

The CIA (Central Intelligence Agency) has also been involved in UFOs since at least 1949. And, like all the others, denied having any UFO-related information until the UFO researcher's requests were accompanied by the FOIA.

But this is only the "tip of the iceberg."

Most of the released documents are vague generalizations. And when researchers pressed for more detailed information, the usual governmental agency response is that the requested information falls out of the reach of the FOIA due to "national security." But my question is, if UFOs pose "no threat to national security" as stated time and time again by the government, then how can the UFO documents be withheld from the public for "national security" reasons? Why would UFO-related documents be withheld if they (UFOs) pose no threat to our national security?

Furthermore, a good percentage of the released documents are blacked out with a magic marker, making it quite impossible to read.

I have obtained a good part of this information from a book en-

titled *Clear Intent* by authors Lawrence Fawcett and Barry J. Greenwood. In their book they state, "Foreign governments, just as the U.S., have said publicly that UFOs are a nonsense subject. Yet, they broadcast UFO data over their most important intelligence channels such that the NSA intercepts the broadcasts and retains the information under top security!"

And, "Since the government has declared many times that UFOs are no threat to national security, we feel fully justified in asking that data about UFOs be released and put out before the public for a fair and open-minded assessment of what is one of the most intriguing topics in recorded history."

I urge readers to write to their congressman/congresswoman. Tell them to "support the free-flow of public information, particularly UFOs" as suggested by the authors of *Clear Intent*.

I also challenge any member of government to disprove the existence of UFOs based on the information now in the possession of UFO researchers. I do not believe that people will "panic" when the truth is finally told, so I cannot accept that theory as the one which explains the government cover-up.

I believe people are intelligent and mature enough to realize that we humans are not the only intelligent species in God's great, infinite universe.

LOST IN TIME

He Hardly Believes It Himself

GREENSBORO
ONE SEPTEMBER night in 1968, when David Oldham was 16, he and two other boys were riding around about 8 o'clock killing time.

For some reason, he says, the boy who was driving, Ned, turned onto an isolated road in Guilford

Courthouse National Military Park. As soon as he turned off, he adds, the boys saw a huge light "sitting right on the trees."

"It was as though you could just climb up on the trees and reach and touch it with your hand. It felt that close.

"The set of circumstances at that point froze. Everything was put into a suspended state, and we just sat in the car and observed. And then one of the comments came up out of the car — I don't know who said it, whether it was me or one of the other guys — they said, 'Let's get the hell out of here.' And then we said, 'God, that's a UFO.'"

They drove on to a nightclub outside of Greensboro but did not talk to one another about what they had seen. At the door, they asked what time it was. It was 10:35.

That is when they realized, Oldham says, that they were missing 2½ hours of their evening. What had happened when they saw the UFO?

He says that he eventually found out what happened during the missing 2½ hours.

"It's so far-fetched that even I can't believe it."

SIMILAR REPORTS THAT are surfacing all over the country seem to have in common a mysterious gap in time.

Oldham has serene, bright blue eyes and a salt-and-pepper beard. He seems to be a gentle person and describes himself as a man who is not afraid

to show his emotions. Outdoors, he appears to love the earth and enjoys the sighting of forest animals.

AS HE WALKED the grounds of the park where he says the event took place, and with his terror showing through at times, he told the Journal his hair-raising story:

He did not give the UFO event much thought until nine years after it occurred. He was in an automobile accident, almost died and was in the hospital for quite a while, he says.

Then he started having nightmares. He began a spiritual search and also began to study UFOs and investigate reported sightings.

Once on a visit to New York, he looked up Ted

Bloecher, a well-known UFO expert. They talked about the subject, and Oldham eventually told Bloecher his story. Bloecher arranged for him to see a psychologist for hypnotic regression.

Oldham had tried hypnosis with a therapist in Guilford County, he says, but would always reach a point in the recollections at which he would cry. He could never get past that point.

Dr. Aphrodite Clamar, the psychologist in New York, induced hypnosis, and Oldham had a breakthrough, he says. The information that emerged was terrifying.

He recalled the events that he feels happened to him during the lost 2½ hours:

He found himself outside the car in the park but does not remember getting out of the car.

"All of a sudden, out of the distance, I see a shadow of a person, and, naturally, I freak out." When he turned to get back into the car, he could not move. A human-like being approached him. The sight of it terrified the living daylights out of Oldham.

"You turn the corner, and immediately you're under the control of something. . . . The being — he came at me without me being able to move.

"He looked me in the eye, and I was freaked. I didn't know what to do, and he, through telepathy, told me to close my eyes and relax, that I was frightened and that there were other people that wanted to see me."

David Oldham stands in his yard in Greensboro next to what is left of a tree that was splintered unexplainably several years ago.

Oldham was taken — he does not remember by what means — aboard a craft. He remembers lying on a table in a cylindrical chamber, surrounded by smoke, and having difficulty breathing.

The light in the room was like light in a movie theater, he says, where you see the light but cannot determine its source.

A group of beings stood over him as an instrument passed over his body. The instrument did not touch him, he says, but might have been shining a light on him. It was like being X-rayed.

The beings took him off the table and moved him to another room, but they did not carry him, and he did not walk.

"There's no way, physically and verbally, that I can tell you how it feels to levitate."

Dear Mr. Jones:

I have had an opportunity to examine the photographs and documents concerning the Mexican UFO incident on July 7, 1948. The photographs, of course, allow but a limited evaluation of the body's authenticity and/or origin. There seems to be a good correspondence between the appearance of the specimen in the photographs and the descriptions by the eyewitness. Therefore, I will address his comments which provide far greater details than are readily observable on the photographs.

From the descriptions it is obvious that we are hardly dealing with an organism indigenous to the earth. No known man-like or ape-like creature of adult age would have such a large head size:body size ratio. The absence of lips, tongue, teeth, thumbs, toes, ears, nose, genitals and hair rules out an identity with known forms or classifications of life on earth. In sum, a specimen with those characteristics gives no appearance of a natural, earthly origin.

Let me briefly consider the possibility of an extra-terrestrial origin. Considering only the specimen itself and not the radar sighting or the remains of the craft, I would have some doubts about the specimen's origin as outside of the earth. As a scientist and evolutionist I would basically subscribe to the darwinian view that now existing species have descended from previously existing species. Also, I subscribe to the view that evolution has been, essentially, an unfolding process whereby species gradually transform in directions partly determined by (1) their previous shape and size and by (2) mutations which are altogether unpredictable. In short, the history of life on the planet has been a unique and unrepeatable accumulation of events. Therefore, it is highly unlikely that an organism of non-earthly origins would so closely though admittedly only superficially resemble something earth-like. For example, creatures capable of inter-planetary travel should not be expected to have two arms, two legs, round heads, and holes for both nostrils and ears. They, moreover, should not be expected to have arm and leg joints in positions similar to ours. I would expect some visitor from elsewhere in the universe to look literally like something from out of this world. If it is from out of this world, then perhaps some extra-terrestrial civilization has fashioned a somewhat crude, man-like robot to communicate with and relate to us. Still, I am bothered by the fact that it resembles too closely an earth creature if, allegedly, it had originated elsewhere in the universe.

In conclusion, I realize that at one point I have indicated that it is not a known creature from the earth. Then I have argued against that it is of extra-terrestrial origin. From these seemingly conflicting statements you can see that I am puzzled as to the origins of the specimen. I am sorry that I cannot provide you with a definite or positive identification. I hope that this report is of some value to you in your work. Keep me posted of your progress.

Got your letter and enclosures today re Walker, Sarbacher, Friedman and Steinman, etc and will answer immediately before I tackle my backlog of other mail. Appreciate trust in me with this confidential material and, of course, will not disclose any of it to anybody. Such information as yours helps me assess MJ-12, Aztec-Roswell, etc easier, even though it's still early to make any conclusions. Walker is, indeed, a key informant and I hope he can come through with more details with Steinman before he shuts up or, ~~is~~ is shut up.

Coincidentally, last week I received a letter from Stevens, in response to mine concerning Steinman's "inside" sources, and he ^{also} told me about Dr. Walker being a key source. He also asked me to keep his name confidential, so now I feel better. But your material goes deeper, involving Friedman, but I plan to make no "noise" in this sensitive area.

Other items of interest:

Received word from French source with good connections that he witnessed uncut version of NASA movie showing 6 UFOs descending to area on the moon. Taken by astronaut Borman on Apollo 8 mission. A few weeks later I got word from US airlines pilot who knows a pilot who is friend of Borman's with similar info. I have long heard of these rumors, but now I have direct sources.

No new word from from police officer in New Mexico who knows aging man who witnessed an object being hauled away from Aztec on flatbed truck, etc. Called four times for more info but officer claims he's been too busy for follow up. This is important to me as we need all we can get to substantiate the Aztec case. I'm sure that Bill Moore will try to shoot down this case and Steinman's book when he ^{can} ~~can~~ _{down}

disentangle himself from the MJ-12 mess he created. Moore's role seems curious at times making one pause and wonder if he's a double agent. "flying saucers" are right up there with little green men and pink elephants on the believability scale. And we're encouraged in that regard by our government.

Why? Opinions vary. Some feel that the bureaucrats are simply reflecting the results of good, scientific investigation, and that written reports alone do not an alien make ... to which observers might counter that there are more upstanding citizens living who've seen space men than those who've seen, say, George Washington.

Others, presumably in positions to know, see federal reticence in quite a different light. According to those

individuals, the administrators who roam Washington's halls are engaged in a cover-up that would make Watergate look like child's play. The sources point to nearly a half-century of what they claim is official chicanery elevated to new and lofty heights. The government, they say, not only knows about space vehicles and aliens, but has at least one of each.

Fragments of facts emerge indicating that their suspicions may not be so far fetched.

Those associated with the government's UFO-related activities retire, or leave governmental service, or become disenchanting with what they perceive to be, at least, unnecessary bureaucratic shepherding.

Secrecy oaths, combined with the prospect of time in jail and \$10,000 fines, do an effective job of stemming single-source "whole story" leaks, but bits and pieces do come forth.

One example of a carrier of such information is "Tom," a pseudonym for a sincere, fully patriotic, yet disaffected former military analyst who endorses his government's aims, but not the methods for achieving them.

The final objective, he states, is to enjoin panic. The government numbers among its responsibilities the protection of its citizens. Though all encounters with our space visitors to date have been benign in nature, they have shown their technology, and quite probably their intelligence, to be so vastly superior to ours that should their objectives ever shift from observation to conquest, we would be virtually defenseless. Thinking its citizenry incapable of dealing with this circumstance, Tom feels, the government's response has been to stick its head in the celestial sand.

Tom disagrees with this approach. He, too, thinks that chaos could result

from the sudden popular realization that there are other, and bigger, fish in the pond. But the government's non-response does nothing to bring its charges closer to being able to live with that fact. Tom would propose a metered release of information, a gradual heightening of UFO awareness so that when, and if, outsiders chose to make themselves widely known, the discovery would not prostrate a globe of humanoids.

If sources of like disposition are as qualified to offer opinions as Tom, he may yet see his approach adopted.

Holder of a security clearance above that of the president himself, Tom was asked to analyze the 624-page Grudge Report 13, the last of the series before the Air Force's UFO Project Grudge became Project Blue Book in the early 1950s, whose existence the service has consistently denied.

In the early 50s, of some 1500 sightings investigated to that date, nearly one-third were officially designated as "unknown," and only about 25 percent of the "knowns" were factually verified as ground-based aircraft or other man-made phenomena.

In this report, Tom indicates, the Air Force revealed the actual findings of its investigations. They didn't square with public pronouncements.

(c) Frequent instances of broken legs, as if the animal had been dropped

(d) A total absence of blood, within or around the animal

(e) A complete rejection of the carcass by predators, scavengers and maggots alike

(f) No rigor mortis, even after several days

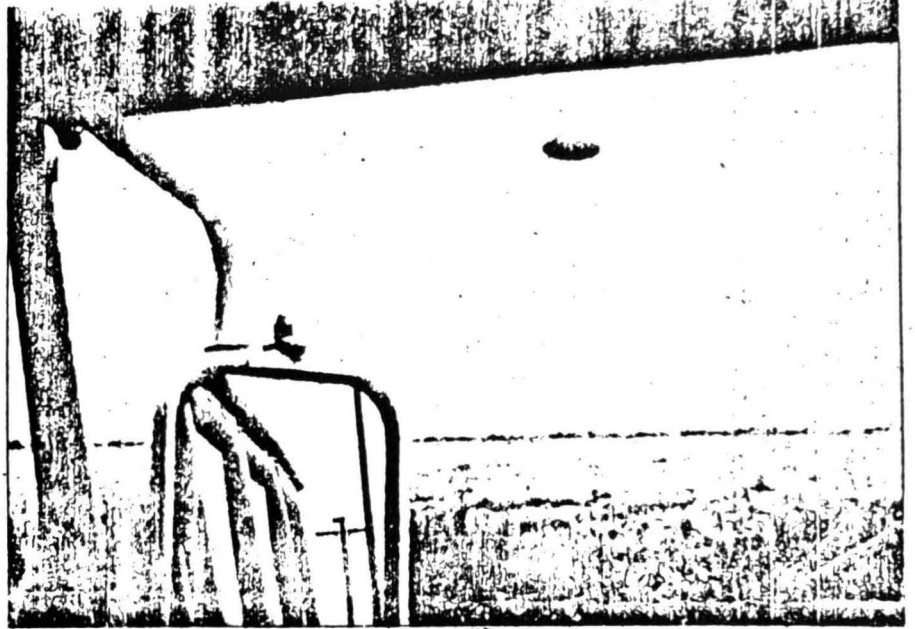
—A composite of the physiology of the space traveler, reflected in the cover illustration and verified by at least one physician who had performed autopsies on alien corpses.

—The existence of approximately 30 such corpses at Wright Patterson and/or Langley air bases.

—The refusal by Wright-Patterson brass to permit Senator Barry Goldwater to view their UFO research facilities.

True? There is photographic evidence for some of it, qualified-witness testimony for the rest.

So what? So, say Tom, APRO and others, the time has come for government to stop patronizing those who authorize its existence, and reveal to them what they have paid it to find out.



Regarding your inquiring letter re "Major," cited in Case A4 in my Status Report II, I hasten to say that he is not reachable at this time and, in my last chat with him by phone (while visiting relatives in Cincinnati) he was not disposed to discuss the subject of UFOs. He said he might call when he returned to Cincinnati, but I doubt it.

Retired as a Colonel, he said that he knew that I was "monitored", admitted that he was aware of MJ-12 but would not comment on any of my questions on past or current issues. Years ago when I talked with him re retrieved craft and bodies he seemed to be more open on the subject, however, he did not say much about the meeting at Wright-Fat. I believe that he had been advised since that time to clam up. About five years ago, when he lived in Cincinnati, I tried to reach him on a C/R matter, but he never responded to my calls. His wife invariably answered the phone. I gave up.

Such behavior is typical of all my informants. Out of 29 firsthand sources over the years not one is currently available. Most became unreachable shortly after our initial communication. Even my source in Status Report IV, re Ft. Dix-McGuire case, left the States 17 months ago for overseas employment. Perhaps, safer there.

In past six weeks a new source surfaced to relate some C/R information and promised to return for more confidential exchanges. Then, silence. After a month, the source called briefly to relate that he was advised to shut up.

I do know from others that a clampdown on security is in effect since January in deference to high-level meetings on the UFO problem.

Glad to hear you're working closely with Grsnt for whom I have the greatest respect.

Appreciate your informative letter re Ceytes case and attempts to get additional information re Wilbert Smith from the Dept of External Affairs. I hope your efforts are productive, as things seem to be heating up on the UFO scene since Moore released the controversial MS-12 documents. Much is to be said for the criticism of Fawcett & Greenwood in JUST CAUSE and, by Moseley in Saucer Swear who believe the papers are a hoax. But, it's a bit too early to make any conclusions. Some believe that Moore is behind the hoax to build up his Roswell case or for other more sinister reasons. Double agent? - But, I believe if the MS-12 papers are a hoax, then Moore was duped - and this will seriously hurt UFO research credibility. And, like you say, if MS-12 is for real then the Ceytes case can be questioned. Time may tell or will it?

In this pot pourri, the mysterious Steiman source re Ceytes may play an important role if and when ~~the~~ challenged by research or by Moore.

I find it difficult to believe that Steinman has not shared his key source with me. Certainly he should know that I have always kept my trust with confidential sources and that he will need my support in the long run. But Steinman behaves in strange ways.

It was also hard for me to believe the way he handled the Sebacher disclosures. After he got the name in my Status Report III, I referred him to the address of my source and then, silence. Once he got responses from Sebacher he chose to give it to Moore, Moseley & others and ignored me. Had I known of his successes I could have helped him in many ways. But Dad's water under the bridge and he knows he made a major goof in sharing it with the wrong people.

apart from Moore & Steinman, I was ^{recently} led to an independent source who allegedly served in MI-12. Making contact, I was unable to get admission, of course, but the individual was, indeed, well-informed on UFO matters.

also, I'm working on another source, ~~who~~ a police officer in New Mexico who knows of two people who recall the Aylee incident.

One is a gentleman in mid-80's, who related to the officer several years ago that he saw the flat bed truck hauling something, under protective cover, away from the crash site and was told that he would be prosecuted if he talked about it. The police officer promised he would try to trace down the source and get a statement for me. Perhaps the source is dead by now, but the officer's word is good testimony.

Good luck in your quest with the RCMP, and again, thanks for sharing info and your thoughts with me. Be assured you can trust me with any sensitive material. Nothing will be published without your permission.
