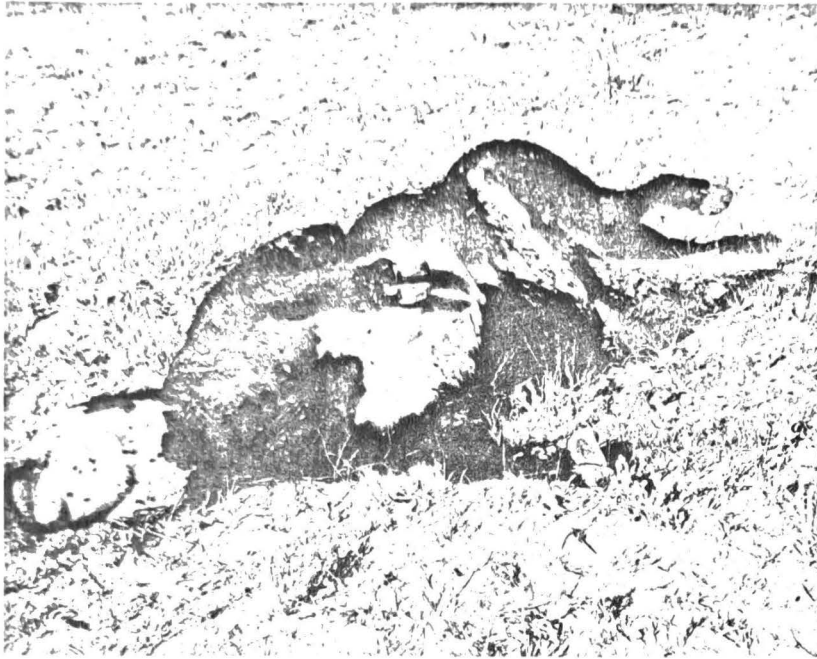

CATTLE MUTILATION:

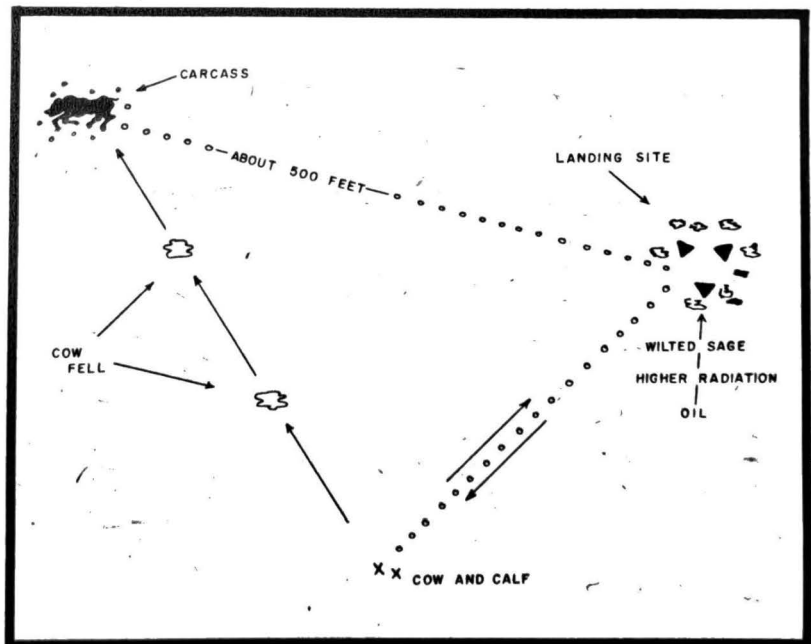

Witchcraft Rituals or Space Invasion?



The cattle seemed to have been butchered in a ritual manner. This photo was taken several days after the discovery. The evidence shows that it is not the work of scavenger animals.

After examining the site, evidence was found which pointed to some sort of strange machine which had landed not far from the mutilated animals. 4 inch pod prints were found in soil.



What kind of cattle rustler flies around in a tripod-type landing craft and rides a pogo stick that covers exactly 28 inches to the bounce? It may sound like a small child's riddle, but it is serious business—for each time one of these dry-gulchers drops in from the sky, it's the last roundup for some unfortunate animal.

A bizarre form of cattle rustling has been happening all through the western countryside and rural areas of the Midwest. In fact, stories are so bizarre that there are implications the acts are being committed by visitors from space.

If all the cases were reported, the total number would probably be more than 2,000 animals destroyed or missing. The property loss for this type of operation may have passed the million dollar mark. It is time that officials and law officers admit that we have a full-scale operation in progress, which often appears to be associated with space vehicles.

One such incident happened at Dulce, New Mexico; it left the investigating team puzzled completely and not a little apprehensive. The investigation of this weird event has given us more good measurements, more hard data, and more unusual pictures than any other in our almost 30 years of UFO chasing. But firm evidence is not always pleasant. It can leave you with the uncomfortable feeling that you almost met the visitors but you completely missed the party.

When the data is a bit hazy, it is always possible to let your imagination fill in the gaps. It is also easy for investigators to generate excuses. This was not the case in the high mountain meadow of northern New Mexico in mid-June of 1976.

Perhaps extraterrestrial visitors were not involved in this strange happening. The reader can judge from the facts as we found and recorded them on film and paper. Maybe the whole thing was just a hoax or the work of a twisted mind. But in any case, it required

skill and resources far above those available to the average human being.

It began like hundreds of other cattle mutilation stories that seldom make the news, but this time new and exciting evidence spotted by an alert State Police officer opened up what may become one of the best-documented events of the year.

Manuel Gomez is a rancher who also operates a small store in the village of Dulce. He keeps his cattle in a fenced and locked 5,000-acre area about ten miles out of town. On a routine weekly inspection, he found the body of one of his cows on which a precision surgical job appeared to be in progress. In the classic mutilation case, the pattern is to remove the rectum area, udder if a cow, tongue, lips, left ear, and all of the blood. Sometimes the heart is also removed. Manuel's arrival was well timed, when he reached the animal, some of the above mentioned parts were still with the body. Although it was more than a mile inside the nearest fence, there was no human, vehicle, or horse tracks inside the pasture. But near the body were the prints of what appeared to be something walking on suction cups or pods four inches in diameter.

Gomez left the scene immediately and went back to town to notify Officer Valdez of the New Mexico State Police. When the two men returned to the pasture area, it was soon evident that the unknown visitors had come back while Gomez was away to complete their interrupted surgical work. All of the preferred items were now missing. *Over* the tire tracks left by Gomez on his first trip were more fresh pod prints. There was no blood left in the animal, and none had been spilled around it.

State Police Officer Valdez, known to his friends as Gabe, is a very perceptive investigator with an open and inquiring mind. As evidence of his technical and

mechanical skills, Gabe is a pit assistant to his good friend Bobby Unser, the famed two-time Indianapolis 500 winner. Gabe's curiosity was caught by the round pod prints. They wandered around the animal as if whatever had performed the surgery was walking on inverted suction cups four inches in diameter and about one inch deep.

On further searching, he found a line of the weird prints leading up a small hill. When they traveled any distance the prints were in a straight line spaced 28 inches apart. They did not have the human type of left, right walking. About 500 feet up the slope the trail ended at what appeared to be the landing site of a tripod-type vehicle. The vehicle seemed to have stood on three legs with each leg resting on a triangular base pad or foot, measuring about thirteen inches on each side. Three base pads or feet were spaced six feet apart to form a triangle. The miniature sage and chamiso bushes were wilting and dying around each pad print. A dark, oily substance was found near the prints.

At this point in the investigation we were contracted to do radiation and other measurements. As we investigated further we found several lines of prints, all leading to a single point at the landing site. Perhaps it was the side of the craft where a door was located.

No soil compression test equipment was taken to the remote location. However, a crude test print was made in the same soil. It left us with the feeling that if the pod prints had been made by something walking, it was perhaps of slighter build than an average human male. When the pod prints were in a line, they were slightly deeper on one side. This might indicate the direction of travel.

Investigation of the landing site suggested the possible use of a helicopter-type machine. However, aviation professionals, including a designer of helicopters,

and also U.S. Air Force officials, told us they knew of no chopper with tripod landing gear. Such an arrangement, they said, would lead to instability at the moment of take-off. If this is true, such a craft could not have operated on the sloping terrain of this landing site. It was interesting to note that flat ground was available nearby but was not used.

The track pattern as we mapped it, told a vivid story. We believe the action went like this; the craft set down about 300 feet from where the cow and her two-month-old calf were standing. A trail of pod marks led from the craft to the cow. At this point something happened. Perhaps the cow was given a shot of some chemical. She began to run. After about 150 feet she stumbled and fell, rolled over, got up and ran again.

After another 100 feet she fell again, struggled to her feet and made a final effort. Another 75 feet and she fell again. This was her "last roundup." It appeared that at this point the little pod prints returned to the craft, perhaps to pick up surgical tools and then came down the hill and closed in. The "blood suckers" proceeded to drain all the blood without wasting so much as a drop. They then began to remove the desired parts and during this step they probably heard the Gomez vehicle approaching up the long canyon. Work was temporarily suspended until Gomez came and left. The operation was then completed, and they departed with their specimens and the two-month-old calf.

Although the tracks on the ground gave a clear picture of what happened in this case, we are familiar with other cases that leave you with the feeling the surgery was completed on board a hovering craft and the carcass then lowered or dropped to the ground, or sometimes to water. In some instances this mode of

operation would explain the lack of all tracks and the cleanliness of the blood removal. It would explain bones that appeared to have been broken after the mutilation. It might also explain how animals known to be within a few feet of an occupied house at sunset were found in the same spot the next morning, but dead and mutilated—yet no one in the house had heard any struggle. Perhaps animals are less fortunate than the human contactees that are taken to the "examination room" on board.

At Dulce there was no doubt that the visitors left something wild animals could sense but we could not. Dead cattle in the mountains will attract scavengers of all types—coyotes, crows, the works. But for at least four days no animal or bird would come near the Dulce carcass. Only the flies. Cattle in a herd have a natural curiosity about the welfare of others in the group. Even when one member is dead, others of the herd will nuzzle and poke around as if trying to find out what is wrong. This is not true in the type of mutilation we are describing. The herd keeps its distance from the dead member. Another oddity is that the carcass in these cases seldom bloats as is so customary for cattle.

During our work at the scene, we casually asked one of the local young men if UFOs were ever seen in this part of the country. The answer was "No." But then one man added, "Several people in town saw a balloon flying along the top of the mountain range Sunday [the day of the killing] and going back on Monday." This gave us the lead we were looking for. Balloons usually do not operate in this manner in this remote area.

An official in the New Mexico balloon club ran a quick but thorough check and found that "no known balloons were in the region at those times." With a

little encouragement, local residents including Indians began to talk more freely.

Many had seen large round objects that would hover and then move rapidly. At night the objects had either red or amber lights that seemed to rotate. One member of the investigating team, who must remain anonymous for work reasons, returned to the site alone on the second day to get more measurements. As he approached the carcass, but was still quite a distance away, he saw a large black object gliding silently away at a high rate of speed. Moving just above the ground, it disappeared into the forest. This sounds very much like the Puerto Rican reports.

The radiation measurements that we made were inconclusive. Due to the chain of events and the distance to the remote mountainous area, it was more than 48 hours before we could get our equipment to the location. However, tests indicated that at the landing site the radiation level was about twice the background level measured in the surrounding area. Radiation experts in atomic research verify our feeling that the measured level has a better than 50% probability of being meaningful.

Part of our mission was to document the investigation on film. During the process we recorded the landing site, pod marks, the dead animal and other items. However, the two most unusual pictures were none of these. These two were intended to be only landscapes of the area, for the record.

We took two photos of the general overall area. The big surprise came when we saw the sky in these two exposures. What are the round things there? We did not see them when we shot the pictures. For those who are technically interested we will pass along the following information:

The two exposures were taken with our back to the sun. These exposures were nine frames apart on a twenty-exposure roll. The only place on the entire roll that such objects occur are in the sky in these two frames. Special care was used with this roll because the investigation was a one-time thing. Under the microscope the images show to be in the emulsion as part of the picture. They are not water or other such spots. When developed for the right contrast, they show a slight halo and one can be seen to be beyond the wispy clouds.

A professional photographer in Durango, Colorado, which is located about 50 airline miles northwest of Dulce, tells us that he recorded two similar objects in the sky over a large fire he was covering. The objects in his picture also were not visible as he took the picture.

When the pictures were shown to people in the Dulce area, they immediately agreed they were similar to the flying objects that they had seen. Although nothing was seen in the sky by any of the investigating team, two women in the group each remarked, "I keep feeling like something is watching us."

We give you the pictures; we make no claims or comments—except that the spots did not happen during the developing

There are two incidents connected with the investigation that we cannot explain. Perhaps they are only coincidence—maybe not. Samples of the oily substance were gathered and taken to the state crime lab for analysis. We waited over two months for test results. The answers could have been a breakthrough on UFO questions that have been with us for a long time. Then the test

results came. "The oily substance has disappeared from the test sample container while waiting for the test. We have nothing to test!"

And tissue samples were sent to the state medical lab for analysis (a different lab). The final report? "The tissue had been soaked in a special fluid to extract any unusual chemicals that might be in the tissue. After extended soaking, the lab technicians who were to make the tests on the fluid found that it was missing from the test container." No one knows how or where it went. Once again nothing to test!

While the Dulce event has given us a large file of hard data on some kind of peculiar visitors, it has actually told us more about humans, especially those in places of responsibility. We feel very fortunate to have been working with an officer like Gabe Valdez. Others were not so pleasant.

There were those such as the state police officer in Taos, New Mexico, who told us with authority that it was a well-established fact that there had never been an animal mutilation. Or there was Dr. McGinity of the University of Missouri Veterinary Department, who has looked at many such cases in that region. He very happily told us that *all* mutilations were just small-toothed animals, eating cows that had died a natural death. When we explained that we knew the Dulce case was different, he became very mean and escorted us from his office. He told us we were wasting his time and interfering with important work. These were not isolated cases; they became a familiar pattern.

Far too many people at decision-making levels refuse to admit anything that they cannot explain.

which make the unconscious conscious," maintains Fabricius. Around the age of 55-60 the unconscious returns again to the birth theme—going back even further this time, though, to relive conception and embryonic life in the womb.

Fabricius sees a whole host of unconscious manifestations in art and everyday life. In the Norwegian expressionist painter Edvard Munch's famous painting "The Cry," he sees an obvious expression of primordial birth angst, with the fjord in the background representing the vagina, and the howling white embryo-like head in the foreground going through the painful process of birth—entry into life. Fabricius sees unconscious symbolism also in Grimm's "Little Red Riding Hood" fairy tale, where the wolf swallows Granny and Red Riding Hood takes on the proportions of a pregnant woman. When the hunter appears later

and cuts open the wolf, a birth—or rebirth—takes place. Here a vital place in the individuation process has been completed. Similarly birth or rebirth angst is seen in popular cartoon strips, where monsters and dragons with terrifying massive gaping jaws abound. The huge popularity of the film *Jaws* Fabricius also puts down to our unconscious birth anxiety, with the indented jaws representing the vagina and the horrors of birth.

In the United States, Dr. Arthur Janov and other Primal Therapists have been guiding patients to re-experience their early traumas. It has been found that many people do find themselves reliving their own birth at some point during the therapy.

Numerous other psychologists have been doing research that tends to support these findings. Buried memories of our birth may be our most important key to self-knowledge. □

In a recent issue of a science publication, a writer stated his firm conviction: "If you see a phenomenon, you can explain it on the basis of what you already know. If you cannot explain it, you did not see it."

At this point we will not hazard a guess as to why certain parts of the cow are preferred. Perhaps "something" has a different way of getting some of the same information that we are trying to extract from our Mars lander. It has been suggested that certain of the items removed from the animal are done so only to mislead investigators and create false assumptions by those who are eager to dismiss the whole thing.

Although this incident has not given us the answer yet, it has left us with more firm information than any that I have been privileged to see.

* It was possible to measure

and map the whole space and time sequence of events.

* We know definitely that the parts were removed surgically, and we know which parts were taken.

* We know the time of day that it happened.

* The "footprints" were measured, photographed and roughly checked for pressure.

* The landing area was measured, photographed and checked for radiation.

* The reaction of other animals was visible and noted.

* Peculiar flying objects were seen nearby on the day and night that it happened.

* We know that a two-month-old calf disappeared.

* No human signs (cigarette butts, gum wrappers, matches, Kleenex, Coke cans, or tracks) were visible within miles.

* Over a dozen people, in-

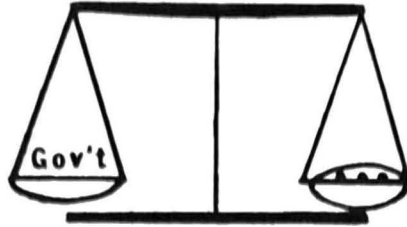
cluding State and Indian officials, saw and verified the facts.

Yes, we just missed the party and we didn't get to see the visitors, but we did get there in time to have a very good look at the unique litter they left.

As Sergeant Bell of the Sheriff's office in Colorado Springs told me, "We would like to think this particular kind of incident is being done by humans, but a Colorado cattleman's association has had an \$18,000 reward offer for more than a year. That's a lot of bounty money. Most people who would do this kind of a thing would also sell their own brother for less. There have been no takers."

Perhaps Sheriff Graves of Logan County, Colorado, has the right answer. He is another officer who is eager to solve the problem, and he jokingly said there's no real problem; it's just "Bionic Coyotes!" □

Bryant v. Justice: Another Step Toward Revealing the "Ultimate Secret"

Saying "this action might help us either to authenticate or to discount the story behind the famous F.B.I. memo of March 22, 1950, recounting how 'An investigator for the Air Forces stated that three so-called flying saucers had been recovered in New Mexico,'" CAUS official Larry W. Bryant filed a Freedom-of-Information-Act lawsuit June 1, 1988, in U. S. District Court for the District of Columbia.

"This latest legal action," Bryant continued, "seeks to compel the Justice Department to disclose the memo's entire contents." The memo, which the Federal Bureau of Investigation released some years ago in response to a routine FOIA request for all UFO-related records in F.B.I. possession, has the principals' identities censored, ostensibly to protect their privacy and/or confidentiality. "Those persons probably are no longer alive, and the dead have no privacy. Anyway, the public's right to know the details about such a momentous event as crashed saucers and their retrieved occupants transcends the government's desire to shield agents, witnesses, and informants from public exposure," Bryant said.

He expects it will take months for the court to render a decision on his complaint, which, because of limited legal-action funds, had to be filed without the services of an attorney.

Meantime, Bryant views this suit as a prelude to what he calls the "Ultimate FOIA Lawsuit": to gain access to all records pertaining to contact between independent TV-documentary producer Linda Moulton Howe and former USAF special-investigations agent Richard C. Doty -- said records reportedly containing formal evidence of the government's coverup of hard-core UFO data, including presidential briefing papers and film footage on the reality of retrieved UFO wreckage and alien crew members.

"For that suit we truly do need an attorney, and we welcome citizens' contributions toward retaining one," Bryant said.

NOTE: The F.B.I.-released version of the memo is reproduced on the reverse side of this press release. Does the document pertain to a hoax; or does it, like the F.B.I. memo of July 10, 1947 (in which J. Edgar Hoover notes, "For instance, in the La. case the Army grabbed it and would not let us have it for cursory examination."), refer to an actual UFO-retrieval operation and subsequent coverup?

I questioned Howe about the NSC Nov 21, 1981 letter from Major General Schweitzer to Major Von Keviczky. She said she had very heard of this but if sent the documents, she had three sources who would know. One was Bruce Maccabee, from the fund for UFO Research. She will contact me with results.

I questioned her on the statement apparently made by the President to ~~William~~^{Spielberg}. She stated this story has floated around for years. She had attempted to interview Spielberg, but was unsuccessful. At one point there was a denial but I don't remember who she said denied it. Synek never mentioned the story to her.

I questioned her as to whether anyone had more info on the Bush statement. She stated there was no news. She was not even sure which state it happened in.

Because of the various reports hinting at NASA involvement in the technology end of this UFO mystery, particularly metals, I asked Howe how NASA ties in.

She stated in 83 she had been told NASA was a "joint agency" because of the numbers of scientists and labs to analyze things. Carter, she said, had tried to re-direct the focus for UFO sightings to NASA, but those who are aware know NS-12 uses many agencies, including coastal geodetic survey, and NARPA.

I asked her why Col. Ernie Edwards was so open to researchers. She stated he is a "very nice man." He is friends with Richard Doty, friends with Dr. Pennington, friends with Jerry Miller (1980 aqueous cable)

During the 1980 Kirkland AFB affair he was chief of security. Now, she stated, he has been promoted and is one of the "top dogs" at Kirkland. Because of his security background.

Diary for the Record: Telephone conversation with Linda Howe
June 8, PE 2:00 AM. (30 minutes)

Linda phoned me to state she had gotten a call from Lucy Fenwick in Toronto inquiring about my statement in a letter that we had received a letter from "the old man." I had promised to keep Fenwick up to date, but stated we would still not release the name.

Fenwick asked Howe if she knew of this letter etc. Howe declined to talk as I had sent her a brief note asking her to keep our earlier letters and conversations confidential for the time being.

I briefed Howe on the letter and all developments since our last conversation. She agreed with our position and expressed a distrust of Friedman, Clark and especially Moore.

She described a disagreement with Clark over a recently published tongue-in-cheek article written about cattle mutilations.

On connection with Moore, I asked her if she could clear up the story about Moore quitting. She repeated exactly the story as outlined in Lear's letter to Schulz, adding that Moore stated he was going to work on M.I.A.s.

I stated that Friedman had denied the statement, putting it down as one of the garbage rumors.

"It happened about three months back," Howe stated. "Moore had lunch with Lee Graham and told him this." Graham related the story to Howe, and Howe related it to Lear.

Howe stated she spends a lot of time with Lear, and is in close contact with Stringfield.

I asked in this connection whether or not Lear had

managed to see Dulce and the suicidal flying saucer. She stated that he had not gotten there yet. "He is planning to fly over the area first with a helicopter."

Valdez however did get into the area but he and one other person found only rocks and rattlesnakes. "That however is all that has been related to as so far."

I mentioned that I had just received a four month old new letter from Moore with the Doty denial. Howe stated;

• Just Cause will be publishing a second (~~letter~~ which updates Moore's letter) Doty denial sent to Greenwood which states ~~that~~ basically the same thing except that it mentions the Carter briefing papers. "Doty can't even keep straight what he told everyone," Howe stated. "I didn't even discuss Carter with him."

• She stated she had gotten many calls from across the USA and Britain defending her story over Doty's.

• In a conversation with Ernie Edwards, head of security at Kirkland AFB, Doty had gotten into some trouble and was now a cook in the WCO "if you can believe that"

• She maintained everything she had formally claimed. "Once shown Presidential briefing papers, we discussed a captured alien at Los Alamos" etc. She added she had sent a not statement to Just Cause outlining her position. She had also provided Greenwood with all the HBO - Doty AFOSI correspondence. She did not tape any calls. "that's not my nature"

• Her conclusion was "I finally have come to accept

that when these people put out a denial or statement they actually believe people will believe it."

She asked me if I had heard ~~ask~~ about the change in the name of MS-12 to PJ40. I told her I had just gotten an article which mentions PJ40, detailing the story of the member of the British parliament who apparently released the documents to reporters in London. She stated she had not heard of this British connection, but maybe this was Stringfield's source.

I stated I would provide her a copy of the article. We both agreed the name now known to researchers would be changed again by now.

She stated ABC had a film of a military source outlining the inside story, and that it would be released by year end. Howe added she doubted Bush would allow this to happen because of the election. (I am assuming this is the Shandera rumor of a month back)

I asked her if she had heard of the Bush statement. Howe quoted what I had heard, and asked if anyone had tracked it down. I stated T. Scott Crane was looking for the State director and that we definitely would follow up on it.

Howe stated she was sending me a pile of material outlining her position for my comments. She also expressed an interest to republish W.B. Smith's "The New Science" and asked if I could find out about who has the rights. I told her Mrs. Smith did and I would approach her on the issue.

"... one of the most readily understandable examples is human control of the entire life cycle of the earth's cattle. In a way, we do our best to keep those cattle in a cattle-like state; we may attempt to improve breeds of cattle or their yields, but we never attempt to assist cattle to evolve *upwards*. We never teach them more than we need to get them to obey *our* needs. We provide them with food or maintain places in which they can do their own foraging. We keep them healthy and sheltered in bad weather. In short, we provide them with more "luxuries" than they might otherwise encounter in the wild state.

"One can understand, then, that over the centuries and millenia, cattle have become hypnotized to a certain extent. They understand that as things go, they are well off. They tolerate the strange, two-legged beings who make so many different sounds and who possess such bewildering technological equipment — for such beings are the ones who provide them with so many comforts and such ample meals. Right up to the end, they have no reason to suspect the treachery that suddenly awaits them as they huddle in the cramped pens of the slaughterhouse.

"Extrapolating toward the macro-cosmic, it is quite possible — perhaps



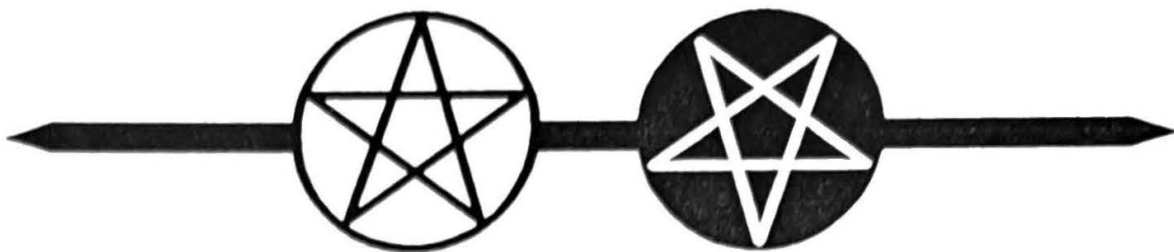
inevitable — that the entire human life cycle is subordinated to the needs of an unperceived macrospecies. ... We may fill some emotional or psycholo-

gical need, maybe as pets or someone's ant farm. We may be a planet-sized laboratory colony, in which our behavior and reactions to various stimuli are being studied. We could be a proving ground for biological or medical experiments, in much the way we breed and maintain mice so that we can test the effects of chemicals or drugs before endangering ourselves by using them. In any case, we are kept 'human.'

"Whether its intentions are 'good' or 'evil' (as imperfectly as we understand those terms) is irrelevant for now, just as it is irrelevant to question human motives for controlling various other life forms. We *need* them under present circumstances. It is likely the same for the species/universe which exercises control over humanity."

I do know that bizarre animal mutilations have happened and continue to happen. I do know that hundreds of people are claiming encounters with craft and alien beings. But the who, why and what-for behind it all — without proof — are still rumor, hypothesis, science fiction. With proof, we might be facing a story that challenges our future as a species. □

Satanic cults are careful about calling attention to themselves. Law enforcement officials and others have come upon physical evidence of their activities, however. The most commonly found evidence is mutilated animals, ritual sites, and robbed graves.

The Animals

During the 1970s, the midwest was hit by an epidemic of animal mutilations. States were reporting incidents by the hundreds, and the news media were teeming with stories. Usually the victims were dairy cows, but horses and beef cattle were also found dismembered. The theories flew; everything from UFOs to natural predators such as wolves, to pranksters doing it just to drive the local sheriff crazy. Part of the mystery was that in many cases footprints of the perpetrators were never found. In other cases, the animals were found miles from where they belonged.

In retrospect, some things are clear. The animals were killed and mutilated in a deliberate and skillful manner. Judging by what was done to the animals—what body parts were taken, the fact that blood was drained—Satanic cults may have played a role.

Although it rarely makes the news anymore, mutilations continue today in all areas of the country.

CAPT. DALE GRIFFIS: I get a lot of calls about animal mutilations, probably because I'm in the midwest. There was a time when it seemed that it was going on all over the midwest. I got one call from a farmer in Indiana, not too far from Elkhart. He lost five head of cattle; someone had gone in and cut the vaginas out. He had one cow left, and he was going to sit up all night with a shotgun. He was going to get those bastards.

Why would someone cut out the sex organs? In Satanic religion, the sex organs are supposed to contain power. Satanism is a religion based on hedonism and the belief that the release of sexual energy is one way for you to reach a higher consciousness. You want anything that can add power to your rituals. By taking the sexual organs of an animal, you have some of that energy for your use.

I talked to the law enforcement people involved, told them what to look for, and they went back and started to look for Satanic paraphernalia at the scene. They were able to build up indicators that there was a traditional occult group in the area. As it turned out, the animal mutilations occurred a couple of days before an occult holiday.

From some of the people I've talked to, and autopsy reports that I've seen of animals that appear to have been used for rituals, occultists will stun the animal on his back with an electric probe. Then they will spray freon on the animal's throat. The animal is living, but he's not living, if you know what I mean. The heart's still pumping, and they will use an embalming tool to get the blood out. It's fast and efficient. Hell, the farmer heard the animal whine, and he was there within five minutes.

I still get calls all the time. It's become almost an everyday thing. I can't say that every call I get about an animal mutilation is Satanic in nature—most incidents remain unsolved or I don't hear back from the people I've consulted—but the

Subject: Animal Mutilations

On 8-14-79 Sheriff Gus Anglin (Van Buren Co.) Arkansas, chief investigator, Jerry Bradley (Faulkner Co.), Sgt. King (ASP), and this officer interviewed a 23-year-old W/F whose identity must be kept confidential in reference to the recent cattle mutilations in this area. The young lady related the following story to us.

That for five years she was a higher echelon member of a Satanic worshipping cult which was headquartered in Tulsa, Oklahoma. During her five years there she was involved numerous times in trips to outlying remote areas where cattle were killed and the blood drawn out by use of an old embalming machine, which they had converted to battery power. They also removed the cow's eyes, tongue, sex organs and sometimes the udder.

She related the cult she belonged to was quite wealthy and had a helicopter and several van type trucks which were used in obtaining the organs and blood needed from the cows to be used in their rituals. She also stated that doctors, lawyers, veterinarians and other prominent persons belonged to this cult and were all taught by doctors and vets how to precisely cut the parts needed and exactly where to stick the needle to draw out the blood.

She stated the blood was put into gallon jugs and kept cool for baptizing new cult members. They were baptized in the same manner in which most churches do except the baptismal vat would be filled with blood which had been extracted from the animals. The eyes taken were boiled and eaten by the cult members at rituals. The sex organs were used in the rituals, also, because the cult believes in free sex to everyone.

When using the helicopter they sometimes picked up the cow by using a home made belt type sling and one man would go down and fasten it around the cow, and they would move it and drop it further down from where the mutilations occurred. This would account for there not being any footprints or tire tracks.

When using the van trucks they would also have a telescoping lift which she stated was about 200 feet long mounted outside the truck and would use that to extend a man out to the cow, and he would mutilate it from a board platform on the end of the boom and would never touch the ground.

She stated that they love the publicity that surrounds the mutilations, and as long as the publicity is in one area they will keep returning because they like to baffle law enforcement.

She stated that they would repeatedly go back to one farm if there were a number of roads coming into the area which would be accessible for a quick get away route. If not, they usually hit one time and then move on to another location. They sometimes do three or four cows a night.

The cult usually prefers the dairy cattle but will mutilate any type of cow when no dairy herds are easily found. They will also mutilate cattle which

have died if they are still fresh and haven't started to deteriorate. They have mutilated bulls, horses, and dogs to get blood for their rituals.

She left the cult about a year ago because one couple sacrificed their 15-month-old baby. They placed the little girl on a table at one of the rituals and placed oil on her body and cut her up with a large knife to prove their love for Satan. She said that after seeing this she realized that the cult was not for love and left. She was beaten by some cult members a few months later who located her and was apparently left for dead.

She has agreed to cooperate in any way she can as long as her identity is kept a secret, because she fears for her life.

The Sites

Finding an actual site used in Satanic rituals is not easy. First, sites are well hidden in out-of-the-way places. Second, if Satanists believe they have been discovered they will destroy the site and move to another area. This is especially true of buildings that have been used for rituals. Some Satanists will move their sites on a regular basis. Third, many of the more prosperous Satanic cults ensure that their actions will not be detected by using private lands owned by a member.

Many law enforcement agencies don't report Satanic sites in such a way that the information can be accumulated. If the site is in a park, for instance, it may be recorded as "vandalism" or "destruction of public property." Also, because not all police officers know what a site looks like, they may simply describe it as an area where people congregate.

In 1979, while producing documentary films for the CBS station in Denver, Colorado, I began research into the world-wide animal mutilation mystery. That research led to ranchers, law enforcement officers and others who had encountered strange lights, and in one case large black-eyed humanoids, in areas where mutilations occurred. Two witnesses were women whose dramatic hypnosis sessions raised serious questions about alien life forms using this planet for their own needs.

Since 1983, the story of mutilations, human abductions and government knowledge about alien life forms has continued to evolve in complex and unpredictable ways. It has taken a year to assemble this 448-page book in an 8½ by 11 format with 31 color photographs, 5 black and white photos, 75 documents and drawings and 54 newspaper and magazine articles. The most direct method of assembly, quality control and prompt distribution has been to publish myself.
