According to an article written by Ann Druffel, titled "*Ufology's 'Mr. Controversy?'*" in the April, 1991 issue of FATE magazine, were contacted by many government sources following the publication of Bill Moore's book on Roswell. "Moore is not sure what the government people's motives were or what they continue to be, wrote Druffel. " Other government sources continued to contact him, and he and Shandera continued to give each source the name of a bird. In this way, the two could discuss the activities in which Moore was involved without having to worry about telephones being bugged or being overheard in public places . . . They hold a variety of 'need to know' security clearances, and seem to know each other."

The process, in his opinion, started 'originally from the National Security Agency (NSA) and high levels of the **AFOSI**. "According to Moore's assessment, **AFOSI** holds prime responsibility for UFO data collection in the government. It is also responsible for planting information and disinformation on the subject.

"Of one thing Moore is sure. Government agents are faster at planting 'data' than civilians can check and verify it. Civilian UFO research finds itself in a pitiful state. Moore pinpointed the case of Paul Bennewitz as an example. The Department of Energy, the National Security Agency (NSA) and other government agencies were interested in Bennewitz' claim that he had intercepted low-frequency electromagnetic signals which he believed originated from UFOs.

"Bennewitz was a reputable scientist; his only crime, according to Moore, was his claim that he was receiving signals from **UFOs**. To this date it is UNCLEAR whether or not the strange signals Bennewitz was picking up actually originated from secret government projects, and had no connection with **UFOs**... "According to Moore, he tried to diffuse all disinformation schemes containing references to underground alien bases, UFO involvement in cattle mutilations, genetic research by aliens and government, (so-called) 'hybrid' babies, and rumors of 'aliens among us.' He recognizes such incredible rumors-- as the sort of thing that was fed to Paul Bennewitz and others. Disinformation, but even more so

According to 'abduction' expert Bud Hopkins, he was approached by the CIA and asked if he would be willing to work for them, and be their 'abduction' expert. Strange that the intelligence community would hire someone to work with abductees when 'abduction', according to them, do not exist - Branton).

"During the past decade, there have been four or five 'summit meetings' of the aviary with Shandera and Moore. Once the meetings began, information flowed quite freely. EBE-1

Said captured in 1947 and died in June of 1952 of an unknown illness: See, *Likeness of EBE 1?* for further information.

EBE-2

Arrived in April 1964 for the first "official" landing and contact: Location was a highly secured Area 17 at White Sands (not Holloman AFB) located just south of the present Shuttle landing site. EBE-2 was described during an interview on March 5th, 1983 as being 4' 9" tall and having a very thin body: He was dressed in a tight fitting jump suit and having only four fingers and no thumb. Interview reportedly took place at Los Alamos National Labs at a Site 30 inside TA49. See URL below for CIA Memos reporting on some of the movements of EBE-2: EBE-2 departed in 1984 according to two reports. See, *Top Secret CIA Mj12 Memos on EBE 2?*

EBE-3 and Aids

Came as an exchange scientist in 1978 along with two aids: One aid was assigned to Groom Lake and the other assigned to Los Alamos National Labs. EBE-3 was not female however, the aid at LANL was female: EBE-3 and his aids left in November 1994. **Correction:** When EBE-3 left in 1994, the aid that was sent to Groom Lake was left behind because the 'committee' would not let him go. His identify: **J-ROD**, J-ROD does not think of himself by that name, but thinks of himself as 'captive'. See below for more on J-Rod.

Below is supposedly what **Jarod** looks like: He is reported to be 200 years old and currently suffering from cell deterioration: His present location is reported to be at Groom Lake, Area 51/Watertown, Nevada.....

Comments from Thomas Mack, retired AF Major, AF Intelligence (now deceased), reference the supposed drawing of JAROD: "With the exception of the long fingernails and the bulkiness this looks just like JAROD. I was in Albuquerque NM from March 20th to 22nd, 1999 meeting with one of my sources: After touring Sandia Base on Kirtland AFB and talking he showed me what he said was a government "case file" drawing of EBE-1: The drawing really "struck a bell" since I knew I had something very similar to it at home but the face was slightly different as well as the colors used in the drawing. I'd received my drawing from Linda Howe back in 1988: Linda sent it to me asking if I had ever seen this type "Alien" before which I hadn't. With the drawing Linda included the following note:

"This EBE was drawn by a male subject under hypnosis after an abduction experience with his wife in Denver Colorado during November 1980. When this man saw his drawing he immediately responded that his skin should be gray and his chin more narrow. He drew with available pastels." *Linda Howe*

Comment, further investigation has indicated that in fact Linda received the above photo from one of her intelligence sources inside the intelligence community and not according to the story she gave me.....Rmc

Additional Comments: The **EBE-1** drawing I saw in Albuquerque on March 21st was allot like the figure drawing except the skin color was more "flesh tone" and the face not as "rounded" as in the figure: Otherwise, I believe the figure drawing a fairly close approximation to the drawing of what was reported to be EBE-1 and, a **Colonel John Grine** was a medical officer on the initial team which examined EBE-1. He also assisted in the autopsy on one of the other EBEns. Colonel Grine retired in 1970 and lived in Austin, TX until 1985 when he

moved to Albuquerque. Colonel Grine died in 1995 at the age of 91.

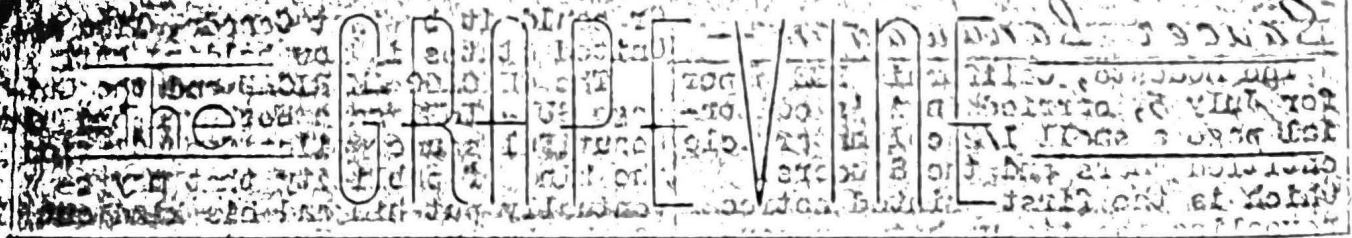

Probably the most ridiculous but nevertheless interesting rumor to reach our ears for many a moon has been to the effect that Mr. Frank Edwards, newscaster for the American Federation of Labor on Mutual Broadcasting System, is in actuality working for Project Bluebook.

This rumor came from Australia and was traced back to the United States and originated in Southern California. Inasmuch as Mr. Edwards has sneered at the crackpots who periodically crawl out from under rocks in Southern Cal and begin spouting saucer lore and taking pictures like mad, it is not difficult to figure out which facet of the saucer clique started that one. We spike that rumor with those few words: Edwards, who has battled tooth and nail against censorship of saucer news, attempting to push into the open the conclusions of Air Force officials regarding saucers, is the last person in the world who could be suspect of collaborating with the Air Force. This rumor is, in our opinion, another attempt by the screeballs and crackpots to disqualify a man who is doing an honest job.

Another rumor which came from Australia but originated in Southern California, is to the effect that the UFO which was downed in Northern California and retrieved by Air Force investigators, is being examined by scientists at Muroc Base while kept under heavy guard. This, at first glance, sounds logical, except for the fact that it would be more sensible to move that thing to the closest base for examination rather than to take it several hundreds of miles further and risk having it let out of the bag. Our sources have indicated that Air Base from the beginning. But then, who knows?

In regard to the rumor that Edgar Jarrold of the Australian Flying Saucer Bureau has obtained a piece of a UFO, let's let that gentleman answer in his own words: "A small clipping contains an official denial issued to the press recently, following our receipt from Shepparton, Victoria, of a portion of one of several aerial objects observed there at the time stated. Confirmation of the arrival of the piece of strange material brought immediate rumors to the effect that

we have a piece of a saucer which crashed in the vicinity of Shepparton on May 12, a 'piece of a green fireball', a 'portion of a hostile missile from outer space', etc. We intended to release a full account of the incident which resulted in our receiving the sample, but the rumors beat us to it, compelling us to issue the denial in order to gain sufficient respite in which to have the substance analyzed. The material is of unknown origin, and the theory of meteoric origin is not even being entertained. You, like the sensible section will, I feel sure, appreciate how dangerous it would be for us to confirm any individual theory without awaiting analytical results, thus we propose to say as little as possible until this is in our possession, after which our official statement can neither be elaborated upon or denied. We agree absolutely, Mr. Jarrold, and would like to ask members not to write Mr. Jarrold and attempt to gain more information. When and if final and conclusive results are obtained the information will be relayed to the Director for dissemination among the members via the Bulletin. Knowing full well the huge amount of mail involved in work of this kind, we know what can happen if one person is rumored to have any kind of startling information. Letters by the hundreds from all over the world flow in, and the digging to get it out is a long, arduous task. It is rumored that airlines pilots who have sighted UFOs while in flight, while instructed by the CAC to report all such sightings, are seriously thinking of either keeping still about sightings or turning them over to civilian organizations rather than to TIC. Seems they're sick of conscientiously detailing reports, and undergoing grueling investigations, only to have the Air Force issue a generalized statement which, although not pinpointing actual sightings, implies that the reports were in actuality reports of mirages, optical illusions or hallucinations. Can't say that we're to blame then-- these men have flown thousands of hours and millions of miles, and are thoroughly familiar with celestial and atmospheric phenomena, plus conventional aircraft. Our retort: Send them to us. We won't attempt to ridicule the observer or the report.

Having spoken with a number of people who have found themselves in similar situations, I know that many view their experiences as intensely personal matters, which more often than not generates a reluctance to speak openly. I should stress, however, that accounts of surreptitious communications with human-like extraterrestrials abound, and, as I will later reveal, the Federal Bureau of Investigation maintains a close watch on people reporting such alien contact.

Although the young woman's account was certainly provocative, there is enough circumstantial evidence in hand to suggest that her experiences were genuine. For example, the claim that a UFO was 'shot down' in 'the past week' (i.e. at some point in October 1967) is interesting. In 1980, a full thirteen years later, the late Leonard Stringfield, a former US Air Force Intelligence officer, learned from a retired source with Army Intelligence that between 1966 and 1968, the US government retrieved the remains of no fewer than five UFOs which had crashed on US soil.¹² Was the 1967 incident reported to the FBI one of those to which the Army officer alluded?

In addition, the woman's assertion that unusual aerial activity was detected throughout August 1967 is highly illuminating. Less than two weeks after her visit to the Dallas FBI office, the Soviet Union instigated a semi-official research project aimed at resolving the UFO problem. According to the Soviets, the project had been proposed in the wake of five recent, well-authenticated UFO sightings. Whoever our mysterious woman was, she seems to have been blessed with remarkable insight, to say the least! Of course, one could argue that the accuracy of her claims was mere coincidence; yet time and time again I come across cases similar to this one, and I am now firmly of the opinion that, for reasons best known to themselves, certain species of alien beings do desire some form of direct, if guarded, contact with the human race.

Available records show that throughout the late 1960s the Federal Bureau of Investigation was obliged to deal with numerous enquiries from members of the public who had latched on to a story that the Bureau had in its possession the bodily remains of an extraterrestrial creature. Consider the following partly censored letter of 14 March 1968 to the Bureau:

Redfern

My name is [deleted]. I work for the United Saucer Hunter Organization. I am writing this in regard to a report that the FBI had captured a saucer occupant. This was published in a flying saucer mag. along with a photo of two alleged FBI agents and a saucer occupant. Is this true? Does the FBI really have a saucer man?

A similar letter to the Bureau from a UFO research group based in Ontario, Canada, states:

Our club is very interested in the study of Unidentified Flying Objects. We were studying a magazine called 'UFO's A Pictorial' and on one of the pages there was a picture of a supposedly [sic.] man from outer space who was being held by two men. Above the picture it stated [that] the two men were FBI agents who had captured this man and were walking down an American street. It had also stated that the picture had first been published in a German newspaper. There was no other additional information. We would appreciate it if you would send us a letter telling us whether this is true or untrue.

'I can assure you the photograph you mentioned does not represent employees of this Bureau,' wrote Hoover in a response of 13 October 1969, adding in a 'Note' for FBI eyes only: 'The photograph in question has previously come to the Bureau's attention and is known to have appeared in a publication in Europe concerning unidentified flying objects. A caption under the photograph alleges two FBI Agents are leading a person from outer space down the street.'

Subsequent research has shown the photograph in question to be bogus, and nothing more than a good-humoured April Fools' Day hoax. However, as the FBI well knew, other accounts of alien bodies being in the possession of the US government could not be dismissed so readily. As we shall see in a subsequent chapter, the Bureau has built up an impressive number of files relating to apparently crashed UFOs and their deceased unearthly occupants.

Midway through 1971, a cryptic letter was sent anonymously to the

Jell, this is the beginning of Advent and every year for the next three Sundays we learn a lot about the sort of thing most people don't want to talk about, to prepare for, to face -- death and judgment. It is all in preparation for the birth of Christ who then we t through the cycle that is the lot of all of us, saints, sinners, liars and lovers.

By the time this reaches you I hope and pray that you too will be knowing a rebirth and that the slow torture of injustice will have passed you by at last. It is easy for all of us to see ourselves persecuted and maligned, but as one a little outside the perimeter I certainly think this was the burnest beef in a long line of them.

That sharp shooting was not done somewhere by somebody -- could be the last to deny but at worst it seems that Doc and Flader tried to outsmart each other and you got caught in the crossfire. For that reason I cannot see why a move for a dismissal, or at least a note for the dismissal of the charges against you, can't be successfully argued and if turned down immediately appealed on the basis of the prosecution's own case. I can't see that you need Doc at all, even if in court in a hospital bed, to prove that you personally had nothing to do with the charges advanced by Flader. His contention that you and you were in a silent partnership before Doc was introduced to you, if not proved by the prosecution just about destroys the conspiracy to operate a con game and all else falls apart like a house of cards. Did they bring out anything to damage the chronological sequence which has been your main contention from the beginning? If they did it seems to me you have the witnesses to destroy it. If they didn't, you have a case as Judge Richards indicated for false arrest right there.

But to lighter things. The reason Gene thinks it unwise to talk to you at his house is that he has good reason to believe his phone is tapped. Some weeks ago he fell upon a fantastic tale through that sound engineer at Disney's. It seems, according to the story, a saucer landed in the area of Edwards Air Base near Mojave. A live pilot was captured. He was loathe to talk but he did point out on a map to the planet Mars. The main difference he showed from earthbound mortals was that his circulatory system was not operated by any pump similar to our heart. Gene wanted to know if I could get in there through some high member of the Air Force. I started to hunt out among those with the rank at least of Brig Gen, when Gene recalled me and told me to forget it because security had clamped down on the thing. He had learned through Brian Dunlevy who was in Navy Intelligence that nobody could get in or out of Edwards for the moment. Not even phone calls were going through to certain staff members.

Gentlemen:

A relative of mine living in Circleville, Ohio has advised me of the following account.

Two years ago a respected farmer living near Circleville saw a lighted object dancing around, flying around in the air over his late at night in a pasture or field, -- a flying saucer. In due time this came to have general knowledge in the community, and about one year ago the story appeared in the Circleville newspaper.

Since then he is presumed to have been consulted with representatives of the F.B.I., so it is said there, and only three weeks ago or so it is said the F. I. representatives came to consult with him again. This time they brought pictures to show the farmer of various types of these flying saucers or space ships that have been apprehended by the government from time to time, and the farmer was able to identify one of them as the type of thing he had seen two years ago.

The farmer was told, as the story goes, by your representatives, that the particular flying saucer he identified is the type that is known to have been flown down from the planet Mars, and that similar ships have been captured, and that your agency or the government hold captive one man at least in California, who was taken from one of these things from Mars. This Martian it is understood is now being taught how to speak English -- in California -- and taught American customs. It is said that it is apparent that this Martian comes from a civil much more advanced than our own civilization... and that this account has general knowledge as reported here in that community.

I understand that the farmer is a Mr. [REDACTED], that he is held in very high repute in the community, prosperous, conservative and of presumed sound mind.

I can only believe that the account is a lot of nonsense, insofar as the F.B.I. telling the farmer that the government has captured several "flying saucers", and that they are from Mars, and that a Martian is being held captive in California. It would be apparent to me that if the government did have such knowledge, they would not confide such information to the farmer, -- and moreover that it is too utterly fantastic to credit with recognition as true. The farmer no doubt saw a "flying saucer", a light reflection or other light phenomenon such as the government has said all such things really are, and not a space ship from Mars or any other place in outer space.

I am writing to hopefully secure your advice, insofar as you can properly advise me publicly as a citizen, of what the truth is in this story. I should like to set my relative there straight. And I am curious personally to know what the real story is about this farmer - Mr. [REDACTED] of the Circleville, Ohio area.

[REDACTED], Circleville, Pickaway County, Ohio, advised he is cognizant of a "flying saucer" report made by Mr. [REDACTED], Circleville, Ohio. According to Mr. [REDACTED] reported that a saucer-shaped object had landed on his farm some time ago, and this report eventually reached local newspapers. In June, 1953, an individual discussed the matter with Mr. [REDACTED] advised that this person did not, to his knowledge, represent himself to be an FBI Agent. The [REDACTED] further declared that he has known [REDACTED] all his life and that he is a prosperous, well-respected local farmer, who is considered trustworthy.

Mr. [REDACTED] was interviewed 7-14-53 at which time he stated that shortly after he received some publicity regarding his report of sighting a saucer-shaped object, he was visited by one [REDACTED], who gave his address as [REDACTED] Tri-Village Station, Columbus, Ohio. According to Mr. [REDACTED] told him he was a salesman of television antennas, and that for over six years he had been pursuing the hobby of investigating "flying saucer" reports. He emphasized that he had no official connection with any part of the Government, but stated that he had once been "checked" by the FBI. Mr. [REDACTED] declared that [REDACTED] showed him pictures of "flying saucers" and told him he was writing a book on the subject, which would be published soon.

Flying Saucer Talk Startles Chamber Membership Meeting

A three-foot tall pilot of a flying saucer from an outer planet has been kept alive in an incubator in the state of California for two years, and progress is being made in efforts to communicate with him, started Chamber of Commerce members were advised here Tuesday.

The air force set up a commission to study saucer reports in 1947 and discovered that 20 per cent of the reports could not be explained satisfactorily. The air defense command at Colorado Springs has a unit designed to study the saucer, and a pin-marked map shows saucer reports indicates they are seen frequently around military installations and atomic research centers, he added.

Information on the still mysterious individual who reportedly was rescued from a "saucer crash" in Montana was divulged at the Vail hotel last night by Joseph Rohrer, president of the Pikes Peak Broadcasting Co.

CHARTER REVISION GROUP WILL MEET

An advisory citizens' group whose identity has not been revealed at city hall will meet at 7:30 p. m. Friday with city council's charter revision committee to discuss the revision of the charter.

The reputed lone survivor among crews of three saucers that have fallen in that state has been shown pictures and has shown great interest in them and primary steps used in teaching a child to read and write are being employed," the speaker stated.

A chamber of commerce official was asked to name four representatives of civic and service clubs, and non-profit organizations as the groups club the American Association of University Women, the Pueblo United Labor League and city employees were asked to appoint members. Thus use of the flywheel, a magnetic field is created which permits the saucers to travel at tremendous speeds, said Rohrer, who became interested in flying saucers as the result of a thesis he wrote on electronic tubes used to measure electronic tubes during his college training in electrical engineering.

DRAGLINE DAMAGED BY SEVEN YOUTHS

Seven boys, eight to 15 years of age, admitted Tuesday to Police Capt. Robert L. Mayher that they had damaged a dragline Monday by putting sand in the gasoline tank and cracking of the machine.

"If a magnetic field is opened around the earth it would be possible to travel at about the speed of light," he stated. "They have never tried to fly the saucers that have been captured. They are put together in five sections and about apart each after the center section is removed.

I received these memos (3 shown here of 8) from Bill Moore in 1986 and they've been gathering dust up till now not knowing whether they were real or not: These memos have been reviewed by two sources who were in a "need to know" position before leaving their respective jobs in the Air Force: One as a Branch Chief at FTD now NAIC and the other as a former AFOSI Agent: Both sources have made the same identical remarks that although the memos are not properly classified documents the information in them is correct from what they knew. Or, to reference what Stanton Friedman has been saying: These type memos can be considered A to B documents and were not to be read by anybody outside a very closed tight knit circle. And in this case with the intent that they be destroyed right after they were read.

My ex AFOSI contact never knew that Bill Moore , Jamie Shandera or myself had these memos in our possession: He totally "flipped" just recently when he saw one of these memos posted to a Web page and asked "how did Bill Moore get these ?" He went on to say that he had seen these in a properly classified Top Secret codeword document some years (mid eighties) back. His words, "there real !"

The other 5 CIA Mj-12 Memos deal with various other topics including comments on IACs 1, 2 and 3 and Project "A." See CIA Mj12 Memos on IACs ? and CIA Mj12 Memos on Project Aquarius ?

Comment: In all three documents the subject is EBE-2 or Extraterrestrial Biological Entity-2 which was reported to be a guest of the US government from 1964 to 1984 ? These memos supposedly describe the day to day problems in dealing with EBE-2.

In the first document (figure 1) dated May 14, 1980 with signed typed initials of MJ9 it refers to an R5 at CIA DCD and a R-3 and R-2A in the text: At this point we don't know who these people/groups were in May of 1980.

Concluding remarks: If anymore information comes along to validate or invalidate these CIA Memos we will promptly inform the readers. There have been rumored to be statements from the CIA that the Air Force Office of Special Investigations PJ office hoaxed these memos using CIA letterhead: But, nothing to date has shown this to be true. Quite the contrary, information so far suggests they may be in fact authentic.

Interview with EBE-2: March 5th, 1983 at Los Alamos National Labs

The following is an account of the meeting I (source) was involved in with EBE-2.

On March 5, 1983, I was at Los Alamos National Laboratories conducting business on a counterintelligence project. During my visit, a source I'll call LANL-1, asked me to sit in on a very special interview. Not knowing what he was talking about, I questioned him. However, he wouldn't say exactly what the project involved or who was being interviewed. I accompanied LANL-1 to an underground facility west of the Los Alamos complex.

The area was called, Site 30. Access to this facility was gained by entering Area 49. Access to the underground facility was through building number 49-2091.

Comments: See URL below for TA 49: Notice that Bldg 49-2091 is not labeled on the map as expected ? But, this may or not mean that the building is really there ? But, there are buildings 49-113 and 49-114: And, we did find a building 2091 in TA 3 that was approximately 760 square feet having three offices and a conference room. Remember though, the information on LANL structures available in their map rooms is "PUBLIC INFORMATION:" And so, one would not expect those map files on LANL structures; both above and below ground. And besides, the bulidings marked as 49-113 and 49-114 are part of the new numbering system and on an old map 49-2091 is a numbered sequence in TA 49: It's believed that one or more of those old maps is still classified: Also, from 1945 to the early nineteen eighties LANL had two numbering systems: One for internal use only and one for outside release.

Continuing: An elevator took us down about 60 feet (only estimating). Once we arrived, access was gained through a large vault opening outside the elevator. We walked down a hallway to another vault door. We entered and turned right. We walked about 200 feet turned left and entered vault door to a large room. This room contained two tables, several chairs and recording equipment. I sat near the door. About ten minutes later, three people, who I did not know, entered the room. One, an Air Force Colonel, asked me to sign a security document, which gave me an upgraded clearance, TS/SCI/Group-MJ-B-3/clearance. I've never heard of this but I signed. The Colonel told me I was to listen and not make any sounds during the interview.

I asked the Colonel who was being interviewed and he told me a guest from another Planet! The Colonel left. The other two people set up a table with a microphone and recording equipment, including a camera. About five minutes later, in walks a 4' 9" non human looking creature. It was dressed in a tight fitting cream colored suit. It had no hair and was identified to me as EBE-2. EBE-2 sat in

a chair across the table from two civilians and the AF Colonel. I did not know the identity of the three. LANL-1 came into the room and sat next to me. I listened while the three asked EBE-2 a series of questions pertaining to it's home planet. First question was about the temperature, climate and weather. EBE-2 responded in perfect English but sounded like a machine generated voice. Very hard to explain but it was either coming from a device that EBE-2 had in front of him or from something in it's body. EBE-2 explained the weather of it's planet which was dry, varying temperature between 65-90 degrees. There was 35 hours of constant sunshine and three hours of darkness. Rainfall occurred only during one of it's months each year. The day lasted 38 of our hours. They did not have months but did have years which consisted of approximately 600 of our days. They used a society cycle which I understood to be similar to our months. During this society cycle each Eben worked a certain time and conducted business. There was also a rest cycle which consisted of a regulated period of sleep. I don't recall the exact number of hours or sleep/rest. EBE-2 discussed weather patterns and how they were formed. I don't recall the exact words. However, EBE-2 seemed very intelligent and fully explained each weather pattern in precise detail. He used Earth's equivalents for Meteorology terms. The interesting part of this interview was that I didn't hear any questions being asked by the three humans sitting across from EBE-2. Either the questions were already given to EBE-2 or the three humans were "thinking the questions" and EBE-2 would respond in English.

This interview lasted about one hour. I didn't check my watch but I estimated from the time I entered the room to the end of the interview was about 1 hour and 15 minutes. Considering I was in the room about 15 minutes before EBE-2 arrived, then I can estimate the interview to have been 1 hour. When the interview was completed, EBE-2 stood up and walked to the door. Just before exiting it looked at me. I felt a little strange but I immediately felt happiness! I can't explain it but I just felt really at ease, peaceful. EBE-2 didn't smile but he did make a strange facial expression that I can only assume to be a smile. He then left the room. The Colonel then told me I would be escorted out of the facility by LANL-1.
