"All hell broke loose" Thursday, March 13, in Ashland said Professor Eugene Lundholm, head of the library and a psychology instructor at the University of Wisconsin-Superior.

That was the evening when Ashland County Undersheriff George Ree, four Ashland County deputies, and two Iron County deputies sighted between one ~~and~~ ^{to} four unidentified flying objects near this northern Wisconsin community of about 9,500 located on Lake Superior.

It was the same evening the Phil Baker family claims that an object landed 450 feet down the road from their driveway near Mellen.

"It would get bright, it would move, do a jig, change colors, make a 'u,' go down, and dart back and forth," the undersheriff said of one of the four objects he observed.

"It was shiny, with red and green lights; it made a lot of noise . . . then there was a big boom and it was gone," said 15-year-old Jane Baker.

"I didn't know what to think; my eyes didn't want to tell my brain what I was seeing," said her father, Phil, a veneer clipper for a plywood plant.

with the sherrif, deputies, and the Bakers. ~~One~~ hesitates, he says, to make any conclusions "until all the evidence is in."

Lundholm has been doing research on UFOs in a seven county area of Northern Wisconsin for two years now. He said that he works closely with Dr. J. Allen Hyneck, chairman of the astronomy department at Northwestern University. Hyneck researched UFOs for the U.S. Air Force for years and now heads the Center for UFO Studies.

"Hyneck tells me this is a hot area," the professor said. *Hyneck is in New Mexico and could not be reached for comment.*

~~He~~ Lundholm claims there were ~~six~~ sightings January 14 and 24 near Superior. Then on Wednesday, March 12, he said that the sherrif of Superior followed a UFO down Highway 53 in his patrol car.

On Thursday, "all hell broke loose."

Besides the Ashland sightings, there "quite a few sightings" near Gordon, 40 miles south of Superior.

What does he think the objects are?

"Can I quote somebody else?" he asked. "Stanton Friedman, a nuclear physist in California, says categorically, after 16 years of investigation, that they are from another planetary system out in the galaxy here to observe us." Lundholm doubts "very seriously" if they are secret military vehicles. He plans on returning to Ashland this weekend for further investigation.

Not many people are skeptical about the existence of unidentified flying objects in Ashland, a small Wisconsin town on Lake Superior.

Thursday, March 13, Ashland County Undersheriff George Ree and six deputies watched one to four UFOs "do a jig, change colors, make a 'u,' go down, and dart back and forth" while Sheriff Joe Croteau kept losing radio contact with them as the objects passed overhead.

And if that wasn't enough, the Phil Baker family frantically reported that an object landed down the road from their home near Mellen.

Yet the public information officer of Duluth Field, Capt. Anthony Kehnle, said "there was no (radar) contact with any such thing as an unknown Thursday evening" and that the Air Force "has never had contact with a supposed unknown."

That evening Phil Baker was sitting on the davenport in the living room examining seed packages he recently ordered. It was about 9 p.m., he said.

Suddenly, his 15-year-old daughter, Jane, or Jo, yelled

hysterically. She had been performing an evening ritual of putting the cats in the garage for the night when she spotted a strange, bright object about 450 feet away from the driveway.

Baker said he quickly put on his shoes, "stepped out the door and there it was.

"I didn't know what to think; my eyes didn't want to tell my brain what I was seeing," he said.

He thinks it was a circular object about 12 feet across.

"It had red and blue lights and the center was like an open door with a real brilliant light on the inside," he said. "It made a high, whiny, singsongy noise; I never heard a sound like that before."

The object stood there for about 10 minutes, said Baker, a veneer clipper for a plywood plant.

"I have a camera and I have binoculars, but I'll tell you at that time a camera and binoculars were the last thing on my mind!"

Suddenly, he said, he heard a pounding noise, like hammering on metal.

"I didn't know what to expect," he said. "I thought maybe my eyes deceived me; maybe it was a light plane that had crashed and somebody needed help. I told my wife I had better go and investigate but she said stay away from it.

"She said we should call somebody and I said, 'Who we gonna call? People will think we're weird'"

Nevertheless, he called Undersheriff Ree.

"No sooner was I on the phone but there appeared to be an explosion and it vanished," he said.

The object didn't interfere with the television and radio, both on in the house.

When the undersheriff arrived, there was no trace of the UFO.

"I really felt foolish," Baker said. "I know what we saw and I'm not a drinking man; I don't drink."

The next morning, he said, Jane went outside with the dog. She told her father she saw an object hovering to the west over "a kind of swamp."

"S he insists the object was the same as she saw on the road," Baker said.

The girl told him she didn't hear a sound, but that the dog fell to the ground and kept hitting his front paws on his ears.

"She had to carry him back to the house; it was just like ~~he~~ ^{she} was paralyzed," ~~he said~~.

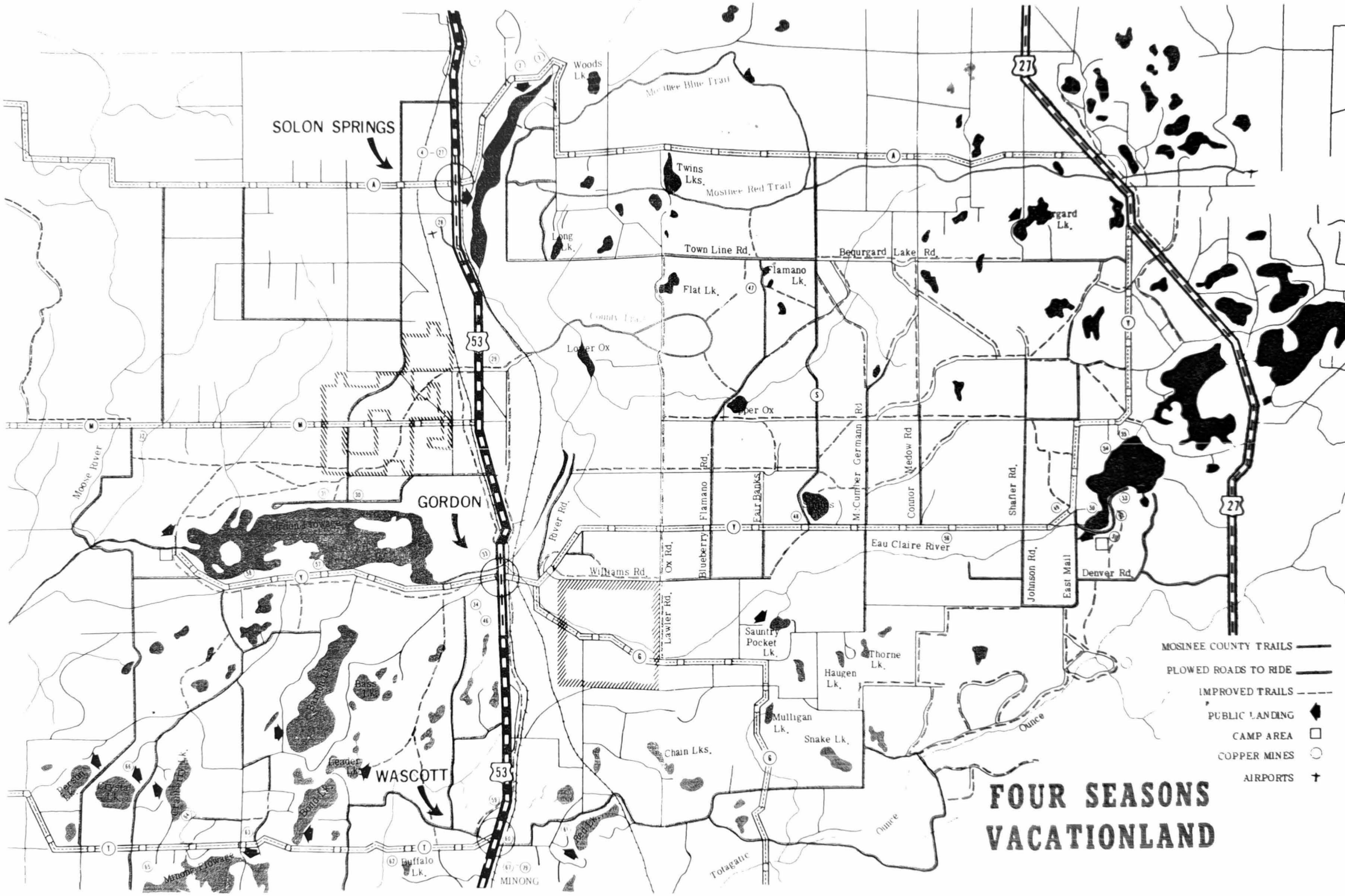
When she returned outside, the object was gone.

Baker said that the only evidence that the UFO had landed was a round circle in the ~~road~~ road with snow "ruffled" up around it. His boys' bicycle tracks lead up to the circle, stopped, and continued on the other side. But in a few hours, he said, the

sun had melted the snow.

(this happened on April 20, 1975)

I was driving north towards town here (Superior) from Solon Springs (on U.S. 53). it was a real clear night. The first thing I saw was a shooting star. it was on the righthand side of the road, and right after I turned around from that I saw this big object in the middle of the road ahead of me. By the time I stopped it was about 200 feet away. it was about two car lengths above the ground (10 feet) and it was dome-shaped, but the bottom part didn't have any definition. It wasn't like the top was. It was sort of, irregular, and it was glowing, and it was just hovering. It wasn't moving. and there was a great big round red light on my side of the road. it was flashing. (The red light was over your lane of the highway?) Right. It would be on the lefthand side of that thing (lookin' toward me). And it was glowing like, like green, like light green. It looked like gases, and as I came up to it I was thinking all the logical things it could be, like when you come over a hill at night and the car lights are fanning out. It was just about like that kind of a brightness, and I thought/the red light it was an accident, but as I was getting closer to it, it wasn't. It was just there on the road. and so I stopped, and I looked at it and I said, 'I do 't know what it is,' so I turned around to head back toward Solon and I was watching the thing in my rearview mirror, wasn't even looking at the road where I was driving, hardly. Just blinked, and then it just disappeared and then these lights were coming at me, while I was using my mind 'they're coming to get me' and I kept going and going, and it turned out to be a squad car. when he stopped me he didn't know why I was speeding, and I said, 'didn't you see that thing on the road,' and he said, 'No,' and he went through it all there was on the road was this low-lying fog in this place where I saw it and it smelled like garbage burning. He followed me back there and that

stuff was still on the road, but the thing of it was that there was none before it and none after it and it was such a clear night, and there was just this residue or whatever it was that was left on the ground and he made the comment that it could maybe be the, uh, what they leave after take off, (Exhaust?) yeah, right . . . (When you first saw it, how far down the highway do you think it was?) I don't know, I'm not very good at distances, but as soon as I saw it I started slowing down, I suppose maybe (pause) two blocks? (Was this on a straightaway?) yes. (You saw this shooting star and then looked forward and there it was?) Right. (Did you see it land or come down or anything?) No. Unless I had come around that curve--see, I mean I can't really analyze what I did because I wasn't think I'll have to explain this later, you know. So, I mean, there is a _____, so I couldn't be coming around the curve, I don't know. Like I say, I wasn't really looking at the road. (About how fast were you going?) The speed limit, 50, 55. (And this was in your Mustang?) Yes. (What year is that, a 1967?) 1968. (You were alone?) Yeah. (You had been down in Solon visiting people or what?) Yes, my boyfriend. (And you were on your way back to Superior?) To home, yes, but when I saw that and after I analyzed all the things I thought it possibly could be ~~that~~ ^{that} would make sense, I ran out of things and then when I saw that flashing light, that big red light it was just flashing and flashin and just thought, you know, it was a big, intense round light. It wasn't like a squad car light or accident light. It was just a red light (How ~~big~~ big a bulb, uh, was it an individual light in ~~it~~ itself or did the whole thing just glow?) The whole thing was glowing, yeah (But you didn't see anything you could define as a light itself, like a spotlight or--), no, just that ~~was~~ red light. (How large would you say it was) it was pretty big. (This thing covered the highway) Oh yeah, both sides of the highway, and it was really big, like up ^(above) into the trees

but it was off the ground and it wasn't moving, and it had, I don't know what it's called, a corona, coming out of it. Like I say, it was about as bright as when you're coming over a hill and the headlights fan out like that? Well, that bright. And that's pretty bright for down the road, especially when it's sitting there in a mass ~~mess~~ piece. The thing that really scared me about it was that red light. I didn't know what that light was doing. I betcha that light was about as big as that window (pointed to living room front window). (Really? And that's about 4½ to 5 feet square?) yes. It was big. That's why I knew it wasn't something from an accident or something like that because it was too big. (How frequently did ~~know~~ it flash, how often?) I can remember maybe three or four times. (Was it a sloooow, steady pulsating?) Yes. (And it wasn't directing a beam down ~~or~~ or in any direction, was it?) No. (Was the highway lit up in a red color?) I don't think so. (Was the highway itself lit up?) No, just from that thing itself, but it didn't make great big lights all over the ^e road. (You couldn't see the fences along the side of the road?) There was no fences (Or fields or whatever?) I really didn't look at the fields, except I looked around when I was going to turn around and I thought, 'Should I get out of this car and run into the field or what g should I do?' You know, I didn't know really what to do except turn back and go get some help in Solon or have somebody see it or, you know, because I didn't know what was going to happen to me. It was so unknow~~n~~, that's what scared me. And then by the time I got to Solon, well then the squad car stopped me. (And you didn't hear anything?) No, I didn't, and I was telling the professor I didn't even, I, --it would have been neat if I'd listened to see if my radio went off because I don't remember-- I know I had my radio on, but I don't remember listening if it faded or anything like that, which would have been helpful because maybe it was throwing off something that was giving me static. ~~now~~ usually turn the radio down. When I get into a traffic jam

or something like that I usually turn the radio down, because it's like I can't think if I'm listening to music, so maybe I did that. (You say the whole object was glowing a greenish color?) Light green, but it was like ~~xxx~~ iridescent. It was bright, real light, --really a light, but it was bright because it was so lit up. (Was it the color of a traffic light?) No (much lighter ~~to~~ like a yellow-green?) Maybe a couple of shades lighter than these walls (a pale apple green color) (Could you distinguish any features on this other than the red light?) Just the shape. (The shape was?) Dome shaped (High and ~~dome~~^m shaped on top?) Yes. (And flatter on the bottom?) Yes, it had sort of a, you know, a small semi-circle but it wasn't as big as the dome on top. It was shallowed but but there was no, like flatness of this table. It was irregular. (And the only distinguishing feature was the red light?) Right. (No edges around the thing or rims or anything like that?) N^o, but it looked three-dimensional but it wasn't, like I didn't see any windows or anything like that. ~~xxxxxxxxxxxx~~ It was just whatever it was, those gases or (Did it glow all around or--) Not on the bottom, just on the top. (And the bottom was dark except for the red light?) It was the same color as the top. (And it wasn't glowing?) It was glowing but there wasn't any definition of the bottom. The whole thing was the same color, except for that red light. And somebody said, 'Well, it's pretty swampy down there, it was probably the fog coming up off the road and ~~xxx~~ some headlights,' but I said there were no headlights coming at me, and fog doesn't come up in a shape off the road and hover. I mean, if there's fog down and up and all over, it doesn't take shape. (Was there fog in the road at that time?) No, as I said, the night was as clear as a bell. In fact, I thought of it as really a fair night. I saw that shooting star on the righthand side and I thought, 'That's the first shooting star I ever saw.' (This was a really shooting star?) Yeah, and I thought, 'Oh, that's beautiful,' and then I turned around from that

and there that thing was on the road. Maybe it could have come in the time I was looking at that star. (Now, the officer smelled something as he came through, did you?) You mean when I was sitting there watching it? No, I didn't smell it until I was leaving (going back to Superior after being stopped by the officer). When he was following me back, the fog was still on the road and it smelled like garbage. (That fog was not there the first time?) That's right. But as far as before or after that time, there was no fog ~~xx~~ anywhere, just on that piece of the road. (When you went back, did the fog cover a wide area or just where the object was?) Just on the road where I saw that thing. Not out in the fields or anywhere, just on those two lanes of the highway. It wasn't like it was coming out of the swamp, you know. It was just sitting there. (Is this a straight stretch there, the highway?) Yeah, I think from there on it's pretty ~~straight~~ straight. There's a few curves before you get into it. (And it's pretty wide there, isn't it?) Yeah, it's a nice wide highway. (And it's flat there, no hills?) Yeah, it's flat. (You watched it when you turned around?) Yes (Did you take your time turning around or did you spin your wheels or--) No, I didn't spin my wheels, because I thought ^{of that} ~~x~~ when I was turning around, what if I go into the, if I go way too fast I might end up in the ditch and then I'd really be ~~trouble, s. I took~~ it real slow when I was turning. (How long do you think you sat there before you decided to turn around?) I think probably about, I don't know. They say time when you're nervous really stretches out but maybe a minute ~~by the time~~ by the time I-- (You just came to a stop, eh?) right. I ~~x~~ came to a slow stop. I pulled over close ^(to the shoulder) because when you get in the gravel it can throw you. (You pulled off the road?) Yeah, I pulled onto the gravel, because I knew I had to get a big enough swing to us, because when I saw that, ~~xxxxxxx~~ after I figured it out I thought 'I am not going up there,' so that's why I pulled over because I knew I was going to make a turn, and I looked at it a few more times

before I finally did, and then I took off. (Did you ever consider going under it?) Unh-unh, no. I could have fit under it though. There was enough room, but I didn't know what, you know, that ~~a~~ red light. I didn't know if it was some pulling power or or if ~~a~~ I'd be hypnotized or, I mean I didn't know, I was just so scared I just thought, 'I've got to get away from it.' So then I was finally stopped at the Solon limits. . . . The cop didn't see it, but I didn't see his lights until until after it disappeared. When I was looking in my rearview mirror that thing disappeared and then I saw those headlights. (How long after that did you see the headlights?) Oh, maybe a minute, it's hard to tell. And that's what I thought, that thing disappeared maybe it was some little car or something, you ~~xxx~~ know, if they're that advanced to get here I thought maybe they were sending a little car after me, and that's what scared me more. He was like on my tail and I thought, 'Oogh' (cross between Ugh and Ooh), I was looking at the road and I was so nervous I thought, 'why don't you just push me off the road, ~~and do what you want to do but get this over with.~~' (How long was he behind you?) From probably, I don't really know. Probably--maybe 2-- (When you saw the deputy's lights in your mirror, did you speed up?) Yeah (And how long did he chase you?) Maybe uh-- (When did he turn his blinkers on?) He didn't until we got to the Solon Springs limits. That's what I mean, I told him, 'why didn't you ^{turn} those on a long time ^{ago} because I would ~~have~~ have stopped, that's what I was looking for was help, I wasn't speeding. (What was your reaction when you saw--what did he have, red lights?)

yeah--happiness because I knew that was--you know the strange thing is, I got out of my car ^{first} ~~and started~~ because I was so happy, because it was a sheriff, and then I stopped myself before I started to run to him because I thought, 'I gotta make sure,' and I was looking at his uniform and I said, 'Oh, Oh, you're--' and then I ran to him and I said, 'Oh, ' And

he said 'You know you were speeding?' and I said, 'Did you see that ~~xxxx~~ thing?' And he said, No, and then when he thought about it he said all he saw was that fog. So he went ~~on~~ through it right after it must have disappeared. Because like I told the professor (Lundholm) it didn't just sail off or anything, it just vanished, unless in a split second as I say I was looking in my mirror more than I was my ~~wind~~^{WIND} shield ~~and~~ and in the time I was looking at the road it moved away, But to me it looked like it just disappeared. (How far north of Solon was this?) ~~xxxxxx~~ Just north of Bennet^T, that's the first town right out of Solon. (about 5 miles) [?] 3 to 5 (And you watched that thing in your mirror for how long, maybe a mile?) Maybe half a mile (and then it just vanished?) yes. (Even then you didn't think about turning around again ~~and~~ and heading back to Superior?) Unh-unh! Because right --I was going to go back to Solon and tell somebody about this thing and then right after that he (the deputy) scared the pants off me double, because I saw him coming and I didn't know what he was. Usually if a cop is chasing you he'll put his lights on right away and tell you to pull over. He didn't do that because he said in those dark areas they like to pull them into the city limits before they do that. I said, 'Well, I would've stopped.' He said, 'You were going 80.' I said 'I would have gone 120 if this car went that fast, believe me. I thought they were after me.' Because he was right on my tail and I couldn't see what he was. (Is it true you were hysterical?) Just about, really. I could have used a little slap I think. I wasn't screaming or anything but I was shaking so bad I was thinking I lost control of my body. He said, 'settle down, get in this car (squad car). I mean my legs were shaking, my hands were shaking, my head was shaking, my whole body was--I was so keyed up trying to get away from all these things I didn't know, it took me maybe 20 minutes, a half hour to finally calm down enough to even get in my car. I've never been so scared. I was scared so much I didn't even cry.'

. . . I didn't know if I was facing death or if this was my last escape or what. If I knew I would be here today, alive and well, I probably would have been more curious, knowing I wasn't going to be harmed or hurt but I didn't know that at the time, so I didn't want to take any chances. . . I couldn't imagine anything like that because I ~~didn't even hear~~ ^{hadn't even heard} what they looked like. In fact when he (Lundholm) showed me the picture of the one they saw in Gordon (Mellen, picture was drawn by Jane Baker, 15, after March 13 UFO landing) I was surprised to see it looked like this because I had never heard a description and had never seen one. (Was yours similar to the one in the sketch?) Yeah, except ~~for~~ for the small lights (Mellen one had colored lights around edge and doorway) Hers was silver and mine wasn't silver. . . . (talking about colors)

. . . it was like, I wish I could think of a better descriptive word, but like when they melt steel you know, that moltenness, how it goes orange and yellow and--it didn't change to any other color besides that green except maybe a little lighter and that same tone, but it was like it was bubbly, I mean changing while it was sitting there. That may have been why it looked like it was glowing. It was a bright object but it was, things were like that moltenness--lighter green and it would change like that but it didn't change completely like green to red or something like that. It stayed in the same shade. (And you sat in his car about a half hour after he stopped you to calm down?) yes. (and he escorted you part of the way back to Superior?) past the place where I had seen it, so we knew I was by there, and then I saw another car so I followed him all the way back. . . (You say you were never so scared in your life?) right. I told the professor I would rather have had somebody with a knife or gun--and I'm scared of both, even an unloaded gun. I would have been more happy with something like that because I would have known what I was facing, but that thing I didn't understand and didn't know one

thing about it, and that's what scared me. So unknown. . . . Somebody asked, 'Were you drinking?' and this was at 5 in the morning and I had maybe a half a beer at maybe 8:30 in the evening and it takes a lot more than half a beer to get me drunk, and this was 5 in the morning. And I didn't have any drugs or anything like that, but uh, that's what they all ask me. 'You must have had some pretty good booze,' is what they-- if I had [^]this would have sobered me up anyway. (Lundholm: The sheriff reported you were sober) Oh yeah, I really was. (He never gave you a speeding ticket?) No. I think he ~~genuinely~~ genuinely, I mean nobody could have put on an act like that. I couldn't make my body, I can't do it now to show you how I was. I was just quivering, and ~~boyz~~ Boy! just like this (shuddering) I couldn't stand up, my legs were just giving out on me, just bgh, stuttering, nervous, cold. I was just freezing. I was unnh-unnh.

. . . The (deputy) sheriff said, 'You don't have to feel too strange because we had four other reports tonight,' so that made me feel really good right there. I don't think anybody else saw anything as close as I did . . . When I think about it now, I get kind of quivery and nervous because it puts me back almost into the feeling I had. I don't think I'll ever [^]have that feeling again. (Lundholm: I was wondering if you're ever going to come back from Solon again at 5 in the morning) Unnh. I was tempted to one night. One night I was going to. I got a ride down there and my boyfriend was going to drive me back, and we got a mile out of Solon and his car broke down. I don't think I have good luck when I go down there, it seems, with all these things happening. So I ended up staying there until morning. I was even scared to go then, but I thought as long as he (boyfriend) was there I am not too nervous, and then the car broke down. But I do carry a camera now just in case I do come back and see that thing again. I'd do anything to have a picture just so I can say, 'Haha. it is!'

Receives and stores UFO reports from RCMP; card indexed by dates. Section examines all reports and tries to explain anything of an atmospheric nature, etc. Occasionally will send a staff member out to investigate a case but not very often. Main function of the section is atmospheric research, aurora, meteors, etc. Files on UFOs are open to anyone seriously interested but person must agree not to use names in reports without first checking with the person.

Douglas County Deputy Jack Hunker (Douglas communications center 715-394-0371) interviewed at Sheriff's Office in Superior 5/11/75 in presence of Deputy Jim Hunker, his brother, and another deputy.

(Talked to Kathy Thompson yesterday etc.) I came up behind her and noticed the car going at a high rate of speed and I stopped her outside of Solon and when I went to walk up to the car, she came running up to my car and she was just hysterical. She was just a complete basket case. She was shaking and tears in her eyes practically and everything. she was just really nervous. she couldn't even light up a cigarette, she was so nervous she couldn't get anywhere near the cigarette with the matches. And she explained to me that she had, something was on the road when she came up the road, this object was hovering over the road and it had a flashing ~~light~~ red light on the bottom and it was a kind of green color, I believe. It's been a couple of weeks now and I'm having a hard time remembering exactly what else she said. And she got scared, she came up to it and it was blocking the whole road I think she said about 5 or 10 feet off the road. And she turned her car around and headed back to Solon at a high rate of speed. And I had come through that area--I shouldn't tell this but I had been out of my area (((In an earlier interview ^{with} ~~by~~ Lundholm, Hunker said he had had a bad headache and had driven into Superior to get some aspirin and was heading back to his patrol area, but he didn't explain to me why he had left his area))) and I was hurrying to get back there so I was speedin, and this is why I ~~can~~ caught up with here. (Where was this) County Trunk Road L and US 55. (And this is just north of Bennett. Is this about 5 miles north of Solon?) Yesss (and that's a fairly straight stretch of highway there) yes (I was down there there other day and I don't remember many hills in the area, right, not too many. It's fairly smooth and you can see in both directions for quite a ways (and you spotted here where) it would be down closer to Solon, maybe 3 or 4 miles from where it happened. (And she said you

followed her all the way into Solon) Right, it looked like a guy in the car. with the long hair you couldn't tell, but I figured I'm going to wait and stop him when I got into Solon Springs where there was all the lights from the streets. She never slowed down, so it made it much easier. she was running about 85-90 miles an hour. (Did she speed up when you started following her) yeah, she kept going a little bit faster (How fast do you think she was going when you first saw her) Probably 70. She was doing about 90 when I stopped her. I figured I had a real live ticket but as shook up as she was I don't think she was faking it. You know, I've heard some good stories to drop a ticket but as scared as she was and everything, there was no way she could have made up that story. (How did you calm her down?) Just talked to her about a half hour, 45 minutes, something like that. She sat in the car and we talked for a while. She eventually calmed down enough that she thought she could make it back to Superior and I followed her back through the area, where she had seen this and there was another car going toward Superior and she stayed behind that and I told her to call our office here when she got back, which she did (This was sometime around 3 in the mornin?) Yeah, I think it was right at 3. (She said when you came down through there, there was some fog or something) yeah, there was some smoke or whatever that smelled like burnt garbage. That's what it reminded me of anyway. I've been to a few dumps and that's what it reminded me of. (Was this smoke over the highway or--) Just over the highway. There was none in the fields or anything. (Was it low lying or--) Right, low lying. (Below the top of your car?) Yeah (And you don't know what it was, smoke or fog or--) I don't remember, but when ^{AM} we came back (through) there was no trace of anything (And was the smell still there when you came back) No (The smell was gone too?) Yes. (Is fog normal for this area?) Well, there are patches of fog because there is swampy land, marshes in

the area and it is possible to have it but I haven't run into any that night. (Is this a particularly low lying area?) Well, right at L and 53 there is a kind of like a big pond and a creek in there but she was maybe half a mile or so south of there. What it was I don't know. Because I didn't see anything (in the way of a UFO), so all I did was notice that smell and the fog-like when I went through there, and I was going quite fast myself because I was supposed to be in that area and I wasn't there.
