PUBLIC RELEASE OF UNIDENTIFIED FLYING OBJECTS (UFO) FILES

These copied and redacted files of correspondence on **Unidentified Flying Objects** dating from 1952 to 2009 have been Declassified and released to the public by the New Zealand Defence Force under the Official Information Act.

Access to the original files held by Archives New Zealand is restricted up until the year 2080 for Personal Privacy reasons. These copied files have had the personal details of members of the public making UFO reports removed to preserve their privacy. Personal details of service personnel and civilians employed by the New Zealand Defence Force and other Government Departments and Agencies have not been removed. No other information has been removed or omitted from these files.

GENERAL DESCRIPTION OF FILES

Correspondence on Flying Saucers began in New Zealand Defence Force files in 1952 and continued under different names, Unidentified Flying Objects (UFO) and Unidentified Aerial Sightings (UAS) until the present. The files contain reports of sightings by private individuals and military personnel, investigations by Defence and other Government Departments and agencies into these reports, newspaper clippings on UFOs and letters from individuals who claim to be in touch with alien beings and craft.

While the files are in general date order from 1952 until the present some file periods overlap with one another and the documents within each file are not necessarily in strict date order. There can be duplicate documents within each file and copies of the same documents (particularly media releases and reports) can appear in different files.

ACCESS TO UFO FILES

These redacted files are available in hard copy from the Defence Library c/o Headquarters New Zealand Defence Force Aitken St Wellington. They are not available in electronic format.

Recently it has come to my attention that the New Zealand Air Force has prepared a study of the New Zealand UFO sightings in the Clarence River - Cook Strait regions between December 20th, 1978 and January 10th, 1979 which is available to the general public.

I am at present compiling a publication entitled "Australian Unidentified Flying Objects"(written in collaboration with Mr D.W.Mitchell, a writer for the "Scientific Australian" magazine) which is a skeptical work on this subject and which in part deals with the above dated New Zealand UFO events.

Therefore I request one copy of the NZAF official report on these sightings and any other publication by the Air Force available to the public that provides explanations for these phenomena.

Please notify me as to what costs are required to obtain these.

I have recently obtained a copy of the Department of Scientific and Industrial Research Organisation's Report No.659("Unfamiliar Observations of Lights in the Night Sky", by Mr W.Ireland) which has provided me with an excellent study of these occurrences, however, I also desire the Air Force's report on these matters to, a) establish beyond doubt that perfectly natural explanations exist for these sightings, b) to provide a most detailed analysis of the sightings from both sides, pro or con, for a balanced symposium and c) to verify its conclusions for each particular UFO case with those in the DSIR Report.

Dear Sir,

I am writing, as requested, to inform you of my sightings of the UFO's over Palmerston North on Thursday. I am a member of the band who all saw the UFO's.

At approximately 10.30 pm on Thursday night we left the Lounge Bar of the Albert Motor Lodge to return to our accommodation. While crossing the carpark (cnr Main/Albert) we noticed an "orange ball" in the sky, which we later estimated at roughly 5,000 ft high, and about 45° up from us. The ball moved quite rapidly, considering its size, from a northerly to a SSE direction. At its closest point it gave the appearance that it was burning, as the edges seemed somewhat jagged and constantly changing like fire. It also pulsed from very pale to darker orange.

As the object got further to the south, it "appeared" to send off showers of red sparks at 10 - 15 second intervals. This may have been atmospheric conditions. Also on two or three occasions, as it headed away, it appeared to dip and move from side to side very rapidly, and without the normal turning room a plane would need. It would move and return to its continuous line in a matter of one second or less.

This object was in our view for 5 - 7 minutes at a guess, before becoming too distant to see with the naked eye. We then decided to return home, but as we turned around, we saw three similar objects, in a shallow V formation, in approximately the same position we saw the first. The three moved and looked the same as the first, but tended to move to a slightly more easterly direction. None of the objects made any sound that we could directly relate to them, there was the odd swishing sound, but it wasn't constant, so was probably traffic in the city.

Before the three were out of sight, myself, and a who was staying at the Albert went to the reception and rang Ohakea, who told us to ring Palmerston North Airport, but there was no reply. The Police were no help, so we rang Ohakea again, but didn't get very far. So tried and eventually got through to someone in charge.

If you should require any further information please contact our base address, Wanganui. We'll possibly be there after next week for about a fortnight, otherwise one of the guys in the flat will know where we are. Best ring late at night.

I look forward to being of assistance.

AT ITS CLOSEST POINT IT GAVE THE APPEARANCE THAT IT WAS BURNING, AS THE EDGES SEEMED SOMEWHAT JAGGERED AND CONSTIATLY CHANGING LIKE FIRE. IT ALSO PULSATED FROM VERY PALE TO DARKER ORANGE.

AS THE OBJECT GOT FURTHER TO THE SOUTH, IT "APPEARED" TO SEND OFF SHOWERS OF RED SPARKS AT 10-15 SECOND INTERVALS. THIS MAY HAVE BEEN ATMOSPHERIC CONDITIONS.

ALSO ON 2 OR 3 OCCASSIONS, AS IT HEADED AWAY, IT APPEARED TO DIP AND MOVE FROM SIDE TO SIDE VARY RAPIDLY, ~~AND~~ AND WITHOUT THE NORMAL TURNING ROOM A PLANE WOULD NEED. IT WOULD MOVE AND RETURN TO ITS CONTINUOUS LINE IN A MATTER OF ONE SECOND OR LESS.

THIS OBJECT WAS IN OUR VIEW FOR 5-7 MINUTES AT A GUESS, BEFORE BECOMING TO DISTANT TO SEE WITH THE NAKED EYE.

WE THEN DECIDED TO RETURN HOME, BUT AS WE TURNED AROUND, WE SAW THREE ^{SIMILAR} OBJECTS, IN A SHALLOW V FORMATION, IN APPROXIMATELY THE SAME POSITION. WE SAW THE FIRST

THE THREE MOVED AND LOOKED THE SAME AS THE FIRST, BUT TENDED TO MOVE TO A SLIGHTLY MORE EASTERLY DIRECTION, NONE OF THE OBJECTS MADE ANY SOUND THAT WE COULD DIRECTLY RELATE TO THEM, THERE WAS THE ODD SWISHING SOUND, BUT IT WASN'T CONSTANT, SO WAS PROBABLY TRAFFIC IN THE CITY.

BEFORE THE THREE WERE OUT OF SIGHT, MYSELF, WHO WAS STAYING AT THE ALBERT WENT TO THE RECEPTION AND RONG CHAKKA, WHO TOLD US TO RING AIN AIRPORT, BUT THERE WAS NO REPLY, THE POLICE WERE NO HELP, SO WE RONG CHAKKA AGAIN, BUT DIDN'T GET VERY FAR, SO TRIED, AND EVENTUALLY GOT THROUGH TO SOMEONE IN CHARGE.

REPORT ON UNIDENTIFIED FLYING OBJECT
FROM SQUADRON LEADER G.R. ALLIN

1. Squadron Leader Allin's reported sighting of an Unidentified Flying Object on the night of 21 April has been passed to me in accordance with standard action procedure.

2. From the description and behaviour of the light, it appeared to have the characteristics of a radar balloon carrying a lamp attached to the radar reflector. This is supported by the Superintendent of Physical Meteorology in the Ministry of Transport and although a balloon had not been launched from Ohakea at the time approximate to the sighting, it is not uncommon for these balloons to be found in the hands of others outside the Meteorological Service.

3. It should be explained to Squadron Leader Allin that the investigation carried out by the RNZAF earlier this year on the sightings off the Kaikoura coast, was an isolated case and that the RNZAF does not normally undertake detailed investigations of Unidentified Flying Object sightings.

4. However, as with this sighting, the RNZAF consults a number of Government agencies in an endeavour to eliminate any obvious explanations.

1. On 26th April 1979, I was the Duty Operations Officer for RNZAF OHAKEA. Whilst at home, on call, I was contacted by the Ohakea telephone operator, who, at 2255 hours, informed me that she had been contacted by several residents of PALMERSTON NORTH, who were enquiring about the 'orange lights' that were traversing the city. One such caller, a _____ was put through to me. He stated that he, and several others, had observed coloured lights travelling from north to south above the city. I asked him to submit a written report to the Base Commanding Officer.
2. Shortly afterwards, whilst I was exercising my dog in Featherston Street, I observed a single orange light, approaching from the north north east, and at about fifteen degrees above the horizon. Being a single light source, it was difficult to estimate range, but I assessed it to be about eight kilometres away and tracking along the watershed of the northern TARARUA Range. The weather was calm, clear and cold but it is unlikely if any noise would have been heard at that range.
3. As my family and I had observed an aerial phenomenon on the evening of 20th April, I was anxious to find witnesses of this sighting. Across the road, two youths were operating a C.B. radio. I asked them to confirm the sighting, and for their names and addresses. These are included in the Appendix.
4. At 2305 hours, I arrived back at my house. In transit, the lighted disc had been observed against a moving background, but the impression was gained that its track curved ~~right~~ from south south west to south east. For two or three minutes, my family and I observed the now stationary disc, still at an elevation of about fifteen degrees and at a range of about fifteen kilometres. With the aid of 8x30 binoculars it was possible to make out the disc shape of yellow light, surrounded by thin corona of red light.
5. At 2307 hours, the size of the distant disc grew smaller, giving the impression of a rapid climb, directly away from these four observers on a heading of 130 degrees True, and with an angle of climb of 25 degrees, until it disappeared into the background of stars.
6. I then rang the WELLINGTON Air Traffic Control Centre, and spoke with the duty radar operator. He was informed of the sighting and informed me that he had neither known traffic nor unidentified blip in the area to the south east of Palmerston North. The Defence Duty Staff Officer was next informed of the sighting, with the coincidence of ^{the} last point of observation being identical to that sighting of the 20th April.
7. At 2335 hours, _____ rang me again, stating that the initial sighting had been of a single light source at 2230 hours, seen initially at an elevation of 45 degrees, to the north. The disc had passed over the head of the observer and his two companions, who were standing in the forecourt of the ALBERT Motor Lodge, Albert Street, Palmerston North. As it did so, at an estimated five to eight thousand feet, a pulsating swishing noise was heard. It was not thought that this could be mistaken for traffic noise. As the disc passed to the south, it was observed to emit sparks, which remained incandescent until they fell from sight behind the immediate horizon. The disc disappeared from sight in a like manner. The course of this first disc appeared to be erratic about south south east.

8. At 2235 hours, the three observers saw a shallow vic formation of three orange discs of light. These flew on a course of approximately SSE, overflying from the north. These too, disappeared from sight behind the local horizon. Again, was asked to submit a report in writing to the Base Commander.

9. In the absence of the Base Orderly Officer, the Ohakea telephone operator was asked to request the Orderly Officer to inform the Base Commander of these sightings and to anticipate the receipt of report(s).

10. I have no objection to this report being made available to the media.

Dear Sir,

I regret that I cannot be of much assistance to you in this matter. There are currently over 4600 objects catalogued in orbit about the earth. The orbits of a great number of these satellites take them over New Zealand from time to time. When and how often is a function of the actual orbit of the satellite. We ourselves concentrate on only a small amount of this total, about 200, called Deep Space satellites. It is only on these that we maintain any information, and their nature is such that they normally wouldn't be visible to the naked eye anyway. We ourselves frequently get a satellite on the film that we cannot identify - not because it's a "UFO", but simply because we don't have any data on that particular satellite. 



AERIAL PHENOMENON

1. At approximately 1850 hours, local, on Saturday, 21st April 1979, my thirteen year old son walked from the back door of our house; a distance of some ten metres to the side door of our workshop garage, wherein I was working, in order to call me for our evening meal. Before reaching the door, he called me, in an urgent voice, to "come and have a look at this light in the sky." Aware of his youthful penchant about UFOs, I was somewhat sceptical, but nevertheless went to the door.
2. It was completely dark, civil evening twilight being at about 1800 hours, and the immediate area was unlit. I looked in the direction that he indicated and, against the cloudy night sky, saw a steady white light, moving slowly from left to right. Initially, because a Cessna 206 had been seen earlier, engaged in skydiving manoeuvres from Milson Airport, I assumed this to be the same aircraft embarking on a night drop, or maybe a James Aviation Cessna 402, in a right hand climbing turn after taking off from Runway 07 and with landing light illuminated.

Both my son and I moved to our back door and called for my wife and my mother to observe this phenomenon. I then requested that my son fetch my binoculars. These have a magnification of eight and, as they had been used earlier in the day to observe the skydivers, were correctly adjusted to my vision. Thus, I was immediately able to study the light.
4. Initially, with the naked eye, it appeared as a small ball of fire, similar in appearance to the tailpipe view of a single engined jet aircraft with reheat engaged. This is a sight with which I am most conversant, having flown such aircraft for seventeen years. As it was a single light, I could only assume its course by the steady angle of its approach. This I have ascertained, by use of NZMS 1, 17, and 242A Lands and Survey maps, aerial photographs of my house and a service Marching Compass, to be 235° True or 215° Magnetic. The visual appearance of this single light gave the impression of flight on steady heading, at a height of about 2000 feet and, tracking from the direction AOKAUTERE, when first sighted, towards HOKOWHITU; more precisely $40^{\circ}20'S$ $175^{\circ}42'E$ to $40^{\circ}22'S/175^{\circ}39'E$. This approximates overflying the general axis of the MANAWATU River, upstream of PALMERSTON NORTH, for a distance of 6.5 kilometres. Our house is situated at $40^{\circ}20'51"S/175^{\circ}36'47"E$, or 1100 metres north of the centre of PALMERSTON NORTH.
5. Although the light was seen initially on a True Bearing of 080° from our position, its progress slowed as it moved to a bearing of 130° True. During this period, its angle of elevation increased from 25° steadily to 35° above the horizon.
6. Just prior to its motion ceasing, the light was studied with the aid of the binoculars. The magnified image appeared to be an unflickering, naked flame, with KELVIN characteristics similar to the flame of a kerosene Hurricane lamp. The light source was quite circular and was large enough to present itself as a disc and not as a pin-point of light. In no way did it resemble a reflected image as no mirage 'trembling' was evident. To either side and above the disc was a small area of red light. The definite impression gained was of an oncoming, aurally mounted 6 volt old car headlight, shining alongside a red painted surface.

The closest comparison that I can draw, to a personally observed source is of an RAF Support Command, scarlet painted Whirlwind helicopter, with only its belly spot light illuminated and shining forward, partly illuminating the under fuselage. Another valid comparison would be of a waxen night light flame, at the bottom of a sherry glass, the far side of which was painted red and illuminated by the flame.

7. At this time, I left my mother, wife and son on the back steps, and decided to investigate further. I rang RNZAF Base OHAKEA and asked for Air Traffic Control, in order to check for aircraft movements and radar echoes. I noted the time as 1854 hours. With no answer, I then rang Palmerston North tower. No answer, so I rang Ohakea again and identified myself as the Operations Flight Commander, asking to be connected to the Radar Supervisor at the WELLINGTON Air Traffic Control Centre as quickly as possible. I then returned to the back door.

8. My family informed me that, in my absence, the light had remained stationary for a time, then had moved back on its original track slightly before growing dimmer and changing its position in elevation. I noted the time as 1900 hours.

The light, indeed much dimmer, was still on a bearing of 130° True but now about 30° above the horizon and growing noticeably less bright and smaller as it apparently climbed away on a heading of about 130 True or 110 Magnetic towards PAHIATUA. As it, apparently, climbed, the light was seen to vary or pulse in intensity. This, I assumed, coincided with transit of the thin layer of Altostratus cloud at about 10,000 feet. At this time, the pulsing light was surrounded closely by a slight halo effect, such as a light seen through thin mist. Again, there was a marked similarity to an aircraft climbing directly away from the observer whilst in reheat. Eventually, after another minute or so, the light became so faint that it was lost in the reflected glow from the city. At that time, an occasional sight of stars was made through the thin cloud. At no time was the sound of an aircraft heard, only the muted noise of nearby road traffic, in itself infrequent.

10. At 1905 hours the telephone rang and, after a short delay, I was connected to the Radar Supervisor at Wellington and to whom I gave brief details of our sighting. He stated that no aircraft was airborne in our area, that Ohakea had closed watch earlier and that he would enquire of Palmerston North tower.

11. I next informed the Ohakea Orderly Officer of our sighting and checked weather conditions with the duty meteorologist. These were estimated to be broken Altostratus cloud at approximately 10,000 feet with half cover of Cirrus at 28,000 feet; calm conditions and unlimited visibility.

12. My wife and my son studied the phenomenon through my binoculars.

13. With twenty seven years experience in aviation, I consider myself to be an unbiased, expert witness. Using my personal experience as the only criterion for this opinion, I consider that the phenomenon observed was a sphere of steady flame, of comparatively low temperature, below 1000° Celsius, less than 2 metres in diameter and backed closely on one side by a crimson coloured material. There was no possibility of the



Thank you for your letter of 2 April in which you posed a number of questions relating to the sightings of Unidentified Flying Objects and sought a copy of the investigation report.

The news reports concerning a squadron of aircraft on special alert was in fact an exaggeration by the media. One Skyhawk was placed on standby to investigate further sightings and an Orion aircraft in fact carried out a patrol of the area in which the sightings were being made.

Yes, the pilot of the aircraft carrying the television crew disagreed. However, the pilot also did not believe that the film taken from the aircraft was a good representation of what they actually saw.

Unusual atmospheric conditions on the east coast of the South Island have been well documented since 1948, with many mirage-type effects being witnessed over the years. The specific conditions which prevailed recently were a very clear atmosphere for this time of the year; marked inversion layers and a strong north-west wind aloft causing a föhn effect.

It was suggested that the most likely objects photographed were possibly refracted images of Venus or a squid fleet. The suggestion that the lights from trains and cars could have been responsible for some of the inshore sightings could have been true.

The radar was, at the time, giving so many spurious returns that there was at best only a slight chance of whether or not the lights sighted and the various radar returns were coincident. Bearing in mind that the radar has no height finding facility and that visual observations are not very accurate in term of range, height or bearing, there was very little, if any, correlation between the various sightings.

UFO'S ?

1. At 0330 on 9th April 1979 we were on the north bound leg of a patrol at 9,000 feet when a radar contact was obtained in position 3710S 17130W. This contact, bearing 116/20nm from the aircraft appeared to be keeping formation with the aircraft.
2. We turned on to investigate, and, whilst homing on, the target was sectored upon and the tilt control varied. The target was most distinct at -1.3° of tilt, indicating a target below us, and had the appearance of a light-medium cloud, 3nm long, along track (116°) about 1nm wide. Throughout the homing to "On Top" there was no target movement. After the "On Top" the contact was lost (i.e. aircraft to the east of target) but was regained when the aircraft was again to the west of the target. Despite two homings to "On Top" nothing that could explain the target was seen either above or below us.
3. As the AEO and Radar Operator I believe this contact to have been a cloud contact at a true distance of 40⁴nm on a bearing of 116° true from its apparent position.
4. The P3B radar has a PRF of 400 PPS giving a PRT of 2500 micro-seconds, this limits the max. theoretical range of the radar, (due to time available to "listen" for an echo) to 202nm. Normally at that range the power output would be insufficient to allow detection of anything but the most perfect reflector. However, with atmospheric ducting this range could be increased significantly, allowing the echo to come back not in the listening time for its own pulse, but in time for the next, or even one after that. This would mean that targets would be displayed at a range of X-202 or 404 or 606 etc where X = the actual range of the target from the radar.
5. If this phenomena were to happen in an aircraft travelling at say 300 kts and the real target were say 424nm away, then the target would appear to be at a distance of only 20nm. Furthermore the target would appear to keep formation with the aircraft because the true relative

bearing would only alter very slowly. The radar would only be able to pick up the contact outside of 404nm because as the range closed to say 403nm the echo would arrive back in time, not for zero range on the third pulse, but in time to appear as 202nm on the second pulse's "listening time". Although the contact was not observed coming in at extreme range after the "On Top" due to display limitations, I believe the above to be an explanation of the contact we gained.

6. After extensive enquiries about cloud formations around New Zealand at that time, the Wellington Met Office informed me that the only significant cloud at that time was a belt of high top cloud running north east/south west through 40S 180E/W which coincides with the position of our contact in position 4045S 17915W. This position is calculated by taking 404nm from the apparent targets initial position on the initial bearing of 116°T, and 404nm from the last seen position of the apparent target on the final bearing of 120°T.

7. Had this contact been picked up by a less flexible and well equipped platform the result would almost certainly have been another UFO sighting report. Perhaps this incident, as a proveable example of radar ducting is of public relations value.







RNZAF UFO SIGHTING REPORT

The unidentified radar and visual sightings reported by aircraft and the Air Traffic Control radars off the north east coast of the South Island recently, are the result of natural but unusual atmospheric phenomena.

This is the conclusion arrived at in the Air Force's just completed investigation into the sightings.

Before arriving at his conclusions, the investigating officer interviewed all the principle witnesses involved in the sightings on the nights of 20 and 30 December. He also worked closely with the Department of Scientific and Industrial Research, the Civil Aviation Division of the Ministry of Transport, and the Meteorological Service.

His report reveals that during the months of December and early January, atmospheric conditions over New Zealand were conducive to freak effects on radar and light waves. Also, the planet Venus was rising in the eastern sky early in the morning, and at this time of the year is unusually bright in appearance.

It was also revealed that for some time the Wellington Air Traffic Control radar has been giving spurious returns off the east coast of the South Island.

Over the period more than 50 Japanese squid boats sailed from Wellington to a position 120 miles off Banks Peninsula.

Not only would the squid boats give a good source of radar return whilst in transit to the squid fishing grounds, but they generate a very large amount of light when fishing at night. Each boat generates about 200 kilowatts of light to attract squid to its lures, and this light source cannot be discounted as a cause of some of the visual sightings.

The investigating officer also speculates that lights seen in the Clarence River mouth could have come from trains or vehicles travelling along the coast, and affected by unusual atmospheric reflections and refractions.

There is no evidence to connect the many radar and visual sightings in the Clarence River and the larger lights seen to the east.

A Ministry of Defence spokesman said the Ministry was completely satisfied there were no unexplained physical objects in the skies at the time of the sightings.

The lights were almost certainly from surface or planetary sources affected by atmospheric reflection, refraction and distortion.

Radar sets are known to be subject to spurious returns, and it was significant that on the occasions the large light was being filmed by a television team on board the Argosy freighter, neither Christchurch or Wellington radars reported any related visual sightings on their screens.

The spokesman said that the Ministry of Defence was not specifically charged with formal responsibility for investigating so-called unidentified flying objects in peacetime. However, the Ministry does take an active interest in all such reports and within the limitations of its resources, conducts investigations as necessary.

Commenting on some media speculation that the country was defenceless against air attack, the spokesman said that New Zealand did not have a complex air defence system, comprising sophisticated radar equipment and a force of missiles and interceptor aircraft.

The recently announced Defence Review explains that over the next decade at least, a physical threat to New Zealand's security, by sea or from the air, is so remote that expenditure of funds on sophisticated air defence equipments could not be justified.

No costing of a comprehensive air defence system for New Zealand had been done, but the Defence spokesman said that the bill would be enormous and well beyond current resource levels.

The Defence spokesman concluded by saying that the Ministry totally discounts the possibility of visits to New Zealand, and particularly to the areas of the country where the recent reports have suggested, of alien aircraft or other flying machines. It also categorically discounts any suggestion that air activity of any kind has taken place which poses any threat to New Zealand's security. Defence does not share the view of those who believe we are visited from outer space, or covertly by the aircraft or machines of potentially unfriendly nations.



RNZAF/DSIR INVESTIGATION INTO
UNIDENTIFIED FLYING OBJECTS

1. Attached is a letter from Warrant Officer I.B. Uffindell in which he expresses his reservations about the results of the inter-departmental inquiry into the South Island east coast UFO sightings in December 1978.

2. Warrant Officer Uffindell observed objects from this Base the night of 22/23 December while these were simultaneously plotted by Wellington Radar. The duty Flight Service Officer, Mr Bill Frame, corroborates the Warrant Officer's observations. Thus Uffindell had a personal and professional interest in the outcome of the inquiry.

3. The inter-departmental team visited Woodbourne on Friday, 5 January 1979, and during my time with them I gained the firm impression that they were here to "whitewash" the affair. The DSIR chaps had the answers before they heard the evidence, and when the evidence did not fit the preconceived theory, then it was seemingly put aside.

4. I hold no particular views on the matter, but do agree with Warrant Officer Uffindell's opinion that the RNZAF has gained no benefit from the affair. The Safe Air captains involved have both been quite critical of the outcome of the inquiry, and therefore, indirectly, of the RNZAF.

5. The Warrant Officer's submission is forwarded with the recommendation that Air Staff be advised of the dissatisfaction of one of the prime witnesses.



UFO INVESTIGATION

1. I feel that the findings of the Defence Investigation Committee on UFO's off the Marlborough coast Dec 78/Jan 79 are an insult to all those involved in the sightings and subsequent investigation.
2. Whilst the committee was comprised of men with a high degree of intelligence, and scientific background, I believe they were all biased towards the type of finding they arrived at, before they even commenced their inquiry. This was particularly true of Mr Thompson from the meteorological service. He had rubbished the idea of anything but atmospheric conditions being the cause, on numerous occasions on the TV news.
3. Furthermore, Wg Cdr Clements, the committee chairman, stated that he had no doubts whatever that they would find the cause to be astronomical or meteorological phenomena, and the other three members agreed. This was on Friday 5th January, the inquiry was then still in its first day!
4. Wg Cdr Clements further stated that CDS had ordered the inquiry, that they were dragging all the old files out of the archives, and that they were going to try and find the cause or source of the sightings, no matter how long it took. Yet exactly three weeks later on Thursday 25th January the findings are out, case is closed and we don't want to hear anything more about it.
5. On Monday 22nd January Mr Bill Frame and I took bearings and elevations from the Woodbourne control tower to where we had witnessed three UFO's for an hour. I don't think he even had time to send them to the committee, yet they had requested that we take them.
6. Sir, it is my opinion that this inquiry was a farce from beginning to end and has done much to tarnish the RNZAF's image in the public's eye. I request you draw CDS's attention to the points I have raised and urge him to re-open the inquiry, this time with at least some people who hold an open mind on such matters.

NEW PLYMOUTH, Today (PA).—A Waitara man came up yesterday with a bubbling new theory on UFOs — foam wafted from the sea into the air.

Recent UFO sightings over Kaikoura could be explained by the bubble theory, Mr I.L. Wood said.

He said UFOs were transparent light-reflecting bubbles that rose off the sea from patches of foam produced by pollution. The wind carried the bubbles great distances, and at high speed the oil or other pollutants in them gave them bright colours.

"I have studied these for years, and have watched them lift off the sea around Waitara. They are about the size of a basketball."

The bubbles could look bigger than they were, and when the wind got too strong they burst, deceiving people into thinking they had seen a UFO disappear at high speed, he said.

He said steep hills in the Kaikoura region produced strong updraughts which could carry the bubbles to great heights.

Mr Wood has written to the Ministry of Defence about his theory.

"This has opened the whole thing up for me. The things science has been looking at for years are produced in the sea," he said.
