Subject: Project 8003(d)

1. (S/NOFORN) At 151200 hours October 1980, interviewer #66 informed me that in conversation with LTC Watt earlier that day, #66 had been made aware of the fact that an earlier session #66 had facilitated against a sealed envelope target had been directed against the [REDACTED] SG1A

2. (S/NOFORN) Apparently, this information was gleaned from a conversation regarding targeting for session D- #66 was told by LTC Watt to "do like had been done against [REDACTED] when #66 asked

 the sealed envelope session.
 When #66 expressed surprise
 that the sealed envelope target
 had been targeted against the

 LtC Watt attempted to

3. (S/NOFORN) In summary, future
 sessions (if any) against 8003(A)
 must take into account that

 having been targeted in the
 past. This is an important
