1. (S/CL-1/NOFORN) Initial CDIP action to authorize/fund GRILL FLAME activity as a HUMINT entity failed and congressional committees directed the Army curtail operational activities on the ACSI project within the National Foreign Intelligence Program at the end of FY 82.
2. (S/CL-1/NOFORN) The CG stated that he wanted to establish a similar program and would do so out of hide, directing use of S&IA funds and implementing an Army Special Access Program called CENTER LANE within Security Support Detachment (SSD), 902d MI Group (MIG).
