



I. FORTIFICATIONS



- a. two types of mines, one w/ antenna like device, located in grassy areas btwn Chauncery bldg
- b. grassy area btwn Chauncery is covered by line of fire with heavy crew-manned machine guns.
- c. possible machine gun positions on top of Ambassador's gtrs, in glass penthouse.

- a. sailboat type of boat
- b. the name on back is R-A-M-S-E-S II
- c. boat was found in garage-type bldg located adjacent to Ambassador's quarters.

Other information passed on to [REDACTED]

I. PRISONER-TYPE CONFINEMENT LCTD OFF COMPOUND

- a. names of individuals found in this environment: HOLLAND, METRINKO, AHERN, NEEDHAM, LAINGEN
- b. 12 sessions from 1 DEC 79 to 3 JAN 80 has placed individuals in an off-the-compound prison-like atmosphere
- c. general similarities described by different sources
 1. large, light colored stucco, multi-storey bldg. key words are (official, police, prison)
 2. cool, dark, damp, basement/dungeon-like atmosphere
 3. bars on windows and doors
 4. courtyard associated with this complex

II. HOSPITAL/INFIRMARY SITUATION

- a. Source was asked to locate AHERN and described AHERN as being in good condition.
- b. At same location source stated that there was another hostage in what appeared to be hospital environ. This hostage was described as being in very bad physical state. Key words are (sweating profusely, cold, clammy, unconscious)
- c. This situation took place sometime around late March.
- d. On or about 22 FEB 80 a source was asked to describe situation on 22 MAR 80. Among other things source stated that two individuals would be moved to hospital.

After this exchange of data [REDACTED] asked if sessions were still on-going with regards to Dran. I said; yes, that we were trying to accomplish 3-4 per week. He then asked if we were utilizing all of our sources or only a few. I stated that we were utilizing all our sources with the exception of myself, who has been functioning as interviewer and coordinator of this tasking. I also told [REDACTED] that the session scheduled for today was cancelled due to excessive ambient room noise.

[REDACTED] called today at 0900 hrs. I told him that the boat was sighted on 8th February. I also told him that the dates for the precog hospital info are confirmed and that this info was obtained by 2 different sources at two different times. The latter being 1 April 1980.
