1. (S/NF/SK) Tasking: Initial tasking received 23 Oct 86; see attached data sheet. Additional instructions: obtain a S6 description of site and use the increased site contact to attempt a "finer resolution" of the time line.
2. (S/NF/SK) Session: Source was informed that site was same as last worked. Began session with same coordinates; moved from S3 to S6. Source was instructed to move a straightedge slowly from north to south across his S6 worksheet while perceiving site data. Afterwards, source was told to utilize a time line (1978-1988) with yearly tic marks. Monitor "front-loaded" the source with the idea that his search on the time line might be for something connected with the special area/product described below. Source was asked to search beyond 1988 (end of line), even with the knowledge that data would probably be AOL.
3. (S/NF/SK) Summary: Proceeding from N to S at site source perceived the following: restricted area, fence, hospital, official visitors (inspecting), "secret", aircraft; large, complex/facility, important; large, open area, large structures, tall structures (see sketch); the idea of "producing something dangerous" or an idea of an activity the results/product/outcome of which are not entirely foreknown (AOL-"NSA"). A separate facility is present which produces something which requires special handling, (people in protective suits); the ~~product~~ product is "like ceramic" and is extremely meticulously engineered; (associated ideas are "flux", "catalyst", and ultra-high temperatures (AOL-"nuclear fusion").

The requested time line search (of the entire site area/facility) yielded the following data: Nothing significant to report prior to 1982. Late in 1983, activity picked up, then decreased towards the last quarter of 1984, then increased again, maintaining a high level to the end of the time line. Source feels that the nature of the activity here involves the idea of a "SAP". ✓

4. (S/NF/SK) Feedback: Source was informed that another session would be undertaken, this time to target a specific aspect of the site.
