1. (S/NF/SK) TASKING: The Interviewer was not knowledgeable of the true nature of the target. Prior to the initial session, the Interviewer was provided a sheet of notebook paper on which the following tasking had been written: "Project FY8704 - Interviewer/Monitor Tasking. 1. Describe the area (purpose of) located vic: 377566/752042. 2. Describe the structure(s) located 6KM SW of the above area - personnel, activities, equipment, etc. 3. (Feedback) to be announced". Following the initial session, the Interviewer was told that the Source should be targeted to the area 6KM south of the area described in the initial report and to concentrate all further collection efforts to that region. In the initial session, Source was provided only the encrypted coordinates, as per Extended Remote Viewing (ERV) protocols, designed to prevent inadvertent geographic cuing. In the subsequent two sessions, Source was told to "concentrate your efforts to an area 6KM southwest of the site you described in the initial session." Source was also provided the same encrypted coordinates during each of the sessions. No other cuing or descriptions except that described above was provided to Source.

2. (S/NF/SK) SESSION: There were no reportable incidents or anomalies in any of the three sessions covered in this report which may have affected the data provided by Source.

3. (S/NF/SK) SUMMARY:

a. (S/NF/SK) A total of three sessions are covered in this report. In the initial session, Source reported that the, "location is different, set apart...the location makes it different...close to a magnificent area...". This may have been an early attempt by Source to indicate that actual target, (6KM

southwest), is somewhere besides where She was initially targeted. In the area being viewed by Source, there was a further impression of a, "round circular area (beginning) where the water is and goes uphill to the trees...a multi-storied structure...clean, new near the water...(at the structure) certain parts spin around...a structure that has big, wide slats, hands go around, a spinning...fast, slow...the area is very spread out...". Again, there may be indications that Source had an insight that there was a target away from the area on which She was reporting. This continued to present a problem for the review process since it was difficult to determine if Source had remained at the initial area or was, in fact, overlaying simultaneous perceptions from the actual target 6KM to the southwest. Given that possibility, the subsequent information provided by Source became somewhat erratic, beginning with a "change" from wide open area with multi-storied structures to a, "dark place...under...large, flat, stony (area)...black earth...piles of dirt...men clean(ing) up...dirty environment...very strict...bells ring(ing)...land in this area is not good, it was stripped...the men here are to clear it out...but they are not here to make it look nice...take out the large bumps, paving, evening out...sometimes I feel like I'm underground, mining, stripping...". The nature of the reporting now changes again to images reminiscent of a mining or similar underground construction project. In this area, according to Source, "one man is standing beside the entrance, allowing the workers to go up...strings, light feathery strings hanging down, airy feeling...". In this area it is, "very narrow, very small, very black, sometimes meetings are conducted here...a very large area...men meet, men vote...one part of the room is rocky, part of the environment...". Source was then directed back to the area where men were previously described as working. In this area, presumably outside the open area, the men, "do only what they are told...they don't really know what they are doing here, the planning is done elsewhere...earth, dirt, sparkling black, black dirt, been around a long time...it lays inside the large rocks...water can get dirty sometimes because of this or is dirty as a result of this...it has worth at one time, much cleaning to do...".

b. (S/NF/SK) In the second session, Source was prebriefed that the real target was, 6KM southwest of the area reported on before and during this session concentrate only on that area". Source began the second session by reporting on an, "open area...energy seen and unseen...an energy that spreads over a large area, it makes me feel good, goes up, pushes up...men laying things out flat...big pieces, metal, heavy work, silver...you can put something long on here, rinsing up, but it's not here. I don't know if they are going to do it...a highly protected area, highly guarded, spilling over not good if it happens...men working here

need to be protected...a structure inside where men work...covering their hands to work...to handle the stuff...containers, big and little...comes from deep inside the earth, from the core but it's not good, exposure...makes me dizzy...I feel that I'm in a cave or cavern, rounded, natural, stony, rocky...". In the area outside, Source described the activity as, "men working close to the ground, touching, weighing, kneeling, what is on the ground is important, they bend over, pick and smell, a laying over, a covering, flat, this could be a way you can transport (the material) out of the area...I don't know if this...can ever leave the area...important stuff on the ground...weighed, very tiny...odorless...". The data now becomes even more disjointed and confusing as the Source continues to describe some type of substance, possibly a naturally occurring substance, in the area which Source perceived as, "powerful, danger(ous), it is being studied, manmade, man developed...a shooting out, movement back and forth, scanning efforts, going around, covering a large area...an object which goes around...". Again the Source appears to have diverged to another topic or, as stated earlier, another area. The topic (area?) now centered around an object which Source described as, "rather simple, manmade, the power is not in the object, it's what comes out, tall, narrow, at the top it's circular, moves around, stands straight up with a circular part, all the heat comes from this part, penetrates the area...it's there to give notice...sends out energies but does not receive...pre-planned...controlled...". After a few curious references to, "men sitting, communicating", Source seemed to return to an earlier series of references when She again began to describe, "layering, chosen because of the environment...it's isolated...low hills, circular area...placement is here because of the air and because the ability to reach out to important areas everywhere...people think it was put here for another purpose...". The object, (again another transposing "wink") is described as, "mobile, you can take it down...move it...expensive...men working in a shelter...". By now a full circle had been achieved and Source was back to describing the concept of men working in a shelter in a protected area etc. etc. Since this was not a productive channel at this point, the session was terminated.

c. (S/NF/SK) In the third and final session covered in this report, Source again began by describing a, "big circular area, large object, round at the top...people working...", all of which was very similar to the perceptions provided in the previous sessions. Source then added new images of, "structures...laid out in a path...low structures, laid out across the land, here to support the large object...people who work here are sent, they don't live here, it's an isolated location, the structures are square, built low to the ground...wiring (fence) for protection to keep people away...the area is backwards and primitive, modern

things brought here...". Included with this series of images was an unusual description of, "square vehicles...walking vehicles...opening and closing outside...". These images could not be clarified and therefore were laid aside with the expectations that their importance, if any, would be reported again in perhaps clearer or more pertinent form. Source continued to reference a large object which She described as, "cold, silver steel, gives out, picks up, sends, receives, it listens, it hears...associated with helping the people on the ground, they have specialties...it sits in a the ground and the top part moves, it sends out signalling to a large area...certain times people hear better..it depends on the air...men always working...never shut down...". The smaller structures, which according to Source, are associated with the large object, were further described as containing men who, "work independently, not knowing what each other is doing...", and work with, "tall boxes, tuning, knobs, listening in, hearing (is) most important, putting out reports...they were hired to listen, machines help listen...picking up a lot of wind even inside (static?)...(the men) had tough training, (the) job is easier compared to the training...live together because this is not their homeland...". Source mentioned the word, "array" in conjunction with these images which, in itself, is unusual, but in conjunction with the above description seemed to indicate that Source was viewing an antenna array which was being utilized for reason which could not objectified. The large object seemed to be a large scanning antenna of some sort but in some ways Source's descriptions indicated that it may have been mobile, i.e., "...a swinging affect, movement, is swaying, in the core of this object is heat (microwave?)...you can take this thing down, once it's up it can come down...when down it's wheeled away...(the heat) comes out of the object. It starts in the middle of the core, hot, heat waves, hot when in use, scalding, burning hot, it goes on and on and on...". These last images were a modification of the concept of an antenna since the idea of the "heat" seemed to become more important with a fleeting reference to a "core". These incongruities between the idea of a radio/radar/heated core could not be resolved nor could it be determined if they were all, in some way, directly related.

d. (S/NF/SK) All notes, sketches and other Source material pertaining to this mission are located in the mission field dossier maintained at this location.


4. (S/NF/SK) OPS FEEDBACK: Source's perceptions were communicated in an excellent manner, however, the relevance could not be determined by the Interviewer who remained essentially unknowledgeable of the true nature of the target. It was subsequently learned that, in fact, the true nature of the target was unclear to begin with, consisting of a standard, "what's going

on here" tasking. No firm conclusions can be drawn from Source's sessions except perhaps to infer that some type of high-tech, radio electronics is associated with this site. There does seem to be a sense of danger to some components, i.e., dirty environment, scalding heat, clearing, cleaning, etc., but no assumptions can realistically be drawn from the data provided by Source.
