2. (S/NF/SK) VIEWER TASKING: Encrypted coordinates 127880/79629. The cue "item of interest" refers to any drugs on board the vessel (if any).
3. (S/NF/SK) COMMENTS: In this session O18 accessed the drugs. In the next session further refinement on this will be accomplished and the specific requirements concerning the drugs addressed.

2. (S-SS) CUING: "Access and describe the target site located at encrypted coordinates 127880/796229."

3. (S-SS) RESULTS:

a. The site is a land/water/structure interface. There is an object at the site which is in motion.

b. The structure at the site is sectional (see sketch, page 8) and somehow oddly-made, giving me the impression of a "toonerville trolley" and/or a "Rube Goldberg invention".

c. At this structure, the entrance to the particular item of interest appears as a sort of squarish "pan of cooled tar" (see sketch, page 9), which acts as a covering. Below this is a semi-dark space in which is located the item of interest.

d. The item of interest appears to be small, and appears to "sparkle", partly from light reflected off chrome-like parts, and partly because the item actually has small lights on it.

e. I accessed a person at this sight who was overwhelmingly impressed with the item of interest. This person is not just a casual observer; he is an expert in the particular field of interest, and knows enough to truly appreciate it with full understanding. From where he stands, he has to look downward to look at it (as though it were sitting on the floor).
